

SELF-GRAVITATING PHASE TRANSITIONS: POINT PARTICLES, BLACK HOLES AND STRINGS

Abstract

We compute the quantum string entropy $S_s(m; j)$ of the microscopic string states of mass m and spin j in two physically relevant backgrounds: Kerr (rotating) black holes and de Sitter (dS) space-time. We find a new formula for the quantum gravitational entropy $S_{\text{sem}}(M; J)$, as a function of the usual Bekenstein-Hawking entropy $S_{\text{sem}}^{(0)}(M; J)$. We compute the quantum string emission by a black hole in de Sitter space-time (bh dS). In all these cases: (i) strings with the highest spin, and (ii) in dS space-time, (iii) quantum rotating black holes, (iv) quantum dS regime, (v) late bh dS evaporation, we find a new gravitational phase transition with a common distinctive universal feature: A square root branch point singularity in any space-time dimensions. This is the same behavior as for the thermal self-gravitating gas of point particles (de Vega-Sanchez transition), thus describing a new universality class.

Nous calculons l'entropie $S_s(m; j)$ des états microscopiques de masse m et spin j des cordes quantiques dans deux espaces-temps physiquement rélevants: Le trou noir en rotation (de Kerr) et l'espace-temps de de Sitter (dS). Nous trouvons une nouvelle formule pour l'entropie gravitationnelle quantique $S_{\text{sem}}(M; J)$ comme fonction de l'entropie de Bekenstein-Hawking $S_{\text{sem}}^{(0)}(M)$. Nous calculons l'émission quantique des cordes par un trou noir avec constante cosmologique (bh dS). Dans tous ces cas: (i) cordes avec le spin maximal, et (ii) dans l'espace-temps de dS, (iii) trous noirs de grand moment angulaire, (iv) régime quantique de dS, (v) dernière étape d'évaporation bh dS, nous trouvons une nouvelle transition de phase avec la même caractéristique distinctive universelle: un point de ramification racine carrée à la transition, pour toute dimension de l'espace-temps. C'est le même comportement que pour le gaz auto gravitant de particules ponctuelles (transition de de Vega-Sanchez), de nissant ainsi une nouvelle classe d'universalité.

Key words: gravitational phase transitions, rotating black holes, quantum strings, de Sitter, self-gravitating gas

A theory of quantum gravity, such as string theory, should account for a unified and consistent description of both black holes and elementary particles, and the physics of the early universe as well.

A central object in string theory is $\rho_s(m; j)$, the microscopic string density of states of mass m and spin j . We find $\rho_s(m; j)$ by solving the non-linear and quantum string dynamics in the curved space-times considered, refs. [1]–[5]. We compute the quantum string entropy from the microscopic density of states $\rho_s(m; j)$ in two physically relevant space-times: the rotating (Kerr) black hole and the de Sitter space-time, refs [6], [7]. Combination of the two effects at the transition: black hole and cosmological constant are also treated for a black hole in de Sitter space-time (bh dS), ref. [7].

The Hawking temperature T_{sem} and the string (Hagedorn) temperature T_s are the same concept in different (semiclassical and quantum) gravity regimes, ref. [2]. Similarly, it holds for the Bekenstein-Hawking entropy and the string entropy, ref. [2]. T_s is the precise quantum dual of $T_{\text{sem}} = \hbar c / (2 k_B L_C)$, L_C being the classical radius: $2R_s = (D-3)r_s$, (r_s is the black hole radius), or $c = H$ for Sitter space-time, H being the Hubble constant, (in any D space-time dimensions). For $L_C \gg \ell_{\text{Planck}}$, i.e. for low curvature or low $H \ll c / \ell_{\text{Planck}}$, (semiclassical gravity regime), the Bekenstein-Hawking entropy $S_{\text{sem}}^{(0)}$ is the leading term of the whole entropy S_{sem} , but for high curvature or very small radius near ℓ_{Planck} , (quantum gravity regime), a new phase transition operates and the whole entropy S_{sem} is drastically different from the Bekenstein-Hawking entropy $S_{\text{sem}}^{(0)}$, refs [6], [7].

The phase transitions we found for quantum strings in Minkowski, Kerr and de Sitter backgrounds, as well as for the quantum regimes of rotating black holes and de Sitter space, are all of the same nature: a square root branch point singularity, (the value of the critical temperature being different in each case). This phase transition does not occur in Anti de Sitter space-time (AdS): in the AdS background, the density of mass states is finite, the negative cosmological constant "pushes" the critical temperature to infinity and there is no singularity at all, refs [1], [2].

The origin of this string or gravitational square root phase transition is gravity at finite temperature or in the presence of a repulsive force (angular momentum, positive cosmological constant). This behavior is similar to that found for the self-gravitating gas of point particles (de Vega-Sanchez transi-

tion), refs.[8], [9]. In our context here, the temperature is not an external parameter, but intrinsic to the theory, determined by the mass of the system (strings, or space-time backgrounds). Furthermore, our treatment here is not statistical mechanical, but microscopic or dynamical.

Here, we focus on the phase transition we found for strings and the quantum black hole and de Sitter regimes. More results and implications on these new issues can be found in refs. [6],[7]. Black hole evaporation ends as quantum string decay into elementary particles (most massless), ie pure (non mixed) quantum states refs [2],[6], [7].

Quantum String Entropy in the Kerr background: The string entropy $S_s(m; j)$ in a Kerr black hole background is given by $S_s(m; j) = e^{\frac{S_s(m; j)}{k_B}}$, where the microscopic string density of states of mass m and spin j , $S_s(m; j)$, has been found in ref. [6] and can be expressed as

$$S_s(m; j) = \frac{S_s^{(0)}}{k_B} + e^{\frac{S_s^{(0)}}{k_B}} F(S_s^{(0)}; j);$$

$$F(S_s^{(0)}; j) = e^{-\frac{S_s^{(0)}}{k_B} \frac{(1 - \frac{m_s}{m})^2}{2}} \cosh^2 \frac{S_s^{(0)} (1 - \frac{m_s}{m})^2}{4k_B}$$

$$S_s = \frac{1}{1 - \frac{4j}{m^2 c^2}} = \frac{1}{1 - \frac{j}{h} \frac{k_B b}{S_s^{(0)}}}; \quad 4j = m^2 c^2.$$

$S_s^{(0)}$ is the zero order string entropy for $j = 0$: $S_s^{(0)} = \frac{1}{2} \frac{m c^2}{t_s}$ (closed strings), $S_s^{(0)} = \frac{m c^2}{t_s}$ (open strings), and t_s is the string Hagedorn temperature, $t_s = \frac{m_s c^2}{k_B b}$, being $b = 2 \frac{D-2}{6}$, $a = D$ (closed strings), $a = (D-1)=2$ (open strings). D is the number of space-time dimensions. m_s is the fundamental string mass: $m_s = \frac{h}{c \lambda_s}$. λ_s is the fundamental string length. λ_s can be expressed as:

$$\lambda_s = \frac{1}{1 - \frac{j}{h} \frac{m_s}{m}} = \frac{1}{1 - \frac{j}{h} \frac{t_s}{T}}; \quad T = \frac{m c^2}{k_B b}.$$

$F(m; j)$ takes into account the effect of the angular modes j , being $F(m; j=0) = 1$. Therefore, the string entropy $S_s(m; j)$ in the Kerr background is given by

$$S_s(m; j) = S_s^{(0)} + k_B \ln \frac{S_s^{(0)}}{k_B} + k_B \ln F(S_s^{(0)}; j)$$

The last new term $k_B \ln F(S_s^{(0)}; j)$ is entirely due to the spin $j \neq 0$. Interestingly enough, this formula expresses the string entropy $S_s(m; j)$ for mass m and spin j in terms of the string entropy $S_s^{(0)}$ for $j = 0$. For $j = 0$, we recover the usual expression. The logarithmic terms have a negative sign, the effect of the spin is to reduce the entropy. $S_s(m; j)$ is maximal for $j = 0$ (ie, for $s = 1$).

For $j < (m = m_s)^2$, and $m \ll m_s$, that is for low j and very excited string states, $S_s^{(0)}(m; j)$ is the leading term, but for high j , that is $j \sim m^2/c$, ie $s \sim 0$, the situation is very different as we see it below. Moreover, $S_s(m; j)$ allows us to write the full expression for the gravitational Kerr black hole entropy S_{sem} , as a function of the Bekenstein-Hawking entropy $S_{\text{sem}}^{(0)}$.

Extremal String States. A New Transition: In ref. [6] we considered a new kind of string states, the states in which j reaches its maximal value, that is $j = m^2/c$, we call these states "extremal string states". In this case, $s = 0$. For $s \sim 0$, the entropy $S_s(m; j)$ behaves as

$$S_s(m; j)_{\text{extremal}} = (a+1)k_B \ln \frac{s}{2} + k_B \ln 2 + s \frac{3}{4} S_s^{(0)} - a k_B + O(s^2)$$

In the extreme limit $(j=h) \sim (m=m_s)^2$: $S_{s \text{ extremal}} = \frac{p}{2} \frac{r}{1 - \frac{j}{h}^{1=2} \frac{m_s}{m}}$
and $S_s(m; j)_{\text{extremal}}$ is dominated by

$$S_s(m; j)_{\text{extremal}} = (a+1)k_B \ln \frac{s}{1 - \frac{j}{h}^{1=2} \frac{t_s}{T}} + O(1)$$

This shows a phase transition takes place at $T \sim \frac{q}{(j=h) t_s}$, we call it extremal transition. This is not the usual (Hagedorn/Carlitz) string phase transition occurring for $m \gg 1$, $T \gg t_s$; such transition is also present for $j \neq 0$ since $(m; j)$ has the same $m \gg 1$ behaviour as (m) . The extremal transition we found here is a gravitational like phase transition: the square root branch point behaviour near the transition is analogous to that found in the thermal self-gravitating gas of (non-relativistic) particles (by both mean field and Monte Carlo methods), refs. [8],[9]. And this is also the same behaviour found for the microscopic density of states and entropy of strings in de Sitter background, refs. [2], [7].

As pointed out in ref.[2], this string behaviour is universal: the logarithmic singularity in the entropy (or pole singularity in the specific heat) holds in any number of dimensions, and is due to the gravitational interaction in

the presence of temperature, similar to the Jeans's like instability at finite temperature but with a more complex structure. A particular new aspect here is that the transition shows up at high angular momentum, (while in the thermodynamical gas or for strings in de Sitter space, angular momentum was not considered, (although it could be taken into account)). Since $j \neq 0$, the extremal transition occurs at a temperature $T_{sj} = j\hbar T_s$, higher than the string temperature T_s . That is, the angular momentum which acts in the sense of the string tension, appears in the transition as an "effective string tension" $(\frac{0}{j})^{-1}$: a smaller $\frac{0}{j}$ $\Rightarrow$ $\hbar=j \frac{0}{j}$ (and thus a higher tension).

Quantum String Entropy in de Sitter Background: The entropy of quantum strings in de Sitter background is defined by $S_s(m; H) = e^{\frac{S_s(m; H)}{k_B}}$, where $S_s(m; H)$ is the microscopic string density states of mass m in de Sitter space time, and H is the Hubble constant. In terms of the zero order string entropy in flat space time ($H = 0$) $S_s^{(0)}$, the string density of mass states $S_s(m; H)$ for both open and closed strings can be expressed as :

$$S_s(m; H) = \frac{S_s^{(0)}}{k_B} \frac{1}{f(x)} e^{\frac{S_s^{(0)}}{k_B} \frac{p}{f(x)}} F(x) ; \quad F(x) = \frac{1}{f(x)};$$

$$f(x) = \frac{2}{1 + \frac{x^2}{M_s^2}} ; \quad a = \frac{(D-1)}{2} \text{ (open)}; \quad a = D \text{ (closed)};$$

x being the dimensionless variable $x(m; H) = \frac{1}{2} \frac{m}{M_s} = \frac{m_s}{2M_s} \frac{S_s^{(0)}}{k_B}$ and S_s is given by:

$$S_s = \frac{p}{1 + \frac{x^2}{M_s^2}} = \frac{s}{1 + \frac{m^2}{M_s^2}}$$

M_s is the highest string mass in de Sitter space time [1],[2],[3],[5]

$$M_s = \frac{L_{c'}}{0} = \frac{c}{H_0}; \quad \frac{m_s}{M_s} = \frac{L_s}{L_{c'}} = \frac{H}{c} L_s$$

$L_{c'} = c/H$ being the classical de Sitter radius. Furthermore, M_s defines the quantum string de Sitter length L_s and the de Sitter string temperature T_s :

$$L_s = \frac{\hbar}{M_s c} = \frac{\hbar^2}{L_{c'}} = \frac{\hbar^0}{c^2} H ; \quad T_s = \frac{1}{2} \frac{1}{M_s c^2} = \frac{\hbar c}{2 k_B} \frac{1}{L_s} = \frac{1}{2} \frac{c^3}{k_B H^0}$$

T_s appears to be a true critical temperature as we will see below.

For small x , (small $H m^0 = c$), $f(x)$ can be naturally expressed as a power expansion in x . In particular, for $H = 0$, we have $x = 0$ and $f(x) = 1$, and we

recover the flat space time string solution: $S_s(m; H = 0) = \frac{S_s^{(0)}}{k_B} \approx e^{\left(\frac{S_s^{(0)}}{k_B}\right)}$.

From $S_s(m; H)$, we can read the full string entropy in de Sitter space:

$$S_s(m; H) = \hat{S}_s^{(0)}(m; H) - a k_B \ln \left(\frac{\hat{S}_s^{(0)}(m; H)}{k_B} \right) + k_B \ln F(m; H)$$

$$\hat{S}_s^{(0)}(m; H) = S_s^{(0)} \frac{1}{f(x)}$$

The mass domain is $0 \leq m \leq M_s$, i.e. $0 \leq x \leq 1=2$, (which implies $0 \leq S_s \leq 1$, i.e. $1 \geq f(x) \geq 2$). All terms in the entropy $S_s(m; H)$ except the first one have negative sign. For $S_s \notin 0$, (i.e. $m \notin M_s$), the entropy $S_s(m; H)$ of string states in de Sitter space is smaller than the string entropy for $H = 0$. The effect of the Hubble constant is to reduce the entropy.

For low masses $m \leq M_s$, the entropy is a series expansion in $(H m^0 = c)$ 1), like a low H expansion around the flat $H = 0$ solution, $S_s^{(0)}$ being its leading term. But for high masses $m \gg M_s$, that is $(H m^0 = c) \gg 1$, (i.e. $S_s \gg 0$), the situation is very different as we see it below. Moreover, $S_s(m; H)$ allows us to write the whole expression for the semiclassical de Sitter entropy $S_{sem}(H)$, as a function of the (Bekenstein-Hawking) de Sitter entropy $S_{sem}^{(0)}(H)$.

The String de Sitter Phase Transition: For high masses $m \gg M_s$, (or in terms of temperature $T \gg T_s$), the entropy behaves as:

$$S_s(T; H)_{T \gg T_s} = k_B \ln \left(1 - \frac{T}{T_s} \right) - k_B \ln 2 + k_B \frac{b}{2} \left(\frac{T_s}{t_s} \right) - a k_B \ln \left(\frac{T_s}{t_s} \right)$$

where $T = m c^2 = 2 k_B$. We see that a phase transition takes place at $m = M_s$, i.e. $T = T_s$. This is a gravitational like phase transition: the square root branch point behaviour near the transition is analogous to the thermal self-gravitating gas phase transition of point particles, refs. [8],[9]. This is also the same behaviour of the microscopic density of states and entropy of strings with the spin modes included ref. [6].

The transition occurs at the string de Sitter temperature T_s higher than the (flat space) string temperature t_s : $(T_s = t_s) = (M_s = 2 m_s) = (b L_c = 2 \lambda_s)$. This is so since in de Sitter background, the flat space-time string mass m_s ,

(or Hagedorn temperature t_s) is the scale mass, (or scale temperature), in the low Hm regime. For high masses, the critical string mass, (temperature), in de Sitter background is T_s , instead of m_s , (t_s). In de Sitter space, H "pushes" the string temperature beyond its flat space Hagedorn value t_s . That is, H , which acts in the sense of the string tension, does appear in the transition temperature as an "effective string tension" $(\frac{0}{H})^{-1}$: a smaller $\frac{0}{H} = (h=c)(H^0=c)^2$, (and thus a higher tension). The effect of H in the transition is similar to the effect of angular momentum j . Furthermore, for high masses ($m \rightarrow M_s$), the partition function $\ln Z$ of a gas of strings in de Sitter space-time, behaves as

$$(\ln Z)_{T \rightarrow T_s} \sim V_D^{-1} \frac{k_B T_{\text{sem}}}{hc} \left(\frac{D-1}{2} \right)^{\frac{1}{2}} \frac{1}{1 - \frac{T_{\text{sem}}}{T_s}}$$

where T_s is the string de Sitter temperature and T_{sem} is the semiclassical (Gibbons-Hawking) de Sitter temperature. $\ln Z$ shows a singular behavior for $T_{\text{sem}} \rightarrow T_s$ which is general for any space-time dimensions D . Again, this is a square root branch point at $T_{\text{sem}} = T_s$. That is, a phase transition takes place for $T_{\text{sem}} \rightarrow T_s$, which implies $M_c \rightarrow m_s$, $L_c \rightarrow \lambda_s$. Furthermore, the high mass behaviour of $\ln Z$ implies that T_{sem} has to be bounded by T_s , ($T_{\text{sem}} < T_s$), which means: $L_c > \lambda_s$; i.e.; $H < c=\lambda_s$. In the de Sitter string phase transition $T_{\text{sem}} \rightarrow T_s$, H reaches a maximum value sustained by the string tension $\frac{0}{H}$ (and the fundamental constants h, c as well):

$$H_s = c \frac{r}{\frac{c}{h}}; \quad \text{i.e.;} \quad s = \frac{1}{2\lambda_s^2} (D-1)(D-2)$$

The highly excited $m \rightarrow M_s$ string gas in de Sitter space undergoes a phase transition at high temperature $T_{\text{sem}} \rightarrow T_s$, into a condensate stringy state. This means that the background itself becomes a string state.

These results also allow to consider the string regimes of a black hole in a de Sitter (or asymptotically) de Sitter background. This allow to study the effects of the cosmological constant on the quantum string emission by black holes, and the string bounds on the semiclassical (Gibbons-Hawking) black hole-de Sitter (bhds) temperature $T_{\text{sem bhds}}$, ref. [7]. We computed the quantum string emission cross section σ_{string} by a black hole in de Sitter (or asymptotically de Sitter) space-time (bhds), ref. [7]. For $T_{\text{sem bhds}} \rightarrow T_s$, (early evaporation stage), it shows the QFT Hawking emission with temperature $T_{\text{sem bhds}}$, (semiclassical regime). For $T_{\text{sem bhds}} \rightarrow T_s$, string exhibits

a phase transition into a string de Sitter state of size $L_s = \sqrt{V_D} = L_{C^*}$, ($\rho_s = \rho_{C^*}$), and string de Sitter temperature T_s . For high masses ($m \gg M_s$), we find for the string leading behavior:

$$\rho_{\text{string}}(T = T_s) = \frac{V_D^{-1} A}{hc} \frac{k_B T_{\text{sem bhdS}}}{1 + \frac{T_{\text{sem bhdS}}}{T_s}}$$

Instead of featuring a single pole singularity in the temperature (Carlitz transition), it features a square root branch point (de Vega-Sanchez transition, refs.[8],[9]). New bounds on the black hole radius r_g emerge in the bhdS string regime: it can become $r_g = L_s/2$, or it can reach a more quantum value, $r_g = 0.365 L_s$, ref. [7].

Semi-classical and quantum (string) black hole regimes: Our analysis of the string canonical partition function, the black hole quantum string emission and the string bounds on the black hole, shows that a semi-classical black hole (BH) with size L_{C^*} , mass M , temperature T_{sem} , density of states ρ_{sem} and entropy S_{sem} , namely $(BH)_{\text{sem}} = (L_{C^*}; M; T_{\text{sem}}; \rho_{\text{sem}}; S_{\text{sem}})$, evolves through evaporation into a quantum string state of size L_s , mass m , temperature T_s , density of states ρ_s and entropy S_s , namely $(BH)_s = (L_s; m; T_s; \rho_s; S_s)$. The quantities in the set $(BH)_{\text{sem}}$ are precisely the semi-classical expressions of the respective ones in the set $(BH)_s$. In the quantum string regime, the black hole size L_{C^*} becomes the string size L_s , the Hawking temperature T_{sem} becomes the string temperature T_s , the black hole entropy S_{sem} becomes the string entropy S_s . The sets $(BH)_s$ and $(BH)_{\text{sem}}$ are the same quantities but in different (quantum and semi-classical/classical) domains. That is, $(BH)_s$ is the quantum dual of the semi-classical set $(BH)_{\text{sem}}$ in the precise sense of the wave-particle (de Broglie) duality. This is the usual classical/quantum duality but in the gravity domain, which is universal, not linked to any symmetry or isometry nor to the number or the kind of space-time dimensions. From the semi-classical and quantum (string) black hole regimes $(BH)_{\text{sem}}$ and $(BH)_s$, we can write the full gravity entropy $S_{\text{sem}}(M; J)$ for the Kerr black hole such that it becomes the string entropy $S_s(m; j)$ in the quantum string regime, namely:

$$S_{\text{sem}}(M; J) = S_{\text{sem}}^{(0)}(M; J) - a k_B \ln \frac{S_{\text{sem}}^{(0)}(J; M)}{k_B} + k_B \ln F(S_{\text{sem}}^{(0)}; J)$$

where $S_{\text{sem}}^{(0)}(M; J)$ is the Kerr black hole Bekenstein-Hawking entropy and

$F(S_{\text{sem}}^{(0)}; J)$ is given by

$$F = \frac{1}{2} \frac{1 + a}{e^{\frac{1}{1+a} \frac{S_{\text{sem}}^{(0)}(M; J)}{k_B}}} \cosh^2 \left(\frac{(1-a) S_{\text{sem}}^{(0)}(M; J)}{2k_B} \right)$$

For $J = 0$: $F = 1$; $S_{\text{sem}}^{(0)}(M; J = 0) = S_{\text{sem}}^{(0)} = 4 k_B \frac{M}{m_{\text{Pl}}}^2$

$S_{\text{sem}}^{(0)}$ being the Schwarzschild black hole Bekenstein-Hawking entropy. is given by :

$$= \frac{S}{1 - \frac{J^2}{h^2} \frac{4 k_B}{S_{\text{sem}}^{(0)}}} = \frac{S}{1 - \frac{J^2}{h^2} \frac{m_{\text{Pl}}^4}{M}} = \frac{S}{1 - \frac{J^2}{h^2} \frac{T_{\text{sem}}^2}{T}}$$

where $T = M^2 = 8 k_B$ and T_{sem} is the Schwarzschild Hawking temperature. m_{Pl} is the Planck mass. Notice the new term $k_B \ln F(S_{\text{sem}}^{(0)}; J)$ in $S_{\text{sem}}(M; J)$ entirely due to $J \neq 0$. For $J \neq 0$, the effect of the angular momentum is to reduce the entropy. $S_{\text{sem}}(M; J)$ is maximal for $J = 0$ (ie, for $a = 1$); for $J = 0$ we have: $S_{\text{sem}}(M) = S_{\text{sem}}^{(0)} - a k_B \ln S_{\text{sem}}^{(0)}$.

$S_{\text{sem}}(M; J)$ provides the full Kerr black hole entropy as a function of the Kerr Bekenstein-Hawking entropy $S_{\text{sem}}^{(0)}(M; J)$. Interestingly enough, the full Kerr black hole entropy $S_{\text{sem}}(M; J)$ can be also written entirely in terms of the Schwarzschild Bekenstein-Hawking entropy $S_{\text{sem}}^{(0)}$, this is done in ref. [6]. For $M \gg m_{\text{Pl}}$ and $J < GM^2 = c$, $S_{\text{sem}}^{(0)}$ is the leading term of this expression, but for high angular momentum, (nearly extremal or extremal case $J = GM^2 = c$), a gravitational phase transition operates and the whole entropy S_{sem} is drastically different from the Bekenstein-Hawking entropy $S_{\text{sem}}^{(0)}$, as we precisely see it below.

A New feature. The Extremal Black Hole Phase Transition: When J reaches its maximal value, that is $J = M^2 G = c^2$, then $a = 0$ and the term $S_{\text{sem}}^{(0)}(M; J)$ is minimal: $S_{\text{sem}}^{(0)}(M; J)_{\text{extremal}} = \frac{1}{2} S_{\text{sem}}^{(0)}$. But for $a \neq 0$, the last term in the expression for $S_{\text{sem}}(M; J)$ subtracts the first one, the poles in cancel out, yielding:

$$S_{\text{sem}}(M; J)_{\text{extremal}} = (a+1) k_B \ln \frac{1}{2} + k_B \ln 2 + \frac{3}{4} S_{\text{sem}}^{(0)} - a k_B + O(a^2)$$

In the extreme limit ($J=h$)! ($M=m_{\text{Pl}}$)²: $S_{\text{sem}}(M; J)_{\text{extremal}} = \frac{1}{2} \left(1 - \frac{J^2}{h^2} \frac{m_{\text{Pl}}^4}{M} \right)$ and $S_{\text{sem}}(M; J)_{\text{extremal}}$ is dominated by

$$S_{\text{sem}}(M; J)_{\text{extremal}} = (a+1) k_B \ln \left(1 - \frac{J^2}{h^2} \frac{t_{\text{Pl}}}{T} \right) + O(1)$$

This shows that a phase transition takes place at $T = (J=\hbar) t_{P1}$, equivalently, at $T = (J=\hbar) T_{sem}$, we call it extremal transition. t_{P1} is the Planck temperature. The characteristic features of this gravitational transition can be discussed on the lines of the extremal string transition we analysed for the extremal string states. Our discussion on the string case translates into the respective black hole quantities but we do not extend on these new features and implications here.

Semi-classical and quantum (string) de Sitter regimes: From the microscopic string density of mass states $\rho_s(m; H)$, we have shown that for $m \ll M_{cl}$, i.e. $T \ll T_s$, the string undergoes a phase transition into a semi-classical phase with mass M_{cl} and temperature T_{sem} . Conversely, from the string canonical partition function in de Sitter space and from the quantum string emission by a black hole in de Sitter space, we have shown that for $T_{sem} \ll T_s$, the semi-classical (Q.F.T.) regime with Hawking-Gibbons temperature T_{sem} undergoes a phase transition into a string phase at the string de Sitter temperature T_s . This means that in the quantum string regime, the semi-classical mass density of states ρ_{sem} and entropy S_{sem} become the string density of states ρ_s and string entropy S_s respectively. Namely, a semi-classical de Sitter state, $(dS)_{sem} = (L_{cl}; M_{cl}; T_{sem}; \rho_{sem}; S_{sem})$, undergoes a phase transition into a quantum string state $(dS)_s = (L_s; m; T_s; \rho_s; S_s)$. The sets $(dS)_s$ and $(dS)_{sem}$ are the same quantities but in different (quantum and semi-classical/classical) regimes. This is the usual classical/quantum duality but in the gravity domain, which is universal, not linked to any symmetry or isometry nor to the number or the kind of dimensions. From the semi-classical and quantum de Sitter regimes $(dS)_{sem}$ and $(dS)_s$, we can write the full de Sitter entropy $S_{sem}(H)$, with quantum corrections included, such that it becomes the de Sitter string entropy $S_s(m; H)$ in the string regime: the full de Sitter entropy $S_{sem}(H)$ is given by

$$S_{sem}(H) = \hat{S}_{sem}^{(0)}(H) - a k_B \ln \left(\frac{\hat{S}_{sem}^{(0)}(H)}{k_B} \right) + k_B \ln F(H)$$

$$\hat{S}_{sem}^{(0)}(H) = \frac{S_{sem}^{(0)}(H)}{f(X)}; F(H) = \frac{f(X)}{f(X)}; a = D; f(X) = \frac{2}{1 + \frac{P}{1 - 4X^2}} = \frac{\sum_{i=1}^v \frac{k_B}{S_{sem}^{(0)}(H)}}{1 - 4X^2}; X(H) = \frac{k_B}{2S_{sem}^{(0)}(H)} = \frac{M_{sem}}{M_{cl}} = \frac{m_{Pl}}{M_{cl}}.$$

$S_{sem}^{(0)}(H)$ is the usual Bekenstein-Hawking entropy of de Sitter space. $M_{cl} = c^2/GH$ is the de Sitter mass scale, $M_{sem} = m_{Pl} = M_{cl}$ is the semi-classical mass.

In this expression, the mass domain is $m_{pl} < M_c < 1$, that is, $0 < X < 1=2$. (ie. $0 < \alpha < 1$). The same formula but with $\hat{X}(H) = S_{sem}^{(0)}(H) = 2 k_B$, instead of $X(H)$, describes $S_{sem}(H)$ in the mass domain $0 < M_{cl} < m_{pl}$. This provides the whole de Sitter entropy $S_{sem}(H)$ as a function of the Bekenstein-Hawking entropy $S_{sem}^{(0)}(H)$.

The limit $X \rightarrow 0$ corresponds to $M_{cl} \rightarrow m_{pl}$, that is $L_c \rightarrow \lambda_{pl}$, (low $H \rightarrow c/\lambda_{pl}$ or low curvature regime). In this limit, $\alpha \rightarrow 1$, $f(X) \rightarrow 1$ and $S_{sem}^{(0)}(H)$ is the leading term of $S_{sem}(H)$, with its logarithmic correction:

$$S_{sem}(H) = S_{sem}^{(0)}(H) - k_B \ln \frac{S_{sem}^{(0)}(H)}{k_B}$$

But for high Hubble constant, $H \rightarrow c/\lambda_{pl}$, (ie. $M_{cl} \rightarrow m_{pl}$), (that is high curvature or quantum gravity regime), $S_{sem}^{(0)}(H)$ is sub-dominant, a gravitational phase transition operates and the whole entropy $S_{sem}(H)$ is drastically different from the Bekenstein-Hawking entropy $S_{sem}^{(0)}(H)$, as we precisely see below.

The de Sitter Gravitational Phase Transition : For $\alpha \rightarrow 0$, that is for $M_c \rightarrow M_{sem}$, the full de Sitter entropy $S_{sem}(H)$ behaves as:

$$S_{sem}(H) \rightarrow 0 = k_B \ln 1 + O(1)$$

In this limit, the Bekenstein-Hawking entropy $S_{sem}^{(0)}(H)$ is sub-leading, $O(1)$, ($S_{sem}^{(0)}(H) \rightarrow 0 = k_B$). In terms of the mass, or temperature:

$$= \frac{S}{1 - \frac{m_{pl}^4}{M_{cl}^4}} = \frac{S}{1 - \frac{T_{sem}^2}{T}}; \quad T = \frac{1}{2 k_B} M_{cl} c^2$$

T_{sem} is the semiclassical (Gibbons-Hawking) de Sitter temperature. In the limit $M_c \rightarrow M_{sem}$, which implies $M_{cl} \rightarrow m_{pl}$, $S_{sem}(H)$ is dominated by

$$S_{sem}(H) \rightarrow 0 = k_B \ln \left(1 - \frac{T_{sem}}{T} \right) + O(1)$$

This shows that a phase transition takes place at $T \rightarrow T_{sem}$. This implies that the transition occurs for $M_{cl} \rightarrow m_{pl}$, ie $T \rightarrow t_{pl}$, (that is for high $H \rightarrow c/\lambda_{pl}$). This is a gravitational like transition, similar to the de Sitter string transition we analysed above: the signature of this transition is the square root branch point behavior at the critical mass (temperature) analogous to the thermally self-gravitating gas behavior of point particles, refs [8],

[9], and to the string gas in de Sitter space, ref.[7]. This is also the same behaviour as that found for the entropy of the Kerr black hole in the high angular momentum $J \rightarrow M^2 G/c$ regime, (extremal transition), ref.[6]. This is universal, in any number of space-time dimensions.
