### BIAS-FREE MEASUREMENT OF GIANT MOLECULAR CLOUD PROPERTIES

# ABSTRACT

We review methods for measuring the sizes, line widths, and lum inosities of giant molecular clouds (GMCs) in molecular-line data cubes with low resolution and sensitivity. We nd that moment m ethods are robust and sensitive | m aking full use of both position and intensity inform ation | and we recommend a standard method to measure the position angle, mapr and minor axis sizes, line width, and lum inosity using moment methods. Without corrections for the elects of beam convolution and sensitivity to GMC properties, the resulting properties may be severely biased. This is particularly true for extragalactic observations, where resolution and sensitivity e ects often bias measured values by 40% orm ore. We correct for nite spatial and spectral resolutions with a simple deconvolution and we correct for sensitivity biases by extrapolating properties of a GMC to those we would expect to m easure with perfect sensitivity (i.e. the 0 K isosurface). The resulting m ethod recovers the properties of a GMC to within 10% over a large range of resolutions and sensitivities, provided the clouds are m arginally resolved with a peak signal-to-noise ratio greater than 10. We note that interferom eters system atically underestim ate cloud properties, particularly the ux from a cloud. The degree of bias depends on the sensitivity of the observations and the (u;v) coverage of the observations. In the Appendix to the paper we present a conservative, new decomposition algorithm for identifying GMCs in molecular-line observations. This algorithm treats the data in physical rather than observational units (i.e. parsecs rather than beam s or arcseconds), does not produce spurious clouds in the presence of noise, and is sensitive to a range of morphologies. As a result, the output of this decomposition should be directly com parable am ong disparate data sets.

### 1. INTRODUCTION

Over the last 15 years, it has become possible to observe molecular emission in nearby galaxies with su cient resolution and sensitivity to distinguish individual giant molecular clouds (GMCs). The immediate goal of such studies is to determ ine whether (and how) the GMCs in other galaxies dier from those seen in the Solar neighborhood. The most common method used to address this question has been to use molecular-line tracers of H<sub>2</sub>, in particular  $^{12}$ CO (1 ! 0), to compare the macroscopic properties (size, line width, and lum inosity) of GMCs in other galaxies to those of M ilky W ay GMCs. Unfortunately, a wide variety of methods have been used to reduce data from spectral line data cubes into macroscopic GMC properties. As a result, many of the di erences between GMC populations found in the literature can be attributed, at least partially, to observational artifacts or m ethodological di erences. It is therefore di cult to assess what the real di erences between GMC populations are based on the reported data in the literature.




Fig. 1. The resolution bias for a model cloud. These two panels show the variations in the measured spatial size (left) and line width (right) as a function of the resolution of a data set. These plots show measurements of G aussian clouds convolved with a G aussian beam and integrated across square velocity channels. M arginally resolved data yields measurements a ected by a signi – cant resolution bias. The spatial size bias is encountered frequently in extragalactic GMC measurements.

For GMCs that are either marginally resolved or marginally detected, observational biases can be severe. Figure 1 shows the variation of the measured spatial size




Fig. 2.| The sensitivity bias for a bright GMC in M 33 (EPRB1 from Rosolow sky et al. 2003). These four panels show the variations in the measured spatial size, line width, and ux of the GMC for a range of sensitivities (signal-to-noise ratios). We simulate the e ect of changing sensitivity by varying the boundary isosurface,  $T_{edge}$ , and measuring properties only from data within this isosurface. All four properties are a strong function of  $T_{edge}$ , so the data display a substantial sensitivity bias. The gray, dashed lines show the extrapolation to the 0 K elvin isosurface using a weighted, least-squares t to each property as a function of  $T_{edge}$ . The extrapolated value is show n as an

and line width with the resolution for a model cloud. Typical Galactic GMCs have sizes of a few 10s of parsecs, com parable to the spatial resolution of m any data sets used to study extragalactic GMCs (e.g. Vogel et al. 1987; W ilson & Scoville 1990; W ilson & Reid 1991; Israelet al. 1993; W ilson & Rudolph 1993; Fukuiet al. 1999; Sheth et al. 2000; Rosolow sky et al. 2003). Figure 1 shows that when the size of the beam is com parable to the size of the object, the measured size is much higher than the true size of the object. M illim eter spectrom eters and correlators often have excellent frequency resolution, so the spectral resolution bias is usually less important for GMC studies, but it can become substantial when data are binned to increase signal-tonoise. Figure 2 shows that the measured spatial size, line width, and ux of a real GMC in M 33 (EPRB1 from Rosolowsky et al. 2003) are all strong functions of the sensitivity of the data. We discuss another major source of bias, the m ethod by which em ission is decom posed into GMCs, in the Appendix.

To place these biases in the the context of realm olecular cloud studies, Figure 3 shows the peak ux and angular size of typical GMCs (those of Solom on et al. 1987) as a function of distance. The sensitivities and resolutions of a representative sam ple of molecular cloud studies have been indicated as horizontal lines in these plots. D istances to commonly observed objects have also been labeled. Figure 3 demonstrates that most studies of extragalactic GMCs are conducted where the clouds

of interest are only m arginally resolved and are found at low sensitivity. Even future observations of GMCs in the Virgo cluster using the Atacam a Large M illimeter A rray (ALMA) will be a ected by resolution and sensitivity biases.

In this paper, we exam ine the e ects of biases stem ming from nite spatial resolution, spectral resolution, and sensitivity in molecular-line observations of GMCs. W e recomm end data analysism ethods to produce a standardized set of observed cloud properties that account for these biases. Most of the methods used in this paper have been adopted piecem eal and ad hoc in previous studies. Here, we endeavor to justify our choice of methodologies and to synthesize various author's techniques for approaching the problem s of m olecular cloud data analysis. In Section 2, we describe a standardized m ethod to measure three basic properties of an emission distribution | size, line width, and ux | while accounting for the sensitivity and resolution of a data set. In Section 3, we discuss how these measurements can be transformed into physical quantities | radius, line width, lum inosity, and implied mass. Finally, we consider the e ects of using interferom eters to derive cloud properties in Section 4. The results in these three sections are applicable to all observations of m olecular clouds. In contrast, the methods used for decomposing emission into molecular clouds vary widely, and there is little basis for favoring one method over another in all cases. Hence, we defer a presentation of our decomposition algorithm to the Appendix of the paper, leaving only a brief discussion of the decomposition problem in Section 5. We conclude the paper by exhibiting several examples of the application of our standardized m ethods to previously observed data and making recommendations for future observations (Section 6).

The methods described in this paper require a computer program to apply. A documented software version of the decomposition and measurement algorithms is available from the authors as an ID L package. This section describes how to derive the spatial size, line width, and ux from a region of emission within a spectral line m ap (a \data cube") while accounting for the nite sensitivity and resolution of the data set. W e use m om ent m ethods (e.g. Solom on et al. 1987), which m ake full use of position and intensity inform ation without assuming a functional form for the cloud. They are therefore robust to pathologies in the data within the cloud.

M om ents are, however, sensitive to the inclusion of false em ission (noise) at the edge of a cloud. Including noise has the e ect of arti cially increasing the values of them om ent. Therefore them ethods outlined here should be em ployed in conjunction with careful signal identi - cation so that the calculations include as little noise as possible. W e assume throughout this section that the algorithm is being applied to a distribution of realem ission that we label a \cloud" (we discuss signal identi cation and decom position in the Appendix).

# 2.1. M om ent M easurem ents of Size, Line W idth, and F lux

This subsection describes how to apply moment methods to derive the size, line width, and ux from a distribution of mission (a \cloud") within a position-position-velocity data cube. The data cube consists of a number of pixels that have sizes of x, y, and v in the two spatial dimensions and the velocity dimension, respectively. The ith pixel in the data cube has positions  $x_i$  and  $y_i$ , velocity  $v_i$ , and brightness temperature  $T_i$ . We assume that the cloud is contiguous and bordered by an isosurface in brightness temperature of value  $T_{edge}$ , so that all of the pixels in the cloud have  $T > T_{edge}$  and the pixels outside the cloud have  $T < T_{edge}$ .

W e begin by rotating the spatial axes so that the x and y axes align with the m a pr and m inor axis of the cloud, respectively. W e determ ine the orientation of the m a pr axis using principal component analysis. We nd the eigenvectors of the intensity-weighted covariance m atrix for the cloud,

In the equations above the sum i runs over all pixels within the cloud and x and y are the intensity weighted m ean positions within the cloud (de ned below). We de ne the new x axis to lie along the eigenvector with the largest eigenvalue | them a praxis of the cloud. The y axis lies perpendicular to the x axis along the m inor axis of the cloud. In the discussion below, x refers to position along the m a praxis and y refers to position along the m inor axis. Rotating the axes in this m anner yields inform ation about the axis ratio of the cloud and allows a m ore careful deconvolution. This m ethod for determ ining the position angle of m olecular clouds has also been adopted by K oda et al. (2005).

To measure of the size of the cloud, we compute the geometric mean of the second spatial moments along the major and minor axis. This is r, the root-mean-squared (RM S) spatial size:

where  $_{m aj}$  ( $T_{edge}$ ) and  $_{m in}$  ( $T_{edge}$ ) are the RMS sizes (second moments) of the intensity distribution along the two spatial dimensions. We adopt this particular functional form since it has been used in previous observational studies (Solom on et al. 1987) and explored in depth by Bertoldi & McKee (1992) with respect to inclination, aspect ratio, and virialization. We calculate  $_{m aj}$  ( $T_{edge}$ ) and  $_{m in}$  ( $T_{edge}$ ) by:

In the equations above the sum  $\lim_{i}^{L} \sum_{i}^{cloud} xuns over all pix$ els within the cloud. We have written each of the mo $ments as a function of <math>T_{edge}$  because changing the isosurface that de ness the boundary of the cloud ( $T_{edge}$ ) will change the set of pixels included in the sum and therefore

the values of the moments. Note that  $_{r}$  is not the RMS distance (d =  $\frac{x^{2} + y^{2}}{x^{2} + y^{2}}$ ) from the center of the cloud. Rather it is the analogous to the RMS size of the cloud along an arbitrarily chosen axis. Thus,  $_{r} = _{x} = _{y}$  for a perfectly round cloud, while the RMS distance from the center for such a distribution is larger,  $_{d} = \frac{2}{2} x > x$ . A lso note that  $_{m aj} = _{m in}$  is the axis ratio of the cloud and will be 1 for round clouds and 1 for elongated or lamentary clouds.

W e calculate the velocity dispersion,  $~_{\rm v}$  (T $_{\rm edge}) in the same m anner as the size:$

The sums again run over all emission in the cloud. For a Gaussian line pro le, such as that found for most clouds, the full-width half-maximum (FW HM) line width, V ( $T_{edge}$ ) will be related to  $_{v}$  ( $T_{edge}$ ) by

Finally, we calculate the ux of the cloud,  $F_{CO}$  ( $T_{edge}$ ) using the zeroth moment:


If x and y are in units of arcseconds, v in km  $s^1$ , and  $T_i$  in K, then the resulting ux will have units of K km  $s^1$  arcsecond<sup>2</sup>.

## 2.2. Correcting for the Sensitivity B ias

The sensitivity of a dataset in uences the cloud properties derived from that data, a fact that we have em phasized in the previous section by explicitly writing the m om ents as functions of T<sub>edge</sub>, the cloud boundary (usually set by the signal-to-noise ratio of the data). Figure 2 shows the variation of spatial size, line width, and ux as a function of sensitivity for a bright cloud in M 33. The data for this cloud shows a substantial sensitivity bias; all of the derived properties are strong functions of the boundary isosurface (T<sub>edge</sub>). In order to com pare data sets with di erent sensitivities, one must account for this bias. In this section we describe a method to do this by extrapolating the measured properties of a cloud maj ( $T_{edge}$ ), min ( $T_{edge}$ ), v ( $T_{edge}$ ), and  $F_{CO}$  ( $T_{edge}$ ) to those we would expect to measure for a cloud within a boundary isosurface of  $T_{edge} = 0$  K elvin (i.e., perfect sensitivity).

W e estim ate the values of the m om ents at  $T_{edge} = 0$  K by extrapolating from higher values of  $T_{edge}$ . This technique was originally suggested for inferring total cloud areas by B litz & Thaddeus (1980) and applied to molecular cloud properties by Scoville et al. (1987). We calculate each of the m om ents for a sam ple of boundary tem peratures,  $T_{edge}$ , ranging from near the peak tem perature of the cloud to the lowest boundaries allowed by the data. Thus, we measure the variations of the m om ents as a function of the boundary tem perature,  $T_{edge}$ , within the cloud (this is how we constructed the plot shown in Figure 2). Below, we assume that we have measured each of the four moments for values of  $T_{edge}$  ranging from  $T_{m in}$  (them inimum allowed by the data, that is the sensitivity lim it) to  $T_{m ax}$  (near the peak tem perature of the cloud).

W e estim ate the value of the m om ents at  $T_{edge} = 0 K$ 






Fig. 4.] The recovered ux as a function of sensitivity,  $T_{peak}=T_{edge}$ . The three lines show the fraction of the total ux m easured for a Gaussian cloud using no sensitivity correction (dashed line), a linear extrapolation to perfect sensitivity (gray line), and a quadratic extrapolation (black line). The quadratic extrapolation does an excellent job of recovering the correct value of the ux down to low sensitivities. The uncorrected sum and the ux corrected by a linear extrapolation both show a substantial sensitivity bias.

by performing a weighted, linear least-squares t to the measured moments. As an example, we consider  $_{m \ aj}$  (T<sub>edge</sub>). The data are modeled as

and the t determines the extrapolated moment, maj (0 K). For the t, each pair of data  $fT_{edge}$ ; maj  $(T_{edge})g$  is assigned a weight proportional to the number of data in the cloud with  $T > T_{edge}$ so that measurements of the moment using more data are weighted m ore heavily. Practically, this m eans that points to the left in Figure 2 have higher weights than those to the right. We use this linear extrapolation for  $m_{aj}$ ,  $m_{in}$ , and v, but we nd that a quadratic extrapolation (including a  $T_{edge}^2$  term ) gives better results for the zeroth m om ent,  $F_{\rm C\,O}$  (though we revert to a linear extrapolation when the extrapolated ux is lower than the measured ux). We plot the ux of a Gaussian cloud as a function of T<sub>edge</sub> in Figure 4 for an uncorrected zeroth m om ent and the linear and quadratic extrapolations to illustrate the appropriateness of the quadratic t to the zeroth m om ent. At very low sensitivities (signal-to-noise ratios near unity), the quadratic extrapolation is very noisy, but for signal-to-noise ratios of 2 or better it does a dram atically better job of recovering the true ux of the cloud ( $F = F_0 = 1$ ) than either the linear extrapolation or no extrapolation.

Figure 2 also shows these extrapolations for a bright cloud in M 33. The result of this extrapolation is a set of four moments  $|_{m aj}(0 \text{ K}), _{m in}(0 \text{ K}), _{v}(0 \text{ K}),$ and  $F_{CO}(0 \text{ K}) |$  that correspond to those we would expect to measure given in nite sensitivity. The values of these moments should be directly comparable even among datasets with di erent sensitivities (values ofT<sub>m in</sub>).

Note that di use em ission surrounding a GMC may confuse this method. If one data set is measured with sensitivity su cient to detect di use em ission surrounding a GMC, while another lacks the sensitivity to do so then this approach may not be su cient to correct for the sensitivity bias. This problem may be particularly acute when comparing Galactic GMCs observed with very good sensitivity to extragalactic clouds with worse signal-to-noise ratios. Interferom etric data \resolves out" em ission signi cantly more extended than the synthesized beam (see x4), representing another bias against detecting di use em ission. Polk et al. (1988), Blitz (1985), Rosolowsky et al. (2003), and Leroy et al. (2005) nd evidence for di use em ission surrounding GMCs in the Milky W ay and the Local G roup G alaxies M 31, M 33, and IC 10, respectively.

## 2.3. Correcting for the Resolution B ias

A ny astronom ical data set represents the convolution of the intensity of the source with the pro le of the instrument used to observe it. Care must therefore be taken in measuring sizes and line widths when the extent of the intensity distribution is comparable to the instrumental pro le. In a typical spectral line data cube two pro les are important: the spatial beam and the width of a velocity channel. In this section, we describe simple corrections to account for the e ects of nite spatial and spectral resolution.

We \deconvolve" the spatial beam from the measured cloud size by subtracting the RMS beam size,  $_{\text{beam}}$ , from the extrapolated spatial moments,  $_{\text{maj}}(T_{\text{edge}} = 0 \text{ K})$ , and  $_{\text{min}}(T_{\text{edge}} = 0 \text{ K})$ , in quadrature | an approach that is exact for G aussians. The deconvolved second moment is given by:

where  $m_{aj}$  (0 K) and  $m_{in}$  (0 K) are extrapolated to the 0 K elvin isosurface as described in x2.2. This extrapolation is necessary to make this deconvolution valid: subtracting the full beam from the spatialm om ent measured for only part of the cloud will lead to an overcorrection and thus to an underestimate of the cloud size. Measuring the spatial size along the minor axis is also necessary to ensure that the cloud is indeed resolved in all dimensions. This is an advantage of the choice of axes (major/minor) described above. With su cient signal-to-noise, this method of deconvolution provides a robust measurement of cloud size even for marginally resolved clouds.

Instrum ental resolution also a ects the measured line width. Spectrom eters measure the average intensity across a channel, rather than sam pling the intensity at the center (nom inal frequency) of that channel. W hen the width of the spectral line under consideration is com parable to the bandwidth of a single channel, the line strength varies signi cantly across an individual channel. In this case, the average value may di er substantially from the value at line center. The output of the spectrom eter is thus a convolution of the true spectral pro le with the pro le of an individual channel. W e account for this potential bias tow ards higher line widths by a simple deconvolution of the channel width from the extrapolated second m om ent:

where  $_v$  (0 K) is the second m om ent of the cloud in the v dimension extrapolated to 0 K elvin as described in x2.2 and V <sub>chan</sub> is the width of a velocity resolution element. A lthough the channel pro les are usually square in shape and not G aussian, we sim plify the deconvolution by approximating the channel shape as a G aussian with integrated area equal to that of a square channel with width V <sub>chan</sub>. For such a G aussian, <sub>chan</sub> = V <sub>chan</sub> =  $\frac{1}{2}$ .

# 2.4. Comparison with O ther M ethods

W e use extrapolated m om ents to m easure GM C properties rather than em ploying an established m ethod from the literature. In this section, we justify our choice by com paring several m ethods of m easuring GM C properties. W e focus on the perform ance of these m ethods at m arginal resolution and low signal-to-noise, conditions typical of extragalactic GM C observations.

D eterm ining the radius of a cloud is particularly di cult because GMCs are often asymmetrical with poorly de ned boundaries. Several authors have devised methods to return a single characteristic size for complicated emission distributions. The intensity-weighted second moments in the spatial directions have been used in many studies (e.g. Solom on et al. 1987), but are sensitive to both noise and convolution e ects. The other commonly used method (e.g. Williams et al. 1994; Heyer et al. 2001) is to infer the radius based on the area of the cloud:

$$R_e = \frac{A A_{pt}}{A}$$

Here  $A_{pt}$  is the area of a point source that has been convolved with a beam and measured with the same signal-to-noise as the emission in the map. Finally, W ilson & Scoville (1990) and Taylor et al. (1999) adopted the size of the cloud as the mean of the deconvolved FW HM s of the emission distribution along two perpendicular directions.





Fig. 5.| The recovered radius as a function of sensitivity ( $T_{m ax} = _{RM S}$ ) and resolution ( $_{0} = _{beam}$ ). The four panels show the radius recovered by (a) the extrapolated moment method (this paper), (b) the uncorrected moment method, (c) the area method, and (d) the FW HM method. The hashed region indicates the where each algorithm obtains a result within 10% of the original value. The extrapolated moment accurately recovers the radius over a large zone of parameter space. Of particular importance for extragalactic measurements, it performs better at low signal-to-noise than the other three methods.

W e com pare these three m ethods to the extrapolated m om ent m ethod presented above across a range of resolutions and sensitivities. W em easure the size of a G alactic GMC using each method after convolving it to a desired resolution and adding noise to produce a particular signal-to-noise ratio. For the data, we use the <sup>12</sup>CO data from the Rosette molecular cloud (Blitz & Stark 1986), which we clip at 2 RMS (the RMS noise in the original data set) and integrate in the velocity dimension to produce a map of integrated intensity. For a range of sensitivities and resolutions, we convolve this map with a Gaussian beam and add noise. W e measure the size of the cloud in 100 realizations of the noise for each such fresolution, sensitivity gpair using (a) the extrapolated m om ent m ethod, (b) the m om ent of the data w ithout extrapolation, (c) the area method and (d) the FW HM method. W herever possible we corrected for the e ects of beam convolution and signal-to-noise for each of the methods. The results of the analysis are shown in Figure 5.

Figure 5 shows the recovered radius as a function of resolution and sensitivity, with the \true" radius de ned as that measured at very high sensitivity and very good resolution (i.e. in the original data, the top right corner of each plot). The hashed region of parameter space shows the range of parameters over which each algorithm recovers a radius within 10% of the true value. The extrapolated moment method has the largest hashed region and so is remarkably robust, recovering the true radius over a large range of sensitivities and resolutions. Only at low sensitivity ( $T_{max} = RM_S < 5$ ) and marginal resolution (  $_{\text{beam}}$  &  $_{0}$ ), does the derived radii depart system atically from the true radius. Notably, the extrapolated second m om ent perform s quite w ell at signalto-noise ratios from 5 to 10 (in the integrated intensity map), values typical of extragalactic CO data sets. By contrast, the uncorrected m om ent m ethod (panel b in Figure 5) underestimates the size at low signal-to-noise since (by construction) the uncorrected m om ent does not account for emission below the noise level. Similarly, the area m ethod (panel c) shows system atic variation at both low signal-to-noise (where em ission drops below the noise level) and low resolution (where the convolved area of the emission distribution grows disproportionately because of the lam entary nature of the cloud). Finally, the FW HM method (paneld) shows large system atic variations since it depends only on the location of the FW HM contour and not on the rem ainder of the em ission distribution.

The region of system atic underestim ation at low signalto-noise but reasonable resolution shows the e ects of m issing the di use emission mentioned in x2.2. The Rosette includes more CO emission at low intensities than the extrapolated moment predicts from the high intensity data. As a result, when that di use emission is not included in the measurement, the algorithm underestim ates the true radius of the GMC. This e ect is seen panels (a) and (b) | the extrapolated and uncorrected second moments | and ism ore pronounced in the uncorrected second moment, panel (b).




Fig. 6. The measured line width as a function of sensitivity ( $T_{m ax} = _{RM S}$ ) and spectral resolution ( $V_{FWHM} = V_{chan}$ ). The three panels show the line width of a Gaussian with known properties measured using (a) the extrapolated moment method (this paper), (b) an uncorrected second moment and (c) a Gaussian to the resulting spectrum. The hashed region indicates the zone of parameter space where each algorithm measures a line width within 10% of the actual value. The extrapolated moment provides a good measurement of the line width, remaining comparable to a direct t even in the line if of low signal-to-noise and spectral resolution. Because the Gaussian t is provides poor results for non-Gaussian line proles, we prefer the extrapolated moment method.

We perform a similar experiment on recovering the line width of an emission line in noisy data. We measure the recovered line width of a Gaussian line of known width using three m ethods (a) the extrapolated m om ent method (b) an uncorrected second moment and (c) a Gaussian t to the line. For a range of signal-to-noise levels ( $T_{m ax} = RM S$ ) and channelwidths  $V_{chan}$  we measure the recovered line width relative to the known line width. The mean values of the recovered line for 1000 realizations of the noise are plotted in Figure 6. The extrapolated m om ent does not show the system atic variation with signal-to-noise seen in the uncorrected moment. The extrapolated moment is nearly as robust a m easure as the G aussian t for a perfectly G aussian line and will prove superior if the line is not Gaussian. Robust recovery of the line width using any method requires  $V_{line} = V_{chan} > 2.$ 

### 2.5. A ssessing Errors in GMC Properties

The form al uncertainty associated with each moment measurement is quite small. C loud identication and extrapolation represent larger sources of uncertainty, but their e ects are dicult to assess formally. We use bootstrapping methods to estimate the uncertainties in

our m easurem ents of cloud properties. The bootstrapping m ethod determ ines errors by generating several trial clouds from the original cloud data. A trial cloud is generated by considering the cloud to be a collection of data  $fx_i; y_i; v_i; T_ig$  for i = 1 ::: N, the number of points in the cloud. The data are sampled for N random values of i, allowing for i to be repeated. The properties of the cloud are measured for each trial cloud. We estimate the uncertainty from the variance of the cloud properties derived from these resampled and rem easured data sets. The naluncertainty in each property is the standard deviation of the bootstrapped values scaled up by the square root of the oversam pling rate. The oversam pling rate, which is usually equal to the number of pixels per beam, accounts for the fact that not all of the data in each cloud are independent. For many interferom etric data sets this is an important e ect, since these data can have 10 orm ore pixels per beam .

W e com pare the uncertainties produced by the boot-

strapping to those derived from repeatedly adding noise to and then reanalyzing a data set. We use the bright cloud in M 33 shown in Figure 2. We conduct 100 realizations of the data plus random noise. The resulting uncertainties in maj, min, v, and the ux are 3%, 2%, 3%, and 3%. Repeatedly bootstrapping the same data set (adjusted to have the same nal noise level) yields average uncertainties of 9%, 9%, 11%, and 5%. The bootstrapping estim ates are higher for this bright cloud because they re ect both the form aluncertainty and the robustness of the result to the rem ovalof a given piece of data. In the low signal-to-noise regime, the values for the twom ethods converge as noise dom inates the uncertainty derived from bootstrapping | for example, performing the same experiment in a dimmer M 33 cloud with 1=4 the lum inosity of the bright cloud and com parable noise, bootstrapping yields errors of 31%, 33%, 32%, and 35% in the fourm om ents while repeated realizations produces scatters of 15% , 27% , 30% , and 40% .

The bootstrapping m ethod produces a robust, believable estim ate of the uncertainty in the m easurem ent of the properties of a particular, de ned cloud. It does not account for uncertainties in the assignment of em ission to a cloud either as a result of noise or choice of algorithm. These uncertainties are m ore system atic than random in nature and m ay be best assessed by analyzing the em ission distribution using several m ethods. The bootstrapping estimate m ay be treated as an accurate estimate of the uncertainties in the results given that one adopts the m ethods presented in this paper.

# 3. DER IV ING PHYSICAL QUANTITIES FROM MOMENT MEASUREMENTS

In this section, we outline how to use the measured size, line width, and ux to calculate several physical quantities of interest: the e ective spherical radius, the virial mass, and the lum inous mass. Throughout this section we assume that clouds can be described as self-gravitating spheres with density pro les  $/ r^{1}$  and negligible support from magnetic elds or con nement by external pressure.

W e assume below that the data consists of observations of the  $^{12}$ CO (1 ! 0) transition, in units of brightness tem perature, but the method is readily adaptable to analogous data sets.

#### 3.1. The Spherical Radius

We de ne a factor that relates the one-dimensional RMS size,  $_{\rm r}$ , to the radius of a spherical cloud R : R =

For a cloud with = 1, =  ${}^{p}\overline{6}$ , som ewhat higher than the empirical correction of 3.4= derived by Solom on et al. (1987). The di erence arises, in part, from using  ${}^{12}CO$  as a density tracer. Since  ${}^{12}CO$  em ission saturates in dense regions and vanishes from low density regions, the apparent density pro le in  ${}^{12}CO$  is shallower than the true density pro le. Hence, an appropriate value of

likely falls in the range between  $3.4=^{r}$  and r 6. For tracers like <sup>13</sup>CO with higher critical densities, a di erent value of may be appropriate. Since comparison to this \anchoring" data set may be more important than adopting a self-consistent | but grossly oversimplied | model for a cloud, we recommend the Solom on et al. (1987) de nition of the cloud radius, R 1:91 r. Note, that adjusting the de nition of the radius renders the virialm ass form ula we present below inexact.

# 32. The Spatial Size, Line W idth, Lum inosity, and M ass

W e convert the cloud properties  $_{r}$  (0 K),  $_{v}$  (0 K), and  $F_{CO}$  (0 K) to the physical quantities R, V, and L  $_{CO}$ . For a cloud at a distance of d (in parsecs), the physical radius will be

A particular CO luminosity,  $\rm L_{CO}$  , implies a mass of molecular gas, M  $_{\rm Lum}$  , of

where X $_{\rm CO}$  is the assumed CO-to-H $_2$  conversion factor. This calculation includes a factor of 1.36 (by mass) to account for the presence of helium . Including helium is in portant to facilitate comparison with the virial mass, which should re ect all of the gravitating mass in the cloud. We have adopted a ducial value of the CO-to-H $_2$  conversion factor of X $_{\rm CO}$  = 2  $10^{20}$  cm  $^2$  (K km s $^1$ ) $^1$  and express changes relative to this value in term s of the parameter X $_2$ .

#### 3.3. The Virial Mass

W e compute the virial masses under the assumption that each cloud is spherical and virialized with a density prole described by a truncated power law of the form

/ r with no magnetic support or pressure con nement. As with the spherical radius correction, the exact density pro le of the cloud will a ect the correct form of the virial theorem mass. For = 1, the virial mass is given by the form ula (Solom on et al. 1987):

where V is the FW HM velocity line width in km s  $^1$  , R is the radius in pc, and the cloud has a density pro le of  $/\ r$  .

C buds exhibit a range of non-spherical geom etries and m ay be supported by m agnetic elds or con ned by pressure. Therefore, the studying the virial param eter m ay be m ore useful than the virial m ass itself. The virial param eter is a constant of order unity that characterizes deviations from the virial theorem applied to a nonm agnetic cloud with no external pressure and constant density. Following M cK ee & Zweibel (1992), we de ne the virial param eter as

Larger-than-unity virial param eters can result from pressure con nem ent, while < 1 m ay result from signi cant m agnetic support. Incorrect values of the CO -to-H<sub>2</sub> conversion factor m ay skew the result in either direction. Finding < 2 m eans that the clouds are gravitationally bound in the absence of signi cant m agnetic support.

#### 4. M EASURING CLOUD PROPERTIES FROM INTERFEROMETER OBSERVATIONS

M illim eter-wave interferom eters are required to resolve even the most massive molecular clouds in galaxies beyond the Magellanic clouds (see Figure 3). Unfortunately, interferom eters are not sensitive to spatial frequencies outside the limited region of the (u;v) plane that they sam ple. P ractically, this means interferom eters do not measure the total ux from the emission distribution; and structures are resolved out, usually on large angular scales that correspond to small separations in the (u;v) plane. Ideally, interferom eter observations are combined with single-dish observations that supply the m issing information. In practice such observations are conducted infrequently and the unknown total ux and short-spacing information is estimated using deconvolution algorithms such as CLEAN or maximum entropy (see Thom pson et al. 2001, and references therein).

Sheth et al. (2000) simulate the results of using only an interferom eter to observe G a lactic GMC s as if these wellstudied clouds were located in M 31. They nd that interferom eters experience signi cant (50%) ux loss for their simulated observation, primarily from extended em ission around clouds. However, they nd that the ux loss does not change the size and line width of the cloud. Helfer et al. (2002) exam ine the recovery of large-scale ux distributions from interferom eter measurements in m ore depth and explore the e ectiveness of deconvolution algorithms at low signal-to-noise. They nd that deconvolution algorithms recover ux nonlinearly at low sensitivities, nding much less ux at low sensitivities than one would expect. Since much of the data on extragalactic GMCs have low signal-to-noise, this may represent an important bias.

We assess the e ects of interferom etric biases on the methods presented here by extending the method of Sheth et al. (2000). We use  $^{12}CO$  observations of three galactic GMCs: the Orion molecular com – plex (W ilson et al. 2005), the Rosette Molecular C loud (B litz & Stark 1986), and an excerpt from the Outer Galaxy Survey of Heyer et al. (2001) which contains the molecular clouds associated with the W 3/W 4/W 5 H II regions<sup>2</sup>. We simulate observing these three molecular com plexes in M 31 (D = 770 kpc) with the BIM A interferom eter.

W e Fourier transform each plane of each data set into the (u;v) dom ain and resam ple the data along the (u;v) tracks that would be sam pled by B IM A observations of the data provided the GMCs were in M 31. The (u;v) coverage re ects typical observing strategies for extragalactic clouds, such as interleaving observations of the source with calibrators and other sources. W e add therm alnoise and phase noise to the (u;v) data, including a phase noise component with a magnitude that depends

on the length of the baseline. We adjust the scale of the therm aland phase noise to produce the desired peak signal-to-noise (we nd our results depend only weakly on whether the noise is therm alorphase). We invert the resulting (u;v) data using the M IR IAD software package (Sault et al. 1995) producing maps separated by 2 km s<sup>1</sup>, and then we deconvolve the dirty maps using a CLEAN algorithm that term inates at the 2 <sub>RM S</sub> level. For each trial cloud, we then calculate the cloud properties using the m ethods of xx2 and 3.

For comparison, we compute cloud properties using the same procedure to simulate single-dish observations with signal-to-noise and e ective resolution identical to the mock interferom eter data. We generate the mock single-dish observations by sam pling the transform ed im age data for an equal num ber of (u;v) points as the interferom eter data, but the points are norm ally distributed in the (u;v) plane and one point is forced to lie at (0;0)thus sam pling the total power. The width of the (u;v) point distribution is chosen to give a beam size similar to that of the mock interferom eter data. Random therm al and phase noise is added to these data in the same fashion as for the interferom eter data. Then the data are inverted using natural weighting and deconvolved in the exact same fashion as the interferom eter data (though the deconvolution step has little e ect). Again, we extract cloud properties using the m ethods of xx2 and 3.

W ith these simulations, we compare the cloud properties derived from interferom eter data to single-dish data that are equivalent in every other fashion, thereby isolating the e ects of interferom eters on the derived properties. The additional biases in posed by limited resolution and sensitivity are discussed separately in x2.4. Here we focus on mock BIMA observations of the three molecular com plexes using three antenna con gurations: the C array (extended), the D (com pact) array, and a com bination of C and D array (see W right 1996, for details on the con gurations). The synthesized beam sizes for these con gurations are  $14:4^{\circ\circ}$ ,  $6:1^{\circ\circ}$  and  $8:8^{\circ\circ}$  for the D, C and C + D hybrid array observations respectively, corresponding in turn to 54, 22 and 33 parsecs at 770 kpc. W e conduct 10 sample observations for each cloud in each array at a range of sensitivities ranging from  $T_{peak} = RM S = 3$ to > 100.




Fig. 7.| The elects of interferom eter observations on the measurement of cloud properties. Each panel shows the variation of cloud properties as a function of signal-to-noise for interferom eter observations. The value of each property (lum inosity, line width, radius) is normalized by the value that is measured for single dish observations at the same resolution and sensitivity as that of the interferom eter. The Figure shows the behavior of cloud properties for simulated BIM A observations of the O rion molecular complex as if the clouds were located in M 31. No D-array curve is plotted for radius measurements since O rion would be unresolved in M 31. The recovery of cloud properties is a function of both sensitivity and the (u;v) coverage of the interferom eter.

Figure 7 shows the properties recovered by mock observations of the O rion m olecular com plex for each array and a range of sensitivities. The values of each properties are normalized by the value recovered by mock singledish observations at the sam e sensitivity and resolution. Thus, the only di erence between the four sets of properties (C, D, C + D, and single dish) is the (u;v) coverage of the simulated observations. We nd that the derived properties from mock single-dish observations follow the same behavior as the simulations in x2.4. Thus, it is possible to decouple the two sets of biases { those arising from marginal resolution and sensitivity and those arising from using interferom eters { and exam ine only the latter. We plot the results for 0 rion because these observations show the most dram atic variation of the three com plexes studied, but the results are qualitatively the same for all three data sets. O rion is the most sensitive of the three to spatial Itering because it consists of three GMCs and therefore showsmore structure than the other two targets.

Based on the results of the mock observations, we make the following comments regarding the use of interferom – eter data alone in measuring cloud properties. Most of these points can be seen visually in Figure 7.

- 1. Cloud properties measured from interferom etric data are biased. The degree of bias is a ected by the sensitivity of the array as well as the (u;v) coverage of the observations.
- 2. A m inim um signal-to-noise of 10 is required for stable recovery of cloud properties. Below this level, errors in cloud properties, can approach 100% for interferom eter data.
- 3. Even for intermediate signal-to-noise values  $(T_{peak} = _{RM S} = 10)$  there are signi cant system atic e ects on the cloud properties. The most extreme e ects are on the lum inosity measurement, which can be 40% lower than a single-dish observation. This e ect is much less pronounced form easurements of the line width and the radius, which show . 10% variations. This result, that the radius and line width are relatively robust to the spatial ltering of the interferom eter, con ms the qualitative results of Sheth et al. (2000). The values of derived properties are always underestim ated relative to single-dish observations.
- 4. Even at high sensitivities, the spatial ltering of interferom eters a ects property recovery at the 10% level. For example, C-array observations of O rion system atically underestim ate the radius of the cloud by 10% even for very high signal to noise ratios and D-array observations underestim ate the ux of the O rion by 5% even at high sensitivity.
- 5. For interferom eter observations, the dynamical m assmeasurem ents of GMC s are more robust than the lum inosity m easurem ents. This behavior will bias interpretations of the virial parameter in extragalactic observations. Estimates of the CO-to- $H_2$  conversion factor based on the assumption that GMC s are bound or virialized are likely to overestimate X<sub>CO</sub>.
- 6. For a given signal-to-noise value, observations with the widest range of (u;v) coverage provide them ost robust m easurem ent of cloud properties. Thus, in achieving a given sensitivity, observers should favor arrays with m ore antennae or observations m ade in m ultiple con gurations.

### 5. A NOTE ON DECOMPOSITION

The choice of how to decom pose an emission distribution into individual clouds may be the most important source of bias in GMC property measurements. Many di erent methods have been applied to identify GMCs in blended emission, the most prevalent being decom position by eye and the application of the GAUSSCLUM PS (Stutzki& Gusten 1990) or the CLUM PF IND algorithm (W illiam set al. 1994). When comparing GMCs between two data sets, care must be taken to decom pose emission in a consistent way across both data sets, preferably using the same algorithm on both data sets. Furtherm ore,

the physical values of any tuning parameters in the algorithm s should be matched where possible so that both algorithm s search for peaks in the emission over the same spatial scale (rather than angular or resolution-units) or intensity range. This will avoid, for example, comparing \clumps" in a Galactic molecular cloud to GMCs in another galaxy. A more extreme method to ensure accurate comparison is to convolve the higher (spatial) resolution data set to the spatial resolution of the other data (e.g. Sheth et al. 2000). However, this approach clearly sacri ces accuracy of the derived parameters to allow a more careful comparison between two data sets.

In the Appendix to this paper we present a robust, conservative, new decom position algorithm. This algorithm is designed to avoid creating spurious clouds from noise and to remain sensitive to non-Gaussian structures in the data. Additionally, the parameters of the algorithm are xed to physical values rather than being determ ined by the data. This algorithm is designed explicitly with the goal of decomposing emission into GMCs (rather than clum ps or other structures) with extragalactic data in m ind. The m ethods for m easurem ent of cloud properties including the sensitivity and resoludescribed above tion corrections | are independent of the decom position algorithm and are important no matter what decomposition algorithm is chosen. In order to avoid confusion between these two separate problem s, we choose to describe the decomposition algorithm in the Appendix.

### 6. DISCUSSION AND CONCLUSIONS

W e conclude the paper by applying these m ethods to m olecular line data sets that have been previously published. In future studies, the algorithm will be used to evaluate the di erences between GMC populations between galaxies. Here, we sim ply present an analysis designed to dem onstrate the m ethod's utility. W e present them edian corrections found for a large set of extragalactic (Local G roup) observations and a test application of our m ethods to G alactic data. W e use all the m ethods discussed in the previous sections and the decom position algorithm discussed in the Appendix.

#### 6.1. The E ects of Extrapolation and Deconvolution

W eapply them ethods outlined here to an array of data from across the LocalG roup and measure the properties of 110 spatially resolved clouds to estim ate the typical magnitude of the sensitivity and resolution corrections for extragalactic data. We use BIMA data on M 33 and M 31 (Rosolowsky et al. 2003; Rosolowsky 2005); NANTEN observations of the LMC (Fukuiet al. 1999); OVRO observations of IC 10 (W alter 2005); and a SEST map of N 83 in the SMC (Bolatto et al. 2003). Table 1 shows the number of clouds measured in each galaxy along with the median sensitivity and resolution corrections applied to the radius, line width, and ux. For com parison, we also measure the properties of a num ber of clouds in the outer Galaxy (Quadrant 2, see below) from the Dame et al. (2001) CO survey of the Milky W ay. Table 1 includes all spatially resolved clouds with masses (derived from the CO lum inosity) of 5 10<sup>#</sup> M orm ore (92 of the 110 extragalactic clouds are above this m ass).

The numbers quoted in Table 1 are correction factors,"




Table 1 shows that throughout the LocalG roup data the corrections suggested in this paper have m agnitudes of a few tens of percent. W e draw several conclusions based on these data:

1. Resolution e ects on the size of clouds tend to be signi cant | we would overestim ate cloud sizes by

40% if we did not apply a deconvolution. In the M ilky W ay data, this e ect is much less severe. The sizes of M ilky W ay clouds are measured to within 5% before the resolution correction. Unresolved clouds do not contribute to Table 1, so if the e ects of the resolution bias were com pletely neglected this would be much larger (a naive approach would measure these clouds to have the size of the spatial beam ).

- 2. Resolution e ects on the line width are negligible throughout the LocalG roup data.
- 3. Sensitivity e ects are also signi cant. W ithout a correction for the sensitivity bias, the size, line width, and lum inosity of clouds would all be signi cantly underestim ated. This sensitivity bias is least severe | only about 20 { 30% | for the line width, and most signi cant (and variable) for the lum inosity. Sensitivity corrections to the lum inosity vary from 20% to more than 100%.
- 4. The resolution and sensitivity biases for the size m easurem ent tend to cancel out, so that the completely uncorrected radius m easurem ent is offen within 10 { 20% of the corrected value. This is a happy coincidence of resolution and sensitivity within the Local G roup, not evidence that sensitivity and resolution corrections are unim portant.
- 5. The magnitude of corrections across the Local G roup data are fairly uniform. This is because G M C s near the resolution lim it tend to outnum ber higher m ass G M C s. U nresolved G M C s are not included in the analysis, so the median cloud through all the data sets appears marginally resolved.
- 6. In order to com pare extragalactic data to G alactic data (with very good sensitivity and resolution and therefore sm all corrections) it is crucial to correct for the sensitivity and resolution biases.

#### 62. Analysis of Second Quadrant CO Data

The m ethod described in this paper has been designed with extragalactic data in m ind. However, a crucial step in interpreting extragalactic m easurements is to make a fair comparison with Galactic data. In this section we report some results of applying our decomposition and m easurement algorithms to the survey of the second Galactic quadrant by Dame et al. (2001). We compare the results of this analysis to the results by Heyer et al. (2001) and show that our analysis recovers results that are consistent with theirs.

We decompose and analyze  $^{12}$ CO (1 ! 0) from the second quadrant (Survey 17 in Table 1 ofD am e et al.2001). The data set covers the Galactic plane from ` = 70 to ` = 210 with a noise level of 0.3 K.We measure the distance to the molecular emission using the kinematic distances by adopting a at rotation curve with  $_{\rm LSR}$  = 220 km s<sup>1</sup> and R = 8.5 kpc. We om it local emission by discarding all elements of the data cube

calem ission by discarding all elements of the data cube with a kinematic distance less than 2 kpc as well as all elements in the data cube that are connected by signi – cant emission in position or velocity space to such pixels. W e apply the decom position algorithm described in the Appendix and m easured sizes, line widths, and lum inosities of GMCs using the m ethods of x2.2 and x2.3. The analysis recovers 431 clouds with resolved angular sizes and line widths located within 10 kpc of the Sun. We include the m edian sensitivity and resolution corrections for massive (> 5 10<sup>6</sup> M ) clouds in Table 1 above.

Do the results from our algorithm agree with previous studies of G alactic GMCs? The data set covers the region studied by Heyer et al. (2001) using the  $45^{00}$  resolution of the FCRAO 14m. That data set has a lower sensitivity than the D am e et al. (2001) data, so we apply a rudim entary sensitivity correction (assuming that the GMCs are G aussian and using their peak tem perature and boundary isosurface) to their results and scale to X<sub>CO</sub> = 2  $10^{20}$  cm<sup>2</sup> (K km s<sup>1</sup>)<sup>1</sup> before com paring GMC properties. We focus on a com parison of the virial param eter between the two studies | a full treatm ent of the G alactic \Larson's Laws" is beyond the scope of this paper. We draw several conclusions from the com – parison:




Fig. 8. Virial Param eter as a Function of Lum inous M ass for C buds in the Perseus A m. G ray dots indicate the 431 clouds for which the virial and lum inous m ass can both be determ ined. The solid black line is the average of the data in bins of 0.25 dex in m ass. For com parison, the average virial param eter is plotted as a function of m ass for the clouds in the 0 G S catalog (dashed line). The two data sets show sim ilar virial param eters at all m asses, recovering nearly the sam e virial param eter for a given m ass.

- Figure 8 shows that the virial parameters derived in our analysis largely agree with those found by Heyer et al. (2001). Below masses of 3 10<sup>6</sup> M , both surveys nd the same virial parameter in a given mass bin.
- 2.Above 10~M , our analysis of the 3 Dame et al. (2001) data set may yield a slightly higher virial parameter, on average. This may be evidence for the di use em ission mentioned in x2.2 the higher sensitivity Dame et al. (2001) data m ay include di use em ission surrounding the GMCs while the Heyer et al. (2001) data may m iss this e ect. It may also re ect inadequacies in the simple sensitivity correction we apply to the Heyer et al. (2001) data. Resolution e ects may also play a role the Heyer et al. (2001) 5 tim es better resolution than the data set has D am e et al. (2001) data and so the lower resolution data may tend to lum p unbound clouds together. The number of clouds in the high mass bins is relatively low, so the discrepancy m ay not be particularly signi cant.
- 3. We apply our algorithm to a small portion of the OGS data and nd our corrections for resolution and sensitivity bias increase the mean virial parameter to be consistent with the results from the D am e et al. (2001) data. This suggests that the di erences in the virial parameters for the high mass clouds in Figure 8 may simply be method-ological.
- 4. Both catalogs of outer G alaxy clouds nd an inverse relationship between lum inous m ass and the virial parameter, approximately  $/M_{Lum}^{0.2}$  | a relationship that was also observed by Solom on et al. (1987) for inner G alaxy m olecular clouds.

Thus we nd agreem ent with the results of previous studies of G alactic m olecular clouds. Our m ethods applied to G alactic data nd the same behavior observed in earlier work and we nd agreem ent am ong the m ethod applied to several data sets.

#### 6.3. Conclusions

We have presented a method for measuring macroscopic GMC properties | spatial size, line width, and lum inosity from a region of emission in a spectral line data cube. This method corrects for biases from limited sensitivity and resolution and produces reliable results that are directly com parable among a wide variety of data sets. We correct for limited sensitivity via an extrapolation to a theoretical O K elvin isosurface. W e apply a simple quadratic deconvolution to the extrapolated values to account for resolution biases. We nd that bootstrapping m ethods yield believable estim ates of the uncertainties in the derived param eters. W e present a set of suggestions for transform ing the derived properties into physical quantities of interest. In the Appendix to this paper we present a new method for decomposing em ission into individual GMCs. This method is conservative and robust, designed to produce robust results from low resolution/sensitivity data. In this section we have applied all of these m ethods to an array of extragalactic (Local Group) and Galactic data. We nd that the algorithm reproduces established results for G alactic GMCs and that the sensitivity and resolution biases are potentially signi cant | often 40% | for even the most recent LocalG roup GMC measurements.

Based on this investigation of the observational biases in measuring molecular cloud properties, we note several in portant points that should be considered in planning observations of GMCs and interpreting the results. F irst, resolution and sensitivity biases can be corrected to < 10% error provided the cloud has a modest peak signalto-noise ( $T_{peak} = RMS \& 10$ ) and is marginally resolved  $R_{cld} > 0.8_{FWHM}$ , where FWHM is the full width at half maximum extent of the beam . Given current and future telescope capabilities, even the properties of extragalactic GMCs can be accurately measured. From Figure 3, we can see that single dish surveys can accurately study clouds more massive than  $10^4$  M in the Magellanic clouds and careful interferom eter observations can recover cloud properties for clouds with mass M  $\& 10^5$  M in M 31 and M 33. However, interferom eter observations system atically underestim atem olecular cloud properties. All else being equal, interferom eters can underestim ate uxes by 40% and cloud radii by 10% relative to singledish observations. Line widths are largely una ected by interferom eter observations. The magnitude of the system atic bias depends on the array con guration and the sensitivity of the observations. In general, wider coverage of the (u;v) plane produces better property recovery. To m in im ize bias, observers should favor observations from several array con gurations or from arrays with many elements. If possible, the interferom eter data should be supplemented with single-dish observations. Finally, the decomposition algorithm used to separate emission into physically relevant structures will system atically a ect molecular cloud properties. To date, there is no algorithm that should be favored in all circum stances, but any com parative study of GMC properties should be consistent in the choice of algorithm. For example, the results of a CLUMPFIND algorithm applied to an extragalactic data set are not directly com parable to a catalog produced by a simple contouring method applied to Milky W ay data. Provided the same algorithm is used across multiple data sets, referencing algorithm param eters to a com m on physical scale will m in in ize system atic di erences.

W e will make a software version of the decomposition and measurement algorithm available as an ID L package. Further, since m ethodology can a ect the results of GMC studies so strongly, we encourage authors working in the eld to make their data available to the community after publication in order to facilitate future rigorous com parisons.

#### APPENDIX

## APPENDIX: A NEW DECOMPOSITION ALGORITHM

The choice of what emission to identify as a GMC may be the single largest source of uncertainty in measuring and comparing GMC properties. A number of methods have been employed over the years, from simple contouring methods (e.g. Sanders et al. 1985; Dame et al. 1986; Solom on et al. 1987; Heyer et al. 2001) to thing threedimensional Gaussians (GAUSSCLUMPS, Stutzki& Gusten 1990; Kramer et al. 1998), to modied watershed algorithms (CLUMPFIND and its kin, W illiams et al. 1994; Brunt et al. 2003).

In this section we present a new decomposition algorithm that is designed to identify clouds at low sensitivities while avoiding the introduction of a false clouds due to noise. This algorithm consists of two parts: identifying regions of signi cant em ission in the data set and then assigning this em ission to individual \clouds."

#### Signal Identi cation

We rst identify regions of contiguous, signi cant em ission in our position-position-velocity data cube. We estimate the noise in the data set by measuring the RMS intensity,  $_{RMS}$ , from a signal-free region of the data cube. We then construct a high-signi cance mask. This mask includes only adjacent channels that both have intensities above  $4_{RMS}$ . We expand that mask to include allem ission above a lower threshold | typically two channels above  $2_{RMS}$  signi cance | that is connected to the original high signi cance mask through pixels with  $2_{RMS}$  signi cance. The resulting mask contains most of the signi cant em ission in the data cube. Lowering the threshold below two channels at  $1.5_{RMS}$  runs the risk of biasing the moment measurements towards high values by including false emission (noise with positive values) in the cloud.

#### C bud Identi cation

In this section, we describe the algorithm used to decompose a region of emission into individual subsections representing the physically distinct entities in the data (\clouds"). Through the description of the algorithm, there are several parameters that can be varied to produce changes in the resulting decomposition. In general, we set these parameters using physical prior know ledge of the GMCs we are seeking to catalog. We discuss the choice of these parameters in the following section.

- 1. D iscard Sm all or Low Contrast Regions: If a region is too sm all for us to measure meaningful properties from it, we discard the region. We require that each region has an area larger than two beam sizes, so that we can measure its size; and a velocity width of more than a single channel, so that we can measure its line width. If the intensity contrast between the peak and the edge of the region is less than a factor of two, we lack the dynamic range needed to correct the sensitivity bias and we therefore discard the region. If a region is not discarded we proceed to the next step.
- 2. Rescale the D ata to Reduce the E ects of Substructure: M olecular clouds contain signi cant substructure that confuses the decom position of these sources. The substructure is often signi cantly brighter than bulk of the gas in the cloud. We rescale the data to reduce the contrast between this substructure and the cloud as a whole. The data are rescaled using the follow ing transform :

This transform reduces the contrast pixels with T &  $2T_{clip}$  while preserving the relative brightness distribution. The value of  $T_{clip}$  is left as a free parameter. The transform ed data are used in the decomposition algorithm. Such brightness transforms are frequently used in the decomposition algorithms used in other elds such as medical imaging (e.g. Lin et al. 2003).

- 3. Identify Independent Local M axim a: W e identify potential local m axim a, by identifying the elements in the data cube that are larger than all their neighbors. We consider neighbors to be all data that lie within a box with side length D<sub>m ax</sub> in position and V<sub>m ax</sub> in velocity centered on the local m axim um. These are our \candidate m axim a." The parameters D<sub>m ax</sub> and V<sub>m ax</sub> are free parameters. If we nd more than one candidate m axim um in a region of emission, we proceed to the next steps to further verify each m axim um 's independence. If we nd a single candidate m axim um then we label the region as a cloud and m easure its properties as described in the m ain paper.
- 4. Find Shared Isosurfaces and Reject Sm all C buds or those with Sm ooth M ergers: For each pair of candidate m axim a we calculate the value of the highest intensity isosurface to contain both m axim a. We refer to this highest shared isosurface as the merge level. U sing this set of highest shared isosurfaces, we calculate three properties of interest:
  - (a) The area uniquely associated with each maximum (i.e. the area above the merge level for that maximum).
  - (b) The antenna tem perature interval between the merge level and each maximum, referred to as the contrast interval.
  - (c) The fractional amount by which each of the (unextrapolated) moment values changes across each shared isosurface (i.e.  $\frac{m a j}{m a j}$  for each maximum across each shared isosurface). We consider the two clouds to merge smoothly across the isosurface only if:
    - i. None of the second moments increase by more than 100% for both maxima.
    - ii. No two of the second m om ents increase by m ore than 50% for both m axim a.
    - iii. The ux increases by less 200% for both maxima.

We use these three properties to pare maxim a from the region. We reject maxim a associated with sm all areas (less than two beam sizes, as for the region above) and contrast intervals less than  $T_{max}$ , a free parameter. Choosing  $T_{max}$  2 signi cantly reduces the e ects of noise on decomposition (e.g. Brunt et al. 2003) since noise is associated with low contrast intervals. Finally, when a pair of maxim a merge sm oothly across a shared isosurface, we keep the higher intensity maximum and discard the lower one. This is a conservative choice in the decomposition algorithm : unless merging the two kernels signi cantly alters the properties of one of the clouds associated with the separate kernels, we assume the kernels are not physically distinct. The e ect of removing kernels that merge sm oothly from our data set is to reduce the algorithm 's sensitivity to substructure within clouds. We iterate this step until we have a set of maxim a associated with the required areas and separated from each other by signi cant jumps in their properties.

5. De ne C buds U sing Shared Isosurfaces: The surviving maxim a each correspond to a \cbud." That cloud consists of the em ission within the lowest intensity isosurface uniquely associated with the cloud. Em ission that lies below this isosurface is part of a \watershed" shared among clouds and we do not assign it to any cloud. By not considering contested em ission, i.e. em ission that could be associated with distinct localmaxima, we avoid the problem of how to properly assign this em ission to localmaxima.

6. Measure C bud Properties: Finally, we apply the methods described in x2 and 3 to derive spatial sizes, line widths, and lum inosities for each cloud. The transform ed data (Step 2) are inverse transform ed into the original brightness units for this analysis.

#### U sing Physical Priors to Establish A gorithm Parameters

Several of the algorithm 's param eters are left to the choice of the user. W ithout any prior know ledge of the physical objects in the data, we establish default values for these param eters that will produce a reasonable decom position based solely on the characteristics of the data. These defaults are chosen to provide sensitivity to real substructure within the data without contam ination by noise and can be regarded as the minimum appropriate values for these param eters in most cases. The free param eters in the algorithm are the brightness transform threshold ( $T_{clip}$ , Step 2) position and velocity window size used in searching for local maxima ( $D_{max}$  and  $V_{max}$ , Step 3), and the minimum contrast temperature ( $T_{max}$ , Step 4b). W ithout prior know ledge of substructure in the data, no brightness transform should be applied ( $T_{clip} = 1$ ). The minimum values for the param eters in the search for initial local maxim a are set by the resolution of the data:  $D_{max} = b_{eam}$  and  $V_{max} = V_{chan}$  or else separations between local maxim a cannot be resolved. Finally, we use  $T_{max} = 2_{RMS}$  to prevent the noise in the data set from being recognized by the algorithm as legitim ate structure and becom ing the basis for the decom position.

In the main section of the paper, we developed methods that measured physical properties of molecular emission without observational bias. Ideally, the decomposition algorithm used in the analysis would also be free of observational bias. A good algorithm would, for example, decompose the same emission into similar structures regardless of the resolution and sensitivity of the observations. To progress tow ands this goal, we set the parameters of the decomposition algorithm to have similar values in physical units (pc, km s<sup>1</sup>, K) rather than data units (beam widths, channels, RMS).

In the molecular ISM , which has structure on a range of scales, the choice of the physical values for the algorithm param eters must be motivated by prior know ledge of the objects that we wish to identify. The choice of param eters for identifying GMCs would be dierent from the choice of parameters for identifying clum ps and cores. As a population, GMCs have size scales of 10s of parsecs, line widths of several km  $\,\mathrm{s}^{\,1}$  , and brightness tem peratures of T  $\,$  10 K (e.g. Solom on et al. 1987). In contrast, the clum py substructure within clouds has a size scale of 1 pc, line widths of order 1 km s<sup>1</sup> and can have brightness tem peratures of 30 K or higher (e.g. W illiam set al. 1994). We select the parameters of the algorithm to ndm olecular clouds rather than the clumps within them. In particular, we set the minimum separation between local maxima as  $D_{max} = 15$  pc and the velocity separation to be  $V_{max} = 2$  km  $s^1$ . We also x a contrast interval in antenna tem perature of T  $m_{ax}$  = 1 K rather than the data-driven value of 2 RMS. Finally, we must account for the presence of bright molecular gas substructure within molecular clouds. For example, Orion A has a few distinct regions separated by > 15 pc with antenna tem peratures in excess of 15 K (W ilson et al. 2005). These are associated with hot molecular gas around young stars like the Trapezium cluster. In general, the typical kinetic tem perature of gas in GMCs is 10 K so brightness tem peratures in excess of 10 K are usually associated with structure within molecular clouds not changes from cloud to cloud. Hence, to catalog clouds and not substructure, we must reduce the in uence of the high  $T_b$  data with the parameter  $T_{clip}$ . We use  $T_{clip} = 2.5$  K to maintain the full sensitivity for the gas separating GMCs (which typically has  $T_A$  . 5 K in the Solomon et al. (1987) data) while reducing the in uence of brighter gas associated with a single GMC. Using T<sub>clip</sub> = 2:5 K has little in uence on extragalactic data where beam deconvolution typically averages out the presence of bright substructure within the clouds.

W e sum m arize our choices of parameters in Table A 2 when the parameters are motivated by the data (D ata-B ased) or by physical assumptions about the structures being extracted (G M C PhysicalPriors). The resolution or the sensitivity of a data set may be su ciently poor that the physical parameters are unattainable in the data set (e.g.  $_{beam} > 15 \text{ pc}$ , 2  $_{rm s} > 1 \text{ K}$ ). In this case, the decomposition must be regarded with caution as it may not be directly comparable to other data sets. The adopted values are appropriate for decomposing data sets of  $^{12}$ CO emission. The values of  $T_{clip}$  and T  $_{m ax}$  would be di erent for other tracers.

#### C om parison with Existing A lgorithm s

To demonstrate that the proposed algorithm is actually an improvement on existing methods, we analyze trial data sets with known properties using this algorithm and compare the results to those from the GAUSSCLUMPS and



CLUM PFIND algorithm s to the trialdata. We use the CLFIND algorithm in plemented in MIRIAD (Sault et al. 1995) and our own IDL im plementation of the Kramer et al. (1998) GAUSSCLUM PS algorithm, which we have compared to the standard algorithm operating on a realdata set with satisfactory results.

We rst exam ine how adept the three algorithm s are at decom posing a pair of blended clouds. We construct a series of data cubes with two unresolved model clouds separated in position by a variable distance. The model clouds each have a peak signal-to-noise ratio of 10 with a Gaussian line prole. For each value of the separation, we decom pose 100 data cubes with di erent realizations of the noise using the three algorithms, using data based choices for the algorithm parameters. Figure A 9 (left) shows the mean number of clouds recovered by each algorithm as a function of the separation (we count clouds with peak signal-to-noise larger than 5 as \recovered"). As the trial clouds are moved farther apart, the typical number of clouds detected by each algorithm increases by 1. How ever, only the algorithm presented here consistently recovers a single cloud at low separations. GAUSSCLUM PS and CLUM PF IND produce false clouds from the noise. The jump in the number of clouds detected by the GAUSSCLUM PS algorithm occurs where the separation equals the resolution, whereas both the current algorithm and CLUM PF IND are able to distinguish the clouds only if their separation is over 1.5 tim es the resolution. GAUSSCLUM PS appears to be able to distinguish tight blends of clouds but is the most susceptible to noise.

As a second test of the algorithms, we compared the number of clouds that the algorithms recover from a single cloud with a circular top-hat brightness prole ( $T_A = const.$  for  $r < R_0$ ; 0 otherwise) and peak signal-to-noise of 10. The size of the cloud is varied with respect to the resolution of the data set and 100 data sets for each value of  $R_0$  are decomposed by each algorithm. The non-G aussian brightness prole confounds all of the algorithms but to varying degrees. CLUM PFIND detects an increasing number of spurious clouds as the cloud grows, suggesting that the number of false clouds grows with the volume studied. Despite the non-G aussian prole, GAUSSCLUM PS does suprisingly well with large sources. The current algorithm, how ever, does the best job of detecting a single source in the presence of noise. For analyzing data with a relatively low signal-to-noise, we not the decomposition algorithm presented in this Appendix should be favored for identifying clouds.

#### Applying the Algorithm to the Orion-Monoceros Region

The O rion M olecular C bud is am ong the best studied of all G M C s, so it is an good place to compare the results of our m ethods to those of previous work. For this comparison, we use the data and results of the recent, uniform survey of the entire O rion-M onoceros region by W ilson et al. (2005). We analyze their naldata set using the m ethods in this paper (w ith physical priors for the decom position algorithm param eters) and sum m arize the results in F igure A 10, an integrated intensity m ap of the region. The decom position results in 81 m olecular clouds, m ost of which are associated with the G alactic plane at the top of the F igure.

The results of the algorithm s decom position of the region are good: m a jor m olecular clouds are identified as single entities in the decom position. The algorithm succeeds where other cloud identification schemes would face diffu N early all of the emission in the data is connected above a single isosurface so that simple contouring m ethods would identify the entire O rion-M onoceros region as a single m olecular cloud, though m ore complicated algorithm s (Scoville et al. 1987) m ay succeed. CLUM PFIND and GAUSSCLUM PS would isolate individual peaks and decom pose



clouds into their substructure | as was intended by their design (CLUMPFIND identies 617 clumps in the same data).

The properties of the clouds agree well with the values published for a hum an decom position of the emission. The results of the analysis are given in Table A3. For comparison, we adopt the distances of W ilson et al. (2005). We compare the results of the algorithm to their results, after scaling their mass up by 10% to account for a di erence in the adopted  $CO - to-H_2$  conversion factors. In several cases the masses agree quite well (to within 5%, O rion A, M on R2, Scissors), while other features show 30% di erences. These system atic discrepancies arise from di erences in how emission is assigned into structures. For example, the algorithm only identi es the central region of O rion B as a molecular cloud; it does not include emission is contested with neighboring clouds. Sim ilarly, the algorithm characterizes the N orthern Film ent region as ve distinct clouds rather than the single large cloud that a hum an decom position produced. D espite these di erences, the results of the algorithm are reassuring { in most cases, the well-know n m olecular clouds are identi ed as single clouds and there is good agreem ent between their derived physical properties and the results of previous studies.



# Decom posing O rion-like C buds in O ther G alaxies

As a naltest of the decomposition and analysis algorithm, we apply the algorithm to simulated observations of the O rion-M onoceros region with beam sizes and signal-to-noise values typical of extragalactic GMC observations. We simulate observations by convolving the data set to the desired resolution and adding a convolved data cube of noise which is scaled up to give the desired peak signal-to-noise ratio in the data. We perform this for a peak signal-to-noise (S=N) values of 10 and 30 combined with beam sizes of 10, 20 and 50 pc. The results of the decompositions are displayed in Figure A 11.

At coarse resolution and low sensitivity, the fainter clouds are undetectable. However, the algorithm identi es each of O rion A, O rion B, M on R2 and the N orthern F ilam ent in at least one of the trial data sets. At high resolution (10 pc) and peak signal-to-noise (S=N = 30), the algorithm successfully identi es the clouds with properties that are consistent, within the uncertainties determ ined by the algorithm, with the masses of the clouds in Table A3. The system atic e ects of poor resolution manifest them selves for beam sizes & 20 pc where the decom position of blended em ission results in 20% variations in the properties of the clouds relative to those found in the original data set for both high and low S=N. For a beam size of 20 pc, the clouds are not resolved since this is over tw ice the size of the clouds along their m inor axes. Finally, at 50 pc resolution, M on R2 is not found by the algorithm and high S=N is required to distinguish O rion A and O rion B. There is a variation of 100% (0.3 dex) in the derived physical parameters for the clouds are not spatially resolved for a beam size of 50 pc. An accurate decom position of em ission into typical G alactic G M C s requires a beam size 20 pc though only a modest sensitivity is required: S=N & 10.
