The self-gravitating gas in them alequilibrium is studied using a $N$ ew tonian potential regu larized at short distances. This short distance cuto perm its us to obtain a com plete description of the gas including its collapsed phase. W e give a eld theory description of the N -body regularized selfgravitating gas in the canonicalensem ble. T he corresponding functionalintegral is dom inated in the $\mathrm{N}!1$ lim it by saddle points which provide a m ean eld description. The well-known dilute solutions (isotherm al spheres) are recovered. W e nd new solutions which are regular in the regularized theory but becom e singular in the zero cuto lim it. They describe collapsed con gurations where the particles are densely concentrated in a region of the size of the cuto. These collapsed solutions provide the absolute $m$ inim um of the free energy. W e nd further new solutions which interpolate betw een the collapsed and the dihute con gurations and describe tunneling processes w here the gas collapses. The transition probability for such collapse processes tums out to be extrem ely sm all for large N. That is, the dilute solutions are in practice stable in the regim e where they are locally stable.

## I. INTRODUCTION

Selfgravitating system are ubiquous in the universe. Selfgravity govems the form ation and evolution of the large scale structure in the universe as well as the dynam ics of galaxy form ation, stars and interstellar m edium [1], 2]. It is therefore of great interest to study self-gravitating uids in therm al equilibrium although $m$ ost astrophysical and cosm ological system $s$ are not in exact them al equilibrium [1]-[8].

The self-gravitating gas has peculiar properties from the point of view of equilibrium statistical mechanics: the $m$ ost im portant con gurations are inhom ogeneous and the them odynam ic functions ex ist in the dilute lim it [5, 6, 7]

[^0]$w$ here $N$ is the num ber of particles and $V$ stands for the volum e of the box containing them. In such a lim it, the intemal energy, the free energy and the entropy tums to be extensive. That is, they take the form of $N$ tim es a function of intensive dim ensionless variables. In the case of a sphericalbox of radius $R$ (so that $V=4 R^{3}=3$ ) there is only one such variable, that is the ratio of the characteristic gravitationalenergy $G m{ }^{2} N=R \quad(m$ is the particle $m$ ass and $G$ is $N$ ew ton's constant) and the kinetic energy of the order of the tem perature $T$ of a particle in the gas [5, 6, 7]:

Form ore com plex geom etries there will be, besides
(in such cases $R$ is to be identi ed $w$ ith the linear scale of the box), other dim ensionless shape param eters.

In this paper we restrict the analysis to the sim plest case of a sphericalbox and follow the approach of refs. [5, 6, 7] where the starting point is the partition function for non-relativistic particles interacting through their gravitational attraction in them al equilibrium. The con gurational part of this partition function is expressed as a functional integral over a scalar eld (x) [proportional to the the gravitational potential] with an Euclidean action (that is $m$ inus the logarithm of statistical weight) proportional to $N$. Therefore, the saddle point technique (or $m$ ean eld $m$ ethod) perm its to com pute the con guration partition function in the large $N$ lim it.

As investigated in refs.[3, 5, 6, 7] the self-gravitating gas in the canonical ensemble is in a gaseous phase for $0<T_{\text {where }}=2: 43450::$ :. (Further studies on self-gravitating gases are reported in ref. [4, 8, 9, 11]). At this point the isotherm al com pressibility diverges and the speed of sound inside the sphere becom es im aginary. $T$ his clearly show sthat the gas phase collapses at this point in the canonicalensem ble as a consequence of the Jeans instability. $M$ onte $C$ arlo sim ulations explicitly show that the gas collapses for \& $T$ into a very dense and com pact phase [5].

It $m$ ust be recalled that the $s m$ all uctuations around the $m$ ean eld solution in the canonicalensem ble are stable for $<c=2: 517551:::[6]$. $N$ am ely, uctuations in the partition function do not feel the divergence of the isotherm al com pressibility neither the fact that the speed of sound becom es im aginary.

Even in the regim e where the gaseous phase is locally stable there are alw ays collapsed con gurations which have $m$ uch low er energy than the gas. In fact, the energy has its absolutem inim um in the collapsed phase where allparticles fall to one point and this con guration com pletely dom inates the free energy, causing its divergence to $m$ inus in nity. O f course, interactions other than gravitational alw ays dom inate for short distances. Therefore, the properties the collapsed phase depend on the short distance physics. This physics is di erent according to the nature of the particles' considered. They can be from galaxies tillm olecules or atom $s$. Still, we can study the regim e when collapse happens just introducing a short distance cuto (ultraviolet regulator) to the gravitationalinteraction.

W e present a com plete description of the self-gravitating gas, including the collapsed phase, using a N ew tonian potential regularized at short distances. $W$ e choose the $N$ ew ton potential to be $G \mathrm{~m}^{2}=A$ for interparticle distances $r$ A instead of $N$ ew ton's law $G \mathrm{~m}^{2}=r$. The cuto $A$ is chosen very sm all com pared $w$ th the size of the box.
$W$ e give an exact $m$ apping of the $N$ boody regularized problem into a eld theory functionalintegral. This functional integral is dom inated by its saddle points in the $N$ ! 1 , nam ely by them ean eld equations. Them ean eld equations coincide for zero cuto $w$ ith the Lane $E m$ den equation obtained from hydrostatics and assum ing an idealgas equation of state.

In this w ay w e reproduce the well-know $n$ isothem alsphere solutions describing a self-gravitating gas in localtherm al equilibrium . T hese diluted solutions get sm all corrections for sm all cuto .

W e nd a host of new solutions (saddle points) from our regularized m ean eld equations. These new solutions are singular in the lim it of zero cuto and cannot be nd from the standard (no cuto ) Lane Em den equation. In these new solutions, which are perfectly regular for non-zero cuto, a large num ber of particles concentrate near the origin. $T$ here are two new types of solutions.

T he rst type are the collapsed saddle point solutions: all the particles are densely concentrated in a region of size of the order of the cuto. These solutions are studied analytically and provide the absolute $m$ inim a of the free energy, which reads, at dom inant order for sm all cuto A $R$ :

Here, $T$ is the tem perature and $F_{0}$ is the free energy of an ideal gas. The rst term is just the potential energy of $N$ particles clustered in a sm all sphere of radius $A=2$, where the regularized gravitational interaction is the sam efor all $\frac{1}{2} \mathrm{~N}(\mathbb{N} \quad 1)$ particle pairs. The second term is $T$ tim es the entropy loss in the collapse. This free energy is large and negative, unbounded from below as A ! 0. In particular, this free energy is well below the free energy of the dilute solution.

The second type of saddle point solutions interpolate betw een the gas phase and the collapsed phase, in a sort of pre\{collapse. This solution has a nite action in the zero cuto $\lim$ it and describes the tunneling transition where a
sm all fraction of particles coalesce into a region of the size of the short\{distance regulator so that the density near the origin is very large. T he tunneling probability to collapse for a dilute solution tums out to be extrem ely sm all for large $N$ and smallA. This means in practioe that dilute solutions which are locally stable can be considered stable. A smentioned above this happens in the canonicalensemble for $0 \quad<{ }_{T}$ where $T_{T}=2: 43450::$ :.
$T$ he param eter for the collapsed solutions can be arbitrarily large. T hat is, the particle density does not need to be dilute $N \quad V^{\frac{1}{3}}$ [see eq.(1.1)] but we can have $N \quad V$.

W e obtain in sec. V B an estim ate for the lifetim e for the dilute phase of the self-gravitating gas:

O ne can see that the lifetim e becom es in nitely long in the zero cuto lim it as well as when N ! 1 at xed cuto [recall that $\mathrm{R} \quad \mathrm{N}$ in the dilute lim it ofeq. (1.1)].

In sum $m$ ary, we provide through $m$ ean eld theory a com plete statistical description of the self-gravitating gas including the absolute $m$ inim um of the free energy.

## II. MEAN FIELDAPPROACH TO THE SELF-GRAVITATINGGAS

At short distances, the particle interaction for the self-gravitating gas in physical situations is not gravitational. Its exact nature depends on the problem under consideration (opacity lim it, $V$ an der $W$ aals foroes form olecules etc.). $W$ e shall just assum e a null short \{ distance pair force; that is, we consider the H am iltonian

It $m$ ust be stressed that the results presented in this work using the soft-core cut-o eq.(2.1) w ill be qualitatively the sam e for other types of cut-o since R A.

W ewant to stress that this eld \{theoretic functional form ulation of the self-gravitating gas is fully equivalent, for any N , to the original one in term s of particles. The functional integral representation of the partition function presented in ref. [5, 6] for the canonicalensem ble is slightly di erent but equivalent to eqs. (2.9) and (2.10) for large $N$. Let us also observe that the nonlocal operator $r_{A}^{2}$ reduces to the standard Laplacian operator in the lim it A ! 0 . H ow ever, this lim it is not so straightforw ard in the functional integral above, since the interaction term $S_{\text {int }}$ in the action $m$ ay (and indeed does) becom e unbounded from below in such lim it.

Having factored out of the action the num ber of particles $N$, it is natural to use the saddle points $m$ ethod to evaluate the functional integral over in the $\lim$ it $N!1$ at $x e d$, that is in the dilute lim it. Strictly speaking, how ever, the action per particle $s[]$ still depends on $N$ through $a=A=R / A=N$. Thus we should better regard the saddle point $m$ ethod as a $m$ ean eld type approxim ation yielding the free energy $F$ to leading order in $N$, as we shall now show. The stationarity condition

This holds true for stationary point which are regular at the $a=0 \lim$ it. $W e$ show below that there are saddle points which becom e singular in the a! 0 lim it and consequently the free energy is not proportional to N. Sim ilarly, the subleading term $s$ in eq. (2.19) are order one only for saddle points which are regular for $a=0 . W$ hat is alw ays true is that they are indeed subleading for any given saddle point.

## III. SPHERICALLY SYMMETRIC SOLUTION S

In the case of spherically sym $m$ etry the integration over angles in eq. (2.16) can be perform ed explicitly, yielding the one\{dim ensional non \{linear integro\{di erential equation

IV. SOLUTIONSREGULARASA! O

The saddle point equation (2.13) adm its solutions which are regular as a ! 0 and reproduce in this lim it the solutions of the standard Lane\{Em den equation. We call them dilute solutions. These are know since longtim e in the spherically sym $m$ etric case [3]. To study such solutions we can set the cuto A to zero from the start. Equivalently, one can take the lim it a! 0 in eq. In $F$ ig. 5 we also com pare the solutions of the integral equation (3.3) or (5.2) to those of the di erential equation (4.1) , w ith boundary conditions (4.2), in which $Q$ takes the value obtained by the integralm ethod, upon using eqs. (5.1) and (5.4). W e see that the agreem ent is very good dow $n$ to $r$ oforder a, when the short \{ distance regularization becom es e ective, while the solutions of the di erentialequation (4.1) eventually blow to 1 as r! 0 . This agreem ent appears very natural from the integro\{di erential form ulation of eq. (3.1), where the short\{distance regulator a can play a signi cant role only for r . a.

This explains why the oscillations on the right get reversed com pared w th the oscillations on the left of g.4.

The rst term is just the potentialenergy ofN particles clustered in a sm allsphere of radiusA $=2$, where the regularized gravitational interaction is the sam e for all $\frac{1}{2} N(\mathbb{N} \quad 1)$ particle pairs. $T$ he second term is $T$ tim es the entropy loss in the collapse. A s one could expect, this free energy is large and negative, unbounded from below as A ! 0. In particular, this free energy is wellbelow the free energy of the dilute solution eq. 4.8) and Fig . 3 for all values $>0$. $T$ hat is, the singular solution eq. (5.9) provides the absolute $m$ inim um for the free energy eq. (2.11) for any $>0$. $T$ he dilute solution eqs.(4.4) and (4.2) is only a localm inim um. In the next subsection we shall address the issue of the $m$ etastability of the dilute phase.

Let us now com pute som e physicalquantities characterizing the collapsed phase.
$T$ he equation of state has the $m$ ean eld form

$T$ hus, the pressure at the boundary is exponentially sm all in the collapsed phase. The com plete plot of $P \mathrm{~V}=\mathrm{N} T \mathrm{Vs}$.
is given in F ig. 7 . O ne can see how the well known [3] spiraling tow ards $(=2 ; f()=1=3)$, characteristic of the dilute solutions, is now lim ited to the case when is of order a. W hen reaches values of order 1 the inw ard spiral com es to a halt and then winds back until. O ( $\log \frac{1}{a}$ ). For larger values of , that is $=a$ as in the collapsed phase, $\mathrm{PV}=\mathrm{N}$ T drops to values exponentially sm all in $\frac{1}{a}$. A nalogous plots are obtained for other types of cuto in refs. [9].

B. Interpolating solution : m etastability

The dilute solutions studied in sec. IV arem etastable because the collapsed solution provides the absolute m in im um for free energy (eq. (5.11)]. T he collapse transition from the dilute phase to the collapsed phase can take place through an interpolating solution in an analogous w ay to the bubbles in liquid-gas rst order phase transitions [10].

Such interpolating solutions are the saddle points ofeq. (2.13), which correspond to the sudden drop of as a function of $\log \quad$ (see Fig. (4) located approxim ately at ${ }^{2} \mathrm{a}^{2} \quad \log \frac{1}{a}$. In this narrow drop region we have $O$ (a). < c, so
the interpolating solutions are allow ed only in this interval of. Exam ples of the intenpolating solutions are given in g. 5.

A ccording to the qualitative discussion below eq. (5.8), the location of the drop can be obtained approxim ately as the values of at which the function ( ) has the crossover from the free solution ( ) ' $Q=+C_{1}$ to the logarithm ic solution $\log \left(2={ }^{2}\right)$. That is for ${ }^{2} a^{2} \quad \log \frac{1}{a}$, since $c_{0}=O\left({ }^{3} a^{3}\right)$ and $c_{1}=O\left({ }^{2} a^{2}\right)$, see eq. (5.8). Then the scaling as a! 0 of ( 0 ), the density in the origin, can be obtained from eq. (5.1) and the num ericalanalysis as

O n the other hand, from Fig. 5 one sees that the value of the density for $r$ a and in particular the value at the border (1) di er by order a w r.t. the dilute phase. The equation of state (5.12), which holds for any value of , then im plies that the pressure in the dihute and intenpolating solution, for the same value of , di er only by order a, as evident also from F ig. 7 .

In practice, one can regard an interpolating con guration as a special spherical uctuation of the dilute phase in which a fraction of particles of order a $\log \frac{1}{a}$ is alm ost uniform ely rem oved from everyw here and concentrated in a region of size a around the origin. In fact, this result has an heuristic explanation by a sim ple energy \{entropy argum ent: if we denote by the variation of the density in a region of size a around the origin, we then have

We may neglect the e ect due to the rest of the particles if we assum e that $\frac{\mathrm{N}}{\mathrm{N}}$, the fraction of particle $m$ oved around, would vanish as a! 0. M inim izing eq. (5.15) w r.t. yields

$T$ his result is in very good agreem ent w th the num erical values obtained by solving eqs.(3.3) and (3.6).
A ccording to the interpretation of the interpolating solutions as saddle points through w hich the dilute phase $m$ ay decay to the collapsed one, the lifetim e of the dilute phase is given by

where $D$ et stands for the determ inant ofsm all uctuations around the intenpolating solution and $D$ et for that around the dilute solution.
$T$ his ratio of determ inants can be estim ated as follow $s$ : in the interpolating pro le there should be only one negative $m$ ode necessarily localized in a region of size a around the origin, where the density is very large, since (r) plays the role of Schroedinger potential in the eigenvalue equation for the sm all uctuations. Eq. (5.16) then im plies that $\frac{1}{a^{2}} \log \frac{1}{a}$ provides the scale of the potential felt by this negative $m$ ode. $H$ ence the corresponding negative eigenvalue should be of the sam e order, while the rest of the spectrum should be alm ost una ected, since the two density pro les di er only by order a for $r \& 2 \mathrm{a}$. Therefore

O ne can see that the lifetim e becom es in nitely long in the zero cuto lim it aswell as when N ! 1 at xed cuto [recall that $\mathrm{R} \quad \mathrm{N}$ in the dilute lim it of eq. (1.1)].
W e want to stress that the lifetim e of the dilute solutions is extrem ely long for large N and sm all cuto A . This is due to the fact that although the collapsed solution has a much low er energy than the dilute solution, in the latter there is a huge entropy barrier against the gathering, in a sm all dom ain of size A, of a num ber particles large enough to start the collapse. A qualitatively sim ilar conclusion is reached in ref. [11].
$W$ e shall com e back for a m ore detailed study of this problem in a subsequent paper.
