Pulsars as A strophysical Laboratories for Nuclear and Particle Physics

Abstract

A forefront area of research concerns the exploration of the properties of hadronic m atter under extrem e conditions of tem perature and density, and the determ ination of the equation of state{the relation between pressure, tem perature and density{of such m atter. Experim entally, relativistic heavy-ion collision experim ents enable physicists to cast a brief glance at hot and ultra-dense m atter for times as little as about 10²² seconds. C om plem entary to this, the m atter that exists in the cores of neutron stars, observed as radio pulsars, X -ray pulsars, and m agnetars, is at low tem peratures but com pressed perm anently to ultra-high densities that m ay be m ore than an order of m agnitude higher than the density of atom ic nuclei. This m akes pulsars superb astrophysical laboratories for m edium and high-energy nuclear physics, as discussed in this paper.

1 Introduction

Exploring the properties of hadronic m atter under extrem e conditions of tem perature and density has become a forefront area of modern physics, both theoretically and experimentally. On the earth, heavy ion experiments enable physicists to cast a brief glance at such matter for times as little as about 10²² seconds. On the other hand, it is well known that galaxies like our M ilky W ay contain up to 10⁸ to 10⁹ neutron stars, which are observed as pulsars (rotating neutron stars). Such objects contain ultra-dense hadronic matter as a permanent component of matter in their centers. Radio telescopes, X -ray satellites{and soon the latest generation of gravitational-wave detectors{provide physicists and astronom ers with an unprecedented wealth of high-quality data on such objects and thus serve as the observationalwindows on the innerworkings of pulsars. This feature makes pulsars superb astrophysical laboratories form edium and high-energy nuclear physics (plus other elds of physics) [1, 2, 3, 4, 5, 6, 7, 8]. Som e of the key questions that can be addressed by studying the properties of pulsars are (see Fig. 1):

W hat are the fundam ental building blocks of cold ultra-dense m atter? Speci cally, does \exotic" m atter exist in the cores of pulsars, such as boson condensates, color-superconducting quark m atter, and multi-quark states?

A re there pulsar observables that could signal the existence of exotica in their cores?

A re there rotationally-driven (accretion-driven) phase transitions in pulsars?

How does color-superconducting quark matter alter the properties of pulsars?

W hat is the true ground state of the strong interaction? Is it ordinary nuclear matter (i.e. atom ic nuclei) or a color-neutral collection of up, down, and strange quarks (so-called strange quark matter)?

W hat are the distinguishing features of pulsars m ade of strange quark m atter rather than ordinary hadronic m atter?

W hat are the properties of matter subjected to ultra-high density radiation elds, ultra-high magnetic elds, ultra-high electric elds? How do such elds alter the properties of pulsars?

W hat are the key nuclear (heavy ion) reactions in the non-equilibrium crusts of accreting X-ray pulsars?

How strongly do pycnonuclear reactions in the crusts of accreting neutron stars alter the therm al evolution of such objects?

Do gravitational-radiation reaction driven instabilities lim it the spins of pulsars?

W hat is the shell structure for very neutron rich nuclei in the crusts of pulsars? $D \circ N = 50$ and N = 82 rem ain m agic numbers?

Before we discuss some of these issues in m ore detail, we review some of the key properties of neutron stars. The nst property concerns the masses of neutron stars, which range theoretically from around 0.1 M (where $M = 2 \ 10^{33}$ g is the mass of the sun) to about 3 M. Matter in the centers of neutron stars possess densities ranging from a few times n_0 to an order of magnitude higher. Here $n_0 = 0.15$ nucleons/fm³ denotes the baryon number density of normal nuclear matter, which corresponds to a mass density of 2.5 10^{14} g/cm³. The number of baryons forming a neutron star is of the order of 10^{57} . Rotating neutron stars are called pulsars. Three distinct classes of pulsars are currently known. These are (1) rotation-powered pulsars, where the loss of rotational energy of the star powers

the emitted electrom agnetic radiation, (2) accretion-powered (X-ray) pulsars, where the gravitational potential energy of the matter accreted from a low-mass companion is the energy source, and (3)m agnetars (e.g., SGR 1806-20), where the decay of a ultra-strong m agnetic eld powers the radiation. The fastest, very recently discovered neutron star, PSR J1748-2446ad, rotates at a period of 1.39 m s (which corresponds to 719 Hz) [9], followed by PSR B1937+21 [10] and PSR B1957+20 [11] whose rotational periods are 1.58 m s (633 H z) and 1.61 m s (621 H z), respectively. PSR B1957+20 is moving through the galaxy at a speed of alm ost a million kilom eters per hour. Due to this remarkable motion a bow shock wave is visible to optical telescopes. Other signicant pulsars are Cen X-3 (rst X-ray pulsar), SAX J1808.4-3658 (rst accreting millisecond X-ray pulsar), and PSR J0737-3039A&B (rst double pulsar binary system, which will perm it a strong-eld test of General Relativity). When neutron stars are form ed they have interior tem peratures of the order of 10¹¹ K (around 10 M eV). They coolby neutrino em ission processes to interior tem peratures of 10¹⁰ K within a few days. Throughout most of the active life of neutron stars in pulsars and X -ray sources, the interior tem perature is 10⁹ 10^{7} K. Surface tem peratures are an order of magnitude or more smaller. Measurements of the surface tem perature of the C rab pulsar (B0531+21), for instance, have led to T < 2 10⁶ K.) Rotating m agnetized neutron stars in pulsars are surrounded by a plasm a, the so-called m agnetosphere, in which via plasm a processes the electrom agnetic radiation from pulsars is generated. The m agnetic elds near the surface of neutron stars in compact X -ray sources play an in portant role in channeling the accreting m atter onto the neutron star surface. To date over 1600 pulsars are known. This gure is expected to increase dram atically with the operation of instrum ents like the Square-K ilom eter-A rray (SkA). The sensitivity of SkA will be around 100 times higher than the VLA sensitivity; it is expected that around 20,000 new pulsars (including pulsars around black holes) will be discovered with SkA. The num ber of m illisecond pulsars is expected to go up from its present value by a factor of 100. The initial operations of SkA will start around 2016, and the naloperations are expected to begin around 2020.

2 Bounds on the Nuclear Equation of State

In 1939, Tolm an, Oppenheim er and Volko perform ed the rst neutron star calculations, assuming that such objects are entirely made of a gas of non-interacting relativistic neutrons [12, 13]. The EoS of

such a gas is extremely soft, i.e. very little additional pressure is gained with increasing density, as can be seen from Fig. 2, and predicts a maximum neutron starmass of just 0:7 M (Figs. 3 and 4) at an unrealistically high density of 17 times the density of nuclear matter (Fig. 3). It is interesting to note that the inclusion of interactions among the neutrons increases the star's maximum mass from 0:7 M to around 3 M (Figs. 3 and 4). How ever, the radii of the latter stars are so big that m ass shedding from the equator occurs form ost stars of the sequence at rotational frequencies that are considerably sm aller than 716 Hz observed for PSR J1748-2446ad, or B1937+21, 630 Hz (1.58 ms) [10]. An interacting neutron gas thus fails to accom m odate the rotational frequencies of the m ost rapidly rotating, observed neutron stars. The other extreme, a non-interacting relativistic neutron gas, fails too since it does not accomm odate the Hulse-Taylor pulsar (M = 1.44M) [14], and also conjects with the average 0**:**004M derived by Thorsett and Chakrabarty [15] from observations of neutron starm ass of 1:350 radio pulsar system s. M ore than that, recent observations indicate that neutron star m asses m ay be as high as around 2 M \cdot Examples of such very heavy neutron stars are M _{J0751+1807} = 2:1 02 M $[17], M_{Velax 1} = 1:86 0:16M$ $[18], M_{CyqX} = 1:78$ $[16], M_{4U \ 1636+\ 536} = 2:0$ 0:1 M 0:23M [19, 20]. Large masses have also been reported for the high-mass X-ray binary 4U 1700{37 and the compact object in the low-mass X-ray binary $2S0921\{630, M_{4U}\}_{1700}$ 37 = 2:44 027 M [21] and $M_{2S0921} = 2.0$ 4:3M [22], respectively. The latter two objects may be either massive neutron stars or low-mass black holes with masses slightly higher than the maximum possible neutron starmass . This value follows from a general, theoretical estimate of the maximal possible mass of a of ЗM stable neutron star [23]. If either one of the two objects 4U 1700{37 or 2S0921{630 were a black hole, it would con m the prediction of the existence of low m ass black holes [24]. Conversely, if these objects were massive neutron stars, their high masses would severely constrain the EoS of dense nuclear matter.

3 Nuclear M any-Body M odels

A vast number of models for the equation of state (EoS) of neutron starm atter has been derived in the literature over the years. The majority of these models belong to either one of the following categories: 1. Thom as Ferm ibased models [25, 26] such as the new Thom as Ferm iapproach of Myers and Swiatecki [25]. It is based on a Seyler-B lanchard potential generalized by the addition of one momentum dependent and one density dependent term

The upper (lower) sign in Eq. (1) corresponds to nucleons with equal (unequal) isospin. The quantities k_{F_0} , $T_0 \ (= k_{F_0}^2 = 2m)$, and $_0$ are the Ferm imomentum, the Ferm i energy and the saturation density of symmetric nuclearmatter. The potential's radial dependence is described by a Yukawa-type interaction of the form Y (r_{12}) = (4 a^3) $^1 \exp(r_{12}=a)=(r_{12}=a)$. Its strength depends both on the magnitude of the particles' relative momentum, p_{12} , and on an average of the densities at the locations of the particles. The parameters and were introduced in order to achieve better agreement with asymmetric nuclear systems. The behavior of the optical potential is in proved by the term $(2 = _0)^{2=3}$ with the average density de ned as $^{-2=3} = (\frac{2^{=3}}{1} + \frac{2^{=3}}{2})=2$, where $_1$ and $_2$ the densities of interacting neutron or protons at points 1 and 2. The seven free parameters of the behavior of the optical potential form the optical potential [25].

2. Schroedinger-based models [3, 7, 27, 28, 29] are derived from Ham iltonians of the form

where V_{ij} and V_{ijk} denote two and three-nucleon interactions. The many-body equations are then solved, for instance, in the framework of the hole-line expansion (Brueckner theory), coupled cluster method, self-consistent G reen functions technique, or variational approach.

3. Relativistic nucler eld-theoretical treatments such as relativistic mean eld (RMF), Hartree-Fock (RHF), standard Brueckner-Hartree-Fock (RBHF), density dependent RBHF (DD-RBHF) [1, 2, 30, 31, 32, 33, 34, 35] which are based on a Lagrangian of the form $L = L_B + L_M + L_{int} + L_{lept}$, where

Here, L_B and L_M are the free baryonic and the free mesonic Lagrangians, respectively, and interactions are described by L_{int} , where $F^{()} = (A^{()} (A^{()})$ is the eld strength tensor of one of the vector mesons (= !;). In RMF, RHF and RBHF the meson-baryon vertices (= ;!; ;) are density-independent quantities which are given by expressions like ^ = ig for the scalar meson, $^{1}_{!} = g_{!} + (i=2) (f_{!}=2m) ([;])$ for ! mesons, etc. [2]. In the framework of the DD-RBHF scheme, the meson-baryon vertices ^ are not only determined by D irac matrices but depend on the baryon eld operators [33].

4. The Nam bu-Jona-Lasinio (NJL) model was originally introduced to describe nucleons with dynam – ically generated masses. In recent years it has become a popular model to describe quarks{hadron matter, and to explore the condensation patter of color superconducting quark matter [36, 37, 38, 39, 40, 41, 42, 43]. The avor SU (2) NJL-Lagrangian, for instance, which has been applied in [43] to derive both nuclear matter and quark matter phases, is given by

Here m_q is the current quark mass, is the avor SU (2) quark eld, and the coupling constants G, G₁ and G characterize the qq interactions in the scalar, pseudoscalar and vector m eson channels, while G_s refers to the interaction in the scalar diquark channel [38, 43].

5. A side from the NJL m odel, there are several other phenom enological models based on quark degrees of freedom, such as the quark meson coupling model, the cloudy bag model, the quark mean eld model, and the chiral SU (3) quark mean eld model [44]. In the latter model, quarks are con ned

within baryons by an elective potential. The quark-meson interaction and meson self-interaction are based on SU (3) chiral symmetry. The chiral SU (3) quark mean eld model was applied recently to the study of neutron stars and strange stars [44].

A collection of equations of state computed for several of these models is shown in Fig.2. M ass{radius relationships of neutron stars based on these EoS are shown in Figs. 4 and 5. Strange star sequences are shown in these gures too. The strange star sequences shown in Fig. 5 show the impact of ultrastrong electric elds of the mass{radius relationship of strange stars. The energy-momentum tensor of such stars consists of the usual perfect- uid term, which is supplemented with the electrom agnetic energy-momentum tensor [45], T = (p+ c^2) u u + p + F $^{1}F_{1}$ + $F_{kl}F^{kl}$ =4]=4, where u is the uid's four-velocity, p and c^2 are the pressure and energy density, respectively, and F satis es the covariant M axwell equation, [(g)¹⁼²F]; = 4 J (g)¹⁼². The total mass of the star, contained within a radial distance r from the star's center, is given by dm (r)=dr = (4 r^2)= c^2 + (Q (r)= c^2 r) (dQ (r)=dr). This relation shows that, in addition to the standard term originating from the EoS of the stellar uid, the electric eld energy too contributes to the star's total mass. The Tolm an-Oppenheim er-Volko (TOV) equation of electrically charged stars is given by

As shown in [45], electric elds can substantially alter the structure of compact stars. This is specifically the case for the masses of neutron stars, provided they posses net electric charges. For strange stars, however, even the maximum possible electric elds, 10^{18} V/cm, modiles the mass{radius relationship only very weakly as can be seen from Fig. 5.

4 Building Blocks of Neutron Star M atter

4.1 Hyperons and baryon resonances

At the densities in the interior of neutron stars, the neutron chem ical potential, ⁿ, is likely to exceed the masses, modiled by interactions, of ; and possibly hyperons [2, 46]. Hence, in addition to nucleons, neutron star matter may be expected to contain signi cant populations of strangeness carrying hyperons. The thresholds of the lightest baryon resonances ($; {}^{0}; {}^{+}; {}^{++}$) are not reached in relativistic mean-eld (RMF) calculations. This is dilerent for many-body calculations performed

for the relativistic B rueckner-H artree Fock (RBHF) approximation where 's appear rather abundantly [47], com pare Figs. 6 and 7. Depending on the star's mass, the total hyperon population can be very large [46], which is illustrated graphically in Figs. 8 and 9 for rotating neutron stars whose EoS is computed in the framework of the relativistic DD-RBHF formalism [33]. The stars shown in these gures have rotational frequencies ranging from zero to the mass shedding frequency, κ , which is the maximum frequency a star can have before mass loss at the equator sets in. This frequency sets an absolute upper lim it on stable rapid rotation and follows from a metric of the form [2, 48]

denote the metric functions which depend on the radial coordinate r, polar angle where , , and and, implicitly, on the star's angular velocity as well as on the angular velocity ! at which the local inertial frames are dragged along in the direction of the star's rotation. In New tonian mechanics, m ass shedding is determ ined by the equality between centrifuge and gravity, and is readily obtained as $M = R^3$. Its general relativistic counterpart, com puted here, is given by [2, 48] к = 2

The primes denote derivatives with respect to the Schwarzschild radial coordinate. Finally, we take a brief look at the composition of proto-neutron star matter. The composition of such matter is determ ined by the requirements of charge neutrality and equilibrium under the weak processes, B_1 ! $B_2 + 1 + 1$ and $B_2 + 1! B_1 + 1$, where B_1 and B_2 are baryons, and 1 is a lepton, either an electron or a muon. For standard neutron star matter, where the neutrinos have left the system, these two $_{i}q_{i}n_{B_{i}} + [_{l=e}, q_{l}n_{l} = 0$ (electric charge neutrality) and $^{B_{i}} = b_{i}^{n} q_{i}^{l}$ requirem ents in ply that Q = 1(chem ical equilibrium), where $q_{i=1}$ denotes the electric charge density of a given particle, and $n_{B_{i}}$ (n_{1}) is the baryon (lepton) num ber density. The subscript i runs over all the baryons considered. The sym bol

 B_i refers to the chem ical potential of baryon i, b_i is the particle's baryon num ber, and q_i is its charge. The chem ical potential of the neutron is denoted by n . When the neutrinos are trapped, as it is the case for proto-neutron starm atter, the chem ical equilibrium condition is altered to $B_i = b_i^n - q_i^{(1)}$ 1)

and ^e ^e = , where ¹ is the chem ical potential of the neutrino ₁. In proto-neutron star matter, the electron lepton number $Y_L = (n_e + n_e) = n_B$ is initially xed at a value of around $Y_{L_e} = Y_e + Y_e'$ 0.3 0.4 as suggested by gravitational collapse calculations of massive stars. A loo, because no muons are present when neutrinos are trapped, the constraint $Y_L = Y + Y_m u = 0$ can be in posed. Figures 10 and 11 show sample compositions of proto-neutron star matter and standard neutron starm atter (no neutrinos) com puted for the relativistic mean-eld approximation. The presence of the particle in (proto) neutron starm atter at nite temperature is striking. A salready mentioned at the beginning of this section, this particle is generally absent in cold neutron starm atter treated in the relativistic mean-eld approximation.

4.2 Meson condensation

The condensation of negatively charged m esons in neutron starm atter is favored because such m esons would replace electrons with very high Ferm im om enta. Early estim ates predicted the onset of a negatively charged pion condensate at around 2n₀. How ever, these estim ates are very sensitive to the strength of the elective nucleon particle-hole repulsion in the isospin T = 1, spin S = 1 channel, described by the Landau Ferm i-liquid parameter q⁰, which tends to suppress the condensation mechanism. Measurem ents in nuclei tend to indicate that the repulsion is too strong to perm it condensation in nuclearm atter [49, 50]. In the m id 1980s, it was discovered that the in-m edium properties of K [us] m esons m ay be such that this meson rather than the meson may condense in neutron starmatter [51, 52]. The condensation is initiated by the schematic reaction e + K + e. If this reaction becomes possible in neutron starm atter, it is energetically advantageous to replace the ferm ionic electrons with the bosonic m esons. Whether or not this happens depends on the behavior of the K mass, m_{K} , in neutron Κ star matter. Experiments which shed light on the properties of the K in nuclear matter have been perform ed with the K aon Spectrom eter (K aoS) and the FOPI detector at the heavy-ion synchrotron SIS at G SI [53]. An analysis of the early K kinetic energy spectra extracted from Ni+Ni collisions showed that the attraction from nuclear matter would bring the K mass down to m_K / 200 M eV at densities $3n_0$. For neutron-rich matter, the relation m_K = m_K ' 1 02n=n₀ was established [54], with $m_K = 495 \text{ MeV}$ the K vacuum mass. Values of around m_K ' 200 MeV may be reached by the electron chemical potential, ^e, in neutron starm atter [2, 46] so that the threshold condition for the condensation, $e = m_{K}$, might be fulled for su ciently dense neutron stars, provided onset of K other negatively charged particles (, , d and s quarks) are not populated rst and prevent the electron chem ical potential from increasing with density. We also note that K condensation allows the conversion reaction n ! p + K . By this conversion the nucleons in the cores of neutron stars can

become half neutrons and half protons, which lowers the energy per baryon of the matter. The relative isospin symmetric composition achieved in this way resembles the one of atom ic nuclei, which are made up of roughly equal numbers of neutrons and protons. Neutron stars are therefore referred to, in this picture, as nucleon stars. The maximum mass of such stars has been calculated to be around 1.5M [55]. Consequently, the collapsing core of a supernova, e.g. 1987A, if heavier than this value, should go into a black hole rather than forming a neutron star, as pointed out by B rown et al. [24]. This would imply the existence of a large number of low-mass black holes in our galaxy [24]. Thielem ann and Hashim oto [56] deduced from the total amount of ejected ⁵⁶N i in supernova 1987A a neutron star mass range of 1.43 1.52 M. If the maximum neutron star mass around 2 M. (Sect. 2) would be nuled out.

4.3 H-m atter and exotic baryons

A novel particle that could be of relevance for the composition of neutron starm atter is the H-dibaryon (H = ([ud][ds][su])), a doubly strange six-quark com posite with spin and isospin zero, and baryon num ber two [58]. Since its rst prediction in 1977, the H-dibaryon has been the subject of many theoretical and experim ental studies as a possible candidate for a strongly bound exotic state. In neutron starm atter, which may contain a signi cant fraction of hyperons, the 's could combine to form H-dibaryons, which could give way to the form ation of H-dibaryon matter at densities som ewhere above 4n₀ [59]. If form ed in neutron stars, how ever, H-m atter appears unstable against com pression which could trigger the conversion of neutron stars into hypothetical strange stars [60, 61]. A nother particle, referred to as an exotic baryon, of potential relevance for neutron stars, could be the pentaquark, $+ ([ud]^2s)$, with a predicted m ass of 1540 M eV. The pentaquark, which carries baryon number one, is a hypothetical subatom ic particle consisting of a group of four quarks and one anti-quark (com pared to three quarks in normal baryons and two in mesons), bound by the strong color-spin correlation force (attraction between quarks in the color 3_c channel) that drives color superconductivity [62]. The pentaquark decays according to + (1540) ! K + [su] + n [udd] and thus has the same quantum numbers as the K⁺n.

4.4 Quark decon nem ent

It has been suggested already several decades ago [63, 64, 65, 66, 67, 68, 69, 70] that the nucleons in the cores of neutron stars m ay melt under the enorm ous pressures that exist in the cores, creating a new state of matter know as quark matter. From simple geometrical considerations it follows that quark con nem ent could occur at densities som ewhere between around 2 $10n_0$. Depending on rotational frequency and neutron starm ass, densities greater than two to three times n_0 are easily reached in the cores of neutron stars so that the neutrons and protons in the cores of neutron stars m ay indeed be broken up into their quarks constituents [1, 2, 6, 71]. M ore than that, since the m ass of the strange quark is only around 150 MeV, high-energetic up and down quarks will readily transform to strange quarks at about the same density at which up and down quark decon nement sets in. Thus, if quark matter exists in the cores of neutron stars, it should be made of the three lightest quark avors. The remaining three quark avors (charm, top, bottom) are way to massive to be created in neutron stars. For instance, the creation of charm quark requires a density greater than 10^{17} g=cm³, which around 100 times greater than the density reached in neutron stars. A stability analysis of stars with a charm quark population reveals that such objects are unstable against radial oscillations and, thus, can not exist stably in the Universe [2, 6]. The same is true for ultra-com pact stars with uncon ned populations of top and bottom quarks, since the pulsation eigen-equations are of Sturm -Liouville type.

The phase transition from con ned hadronic (H) matter to decon ned quark (Q) matter is characterized by the conservation of baryon charge and electric charge. The G ibbs condition for phase equilibrium then is that the two associated chemical potentials, ⁿ and ^e, and the pressure in the two phases be equal [71], P_H (ⁿ; ^e; f g;T) = P_Q (ⁿ; ^e;T), where P_H denotes the pressure of hadronic matter computed for a given hadronic Lagrangian L_M (f g), with f g the eld variables and Ferm i m om enta that characterize a solution to the eld equations of con ned hadronic matter,

The pressure of quark m atter, P_Q , is obtainable from the bag m odel. The quark chem ical potentials u ; d ; s are related to the baryon and charge chem ical potentials as $^{u} = (\begin{array}{c} n & 2 \end{array}{}^{e} = 3 \end{array}$ and $^{d} = {}^{s} = (\begin{array}{c} n + \end{array}{}^{e} = 3$. The G ibbs condition is to be supplemented with the global relations for conservation of baryon charge and electric charge within an unknown volume V containing A baryons. The rst

For a given tem perature, T, these equations serve to determ ine the two independent chem ical potentials and the volum e V for a specied volum e of the quark phase in equilibrium with the hadronic phase. A fler completion V_0 is obtained fraction as $V_0 = V$. The chemical potentials depend on the proportion of the phases in equilibrium, and hence so do all properties that depend on them, i.e. the energy densities, baryon and charge densities of each phase, and the common pressure. For the mixed phase, the volume proportion of quark matter varies from 0 1 and the energy density is the linear combination of the two phases $_{\circ}$ (ⁿ; ^e;T). M odel neutron star compositions computed within the)_H (ⁿ; ^e;f g;T)+ = (1 fram ework described just above are shown in Figs. 12 and 13. Possible astrophysical signals associated with quark decon nement, the most striking of which being \backbending" of isolated pulsars, are discussed in [1, 2, 6, 72].

4.5 Color-superconductivity of quark matter

There has been much recent progress in our understanding of quark matter, culm inating in the discovery that if quark matter exists it ought to be in a color superconducting state [36, 73, 74, 75]. This is made possible by the strong interaction among the quarks which is very attractive in some channels (antisymmetric antitriplet channel). Pairs of quarks are thus expected to form C ooper pairs very readily. Since pairs of quarks cannot be color-neutral, the resulting condensate will break the local color symmetry and form what is called a color superconductor. The phase diagram of such matter is expected to be very complex [73, 74]. The complexity is caused by the fact that quarks come in three di erent colors, di erent avors, and di erent masses. Moreover, bulk matter is neutral with respect to both electric and color charge, and is in chemical equilibrium under the weak interaction processes that turn one quark avor into another. To illustrate the condensation pattern brie y, we note the follow ing pairing ansatz for the quark condensate h $_{f_a}C_{5}$ $_{f_b}i_{1}$ $_{1}^{1}$ $_{f_a}f_{b}1^{+}$ $_{2}^{2}$ $_{f_a}f_{b}2^{+}$ $_{3}^{3}$ $_{f_a}f_{b}3$, where

 $_{f_a}$ is a quark of color = (r;g;b) and avor $f_a = (u;d;s)$. The condensate is a Lorentz scalar, antisym metric in D irac indices, antisym metric in color, and thus antisym metric in avor. The gap parameters $_1$, $_2$ and $_3$ describe d-s, u-s and u-d quark C cooper pairs, respectively. The following pairing schemes have emerged: At asymptotic densities (m $_s$! 0 or ! 1) the ground state of QCD with a vanishing strange quark mass is the color-avor locked (CFL) phase (color-avor locked quark pairing), in which all three quark avors participate symmetrically. The gaps associated with this phase are $_3$ ' $_2$ = $_1$ = , and the quark condensates of the CFL phase are approximately of the form h $_{f_a}C_{5}$ $_{f_b}i$ ^X $_{f_af_bX}$, with color and avor indices all running from 1 to 3. Since

 $_{\rm f_b\ f_a}$ one sees that the condensate involves K ronecker delta functions that link ${}^{X} {}_{f_a f_b X} = {}_{f_a f_b}$ color and avor indices. Hence the notion color-avor locking. The CFL phase has been shown to be electrically neutral without any need for electrons for a signi cant range of chem ical potentials and strange quark masses [76]. If the strange quark mass is heavy enough to be ignored, then up and down quarks may pair in the two-avor superconducting (2SC) phase. Other possible condensation patterns are CFL-K⁰, CFL-K⁺ and CFL-^{0;}, gCFL (gapless CFL phase), 1SC (single-avor-pairing), CSL (color-spin locked phase), and the LOFF (crystalline pairing) phase, depending on m_s, , and electric charge density (for references, see [6]). Calculations perform ed for massless up and down quarks and a very heavy strange quark m ass (m $_{\rm s}$! 1) agree that the quarks prefer to pair in the two- avor superconducting (2SC) phase where $_3 > 0$; and $_2 = _1 = 0$. In this case the pairing ansatz ³. Here the resulting condensate picks a color direction (3 or blue reduces to h _{fa}C _{5 fb}i/ ab in the example above), and creates a gap at the Ferm i surfaces of quarks with the other two out of three colors (red and green). The gapless CFL phase (gCFL) may prevail over the CFL and 2SC phases at intermediate values of $m_s^2 = w$ ith gaps given obeying the relation $_3 > _2 > _1 > 0$: For chem ical potentials that are of astrophysical interest, < 1000 MeV, the gap is between 50 and 100 MeV. The order of magnitude of this result agrees with calculations based on phenom enological e ective interactions [75, 77] as well as with perturbative calculations for > 10 GeV [78]. We also note that superconductivity modi es the EoS at the order of $(=)^2$ [79, 80], which is even for such large gaps only a few percent of the bulk energy. Such smalle ects may be safely neglected in present determ inations of models for the EoS of quark-hybrid stars. There has been much recent work on how color superconductivity in neutron stars could a ect their properties [73, 74, 81, 82, 83, 84]. These studies reveal that possible signatures include the cooling by neutrino emission, the pattern of the arrival times of supernova neutrinos, the evolution of neutron star magnetic elds, rotational stellar instabilities, and glitches in rotation frequencies.

4.6 A b solutely stable strange quark m atter

It is most intriguing that for strange quark matter made of more than a few hundred up, down, and strange quarks, the energy of strange quark matter may be well below the energy of nuclear matter, E = A = 930 MeV, which gives rise to new and novel classes of strange matter objects, ranging from strangelets at the low baryon-number end to strange stars at the high baryon number end [2, 6, 85, 86, 87]. The presence of electrons in strange quark matter may lead to the formation of an electric dipole layer on the surface of strange matter, with huge electric elds on the order of 10^{19} V/cm . This peculiar feature enables strange quark stars to be enveloped in nuclear crusts made of ordinary atom ic nuclei [85, 88, 89]. Sequences of compact strange stars with and without (bare) nuclear crusts are shown in Fig. 4. Since the nuclear crusts is gravitationally bound to the quark matter, the mass-radius relationship of strange stars with crusts resembles the one of neutron stars and even that of white dwarfs [90, 91]. In contrast to neutron stars, how ever, strange stars obey M / R³ because they are self-bound and the mass density of quark matter is alm ost constant inside strange stars. The electrons surrounding strange quark matter are held to quark matter electrostatically. Since neither component, electrons nor quark matter, is held in place gravitationally, the Eddington lim it to the lum inosity that

a static surface m ay em it does not apply, and thus the object m ay have photon lum inosities m uch greater than 10^{38} erg=s. It was shown by U sov [92] that this value m ay be exceeded by m any orders of magnitude by the lum inosity of e⁺ e pairs produced by the C oulom b barrier at the surface of a hot strange star. For a surface temperature of 10^{11} K, the lum inosity in the out ow ing pair plasm a was calculated to be as high as $3 \ 10^{51}$ erg=s. Such an e ect m ay be a good observational signature of bare strange stars [92, 93, 94, 95]. If the strange star is enveloped by a nuclear crust how ever, which is gravitationally bound to the strange star, the surface m ade up of ordinary atom ic m atter would be subject to the Eddington lim it. Hence the photon em issivity of such a strange star would be the sam e as for an ordinary neutron star. If quark m atter surface m ay be tunned o , since cold CFL quark m atter is electrically neutral so that no electrons are required and none are adm itted inside CFL quark m atter [76]. This m ay be di erent for the early stages of a hot CFL quark star [96].

5 Latent H eat of P hase T ransitions

A neutron star is born with enorm ous reserves of rotational and them all energy, which it boses over m illions of years through processes such as magnetic dipole radiation from the magnetosphere, them all radiation and electron winds from the surface and neutrinos from the core. In doing so the star cools down and changes structure as the radius diminishes with the rotation frequency{by as much as a few kilom eters if it started out near its limiting Kepler frequency{shifting the interior boundaries of any phase transitions there in the process. Any latent heat evolved or absorbed by particles crossing these boundaries will contribute to the therm allevolution af the star, and in this section we discuss the form alism for describing these elects. The therm allevolution of a spherical star in General Relativity is given by a local energy balance equation [97, 98]:

where L_r is the local lum inosity given by the conduction of non-neutrino energy through a sphere of radius r, _{nuc} is the rate, per volum e, at which nuclear reactions create non-nuclear energy, is the neutrino emissivity per volum e, is the rest mass density, P is the pressure and is the speci c internal energy per unit rest mass, which in the absence of any phase transitions may be written

with c_V the heat capacity per unit volume and T the temperature. Since $P = (0E = 0V)_T$ we then have 0 = 0 = P = 2 so in this case

However in the presence of any phase transitions the heat capacity m ay be discontinuous and this will give rise to extra terms as particles cross the phase boundaries in either temperature for super uid transitions or in density if there is a transition from hadronic matter to quark matter. To see this for a sharp phase transition with no mixed phase, we may write as

where is the H eaviside step function, can be either T, (which may be discontinous at the phase transition) or some other convenient quantity depending on the nature of the phase transition, $_{\rm c}$ is the critical for the phase transition and num erical subscripts identi es a variable with either of the two phases. D i erentiating with respect to time we then get the same term s as above and additional term s from the H eaviside functions:

This is of course the well known result that each particle crossing a phase boundary contributes to the surrounding medium an energy $[99]q = T[_2 _1] = T$, where is the entropy per particle. If is a continuous variable such as T or P the distinction between $_{c;1}$ and $_{c;2}$ is pointless and the delta functions m ay be taken outside, and a second order transition with continuous entropy density at the phase transition would then cause the last term in Eq. (18) to vanish.

A mixed phase may be treated similarly by replacing the H eaviside functions with a volum e fraction , such that 1 is the fraction of a given volum e occupied by phase 1 and is that occupied by phase 2 so = $(1)_{1} + _{2}$ and hence

The transition to a super uid state is a second order transition taking place through a mixed phase with / $(1 T=T_c)$ and $\lim_{T \to 0} = 1 (2 _0=T)^{1=2}e^{0=T}$ for simple Fermi gasses [99]. The latent heat released in this process is custom arily treated as an increase in the heat capacity letting $c_V ! c_V R (T=T_c)$ with the e ect of slightly slowing the cooling process { at tem peratures around $0.2T_c$ the reduction factor, $R (T=T_c)$, goes to zero and has the opposite e ect of signi cantly accelerating the cooling. This has been extensively treated in the literature and we refer to [100] for a recent review.

The transition from hadronic to quark matter is a rst order transition which will take place through a mixed phase [71] if nite size e ects and charge screening do not prohibit such a phase [101, 102] (although see the comments in [103]). If the transition is sharp it happens at a specie critical pressure, where the density will be discontinuous and heat will be released there at a total rate of e T (dN $_q$ =dt), with dN $_q$ =dt the number of particles making the transition per unit time. If the transition is through a mixed phase the pressure and average entropy density, $s = (1) s_1 + s_2$, vary continously in the region where the phase transition takes place, but the individual entropy densities will not be equal and particles making the transition will release heat at a local rate of e (@ =@t)T s, where will increase as the star becomes more dense.

To estim ate whether the contribution from these terms makes any signi cant di erence or we are just carrying coal to New castle, we note that a transition from hadronic to quark matter may in a rough approximation be seen as a transition between free Ferm igasses at di erent densities (one of them with a bag constant in the energy density, but this does not a lect the entropy density. A ssum ing both gasses are relativistic and degenerate the entropy per particle with Boltzm ann's constant set to one is [99]

where $_{c}$ is the color degeneracy, n is the particle density which for quark matter is three times the baryon density, n_{QM} , in the quark phase and in the hadronic phase is equal to the baryon density there, n_{H} . The resulting term in in Eq. (12) is then on the order of

where $T_9 = T = 10^9$ K and $dN_q = dt$ is normalized to a whole star converted on a timescale of 10^7 years. For the quarks c = 3 was canceled by a factor 1=3 since it takes 3 quarks to make a baryon. This is a rather sm all contribution unless the tem perature is high or the star is changing structure fast. Furtherm ore the term is only positive if $n_{\rm H} < 3n_{\rm OM}$, but this condition is of course subject to the speci c assumptions we made here and would change in a more detailed treatment of the EoS. It should also be noted that this treatment accounts only for the latent heat from the decon nement of the quarks, and that there would be further contributions from the subsequent weak reactions required to bring the matter into chem ical equilibrium by converting d-quarks to s-quarks. These reactions would contribute to the nuc term s in Eq. (12) and m ust be treated similarly to the rotochem ical heating discussed by [104]. and As shown by [105] it is furtherm ore very in portant to know exactly where in the star a heating source is located, since sources located below the outer crust of the star tend to contribute only to the neutrino lum inosity and make little di erence to the surface tem perature. In spite of such reservations one might still optim istically expect to nd signals from the latent heat of a quark matter phase transition either early in a star's them alhistory, when it is hot and spinning down rapidly, or from later episodes of rapid structure change. Such rapid structure change could result from glitches, which may be associated with the buildup and release of stress in a crystalline m ixed quark hadron phase [106], or the appearance of quark matter in a neutron star core, which softens the equations of state and allows the star to change structure rapidly possibly even through a core quake if a m etastable state can be accessed [107]. Future work will explore these possibilities.

6 Summary

O byiously, our view of the interior composition of pulsars, which contain matter in one of the densest form s found in the Universe, has changed dram atically since their rst discovery some 40 years ago. It has also become clear during that time period that all the ambient conditions that characterize pulsars tend to the extrem e as well, rendering pulsars to almost ideal astrophysical laboratories for a broad range of physical studies. O wing to the unprecedented wealth of high-quality data on pulsars provided by radio telescopes, X -ray satellites{and soon the latest generation of gravitational-wave detectors{it seem s within reach to decipher the inner workings of these enigm atic objects, and to explore the phase diagram of cold and ultra-dense hadronic matter from astrophysics.
