## G LA ST sensitivity to Point Sources of Dark M atter Annihilation

W e study the prospects for detecting gam m a-rays from point sources of D ark M atter annihilation with the space satellite G LA ST . W e simulate the instrum ent response to the gam m a-ray spectrum arising from the annihilation of common D ark M atter candidates, and derive full-sky sensitivity m aps for the detection of point sources and for the identi cation of the D ark M atter (as opposed to astrophysical) origin of the gam m a-ray em ission. These m aps represent a powerful tool to assess the detectability of point sources, i.e. sources with angular size sm aller than the angular resolution of G LA ST, 0:1 , in any D M scenario. As an example, we apply the obtained results to the so-called m ini-spikes scenario, where the annihilation signal originates from large D ark M atter overdensities around Interm ediate M ass B lack H oles. W e nd that if these objects exist in the G alaxy, not only G LA ST should be able to detect them over a tim escale as short as 2 m onths, but in m any cases it should be possible to determ ine with good accuracy the m ass of the annihilating D ark M atter particles, while null scenarios would place stringent constraints on this scenario.

#### I. IN TRODUCTION

In the cosm ological concordance model that has emerged over the past few years, a considerable fraction of the total energy density today,  $_{CDM} = 0:19$ , consists of non-baryonic, collisionless and dissipation-free (i.e. cold) m atter [1]. To unveil the { so far com pletely unknown { nature of this dark m atter (DM ) is one of the m ost outstanding challenges for cosm ology and astroparticle physics today. The list of proposed DM candidates is long, ranging from modi ed theories of gravity, that would e ectively m in ic a large non-relativistic com ponent in the total energy content of the universe, to a whole zoo of speculative new particles that the DM may consist of. W hile the form er approach m av, in fact, be extrem ely successful to describe certain isolated phenom ena, like the attening of galactic rotation curves [2], it is notoriously di cult to reconcile with the whole range of accessible observations; in the follow ing, we will therefore restrict ourselves to the latter possibility (see R efs. [3, 4] for recent reviews on particle DM).

Search strategies for DM particles (going beyond m erely testing their gravitational in uence) can be grouped into two categories. In direct detection experim ents, one tries to trace these particles by looking for the recoilenergy they would transfer during scattering events with the atom s of the detector m aterial; null searches start to place non-trivial bounds on the param eter space of the underlying m odels (see, e.g., [5] and references therein). A Itematively, one can use indirect detection techniques, m aking use of the fact that DM particles will generally pair-annihilate in regions of enhanced DM densities; the decay products m ay then be revealed as exotic contributions to astrophysical uxes of gam m a-ray, neutrino and anti-m atter.

The space satellite G LA ST is expected to play a crucial role in indirect DM searches, thanks both to its ability to

perform observations at energy scales com parable to the mass of common DM candidates and to its potential of making deep full-sky maps in gamma-rays, thanks to its large (2:4 sr) eld-of-view [6]. In the rst part of this paper, we study the prospects for detecting point sources of DM annihilation with GLAST, and assess the possibility to discriminate them from ordinary astrophysical sources. As a result of this analysis, we obtain full-sky sensitivity maps for the detection of sources above the di use background, as well as for the identi cation of DM annihilation sources, i.e. for the detection of sources that can be discriminated against ordinary astrophysical sources.

This analysis can be applied to any astrophysical senario that predicts the existence of point-like sources of gam m a-rays from DM annihilations, where \point-like" in this context m eans sources with an angular size sm aller than the GLAST angular resolution, 0:1 (see below for further details). In the second part of the paper, in order to show the e ectiveness of this approach, we apply our results to a speci c astrophysical scenario, where gamma-rays originate from DM mini-spikes. In fact, it has been recently pointed out that interm ediate m ass black holes (IM BHs) are a particularly prom ising place to look for DM self-annihilations, since, under certain assumptions about their formation mechanism, they will be surrounded by regions of highly enhanced DM density, called mini-spikes [34]. As a consequence, they are expected to appear as bright sources of gam m a rays, thereby providing a new possible means of indirect DM detection. Using the sensitivity maps obtained in the rst part of the present paper, we study in detail the prospects for detecting these objects, and show that GLAST can nd a large fraction of the mini-spike population in the Milky W ay over a time scale as short as 2 m onths, or set strong constraints on their existence in case of null searches. Finally we show that, in most cases,

one can not only expect a clear discrim ination from ordinary astrophysical sources, but also obtain a satisfactory determ ination of the DM m ass as well as hints on its nature, through the determ ination of the leading annihilation channel. If the m ass of the annihilating particle exceeds the energy range of GLAST, the study of the detected sources can be extended to higher energies by air Cerenkov telescopes (ACTs) like CANGAROO [7], HESS [8], MAGIC [9] or VERITAS [10].

This article is organized as follows. In Sec. II, we give an overview over indirect DM searches through gamma rays and introduce the gamma-ray spectra that are typically expected from the annihilation of DM particles. The main characteristics of GLAST, along with a brief account of its scientic goals and expected perform ances, are presented in Sec. III. In Sec. IV, we show the sensitivity maps for the detection and identication of point sources of DM annihilation. We then apply our results to mini-spikes around IM BHs in Sec.V, where we make detailed predictions about the detectability of these objects. Finally, we present our conclusions in Sec.V II.

### II. IN D IRECT DARK MATTER SEARCHES THROUGH GAMMA RAYS

A theoretically particularly well-motivated type of DM candidates are weakly interacting massive particles (W  $\mathbb{M}$  Ps) that appear in various extensions to the standard model of particle physics (SM); with masses and couplings at the electroweak scale, they would be thermally produced in the early universe and automatically acquire the necessary relic density to account for the DM today. U sually, the W  $\mathbb{M}$  P appears as the lightest of a whole set of new, heavy particles and its decay into SM degrees of freedom is protected by a new symmetry.

The prototype example for a DM candidate of this type is the neutralino (see [11] for a classic review) that appears in most supersymmetric extensions to the SM as the lightest supersymmetric particle (LSP) and is given by a linear combination of the superpartners of the gauge and Higgs elds,

The neutralino m ass is usually several hundred G eV or less; for very high H iggsino or W ino fractions, how ever, it can be considerably higher (up to 2.2 TeV in the latter case). M ore recently, considerable attention has also turned to m odels with universal extra dimensions (UED) [12], where the higher-dimensional degrees of freedom m anifest them selves as towers of new, heavy states in the low-energy, e ectively four-dimensional theory. The lightest of these K aluza-K lein particles (LKP) has a m ass very close to the inverse of the compactication scale R, and for R<sup>1</sup> 1 TeV it turns out to be a perfect W MP DM candidate just as the neutralino [13, 14]. In the minimal UED setup [13], the LKP is given by the <sup>(1)</sup>, the rst KK excitation of the photon. For the discussion

that follows, we will mainly have these DM candidates in mind; however, we will also argue that the gam maray signals we expect in these cases are rather generic, so that our conclusions about the prospects for a detection of DM annihilation point-sources will remain essentially unchanged even for other DM candidates.

B oth LSP and LKP are charged under a  $Z_2$  sym m etry (R-parity and KK parity, respectively), under which all SM particles remain neutral. This ensures their stability against decay, but at the same time allows the (pair-) annihilation into SM particles. The resulting di erential gam ma-ray ux at earth is then given by

where the integral over the DM density is along the line of sight for a given angle of observation, h vi is the totalannihilation rate, m the dark matter particle's mass and  $E = m \times the photon energy; the sum, nally, runs$ over all possible annihilation channels, with branching ratios B<sup>f</sup> and photon multiplicities dN<sup>f</sup>=dx. The left-(E ) determ ines hand side of the above expression for the spectral form of the signal; it depends only on the underlying model of particle physics and can be computed to a very good accuracy. However, since the dark matter distribution (r) is only poorly known, the same is unfortunately not true for the line-of-sight integral that appears on the right-hand side of Eq. (2). For classical targets of indirect DM searches like the galactic center, for example, these astrophysical uncertainties result in a predicted am plitude for the ux that m ay vary over severalorders of m agnitude [15]. A nother problem that indirect DM searches have to face is that regions of expected high DM density usually also contain a sizeable amount of ordinary m atter which gives rise to m ore conventional, astrophysical sources of gam ma-rays. This is particularly true for the galactic center and even if the observed gam ma-ray signal from that direction is still not identi ed unam biguously, it is very unlikely that the HESS source can mainly be attributed to DM annihilations [16]. A DM component could still be singled out wth GLAST in the 10-300 G eV energy range, where a D M source can provide a good tof the EGRET data [17, 18], but in order to be conclusive, it is of great in portance to provide sm oking-gun evidence for any claim ed indirect detection ofDM.Such evidence may come from a multi-wavelength analysis of the annihilation spectrum [19] or from pronounced spectral features that cannot be m im icked by astrophysical processes, like line-signals [20] or the very sharp cuto s that are associated with nal state radiation [21, 22, 23, 24]. A third possibility is the one that we will discuss later, namely the appearance of a great num ber of sources with identical spectra as expected in the mini-spike IMBH scenario.

Let us now investigate in a bit m ore detail the gam m aray spectra that m ay result from DM annihilations. In principle, there are three di erent types of contributions

to consider. The dominant source of gamma rays is usually associated to secondary photons from quark (or gauge boson) fragm entation and decay, mainly through the process  $^{0}$  ! . The second contribution arises from nal state radiation (FSR), where an additional photon is em itted from charged particle nal states; this becom es particularly important for a sizable branching ratio into  $e^+e$  pairs [21, 22], though, for m > 1 TeV, the same can be true even for W  $^+$  W pairs [24]. Finally, dark matter particles can annihilate directly into photons, giving rise to a characteristic line signal at the DM particle's mass [20]. However, since the DM has to be electrically neutral, these channels ( or

! Z ) are necessarily loop-suppressed and thus usually negligible { at least for current detector resolutions and in the absence of e cient enhancement mechanisms [25]. Having in m ind the limited reach of GLAST for very high energies, we therefore concentrate in the following on secondary photons and FSR photons from  $e^+\,e^-$  nal states.

For the secondary photons, we have adopted the param eterizations that were obtained in Ref. [15] by nunning the Pythia M onte C arlo code [26]:

where = 2 for the annihilation into W W, ZZ and t, and 1 otherwise. The value of the parameters (a;b;c;d;e)for the various annihilation channels f and a set of D M m asses can be found in R ef. [15]. We limit ourselves here to show in Figure 1 the photon multiplicities dN =dx per annihilation into quark and gauge boson pairs, for two di erent values of the D M m ass, M = 500 G eV and M = 1000 G eV. For the bb channel, which we will consider below, the parameter values are (;a;b;c;d;e) = (1;1:50;0:37; 16:05;18:01; 19:50).

The  $e^+e$  FSR spectrum, on the other hand, can be determ ined analytically and is, in leading logarithm ic order, given by [22, 23]

For the other charged leptons, one has simply to replace the electron mass m<sub>e</sub> in the above expression with the corresponding lepton mass, leading to roughly the sam e spectral form as in the  $e^+e^-$  case. The situation for

leptons is actually a bit more complicated since their sem i-hadronic decay produces secondary photons on top of the FSR contribution. The resulting spectrum exhibits a power-law behaviour for small photon energies, with a spectral index of about 1:3, and a cuto that is sharper than in the case of quarks or gauge bosons, but less pronounced than for  $e^+e^-$  pairs [15]. In the following, we will not consider this type of spectrum separately. We note that even in the LKP case, where gam marrays from

leptons are known to give an unusually important contribution [22], this does not change our general conclusions about the determ ination of the cuto .

We are now in a position to make two important observations about the gamma-ray spectra that can be ex-

pected from DM annihilations. First, expressed in the variable x = E = m, they are to a very good approximation independent of the DM mass m. Second, there are essentially only two types of spectra. FSR spectra, to begin with, show an asymptotic  $x^{-1}$  power law for smallx and a characteristic, extrem ely sharp cuto at the highest energy that is kinematically available. The spectra of secondary photons, on the other hand, exhibit an asymptotic  $x^{-1:5}$  power law and a much less pronounced cuto . In fact, spectra of this second type are almost indistinguishable if the dark matter mass is not known by some independent measurement. To make this point more clear, let us consider a rescaled version of the photon multiplicities for secondary photons,

Here,  $A_f$  represents an overall norm alization of the amplitude while  $B_f$  corresponds to a shift in the cuto , i.e. the DM mass. Since neither of these parameters is a priori known, we should use  $dN^{\rm f;res}=dx$ , rather than  $dN^{\rm f}=dx$ , to compare the di erent spectra. The scaling parameters  $A_f$  and  $B_f$  can then be xed by demanding that all spectra have the same norm alization for small x and the same cuto (which we de ne here, som ew hat arbitrary, as a 10<sup>-3</sup> drop of the spectrum with respect to the asymptotic x<sup>-1:5</sup> power law). The resulting rescaled spectra are shown in Fig. 2, with scaling parameters as given in Table I.

For illustration, we will in the following consider two di erent, rather simpli ed DM models: in model A, the DM mainly annihilates into bb pairs while in model B, we x a branching ratio of 80% into bb and 20% into  $e^+ e^-$ 

nal states. The rst case corresponds roughly to the situation one generally expects for the LSP (at least for m assess smaller than a few hundred G eV, see, e.g., [27]), while a large branching ratio into leptons like in m odel B is for example realized in the case of the LKP.From the above discussion, how ever, it should be clear that our m odels A and B are m ore general in the sense that they cover the two basic possibilities for spectral distributions that can be expected from DM annihilations. At this point, a word of caution is in order. W hile the characteristic sharp FSR cuto can be used to unam biguously identify the DM m ass to an accuracy that corresponds to the energy resolution of the detector, a certain theoretical uncertainty enters into the determ ination of m when only the rather soft cuto from secondary photons

when only the rather solt cuto from secondary photons is observed. If, e.g., DM mainly annihilates into light quarks or gauge bosons, one would not be able to tell the di erence from our case A, but underestim ate the actual DM mass by up to 50% (see Table I).

Let us conclude this Section by stressing once more that the detection of many sources with the same spectrum, and in particular with the same cuto, would provide a smoking-gun evidence for DM annihilations { even if the cuto is not very pronounced, like in model A, and would therefore not provide conclusive evidence when ob-

served from a single source alone.

### III. G LA ST

The Gamma-ray Large Area Space Telescope (GLAST) is a next generation gamma ray observatory due for launch in Fall 2007. The main scienti c objects are the study of all gam m a ray sources such as blazars, gam m a-ray bursts, supernova rem nants, pulsars, di use radiation, and unidenti ed high-energy sources. Indeed, GLAST might be called the "Hubble Telescope" of gamma-ray astronomy as it will be able to observe AGN sources up to z 4 and beyond, if such objects actually existed at such early times in the universe. Extrapolation from EGRET AGN detections shows that about 5,000 AGN sources will be detected in a 2 years cumulative scanning mode observation by  $\operatorname{GLAST}$  , as com pared to the 85 that have been observed by EGRET in a similar time interval. The GLAST collaboration has also a strong interest in DM detection and several works in the literature investigate possible scenarios and the corresponding detection capabilities (see e.g. Ref. [28] and the aforementioned reviews [3, 4] for further details).

The prim ary instrum ent on board is the Large A rea Telescope (LAT), a pair-production telescope designed to allow observation of celestial sources in the range 20 M eV {300 G eV [29]; LAT was developed by an international collaboration of particle physics and astrophysics communities from 26 institutions in the United States, Italy, Japan, France and G erm any. The LAT is an 4x4 array of identical towers, each form ed by

> Sistrip Tracker D etectors and converters arranged in 18 XY tracking planes for the m easurem ent of the photon direction,

> Segmented array of C sI(T l) crystals for the measurement the photon energy,

Segmented Anticoincidence Detector (ACD).

During norm all operation the LAT will continuously scan the whole sky, obtaining a complete coverage about every 3 hours due to the great eld of view (2 sr). The

uniform sky coverage, in addition to the large e ective area and the good angular resolution should ensure m any advances in the study of all celestial sources of interest. In Tab. II, we sum m arize from [30] the LAT perform ances m ore relevant in our context.

## IV. DARK MATTER SENSITIVITY MAPS

In order to study the LAT sensitivity for DM annihilation signals, we perform a simulation of the gam ma-ray sky as it will be observed by this instrum ent, based on a param etrization of the instrum ent response. This allow sus to rapidly simulate severalm onths of data-taking in a relatively short time, without having to deal with a com plex M onteC arb simulation of the physical processes involved. For additional information about G LA ST LAT simulations, see, for example, Ref. [31].

A ll sim ulations perform ed for this study correspond to 2 m onths of scanning (i.e. not pointed) LAT observations. The tim e duration was selected such as to allow for a relatively fast discovery of a DM signal; the trade-o is a sizeable decrease in the num ber of resolved and correctly

identi ed sources. No other (non-DM) point sources were sim ulated and source spatial coincidence was not considered, in order to sim plify the analysis and to allow for an autom ated analysis process.

The extragalactic di use background was simulated by extending the EGRET observations to the LAT energy range [32]. The galactic di use background model is im – plemented in the framework of the GALPROP code for cosmic-ray propagation and incorporates up-to-date surveys of the interstellar medium, as well as current models for the interstellar radiation eld, updated production functions and inverse scattering calculations [33]. A sm otivated in Sec. II, we will focus on DM candidatesm ainly annihilating into bb, and discuss below how the detection of deviations from the corresponding gam ma-ray spectrum may provide useful insights on the nature of the DM particles.

In the rst part of our analysis, we investigated the intensity required to resolve a point-source of DM annihilations at a 5 signi cance level. We divided the sky into regions of about 10 degrees in radius, and in each region we placed one DM source. Then, we considered each source separately and let the ux intensity vary

from 10  $^4$  to 2 10  $^3$  ph m  $^2$  s  $^1$ . For each intensity, we calculated the signi cance of the observed signal, given the localbackground counts, with a maximum likelihood analysis assuming Poisson statistics. By estimating the minimum ux required to discriminate the DM source

from the background at a 5 level on a grid of points uniform ly distributed over the sky, we have obtained the sensitivity m ap shown in the top panel of Fig. 4 (where we adopted a DM particle mass m = 150 GeV). The sensitivity appears to depend signi cantly on the Galac-

tic longitude only along the G alactic disk, as expected. At high galactic latitudes a source as faint as  $2 \quad 10^{4}$  ph m<sup>2</sup> s<sup>1</sup> is resolved, while close to the galactic center a minimum ux of 1:5  $10^{3}$  ph m<sup>2</sup> s<sup>1</sup> is required.

In a similar way, we can also produce a sensitivity map for a reliable identi cation of the DM spectral cuto. To do so, we compare for each observed spectrum the likelihood of a plain power law, with that of a DM – like spectrum, and check whether the latter hypothesis is favoured. The result of this analysis is shown in Fig. 5. Inside the galactic plane (bj< 5) the minimum intensity required to pinpoint the high energy cuto is far greater than the intensity required for a 5 detection. This im – plies that there will be some sources that can correctly be identi ed as a DM signal only after observation times longer than the 2 m onths considered here.

All gures quoted in this work were calculated by taking into account in the analysis only detected photons with energies between 100 M eV and 200 G eV. W e lim it ourselves to this energy range in order to avoid the (present) uncertainties in the LAT response functions at very low (down to 20M eV) and high energies (up to 500 G eV).On the other hand, we do take into account all m a jor e ects such as orbiting, rocking and dead times. W hile our sensitivity m aps are in principle still subject to further revisions as the know ledge of the LAT response im proves, we are therefore con dent that they will receive only m inor corrections (im proving the detection efciency).

The time scale of 2 m onths adopted here corresponds roughly to the periodicity of the LAT orbit given an in-28:5 ( 55 days). A ssuming that the clination of detection statistics are dom inated by di use counts and not by stochastic uctuation, it is possible to build detection maps for longer observation times  $t_{\rm obs}$  by sim ply scaling down the minimum  $\mbox{ ux with } t_{\rm obs}^{1=2}$  . For instance, by increasing the observation time by a factor 4,  $t_{obs} = 8 \text{ m}$  on the minimum uxes shown in the maps are roughly halved. For the identi cation maps, on the other hand, the situation is more complicated. It is in fact not trivial to scale m in im um uxes for the determ ination of the DM mass to longer observation time, since the analysis is based on a comparison of likelihood between models, in a regime where both background counts and low statistics play an important role. Although a scaling  $t_{obs}^{1=2}$  appears as a conservative estimate in this case, we feel that this issue deserves a dedicated study.

The sensitivity map for the detection of DM point sources is rather insensitive to the DM particle mass, since the ux is dominated by the low energy tail of the annihilation spectrum. However, things are dierent for the identication map, at least above 200G eV. In fact, the determination of a high energy cut-o strongly depends on the possibility of obtaining good quality data (in terms of angular and energy resolution), for photons above this energy. A detailed study of high-mass models will thus be possible only with a reliable simulation of the instrum ent response at energies above the range considered, although it should be possible to identify its DM origin, through the rather distinctive slope of the annihilation spectrum (see discussion below). Finally, we note that neither the detection nor the identi cation of DM point sources depends signi cantly on the annihilation channels; this situation would, in principle, change for longer observation times and DM masses below a few hundred G eV, when the pronounced sharp cuto for FSR photons from e<sup>+</sup> e nal states becomes clearly visible, thereby enhancing the prospects for the identi cation of m odel B type DM.

We stress that the sensitivity maps in Fig. 4 and 5 represent a powerful tool to assess the observability of any population of point sources of DM annihilations, without having to perform a case-by-case study (simulation plus analysis) of individual sources.

#### V. DETECTABILITY OF M IN I-SPIKES

We now apply the results obtained in the rst part to a speci c astrophysical scenario, namely to DM m inispikes around Interm ediate M ass B lack H oles (IM BH s), and study the prospects for detecting these objects with G LA ST. In this section, following closely Ref. [34], we will rst review the basics of the m ini-spike scenario, and derive, for a M ilky-W ay like galaxy, their number, pro-

le and total lum inosity in term s of DM annihilations. W e will then com bine this inform ation with the sensitivity m aps shown above to determ ine the prospects for a detection with GLAST.

#### A. The M ini-spikes scenario

The e ect of the form ation of a central object on the surrounding distribution of matter has been investigated in Refs. [35, 36, 37, 38] and for the rst time in the fram ework of DM annihilations in Ref. [39]. It was shown that the adiabatic grow th of a massive object at the center of a power-law distribution of DM with index , induces a redistribution of matter into a new power-law (dubbed \spike") with index

This formula is valid over a region of size  $r_{sp} = 0.2r_h$ , where  $r_{BH}$  is the radius of gravitational in uence of the black hole (see below for further details). The adiabaticity of the black hole's grow this in particular valid for the SM BH at the G alactic center. A critical assessment of the formation and survival of the central spike, over cosmological timescales, is presented in Refs. [40, 41] (see also references therein). We limit ourselves here to note that adiabatic spikes are rather fragile structures, that require ne-tuned conditions to form at the center of galactic halos [42], and that can be easily destroyed by dynam ical processes such as major mergers [43] and gravitational scattering o stars [40, 44].

It was recently shown that a  $/r^{3=2}$  DM overdensity can be predicted in any halo at the center of any galaxy old enough to have grown a power-law density cusp in the stars via the Bahcall-W olf mechanism [45]. Collisional generation of these DM "crests" (Collisionally RE generated ST tructures) was demonstrated even in the extreme case where the DM density was lowered by slingshot ejection from a binary super-massive black hole. However, the enhancement of the annihilation signal from a DM crest is typically much smaller than for adiabatic spikes [45].

A though it is unlikely that a spikem ay survive around the Super-massive Black Hole at the Galactic center, they can evolve unperturbed around Interm ediate M ass Black Holes (IMBHs), i.e. wandering BHs with mass  $10^2$  < M = M <  $10^6$ . Scenarios that seek to explain the properties of the observed super-m assive black holes population result, in fact, in the prediction of a large population of IM BHs. The number and properties of m inispikes around IM BHs have been discussed in Ref. [34], where two di erent form ation scenarios have been investigated. In the stone, MBHs form in rare, overdense regions at high redshift, z 20, as rem nants of Population III stars, and have a characteristic mass-scale of a few 10<sup>2</sup>M [46] (the form ation of mild mini-spikes around these objects was also discussed in Ref. [47, 48, 49]). In this scenario, these black holes serve as the seeds for the growth of super-massive black holes found in galactic spheroids [50]. Wew ill not further consider this scenario, because of the m any uncertainties associated to the initial and nalm ass function of  $\mathbb{M}$  BHs, and the lack of a solid prescription for the initial DM distribution and BH m ass grow due to gas accretion as these objects m ove in galactic halos.

W e will instead focus on the second scenario discussed in Ref. [34], based on the proposal of Ref. [51], which is representative of a class of m odels in which black holes originate from massive objects formed directly during the collapse of prim ordial gas in early-form ing halos. In practice, during the virialization and collapse of the rst halos, the gas cools and forms pressure-supported disks at the centers of halos that are su ciently massive for m olecular hydrogen cooling to be e cient. G ravitational instabilities in the disk lead to an e ective viscosity that transfers mass inward and angular momentum outward until the rst generation of stars heats the disk and term inates this process. In this case, the characteristicm ass of the black hole forming in a halo of virial mass M  $_v$  is given by [51]

where f is the fraction of the total baryonic m ass in the halo that has fallen into the disk, z is the redshift of

form ation, is the baryon fraction that lost its angular momentum on a time  $t_{ev}$ , and  $t_{ev}$  is the time scale for the evolution of the rst generation of stars [51]. The distribution of black hole masses is a log-norm all distribution with a mean value given by the characteristic mass above and a standard deviation  $M_{\rm bb} = 0.9$ .

The \initial" DM host m inihalo (that is, the DM distribution prior to black hole form ation) can be well approxim ated by a Navarro, Frenk, and W hite (NFW ) prole [52]

The norm alization constant  $_{\rm 0}$ , and the scale radius  $r_{\rm s}$ , can be expressed in terms of the virial mass of the halo at the time when the IM BH form ed, M  $_{\rm vir}$ , and the virial concentration parameter,  $c_{\rm vir}$ . See Ref. [34] for further details. A lternatively, we could have chosen the more recent parametrization proposed by N avarro et al. [53] (see also Refs. [54, 55]). However, this prole im plies modi cations at scales smaller than those we are interested in, where the prole is anyway modi ed by the presence of the IM BH, hence leading to a negligible change in the predicted uxes.

W e assume that the black holes form over a timescale long enough to guarantee adiabaticity, but short compared to the cosm ological evolution of the host halo (see Ref. [34] for further details). In fact, the condition of \adiabaticity", fundamental to grow \m ini-spikes", requires that the form ation time of the black hole is much larger than the dynamical timescale at a distance  $r_{\rm h}$  from the black hole, where  $r_{\rm h}$  is the radius of the sphere of gravitational in uence of the black hole,  $r_{\rm h}$  ' GM  $_{\rm bh}=$  <sup>2</sup>, and is the velocity dispersion of DM particles at  $r_{\rm h}$ . In practice,  $r_{\rm h}$  is estimated by solving the implicit equation

Inside a region  $r_{sp}$  0.2 $r_h$  [56], and assuming a NFW prole as in Eq. (8), the spike prole is given by

Such a steep power-law leads to a density pro lethat diverges at sm all radii. A lthough the Schwarzschild radius of the black hole provides already a physical lower cuto, the pro le already 'saturates' at larger radii, where the DM annihilation timescale becomes shorter than the time  $t_{\rm sp}$  elapsed since the form ation of the spike. This radius  $r_{\rm lim}$  can be expressed im plicitly as

where v is the annihilation cross section times the relative velocity of the DM particle. W hen performing our integrations, we thus stop at a \cut" radius de ned as

where  $R_{\rm s}=2.95\,{\rm km}~{\rm M}_{\rm bh}={\rm M}_{\rm s}$  is the Schwarzschild radius of the IM BH .

The ux of gam m a-rays from a m ini-spike around an IM BH can be expressed as [34]

where  $_0 = 9 \, 10^{10} \, \text{cm}^2 \, \text{s}^1$  and D is the IM BH distance to the Earth. Note that the annihilation ux in this case does not depend, as one may na vely expect, on the ratio (v=m<sup>2</sup>), because  $r_{cut}$  is itself a function of the particle mass and cross section. It is easy to show that in this case the (integrated) gam ma-ray ux is proportional to (v)<sup>2=7</sup>m<sup>9=7</sup> (given that dN =dx is alm ost independent of m), which means that { due to the \saturation" of the DM pro le described above { the predicted uxes

are much less sensitive to the particle physics param eters than in the usual case.

In order to assess the detectability of m ini-spikes, we have followed the procedure outlined in Refs. [34, 57] to build mock catalogs of sources. As detailed in the next Section, we have then perform ed our analysis on 200 statistical realizations of a M ilky-W ay like halo, studied the detectability in each realization, and then perform ed a statistical analysis of the results.

### B. Prospects for detection with GLAST

W e now turn to the prospects for detecting m ini-spikes with GLAST. To this aim, we simply have to compare ourm ock catalogs of sources, described in m ore detail in the previous section, with the sensitivity m aps of F igs. 4 and 5. If the ux from a given source is greater than the m inim al ux required to grant a 5 detection we will say that the source is resolved; if it is also greater than the threshold for the discrim ination from astrophysical sources, we will say the source is identi ed. Let us point

out here that, obviously, the discussion on the detectability of m ini-spikes can only be performed in a statistical sense, since we do not know in what realization of the simulated M ilky W ay halo we live in.

The result of the above procedure is shown in Fig. 6, where we show the number N  $_{\rm R}\,$  of realizations with N  $_{\rm S}\,$ resolved (and identi ed) m ini-spikes. Let us stress that some of the realizations actually contain sources that would shine brighter than the brightest EGRET unidenti ed source outside the galactic plane (3EG J1835p5918, [58]). In order not to violate the observational constraints, we therefore reject any realization where the ux of at least one source exceeds  $m_{ax} = 2 10^2$  ph m<sup>2</sup> s<sup>1</sup> above 20 M eV; these rejected realizations are not included in Fig. 6 and will not be considered in the following, either. Incidentally, it is interesting to note that the spectral index reported for the brightest unidentied EGRET source is n = 1:69 0:07, quite close to what is expected for the low energy tail of the annihilation spectrum (EGRET was sensitive to energies up to 30 GeV). At lower energies, COMPTEL (in the range 0.75{30 M eV) did not resolve this source from the steep blazarQSO1739+522 [59].

W e can see from F ig. 6 that, in m ost realizations and adopting a particle m ass m = 150 GeV, we can expect a large number of sources to be detectable; T ab. III, furtherm ore, shows that only a sm all fraction of all the realizations is in violation of the observational constraints set by EGRET.

The expected ux from any given mini-spike does, how ever, depend on various particle physics and astrophysical parameters. For what concerns the particle physics parameters, we have already stressed that  $_{\rm i}$  (E) / (v)<sup>2=7</sup>m<sup>9=7</sup>. As for the astrophysical uncertainties, we have shown in Eq. 7 the dependence of the BH mass on the form ation model parameters. W ithout entering here into a detailed discussion of the parameter space of the model, we incorporate the e ect of varying all parameters, by introducing a global rescaling parameter.

eter , building new realizations with uxes

where  $_{i}$  are the uxes obtained in the reference standard scenario discussed above, which then corresponds to the case = 1. For high values of , we expect a lower number of acceptable sources, since m any of them will violate the EGRET constraint, while lowering will m ake a larger number of realizations compatible with the same bound. We show the results for the cases = 0.2 and 5, respectively, in Fig. 7, and sum m arize the number of accepted realizations, resolved sources and identi ed sources, in Tab. III.

# VI. TOW ARDS THE NATURE OF DARK MATTER

In this Section, we analyze in m ore detail som e aspects of the detected sources. As a rst step, it is in portant to verify under which conditions the LAT is able to detect the cuto for a DM candidate like, e.g., in our model A, i.e. under which conditions the tobtained by adopting the parametrization of Eq. (3) (with only m and the absolute norm alization as free param eters) has a greater likelihood than an ordinary power-law t (where the free param eters are the overall norm alization and the spectral slope). We nd that the highest DM mass m that still gives a spectrum recognizable as DM -induced is close to 1 TeV for the brightest sources. The e ciency in the m estim ate, how ever, is strongly dependent on the mass itself. For a simulated source with m = 150 GeV, e.g., we can estim ate the mass of the DM particle with a precision better than 25 G eV. For higher m asses the precision on the determ ination of the DM m ass depends strongly on the possibility to extend the instrum ent's energy range to photon energies above 200 G eV ; an educated guess on the instrum ent's response suggests that a m ass of 1 TeV can be reconstructed with a precision of 10% for the brightest sources. A detailed analysis would warrant a

dedicated study, also because the exact role of system atics and stochastical uctuation is at present not clear. M ass spectroscopy, in any case, should be postponed until a better know ledge of the instrum ent's response at high energies and data from longer observation periods becom e available.

Turning to some illustrative examples of simulated sources, we show in Fig. 8 the situation of a model A type source, at a position  $(l_{p}) = (0,25)$  in galactic coordinates, with a mass m = 150 GeV and a ux  $= 2 \times 10^{-3}$ ph m<sup>2</sup> s<sup>1</sup>. At this location, we expect a moderate diffuse background contribution; it was chosen such as to dem onstrate that a source corresponding to EGRET's faintest detected source is easily identied. In the same gure, we also present a source with m = 1 TeV and =  $2 10^{2}$  phm<sup>2</sup> s<sup>1</sup>. Here, we have picked a position in the galactic plane, at (l,b)= (50,0), to show that even in presence of an intense di use gam ma-ray background, a cuto at 1 TeV is well within the reach of our analysis { at least for the brightest sources in our realizations. In the right panel of Fig. 8, nally, we show an example spectrum for a bright ( =  $2 \cdot 10^2$  ph m<sup>2</sup> s<sup>1</sup>) model B - type DM source with m = 150 GeV. The source was simulated at galactic coordinates  $(l_{,b}) = (0,50)$ , where background counts are negligible; the superim posed t was computed with the usual Eq. (3), i.e. without taking into account the leptonic contribution. At high energies, one clearly notices a photon excess due to the leptonic com ponent; how ever, the photon counts are nonetheless rather sm all and therefore uctuations play a major role. As observation time increases, a leptonic component as in modelB would be recognizable as such even for fainter sources; for the brighter sources, on the other hand, we expect the characteristic, sharply pronounced cuto to becom e ever m ore visible. For a m ore detailed discussion, a dedicated analysis would be necessary; we leave this interesting issue open for future studies.

To conclude this Section, let us brie y return to the question of how to discriminate a DM from a mere astrophysical origin of gam m a-ray point sources, which is certainly mostly based on the detection of the high energy cuto at the mass of the DM particle. The GLAST LAT is expected to observe m ore than a hundred of A ctive Galactic Nuclei (AGNs) in the period we selected for this analysis (2 m onths), som e of w hich would, due to EBL attenuation [60], feature a spectral signature sim ilar to that of DM annihilations. However, a population of DM sources would exhibit distinctive features that should allow to discrm inate the from AGNs, such as the low energy spectral index of 1:5 and the absence of variability. Furtherm ore, a population of DM sources should appear as a distinctive excess in the Fazio-Stecker plot (see for example [60]) that can be obtained from the LAT AGN catalog.

#### VII. DISCUSSION AND CONCLUSIONS

The upcom ing space telescope GLAST will perform full-sky observations of the gam ma-ray sky, at energies that are of particular interest for indirect DM studies. In this paper, we have perform ed a 2 m onths simulation of the gam ma-ray sky as observed by the LAT instrum ent on board the satellite, and, assum ing a gam ma-ray spectrum typical for DM annihilations, we have estimated the minimum ux, at all galactic latitudes and longitudes, required to detect the source at 5 above the background, and to identify it, i.e. to discriminate it against ordinary astrophysical sources through the analysis of its spectral features.

We have used this information to produce the sensitivity maps in Figs. 4 and 5, which represent the main result of this paper. The set one is a sensitivity map for the detection of point sources of DM annihilation, the second a sensitivity map for the identi cation of its DM origin, and determ ination of the mass thanks to a t of the high-energy cut-o. It should actually be possible to identify the DM origin of a population of gam ma-ray sources also in absence of a precise determ ination of the high-energy cut-o, thanks to the distinctive value of the spectral slope in the low energy tail, as discussed in Section II, the presence of an excess in the Fazio-Stecker plot, and absence of variability, as argued in Section V II. However, the precise determ ination of the high-energy cut-o would provide the opportunity of making an even stronger case for the 'exotic' origin of the gam ma-ray signal, since astrophysical sources can hardly m in ic DM spectral features (see also the recent paper by Baltz et al. [61]).

These maps represent a powerful tool to rapidly, and e ciently, investigate the detectability of any population of point sources of DM annihilation, such as small scale clum ps [62, 63, 64, 65, 66, 67], com pact DM structures like Spikes [39, 40, 41, 42, 68] or C rests [45], and DM m ini-spikes [34, 47]. All these objects would appear as pointlike sources with G LAST, if their angular size is sm aller than the angular resolution of the instrum ent, ie.

0.1. O b jects of physical size  $R_{\rm p}$  would thus appear pointlike when at distance D  $^>$  5:7  $10^2 R_{\rm p}$ , a constraint often satis ed by the objects listed above.

In order to prove the e ectiveness of the method, we have applied our results to the mini-spikes scenario discussed in Ref. [34], consisting of a population of 100

DM overdensities, dubbed m ini-spikes, around Interm ediate M ass B lack Holes. We were thereby able to show that a large number of these objects can be detected and identied with GLAST, if they exist, while null searches would place extremely stringent constraints on the whole scenario. Although a set of ducial astrophysical parameters was chosen for the mini-spike scenario, in order to perform this study, the analysis can easily, and rapidly, be generalized to any other set of param eters.

Finally, we have shown that, in case of detection, GLAST can provide useful information on the nature of the annihilating DM particles: rst, with a relatively accurate determ ination of their mass, and second, with the identication of some specic spectral features, like a possible hard spectrum contribution near the cut-o at the DM mass, due to the annihilation to charged leptons.
