Generalised Scalar Field Potentials and In ation

A bstract

We investigate the range of in ationary universe models driven by scalar elds possessing a general interaction potential of the form V () = $V_0^{n} \exp(m)$. Power-law, de Sitter and interm ediate in ationary universes emerge as special cases together with several new varieties of in ation. A nalysing the behaviour of these models at the extrem a of we derive su cient constraints on the m - n parameter space such that in ation may occur as both an early and late-time phenom enon. We also compute the scalar and tensor perturbations produced in the model and compare these results with recent observations.

1 Introduction

In ationary cosm ologies have become the most popular models of the early universe. Their ability to solve many of the problems inherent in the standard cosm ology [1, 2], whilst simultaneously o ering a mechanism for the generation of the seed uctuations for structure form ation [3], consistent with recent observations [4, 5], make in ation a very elegant and appealing scenario. M any variations now exist: in addition to G uth's original version with an ephem eral cosm ological constant [6], there exist models in which the self-interaction potential V for the in atom eld assumes exponential [7, 8, 9] or positive power-law form s [10]. These potentials give rise to power-law and polynom ial-chaotic in ation respectively [10, 11]. A loo of current interest, because of their ability to produce unusual perturbation spectra, are the interm ediate in ationary models of [12 { 15]. These arise when the potential behaves asymptotically as a decaying power-law.

In this paper we endeavour to combine all of these models as special cases of a single more general potential,

This possibility was originally examined by Barrow [16], where it was shown that m 1 was a necessary condition for in ation at large values of . In the absence of an exact solution for the potential of Eq. (1.1) we demonstrate that the slow-roll approximation [17] is generically satis ed at large in all such models, when m 1. We employ asymptotic techniques to ascertain the behaviour of the system at large in all regions of the m - n parameter space, revealing some new types of in ationary universe. We are able to verify that m 1 is also a su cient condition for the potential to support an epoch of in ation at large , and there are no constraints on the value of n in this limit. We nd that when 0 < m 1 in ation occurs as a late-time phenomenon. However, in most cases with m < 0

we nd that grows large as t becomes small and in ation is an early time feature. In these models — is negative and the potential steepens at small to end in ation naturally. Furthermore, if m < 0, and V is an even function of , then the potential will contain a m inim um at = 0, which allows the eld ultimately to decay into particles that reheat the universe once in ation ends [1], without requiring additionalm odi cations to them odel. W e also nd that when m > 1, in ation occurs uniquely at early times before the kinetic energy of the eld comes to dominate as t! 1. If 0 < m < 1 in ation proceeds inde nitely. This also occurs in some models with m < 0 and should be viewed as describing the behaviour of the system on a discrete portion of some grander potential with a minimum . Finally, we calculate the scalar and tensor uctuation spectra arising in the generalized model. W e use these results in conjunction with observations to constrain further the allowed parameter values in Eq. (1.1).

2 Equations of M otion

We shall concern ourselves with the behaviour of a zero-curvature Friedmann universe. The matter content is dominated by a hom ogeneous scalar eld with potential V (). The scale factor of the universe is a (t), where t is synchronous cosm ic time, and we de ne the Hubble expansion parameter as

where primes denote derivatives with respect to the scalar eld and M_{Pl} is the Planck m ass. Solution of these equations exactly is not always possible, although we can offen m ake progress within the context of the slow-roll approximation. The Hubble Slow-Roll Approximation (HSRA) [17] is de ned by the smallness of a set of parameters, the rst two of which are given by

The condition $_{\rm H}$ < 1 is identical to the condition a (t) > 0 for in ation. In [17] the HSRA was formulated as a perturbative expansion, here we shall just be concerned with the zeroth order approximation, which neglects the kinetic term s ($^{-2}$ and) in the equations of motion. In this regime Eqs. (2.2) - (2.3) simplify to

For completeness we also mention the Potential Slow-RollApproximation (PSRA) [17], the validity of which is given by the smallness of the parameters

The PSRA is in some respects more useful than the HSRA in that it allows a certain amount of insight into the behaviour of the system simply from examining the form of the potential. However, one should exercise caution with such an approach. Sm allness of the PSRA parameters only classi es the atness of the potential; it carries no information regarding the initial conditions f₀; $_{-0}$ g and so o ers no guarantee that the eld will be genuinely slow-rolling. Thus for the PSRA to be valid requires the additional assumption that the evolution has reached a form of attractor solution, onto which all trajectories from all possible initial conditions will have converged to within acceptable tolerances. This is the in ationary attractor hypothesis discussed in [17]. The parameters $_v$ and $_v$ for the potential of Eq. (1.1) are

These expressions will prove useful in our later discussion of perturbation spectra as well as providing a reliable probe for determ ining when in ation occurs.

3 A symptotic A nalysis of V () = $V_0^n \exp(m^m)$

The behaviour of in ationary universe models driven by potentials of the form, V () = $V_0^n \exp(m)$, was rst investigated and classified by Barrow [16], where it was shown that late-time in ation only occurs form odels in which m 1, encompassing a broad spectrum of possibilities. When m = 0 and n is positive we have polynom ial-chaotic in ation, for negative n the evolution asymptotes to intermediate in ation and when m = 1, n = 0 we retrieve the power-law in ationary solution. The choice m = n = 0 leads back to Guth's original model [6] with exponential expansion.

We shall now exam ine how this model behaves in the parameter ranges 0 < m < 1 and m < 0. In these cases the equations of motion are not exactly soluble, although we may

m ake progress within the context of the slow -roll approxim ation. Generically this will apply on the asymptotic region of the potential, is at large , allowing us to employ asymptotic techniques [18] to solve Eqs. (2.9) and (1.1) and obtain the complete slow-rolling solution.

3.1 The case 0 < m < 1

Dierentiating Eq. (1.1) with respect to yields

A nalysing the positivity of a(t) at large t in the neighbourhood of $m = 1 \mod m$ s the result that in ation only occurs when m 1. Thus in general we have a new form of in ation when 0 < m < 1; m $\neq 1$. A sm ight be expected, the solution reduces to power-law in ation when m = 1 and is independent of n to leading order.

3.2 The case m < 0

The behaviour of -at large for m < 0 leads to three distinct cases:

3.2.1 m < 0; n € 0; 4

In this subclass of solutions the rst term in Eq. (3.1) will dom in ate. Eqs. (2.7) and (2.8) then im ply

(i) n > 4. This implies n(n = 4) > 0 and ; > 0. Eq. (3.13) reveals that t ! 0 as ! 1 | our asymptotic analysis is thus concerned with the earliest stages of the universe's evolution. (ii) 0 < n < 4. Since n (n 4) < 0, the constraints on Eq. (3.18) in this case are
> 0;1 < < 1 . Eq. (3.13) impliest! 1 as ! 1 and in ation arises once again as a primordiale ect ¹.

(iii) n < 0. Here n(n = 4) > 0. The parameter constraints are > 0; 0 < < 1. In this case we are concerned with the late-time evolution of the solution since from Eq. (3.13) t! 1 as ! 1. The solution asymptotes to an intermediate in ationary model.

Cases (i) and (ii) display in ationary behaviour as an early-time feature in a manner akin to chaotic in ation models with concave potentials. In ation proceeds for a nite time before switching o as the potential becomes too steep.

3.2.2 m < 0; n = 0

¹ The apparent discrepancy in the de nition of early between cases (i) and (ii) (t! 0 and t! 1) is a result of the special choices of time co-ordinate arising in the particular solutions as a result of ignoring integration constants. Both should be taken to represent the early-time limit.

We see that $_{2}$ (t) ! 1 as ! 1 and so we recover the de Sitter solution in this limit, as expected. We also see from Eq. (3.20) that t ! 1 as ! 1 and in ation is an early-time feature in the evolution of the universe.

and tends to unity in the large limit. Eq. (3.27) reveals that t ! 1 when ! 1; once again we are dealing with the early evolution of the system and Eq. (3.29) veri es the asymptotic approach of the model to standard V () / ⁴ models. Potentials such as this, which are symmetric about = 0, contain minima and allow a natural end to in ation within the model. One can thus expect a nite amount of in ation in these theories, dependent on the initial value of .

In m any of the m odels exam ined in the previous section, in ationary behaviour arose as an early-time feature at large values. This poses the question of in ation at smallt in general for the family of potentials de ned by V() = $V_0^{n} \exp((m)$. In [16] a perturbative analysis was employed at large t to arrive at the constraint m 1 necessary for in ation at late times (corresponding to large for the particular parameter ranges considered). A similar treatment here at small times would be innapropriate because of the ambiguities concerning the de nition of \early-time" encountered in section 3.2. Instead we shall treat the scalar eld as a time variable, as outlined in [19]. The monotonicity of -that is required to do this guarantees that each extrem um of t will correspond to a unique extrem um of and vice-versa; exam ining the system at large and small is su cient to obtain the complete solution at early and late times. We thus complete our picture of in ationary models arising from Eq. (1.1) by analysing their behaviour at small t.

Conditions on the potential such that in ation can occur, derived from perturbation theory within this parameterised formalism concur with those obtained from the PSRA ². We shall be concerned in particular with $_{\rm v}$ since it o ers a good approximation to $_{\rm H}$,

 $^{^{2}}$ The applicability of this scheme at small t could be regarded as questionable, since the PSRA only applies generically once the system has had su cient time to settle into the in ationary attractor [9, 17]. Here, we assume that the slow-rolling portion of the potential is large enough to allow the attractor to be

the sm allness of which is linked directly to the positivity of a. Inspecting the form of $_{v}$ for these models, given in Eq. (2.12) we see immediately that for sm all , $_{v}$ will always blow up unless n = 0; n = 0 is thus a necessary condition for in ation at sm all . In this case Eq. (2.12) simpli es considerably to become

Requiring this to be small as ! 0 is equivalent to demanding that 2m 2 be positive or zero, leading to the constraint m 1 for in ation. The bound in parameter space at small is thus opposite to the bound at large .

Next we look for small solutions. D i erentiating V () and substituting into Eq. (2.9) yields s

The choice m = 1 leads to power-law in ation, and so we shall be concerned only with m > 1. Two distinct cases arise:

4.1 The case m > 1; 6 2

The analysis in this general case for positive m at small parallels that of section 3.2.2 for negative m at large and we obtain the approximate solution already given in Eqs. (3.21) { (3.24). When 1 < m < 2; t! 0 as ! 0. If m > 2; t! 1 as ! 0 and the solution is valid at early times. Also, $_{2}$ (t) tends to unity in this limit, as expected.

attained well before leaving the early-time asymptopia, although in practice this should be checked.

4.2 The case m = 2

M odels with m < 1 in ate at large t, whereas those with m = 1 in ate for all t (powerlaw in ation). It should not be surprising then that the solutions in ate at small t when m > 1. Both the solutions (3.24) and (4.6), presented above, tend to de Sitter expansion in the small t lim it.

5 Density and Gravitational W ave Perturbations

A period of in ation in the early universe provides a means to generate the small uctuations from which the large-scale structure we observe in the universe today can have grow n. The stretching and freezing-out of quantum excitations in the in aton and graviton elds during in ation gives rise to a spectrum of scalar and tensor uctuations in the cosm ic m icrow ave background; they can be classi ed by the spectral indices \hat{n}_s and \hat{n}_g respectively [3]. These are de ned as

is the scalar density contrast on a scale corresponding to comoving wavenumber k = aH(aH evaluated when the uctuation crossed outside the Hubble radius during in ation) and _H (k) is the dimensionless strain induced by the gravitational wave perturbations on scale k. During slow-rolling in ation, one may express \hat{n}_s and \hat{n}_g to rst order in the PSRA parameters as [3]

Furtherm ore, the ratio of the amplitudes of tensor to scalar modes in the COBE signal on a scale corresponding to the 1^{th} multipole of the tem perature anisotropy expansion is

where l is the multipole corresponding to the scale k() at which $_{v}$ is evaluated. Tensor uctuations are thus always sub-dom inant in slow-roll and $\hat{\pi}_{s}$ is close to unity, as observed by COBE [4].

M uch work has been carried out recently using the second-order results of [20]. However here the second-order corrections to Eqs. (5.4) - (5.6) prove too cum bersom e to be of use, as well as exceeding the accuracy of the approxim ate results already presented. C on ning ourselves to a rst-order treatment and utilising Eqs. (2.12) and (2.13) yields

These expressions are evaluated at horizon crossing when k() = aH. The relation between the eld and scale k is established by considering the number of e-foldings of contraction experienced by the comoving Hubble length (aH)¹, given by

W ith a view to num erical evaluation, the M $_{P1}$ factors have been restored to this expression and are retained hereafter. The form of N is dependent upon the range of m and n and the appropriate limit of required to obtain in ationary behaviour:

(i) 0 < m < 1 and m 0; n = 0 as ! 1 or m > 1 as ! 0. In these cases we obtain,

Eqs. (5.12) and (5.13), together with N (k) establish the -k correspondences necessary to relate quantum uctuations at a $\pm m e$ to m icrow ave background uctuations on a scale k.

A successfulm odel of in ation requires a m in in um of 70 e-foldings of com oving contraction (to solve the horizon and atness problem s) before the conditions v, v 1 become violated [6]. This constraint provides bounds on the potential in models where 1 is xed by particular initial conditions. When the potential possesses a m in imum this does not apply; then, v; v ! 0 at late times, and such models must be modified if in ation is to end. Potentially, this permits an enormous amount of expansion.

It was seen earlier that the amplitude of the uctuations arising from slow-rolling in ation is dom inated by the scalar component. This has been calculated to zeroth order in the PSRA [3] as

The form of N (k) given in [17] in plies that (aH) ¹ shrunk to scales of astrophysical interest at approximately = ,60 com oving e-folds before the end of in ation, a gure which is weakly sensitive to the physics of reheating. Models in which in ation ends naturally (namely those occupying the regions m < 0; n 0 or m > 1; n = 0 of m - n parameter space) can thus be constrained further by demanding $_{\rm H}$ (k) be consistent with observational data. This requires know ledge of ($_{\rm V}$) so that one m ay obtain a reliable approximation to $_{\rm end}$ ($_{\rm V}$ = 1), the value of at which in ation ends. In particular, if

The most recent analysis of the COBE data [5] gives $_{\rm H}$ ' 2:3 10 ⁵ which, once and m have been xed, in poses a constraint on the value of V₀.

6 Conclusions

We have studied the behaviour of in ationary universe models emerging when one posits a form for the in aton potential containing both exponential and power-law factors. By examining the validity of the slow-roll approximation in these models at the extremes of we have determined the structure of the m -n parameter space at early and late times. We have isolated the regions in which in ation may occur in these two eras and we have obtained a wide variety of qualitatively diment solutions to the equations of motion, dependent to a large extent on the value of m. We not that when m > 1, quasi-de Sitter in ation is manifest at early-times provided n = 0 but this is not a feature as t! 1, where the potential tends to zero faster than the kinetic energy of the eld, and all models are non-in ationary. This is the case at all times when m > 1; $n \in 0$; these models can never in ate. W ithin the broad range 0 m 1 in ation is generic at late times for all n. In particular, when m = 0, the solutions exhibit polynom ial-chaotic or intermediate in ationary behaviour (dependent upon the sign of n) and, if n = 0, we recover the de Sitter solution. If m = 1 and n = 0we have power-law in ation; when $n \in 0$ the behaviour will asymptote to the power-law form at large t. When 0 < m < 1 the scale factor approaches a new type of behaviour, proportional to exp $(\ln^{(2 m) \to m} t)$ as t! 1. If m < 0 and n 0, in ation occurs at early times; but, if n < 0, it proceeds once more as a late-time phenomenon and the precise form of the in ationary behaviour is determined by the speci c value of n.

In sum m ary, our analysis extends the treatment presented in [16] to establish a set of su cient conditions for in ation to occur at early or late epochs, sum m arised in Table 1 below.

The calculation of the perturbation spectra produced in these theories allows further constraints to be placed on m, n and by comparison with m icrowave background observation. Moreover, the restrictions in posed on V_0 from the amplitude of scalar uctuations

go som e way toward determ ining the energy scale at which in ation occurs [21].
