# G eneralised Scalar Field P otentials and In ation

#### Abstract

W e investigate the range of in ationary universe m odels driven by scalar elds possessing a generalinteraction potential of the form $V()=V_{0}{ }^{n} \exp \left({ }^{m}\right)$. Power-law, de Sitter and interm ediate in ationary universes em erge as special cases together with several new varieties of in ation. A nalysing the behaviour of these $m$ odels at the extrem a of we derive su cient constraints on the $m-n$ param eter space such that in ation $m$ ay occur as both an early and late-tim e phenom enon. W e also com pute the scalar and tensor perturbations produced in the $m$ odel and com pare these results $w$ ith recent observations.

## 1 Introduction

In ationary cosm ologies have becom e the $m$ ost popularm odels of the early univense. T heir
 sim ultaneously o ering a m echanism for the generation of the seed uctuations for structure
 appealing scenario. $M$ any variations now exist: in addition to $G$ uth's original version w ith an ephem eral cosm ological constant [i] $]$, there exist $m$ odels in which the self-interaction potentialV for the in aton eld assum es exponentiall [1]Ō]. T hese potentials give rise to pow er-law and polynom ial-chaotic in ation respectively
 spectra, are the interm ediate in ationary models of [12 \{15]. T hese arise when the potential behaves asym ptotically as a decaying pow er-law .

In this paper we endeavour to com bine all of these m odels as special cases of a single $m$ ore general potential,

This possibility was originally exam ined by B arrow [1] was a necessary condition for in ation at large values of. In the absence of an exact
 is generically satis ed at large in all such models, when $m \quad 1 . \mathrm{W}$ e em ploy asym ptotic techniques to ascertain the behaviour of the system at large in all regions of the $m-n$ param eter space, revealing som e new types of in ationary universe. $W$ e are $a b l e$ to verify that $m \quad 1$ is also a su cient condition for the potential to support an epoch of in ation at large, and there are no constraints on the value of $n$ in this lim it. We nd that when $0<m \quad 1$ in ation occurs as a late-tim e phenom enon. H ow ever, in $m$ ost cases $w$ ith $m<0$
we nd that grows large as $t$ becom es $s m$ all and in ation is an early tim e feature. In these $m$ odels - is negative and the potential steepens at $s m$ all to end in ation naturally. Furtherm ore, if $m<0$, and $V$ is an even function of, then the potential will contain a $m$ inimum at $=0$, which allow s the eld ultim ately to decay into particles that reheat the universe once in ation ends $[\underline{-1} 1]$, w ithout requiring additionalm odi cations to the m odel. W e also nd that when $m>1$, in ation occurs uniquely at early tim es before the kinetic energy of the eld com es to dom inate ast! 1 . If $0<m<1$ in ation proceeds inde nitely. $T$ his also occurs in som e m odels with $m<0$ and should be view ed as describing the behaviour of the system on a discrete portion of som e grander potential w ith a minim um.Finally, we calculate the scalar and tensor uctuation spectra arising in the generalised $m$ odel. W e use these results in conjunction w ith observations to constrain further the allowed param eter values in Eq. (1, 1

## 2 Equations of M otion

W e shall concem ourselves w ith the behaviour of a zero-curvature Friedm ann universe. T he $m$ atter content is dom inated by a hom ogeneous scalar eld with potential V ( ). The scale factor of the universe is a ( $t$ ), where $t$ is synchronous cosm ic tim $e$, and we de ne the H ubble expansion param eter as

Solution of these equations exactly is not always possible, although we can often $m$ ake progress $w$ thin the context of the slow roll approxim ation. The Hubble Slow R oll A pproxim ation (H SRA) [ of which are given by

The condition ${ }_{H}<1$ is identical to the condition $a(t)>0$ for in ation. In w as form ulated as a perturbative expansion, here we shall just be conœemed w ith the zeroth order approxim ation, which neglects the kinetic term s ( $-^{2}$ and ) in the equations ofm otion . The PSRA is in some respects more useful than the HSRA in that it allow $s$ a certain am ount of insight into the behaviour of the system simply from exam ining the form of
the potential. H ow ever, one should exercise caution w th such an approach. Sm allness of the P SRA param eters only classi es the atness of the potential; it carries no inform ation regarding the initial conditions $f 0 ;-g$ and so o ers no guarantee that the eld will be genuinely slow rolling. T hus for the P SR A to be valid requires the additional assum ption that the evolution has reached a form of attractor solution, onto which all tra jectories from all possible in itial conditions w ill have converged to w th in acceptable tolerances. This is the in ationary attractor hypothesis discussed in [1] $\overline{1} 1]$. The param eters v and v for the potential of Eq. (19) are

T hese expressions w ill prove usefill in our later discussion of perturbation spectra as well as providing a reliable probe for determ ining when in ation occurs.

## 3 A sym ptotic A nalysis of V ( ) = Vo ${ }^{\mathrm{n}} \exp \left(\mathrm{m}^{\mathrm{m}}\right)$

The behaviour of in ationary universe models driven by potentials of the form , V ( ) = $V_{0}{ }^{n} \exp \left(m^{m}\right)$, was rst investigated and classi ed by B arrow $\overline{1} \overline{6}$, where it was shown that late-tim $e$ in ation only occurs form odels in which $m \quad 1$, encom passing a broad spectrum of possibilities. W hen $m=0$ and $n$ is positive we have polynom ial-chaotic in ation, for negative n the evolution asym ptotes to interm ediate in ation and when $\mathrm{m}=1, \mathrm{n}=0$ we retrieve the pow er-law in ationary solution. The choige $m=n=0$ leads back to $G u t h ' s$ originalm odel [ $[\underline{\sigma}]$ w th exponential expansion.

W e shall now exam ine how this $m$ odelbehaves in the param eter ranges $0<m<1$ and $m<0$. In these cases the equations of $m$ otion are not exactly soluble, although we $m$ ay
$m$ ake progress $w$ thin the context of the slow -rollapproxim ation. G enerically this w ill apply on the asym ptotic region of the potential, ie at large , allow ing us to em ploy asym ptotic


### 3.1 T he case $0<m<1$

A nalysing the positivity of a ( t ) at large t in the neighbourhood ofm $=1 \mathrm{con} \mathrm{m}$ s the result that in ation only occurs when $m$ 1. Thus in general we have a new form of in ation when $0<m<1 ; m \in 1$. Asm ight be expected, the solution reduces to power-law in ation w hen $\mathrm{m}=1$ and is independent of n to leading order.

### 3.2 The case m < 0

The behaviour of - at large for $m<0$ leads to three distinct cases:

In this case we are concemed w the late-tim e evolution of the solution since from E $q$. $\left(\overline{3} \cdot 13^{\prime}\right)$ t! 1 as ! 1 . The solution asym ptotes to an interm ediate in ationary model.
$C$ ases (i) and (ii) display in ationary behaviour as an early-tim e feature in a m anner akin to chaotic in ation m odels $w$ th concave potentials. In ation proceeds for a nite tim e before sw itching o as the potential becom es too steep.

P otentials such as this, $w h i c h$ are sym $m$ etric about $=0$, contain $m$ inim a and allow a natural end to in ation w ithin the model. O ne can thus expect a nite am ount of in ation in these theories, dependent on the in itial value of .

## 4 A nalysis of V ( ) = Vo ${ }^{\mathrm{n}} \exp \left(\mathrm{m}^{\mathrm{m}}\right)$ at sm all

In $m$ any of the $m$ odels exam ined in the previous section, in ationary behaviour arose as an early-tim e feature at large values. This poses the question of in ation at sm allt in general for the fam ily of potentials de ned by $V()=V_{0}{ }^{n} \exp \left({ }^{m}\right)$. In [1] 1 ] a perturbative analysis was em ployed at large to arrive at the constraint $m \quad 1$ necessary for in ation at late tim es (corresponding to large for the particular param eter ranges considered). A sim ilar treatm ent here at sm all tim es would be innapropriate because of the am biguities conceming the de nition of learly-tim e" encountered in section $\overline{2} \overline{2} \overline{2}$. Instead we shall treat the scalar eld as a tim e variable, as outlined in [19 ind $_{1}$. Them onotonicity of that is required to do this guarantees that each extrem um of $t w i l l$ correspond to a unique extrem um of and vice-versa; exam ining the system at large and sm all is su cient to obtain the com plete solution at early and late tim es. W e thus com plete our picture of in ationary $m$ odels arising from Eq. (11) by analysing their behaviour at sm all .

C onditions on the potential such that in ation can occur, derived from perturbation theory within this -param eterised form alism concur with those obtained from the PSRA ${ }_{\underline{L}}^{R_{1}}$. W e shall be concemed in particular $w$ ith v since it O ens a good approxim ation to ${ }_{\mathrm{n}}$,

[^1]the sm allness of which is linked directly to the positivity of a. Inspecting the form of $v$ for these $m$ odels, given in Eq. (2-12) we see im m ediately that for $s m$ all , $v$ will alw ays blow up unless $n=0 ; n=0$ is thus a necessary condition for in ation at sm all. In this case Eq. (2.12) sim pli es considerably to becom e

$M$ odels $w$ ith $m<1$ in ate at large $t$, whereas those with $m=1$ in ate for all $t$ (powerlaw in ation). It should not be surprising then that the solutions in ate at sm all $t$ when $m>1$. B oth the solutions $(3-2 \overline{4})$ and $(\overline{4}-\bar{a})$, presented above, tend to de Silter expansion in the smallt lim it.

## 5 D ensity and G ravitational W ave P erturbations

A period ofin ation in the early universe provides a m eans to generate the $s m$ all uctuations from which the large-scale structure we observe in the univense today can have grow $n$. T he stretching and freezing-out ofquantum excitations in the in aton and graviton elds during in ation gives rise to a spectrum of scalar and tensor uctuations in the cosm ic $m$ icrow ave

Eqs. $(5.12)$ and $(5.13)$, together w ith $N(k)$ establish the $-k$ correspondences necessary to relate quantum uctuations at a \tim e" to microw ave background uctuations on a scale k.

A successfulm odelof in ation requires a minim of 70 e-floldings of com oving contraction (to solve the horizon and atness problem s) before the conditions v, v 1 become violated [G]. This constraint provides bounds on the potential in models where 1 is xed by particular initial conditions. $W$ hen the potential possesses a $m$ in im um this does not apply; then, v; v ! 0 at late tim es, and such models must be modi ed if in ation is to end. P otentially, th is perm its an enorm ous am ount of expansion.

It was seen earlier that the am plitude of the uctuations arising from slow frolling in ation is dom inated by the scalar com ponent. This has been calculated to zeroth order in the PSRA $\left[\begin{array}{l}-1 / 1\end{array}\right]$

The form of $N(k)$ given in [1] ${ }_{[1]}^{1} \bar{T}_{1}$ im plies that (aH $)^{1}$ shrunk to scales of astrophysical interest at approxim ately $=, 60$ com oving e-falds before the end of in ation, a gure which is weakly sensitive to the physics of reheating. M odels in which in ation ends naturally (nam ely those occupying the regions $m<0 ; n \quad 0$ or $m>1 ; n=0$ of $m-n$ param eter space) can thus be constrained further by dem anding ${ }_{\mathrm{n}}(\mathrm{k}$ ) be consistent w ith observational data. This requires know ledge of ( v ) so that one $m$ ay obtain a reliable approxim ation to end $\quad(\mathrm{v}=1)$, the value of at which in ation ends. In particular, if

## 6 C onclusions

W e have studied the behaviour of in ationary univense $m$ odels em erging $w$ hen one posits a form for the in aton potential containing both exponential and power-law factors. By exam ining the validity of the slow roll approxim ation in these $m$ odels at the extrem es of we have determ ined the structure of the $m-n$ param eter space at early and late tim es. W e have isolated the regions in which in ation $m$ ay occur in these tw o eras and we have obtained a w ide variety of qualitatively di erent solutions to the equations ofm otion, dependent to a large extent on the value ofm. We nd that when $m>1$, quasi-de Sitter in ation ism anifest
at early-tim es provided $n=0$ but this is not a feature ast! 1 ,where the potential tends to zero faster than the kinetic energy of the eld, and allm odels are non-in ationary. This is the case at alltim es when $m>1 ; n \in 0$; these $m$ odels can never in ate. $W$ thin the broad range $0 \quad \mathrm{~m} \quad 1 \mathrm{in}$ ation is generic at late tim es for all n . In particular, when $\mathrm{m}=0$, the solutions exhibit polynom ial-chaotic or interm ediate in ationary behaviour (dependent upon the sign of $n$ ) and, if $n=0$, we recover the de Sitter solution. If $m=1$ and $n=0$ we have power-law in ation; when $n \in 0$ the behaviour will asym ptote to the pow er-law form at large $t$. $W$ hen $0<m<1$ the scale factor approaches a new type of behaviour, proportional to $\exp \left(\ln ^{(2 \mathrm{~m})=m} \mathrm{t}\right)$ ast! 1 . If $m<0$ and $n \quad 0$, in ation occurs at early tim es; but, if $n<0$, it proceeds once $m$ ore as a late-tim e phenom enon and the precise form of the in ationary behaviour is determ ined by the speci c value of $n$.

In sum $m$ ary, our analysis extends the treatm ent presented in [1] $\overline{1} \overline{1}]$ to establish a set of su cient conditions for in ation to occur at early or late epochs, sum $m$ arised in Table 1 below .

The calculation of the perturbation spectra produced in these theories allow $s$ further constraints to be placed on $m, n$ and by com parison $w$ th $m$ icrow ave background observation. M oreover, the restrictions im posed on $V_{0}$ from the am plitude of scalar uctuations
go som e way tow ard determ ining the energy scale at which in ation occurs [1] $\left.\underline{1}_{1}^{1}\right]$.
