# G ravitational Lensing by Cosm ic String Loops

W e calculate the de ection of a light ray caused by the gravitational eld of a cosm ic string loop in the weak eld lim it and reduce the problem to a single quadrature over a tim e slice of the loop's world sheet. We then apply this form alism to the problem of gravitational lensing by cosm ic string loops. In particular, we nd an analytic solution for the special case of a circular loop penpendicular to the optical axis. A s exam ples of m ore com plicated loops, we consider two loops w ith higher frequency F ourier m odes. T he num erical analysis illustrates the general features of loop lenses. O ur estim ates, using typicalparam eters for G U T scale loops, show that the stringy nature of loop lenses can be observed for lensing system $s$ involving high redshift galaxies ( $\begin{aligned} & \mathrm{z} \\ & 2\end{aligned}$ ), and we suggest that gravitational lensing can con $m$ the existence of GUT scale strings if they are the seeds for large scale structure form ation.

## I. IN TRODUCTION

C urrent research focuses on two scenarios for the form ation of structure in the universe: the rst where structure form ation w as seeded by adiabatic perturbationsproduced during an in ationary epoch and the second where structure accretes around isocurvature perturbations produced by topological defects such as cosm ic strings, globalm onopoles or textures. In the latter scenario it should be possible to directly detect the presence of topological defects in the present universe leading to im $m$ ediate con $m$ ation of the scenario. On the other hand, the lack of direct evidence for topological defects in the present univense can lead to constraints on the defect scenario for structure form ation and perhaps be considered as circum stantial evidence in favor of the in ationary altemative. Thus it is quite im portant to consider speci c distinctive signatures of the various topological defects that can be used to directly observe them .

Let us speci cally consider cosm ic strings, the model which $w$ ill be relevant to the work in this paper (for a review of cosm ic strings, see Ref. [1] [1]). A num ber of observable features produced by cosm ic strings of m ass density suitable for structure form ation have been discussed in the literature. T hese include discontinuous pattems in the $m$ icrow ave background radiation $\overline{[\overline{3}}]$, generation of a gravitational wave background that could be detected by noise in the m illisecond pulsar tim ing $[1]$ and gravitational lensing $[4]$ in the $m$ icrow ave background radiation are expected to yield stronger constraints or positive results over the next decade or so. The m illisecond pulsar observations can only im pose tighter constraints on the string scenario since a positive detection of gravitationalw aves does not speci cally im ply the existence of cosm ic strings. There has also been sporadic e ort over the last decade to w ork out the gravitational lensing signature of cosm ic strings but, perhaps due to the di culties encountered in understanding the evolution of the string netw ork, no distinctive result em erged from these analyses. H ow ever, an analytical fram ew ork for describing the string netw ork has been constructed over the last few years and the tim e seem s ripe to reconsider gravitational lensing as a tool for searching for strings. The tim ing is also right from the observationalview point since severalnew in itiatives are underw ay that prom ise to survey $m$ uch wider and deeper regions of the sky.

In this paper we investigate gravitational lensing by cosm ic string loops'1. W e begin in Sec. II by estim ating the probability ofstring lensing and in so doing we review som e of the relevant properties of cosm ic strings. O ur estim ates are based on recent results for the string netw ork evolution sum marized in Ref. [1] . N ext, in Sec. III, we consider photon propagation in the $m$ etric of a loop. The problem appears to be quite di cult at rst because the oscillating loop is a com plicated tim e dependent gravitational source. Yet we are able to show that the problem reduces to one that is static where a speci c tim e slige of the loop's w orld sheet is su cient to determ ine the gravitational lensing

[^0]e ects. In other w ords, the bending of light by a string loop is equivalent to the bending of light by a static curved rod w th non-uniform energy density, a result sim ilar to that for the energy shift of a photon propagating in a string loop background rst derived by Stebbins $\overline{[1]} \overline{1}$. W e also rederive the energy shift of the photon in the A ppendix and recover a logarithm ic term that appears to have been elim inated by the regularization procedure used in $R$ ef. 䁿].

O nce we have set up the form alism for an arbitrary loop and described som e rudim ents of gravitational lensing theory (Sec. $\left.\bar{\prime} \mathbf{I V} \mathrm{A}_{1}^{\prime}\right)$, we apply it to treat the lensing due to a circular loop that is oriented in a plane norm al to the
 the photons passing through the loop rem ain unde ected. The de ection of a photon trajectory not threading the loop can also be described quite sim ply and the whole problem can happily be solved by hand w ithout resorting to num erical evaluation.

The perpendicular circular loop, how ever, is a very special case as even a change in the orientation of the loop yields qualitatively di erent results, and loops with less sym $m$ etry have com pletely di erent lensing behavior. T he assum ption that photons passing through the loop rem ain unde ected fails for generalloops. W e study the lensing due to several generic loops num erically and provide im age m aps that prom ise to distinguish cosm ic string lensed im ages from $m$ ore conventional gravitational lensing events (Sec. 'IV.' . H ere we also show that the E instein radius of the string loop is com parable to the typicalloop size for any value of the string tension and so the stringy nature of the loop plays a crucial role in determ ining the structure of the lensed im ages. E ective techniques | for exam ple, techniques that replace the string loop by a point $m$ ass plus perturbations | are unlikely to yield successful approxim ations leading us to conclude that string loop lenses ought to be observationally distinct from garden variety astrophysical lenses.

In Sec. 'V' we sum $m$ arize and discuss our main results. $W$ e also qualitatively discuss the e ects of long strings and describe further work to com e. F inally, Sec.

## II. LENSING PROBABIITIESW ITH STRING LOOPS

G ravitational lensing by cosm ic string loops is an interesting problem only if there is a realistic chance of observing a loop lens. In this section, we w ill estim ate the typical size and num ber density of loops and use these values to determ ine the likelihood of observing a string loop. O ur argum ents will be based on scaling solutions to the string netw ork evolution which are indicated by num erical sim ulations and sem i-analytic treatm ents (for a review of scaling solutions see Ref. [ill $\left.{ }^{-1}\right]$.

The string network consists of two com ponents | the long (or in nite) strings and the closed string loops | assum ed to have form ed during a phase transition in the very early universe. If the strings are to seed large\{scale structure form ation, they should have a linear mass density $10^{22} \mathrm{gm} \mathrm{s} / \mathrm{om}$ (conveniently expressed in $P$ lanck units as G $210^{6}$ where $G$ is $N$ ew ton's gravitational constant). At any epoch in the history of the universe, curved sections of strings w ill oscillate under their ow n force of tension; colliding and intersecting strings will undergo reconnections; the strings $w$ ill stretch under the in uence of the $H$ ubble expansion, and the oscillating strings $w$ ill lose energy prim arily to gravitational radiation. T he com plicated evolution of the string netw ork has been studied in
 the energy density in the long strings scales with time as $\quad 1=2$ and the typical distance betw een strings also scales w ith tim e, L / $t$, where there are on the order of 10 long strings per horizon at any epoch. The reconnections of long strings and large loops are found to copiously produce sm all loops. But there is generally less agreem ent on the precise num ber density of loops present at any epoch. If the typical loop produced is assum ed to have a length , $\quad t$, then num erical results (that do not take the gravitationalback reaction into account) place an upper lim it of
$<10^{3}[1][1]$. To get a low er lim it on , one supposes that highly curved sections of string straighten out on very short tim e scales due to gravitational radiation which occurs at a rate

where, is a num erical factor depending on the shape of the loop and has been evaluated to be 60 by considering several classes of loops. Since the size of the loops is related to the curvature of strings, the sm allest loops that can be produced are those that have lifetim es longer than the Hubble tim e scale. This leads to G $10^{4}$ which we w ill use for the purpose of num erical estim ates. T hen, for a scaling solution, the num ber density of loops w ith length between `and ` $+d$ 'at a given time $t$ is

where is about $0.5[\underline{[1]}]$. N ow we can estim ate the solid angle of sky coverage necessary to observe a string loop lens. $U$ sing eq. where $t=(2=3) H_{0}{ }^{1}(1+z)^{3=2}$. The various explicit factors of the redshift arise from the changing volum e elem ent in an expanding universe. O ne can evaluate this integral analytically and nd the result

For $z_{0}=1, \quad 2$ and $=G$, there are about $400\left(G{ }_{4}\right)^{1}$ loops per steradian which corresponds to about 1 loop for every $(3)^{2} G \quad 4$ of sky, where we have de ned $G{ }_{4}=G \quad 10^{4}$. But, this does not necessarily tell us how $m$ any loop lenses we can expect to observe because we have not yet factored in the odds that a galaxy w ill be near enough to a given loop to be signi cantly lensed. To resolve this problem we require the lum inosity distribution of high redshift galaxies.

For an order ofm agnitude estim ate of the lum inosity distribution of high redshift galaxies, we can use inform ation about nearby galaxies and extrapolate to higher redshifts. Such an extrapolation is justi ed only if the e ects of evolution can be ignored and we shall assum e that this is the case. T he local hum inosity function, , is reasonably approxim ated by the Schechter function $\left[\underline{1} 2^{-}\right]$,

where $M=19: 53 \quad 25+5 \operatorname{logh}$ is the absolute $m$ agnitude of a characteristic galaxy and a reasonable value for the $m$ agnitude lim it is $m=24$. For a at universe $w$ ith no cosm ological constant, age constraints suggest that we should use a value of $h=0: 5$ which gives a lower bound of $=0: 057$. W e can express the integral over the ux in tem s of an incom plete gam $m$ a function which gives us

Let us suppose that we have a loop located at about a redshift of one aw ay from us and we are observing galaxies that are about a redshift of tw o to three. Then integrating eq. (渞) tells us that there are about 1:4 10 galaxies per steradian to work w th. The typical angular separation betw een galaxies is about 5.6 arc seconds, which we shall see in Sec. ' $\bar{I} \bar{V} \bar{C} \bar{C}$ ' is ism allenough that a foreground string loop can alw ays be expected to have a galaxy in its background. T herefore every loop has a good chance ofbeing seen as a gravitational lens.

## III. GEODESIC DEFLECTION BY A STRING LOOP

In this section, we consider the de ection of null geodesics in the presence of a cosm ic string loop, which in the lim it of geom etric optics, will correspond to the photon paths. (R eaders only interested in lensing applicationsm ight w ish to proceed directly to the nal result given at the end of the section.) W e shall assum e that the background space\{tim $e$ is at $M$ inkow skispace, and ignore the e ects of curvature or universalexpansion. Since we are interested in loops w ith radiim uch sm aller that the horizon or curvature scale, th is approxim ation $w$ ill.be valid for determ in ing
the photon de ection. W e shall further assum $e$ that the string contribution to the $m$ etric is $w$ eak and $m$ ay be treated as a perturbation on the at space. Thus wem ay write the com plete $m$ etric as

To zeroth order, i.e. in the absence of a loop, the C hristo el sym bol vanishes, im plying the $m$ om enta are constants and the coordinates grow linearly with. In particular, one can choose the a ne param eter to be $t=P{ }^{0}$. A lso, since the non \{zero Christo el com ponents are all rst order, we can contract $w$ ith the zeroth order $m$ om enta, and further consider the C hristo el com ponents to be functions of only the zeroth order coordinates. Let us be explicit by considering the dim ensionless four velocity which is de ned by $=P=P{ }_{(0)}^{0}$ where $P_{(0)}^{0}$ is the zeroth order energy.

Let us now consider the light ray em itted from a static source residing at a distance $m$ uch greater than the size of the loop and traveling to a distant observer, that is, we will consider our source and observer to lie e ectively at in nity where spacetime is at. The com ponents of which appear explicitly on the right hand side of eq. ( $1 \mathbf{1} \mathbf{I}_{1}^{\prime}$ ) are zeroth order, and the perturbation in the $m$ etric $h$ is a function only of the zeroth order coordinates. Therefore, we can integrate eq. (14íli) explicitly giving

W e now require the $m$ etric produced by a string loop if we are to calculate the geodesic de ection; in the weak eld lim it, this problem has been solved. T he con guration of a string loop is described by the position of the string $f(; t)$, where $t$ is a tim e variable and is a param eter along the loop. The equations of $m$ otion for the string in M inkow ski space are given by

For any closed loop of length $L$, solutions for fm ust satisfy the periodic condition $f(+L ; t)=f(; t)$. In the center ofm ass fram e of the loop, the functions a and b are periodic as well, but this is not true in general. The description of the loop as given in eq. (20) also applies to loops that have a net $m$ om entum if we use the boundary condition $a(\mathrm{t}) \mathrm{a}(\mathrm{t}+\mathrm{L})=\mathrm{b}(+\mathrm{t}+\mathrm{L}) \mathrm{b}(+\mathrm{t})=$, where is the loop's center of m ass velocity.

Let us use eq. (24) to test the validity the weak eld approxim ation. Derivatives of $f$ are of order unity, so it follow s we m ay treat $F$ as order one. The integral over gives a term of order $L$, the loop length. R oughly then, the perturbation is small, i.e. $h \quad 1$, when $\dot{x} \quad \mathrm{fj} G \mathrm{~L} . \mathrm{The}$ string energy density is given by $G<10{ }^{6}$, so that the weak eld approxim ation will break down only for photons which comewithin a sm all fraction of the loop length of striking the string itself, im plying that, for $m$ ost lensing scenarios, the approxim ation is valid. There is, how ever, an exœeption to this estim ate in the case of cusps. Cusps are points on the loop which m om entarily achieve the speed of light as the string oscillates, and, if the velocity of the cusp points in the direction of the photon tra jectory, the de ection can be singular [1] [1]. H ow ever, cusps only occur instantaneously, and the probability of a photon encountering one $m$ ay be neglected.

Eq. (24) m ight seem to be the appropriate starting point for calculating ray de ections, but we shall see that it is $m$ ore convenient to solve this problem in Fourier rather than coordinate space. To avoid confusion, let us use the follow ing conventions,

O ne should note that $f$ is $m$ easured from an origin chosen som ew here along the zeroth order photon tra jectory and not from the loop center ofm ass. Later we shall nd it m ore convenient to decom pose $f$ into a com ponent rm easured form the center of $m$ ass and $x_{0} m$ easured from the origin on the photon path, but for com pactness we stay $w$ th $f$ for now. ## A.B asic Lens Theory

In the previous section we derived an expression for the de ection of the photon $m$ om entum that passes near a cosm ic string loop. N ow we would like to use this expression to determ ine how an intervening string loop a ects the im ages of various sources. Let us de ne an origin which is located at the center of $m$ ass of the loop, so the vector $r(; t) w i l l$ trace the loop $m$ easured from this origin. Further, we shall de ne a second vector $x_{0}$ which points from the loop center ofm ass to the location of the photon at $t=0$, so we may rew rite $f$ as the di erence $r \quad x_{0}$. N ow let us de ne the optical axis as the line connecting the loop center of mass to the observation point, that is $r_{k}$ and $x_{k}$ both point in the direction de ned by the ray connecting the loop center of $m$ ass $w$ th the observer. Since the source rays which are likely to be a ected by the loop com e in at very shallow angles, we can treat them as rays parallel to the optical axis for the punposes of calculating. We shall also assum e that the de ection occurs instantaneously in the lens plane de ned as the plane norm al to the optical axis located at the loop center ofm ass. In each case, these approxim ations are accurate to term s of order the loop size over the distance of the source or observer to the lens (w hichever is sm aller) . For the loops we shall.be considering, these approxim ations willbe m ore that adequate, since typical distances are on the order of the horizon while the loop size is about a factor $G$ sm aller than that.

In Fig. '11 we show a schem atic representation of the lensing system. A source lies in a plane penpendicular to the optical axis a distance $D_{\text {is }}$ from the lensing plane at the point $S$. The two dim ensional vector in the source plane points from the optical axis to the source. A ray em itted from the source intersects the lensing plane at $I$, and the two dim ensional vector in the lensing plane points from the opticalaxis to I. At I, the ray is de ected by the vector . To be observed, the ray must intersect the observer O at a distance $D_{1}$ from the lens plane on the optical axis. For sm all de ection angles, this condition is $m$ et if

$w$ here $D_{s}$ is the distance from the observer to the source plane. $T$ his form ula, referred to as the lens equation, gives us the location of a source, , given the location of its im age, . U sually we are interested in the inverse problem, nam ely given a source location, where are its im ages located. $N$ ote that the invense ofeq. (3). ${ }^{(35}$ ) is not necessarily single valued, so it is possible that a particular source has m ultiple im ages.

W em ust digress for a $m$ om ent to discuss exactly what is $m$ eant by distance in the lens equation, for in an expanding universe, severalde nitions of distance are possible. For exam ple, if the universe w ere seeded with sources of a know $n$ absolute lum inosity, one could de ne the distance to any of these souroes to be proportional to the square root of the absolute lum inosity divided by the observed ux. H ow ever, for the case of gravitational lenses ( $F$ ig. 1), we are interested in the angular size of an im age as it appears to a terrestrial observer, and we nd that the hum inosity distance is not the best choice. W e should then like to de ne the angular diam eter distance, $d_{A}$, as the ratio of the ob ject size and the angle that the ob ject subtends at the location of the observer. Then, using an FRW m etric and assum ing a at, matter dom inated universe with no cosm ological constant, it is easy to show that the angular diam eter distance is [1]

G iven an extended source, not only can a lens change the location and num ber of im ages observed, it can also a ect the $m$ agni cation and shape as well. To see this, let us, for the sake of convenience, rst rede ne the lens equation in term s of dim ension less variables. The loop length $L$ is de ned in term s of the energy of the loop as $\mathrm{E}=$. A convenient length scale for us is the loop radius which we de ne as $\mathrm{R} \quad \mathrm{L}=2$. If we de ne

O ne interesting question to ask, then, is given a narrow pencilbeam em itted by the source which subtends a solid angle d! , what is the solid angle d! subtended by its im age? This question is directly related to the issue ofm agni cation as the observed ux relative to the em itted ux is just the ratio of the solid angles d! =d! . The answerm ay be found by looking at the Jacobian $m$ atrix

For $m$ any lensing system $s$, there $w$ ill exist curves in $x$ for which ( $x$ ) is in nite or equivalently the determ inant of the Jacobian vanishes. These curves are referred to as critical curves, and the corresponding $m$ ap of the critical curves into the source plane are called caustics. C austics play an im portant role in determ ining the num ber of possible im ages. C onsider a system forw hich the Jacobian never vanishes. T he lens equation is then globally invertible and therefore single valued. T hus when there are no caustics, there can be only one im age of the source. If there exists a caustic, then the lens equation is only locally invertible and there $m$ ay be $m$ ultiple im ages. In fact there are $m$ any general theorem $s w h i c h ~ c a n ~ b e ~ p r o v e d ~ a b o u t ~ c a u s t i c s ~ a n d ~$ im ages; we shall not discuss them here, but the interested reader is directed to a detailed review of the subject of gravitational lensing by Schneider, Ehlers and Falco [1]].

W e have seen how a lens can a ect the magni cation of an im age, and we would now like to show how a lens can change the shape of the observed im age. W e shall restrict ourselves here to a discussion of sm all souroes so that we $m$ ay treat the problem di erentially. C onsider two points on a source separated by a distance Y. From the lens equation we can see, to rst order in the Taylor expansion, that the im age displacem ent X will be

$N$ ow consider a source that is a sm all circle. From eq. (4) we can surm ise that the im age willbe an ellipse w ith $m$ a jor and $m$ inor axis pointing along the eigenvectors of $A$ with lengths equal to their eigenvalues. The $m$ ost dram atic results w ill appear near a critical curve. H ere, usually one of the eigenvalues of A ${ }^{1}$ blow $s$ up, so that im ages are not only $m$ agni ed, but stretched as well. W hat is observed is a stretched im age, but since the ux grow sin proportion to the area, one observes an im age which appears to be a stretched version of the souroe but w ith the originalbrightness.

## B.An A nalytic Exam ple: T he P erpendicular Circular Loop

In this subsection, we w ill consider a sim ple exam ple of a circular loop which lies in a plane penpendicular to the optical axis. This problem has the virtue ofbeing analytically soluble, and it will also illustrate som e of the features that $m$ igh be expected for a $m$ ore general loop. M ost notably, there is a discontinuity in the de ection as light rays go from passing through the loop to passing outside it which notioeably in uences the resulting im ages.

Let us begin by choosing the $z$ direction to point along the optical axis. For the penpendicular circular loop, the con guration of the string is given by

O ne nds that for im age points such that $x<r^{0}$, the residues cancel and there is no de ection, but for im age points such that $x>r^{0}$, the result is non $\left\{z^{2} a^{13}\right.$. . W e point this out because in principle the de ection for any loop can be reduced to nding residues of a com plex contour integral. In practice, how ever, the problem is com plicated by the need to solve eq. (33Z") to get to as a function of , and there appears to be no advantage in using the calculus of residues over num erical integration to nd, although there $m$ ay be other cases aside from the circular loop where this $m$ ethod could be usefully applied. Retuming to the circular loop, one nds that $(x)=0$ if $\dot{x} j<r^{0}$ and

For rays passing outside the loop, the de ection is exactly the sam e as if the loop were replaced by a point $m$ ass. Inside the loop, the ray is unde ected, a feature which distinguishes a norm al circular loop from a point source.

N$ ofe that this de nition is consistent $w$ th the fam iliar de nition of the $E$ instein radius of a point $m$ ass, nam ely $R_{e}=4 G M D_{1 s} D_{l}=D_{s}$, where for a string the $m$ ass is just $M=2 R$. So, if $\bar{C}>r^{0}$, the loop lens $w$ ill have a circular critical curve w ith radius
$\overline{\mathrm{C}}$, but if $\overline{\mathrm{C}}<r^{0}$ there w ill be no critical curve. In the latter case, the loop would be di cult to detect because there will be only one im age of the source which will not be signi cantly distorted or magni ed. In the form er case ( $\overline{\mathrm{C}}>\mathrm{r}^{0}$ ) there are, strictly speaking, tw o criticalcurves because the discontinuity at the location of the string should be sm oothedout on a scale given by the thickness of the string. Then the rst critical curve is the usualE instein ring $w$ ith radius $\bar{C}$ and the second occurs because the determ inant of $A m$ ust change from a positive value (nam ely 1) inside the loop to a negative value just outside the loop (nam ely $1 \quad C^{2}=r^{04}$ ) and hence detA $=0$ when the light ray passes through the string ${ }^{4}$. For the case of the circular loop, we can analytically invert the lens equation as well, and after a little algebra we nd

To help visualize this rather com plicated picture, we show in $F$ ig. $\overline{i n}$ a series of im ages for a circular source as it is displaced further aw ay from the optical axis. W e have chosen a loop radius riol 1 w ith a value of $\mathrm{C}=2.25$ corresponding to an E instein radius of 1.5 . It follow s that there are two critical curves w ith radii $r_{c}=1$ and $1: 5$

[^2]The penpendicular circular loop is one of the few cases which $m$ ay be treated analytically, but it is not a very generic loop. In this subsection, we would like to consider a few exam ples which represent m ore general cases of cosm ic string lenses. W e will consider loops which are neither planar nor oriented in any special way with respect to the optical axis and are characterized by reasonable astrophysical param eters.

Suppose that we have a bright galaxy or chuster of galaxies at a redshift of $z \quad 2$ which is lensed by a cosm ic string loop. W ill a \typical" loop produce any observationally distinctive im ages? The answer to this question depends roughly on the value of the $E$ instein radius of the system. For a general loop, we de ne the $E$ instein radius as

so if we were to replace the loop with a point source $w$ ith $m$ ass equal to the $m$ ass of the loop, the critical curve would be a circle with the $E$ instein radius. If $R_{e} \quad R$ then the im ages which would be signi cantly distorted by the string loop will appear to be sim ilar to those of an equivalent point source. If $R_{e} \quad R$, then the loop will not have a signi cant a ect on any i ages of the source as $m$ ost of the $m$ ass of the loop $w i l l$ lie outside the $E$ instein radius. If string loops are to produce distinctive im ages, we should have $R_{e}$ R. So let us consider what may be reasonable param eters for a loop lens system.

W e can estim ate the size of a \typical" string loop on the basis of the string netw ork evolution described in Sec. iII. Loops are expected to be produced from the netw ork of long strings with typical size $R \quad G \quad t(z=1)=2$. These loops gradually lose their energy to gravitational radiation (eq. (ill)) but survive for about one H ubble period. (W e are assum ing that the loops are not further fragm ented signi cantly by self-intersections. If that is the case, we w ould need to divide the size estim ate by the expected num ber of fragm entations and factor in the survival period in the estim ate of the lensing probability in Sec. "İ.) Then, using this value for the loop radius, taking $=60$ and locating a source at $\mathrm{z}=2$ and the loop at $\mathrm{z}=1$, the E instein radius is given by

which is in just the right range for distinctive string lenses. Further note that the result $R_{e} \quad R$ is independent of the string tension and so the stringy nature of loop lensing is im portant for strings of any $m$ ass density. W e therefore expect that the im ages produced by string loops will have characteristic features of stringy lenses, thus o ering the realistic hope that strings $m$ ay be observed de nitively through gravitational lensing ${ }^{151}$.

W e shall consider tw o classes of loops to ilhustrate the kinds of im ages that one $m$ ay observe $w$ ith cosm ic string loops. The rst is a $m$ ixture of the fiundam ental and the rst excited $m$ ode

W e shall call this the \three\{ loop" for short. In general, the coordinate system which de nes fi; j; kg, i.e. the loop coordinates, can be rotated w th respect to the optical axis, which, for convenience, we shall de ne to be the $z$ axis.

[^3]T he relative orientation of the system s can be described by the three Euler angles. H ow ever, we are not particularly interested in the orientation in the sky, so it is su cient to consider only two of the three. Thus, if we start with the system $\mathrm{sfx} ; \mathrm{y}$; zg and fi; j; kg aligned, we shall rst rotate the loop in the $\mathrm{x} \quad \mathrm{y}$ plane from x to y through an angle ${ }_{1}$. Then we shall tilt the loop $w$ ith respect to the observer by rotating in the $y \quad z$ plane from $y$ to $z$ through an angle 2 , giving us the nalorientation of the loop coordinates $w$ ith respect to the opticalcoordinates.

To nd the im ages for a given source is a num erically non (trivial problem because one has to invent eq. (3) to get as a function of . This involves nding sim ultaneous roots of two equations in two dim ensions. But, as there are no general m ethods to solve such a problem, we are left $w$ th no choice but to $m$ ap the entire im age plane ( ) into the source plane () and then consider the inverse $m$ apping. (In practice, a lattice of points in the im age plane is $m$ apped on to the source plane.) To locate the im ages for a particular source point, we test every triangle in the im age plane that can be form ed by three neighboring points on the lattioe. If, when $m$ apped to the source plane, the im age triangle encom passes a souroe point, then we know that the source has an im age located som ew here inside the im age triangle. C alculating entails perform ing one num erical integration, so the inversion process is reasonably cheap w ith regards to cpu tim e and good resolution is possible. The triangle search $m$ ethod, how ever, has one failing when nding im ages with strings. Since will be discontinuous for light rays which pass just to either side of the string, im age triangles which are form ed by points on either side of the loop $m$ ay encom pass sources which they w ould not if all the im age points were on one side or the other of the loop. These are spurious im ages as they require the light rays to pass through the string_itself, so we have rejected these points when constructing the im ages of speci c sources (see the discussion in Sec. 'IV $\overline{\mathrm{B}} \mathrm{B}^{\prime}$ ).

Let us now use this technology to generate som $e$ im ages for the loops which we have discussed in this sectionn. In Fig. 1 given by which is de ned as the time at which the light ray intersects the lens plane $\mid$ the plane nom al to ${ }^{\wedge}$ and containing the loop's center of $m$ ass. For this rst example, $=0$. The source is located at a redshift of two, the loop at a redshift of one and the loop radius has been chosen to give an $E$ instein radius of $R e=R=1$ which we have show $n$ to be a typical value. This choice corresponds to a loop radius of $\mathrm{R}=2: 310^{5} \mathrm{H}{ }^{1}$. The upper left w indow show s the m apping onto the souroe plane of a series of vertical lines spaced evenly at intervals of 0.02 R in the im age plane. The upper right panel show s the critical curves, the im ages of in nite $m$ agni cation, for this exam ple. The low er left panel show s the unlensed im ages of a grid of source circles each de ned by 15 points. Finally, the low er right panel show s the im ages observed for the loop lens along w ith the projection of the loop. (T his eld of sources is prim arily illustrative; realistic galaxies are larger com pared to realistic loops, and a subsequent set of gures will address this issue.) Im ages were found by the aforem entioned $m$ ethod with a grid resolution of 200 200. Figurelin show sthe sam e tw o\{loop now rotated through $2=0$, but now we only show the lensed eld and the critical curves.

 sam e three\{loop, but now at a phase $=120$.

In the next series of gures, we considerm ore realistic im ages that m ight be observed with a loop lens and a distant galaxy. Recall that we expect the typical loop radius to be $G t=2$. Taking $=60$ and locating the loop at a redshift of $z=1$, one nds that the loop subtends an angle of $32 \mathrm{G} \quad 6 \operatorname{arcsec}$, where $\mathrm{G} \quad 6 \quad 10^{6} \mathrm{G}$. . W e have already stated that G 61 if strings are responsible for seeding structure form ation, but we can $m$ ore precisely constrain th is value. The best data com es from the observation of the cosm ic $m$ icrow ave background. If strings are responsible for the large scale tem perature uctuations observed by COBE, then $\mathrm{G}_{6}=1: 5 \quad: 5$, as calculated by Bennett, Stebbins and B ouchet [2] $]$. Below this range, strings cease to be interesting candidates for structure form ation. U pper lim its on the string tension have also been set by observing $m$ illisecond pulsars. The most recent data suggests that $G{ }_{6}<2$ [3]1]. W e consider G $6=1: 25$ so that our loop diam eter subtends an angle of 4 arc seconds. The angle subtended by the visible portion of a distant galaxy at redshift $z \quad 2$, is roughly 1 arc second. In $F$ igs. exam ples of the $i m$ ages form ed w ith a circular source $w$ ith radius 1 arc sec for each of our loop exam ples $w$ ith $R=2$ acr sec. In each case the $E$ instein radius was xed to be one corresponding to a source redshift of about tw o. Source locations w ere chosen in these exam ples prim arily to show som e of the $m$ ore interesting features of the loop lenses.

[^4]The exam ples in the previous section $m$ ay not represent an exhaustive sam ple of possible loop con gurations, but they do show som e of the generic features of loop lenses. Forboth the tw o lloop and the three $\{$ loop, w e have considered con gurations for which the pro jected loop lies near the $E$ instein radius and $m$ ore com pact con gurations which reside well inside the E instein radius. For the form er case, F igs. ${ }^{\prime}$ lens, we can have im ages which pass through the center of the loop and lie close to where the unlensed im age would be. $T$ his is perhaps the distinguishing feature of loop lens im ages. In $F$ igs. 17 undistorted im ages encircled by arcs and rings in a m anner unlike what one would expect for a m ore hom ogeneous
 som e exam ples w ith three im ages which $m$ ay be distinguishable from ordinary lenses. Still, for all loops, one feature alw ays di erentiates them from ordinary lenses: nam ely that the lens itself is dark.
$W$ ould the observation of lensed im ages lacking an observed lens in itself con $m$ the existence of cosm ic string loops? U nfortunately, the answ er is no; the existence ofdark lenses in and of itself w ould not be conclusive since there are other possibilities. For exam ple, it has been suggested that dark $m$ atter could form halos w ithout a lum inous com ponent and these would result in dark lenses [1] [1d]. $K$ andasw $a m, R$ ees and $C$ hitre $[19]$ found that a single dark $m$ atter halo is not su ciently dense to produce multiple in aging, but the alignm ent of tw o such halos could. Typical im age separation w as on the order of a few arc seconds, sim ilar to the string loop case. H ow ever, these halos w ill have a distribution of $m$ atter consistent $w$ ith collisionless particles (i.e. an isotherm al sphere), so their im ages should be distinguishable from string loops. A second possibility is that the net e ect ofm any distant lenses which individually would not produce $m$ ultiple im ages could add together to produce such an e ect. This, how ever, has been show $n$ to be statistically unlikely [20_]. Perhaps the sim plest explanation for a dark lens is that it is not dark at all. A cluster of galaxies could produce two im ages which are separated on arc second scales, w ith a third located typically an arc $m$ inute aw ay. The third im age could easily go unnoticed creating the false im pression of a dark lens [21]. But again, the im ages should be distinctly di erent than those of a string loop. T he good new s then is that string loop lenses are distinguishable from other dark lens possibilities, especially loops which are not com pact with respect to their $E$ instein radius. Should a dark lens be con m ed, detailed observations of the im age structure ought to determ ine the nature of the lens.

A nother possibility that we have not exam ined in detail in this paper but that is am enable to an identical analysis is the lensing due to wiggly long strings. The presence of $w$ iggles on long strings $m$ eans that the long string can probably be regarded as a sequence of sm all loops. In this case, we should observe a linear sequence of dark lenses w ith each lens having the characteristics of a string loop lens. Such a lens is unlikely to occur in the context of any other model.

## VI. CONCLUSION

In this paper we have derived a m ethod for calculating the de ection of light rays due to the gravitational eld of an oscillating string loop. We have shown that this problem can be reduced to an e ective static problem, greatly sim plifying calculations. T he form alism was then applied to the problem of gravitational lensing by cosm ic strings, and using typical loop param eters, we have show $n$ that a loop lens produces im ages on arc second scales, sim ilar to galactic size ob jects. Speci cally, we nd that for $\left.G \quad\left(\begin{array}{ll}1 & 2\end{array}\right) 10^{6} \right\rvert\,$ values consistent with structure form ation, $m$ icrow ave background anisotropies and $m$ illesecond pulsar tim ing lim its | strings can produce im ages separated on arc second scales which would be observable by both ground based telescopes and the H ubble space telescope and would have features that are distinctly di erent from other dark lens candidates. This suggests that string loops can be de nitively observed as gravitational lenses. Furtherm ore, the lensing due to long strings would appear like a linear sequence of lensings due to loops and these would be the unm istakable ngerprints of cosm ic strings.

The tem perature uctuations induced by cosm ic string loops has previously been investigated by Stebbins $\overline{\underline{p}} \overline{1} /$, using the harm onic gauge as we have done here. Stebbins, how ever, used the real space retarded G reens function to nd the change in 0 , but, as we are solving the problem in Fourier space, it is usefiul to com pare our results. Let us retum then to eq. ( $3 \mathbf{3}_{1}^{\prime}$ ) and replace $k$ with $k_{k}$ or equivalently $k_{0}$. W e should point out that both term $s$ in eq. (A3) are necessary for calculating the icrow ave background anisotropies produced by string loops. In exam ples, how ever, we found that the contribution of the logarithm ic term to the tem perature uctuation was only a few percent at most, and so we suspect that, in general, the logarithm ic term that

A lso, their spherical sym $m$ etry will lead to lensing that is harder to di erentiate from that due to conventional sources.

[^1]:    ${ }^{2}$ A w ord of caution: the realuniverse, especially at late tim es, is, clum ped and only hom ogeneous on average. A better distance choice $m$ ay com efrom $m$ odels like the $D$ yer\{R oeder equation [15], but for the present we prefer not to consider these technical questions.

[^2]:    ${ }^{3} \mathrm{~T}$ h is discontinuous behavior w ill hold for all loops and is easily understood in term $s$ of the $m$ otion of poles in the com plex plane.
    ${ }^{4} \mathrm{~T}$ h is second critical curve is of no observable interest since the string thickness is a m ere $10{ }^{30}$ am s or so. It does have form al signi cance when considering lensing theorem $s$.
