Supercurvature M odes from P reheating in an Open U niverse

P reheating following the in ationary phase in m odels of open in ation is considered. The m ost signi cant di erence from a preheating scenario in at space is that supercurvature m odes can be populated and am pli ed in the open universe. In certain m odels, such m odes can dom inate the usual resonant particle production, thus altering the ensuing therm alhistory w ithin an open universe. The accuracy to which the m asses and couplings need to be tuned to produce such supercurvature m odes, how ever, m akes any large deviation from the at space cases unlikely.

I. IN TRODUCTION

There has been much activity lately in two exciting areas of in ationary cosmology: the construction of \open in ation" models, and the developm ent of a new theory of post-in ationary reheating. To date, these two developm ents have been treated separately; in this paper, we explore som e qualitatively new behavior for the reheating epoch in an open universe. The open in ation models [1 {3] exploit the fact, rst noted by Colem an and De Luccia and independently by Gott and Statler [4], that the metric on the interior of a bubble nucleated in a sea of de-Sitter-like false vacuum would be that of an open Friedmann-Robertson-Walker spacetime. By arranging for an epoch of \slow-roll" in ation to occur within the nucleated bubble, and arranging for the num ber ofe-folds of expansion during this second in ationary phase not to exceed N 65, it is possible to produce an observable universe whose mass density today falls below the critical mass density required for a at universe: 0.2 0.3, rather than the standard in ationary pre-0 diction, $_{\circ} = 1:0$.

Independently, several groups have re-exam ined recently the process of particle production at the close of an in ationary phase, and have found resonances and exponential instabilities in the decay of an in aton eld into bosons, which had been overlooked in the original accounts of reheating. [5{11] A coording to the new theory of reheating, a post-in ationary second-order phase transition should be viewed as having three distinct stages, rather than the older two-stage picture: the highly e cient, often resonant, decay of the oscillating in aton eld into boson decay products (which might include in aton bosons them selves, due to the in aton's self-interaction), followed by the decay of these decay products (along the m ethods originally developed in [12]), follow ed nally by the therm alization of these particles and the establishm ent of the radiation-dom inated era. Kofm an, Linde, and Starobinsky term this rst, resonant stage the \preheating" stage. [5]

As demonstrated in this paper, under certain conditions the resonant decay of the in atom in an open universe can populate \supercurvature" m odes, which have no analogue in the at space case, and no particle-like interpretation. In some open in ation m odels the am pli cation of such supercurvature m odes can even dom inate the usual resonant creation of particles at the tim e of reheating. Thus, m odels of open in ation can display dram atically di erent therm all histories follow ing the end of in ation from in ationary scenarios in a spatially at universe.

A Friedmann-Robertson-Walker universe with nonvanishing spatial curvature has a physical curvature scale given by $a(t) = \frac{1}{1}$, where a(t) is the cosm ic scale factor, and K = 1 or +1 for an open or closed universe, respectively. W ith K =1, the com oving curvature scale is thus simply + 1. From the Friedmann equation it can further be shown that when K =1 the physical curvature scale will always be larger than the Hubble distance, H¹, for any cosm ological epoch. Eigenfunctions of the Laplacian operator can be found for this background spacetime with eigenvalue $(k=a)^2$, where (k=a)is the inverse of a physical length: k=a = 2 = ph, with $0 < k^2 < 1$. Modes with comoving wavenum ber $k^2 > 1$ thus vary on scales shorter than the com oving curvature scale, and are labelled \subcurvature" modes, whereas modes with $0 < k^2 < 1$ correspond to \supercurvature" modes. (See, e.g., [13].) (Note that tensor modes can have di erent values from scalar modes, such as $k^2 =$ 3 for gravitational waves. [14{16]) In a at universe, the com oving curvature scale runs o to in nity, so there are never supercurvature modes. It is this di erence from the at space case that we exam ine here, for the epoch of preheating: even though ! 1 at the end of the second round of in ation, there will still exist a com oving curvature length scale at + 1, the existence of which m ay change the usual physics at the time of preheating.

We begin the study following the nucleation of a single bubble in the midst of a sea of de Sitter space false vacuum. Inside the nucleated bubble, there is a nonvanishing scalar eld potential and a single relevant scalar

eld to drive a second round of in ation within the bubble; both the single- eld models of open in ation [1,2]and Linde's two- eld \hybrid" open in ation model [3] t such a description. Inside the bubble, the Lagrangian density can thus be written:

Switching to conformal time, $d = a^{1}dt$, and using the expression for the d'Alembertian, $2' = (g)^{1=2}Q$ ($g)^{1=2}g$ Q', then inside the bubble equation (4) takes the form :

where primes denote derivatives with respect to conformal time, , and \mathbb{L}^2 is the comoving Laplacian operator. Eigenfunctions of \mathbb{L}^2 in the metric of equation (2) have been studied by many people (see, e.g. [16,17]). Denoting these harm onics as $Y_{k\,lm}$ (;;), with $\mathbb{L}^2Y_{k\,lm}$ = $k^2Y_{k\,lm}$, then we may parametrize the uctuations in terms of mode functions as:

(W e will not need the explicit form of the Y_{klm} 's here, which can be written in closed form in terms of associated Legendre polynom ials. [16]) Finally, if we write $(({}^{2}V={}^{0}{}'^{2}))_{,o}$ as M² ('_o), then the equation for the in aton uctuations becomes:

(W e have neglected the m etric perturbations which couple to $_{\rm k}$, which should be a good approximation during the reheating epoch; for more on such metric perturbations, see [18].) In this paper, we will be concerned with the behavior of solutions of equation (7) after the end of in ation, as the in atom eldo' oscillates near the minimum of its potential.

In Section II, we brie y review the conditions under which the oscillating in atom may decay resonantly into bosons. In an open universe, with the possibility of populating supercurvature modes during the in aton's parametric resonance, we must pay closer attention than is usually done to the conditions under which the in aton's decay m ay be resonant: the harm onic relations between the frequency of the in aton's oscillation and the decay products' momenta are speci ed here for all resonance bands within the narrow resonance regime. In Section III, these resonance conditions are studied for the sim plest model of an in aton decaying into in aton bosons, due to a '⁴ self-coupling. As will be shown, in this case no supercurvature modes may be populated during preheating, and there should be no deviation from the usual at space case. The model is generalized in Section IV to the case of an in aton decaying into a distinct species of boson, via Yukawa and quartic couplings, and in these cases supercurvature modes can be populated, if the masses and couplings of the model satisfy certain relationships to very high accuracy. None of the resonant behavior will a ect in aton decay into ferm ions, because of Ferm iD irac statistics, and we will ignore such couplings here. The results are discussed in Section V.

II. PREHEATING AND RESONANT DECAYS

Near the minimum of its potential, the in aton will begin to oscillate, and this can set up a param etric resonance in the in aton's decay to bosons. [5] Assum ing that the frequency of the in aton's oscillations is greater than the Hubble parameter at this time, we m ay neglect Hubble expansion during the course of the resonant decays. Then the in aton eld oscillates as $'_{\circ}$ () $'_{-\circ}$ cos(! $_{osc}$), where $\overline{'_{\circ}}$ is slowly decreasing on the oscillation time-scale $!_{osc}^{1} = (a_{em})^{1}$. Here a_{e} is a constant giving the value of the cosm ic scale factor at the end of in ation. Note that $(a_{e}H_{e})^{1} < 1$, as will be true for any cosm ological epoch in an open universe. Hence, our assumption about the frequency of the in aton's oscillation translates to $(a_e m)^{1}$ $(a_e H_e)^{1} < 1$, 1. The M² ($'_{0}$) term then contains two types or a_m ofterm s, oscillating and non-oscillating, and m ay be written:

where A, B, and q are determined by a given model's particular couplings. The equation of motion for the inaton uctuations, equation (7), then becomes:

This is now in the form of the Mathieu equation, solutions of which reveal exponential instabilities within various resonance bands.

The narrow resonance regime of equation (9), with g < 1, can be studied perturbatively. The analytic analysis in [6,8,9] demonstrates that in this case the solutions are exponentially unstable in narrow resonance bands $nq!_{osc} = 2!_k = \frac{1}{2}j_n j$ with $j_n j < !_k$, and n a positive integer. Each resonance band with n > 1 corresponds to keeping terms of O (g^n) in the solution to equation (9), and the width of each successive resonance band in the narrow resonance regime shrinks as [19]:

N ear the center of each resonance band, solutions take the form

with $s_k^{(n)}$ real and positive. M odes with a given k^2 slide out of the resonance band due to the slow decrease of $\overline{}_{o}$, and hence of g, due to scatterings and back-reaction e ects. Given such a time-dependence of g, m odes will only become resonantly ampli ed if they initially satisfy

m odes initially satisfying nq! $_{\rm osc} = 2!_k \frac{1}{2} j_n j$ on the bottom edge of the resonance band, will not remain within the band long enough to become am pli ed. We will thus study equation (12) for various models to determine which areas of parameter space allow for the production and am pli cation of supercurvature modes. The subcurvature modes should behave as in the at space case, and hence we will not treat them further here.

As demonstrated explicitly in [9], including a nonzero Hubble expansion during the period over which the in-

aton oscillates does not change the qualitative form of these solutions, but merely narrows the width of the resonance bands. Similarly, including back-reaction and rescattering e ects should further decrease the width of each resonance band. [5,7,8,10,20,21] W e may accom - modate these e ects by inserting a phenomenological parameter (), with 0 < () < 1, into the band width, writing the width of each resonance band as $j_n j = b_n^{-n}$ ()gⁿ!_k, though we will set = 1 in the following.

The broad resonance regime of equation (9) (g 1), identi ed in [5], has been studied analytically in [10], and

also leads to solutions of the form $k_{k;n} / \exp(\frac{k_{k}}{k})$, with $k^{(n)}$ real and positive (and $k^{(n)}$ $s_k^{(n)}$). However, such a broad resonance regim e is ruled out form ost quartic couplings [10]; and even for models with Yukawa couplings between the in aton and a distinct species of boson, the coupling strength (and hence g) may not be made arbitrarily large, because such large couplings would interrupt the usual in ationary dynam ics prior to the preheating epoch. Furtherm ore, the particles produced during a broad resonance have much higher momenta than particles produced in the narrow resonance regim e, and hence no supercurvature m odes are expected to be populated from a broad resonance. For these reasons, we will restrict attention here to the narrow resonance regime for each of the models studied below.

III. IN FLATON DECAY INTO IN FLATON BOSONS

In this section, we consider a model in which the oscillating in aton eld decays into in aton bosons, due to a ⁴ self-coupling. Near the minimum of its potential, any model of open in ation should assume a general chaotic in ation form [22]:

Note from the form of g in equation (14) that g < 1always in this model: in the case of in aton decay into in aton bosons, the only possible resonances lie in the narrow resonance regime, and hence the explicit expressions in section II may be used. Finally, for the potential of equation (13), the oscillating term in equation (9) oscillates at frequency $2!_{osc} = 2a_{e}m$, or q = 2, after use has been m ade of a double-angle form ula for $\cos^2 (!_{osc})$. G iven that $a_{e}m = 1$, we need only consider wavenum – bers in the range $0 < k = a_{e}m$ in our search for any supercurvature m odes which m ay be resonantly am plied during preheating. De ning

As emphasized in [8,10], the exponential instabilities arise for solutions of any di erential equation with periodic $\cos - \operatorname{cients}$, and are more general than the particular form of equation (9).

Keeping only the lowest-order terms in ', this gives

W hen n = 1, the quantity on the righthand side of equation (18) is negative, revealing that neither supercurvature nor subcurvature modes will be amplied in the lowest resonance band when $k < a_em$. For n > 1, the approximation ' 1 is violated, and thus equation (18) cannot be used to study resonant subcurvature modes. Instead, it can easily be demonstrated that when '> 1 (and hence for subcurvature modes only), resonant modes correspond to

again revealing that no consistent solution (with k_{res} real and positive) m ay be found for n = 1. Thus, for the potential of equation (13), only subcurvature m odes m ay be am pli ed during preheating, and only in the narrow resonance regim e with n = 2.

For this particular potential, a lim it on g m ay be set by the independent constraints on m and from ob-10 14, served m icrow ave background an isotropies: and $m = M_{pl}$ 10⁶. [18] An upper bound m ay be placed on $\overline{_{\circ}}$ by equating this with the value of $\overline{_{\circ}}$ once in ation ends, that is, once the slow -roll conditions are violated, at $(0^2 V = (0^2 V)^2 V$ 24 M_{pl}²V. This gives \overline{V}_{0} 0:16M_{pl} (using the constraints on and m), or $\tau_0^2 = m^2$ 104, 2:6 guaranteeing that $g = 4 = 10^4$. With so smallag, resonance bands with n > 2 are unlikely to produce large occupation numbers of in aton bosons, and the resonant decay of the in aton may be rather ine cient in transferring the energy density of the decaying in aton eld into boson decay products. Such tight constraints on the potential's parameters are absent in the case of in aton decay into a distinct species of boson, assuming that the second boson eld is unimportant during the in ationary phase (when the prim ordial density perturbation spectrum is determined). It is to these models that we now tum.

IV.INFLATON DECAY INTO A DISTINCT BOSON SPECIES

In the case of in aton decays into a distinct species of boson, , we may study a potential of the form :

In supersymmetric models, these couplings will satisfy = 2 m. [21] W riting = a 1 ()f ()Y_{plm} (x), the equation for f () will assume the same form as equation (7), with M 2 ! $(2^2V=0)^2 = m^2 + 2' + 2^{2'^2}$. Again taking ! $_{osc}^{1} = (a_em)^{1}$ (a_eH) ¹, the -m odes will obey:

Note from the form of h_1 that $h_1 < 1$ always, so only the narrow resonance regime is viable for the quartic coupling. If we rst consider h_2 ! 0, and if the mass difference between the in atom and the boson is small, then modes with k $a_{e}m$ will become exponentially amplied in bands centered on:

The next order term is of 0 ($k^4 a_e^{-2m} ^2$), which will be completely negligible if $0 < k^2 < 1$ and a_em 1. Though the form of equation (22) for k_{res}^2 boks quite sim – ilar to the corresponding expression for '!' decays, equation (18), there are important di erences. First, there are now two free parameters, (m = m) and h_1 , rather than only the single free parameter g in equation (18). Second, the coupling constant (and hence h_1) is not limited directly by today's observed m icrow ave background spectrum, because it is assumed that the –

eld plays no role during in ation, so h need not be constrained to h_1 O (10⁴) as g is. Finally, the ratio (m =m) may be either greater or less than unity: as noted in [5], it is possible for the in atom to decay into a particle heavier than itself during the resonant preheating stage (a decay which is kinem atically forbidden according to non-resonant B om theory). Thus, supercurvature m odes will be produced and resonantly am pli ed in a resonance band n which satis es

é⁵ 10^{28} , then this is a very tiny window : the If a_a resonant production of supercurvature modes requires that the masses and couplings of the potential obey certain interrelationships to exponential accuracy. Still, by exploiting the freedom in (m = m) and , it is possible to arrange for such conditions to be met (and the nearlyexact cancellation of com binations of param eters is not in itself foreign to particle physics). Furtherm ore, if n = 1and h₁ 1, then all higher (subcurvature) modes could fall outside of resonance bands, leaving only the supercurvature modes to be produced and ampli ed at the preheating stage. Note that if m m, then equation (22) is inappropriate, and only subcurvature modes will be ampli ed at preheating. O ther resonant subcurvature modes, with k > $a_{e}m$, may be found analogously to equation (19), and will not be pursued here.

Sim ilarly, if $h_1 ! 0$ and the Yukawa coupling in equation (20) is active ($h_2 \in 0$), then supercurvature modes will be produced resonantly in a resonance band n if

in the narrow resonance regime, up to terms of O ($k^4 a_e^{-2} m^{-2}$). Again, the pair of parameters (m =m) and may be tuned to satisfy this condition, and if n = 1 and h₂ 1, then the production and amplication of supercurvature modes will dominate the preheating phase. As for the h₁ case, ifm m or if k > a_em, then only subcurvature modes will be produced at preheating.

C are must thus be taken to identify the (modeldependent) dominant decay channel of the in aton, especially if the two couplings in equation (20) are in com – petition with the in aton self-coupling in equation (13). The conditions under which the supercurvature modes may become ampli ed and dominate the production of subcurvaturem odes during the preheating phase depends sensitively upon the couplings and mass scales of the decaying in aton and its decay-product bosons. Note that although $k_{\rm res}^2$! 0 for these supercurvature modes, there is no infrared catastrophe, since every resonance band in the narrow resonance regime has a nite band width.

V.D ISCUSSION

W hat do these exponentially am pli ed supercurvature modes represent? In the usual at space preheating scenario, narrow resonance modes simply correspond to the production of low-momentum (small k) particles, whose occupation numbers may be estimated with the aid of a Bogolyubov transform ation. Yet in the open universe, such small-k modes can stretch beyond the curvature scale (and hence beyond the horizon), and no particle interpretation m ay be given to them. (This is a speci c example of how tenuous the notion of \particle" can becom e in general curved spacetim es. [23])^y Instead, they will contribute to (very) long-wavelength curvature perturbations, akin to supercurvature modes produced during in ation [14{16], though their evolution will be com plicated by the highly non-adiabatic nature of the reheating epoch. The detailed evolution of these modes

m ay be tracked using the methods of [18], though it is unlikely that they will contribute greatly to any observed m icrowave background anisotropies today, given their very long correlation lengths [13]; this is a subject of further study.

Rather, their most dramatic role could be in changing the therm all history in mediately following reheating: the new reheating scenario depends upon the explosive production of particles, far from thermal equilibrium; these decay products then them alize via interactions on a (potentially) quite di erent tim e-scale. W hen the occupation numbers of out-of-equilibrium decay-product particles becom es quite large, this opens up the possibility for such m icrophysical processes as non-therm al phase transitions [24], preheating-induced supersymmetry breaking [25], and GUT-scale baryogenesis [26]. Yet the foregoing analysis reveals that in an open universe, the (resonant) preheating production of particles m ay be either totally absent or strongly diluted, due to som e portion of the in aton's energy density being 'siphoned o' into supercurvature modes. For models in which the resonant production of subcurvature m odes is subdom inant, the in aton will still decay into particles and populate the universe following the end of the resonance regime, according to the processes of the older theory of reheating. If this resonant production of supercurvature m odes and non-resonant production of particles becom es the dom inant e ect, then these other m icrophysical processes in the post-preheating epoch m ay need to be reconsidered.

G iven the exponentially tiny supercurvature resonance regimes in equations (22) and (24), however, it is rather unlikely (though still possible) that the supercurvature modes from the resonant '! decays would dom in ate the preheating epoch. And such modes are completely absent from a strictly '! ' preheating epoch. Thus, large deviations from preheating scenarios in at space are unlikely to appear for models of open in ation.

Finally, as noted in the conclusion in [9], for models with non-minimally coupled scalar elds which recover the Einstein-Hilbert gravitational action near the end of in ation (e.g., models of the form studied in [27]), the analysis of reheating carries over unchanged. Thus, the recent open in ation model based on induced-gravity theory [28] should display the same resonance features and supercurvature modes as analyzed above.

^yA spointed out in [13], supercurvature modes should be absent from the mode expansion of any quantum eld in its vacuum state, since any square-integrable function may be de ned completely in terms of subcurvature modes; the production of supercurvature modes at preheating is consistent with the in aton's departure from the pure vacuum state at that time.
