A re Standard Solar M odels R eliable?

The sound speeds of solar models that include element di usion agree with helioseism ological measurements to a rm s discrepancy of better than 0.2% throughout almost the entire sun. Models that do not include di usion, or in which the interior of the sun is assumed to be signicantly mixed, are electively ruled out by helioseism ology. Standard solar models predict the measured properties of the sun more accurately than is required for applications involving solar neutrinos.

For alm ost three decades, a discrepancy has existed between solar model predictions of neutrino uxes and the rates observed in terrestrial experiments. In recent years, the combined results from four solar neutrino experiments have sharpened the discrepancy in ways that are independent of details of the solar models [1]. This development is of broad interest since a modest extension of standard electroweak theory, in which neutrinos have smallmasses and lepton avor is not conserved, leads to results in excellent agreement with experiments [2].

Since the implications of a discrepancy with the standard electroweak model are of great importance, the question persists: Can the solar neutrino problems be \solved" (or at least alleviated) by changing the solar model? This question has led to a series of generally unsuccessful ad hoc \N on-Standard" solar m odels [3] in which large changes in the physics of the sun are hypothesized in order to lower the calculated rate of the ⁸B neutrino ux. Over the past two decades, the most often hypothesized change is some form of mixing of the solar m aterial that reduces the central tem perature and therefore the important ${}^{8}B$ neutrino ux [4[9]. P revious argum ents that extensive m ixing does not occur are theoretical, including the fact that the required energy is ve orders of m agnitude larger than the total present rotationalenergy [3,9,10]. M ost recently, C um m ing and H axton [11] proposed a ow of ³He, characterized by three free param eters, designed to m ix the sun in such a way as to m in im ize the discrepancy between solar neutrino observations and predictions. By adjusting the param eters, these authors are able to reduce the calculated ⁷Be ux m ore than the ⁸B ux, a result not achieved in previous Non-Standard solarm odels.

The diagnostic power of helioseism ology [12] has been im proved recently through the developm ent by Tom czyk et al. [13] of an instrum ent that m easures with the sam e equipm ent the low - and interm ediate-degree m ode frequencies. By providing a consistent set of frequencies for the low est-degree m odes, w hich penetrate to the greatest depth in the sun, these data constrain the properties of the solar core m ore tightly than earlier m easurem ents.

In this letter, we com pare the solar sound speed c inferred from the rst year of data [14] with sound speeds computed from standard solarm odels used to predict solar neutrino uxes and nd a rm s agreem ent better than 02% over essentially the entire sun, with no adjustment of parameters. Since the deep solar interior behaves essentially as a fully ionized perfect gas, $c^2 / T =$ where T is temperature and is mean molecular weight; thus even tiny fractional errors in the model values of T or would produce measurable discrepancies in the precisely determ ined helioseism ological sound speed

This remarkable agreem ent between standard predictions and helioseism ological observations rules out solar models with temperature or mean molecular weight proles that dier signicantly from standard proles. The helioseism ological data essentially rule out solar models in which deep mixing has occured (cf. [15]) and argue against unmixed models in which the subtle elect of particle di usion {selective sinking of heavier species in the sun's gravitational eld{is not included.




FIG.1. C on parison of sound speeds predicted by di erent standard solar m odels with the sound speeds m easured by helioseism ology. There are no free param eters in the m odels; the m icrophysics is successively in proved by rst including di usion and then by using a m ore com prehensive equation of state. The gure shows the fractional di erence, c=c, between the predicted m odel sound speed and the m easured [12,14] solar values as a function of radial position in the sun (R is the solar radius). The dashed line refers to a m odel [16] in which di usion is neglected and the dotted line was com puted from a m odel [16] in which helium and heavy elem ent di usion are included. The dark line represents a m odel which includes recent in provem ents in the O PA L equation of state and opacities [17,18].

Figure 1 compares the sound speeds computed from three di erent solar models with the values inferred [12,14] from the helioseism ological measurements. The 1995 standard model of Bahcall and Pinsonneault (BP) [16], which includes helium and heavy element di usion, is represented by the dotted line; the corresponding BP modelwithout di usion is represented by the dashed line. The dark line represents the best solar model which in-

cludes recent in provem ents [17,18] in the OPAL equation of state and opacities, as well as helium and heavy elem ent di usion. For the OPAL EOS m odel, the rm s discrepancy between predicted and m easured sound speeds is 0.1% (which m ay be due partly to system atic uncertainies in the data analysis).

In the outer parts of the sun, in the convective region between 0:7R to 0:95R (where the measurements end), the N o D i usion and the 1995 D i usion model have discrepancies as large as 0:5% (see Figure 1). The model with the Livermore equation of state [18], OPAL EOS, ts the observations remarkably well in this region. W e conclude, in agreement with the work of other authors [19], that the OPAL (Livermore National Laboratory) equation of state provides a signi cant in provement in the description of the outer regions of the sun.

The agreem ent between standard m odels and solar observations is independent of the ner details of the solar m odel. The standard m odel of C hristensen-D alsgaard et al. [20], which is derived from an independent computer code with di erent descriptions of the m icrophysics, predicts solar sound speeds that agree everywhere with the m easured speeds to better than 0.2%.

Figure 1 shows that the discrepancies with the N o D iffusion m odel are as large as 1%. The m ean squared dis-

crepancy for the N o D i usion m odel is 22 times larger than for the best m odel with di usion, O PAL EOS. If one supposed optim istically that the N o D i usion m odel were correct, one would have to explain why the di usion m odel ts the data so m uch better. On the basis of F igure 1, we conclude that otherwise standard solar m odels that do not include di usion, such as the m odel of Turck-C hieze and Lopez [21], are inconsistent with helioseism ological observations. This conclusion is consistent with earlier inferences based upon com parisons with less com plete helioseism ological data [12,22,15], including the fact that the present-day surface helium abundance in a standard solar m odel agrees with observations only if di usion is included [16].

Equation 1 and Figure 1 in ply that any changes T=T from the standard m odel values of tem perature must be almost exactly canceled by changes = in m ean m olecularweight. In the standard m odel, T and vary, respectively, by a factor of 53 and 43% over the entire range for which c has been m easured and by 1:9 and 39% over the energy producing region. It would be a rem arkable coincidence if nature chose T and pro les that individually di er m arkedly from the standard m odel but have the sam e ratio T = . Thus we expect that the fractional differences between the solar and the m odel tem perature,

T=T, or m ean m olecular weights, =, are of similar magnitude to $c^2=c^2$, i.e. (using the larger m s error, 0:002, for the solar interior),

How signi cant for solar neutrino studies is the agreem ent between observation and prediction that is shown in Figure 1? The calculated neutrino uxes depend upon the central tem perature of the solarm odel approxim ately as a power of the tem perature, Flux / T^n , where for standard m odels the exponent n varies from n 1:1 for the p pneutrinos to n + 24 for the ⁸B neutrinos [23]. Sim ilar tem perature scalings are found for non-standard solar m odels [24]. Thus, m axim um tem perature di erences of 0.2% would produce changes in the di erent neutrino uxes of several percent or less, m uch less than required [1] to am eliorate the solar neutrino problem s.




FIG.2. Non-standard solar models compared with helioseism obgy. This gure is similar to Figure 1 except that the vertical scale is expanded. The dashed curve represents the sound speeds computed for the mixed solar model of Cum – ming and Haxton [11] with ³He mixing. The dotted line represents the sound speed for a solar model computed with the rate of the ³He(;) ⁷Be reaction set equal to zero. For comparison, we also include the results for the new standard model labeled OPAL EOS in Figure 1.

Figure 2 shows that the $\m ixed$ " m odel of C um m ings and H axton (CH) [11] (illustrated in their Figure 1) is grossly inconsistent with the observed helioseism ological m easurem ents. The vertical scale of Figure 2 had to be expanded by a factor of 2.5 relative to Figure 1 in order to display the large discrepancies with observations for the m ixed m odel. The discrepancies for the CH m ixed m odel (dashed line in Figure 2) range from +8% to 5%. Since in a standard solar m odel decreases m onotonically outward from the solar interior, the m ixed m odel{ with a constant value of { predicts too large values for the sound speed in the inner m ixed region and too sm all values in the outer m ixed region. The asym m etric form of the discrepancies for the CH m odel is due to the com – petition between the assumed constant rescaling of the temperature in the BP NoDi usion model and the assumed mixing of the solar core (constant value of). We also show in Figure 2 the relatively tiny discrepancies found for the new standard model, OPALEOS.

M ore generally, helioseism ology rules out all solarm odels with large am ounts of interior mixing, unless nelytuned compensating changes in the temperature are made. The mean molecular weight in the standard solarmodel with diusion varies monotonically from 0:86 in the deep interior to 0:62 at the outer region of nuclear fusion (R = 0.25R) to 0.60 near the solar surface. Any mixing model will cause to be constant and equal to the average value in the mixed region. At the very least, the region in which nuclear fusion occurs must be mixed in order to a ect signi cantly the calculated neutrino uxes $[3\{7\}]$. Unless almost precisely canceling tem perature changes are assumed, solar models in which the nuclear burning region is mixed (R < 0.25R) will give maximum di erences, c, between the mixed and the standard model predictions, and hence between the m ixed m odel predictions and the observations, of order

which is inconsistent with Figure 1.

A re the helioseism ological measurements sensitive to the rates of the nuclear fusion reactions? In order to

answer this question in its most extreme form, we have computed a model in which the cross section factor, S_{34} , for the ${}^{3}\text{He}(;)^{7}\text{Be reaction is articially set equal to}$ zero. The neutrino uxes computed from this unrealistic model have been used $[\beta]$ to set a lower lim it on the allowed rate of solar neutrinos in the gallium experiments if the solar lum inosity is currently powered by nuclear fusion reactions. Figure 2 shows that although the maximum discrepancies (1%) for the $S_{34} = 0$ model are much smaller than for mixed models, they are still large com pared to the di erences between the standard m odel and helioseism ologicalm easurem ents. The m ean squared discrepancy for the $S_{34} = 0$ m odel is 19 tim es larger than for the standard OPAL EOS model. We conclude that the $S_{34} = 0$ model is not compatible with helioseism ological observations (see also R ef. [25]).

Som e nuclear param eters are in portant for solar neutrino experim ents but have negligible e ects on the com – puted solar m odel values of the sound speed. For exam – ple, we computed a standard solar m odel in which we articially decreased by a factor of two the crucial cross section factor, S_{17} , for the rare ⁷Be(p;)⁸B reaction. The sound speeds computed for this radically di erent value of S_{17} di er by less than 1 part in 10⁴ from the standard m odel values.

Finally, we comment on the e ects of the recent in provements in opacity [17] and equation of state [18] on the predicted solar neutrino uxes. Table I gives the neutrino uxes computed for a series of three di erent standard solarm odels, all of which include helium and heavy element di usion. The model labeled BP 95 is from [16]; the models labeled New O pac and O PAL EOS include, respectively, the improved opacities discussed in [17] and the improved opacities plus the new O PAL equation of state discussed in [18].

TABLE I. Neutrino F luxes for SolarM odels with D i usion. All uxes, except for 8B and ${}^{17}F$, are given in units of 10^{10} per cm 2s 1 at the earth's surface. The 8B and ${}^{17}F$ uxes are in units of 10^6 per cm 2s 1 .

The neutrino uxes computed with the improved opacity and equation of state di er from the previously published values [16] by amounts that are negligible in solar neutrino calculations. The predicted event rate, for all three models, is

for the chlorine experim ent and

$$GaRate = 137^{+8}_{-7} SNU$$

for the gallium experiments. The only noticeable change in the predicted event rates for the chlorine and the gallium experiment is a 2% larger event rate for chlorine, which is due to a small improvement [26] in the calculation of the neutrino absorption cross sections for 8B .

We conclude that the recent in provements in opacity and equation of state do not signicantly a ect the calculated neutrino uxes, although they do result in sound speeds near the solar surface that are closer to the measured helioseism ological values (see Figure 1). The calculations of standard solar models lead to predicted sound speeds that agree closely with the measured helioseismological values. We cannot rule out with mathematical rigor the possibility [27] of constructing nonstandard models, consistent with quantum mechanics and with other stellar evolution observations, that are tuned to give the same sound speeds as the standard solarm odels. How ever, O ckham's razor suggests a strong preference for standard solarm odels.
