A Lower Lim it to the Universal Density of M etals at z 3

ABSTRACT

Column density distribution functions of C IV with 12:05 $\log(N)$ 14:35 and Si IV with 11:70 log(N) 13:93 have been obtained using 81 C IV absorbers and 35 Si IV absorbers redward of the Ly forest in the lines of sight to seven quasars with 2:518 3:78. These distribution functions have Zm been directly integrated to yield ion densities at z = 3 to 3.5 of $_{C IV} = (2.0)$ 10^9 with H₀ = 65 km s¹ Mpc¹ and 10^{8} and $_{Si IV} = (7:0)$ 2:6) 0:5) errors). A larger sample of 11 quasar lines of sight was used to $q_0 = 0.02$ (1) measure C II/C IV, SiIII/SiIV, and N V/C IV ratios, which suggest that C IV and SiIV are the dom inant ionization stages and that corrections to Carbon and silicon are no more than a factor of two. Norm alizing the -process elements to silicon and the Fe-coproduction elements to carbon gives a density of heavy elements in these forest clouds of $m_{etals} = (3:3 \quad 0:8) \quad 10^7$ (H $_0 = 65; q_0 = 0:02$). The implications for the amount of star form ation and for the ionization of the IGM prior to z = 3 are discussed.

1. Introduction

In any CDM or CDM + cosm ology, the rst generation of stars is expected to form at redshifts 10 {30 in sm all (10° M) bound objects and is assumed to imprint the intergalactic medium by both enriching and ionizing it. This enrichment may now have been detected in Keck spectra of the Lyman forest (Cowie et al. 1995; Tytler et al. 1995; Songaila & Cowie 1996 [SC 96]), and various attempts have been made to use the rst crudemeasurements of the forest metallicity (SC 96; Haehnelt, Steinmetz, & Rauch 1996; Rauch, Haehnelt & Steinmetz 1997) to place upper limits on the amount of early star formation in small galaxies (SC 96; Miralda-E scude & Rees 1997; G nedin & O striker 1997; Haiman & Loeb 1997) and to infer the rate of the high redshift type {II supernovae that may be our best hope of detecting objects in these early stages of the galaxy formation era (Miralda-E scude & Rees 1997).

The critical quantity for norm alizing the am ount of early star form ation is the density of m etals at early epochs. This has generally been obtained (e.g. M iralda-E scude & R ees 1997; H aim an & Loeb 1997) by combining the rough estimates of m etallicity in forest clouds with the total baryon density ($_{\rm b}$) inferred from big bang nucleosynthesis (SBBN). A part from the uncertainty in the value of $_{\rm b}$ from SBBN, thism ethodology assumes a uniform enrichment of m etals in the IG M and also entails considerable uncertainty in the determination of individual cloud m etallicities caused by poorly known ionization corrections and abundance patterns in the heavy elements.

It is possible to avoid m any of these problem s by directly integrating the observed ion column densities in the forest clouds to obtain $_{\rm ion}$ and, within plausible limits, $_{\rm m \ etals}$. Carbon and silicon are both well suited to this approach: as discussed below, their dom inant ionization stages in the IGM are C IV and Si IV, strong doublets that are easy to nd and m easure with 10 m class telescopes (x2); they both have strong accessible lines in other ionization stages with which to assess ionization corrections (x3); and the ratio of -process silicon to Fe-coproduction carbon is useful for determ ining the abundance pattern at early epochs and to give some idea of the nature of the initial m ass function (x4). This Letter reports the results of such a direct integration.

2. Observations

The data used comprises high resolution observations of eleven quasars with 2:518 z_{em} 3:78 m ade with the HIRES spectrograph on the Keck I telescope, for a variety of program s, between 1994 N ovem ber and 1997 A pril. All spectra have a resolution R = 36;000 and have variable wavelength coverage in the range 3500 A 7000 A. Full details of the

extraction and processing of these spectra are given in a companion paper (Songaila 1997). Seven of the spectra have complete wavelength coverage between the quasar's Ly and C IV emission lines, whereas the remainder have only partial coverage redward of Ly emission or have remaining inter-order gaps from HIRES's incomplete coverage above 5000 A.

The sample used to construct the C IV column density distribution consists of all C IV doublets detected redward of Ly emission in those spectra with complete coverage. The doublets were found by inspection of the spectra, and con meed by consistency of the column density and velocity structure in the two members of the doublet. Systems within 5000 km s⁻¹ of the quasar's emission redshift were excluded from the sample to avoid including proximate systems which have ion ratios dominated by photoionization from the quasars them selves. A lso excluded were 10 speci cally targeted partial Lym an limit system s (PLLS) in 9 quasars that were chosen to be observed in a program to look for suitable systems in which to measure the primordial ratio of deuterium to hydrogen. The nal sample consists of 81 C IV doublets, with 2:02 z 3:54 and 12:05 log (N_{IV}) 14:35, free from proximity or observational selection bias.

The SiIV column density distribution was similarly determined from all SiIV doublets detected in the same subsample of quasar spectra as used for the C IV distribution. Only systems blueward of the quasars' rest-frame SiIV but redward of the Lyman forest were included, again excluding proximate systems and targeted PLLS. This resulted in 35 systems in seven lines of sight between z = 2:16 and z = 3:54, with 11:70 log (N_{SiIV}) 13:93.

In all cases, ion column densities were determined by tting up to ten Voigt proles to each redshift system, de ned in this context to be all absorption near a given ducial redshift with gaps in velocity space of nom ore than 50 km s¹. The column density at a given redshift is then the total column density of all such components. In all but a few systems, individual lines were unsaturated, so tted column densities are insensitive to b-value.

W ith these samples, the column density distribution function f (\mathbb{N}) was determined for each ion. f (N) is dened as the number of absorbing systems per unit redshift path per unit column density, where at a given redshift z the redshift path, X (z), is de ned as X (z) $\frac{1}{2}[(1 + z)^2 - 1]$ for q = 0 or by X (z) $\frac{2}{3}[(1 + z)^{3=2} - 1]$ for q = 0.5 (Tytler 1982). The C IV and Si IV distribution functions are shown in Figure 1, over the redshift ranges, 2:02 3:54 for C IV, and 2:16z 3 and 3 Z Z 3 and 3 Z 3:54 for SiN. The data were calculated with $q_0 = 0$ and are plotted with 1 error bars calculated from the Poisson errors based on the number of systems in each bin.

Because of the som ewhat heterogeneous nature of the parent observations, the signalto-noise of the nalsample is quite variable, in some cases because the low quasar emission redshift entailed observing below 4000 A where the CCD e ciency dropo is quite severe, in others because of variable coverage at the red end of the spectrum to ll in inter-order gaps. Exposure times were also variable for the usual observational reasons. The amount of incom pleteness at low column density was assessed by recalculating the column density distributions using only systems drawn from the highest signal-to-noise spectrum, toward Q 1422+231, which has an exposure time of 580 m inutes and reaches a 1 limiting column density of 1:3 10^{11} cm 2 for C IV and 5 10^{0} cm 2 for Si IV for b= 6 km s 1 . Comparing this with the distributions obtained from the full sample, it is found that the tumover at low column density (N $_{\rm C IV}$ < 2:8 10^{12} cm 2) in the full sample is almost entirely a result of incom pleteness. To take this into account, power laws were tted only above 5:6 10^{2} cm 2 for C IV and 10^{12} cm 2 for Si IV in the full sample is almost entirely a result of incom pleteness. To take this into account, power laws were tted only above 5:6 10^{2} cm 2 for C IV and 10^{12} cm 2 for Si IV and 2:0 for high redshift Si IV. These values are quite similar to those measured in H I in the forest at these redshifts (Petitjean et al. 1993; Hu et al. 1995; K in et al. 1997) and in higher column density C IV samples (Petitjean & Bergeron 1994).

 $_{\rm C~IV}$ and $_{\rm Si~IV}$ were calculated from the column density distributions of Figure 1 according to $$_{\rm P}$$

where $_{crit} = 1.89 \quad 10^{29}h^2 \text{ g cm}^3$ is the cosm obgical closure density, m $_{ion}$ is the ion's m ass, and H₀ = 100 h km s⁻¹ M pc⁻¹ (e.g., Lanzetta et al. 1991). Values of $_{C-IV}$ and $_{SiIV}$ were calulated for z > 3 in individual lines of sight to the ve quasars in the sample with z_{em} > 3 and complete spectral coverage between the quasar's Ly and C IV em ission lines. The results are tabulated in Table 1 for H₀ = 65 km s⁻¹ M pc⁻¹ and q_b = 0.02 ($_{ion}$ scales as h⁻¹ [1 + 2q_{b}z]^{1=2}) and give some idea of the uncertainty in calculating $_{ion}$. Form all mean values, weighted by X, are $_{C-IV} = (1.2 \quad 0.3) \quad 10^8 h^{-1} [1 + 2q_{b}z]^{1=2}$ and $_{SiIV} = (4.3 \quad 1.6) \quad 10^9 h^{-1} [1 + 2q_{b}z]^{1=2}$, where the errors are 1. The mean redshift of the sample is hzi = 3.18. A sim ilar procedure applied to the z < 3 system s gives $_{C-IV} = 9.3 \quad 10^9 h^{-1} [1 + 2q_{b}z]^{1=2}$ and $_{SiIV} = 5.0 \quad 10^9 h^{-1} [1 + 2q_{b}z]^{1=2}$ at hzi = 2.57.

Because of the rarity of high column density systems (N_{C IV} 3 10^4 cm²) considerably longer path lengths are required to determ ine the number density of such systems, and the present data measure ion only for absorption with column density less than this value. (This corresponds roughly to N_{H I} < 10^{17} cm², from SC 96.) The metal densities of the stronger systems are addressed in a companion paper (Songaila 1997). The contribution of systems to _{C IV} and _{Si IV} converges at the low column density end, and system s weaker than those observed will not contribute signi cantly to the density unless there is a very rapid uptum below the observed range.

3. Ionization Balance

A less restricted sample was used to assess the ionization balance correction to be applied to the C IV and Si IV sample. This was drawn from the full set of eleven quasar spectra, excluding proximate systems. In cases where there was no apparent absorption at the C IV redshift in the other ionic species, an upper limit to the absorption in other ions was found by formally thing the C IV component model to the local continuum. This approach results in conservative upper limits, especially to lower ionization species, since C IV absorption is likely to be more widespread in velocity space than lower ionization absorption.

As is shown in Figure 2, C II is a trace ion relative to C IV with nearly all systems having C II 0.1 C IV. An additional direct search in the spectra for C II systems with no strong C IV yielded no additional systems. For photoionization m odels, this in turn yields a high photoionization parameter (log 2) which, for a wide range of photoionizing spectra, implies that Si III $\stackrel{<}{}$ Si IV and C III $\stackrel{<}{}$ C IV (e.g., Steidel 1990; G iroux & Shull 1997). For Si III this can be directly veriled from observations (m iddle panel of Figure 2) which show that, even with Ly forest contam ination, the upper limits on the Si III colum n density are generally compatible with Si IV m easurements. Ionization by a starburst galaxy spectrum with no high energy photons could result in a much higher ratio of C III to C IV while m aintaining the low C II/C IV and Si III/Si IV ratios, but it would also produce Si IV m uch in excess of C IV, which is not observed: at z > 3 Si IV/C IV has an average value of about 0.2 (SC 96; Songaila 1997).

Finally, neither N V nor O VI is strong in the C IV-selected systems. The right panel of Figure 2 shows that N V < 0.05 C IV in the small number of systems measured. The high observed ratio of Si IV to C IV combined with the low observed values of C II/C IV and N V/C IV suggests that forest clouds at z > 3 are ionized by a broken power low spectrum with relatively few high energy photons and that it is unlikely that there is much material above the C IV and Si IV levels (SC 96; G iroux & Shull 1997). The best guess, therefore, would give carbon $\stackrel{<}{}$ 2 C IV and silicon $\stackrel{<}{}$ 2 Si IV in these clouds.

4. D iscussion

Converting _{carbon} and _{silicon} to the m_{etals} of all metals requires an assumption of an abundance pattern in the z > 3 forest. As in the old metal-poor halo stars, silicon is overabundant with respect to carbon relative to solar. However, assuming that the carbon and silicon abundances trace the universal abundances of iron coproduction and -process elements, respectively (e.g., Timmes, Lauroesch, & Truran 1995), then for

the Fe-coproduction elements (C, N, Fe), = 1.75 c, and for the -process elements sin and setting $c = 2 c_{\text{IV}}$ and $s_i = 2 s_{i \text{IV}}$ gives (O, Ne, Si, Mg, S), = 18:5 $10^7 h^{-1} [1 + 2q_b z]^{1=2}$ (relative abundances from Anders & G revesse m_{m} etals = (2:1 0:6) 1989). Assuming a value of $_{\rm b}$ from SBBN of 0:005 _bh² 0:016 (Songaila, W am pler, $10^5 h [1 + 2q_0 z]^{1-2}$. W ith & Cowie 1997) gives $m_{\text{etals}} = m_{\text{b}} = (13 \quad 0.4 ! 42)$ 12) $H_0 = 65 \text{ km s}^1 \text{ Mpc}^1$, $q_0 = 0.02$, and a solar metallicity of 0.019, this implies a minimum universalm etallicity relative to solar, at z 3, in the range [3:3] to [2:8]. (The value of 3 10⁶ (system atic) given in Tytler, Fan & 10 5 3 10⁶ (statistical) D = H = 23Burles (1996) has now been revised upwards to 3:3 10⁵ (Tytler 1997) which would imply $_{\rm b}h^2 = 0.016$ and a m etallicity of [3.3], while the value of 2 10^4 obtained by W ebb et al. (1997) would give a metallicity of [2:9] [H₀ = 65; $q_0 = 0:02$].) This is a minimum range of m etallicity since there m ay be additional m etals in higher colum n density clouds or galaxies as well as in ionization states that were not sampled by these observations. Furtherm ore, adoption of $q_0 = 0.5$ would roughly double the metallicity. However, much of b_0 inferred from SBBN is believed to reside in the forest clouds at this time (Rauch et al. 1997; K in et al. 1997), suggesting that this calculated m etal density should be a good estim ate of the total m etals. Interestingly, since a m etallicity of 10 $\,^5$ gives rise to one ionizing photon per baryon (e.g., M iralda-E scud e & Rees 1997), the m etallicity m easured here is just su cient to preionize the IGM . However, this metallicity range is substantially lower than the value 10 4 assumed by Miralda-Escude & Rees (1997) and Haiman & Loeb (1997) and of2:4 in plies that their predicted rate of very high-z type-II supernovae could be lowered by as much as an order of magnitude, to a value of around 1 SN per 10 arom in^2 per year.
