1 Destruction of Faint Dwarf Ellipticals in the Core

We have used deep B and R band CCD in ages (with ' $12^{"}$ seeing) of the central ' 700 arcm in^2 of the Com a cluster core (and an associated ' 270 arcm in² control eld) to study the early-type dwarf elliptical (dE) galaxy population (Secker & Harris 1997; Secker, Harris & Plummer 1997). In the left panel of Fig. 1, we plot a subset of the total cluster eld CMD: the galaxy sequence is clearly visible, with the dE sbeginning at R ' 15:5 m ag and a m ean R) ' 1:54 m ag. The larger solid circles represent the trim m ed color of (B R) color in one-m agnitude bins over the entire lum inosity range, median (B and the solid line illustrates the least-squares regression line to median color values in the range 14 < R < 185 m ag. This provides an excellent t, and the bright part of the early-type galaxy sequence shows a strong trend for fainter dE galaxies to have (on average) a bluer color: (B R) = R = 0.056 0.002. Fainter than R ' 18:5 m ag, the dE sequence spreads and m erges with the multitude of noncluster galaxies, which are the dom inant population at these m agnitudes. The e ect is that the program - eld m ean color values are skewed redward, away from the dashed line (an extension of the upper solid line), towards the mean colors of the control-eld objects (open circles).

In the right panel of F ig. 1, we plot the binned, scaled and subtracted C M D : one vertical line segment for each color-m agnitude bin, with a height proportional to the number of objects in that bin. Here, the solid circles represent the m ean corrected color, weighted by the number of objects in each

bin. The regression line from the left panel is reproduced here, together with the extrapolated dotted line: it provides an excellent t to the corrected mean color values of the dE galaxy sequence, over the full range 15:5 R 22:5 m ag. Thus the apparent reddening of the dE sequence in the left panel is attributed entirely to contam ination of the cluster sam ple.

U sing the color-m etallicity relationship derived from m etallicities and integrated colors for G alactic globular clusters, valid over the range 2:4 < [Fe/H] < 0.2 (Harris 1996), we obtain $[Fe/H] = R = 0:19 \quad 0:01$ dex for our sam ple of C om a dE s. C ellone, Forte & G eisler (1994) plot a T₁, (C T₁) CM D (W ashington lters; T₁ ' R) for a sam ple of 14 Formax dE s. From a linear t to their tabulated data points, and the color-m etallicity relationship of G eisler & Forte (1990), we calculate $[Fe/H] = T_1 = 0:18 \quad 0:07$ dex for these Formax dE s. These slopes are form ally consistent, suggesting that the process of dE galaxy form ation is very sim ilar in these very di erent cluster environm ents.

We have also analyzed the completeness-corrected background-subtracted radial number density proles of bright and faint galaxies in the cluster core. Our bright sample includes 280 cluster galaxies, a subsample selected to have 0:7 (B R) 1:9 m ag and R 19:0 m ag (giants plus bright dEs). Our faint sam ple includes 2246 objects selected to have 0:7 (B R) 1:9 m ag and 19:0 < R 22.5 m ag. For the bright galaxy sam ple, the best-tKing m odel has a core radius $R_c = 13:7$ arcm in, signi cantly sm aller than $R_c = 22.2$ arcm in found for the faint dE s. Lobo et al. (1997) analyzed the faint-end slope of the galaxy lum inosity function in C om a, and determ ined that it is shallower in the core than for the cluster as a whole. This is consistent with the dynam ical destruction of dE galaxies in the dense environment of the cluster core. O ur results presented above are also consistent with this hypothesis:

(1) Thom pson & G regory (1993) proposed that the core of the C om a cluster is de cient in the number of faint dE galaxies, and they argued that tidal disruption could be responsible for partially destroying this low m ass population. Our study indicates that the larger core radius for faint dEs is genuine, and in this sense the cluster core is de cient in the number of faint dEs.

(2) M attila (1977) m easured the color of the di use intergalactic com ponent of the C om a cluster light, and obtained (B V) = 0.54 0.18 m ag. From the right panel of F ig. 1, we estimate (B R)' 1.15 m ag for our faintest dE s (R = 22.5 m ag), corresponding to (B V)' 0.70 m ag, which is within the color range found by M attila (1977). This is consistent with a major component of this di use intergalactic light originating as stars tidally stripped from num erous faint, low m ass dE galaxies in the cluster core.

2 Prelim inary A spects of our dE Spectroscopy

The Keck I telescope and the Low Resolution Im aging Spectrograph (LR IS) were used in ' 1:0 arcsec seeing to obtain 2 1800 sec exposures of four elds, with ' 22 objects per eld. The target objects were selected from the photom etric sample described above, based upon their position within the CMD, with the additional constraint of slit placem ent. Our wavelength coverage is 3800 < < 6200 A, with 8 A resolution and S/N ' 50 for the dEs. We have prelim inary results from an LRIS eld located ' 3:8 arcm in west of NGC 4874. Of the 24 objects covered with slits, 17 were \targets" (with 15:5 < R < 20:5 m ag and with 0:7 < (B R) < 1:9 m ag), the others chosen to ll rem aining slitlets. Based upon the num ber density of control-eld objects in this region of the CMD, we would expect '9 10 of these targets to be genuine C om a m em bers. H ow ever, only four of these targets have C om a velocities; a large fraction of the other targets are emission-line galaxies at z ' 02. If this unexpectedly-low fraction of Com a members is not a result of sm all number statistics, and if it continues to the other three LRIS elds, it will constraint measurements of the Com a lum inosity function which rely

on correction using associated control elds (Bernstein et al. 1995; Secker & Harris 1996). Refer to A dam i et al. (1997) for prelim inary results of velocities for objects in the Bernstein et al. (1995) eld. Using the dE spectra, our prim ary goals are to estim at eage and abundances by measuring Lick spectral line indices (W orthey 1994), and to address the following questions:

(a) W hat is the mean metallicity-lum inosity relation determined from metallicity-sensitive indices (e.g., Fe4668, Fe5709, and Fe5782); are the high metallicities inferred by integrated colors con med by spectroscopy?

(b) Is there evidence from age-sensitive indices (e.g., G 4300, H and the higher-order B alm er lines) that the dE s are composed of a hom ogeneous population of old stars as in globular clusters, or is there evidence for young and/or interm ediate age components (as was found in som e Formax dE s; Held & M ould 1994)?
