## An Analytic Expression for the G row th Function in a Flat Universe with a Cosm ological Constant

## ABSTRACT

An analytic expression is given for the growth function for linear perturbations in a low-density universe made at by a cosm ological constant. The result involves elliptic integrals but is otherwise straight-forward.

In linear cosm obgical perturbation theory, the evolution of perturbations in the absence of pressure is reduced to the superposition of two modes with xed time dependence and arbitrary spatial dependence (Peebles 1980). The behavior of these modes in time is a function of the background cosm obgical parameters. The functions of time that describe this behavior are called the growth functions and denoted  $D_1$  and  $D_2$ .

As shown by Heath (1977), the growth functions in cosmologies where pressure uctuations are negligible can be written as

Here, a is the expansion scale factor of the universe, chosen so that a = 1 today; this will be our time coordinate. The redshift z is then a <sup>1</sup> 1. <sub>0</sub> is the density of non-relativistic matter in the universe today in units of the critical density.  $= = 3H_0^2$  is the cosm ological constant relative to the present-day Hubble constant H<sub>0</sub>. <sub>R</sub> is the curvature term and is equal to 1 <sub>0</sub>. We assume that relativistic matter is a negligible contributor to the density of the universe. Finally, H (a) is proportional to the Hubble constant at epoch a, scaled so that H = 1 today. We are interested in the behavior of D<sub>1</sub> (a), as this is the mode whose am plitude grows in time. However, the overall norm alization of D<sub>1</sub> is merely a convention.

The analytic form for  $D_1$  in the = 0 case (W einberg 1972; G roth & Peebles 1975; E dw ards & H eath 1976) is widely known, but no analytic solution for the case of € 0 has been presented in the literature. Instead, workers integrate equation (1) num erically or use the approximations given by Lahav et al. (1991) or C arrollet al. (1992). How ever, the integral can be done in term s of elliptic

integrals, which of course are implemented as special functions in m any numerical packages. Here, we restrict ourselves to the case of a at, low-density universe, i.e.  $_{\rm R} = 0$ ,  $_0 < 1$ , = 1  $_0$ . This is the case commonly used in practice and the solution can be stated rather cleanly.

W e adopt a norm alization for D  $_1$  as

This is chosen so that  $D_1(a)$  ! a as a ! 0. Dening  $v = a^{1 \frac{p_3}{0}} - (1 \frac{p_3}{0})$  and manipulating the integral yields

Doing this last integral (e.g. using 3.139.8 in Gradshteyn & Ryzhik 1994) yields the nalanswer

Here, F and E are incomplete elliptic integrals of the rst and second kind, using the de nitions  $F(;k) = {R \atop 0} (1 \quad k^2 \sin^2)^{1=2} d$  and  $E(;k) = {R \atop 0} (1 \quad k^2 \sin^2)^{1=2} d$ ; note that conventions vary on whether k is squared or not. A loo note that can exceed =2; som e num erical in plem entations of the elliptic integrals do not handle this properly. In this case one can use the identity F(;k) = 2F(=2;k) F(;k) and likew ise for E to compute for > =2.

As a ! 0, v ! +1 and d<sub>1</sub> ! 1 (2=11)v<sup>3</sup> + (16=187)v<sup>6</sup> + O (v<sup>9</sup>). This is not obvious from equation (9); the term s of order v<sup>2</sup> and v cancel. This suggests that for num erical evaluation for v 1, one should be watchful for loss of precision. A lternatively, for v > 5 one can use the large v expansion given above. As a ! 1, v ! 0 and D<sub>1</sub> = 1:4373<sup>P<sub>3</sub></sup>  $_{0}=(1 \ 0)$ .

The approximation of Carrollet al. (1992, adapted from Lahav et al. 1991) that

can be compared to  $d_1(v)$  using = 1  $_0 = (v^3 + 1)^{-1}$ . The thas fractional errors better than 2% over the range z 0 and  $_0 > 0.1$  (i.e. v > 0.48) but deviates for lower  $_0$ . A plot of  $d_1(v)$  and the Carrollet al. (1992) t is shown in Figure 1. The thas similar accuracy for the = 0 case even to much lower  $_0$ .

For completeness, the solution for the expanding epoch of a at universe with  $_0 > 1$  is

v = 1 is the time at which the universe reaches maximum expansion. As v ! 1,  $\tilde{d_1}$  ! 1+ (2=11)v<sup>3</sup> + (16=187)v<sup>6</sup> + O (v<sup>9</sup>).

As a convenience to the reader, we collect other exact equations relevant to low-density, at universes from the literature (Edwards 1972, 1973; Dabrowski & Stelmach 1986, 1987; W einberg 1972, 1989). The time-redshift relation may be written as

where H (a) is de ned in equation (3). The coordinate radius out to redshift z is  $r_1(z) = c[(0))$ 

(z)], where c is the speed of light and the atness of the universe has been used. Then the lum inosity distance  $d_L$  is  $(1 + z)r_1(z)$ , the angular diam eter distance  $d_A$  to an object of given physical size is  $(1 + z)^1 r_1(z)$ , and the comoving volume per unit redshift per unit solid angle is

A quantity related to the growth function is f  $(a=D_1)(dD_1=da)$ , used to relate density perturbations to velocity perturbations. A ssuming the normalization in equation (4), one nds

In sum m ary, the expression presented here for the growth function is marginally m ore com - plicated than the = 0 case, but if one evaluates the elliptic integrals using available num erical packages, the exact function is quite tractable.
