H Velocity M apping of Ultralum inous Infrared G alaxies

ABSTRACT

We use in aging Fabry-P erot observations to explore the dynam ical conditions in four southern ultralum inous ($L_{IR} > 10^{12} L$) infrared galaxies. These galaxies all show morphological and kinem atic features indicative of a major merger, but span a wide range of inferred dynam ical ages: the youngest system is just past the rst encounter, while the oldest has already merged into a single object. This diversity in dynam ical states indicates that ultralum inous activity is not conned solely to late-stage mergers. The H emission is more spatially concentrated in the later stage mergers, in agreement with models which show that mergers drive gas inwards towards the nucleus, but high lum inosities are achieved even in young interactions where the H is quite extended. Our data indicate that physical details other than the dynam ical phase { such as the internal structure or gas content of the galaxies { can play a strong role in determining the lum inosity evolution of merging galaxies. We also not evidence

form assive star-form ing complexes at large radius in the tidal debris, rea ming the notion that som e dwarf galaxies may be spawned during the merger of more massive disk galaxies.

1. Introduction

W ith bolom etric lum inosities rivaling those of quasars, the so-called \ultralum inous infrared galaxies" (ULIRGs) are the most lum inous objects in the local universe. The basic properties of these galaxies have been reviewed by Sanders and M irabel (1996) and their m ost outstanding characteristics can be sum m arized as follows: 1) 90% of their bolom etric lum inosity is em itted in the wavelength range 12–100 ; 2) with one exception, all have very high CO lum inosities (see Solom on et al. 1997); 3) when in aged deep enough, all show signs of strong interactions orm ergers (see M elnick and M irabel 1990, C lem ents and B aker 1996; C lem ents etal 1996a). The phenom enological picture which em erges is that ULIRGS are the m anifestation of the collision and subsequent m erger of two disk system s which are rich in m olecular gas. Support for this picture com es from the observed m olecular gas m asses of ULIRGS which are consistent with what has been m easured for gas-rich lum inous disk galaxies (Solom on et al. 1997), as well as the refutation of the assertion by Leech et al. (1994) that som e ULIRGS were not in strongly interacting systems. Better in aging by C lem ents and Baker (1996), C lem ents etal (1996ab) and Lucas etal (1997) has shown that virtually allULIRGS show m orphological signatures of a m a jor m erger.

Behind the phenom enology, however, lies the physics which produces the very high lum inosities. W hile the trigger for the e lect may now be clear, it remains controversial if starbursts (Joseph & Wright 1985) or AGN activity (Sanders et al. 1988) are the main power source of the lum inosity. Both have been invoked and there is evidence to support either case. For instance, in some ULIRGs, emission line diagnostics indicate the presence of buried AGN in their nuclei, while other systems show no such evidence (Goldader et al. 1995), even in the mid-IR where the dust obscuration is less troublesome (Lutz et al. 1996). While the infrared spectra of ULIRGs are di cult to twith a pure starburst model (Goldader et al. 1995), it remains unclear whether this is due to the presence of an AGN or simply a consequence of extrem e optical depths in ULIRGs (Lutz et al. 1996). Recent ASCA observations by Ogasaka et al. (1997) reveal that at least one ULIRG has a 2-10 keV lum inosity which is sim ilar to that observed in QSOs (eq., 10^{44} ⁴⁵ ergs s¹). On the other hand, VLA observations by C raw ford etal (1996) shows that the radio continuum lum inosity of ULIRGs is consistent with the starburst driven correlation between FIR and radio lum inosity established earlier by Helou et al. (1985).

In reality, both starburst and AGN activity may be occurring concurrently, with the detailed energy balance determ ined by a variety of factors and there may well be some evolutionary connection between these two states. C learly, the very high inferred densities of m olecular gas (up to 10⁷ cm⁻³, Solom on et al. 1992) can generate huge starbursts. M oreover, at these densities the disk is extremely viscous (see Bryant and Scoville 1996). which greatly facilitates the viscous transport of material onto a central engine, if one exists. Hence there maybe valid physical reasons to view ULIRGs as systems that are initially powered by starbursts and then later powered by accretion onto a central engine and in that way ULIRGs a rm the starburst-AGN connection. Support for this hypothesis also comes from the work of Chang et al. (1987) who show that the dynam ical lifetime of dust and other obscuring material which is in near a lum inous AGN is less than the radiating lifetime of the AGN. Hence, if AGN activity is the initial power source of the ULIRGs some fraction of them should evolve to become unobscured QSO s but still show signs of merger activity. O ne example of this evolution might be provided by the low redshift QSO PKS 2349-014 (Bahcall et al. 1995).

To trigger either AGN or starburst activity, some mechanism must act to transport gas down to the central regions of the ULIRGs. Galaxy interactions and m ergers seem the most likely mechanism to drive these central in ows of gas and this is consistent with the phenom enological picture painted above. Dynam ical modeling has dem onstrated the e cacy of interactions at driving in ows (Noguchi 1991; Barnes & Hernquist 1991, 1996; M ihos et al. 1992; Hemquist & M ihos 1995; M ihos & Hemquist 1996). How ever, the details of this link between interactions and lum inous activity are not well understood. W hile most ULIRGs are found in closely interacting and/or merging systems, the converse is not true { the great m a prity of interacting system s do not display \ultralum inous" levels of em ission. Clearly a crucial element in driving central activity in ULIRGs must be the detailed dynamical conditions of the interacting galaxies. Models by Barnes & Hernquist (1996) suggest that the onset and intensity of gas in ows is linked to the geometry and in pact parameter of the galactic collision, while the dynamical role of central bulges in regulating in ows was demonstrated by M ihos & Hernquist (1996). M oreover, the build-up of molecular gas to high densities may also act as an e cient dam per of angular momentum of additional gas which is introduced into the central regions thereby e ectively serving as a conduit to fuel an AGN.

A better understanding of the conditions necessary for spawning ultralum inous

activity can only come through studies of the dynamics of ultralum inous infrared galaxies. Unfortunately, morphology alone gives only a weak handle on the dynam ical state of the system. For example, while two galaxies may appear closely interacting, they may not exhibit a strong dynam ical response, depending on the encounter geometry (prograde vs. retrograde encounters), the structural properties of the galaxies, or the age of the interaction. These uncertainties make it di cult to de ne the true dynam ical state of many lum inous infrared galaxies. To better investigate the dynam ical conditions in ULIRGs, velocity m aps of four southern ULIRG systems, taken with the Rutgers we present H Im aging Fabry-P erot spectrograph. Unlike slit spectra, im aging Fabry-P erot data m ap the full two velocity eld of the galaxies, and the arcsecond spatial resolution achieved in the optical betters that of H I velocity m aps by an order of m agnitude. U sing the m orphology and velocity eld in conjunction with num erical modeling, it is possible to reconstruct much of the dynam ical history of merging systems (e.g., Borne, Balcells, & Hoessel 1988; Stanford & Babells 1991; M ihos et al. 1993; H ibbard & M ihos 1995; M ihos & Bothun 1997) and probe the dynam ical conditions necessary for driving \ultralum inous" levels of activity.

2. Observations

O ur sam ple of ultralum inous infrared galaxies is neither com plete nor unbiased. The four objects (Table 1) were chosen to have high far-IR lum inosity ($L_{IR} > 10^{12} L$) and extended, high surface brightness tidal features. The morphological criteria were employed to maxim ize the likelihood of detecting H in the tidal features, enabling us to map the velocity eld of the system s at large radii. However, selecting on the presence of tidal debris probably biases our sam ple towards system s in which at least one galaxy was a som ewhat prograde disk, and also towards system s which are relatively young. T idal features are much harder to detect in retrograde mergers or in very old rem nants where the tidal debris has become very di use.

The H velocity mapping described here was done using the Rutgers Im aging Fabry-P erot on the CTID 4-m telescope. The Fabry-P erot etalons have a bandpass of 2.2 FW HM, giving an instrum ental velocity dispersion of 50 km s¹. To isolate the H transm ission order, narrow band (80A) H lters were used. Using the Tek 2k CCD, the pixel scale was 0.36^{00} pixel¹ and the circular eld of view covered 1.5^{0} in diam eter. This eld of view was su cient to encom pass each system, with the exception of IRAS 19254-7245, whose long tidal tails extended o the edge of the eld.

O bærvations of each object consist of a æries of 10 m inute exposures typically stepped 1A apart. The spectral range covered depends on the velocity width of the system ; details for each object are given in Table 2. We emphasize that observing time constraints made it in practical to extend spectral coverage in order to detect broad wings that might be associated with nuclear out ow or the presence of an AGN. Data reduction consisted of

at elding, sky subtraction, and norm alization of the individual in ages to a common transparency (see M ihos & Bothun 1997). Because the redshift range of the sam ple and the radial wavelength gradient across the eld of view, night O H sky lines appear on the im ages as di use rings of em ission. These night sky rings are rem oved by masking out the object and creating a map of the median intensity as a function of radius in each im age, which is then subtracted from the original. Transparency norm alization was done by assuming that stars in the eld have a at spectrum over the limited spectral range scanned. Because of the small eld of view, only a few stars are available for photom etry in each eld, making accurate norm alization di cult. Typical corrections for transparency are less than 20%, with errors of 5 to 10%. W avelength calibration was achieved through a series of neon lam p exposures taken during the night.

A fler the in ages are normalized, each pixel has a spectrum associated with it which traces out the spectral shape of the H emission line at each point in the galaxy. Binning the in ages 3x3 to improve signal, the spectra are t to a single Voigt prole using least squares minimization. From this tting, four parameters are extracted: the continuum level, the H line ux, the central velocity of the line, and the gaussian velocity dispersion. Each pixel was tautomatically, after which the individual ts were examined by eye while watching M elrose P lace. Fits to obvious noise were deleted, and bad or missing ts to good data were improved by giving the tter a better initial estimate of the parameters. In the nalmaps, typical errors on the derived velocity are 20 km s¹, as long as the line prole was simple. However, some regions proved di cult to t to a single line prole, having asymmetric lines, multiple components, or velocity widths greater than the scanned spectral range. These regions are discussed in detail in x3 below.

- 3. Individual Objects
- 3.1. IRAS 14348-1447

IRAS 14348-1447 (hereafter IR 14348) is the most distant and infrared lum inous of the four galaxies observed (Table 1). The optical morphology (Sanders et al. 1988; M elnick & M irabel 1990) is that of a double nucleus system, with a bright tidal tail extending to the north and a fainter tail to the southwest. N ear-IR im aging reveals two nuclei (C arico et al. 1990) with a separation of 3.5^{00} (5 kpc). The nuclei have a velocity di erence of $v = 150 \text{ km s}^{-1}$ from optical emission lines, and the nuclear spectra show indications of

AGN activity, classi ed alternately as LINER (Veilleux et al. 1995) or Seyfert 2 (Sanders et al. 1988; Nakajim a et al. 1991). Single dish CO (1-2) m easurem ents indicate the system contains $6 \quad 10^{10}$ M of m olecular gas (Sanders, Scoville, & Soifer 1991).

An examination of the tted spectra showed no complex lines; all data was reasonably well t by a single component Voigt prole. However, the spectral range scanned was not su cient to sample the full velocity width of the Seyfert 2 line prole in the SW nucleus. The spectral line ts here are very suspect, as there is no sampling of the continuum to t the line. In this situation, the line tting algorithm system atically overestimates the continuum and underestimates both the line strength and velocity dispersion. As a result, estimates of the relative H ux and velocity dispersion in the emission line gas are only accurate outside the active nuclear region.

Figures 1 (Plate 1) and 2 show the reduced Fabry-P erot maps for IR 14348. Due to the low ux levels in the o -H in ages, the continuum map shows little more than the two nuclei, separated by 4° . The H intensity map is much more complicated, with extended, clum py emission throughout the body of the system and in the tidal tails. Interestingly, the strongest H in the NE member is found o set from the NE nucleus by 2° away from the interacting companion. This o set is clearly visible in the both reduced maps and the raw in ages, and is not an artifact of the spectral thing process. It is unclear whether this non-nuclear emission is intrinsically stronger than the nuclear emission or if the nuclear region is simply more obscured { more accurate photom etry and reddening corrections are needed to resolve this issue. Regardless, it is clear that the NE member is experiencing signi cant non-nuclear star form ation.

The H emission is not con ned to the main body of the system, either. Several discrete clumps of H are found at large radius, $5\{15^{00} (7\{20 \text{ kpc}) \text{ from the center of the system . These include a bright emission source <math>5^{00}$ to the south, extended emission in the NE tail, and a system of four compact H knots in the SW tail. Using the published H nuclear uxes from Veilleux et al. (1995) to obtain approximate photom etric zeropoints, we can get an estimate of the H luminosity of these objects. The compact objects in the SW tailhave H luminosities of 5 10^{39} erg s^1 each, while the more luminous object to the south has an H luminosities are similar to those of the SM C and LM C respectively (K ennicutt et al. 1995). The velocity dispersion and continuum levels in these regions are low, suggesting this is extended gas which has been compressed during the collision and is now collapsing and forming stars. These regions may represent the early stages of the form ation of tidal dwarf galaxies (e.g., Zwicky 1956; M irabel, D ottori, & Lutz 1992; H ibbard et al. 1993).

From the derived H velocities, we measure a velocity di erence between the nuclei of v = 125 25 km s¹, consistent with previous measurements, with the NE galaxy having a relative blueshift. The velocity map shows that the merging system s each still possess coherent rotation. Extracted one dimensional velocity cuts are shown in Figure 3. The peak-to-peak velocity width of the NE galaxy is $v \sin i$ 200 km s¹, while that for the SW galaxy is smaller $v \sin i$ 150 km s¹, probably due to a lower inclination (recall that the SW nucleus is actually brighter in K by 0.54 m ag; Carico et al. 1990). The extracted velocity eld shows a large (100 km s¹) shift to higher velocities. How this region is dynam ically linked to either or both of the galaxies in the pair is unclear, but in both velocity cuts the higher velocity H em ission occurs after the rotation curves have attened, suggesting it is a distinct dynam ical feature and not merely an extension of the rotation curve(s).

The overall two dimensional velocity eld indicates that, for the NE galaxy, the encounter is fairly prograde. In both galaxies, the far side of the disks have a radial (line-of-sight) velocity in the opposite sense from the system ic velocity of their respective com panion, a classic signature of a prograde encounter. M ore striking evidence com es from the velocity structure of the (largely edge-on) NE tail. The short, stubby tidal features produced in retrograde encounters typically have large velocity gradients, as the m aterial is stripped out of the disk with a velocity in the opposite sense of the rotational velocity. The velocity gradient in the NW tail (F igures 2 and 3) is quite sm all, inconsistent with a retrograde origin. The fact that the tails are rather short (20 kpc) argues either that the collision is not highly prograde, that the encounter is fairly young, or that projection e ects are severe.

3.2. IRAS 19254-7245 (The Superantennae)

RAS 19254-7245 (R 19254) is composed of a pair of galaxies, separated by 10 kpc, and possesses an enomous pair of tidal tails which span 350 kpc from tip to tip (M irabel, Lutz, & M aza 1991). The southern galaxy is a Seyfert 2 nucleus, with complex emission line velocity structure nearly 1500 km s¹ in width (M irabel et al. 1991; Colina, Lipari, & M acchetto 1991). Because the nuclear emission line complex is broader in width than the spectral regions scanned by the Fabry-P erot, no tting could be done in regions in and im m ediately surrounding the nucleus; these regions have been m asked out in the nalm aps. Throughout the rest of the system, single Voigt pro le ts proved adequate to describe the observed line pro les. The reduced Fabry-P erot m aps for IR 19254 are shown in Figures 1 and 4.

Unlike IR 14348, the strongest H emission in IR 19254 is located within a few kpc of the nuclear regions of the galaxies. The exceptions are several H knots along the tidal arm of the northern galaxy and a single bright H II complex on the south side of the southern disk. In fact, the H ux from this bright H II region is comparable to the H ux from the entire northern nucleus. From longslit spectroscopy, the H lum inosity of the northern nucleus is 10^{14} erg s¹ cm² (Colina 1997, private communication), yielding an H lum inosity for the detached star form ing knot of L_H 7 10^{40} erg s¹, a few times larger than that of the LM C (K ennicutt et al. 1995). HST im aging of IR 19254 (B ome et al. 1997) shows a bright unresolved point source at this location; the inferred size is $\stackrel{<}{} 200$ pc. The size and lum inosity of this object is sim ilar to high surface brightness blue compact dwarf galaxies (e.g., M arbove 1997).

Because the disks in R19254 appear more distorted than in R14348, rather than de ning a major axis and extracting rotation curves, in Figure 5 we simply plot the velocities collapsed along the east-west direction { a position-velocity plot. Even with the morphological distortion, we see that the velocity eld of the system is fairly regular, showing two rotating disks with velocity widths of $v \sin i = 400$ km s¹ and 600 km s¹ for the northern and southern galaxies, respectively. Outside the central regions the velocity dispersions are moderately low except for the region between the nuclei. W hile the dispersion is large in this region, there are clearly two components to the line pro le (Figure 6a), suggesting that rather than true random motions, we are observing two disks overlapping in projection. Both disks are rotating in the same sense, with their northern sides receding. The northern galaxy is redshifted compared to its southern companion (by

200 km s¹), con ming the expectation of a prograde encounter based on the presence of the immense, linear tidal tails.

Extending to the east from the brighter southern nucleus is a plume of H which does not correspond closely to any continuum features such as spiral arms or bright knots observed in HST imaging of IR 19254 (Borne et al. 1991). The H line pro le of this region shows a strongly asymmetric blue wing (Figure 6b), suggestive of out owing material. The lum inosity weighted mean velocity of this plume is $v = 17780 \text{ km s}^1$, or $v_{nuc} = 120 \text{ km s}^1$, where the nuclear velocity is de ned by the N aD absorption feature⁴ (Colina et al. 1991). This inferred expansion velocity is much less than that of material in the nuclear regions, which have a velocity width of $v_{nuc} = 800 \text{ km s}^1$ (Colina et al. 1991). At

a projected distance from the nucleus of 5^{00} (6 kpc), the material in this extended plum e must be slowing as it expands outwards, as expected in starburst wind models (e.g., K oo & M cK ee 1992; Heckman et al. 1996). To get a simple estimate of the expansion time of this material, we note that for a spherically symmetric expanding superbubble powered by a constant mechanical luminosity, $r=v = (7=410)t_7$ where r is the radius in kpc, v the expansion velocity in km s¹, and t_7 the expansion time in 10^7 years (e.g., Heckman et al. 1996). If the plum e is expanding outwards at an angle i from the line of sight, we have $t_7 = (410=7)(r_{obs}=v_{obs})$ coti. Our derived expansion age for this H plum e is thus 10^7 coti years, setting a rough timescale for the starburst activity.

O f considerable interest are the velocities of the faint knots at large radius in the tidal tails, as they reveal whether the knots are physically associated with the tails and, if so, give some constraint on the expansion velocity of the tails. Because of the limited eld of view of the Fabry-P erot on the 4-m, only the the three brightest knots in the northern tail (see Figure 1 of M irabel et al. 1991) were observable, and of these knots only the closest had detectable H emission (Figure 6c). The radial (line of sight) velocity of this knot is 18030 km s¹, redshifted by 100 km s¹ from the system ic velocity of the nuclei. This detection is clear evidence that the interaction has triggered star form ation in the tidal tails 60 kpc from the merging pair. Using the observed quantities, we get an expansion age of $r_{obs} = v_{obs} = 6$ 10⁸ years, but this again is very crude, subject to projection e ects and geom etry. However, a lower limit on the expansion age can be estimated from the circular velocity of the disks; dynam ical models of merging galaxies show that the tail expansion velocity is not larger than the circular velocity (Hibbard & Mihos 1995; Mihos, Dubinski, & Hemquist 1997). Taking 300 km s¹ as an upper lim it to the tail velocities, a lower lim it to the expansion age is then 2 10^8 years. It is clear that the starburst age (as measured by the H plum e expansion) is much shorter than the dynam ical age of the m erger (as m easured by the tails). Unlike IR 14348, IR 19254 \waited" a few dynam ical tim es after the initial collision before entering its ultralum inous phase.

3.3. IRAS 20551-4250

IRAS 20551-4250 (IR 20551) is a single object with a relatively high surface brightness tidal tail to the south and a fainter tidal plum e to the north. The surface brightness prole is reasonably well t by an $r^{\frac{1}{4}}$ kw (Johansson 1991), except for in the central regions where it attens; this prole is typical of the mass proles of modeled merger remnants (e.g., Barnes 1992; Hemquist 1992) where violent relaxation redistributes the stellar mass in an $r^{\frac{1}{4}}$ mass prole. The fact that we see this quasi-elliptical light prole suggests that the

violent relaxation in IR 20551 is largely complete and the two nuclei have assimilated into one centralm ass.

The reduced Fabry-P erot m aps of IR 20551 are shown in Figures 1 and 7. The continuum m ap shows the single body along with a bright \ridge" to the southeast { probably a tidal arm or loop sim ilar to those seen, for example, in NGC 7252 (Schweizer 1982; H ibbard et al. 1995). The long tidal tail extending to the south is extrem ely di use, with none of the high surface brightness knots seen in IR 19254 or IR 14348.⁵ The H em ission is concentrated in the central regions with only weak extended em ission visible. The notable exception is an H knot to the southeast of the nucleus, where the tidal loop m eets the m ain body. Very faint em ission is seen in the loop itself as well as in the tidal plum e to the north; however, no H II regions are seen in the long southern tidal tail.

The H velocity eld of the galaxy is very regular, and indicative of simple circular motion, with a velocity width of $v \sin i = 150$ km s¹. This rotating disk of ionized gas is sim ilar to those found in dynam ical models of mergers, where gas which is not driven into the central regions settles into a warped, di use disk once violent relaxation has subsided (e.g., M ihos & H emquist 1996). The low velocity width for such a lum inous system suggests we are viewing this disk largely face-on. If subsequent evolution is mild, this disk may end up resembling the H I disk found in the nearby peculiar elliptical NGC 5128 (van G orkom et al. 1990). The only region that departs from the pattern of circular motion is the region near the tidal bop where material stripped out into tidal features is expected to be moving on very non-circular orbits (e.g., H emquist & Spergel 1992; H ibbard & M ihos 1995).

A lthough no H II regions are seen in the southern tidaltail, we searched for di use H by sum m ing the pixel intensities in a $10^{00} \times 10^{00}$ patch along the tail at a distance of 35^{00} (30 kpc) from the nucleus. Di use H is observed (Figure 8) at a velocity of 12500 km s¹, blueshifted by 100 km s¹ from the system is velocity of the rem nant. At such di use levels of H em ission, it is unclear whether the ionizing source is di use star form ation in the tidaltail or the extragalactic UV background.

From a dynamical standpoint, IR 20551 seems to be the most quiescent of the ultralum inous IR galaxies we observed. The lack of a multiple nucleus, the centrally concentrated H, and the regular velocity eld allargue that the period of violent relaxation associated with the merging is largely over, and that subsequent dynam ical evolution will be slow. Population synthesis modeling of the spectral features in the nuclear regions by Johansson (1991) also suggests that the starburst event peaked a few times 10⁷ years ago. W hile still ultralum inous, we may be catching IR 20551 just past the peak of its lum inous

phase, as violent relaxation ends and the starburst begins to fade. The coincidence between the end of violent relaxation and the possible decline in the starburst intensity suggests that ultralum inous starbursts do not continue long after the merger is complete.

3.4. IRAS 23128-5919

IRAS 23128-5919 (IR 23128) is another double nucleus system, with a separation of 4^{0} (3.5 kpc), and possesses a pair of tidal tails spanning 50^{0} (45 kpc) from tip to tip. Bergval & Johansson (1985) classify the nuclear spectrum as intermediate between Seyfert 2 and LINER, and claim to detect large scale out ow signatures in the form of asymmetric emission lines and an o set between the emission and absorption line velocities of the nucleus. Johansson & Bergvall (1988) also nd W olf-R ayet features in the galaxy spectrum, indicating a strong on-going starburst. A bright compact object is found near the end of each tidal tail, suggestive again of star-form ing knots; how ever, Bergval & Johansson (1985) were unable to detect emission from these knots.

IR 23128 proved the most complex system for thing line proles. Emission in the tails and the northern galaxy was well to by single Voigt proles, but the line proles in the southern object were very complex, showing asymmetric shapes or double-line proles. In such cases, a single symmetric Voigt prole is a poormodel for the emission line, and these its give poor values for the derived line parameters. For this reason, we chose to model obviously distorted lines as a sum of two Voigt proles. This choice is not meant to imply two kinematic subsystems at each spatial point, but simply to provide a better it to the line shape (although in several regions two distinct kinematic proles are indicated by the data). With this change in thing procedure, the derived quantities take on a slightly dilement meaning. The meaning of the continuum map is unchanged, while the H intensity map is now the sum of the ux in the two itted lines. The velocity map now expresses the intensity-weighted mean velocity in the line, and the dispersion map shows the second moment of the prole shape. The reduced Fabry-P erot maps for IR 23128 are shown in Figures 1 and 9.

The continuum map shows the double nucleus and, faintly, the tidal tails stretching north-south. Near the end of the tails, the compact objects are easily visible. The southem galaxy is extended east-west; we argue below that this structure is a rotating disk-like component, perhaps the original disk of the southern galaxy. In the H map, both nuclei show strong emission, along with strong H between the two nuclei. Coincident with the east-west extension of the continuum light, the H traces out a attened disk with strong spiral features around the southern nucleus. Several H II regions are found in the tidal tails. Interestingly, the strongest H peaks in the tails do not correspond to the compact continuum sources. No emission is detected from the continuum source in the northern tail, while the southern object sits on the secondary H peak in that tail. The strongest H peaks in the tails do not have detectable continuum emission. This lack of a strong correlation between continuum peaks and H peaks suggests that the form ation of tidal dwarfs is a stochastic process; continuum knots m ay be more evolved versions of H knots, so that at any given time a spread in population ages is observed. If so, this may make it di cult to nely date the ages of merger remnants through the stellar populations in tidal dwarfs and globular clusters (e.g., Zepf et al. 1995; Schweizer et al. 1996).

The H velocity map reveals a rather chaotic velocity eld; Figure 10 shows the projected position-velocity plot. The tidal tails are moving in opposite directions with a velocity spread of 100 km s¹. The velocity gradients along the tails are smooth, and indicate an axis of rotation along a position angle of 90. In the southern galaxy we nd clear rotation, with a velocity spread of 400 km s¹. The morphology and large velocity spread in this component suggests we are seeing it nearly edge on and that it is rotating about an axis of position angle 0. Rotation in the northern galaxy is less clear, although there is some hint in the position-velocity plot that there is a weak retrograde sense to its motion. The fact that this signature is weak, if present at all, indicates that we see this system largely face-on. In the region between the nuclei the velocity patterns shift again; here the lines are broad and asymmetric, so it is di cult to determ ine whether this is another shift in the net rotation axis or sim ply material decoupling from the overall rotation pattern due to collisional shocks or winds.

The second moment (\dispersion") map shows the largest velocity widths occur along the edge of the rotating disk, away from the galactic nuclei. It is here that we see broad lines which often are broken up into two distinct components (Figure 11). M uch of the broadening of the line progeneous bedue to the fact that we are viewing multiple kinematic components along the same line of sight. It is thus dicult to unambiguously determine the presence of galactic wind in IR 23128. The nuclear spectra on which Bergvall & Johansson (1985) based their wind detection had 6A resolution and was taken through a $4^{0}x2^{0}$ aperture centered on the nuclei { this aperture contains a signi cant amount of ux from the blueshifted portion of the rotating disk, which may explain most, if not all, of the blue wing seen in their low resolution spectra. To be sure, we also observe spectra with strong blue wings, but these are in regions near the disk component and may simply be due to line blending rather than true out owing winds. Higher spectral resolution is necessary to resolve this issue.

The question of galactic winds aside, it is clear the dynam ical state of IR 23128 is

very complex. The axis of rotation shifts by 90 between the outer tidal features and the rotating southern disk, while the northern galaxy shows a som ewhat retrograde motions, around a rotation axis orthogonal to that of the southern disk. The tidal features generally trace much of the initial angular momentum of the system; the fact that the inner disk has been slewed by 90 suggests that the gravitational torques have been strong and slow, i.e. that IR 23128 is well past the rst encounter and now experiencing the nal destructive merging phase. The multiple kinem atic components within the merging pair cannot survive for long { collisional shocks and gravitational torques will rapidly erase these features and drive strong in ow (e.g., M ihos & Hemquist 1996). We are most likely witnessing IR 23128 in a very shortlived phase where violent relaxation is rapidly altering the structural and dynam ical properties of the system.

4. D iscussion

A though our sample of ultralum inous IRAS galaxies is necessarily small, we nevertheless have detected a wide variety of dynamical states, even though the bolom etric lum inosities are all quite sim ilar. The combined morphological and kinem atic features in the galaxies suggests the following age-ordering for the four system s:

IR 14348 is the dynam ically youngest as indicated by its short tidal tails, relatively unperturbed kinem atics, and widely distributed star form ation. The system has not merged yet and its rst dynam ical response to the initial encounter is the initiation of wide spread star form ation, which likely powers much of the observed IR lum inosity. Strong gaseous in ows may not yet have developed in IR 14348, and this system may be analogous to other \young" ultralum inous systems such as II Zw 96, VV 114, and A rp 299 (e.g., Yun, Scoville, & Knop 1994; Goldader et al. 1997).

IR 19254 is well past the st collision as evidenced by the long tidal tails. The two disks are still well-separated (10 kpc) and their coherent rotation suggest it is not yet in the latest stages of merging. It is unclear if the Seyfert activity in the southerm galaxy is a response to the current interaction or was a pre-existing condition. The strong H seen near the nuclear regions suggests the interaction is su ciently advanced that gas is starting to ow inwards.

IR 23128 is dynam ically complex. It is currently experiencing strong dynam ical perturbation. This coupled with its close projected separation and distorted kinem atics indicate it is the nalmerging phase and most of the emission is concentrated in the central regions. Some evidence for kinem atic fædback and

baryonic blow out of the nuclear gas exists and this system may therefore be in a similar state as A p 220 (e.g., Heckman etal 1996).

IR 20551 has a single nucleus and a quiescent velocity eld. These are the conditions expected in the post-m erger phase of the interaction where only its rem nant tidal features attest to a m erger origin for the system. Star form ation is no longer widespread in the system and its likely that its ultralum inous phase is near the end.

G iven this putative dynam ical age dating sequence, it is som ewhat surprising that at sim ilar bolom etric lum inosity we see such a range of dynam ical conditions. Our sam ple was chosen to have high infrared lum inosity, and one m ight have expected that this criteria would have strongly biased our sam ple towards late stage m ergers. W hile the sam ple is sm all, we do not see any strong bias. We do see a trend between dynam ical age and H concentration, in that m ore evolved systems seem to have m ore centrally concentrated H em ission (due to central starbursts or AGN). This is consistent with the idea that collisions drive disk gas into the nucleus over a few dynam ical times during the encounter. N onetheless, it is som ewhat surprising that such high lum inosities can be achieved in young objects with extended em ission as well as the m ore evolved, concentrated objects. C learly, ultralum inous activity is not con ned solely to late stage m ergers where the gaseous in ow s are com plete.

At face value, the fact that these ultralum inous infrared galaxies are found in a variety of dynam ical phases might indicate that the ultralum inous phase is long-lived. If the observed lum inosity is powered by star form ation, this would require starburst activity to last several dynamical timescales. Such a scenario is rather di cult to envision. Spectral m odeling of ultralum inous starbursts by Goldader et al. (1997) indicate starburst lifetim es 10^8 years, much less than typical merging times of 5 10^8 years. Furtherm ore, for of inferred star form ation rates of 100 M yr¹ (e.g., Leitherer & Heckm an 1995; Goldader et al. 1997), the gas depletion times are $5 10^7$ years, again much shorter than the merging timescale; truncating the IMF below 1 M increases the depletion times by only a factor of two (Goldader et al.). It would thus seen unlikely that sustained ultralum inous starburst activity is possible in these systems. Perhaps a more stochastic starburst model, where a series of m inibursts with a long \duty cycle" occurs over a few dynam ical tim escales, m ight supply the observed lum inosity, although such a scenario seem s rather contrived.

An alternative would be to appeal to AGN activity as the primary source of the lum inosity. In this case the timescale mismatch is signicantly lessened as su cient gas is available to sustain AGN activity over a few dynamical timescales. However, the relatively bong time spent by interacting galaxies at apogalacticon would result in a large fraction of ultralum inous IRAS galaxies being observed in wide pairs if the ultralum inous phase does span the merging timescale. This prediction is in the opposite sense of the observed morphological trends (Murphy et al. 1996), where most ultralum inous systems are found to be close mergers.

G iven that a long-lived ultralum inous phase is inconsistent both with observational data and physical considerations, we are driven by our data to the more likely view that dynam ical phase is not the single triggering criteria for ultralum inous activity. A variety of other factors must therefore contribute to the form ation of ultralum inous infrared galaxies. W hile the merger mechanism is the root cause of the observed activity, in portant physical details likely determ ine the particular lum inosity evolution of a given system. Som e of these other factors include 1) the orbital geometry of the encounter (e.g., Barnes & Hemquist 1996), 2) the internal structure of the merging galaxies (M ihos & Hernquist 1994, 1996), or 3) the total amount of gas in the pre-m erger disks. Our sm all data sample does not perm it de nitive conclusions but an important clue com es from the fact that we are witnessing ultralum inous activity in two galaxies which have yet to experience the violent relaxation associated with the m erger (IR 14348 and IR 19254), arguing that internal processes play an important role in determining the response of galaxies to the encounter. Both of these encounters are clearly prograde, as evidenced by the long tidal tails and velocity eld in IR 19254 or the velocity eld of IR 14348. IR 14348 is probably just past the rst collision and signi cantly dynam ically younger than the other three system s. D ynam ical m odels show that the strongest in ows (and, presum ably, starbursts) occur during the nalmerging, and are concentrated in the nuclear regions of the system (Barnes & Hemquist 1991, 1996; M ihos & Hemquist 1994, 1996). W hile IR 19254, IR 20551, and IR 23128 t this general pattern, why did IR 14348 become ultralum inous at an earlier phase, with star form ation over a much larger spatial extent?

The answer may lie in the ambient properties of the disks. IR 14348 is has the highest molecular gas mass of any of the objects in our sample with an inferred molecular mass 6 10¹⁰ M { two to three times that of the other objects (M irabel et al. 1990; Sanders et al. 1991). With such a large reservoir of gas, the perturbation at instance may drive gas into collapse locally, increasing gas densities and boosting star form ation throughout the system without needing to wait for global instabilities to drive gas inwards and fuel a central starburst. As the system evolves, central gas ow swill fuel a central starburst thus changing the relative contributions of nuclear vs extended star form ation to the total emitted energy. Indeed, it is interesting to note that the star form ing morphology of this system is similar to the morphology of high redshift galaxies in the Hubble D exp Field (e.g., Abraham et al. 1996; van den Bergh et al. 1996; G iavalisco et al. 1996); IR 14348 m ay

In our sample of ultralum inous infrared galaxies, we also nd several examples of extrem ely lum inous H knots in tidaltails. These knots have H lum inosities comparable to that of the Large and Sm all M agellenic C buds, and their relatively low velocity dispersions suggest they are pockets of gas in isolated collapse; if they have su cient m ass to resist baryonic blow out, they m ay well evolve into bona- de dwarf galaxies (Zwicky 1956; Duc & M irabel 1994; B ames & H emquist 1992). These objects seem to be m ore common in the less evolved system s IR 14348 and IR 19254; by later stages of the m erging evolution they m ay have depleted their gas and ceased star form ation or, in instances where these clum ps form close to their host galaxies, fallen back into the m erger rem nant. At the very least, how ever, our data clearly show s that objects like dwarf galaxies can form in the early stages of a m erger encounter at distances up to 50 kpc away from the m ain m erging bodies.

In sum mary, the velocity elds of ultralum inous infrared galaxies prove quite diverse. There does not appear to be a common dynamical feature among all four objects, other than the simple fact that they are all strongly interacting. The variety of ages and kinem atic features suggest that several dierent factors play a role into triggering ultralum inous activity, including interaction geometry, galactic structure, and gas content. While numerical models do a reasonable job of describing the evolution of galaxy mergers in a statistical sense, one-to-one matching of individual systems will prove more problem atic due to varying initial conditions for dierent interacting pairs. From a galaxy evolution standpoint, our data reveal the strong and rapid dynam ical evolution associated with violent relaxation in the nalmerging phase. The two objects which have not yet experienced this

nalphase { \mathbb{R} 14348 and \mathbb{R} 19254 { are comprised of relatively simple rotating disks. On the other hand, \mathbb{R} 20551 is perhaps only a few 10⁷ years past its merger, yet it already has settled down into a quiescent kinematic phase. Only \mathbb{R} 23128 shows the very disturbed kinematics expected as two galaxies ultimately merge, and the lifetime for this phase must be short. Over the long dynamical history of a merger event, it is only in the nalphase that strong dynamical evolution occurs on global scales. Once the merger is complete and the starburst quickly fades, the remnant will evolve rather quiescently; however, signatures of the merger remain behind { di use gas disks, tidal features, and, possibly, young dwarf galaxies { which attest to this violent phase of galaxy evolution.
