Absorption of Very High Energy Gamma-Rays by Intergalactic Infared Radiation: A New Determination

A bstract. We present a new calculation of the intergalactic -ray pair-production absorption coeccient as a function of both energy and redshift. In reexam ining this problem, we make use of a new empirially based calculation (as opposed to previous model calculations) of the intergalactic infrared radiation eld (IRF). We not smaller opacities than those given previously (Stecker & De Jager 1997). We apply our results to the new observations of the aring -ray spectra of M rk 421 and M rk 501, both at a redshift of 0.03.0 ur new calculations indicate that there should be no signi cant curvature in the spectra of these sources for energies below 10 TeV, as indicated by recent observations. How ever, the intrinsic spectra of these sources should be harder by amounts of 0.25 to 0.45 in the spectral index (in the 1 - 10 TeV range), with an intergalactic absorption cuto above 20 TeV.

1. Introduction

We have previously pointed out (Stecker, De Jager & Salam on 1992 (hereafter, SD S92)) that very high energy -ray beams from blazars can be used to measure the intergalactic infrared radiation edd, since pair-production interactions of -rays with intergalactic IR photons will attenuate the high-energy ends of blazar spectra. Determ ining the intergalactic IR edd, in turn, allow s us to model the evolution of the galaxies which produce it. As energy thresholds are lowered in both existing and planned ground-based air Cherenkov light detectors (C resti 1996), cuto s in the -ray spectra of more distant blazars are expected, ow ing to extinction by the IRF. These can be used to explore the redshift dependence of the IRF (Stecker & Salam on 1997; Salam on & Stecker 1998). Furtherm ore, by using blazars for a determ ination of attenuation as a function of redshift, com bined with a direct observation of the IR background from the DIRBE detector on COBE, one can, in principle, measure of the Hubble constant H₀ at truly cosm ological distances (Salam on, Stecker & De Jager 1994).

There are now over 50 grazars which have been detected by the EGRET team (Thompson, et al. 1996). These sources, optically violent variable quasars and BL Lac objects, have been detected out to a redshift greater that 2.0 f all of the blazars detected by EGRET, only the bw-redshift BL Lac, M rk 421, has been seen by the W hipple telescope. The fact that the W hipple team did not detect the much brighter EGRET source, 3C 279, at TeV energies (Vacanti, et al. 1990, K errick, et al. 1993) is consistent with the predictions of a cuto for a source at its much higher redshift of 0.54 (see SD S92). So too is the recent observation of two other very close BL Lacs (z < 0.05), viz., M rk 501 (Q uinn, et al. 1996) and 1E S2344+ 514 (C atanese, et al. 1997) which were too faint at G eV energies to be seen by EGRET.

In this paper, we calculate the absorption coe cient of intergalactic space using a new, empirically based calculation of the spectral energy distribution (SED) of intergalactic low energy photons (M alkan & Stecker 1998; hereafter M S98) obtained by integrating lum inosity dependent infrared spectra of galaxies over their lum inosity and redshift distributions. A fler giving our results on the -ray optical depth as a function of energy and redshift out to a redshift of 0.3, we apply our calculations by comparing our results with recent spectral data on M rk 421 as reported by M cEnery, et al. (1997) and spectral data on M rk 501 given by A haronian, et al. (1997). The results presented here supercede those of our previous calculations (Stecker & D e Jager 1997), which were based m ore on theoreticalm odels (see discussion in M S98). W e consider the results presented here to be considerably m ore reliable than any presented previously.

2. The Opacity of Intergalactic Space to the IIR F

The form ulae relevant to absorption calculations involving pair-production are given and discussed in SD S92. For -rays in the TeV energy range, the pair-production cross section is maxim ized when the soft photon energy is in the infrared range:

where $_{e} = h = (m_{e}c)$ is the C ompton wavelength of the electron. For a 1 TeV -ray, this corresponds to a soft photon having a wavelength near the K-band (2.2 m). (Pair-production interactions actually take place with photons over a range of wavelengths around the optim al value as determ ined by the energy dependence of the cross section.) If the emission spectrum of an extragalactic source extends beyond 20 TeV, then the extragalactic infrared eld should cut o the observed spectrum between 20 GeV and 20 TeV, depending on the redshift of the source (Stecker & Salam on 1997; Salam on & Stecker 1998, and this paper).

In our calculations, we make the reasonable sim plifying assumption that the IRF is basically in place at redshifts < 0.3, having been produced primarily at higher redshifts (M adau 1996; Stecker & Salam on 1997; Salam on & Stecker 1998 and references therein). We therefore limited our calculations to z < 0.3. For a treatment of intergalactic absorption at higher redshifts by optical and UV photons using recent data on galaxy evolution at moderate and high redshifts, see Stecker & Salam on (1997) and Salam on & Stecker (1998).

We assume for the IIRF, two of the SEDs given in M S98 (shown in Figure 1); the lower curve in Figure 1 assumes evolution out to z = 1, whereas the upper curve assumes evolution out to z = 2. Evolution in stellar emissivity is expected to levelo or decrease at redshifts greater than 1:5 (Fall, Charlot & Pei1996, M adau 1996), so that the two curves in Fig. 1 m ay be considered to be lower and upper limits, bounding the expected IR ux (M S98). Using these two SEDs for the IIRF, we have obtained parametric expressions for (E;z) for z < 0.3, taking a Hubble constant of H $_{\circ} = 65$ km s ¹M pc ¹ (G ratton, et al. 1997). The double-peaked form of the SED of the IIRF requires a 3rd order polynom ial to reproduce parametrically. It is of the form

where the z-dependent coe cients are given by

Table 1 gives the num erical values for a_{ij}, with i = 0;1;2;3, and j = 0;1;2. The num bers before the brackets are obtained using the lower IIRF SED shown in Figure 1; The num bers in the brackets are obtained using the higher IIRF SED. Because we are using real IRAS data to give m ore accurate estimates of the IIRF, we do not give values of for E < 1 TeV and for larger redshifts, which would involve interactions with starlight photons of wavelengths 1 m. Equation (2) approximates (E;z) correctly within 10% for all values of z and E considered.

Figure 2 shows the results of our calculations of the optical depth for various energies and redshifts up to 0.3. Figure 3 shows observed spectra for M rk 421 (M cEnery, et al. 1997) and M rk 501 (A haronian et al. 1997) in the aring phase, compared with best-t spectra of the form KE exp((E; z = 0.03)), with (E; z) given by the two

appropriate curves shown in Figure 2.B ecause < 1 for E < 10, TeV, there is no obvious curvature in the di erential spectra below this energy; rather, we obtain a slight steepening in the power-law spectra of the sources as a result of the weak absorption. This result in plies that the intrinsic spectra of the sources should be harder by 0.25 in the low er IRRF case, and 0.45 in the higher IRF case.

3.D iscussion and Conclusions

We have calculated the absorption coe cient of intergalactic space from pair-production interactions with low energy photons of the IRF, both as a function of energy and redshift, using new, more reliable estimates of the SED for the IRF which were obtained by M S98.0 ur results predict less absorption than we obtained previously (Stecker & De Jager 1997), because the M S98 IRF is lower than our previous estimate. One reason for this di erence is that our previous IRF spectrum was normalized partly to rect the estimate of G regorich, et al. (1995) of the IRF at 60 m. A coording to Bertin, Dennefeld & M oshir (1997), that estimate may have been based on the inclusion of false detections in their analysis of the IRAS data. For absorption calculations, it is in portant to use the most reliable estimate of the IRF available, since the absorption e ect depends exponentially on the magnitude of the IRF.W hile we do not claim that our new results for the absorption coee cient as a function of energy di er dramatically from those obtained previously (M adM inn & Primack 1996; Stecker & De Jager 1997), we do claim that they are more reliable because they are based on the empirically derived IRF given by M S98, whereas all previous calculations of TeV -ray absorption were based on theoreticalm odeling of the IRF. The M S98 calculation was based on data from nearly 3000 IRAS galaxies. These data included (1) the lum inosity dependent infrared SED s of galaxies, (2) the 60 m lum inosity function of galaxies and, (3) the redshift distribution of galaxies.

We have applied our absorption calculations to recent aring spectra of the nearby BL Lac objects M rk 421 and M rk 501. The spectral calculations given here are in good agreement with the recent observations that indicate no signi cant curvature in the spectra of M rk 421 and M rk 501. The observations are also consistent with our calculated steepening of 0.25 to 0.45 in the spectral index of these sources in the 1-10 TeV range. Our new calculations predict a signi cant intergalactic absorption elect which should cut o the spectra of M rk 421 and M rk 501 at energies greater than 20 TeV. O bservations of these objects at large zenith angles, which give large elective threshold energies, m ay thus demonstrate the elect of intergalactic absorption.

Our new calculations con m the conclusion in SD S92 that TeV spectra of sources at redshifts higher than 0.1 should su er signi cant absorption. The recent detection of another XBL at a redshift below 0.1, viz., 1E S2344+514 (C atanese, et al. 1997), further supports the argument that nearby XBLs may be the only signi cant TeV sources presently detectable (Stecker, De Jager & Salam on 1996).
