M etallicity E ects in NLTE M odel A tm ospheres of Type Ia Supernovae

ABSTRACT

We have calculated a grid of photospheric phase atmospheres of Type Ia supernovae (SN e Ia) with m etallicities from ten times to one thirtieth the solar m etallicity in the C+O layer of the de agration model, W 7. W e have modeled the spectra using the multi-purpose NLTE model-atm osphere and spectrum -synthesis code, PHOENIX.We show models for the epochs 7, 10, 15, 20, and 35 days after explosion. When compared to observed spectra obtained at the approxim ately corresponding epochs these synthetic spectra t reasonably well. The spectra show variation in the overall level of the UV continuum with lower uxes form odels with higher metallicity in the unburned C+O layer. This is consistent with the classical surface cooling and line blocking e ect due to m etals in the outer layers of C+O. The UV features also m ove consistently to the blue with higher metallicity, demonstrating that they are forming at shallower and faster layers in the atm osphere. The potentially most usefule ect is the bluew ard movem ent of the SiII feature at 6150 A with increasing C+O layer metallicity. We also dem onstrate the m ore complex elects of m etallicity variations by m odifying the 54 Fe content of the incomplete burning zone in W 7 at maximum light. We brie y address some shortcom ings of the W 7 m odel when com pared to observations. Finally, we identify that the split in the CaH+K feature produced in W 7 and observed in some SNe Ia is due to a blending e ect of C a II and Si II and does not necessarily represent a com plex abundance or ionization e ect in C a II.

1. Introduction

Type Ia supernovae (SN e Ia) are recognized for their near uniform ity as standard candles. This has led to the use of SN e Ia in cosm ology (B ranch 1999; G amavich et al. 1998; R iess et al. 1998; Perlm utter et al. 1999). The developm ent of em pirical calibrations between peak brightness and light curve shape (P hillips 1993; H am uy et al. 1996; R iess et al. 1996; Perlm utter et al. 1997a,b; Tripp & B ranch 1999), have enhanced the usefulness of SN e Ia as distance indicators. N evertheless theoretical m odelers have yet to agree on the source of these apparently system atic variations. A prim ary concern is the evolutionary lifetim e of SN e Ia progenitors and the possibility of signi cant deviations of distant SN e Ia from their wellobserved counterparts in the local galactic neighborhood. If galactic chem ical evolution occurs slow ly, then m ore distant SN e arise from a younger, m etalpoor population. O n the other hand, the m etallicity variations in the local sam plem ay already span the range of the entire observational sam ple.

We probe the possible e ects of progenitor m etallicity variations on the observed spectra, by m odifying the parameterized de agration m odel, W 7 (N om oto et al. 1984; Thielem ann et al. 1986). U sing base ts to observations (x 2.3) we have scaled all elements heavier than oxygen in the unburned C+O layer of W 7 to simulate the e ects of various m etallicities in the progenitor system . Ho ich et al. (1998) explored this question by m odifying the pre-explosion m etal content of a particular SN e Ia m odel and noted the di erences in nal composition, light curves, and spectra. They found that the composition of the partially burned layers of the ejecta yielded larger quantities of 54 Fe. A similar e ect can be seen in the low ered 54 Fe abundance when W 7 is calculated using a pure C+O m ixture without other m etals (Iwam oto et al. 1999). We have m odi ed the 54 Fe abundance of the partially burned layers of W 7, to replicate this e ect. While Ho ich et al. (1998) focused m ainly on the elects of m etallicity variations on the light curve and energetics, here we concentrate exclusively on its elects on the observed spectra, particularly at early times where the form ation of the spectrum occurs in the unburned C+O layer, which is most sensitive to initial progenitor m etallicity.

O ur com putational m ethods are given in x 2. In x 3 we show the e ects of m etallicity m odi – cation of the C+O layer on the synthetic spectra at each epoch. In x 4 we show the e ects of 54 Fe on day 20 and 35 m odel spectra. In x 5.1 we discuss the evolution of the Si II feature at 6150 A.

2. M ethods

2.1. A bundance M odi cation

To model the e ects of m etallicity on SN e Ia, we have modi ed the base W 7 model at several epochs. W 7, while clearly not the complete model for SN e Ia, is a good starting point for spectral modeling. The composition structure of W 7 as a function of velocity does reasonably well in reproducing the observed spectra of SN e Ia (Harkness 1991a,b; Branch et al. 1985; Nugent et al. 1997). By making separate calculations to consider the direct (C + O m etallicity) and the indirect explosive nucleosynthetic consequences (54 Fe enhancement), our computational methods allow us to probe these e ects of progenitor metallicity independently. Ho ich et al. (1998) changed the composition before computing the hydrodynamics and explosive nucleosynthesis of the model. This gives them consistent nucleosynthesis and energetics within the context of their chosen input physics. How – ever, it is di cult to separate e ects in spectra that arise from di erent consequences of the initial metallicity variation.

To modify the metallicity of the unburned C+O layer we have scaled the number abundances of elements heavier than oxygen in the velocity range $14800{30000 \text{ km s}^1}$ by a constant factor , such that for all species i heavier than oxygen, the new number abundance n_i^0 , is given by

in each layer. For all epochs we have used C+O m etallicity factors, , of 10, 3, 1, 1/3, 1/10, and 1/30. These e ects are discussed in detail in x 3.

The nucleosynthesis results of H o ich et al. (1998) show that modifying the metallicity of the progenitor white dwarf changes the quantity of 54 Fe produced in the incomplete burning zone in a manner approximately proportional to the metallicity. This is due to excess neutrons in the progenitor over a pure C+O mixture, particularly 22 Ne (see for example A mett 1996; Nom oto et al. 1984; Iwam oto et al. 1999, and references therein). To simulate this e ect in W 7, we have scaled the 54 Fe abundance in the incomplete burning zone of W 7, 8800{14800 km s 1 , in the same manner as the C+O layer metallicity,

The mass fractions are then renorm alized in each layer. We have used 54 Fe abundance factors, , of 3, 1, 1/3, 1/10, and 1/30 for the epochs 20 and 35 days after explosion. For the rem aining epochs we have only computed models for $1/10^{54}$ Fe abundance (= 0:1). These e ects are discussed in detail in x 4.

Finally, we simulate the full e ects of progenitor m etallicity on the output spectra, by com - bining the two e ects, C+O layer m etallicity and incomplete burning zone ⁵⁴Fe abundance, into

a single series of m odels. For each m odel we have used the same factor for both C+O m etallicity and ⁵⁴Fe abundance (=). These factors are the same as for the⁵⁴Fe abundance m odi cations above. These e ects are discussed in detail in x 4.

2.2. Com putational M ethods of PHOENIX

The calculations were performed using them ulti-purpose stellar atm ospheres program PHOENIX 9.1 (H auschildt & B aron 1999; B aron & H auschildt 1998; H auschildt et al. 1997a,b, 1996). PHOENIX solves the radiative transfer equation along characteristic rays in spherical symmetry including all special relativistic e ects. The non-LTE (NLTE) rate equations for several ionization states are solved including the e ects of ionization from non-them al electrons from the -decay energy of the 56 N i core. The atom s and ions calculated in NLTE are: H e I (11 levels), H e II (10), C I (228), O I (36), N a I (3), M g II (18), S i II (94), S II (85), T i II (204), F e II (617), and C o II (255). Each m odel atom includes prim ary NLTE transitions, which are used to calculate the level populations and opacity, and weaker secondary NLTE transitions which are are included in the opacity and implicitly a ect the rate equations via their e ect on the solution to the transport equation. In addition to the NLTE transitions, a number of LTE line opacities for atom ic species not treated in NLTE are treated with the equivalent two-level atom source function, using a therm alization parameter, = 0:1, as in Nugent et al. (1997) for LTE lines for all m odels in this paper. The atm ospheres are iterated to energy balance in the co-m oving fram e,

where, S- is the deposited energy from radioactive decay, and have their usual meaning and c = 1. This equation neglects the explicit elects of time dependence in the radiation transport equation, however the term on the right hand side implicitly includes these elects. The models are parameterized only by the day, which determ ine the radii and amount of radioactive decay, and by the lum inosity parameter, , which is de ned as,

where L^{abs} is the instantaneous deposition of radioactive decay -ray energy. The deposition of -rays is determ ined by solving a grey transport equation (Nugent 1997; Nugent et al. 1997; Sutherland & W heeler 1984) as a function of time. This approach has been shown to be of su cient accuracy for our purposes when com pared to detailed M onte-C arb calculations (Sw artz et al. 1995). We use two dierent inner boundary conditions for our models. For days 7, 10, and 15, which are optically thick at the core, we use a di usive inner boundary condition. For days 20 and 35 which have lower total optical depth we use a hebular' inner boundary. This boundary condition takes the downward intensity of any ray and assumes that it passes unimpeded through the core of the atm osphere, becoming the upward intensity on the other side, with only the necessary Lorentz transform ation. A dditional details on the use of PHOENIX in modeling SN e Ia atm ospheres can be found in Nugent (1997).

2.3. Baseline M odels

To perform numerical experiments on the metallicity e ects in the spectra of SN e Ia, we need reasonable base models for each epoch. For each day, an observed spectrum of SN 1994D was tted with a W 7 model of appropriate age. Several models were computed with various lum inosity parameters, , to ne tune the spectral shape. A separate paper tting W 7 to SN 1994D photospheric era spectra (Lentz et al. in preparation) shows the comparisons to observations. Ho ich & Khokhlov (1996) nd (their Q) in the range 0:7 < 1:8. When > 1 stored radiative energy is being released and when < 1 radiative energy is being stored.

The maximum light (epoch day 0 for the observations) t for SN 1994D to W 7 (with = 1.0) at day 20 after the explosion is the same as in Nugent et al. (1997). For the two model ts at days 10 (which we compare to day -9 with respect to B maximum) and 15 (compared to day -4 with respect to B maximum) for W 7 we have used lum inosity parameters of = 0.4 and = 0.8respectively. For these two models the ts are generally good, but with all of the pre-maximum spectra, the red edge of the SiII feature at 6150 A does not extend far enough to the red. For m odel day 7 (t to day -12) we chose the the m odel with lum inosity = 0.1. This m odel ts the lum inosity and most features well; however, like the day 10 models the CaH+K feature not extend blueward enough when compared to the earliest observations. Hatano et al. (1999) have modeled the same spectra and found that the CaH+K feature requires ionized calcium with velocities up 40000 km s¹. We have conducted experiments extending the density pro le of W 7. This to did not provide enough optical depth in the CaH+K feature to a ect the line pro le. Neither do our models reproduce the secondary feature at 4700 A that Hatano et al. (1999) ascribe to Fe II absorption in the C+O layer. For our post-m axim um model, day 35 (15 days after m axim um), we t the observation with a model with $\lim inosity_1 = 1.5$. This model ts generally; how ever, the large feature at 4800 A (probably Fe II) is not seen in the observations. The observed N a ID -line feature is missing, probably due to de ciencies in the sodium model atom, which has already been in proved in the latest version of PHOENIX. Here, we are interested in sm all di erential e ects so it was essential that all models be run with the code version frozen.

3. M etallicity of Unburned C+O Layer

The simplest e ect of metallicity on the spectral form ation in SN e Ia is the change in the metal content of the unburned C+O layer neglecting changes in the density structure and deeper layers. In this section we exam ine these e ects independently of other e ects of progenitor metallicity on SN e Ia. Since ongoing supernova searches are expected to discover SN e early, and early spectra probe the outerm ost layers only, this approach is sensible and yields physical insight that is somewhat model independent.

W hen we look at the overall UVO IR synthetic spectra (Figures 1, 6, 8, 11, and 13) of the models with variations in the C+O layer metallicity, we see two consistent and signi cant e ects: shifts in the UV pseudo-continuum level (expanded view for day 7 in Figure 2) and variations in the SiII line at 6150 A (expanded views in Figure 5).

The general e ect in the UV is the increase in the UV pseudo-continuum levelwith decreasing m etallicity. Simultaneous is the redward (blueward) shift of most UV features with decreasing (increasing) m etallicity. In the UV, the line-form ing region is in the C+O layer. As the m etallicity decreases, the line form ing region must reach deeper into the atmosphere to have the same line opacity, resulting in sm aller line velocities. M odi cation of the C+O layer m etallabundance gives a classic surface cooling e ect, low er tem peratures for higher m etallicity. The higher tem peratures of the low er m etallicity C+O atm ospheres give higher therm all uxes, moving the UV pseudo-continuum higher with low er m etallicity. The surface cooling and the resulting shifts in UV pseudo-continuum are evident at every epoch. There is the com plem entary e ect of additional m etals increasing the line blocking. W e m ake no attempt to separate these two e ects in this paper.

The Si II line at 6150 A (Figure 5) shifts blueward with increases in metallicity for epochs through day 20. These shifts demonstrate that some line formation in this feature takes place in the C+O layer. The earlier epochs show large variations in the total depth of the feature which implies that the line forms less in the incom plete burning zone with its large, unchanging silicon abundance, and more in the C+O layer where the silicon abundance changes. At later epochs these conditions are reversed, resulting in smaller changes with C+O layer metallicity variation. These e ects are discussed further in x 5.1.

The M g II h+k" feature at 2600 A (Figure 2) does not move to the blue or red as them etallicity varies. The decrease in M g II h+k feature strength with increasing m etallicity is caused by the increasing UV line blanketing from background line opacity in the C+O layer. The M g II absorption occurs mostly in the deeper, partially burned layer that is highly enriched in m agnesium . We have con rm ed this hypothesis by calculating diagnostic output spectra without using any background opacity (see B aron et al. 1999, for a discussion of the m ethod). These diagnostic spectra suggest that this feature (and the feature near 2800 A) m ay actually be due to a com plicated blend of M g II UV 1-4 transitions: h+k (UV 1) 2798, (UV 2) 2796, (UV 3) 2933, and (UV 4) 2660.

3.1. Day 7

Our grid of synthetic spectra of W 7 on day 7 with C+O metallicity variations are shown in Figure 1. The case = 10 is likely extreme and is shown for illustrative purposes only, we don't consider it further at this epoch. The UV spectra (Figure 2), show variations in the pseudocontinuum due to surface cooling, line blocking, and feature shifts due to changes in the feature form ation depth (velocity). The pseudo-continuum level in the optical and IR vary with m etallicity. Low erm etallicities have low er pseudo-continuum uxes. Figures 3 and 4 display optical and infrared spectra which illustrate this e ect m ore clearly. This is due to backwarm ing. Figure 3 shows that the line features at 3650 A (Ca II H+K), 4250 A (Fe II, Mg II, & Si III), 4700 A (Fe II), and 5650 A (Si II) nearly disappear as the metallicity drops to 1/30 of normal. The 4700 A Fe II feature is weak and doesn't extend far enough to the blue in the base model ts (x 2.3). Increasing the m etallicity by even a factor of 10 does not extend the feature blueward enough (to su ciently large velocities) to m atch the observations. The same is true of the Ca IIH+K lines. This indicates that more mass extending to higher velocities is needed to t this feature. The Si II feature at 6150 A (Figure 5a) shows the blueward movement of the feature minimum and blue-edge wall with increasing metallicity. The slope of the red edge of the feature changes and at the lowest m etallicities the feature is not strong enough to form the red em ission wing of the P C ygni feature. The infrared spectra (Figure 4) show several features that weaken with lower metallicity, M q II 9226 A and Silcom plexes at 10482 and 10869 A (cf.M illard et al. 1999), as well as two features that strengthen with lower metallicity. These two O I features (7400 A and 8150 A) weaken as the oxygen abundances decreases in favor of higher Z m etals.

3.2. Day 10

O ur grid of synthetic spectra of W 7 on day 10 with m etallicity variations in the C+O layer (Figure 6) display similar variations to those in the day 7 spectra (Figure 1). The UV variations again show the blue-shifted features and lower continua with increasing m etallicity. The optical pseudo-continuum e ects (Figure 7) are still present, but sm aller. W e again see lines that deepen with increased m etallicity such as 3650 A (C a II H+K), 4250 A (Fe II, M g II, & Si III), and 6100 A (Si II), but these e ects are less dram atic than at day 7. The Si II feature (Figure 5b) still shows the changing depth and slopes of the line edges with m etallicity, but, at day 10 the depth of the Si II feature in the lowest m etallicity in odel is larger than in the same m odel on day 7, relative to the highest C+O layer m etallicity in the respective epoch. These e ects on the optical lines indicate that line form ation for certain strong lines is now taking place in layers below the C+O layer. The e ects of line form ation below the C+O layer becomes more important as the supernova atm osphere expands and becomes less opaque.

3.3. Day 15

Our grid of synthetic spectra of W 7 on day 15 with C+O m etallicity variations (Figure 8) are again similar to those in the day 7 and 10 spectra (Figures 1 & 6). The decreasing e ects of C+O layer m etallicity are apparent. The UV pseudo-continuum variation with m etallicity remains strong. The optical (Figure 9) and the near infrared (Figure 10) show the backwarm ing optical/IR pseudo-continuum ux e ect which occurred in the optical at day 10, and extended well into the IR at day 7. Features which increased in strength with increasing C+O m etallicity are a blend of Fe II, M g II, & Si III at 4250 A, the multi-species blend at 3300 A, M g II at 8850 A, and an unidenti ed feature at 10400 A (possibly Si I). The feature at 3300 A is a blend of weak lines that form s in the C+O layer. Figure 9 illustrates the blue shifting of features as changes in m etal content m ove the depth (and thus velocity) of line form ation.

The two component feature at 3700{3900 A is usually labeled C a II H + K .N ugent et al. (1997) have identi ed this C a split' as arising from a blend of C a II H + K with Si II 3858. We have calculated a series of diagnostic spectra at this epoch using the same temperature structure, but without background opacity. We have con rm ed the identi cation of the blue wing with the Si II line. W hen spectra are calculated without any other line opacities, C a II form s a pair of features. The blue C a II absorption form s from the 3727 line, the red absorption from the H + K lines. The Si II feature falls on the peak between the two C a II absorptions. A s the Si II feature strengthens, the ux displaced by its absorption 'lls-in' the C a II H + K absorption creating a 'split'. W ith enough Si II only the blue absorption feature rem ains, while the red feature is weaker or the C a II H + K is stronger, preventing the form ation of a split. This helps to illustrate that in supemovae of all types, features are often the result of m ore than one multiplet, or even ionic species.

The SiII feature at 6150 A (Figure 5c) show smuch smaller, but still signi cant, e ects due to C+O m etallicity. The blue edges are parallel and the red edges nearly so. The depth contrast is now much smaller than before. This is strong evidence that the feature is form ing primarily below the C+O layer at this epoch. Figure 10 shows the displacement of oxygen by metals in the O I lines at 7450 A, 8100 A, and 8250 A, the latter two of which are superim posed on the stronger C = II 'IR triplet' which, like the H+K absorption, forms in the calcium rich incom plete burning zone and is una ected by the C+O metallicity.

3.4. Day 20

Our grid of synthetic spectra of W 7 on day 20, approximately maximum B magnitude, with C+O metallicity variations (Figure 11) shows the continuing reduction in importance of the C+O layer metallicity as the atm osphere becomes more optically thin. The UV pseudo-continuum and feature shift elects are still strong. The only remaining features which display C+O layer metallicity elects in the optical (Figure 12) are the Ca II H+K, the 4250 A (Fe II, Mg II, & Si III), and

6150 A Si II features. As at day 15, the Ca split' remains, the blue component increasing in strength and the red component decreasing with increasing C+O m etallicity. The Si II feature at 6150 A (Figure 5d) now shows parallel edges (both blue and red) for the various C+O layer m etallicities. The relatively sm all changes in the line strength indicate that the feature form s m ostly in the deeper, silicon rich layers, but som e m easurable e ects due to C+O layer m etallicity are still evident.

3.5. Day 35

O ur grid of synthetic spectra of W 7 on day 35 with C+O m etallicity variations are plotted in F igure 13. The UV features still show the same pseudo-continuum and line shifting behavior seen in the previous epochs. This illustrates that even at this epoch the pseudo-continuum formation in the UV is still in the unburned C+O layer. The Si II feature at 6150 A has only sm all variations which can not be separated from the pseudo-continuum e ects. It should be noted that the Si II feature at this epoch to the observations rather poorly.

In the optical we see the blue-shifting of the 4800 A (Fe II) feature with increasing m etallicity without signi cant changes to the overall width, shape, or depth of the feature. This indicates that it form s mostly at deeper layers, with smaller e ects from the C+O layer. When looking for a base t for this epoch, we nd that while the line shapes near 5000 A are better with some what hotter m odels, those m odels had poor overall spectral shape or color. To diagnose this sudden change in m odel behavior, we have plotted the tem perature pro le of the three m odels with the lowest m etallicity, the density pro le, and the carbon abundance (Figure 14). We can see that the = 1=30 m odel has a de nite tem perature inversion. This inversion corresponds to the position of the density spike in W 7 arising from the de agration wave. The higher density coincides with the change from the m ore e cient cooling available by interm ediate m asselements to that of the less e cient cooling of C+O creating the tem perature inversion. In m odels with higher m etal content the e ectiveness of cooling by m etals in the C+O layer provides the needed cooling to prevent the form ation of an inversion.

4. ⁵⁴Fe C ontent of Incom plete Burning Zone

4.1. Pre-Maximum Light Epochs

W e have com puted m odels with 54 Fe abundance reductions of 1/10 in the interm ediate burning zone and m odels with the combined 1/10 C+O m etallicity and 1/10 54 Fe abundance reductions for the epochs 7, 10, and 15 days. W hen we compared the 54 Fe reduced abundance m odels with the related m odels containing the sam e C+O m etallicities (norm al and 1/10 norm al, respectively) we found no changes in feature strength. Som e slight di erences in pseudo-continuum levels were

seen in the day 10 and 15 com parisons. These m ay be due to weaker versions of the 54 Fe abundance caused backwarm ing described in x 42. Since each comparison pair includes two models with di erent composition in the incomplete burning zone this may slightly a ect the tem perature structure.

4.2. Day 20

Our grid of synthetic spectra of W 7 on day 20, approximately maximum B magnitude, with incomplete burning zone ⁵⁴Fe abundance variations is shown in Figure 15. Some small vertical displacements of the UV ux, without blue-or red-shift, can be understood by the elects of surface cooling/backwarming in the incomplete burning zone. As intermediate mass elements are replaced by ⁵⁴Fe, the larger line opacity of iron cools the ⁵⁴Fe rich models. Since this does not a loce the temperature gradient in the C+O layer, the temperature shift remains constant throughout the C+O layer.

In the optical (Figure 16) we can see a few features that decrease with increasing 54 Fe, such as the SiII and S II in the 4850 A feature, the S II \W " at 5300 A, and the SiII feature at 6150 A. This is caused by displacement of the species forming the line by additional 54 Fe. Several features can be seen to strengthen with greater 54 Fe abundance. This indicates that they are formed at least in part by iron in the incomplete burning zone. These features included the feature at 4100 A that erodes the peak of a neighboring feature and the red wing of the 4300 A feature.

O ur grid of synthetic spectra of W 7 on day 20 with incom plete burning zone 54 Fe abundance variations and C+O layer metallicity are shown in Figure 17. The elects of the combined modications mostly separate into the elects seen in Figures 11 & 15. The UV displacements in ux and the elects on the Si II 6150 A feature in the combined models reject the elects of metallicity variation in the C+O layer alone. The S II \W " at 5300 A and the \peak erosion" line at 4100 A show the primary elect of 54 Fe abundance on the optical spectra (Figure 18) when both the 54 Fe abundance and the C+O layer metallicity are varied simultaneously. The elect of the combined modication has the combination elects of deeper red wing strength with increasing 54 Fe abundance and a deeper blue wing (M g II) with increasing C+O layer metallicity. The changes in the C+O layer metallicity and in the 54 Fe abundance of the incom plete burning zone each have elects which are separate from one another and combined elect is essentially the sum of the two elects.

4.3. Day 35

Our grid of synthetic spectra of W 7 on day 35 with incom plete burning zone ⁵⁴Fe abundance variations are shown in Figure 19. The UV pseudo-continuum varies due to the 'surface' cooling and additional line blocking in the incom plete burning zone. The O I feature at 8000 A and the

Si II feature at 6150 A become weaker as oxygen and silicon are displaced by 54 Fe. There are several signi cant e ects in the infrared, however, observations which extend far enough into the IR to compare with real SN e Ia are not available.

Our grid of synthetic spectra of W 7 on day 35 with combined incomplete burning zone 54 Fe abundance and C+O layerm etallicity variations are shown in Figure 20. The elects of the combined modi cations mostly separate in the the elects shown in Figures 13 & 19. The UV pseudo-continuum variation, changes near the 5000 A Fe II feature, and the changes to the 11000A feature relect the C+O m etallicity modi cation alone. The small shift in the Si II feature at 6150 A and the surrounding pseudo-continuum show the contributions of 54 Fe abundance modi cation.

5. D iscussion

5.1. Evolution of SiII

Figure 5 shows the evolution of the SiII 6150 A feature to maximum light. The feature grows s stronger and steeper as line form ation of the SiII 6355 feature m oves into the silicon rich layers of W 7. As line form ation m oves into the silicon rich zones, the e ects of C+O layer m etallicity on line form ation, are reduced, but not elim inated. The blue-shift velocities of the deepest points of the SiII feature are plotted for these m odels in Figure 21. Except for the extrem e case, = 10, the blue-shift velocities increase m onotonically with C+O layer m etallicity through day 20. The increasing opacity from the C+O layer m oves the feature blueward. The velocity shifts due to m etallicity are degenerate with changes that could be expected from silicon rich m aterial extending to higher velocities. However, the e ects of prim ary line form ation in the C+O versus silicon rich layers can be distinguished by line shapes. These general trends and spreads in blueshift velocities are sim ilar to those seen in the data by Branch & van den Bergh (1993). They found that the slow er blueshift velocities tended to be found in earlier galaxy types. A sim ilar study correlating blueshift velocities, peak m agnitude (or a suitable proxy), and a m ore quantitative estim ate of the pre-supernova environm ent m etallicity will be the subject of future work.

5.2. O ther Features and E ects

The UV pseudo-continuum shows the e ects of m etallicity through the surface cooling of the C+O layer, additional line blocking and the shifting of lines which form at faster m oving layers with higher m etallicity. The UV pseudo-continuum displacement is relatively constant and still present at 35 days after explosion. The UV displacement over the entire range of m odels is typically 0.5 dex. For the m ore likely range of m etallicities, 1/3 to 3 times solar, the change is up to 0.2 dex or 0.5 m agnitude. Unfortunately, we cannot use near-UV ux as a m etallicity indicator. The UV ux is diagnostic of the tem perature, density, and radius (velocity) of the C+O layer, but is

not uniquely determ ined for any one quantity. The related backwarm ing causes pseudo-continuum shifts in the optical and near infra-red for the early epoch spectra. This backwarm ing shift in continua fades in strength as pseudo-continuum form ation moves to deeper layers. A sm aller surface cooling/backwarm ing e ect exists in the partially burned layers from changes in ⁵⁴Fe abundance, beginning at day 20.

Ho ich et al. (1998) also report a change in UV pseudo-continuum for models with di erent m etallicity by noting decreases in the U band magnitude with increasing m etallicity. They show a change in ux in the UV spectra presented, but the change occurs in the opposite direction with m etallicity to that which we nd here. This is due to the di erence in the density structures between delayed detonation models (DDs) they employ and that of the parameterized de agration model W 7 that we use here. In the DD model the lower metallicity model form sthe UV pseudo-continuum at a smaller radius and so the ux is lower for smaller metallicities, since the radial ect wins out over the opacity.

Some features which had signi cant impact from C+O m etallicity at early epochs are nearly una ected at later epochs. At day 7 we nd that most of the optical features nearly disappear when the m etal content is dropped to 1/30 norm al. This indicates that m uch of line form ation for these features takes place in the C+O layer. In later epochs the impact of the C+O layer m etallicity on m ost optical features becomes quite small, since line form ation occurs mostly in the deeper layers.

The in uence of 54 Fe abundance in the incom plete burning zone is very small at early epochs, since signi cant spectrum formation occurs in the C+O layer. At maximum light and later, 54 Fe abundance variations change Fe feature strengths, have some small temperature based e ects on the pseudo-continuum, and change the strength of certain features from species, e.g. sulfur, which are displaced by 54 Fe abundance changes.

We have con med the Nugent et al. (1997) identication of SiII 3858 as a component of the Ca II plit'. To the blue of the Ca II H+K feature is the emission peak from another Ca II line. When the SiII line forms, the SiII absorption falls on that peak and the emission from the SiII line form s a peak in the center of the plit'. For models with a strong SiII feature, the absorption m inimum of the red wing of the Ca II H+K will seem to disappear. For W 7, changes in metallicity alter the strength of the SiII line and thus, the shape of the Ca plit' feature. In real SN e Ia, other factors may prevent the form ation of a plit' such as stronger Ca II H+K, weaker SiII, or temperature e ects. Jha et al. (1999) show spectra for several normal SN e Ia. The Ca II H+K feature in the observations display a range of morphologies sim ilar to those seen in our synthetic spectra. We do not require any abundance or ionization e ect to produce this feature. W hile this interpretation is strictly correct in the model W 7, we suspect it also produces the observed feature in SN e Ia, how ever, detailed com parisons of the calculated velocities to those of the observed features are required.

6. Conclusions

By calculating a series of m odel atm ospheres with abundance variations around the base W 7 m odel for SN e Ia, we have dem onstrated unexpected and complex e ects on the output spectra. The UV spectra show lower ux and blueshifting lines as surface cooling, additional line blocking, and outward movement of the line-forming region occur with higher metallicity in the unburned C+O layer. We have demonstrated, at epochs well before maximum light that line form ation occurs largely in the C+O layer for species that will later form in new ly synthesized material. The splitting' of the Ca II H+K feature we can now better understand as a blend of a Si II feature with the stronger C a II lines, without abundance or ionization e ects in the W 7 m odel. W e have shown that the strength, pro le, and velocity of the SN e Ia characteristic SiII 6150 A feature are a ected by C+O layer metallicity. This provides a mechanism for the variation in the blueshift of the SiII feature without variations in the explosion energy. For exploding white dwarfs of di erent m etallicities Ho ich et al. (1998) and Iwam oto et al. (1999) nd changes in nucleosynthesis. W e tested these e ects on spectra by varying the 54 Fe abundance in the incomplete burning zone. We have found that the ⁵⁴Fe abundance has negligible e ect on pre-m aximum spectra and relatively little e ect afterwards. The e ects of progenitor m etallicity variations can mostly be separated into e ects due to 54 Fe, and those due to C+O m etallicity.

P revious spectral studies (B ranch et al. 1985; H arkness 1991a,b; N ugent et al. 1995, 1997) have shown that W 7 has the appropriate composition structure to reproduce photospheric era spectra. In preparing the base ts for this paper we have found that the quality of the ts decreases away from maximum light. The temperature structure inversion in the lowest metallicity model at day 35 demonstrates the importance of changes (20%) in the temperature structure. We see that density/temperature structures are important in thing spectral features. In forthcoming work we will present the results of numerical experiments to alter the density structure of W 7 to make the model better correspond to the observations.

We have shown through parameterized abundance modi cations of the SNe Ia model W 7 that pre-explosion metallicity can have detectable e ects on the output spectra at every epoch. Due to the uncertainty in hydrodynamic models and severe blending of lines in SNe Ia spectra, we cannot give a prescriptive analysis tool for measuring the pre-explosion metallicity of SNe Ia. How ever, hopefully this can contribute to the understanding of the diversity of SN e Ia, and the ways that various progenitor metallicity e ects can a ect SNe Ia. Studies computing detailed spectra of hydrodynamic models that include progenitor metallicity in the evolution of the star and the hydrodynamics and nucleosynthesis of the supernova should show what e ects overall progenitor metallicity have in creating SN e Ia diversity.
