A Dynam ical Approach to Tem perature

W e present a new dynam ical approach form easuring the tem perature of a H am iltonian dynam ical system in them icro canonical ensem ble of therm odynam ics. W e show that under the hypothesis of ergodicity the tem perature can be computed as a time-average of the functional, r $(r H = kr H k^2)$, on the energy-surface. Our method not only yields an e cient computational approach for determ ining the tem perature it also provides an intrinsic link between dynam ical systems theory and the statistical mechanics of H am iltonian systems.

Two crucial assumptions allow one to pass from the dynam icalto the therm odynam ical description of a classical Hamiltonian system . First, the system should exhibit som e sort of ergodicity so that tim e-averages can be replaced with equivalent space-averages over the microcanonical ensemble, i.e. over the corresponding energy surface (possibly with other constraints) and with respect to the invariant Liouville measure. Second, it should make sense to consider a large number of (weakly) coupled sub-system s and look at the statistical behavior of an individual xed sub-system . A sthe size of the am bient system tends to in nity one obtains the therm odynam ic lim it in which the micro-canonical ensemble involving the sub-system is assumed to behave like the canonical or the G ibbs ensemble where quantities like temperature and pressure become operationally de ned. In a few special cases it has been possible to prove the equivalence of the two ensembles but it is believed that under quite general assum ptions the two ensem bles indeed give equivalent descriptions when system s are large. W e refer to R uelle [4] for a more complete treatment on the equivalence of ensem bles, to Lebow itz et al. [3] for an illustrative exam ple of som e di erences between the ensem bles and to Landau and Lifshitz [2] for a general introduction to the subject. For practical calculations using the m icro canonical ensem ble see e.g. Evans and Morriss [1].

In the therm odynam ic description the temperature plays a prominent role and the problem of measuring it using the dynam ical evolution of the system dates back to the early days of therm odynam ics. A lready M axwell realized that when the Ham iltonian has the special form H (p;q;:::) = $p^2=2 + K$ (q;), thus singling out the square of a momenta, the canonical ensemble average of p^2 happens to be the temperature. Thus assuming equivalence of ensembles and ergodicity it suces to measure the time-average of p^2 during the dynam ical evolution in order to get the temperature.

Here we shall pursue a di erent approach in which we focus on the global geom etric structure of the energy surface W e shall assume ergodicity only and show that the tem perature as de ned in the micro-canonical ensemble M

can be obtained as a purely dynam ical tim e-average of a function which is related to the curvatures of the energy surface.

In this presentation we shall for clarity and without loss of generality restrict ourselves to a Euclidean phase space, = R^{2d} (d 1), and a Ham iltonian function, H : ! R, which preserves the Liouville measure (here Lebesgue measure m) and such that for all energies considered the set H () E is bounded and has a sm ooth and connected surface, A (E) = fH () = E g. Furtherm ore, we shall consider the case when the energy itself, H = E, is the only preserved rst integral. We refer to [5] for a generalization of this approach.

For the m icro-canonical ensemble of classical therm odynam ics one de nes the exponential of the entropy to be the (canonically invariant) weighted area of an energy surface :

and the tem perature is obtained through di erentiation

In practise a calculation of the entropy function is in possible when the number of degrees of freedom in the system is large. How ever, we have the following :

Theorem : Suppose that (;H) is ergodic with respect to the Liouville measure $m_{jA(E)}$, restricted to a non-singular energy surface, A (E). Then for $m_{jA(E)}$ -almost every x (0) 2 A (E), one has

The Euclidean m etric is not necessary but provides a convenient way of expressing the dynam ical average in terms of gradients of functions and divergences of vector elds.

where x () is the trajectory of x (0) under the H am iltonian ow and the observable equals r (r H = kr H k^2), which can also be written as :

Remarks:

- The measure and the energy are canonical invariants. Hence, from equations (1) and (2), so are the tem perature and the tim e-average, equation (3), of but not itself. The theorem shows also that the tem perature unlike the entropy is an intrinsic dynamical feature of the system (it can be computed as a dynamical average).
- The theorem can quite easily, at the cost of making the notation more heavy, be generalized to arbitrary sym plectic manifolds without a Riemannian structure (cf. [5]).
- 3. It is of interest to see how the conjugated them odynamic variables of other preserved rst-integrals (e.g. total angular m om entum) can be incorporated in the above dynamical form alism. It is for example well-known that the pressure can be obtained as a time-average of the m om entum transfer per surface area element in the con guration space. It is also of interest to derive general (therm o-)dynamical relations for such quantities in the micro canonical ensem ble (cf. [5]).
- 4. There is a form al resemblance of to the G auss curvature 1=R = r (r H =kr H k), where for the latter quantity the norm of the gradient is not squared. In particular, when the number of degrees of freedom gets large (and the last term in the form ula (4) becomes relatively small) the relationship becomes closer. We do not know of any deeper reasons for this connection.

The idea behind the above Theorem is to cast the energy dependence of the geom etry, i.e. the dependence on A (E) in equations (1) and (2), into an algebraic dependence for a xed geom etry. This is achieved through the introduction of an auxiliary vector eld (to a large extend arbitrary) and it will enable us to take the derivative with respect to the energy inside the integral.

We consider in the following two vector elds on :

Here J is a symplectic matrix, e.g. $\begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}$, and h; i is the usual Euclidean product in . For a vector eld X on we let g_x^t denote the associated ow. Thus g_y^t

is the Ham iltonian ow and g^s is the normalized energy gradient ow. Since $\frac{d}{ds}H(g^s(x)) = hr H(x)$; (x)i = 1 we have

A sum ing that no singular points are encountered along the gradient ow, i.e. that $r H \in 0$ everywhere on the energy surface (which is a generic condition), the map

is a dieomorphism between energy surfaces.

B oth the Liouville m easure m and the energy are preserved under the Hamiltonian ow, i.e. $m(g_v^t dx) = m(dx)$ and $H(g_v^t(x)) = H(x)$. It follows that by considering an in nitesim allow-box (under the energy gradient ow) $g^{[0;]} dA$ and by m easuring the volume of such a ow-box we may de neam easure on the energy surface A (E) which is also invariant under g_v^t ,

For this measure, we have $e^{S(E)} = \frac{R}{A(E)}$ (dA). The ow g^{s} commutes with itself and hence it maps the ow-box $g^{[0;]}$ dA (E) into the ow-box $g^{[0;]}$ dA (E + s) (by equation 7). But then the ratios between the weighted areas of innitesimal surface elements just becomes a ratio between volume elements which is nothing but the Jacobian of the mapping:

(to order s). De ning = r (i.e. our equation 4) we get the relation :

and nally, using the de nition of temperature (2) we obtain :

$$\frac{1}{T(E)} = \frac{A(E)}{A(E)} (dA)$$

The interesting observation is now that if the H am iltonian ow is ergodic with respect to the Liouville measure restricted to the energy surface, , then by Birkho's theorem the right hand side equals the time-average (and thus equation 3) of for -almost every (equivalent to m $_{jA}$ (E)-a.e.) trajectory under the H am iltonian ow, thus proving our theorem .

An illustrative, though trivial, example is given if we take N harmonic oscillators with the Hamiltonian $H = \prod_{i=1}^{N} \frac{1}{2} (q_i^2 + p_i^2)$. Its gradient r H = (q;p) is non-vanishing at all non-zero energies and a straight forward calculation yields = (N - 1)=E = 1=T (E). In this particular case we can directly read o the micro-canonical result, E = (N - 1)T. The xation of the energy 'freezes' one degree of freedom as is seen by comparing with the canonical result, E = N T.

In conclusion we have described a dynamical way of measuring the temperature in the micro canonical ensemble of therm odynamics. It is rigorously shown to work for a H am iltonian system at energies where the energy surface is regular and the ow is ergodic. The approach is purely dynam ical and involves calculating the tim e-average of the functional, r $(r H = kr H \tilde{k})$, on the energy surface. As the derivation shows the dynam ical tem perature is really intrinsic to the dynam ical system in contrast to the entropy itself. W e note that in a classical theory the entropy is in any case only de ned up to a constant. W e believe that the results and the underlying ideas presented here may be of practical in portance in num erical simulations and helpful to physicists who wish to understand the foundations of classical therm odynam ics.
