Inverse versus direct cascades in turbulent advection

A model of scalar turbulent advection in compressible ow is analytically investigated. It is shown that, depending on the dimensionality d of space and the degree of compressibility of the smooth advecting velocity eld, the cascade of the scalar is direct or inverse. If d > 4, the cascade is always direct. For small enough degree of compressibility, the cascade is direct again. O therwise it is inverse, i.e. very large scales are excited. The dynamical hint for the direction of the cascade is the sign of the Lyapunov exponent for particles separation. Positive Lyapunov exponents are associated to direct cascade and G aussianity at small scales. Negative Lyapunov exponents lead to inverse cascade, G aussianity at large scales and strong intermittency at small scales.

The keystone of the celebrated 1941 Kolm ogorov-O bukhov [1,2] theory for 3D fully developed turbulence is the direct (downscales) energy cascade. M any other examples of direct cascades have later been found for turbulent systems (see [3,4] for a review). The presence of a direct cascade expresses the fact the average ux of an integral of motion, which holds for the system in the absence of forcing and dissipation (e.g. energy for 3D Navier-Stokes turbulence and many examples of wave turbulence, vorticity for 2D Navier-Stokes turbulence, etc.), is directed toward sm all scales and is constant along the scales. The variety of turbulent system s is not exhausted by direct cascades. W hen the pum ping is supplied, the ux of an integral of motion can go toward large, and not sm all, scales. This is the case of 2D turbulence, where the dynam ical constraints due to the presence of two integrals of motion lead to the rem arkable phenom enon of the inverse energy cascade discovered by R.H.Kraichnan in [5]. O therexamples of inverse cascade are known in wave turbulence [3].

A dvection of a passive scalar (t;r) (it m ight be the concentration of a pollutant or temperature) by a turbulent incompressible ow belongs to the class of direct cascades [6]. The direct cascade survives if the N avier-Stokes turbulent velocity is replaced by a synthetic eld with prescribed statistical properties [7,8] (this m odel, introduced by K raichnan in [8], is attracting a great deal of attention for the anom alous scaling discovered there [9,10,11]). A one dimensional compressible generalization of the K raichnan m odel was recently introduced in [12]. We have considered the smooth lim it of the model in [13] and shown that an inverse cascade takes place. This has led us to investigate the general relation between compressibility and the direction of the cascade. The aim of this letter is to present and analyze a model where we can continuously move from inverse to direct cascade by varying two parameters: the dimensionality of space d and the degree of compressibility.

The dynam ical equation is

for the Lagrangian tracer scalar eld (t;r) (say temperature or entropy), steadily supplied by the random G aussian source and advected by the compressible d-dimensional G aussian random velocity u(t;r), having zero average. The correlation of the pumping is $h(t_1;r_1)(t_2;r_2i=(r_1 \ r_2)(t_1 \ t_2), with (r)$ regular at the origin and decaying fast at distances larger than the integral scale L. The molecular di usivity is supposed small enough to be in the fully turbulent regime, i.e. L is much larger than the dissipative scale. The pair correlation function of the velocity uctuations, h u (t;r) u $(t^0;r)i$, is

where $C^2 = h(r \ u)^2 i$, $S^2 = h(r \ u)^2 i$ and $u \ (t;r) = u \ (t;r) u \ (t;0)$.

W e show for the model that : the cascade of the scalar is inverse if d < 4 and the degree of compressibility $C^{2}=S^{2} > d=4$; otherwise it is direct. The dimension d = 4 turns then out to be critical for the direction of the cascade. W hen the cascade is inverse and no infrared cuto s are present, the energy is clearly piled up at the large scales and moments of the scalar eld diverge linearly with time. Correlations of scalar di erences will how ever reach stationary values. The PDF at the steady state of scalar di erences is found explicitly in the convective interval, i.e. at scales much larger than the di usive one, both for direct and inverse cascades. The Gaussianity of the scalar distribution, known to be present at sm all scales in the incompressible case [14], emerges at large scales when the cascade is inverse. Sm all scales are then shown to be strongly interm ittent.

Before the system atic analysis, it is worth presenting rst som e sim ple intuitive argum ents. Since the scalar is a tracer, its statistics is very directly related to the one of the Lagrangian trajectories separation and, speci cally for sm ooth velocities, of Lyapunov exponents, describing the rate of the exponential-in-time stretching (or contraction) of the separation. We shall derive below the following relation between the sign of the maximum Lyapunov exponent and the direction of the cascade: is positive in the case of direct cascade and negative in the case of inverse cascade. Its physical origin is simple to explain. Indeed, once the statistics of the scalar eld is expressed in terms of Lagrangian paths properties, the crucial question becomes: given two particles initially separated by r, what is the probability that their distance will ever reach the typical scale of the pumping L ? If the Lyapunov exponent is positive, separations will typically grow exponentially in time. Starting from L, the scale of the pum ping is alm ost a separation r certainly reached; viceversa, ifr L, there is practically no chance to reach L. This is the dynam ical hint of the direct cascade. Consider now a negative Lyapunov exponent. The picture is completely reversed. Since typical trajectories are contracting, the probability to reach L is much higher at scales r L than r L. The characteristic sign of the inverse cascade is em erging here. Furtherm ore, the described physics of the relation between the stretching-contraction interplay does have a certain generality. For incompressible ow, the strain tensor being traceless, no strong trapping phenom ena are possible and the rate of typical separations grow th is expected to be positive. Strong trapping appear for compressible ow, where it can lead to a substantial slow -down of transport (see [15]) and, possibly, to a negative rate of the Lagrangian separations stretching. Finally, the importance of traps for transport should de nitely reduce when the dim ensionality of space increases.

Let us now start the system atic analysis of the model by considering Lagrangian separations statistics. The stochastic di erential equation governing the evolution of the separation R (t) between two Lagrangian particles, in the absence of molecular di usion, is $Q_t R$ = R . The statistics of the random strain is Gaussian. Its irreducible correlation function hh (t) (t⁰)ii is simply obtained operating with $r_r r_r = 2$ on (2). The $\frac{1}{2d}$ C² average h i = is xed by the condition hR (t) i = R (0), which is an immediate consequence of isotropy (see [13] for more details). It is worth noting that the average of vanishes for incom pressible ow. The 2n-th m om ent of R (t) obeys the following di erential equation

corresponding to the following G aussian statistics of the exponential stretching rate $\ln \mathbb{R}(t) = \mathbb{R}(0) = t$:

The largest Lyapunov exponent (generally there are d of them) has been denoted by $\overline{}$ and $\overline{}$ is the variance of \cdot . For incompressible velocity elds, $C^2 = 0$ and the Lyapunov exponent is always positive. The opposite lim it is the one of gradient-type velocity elds u = r , where the equality $C^2 = S^2 = h()^2$ i holds. The interesting conclusion arising from (4) is that d = 4 is actually a critical dimension for gradient-type elds. For generic smooth ow, the largest Lyapunov exponent is always positive for d > 4 and its precise behavior (including the value of the possible critical dimension $d_c = 4C^2 = S^2$) depends on the specic value of the degree of com pressibility $C^2=S^2$. It follows from (4) that, if the Lyapunov exponent is negative, the low -order m om ents of the Lagrangian separation decay in time, but their high-order (e.g. integer moments) grow exponentially. As rst highlighted in [16], this means that the dynam ics of Lagrangian separations is dom inated by rare events and this is the origin of the strong interm ittency of the scalar at sm all scales which will be evidenced below.

We proceed now with the derivation of the scalar statistics. The relation between Lagrangian trajectories and the passive scalar eld in (1) is very direct. The solution of the equation can indeed be presented as

 $(t;r) = \bigwedge_{1}^{R} dt^{0} (t^{0}; (t^{0})), \text{ where the Lagrangian trajectory (t) satisfies _(t^{0}) = u (t^{0}; (t^{0})) and (t) = r . For the sake of simplicity of the presentation, we have not taken into account molecular di usion (see, for example, [13] for the detailed path integral form ulation including di usion). Its smearing e ects on Lagrangian trajectories can be neglected in the analysis presented in the sequel. The simultaneous 2n-th order scalar correlation function can be rewritten in terms of the average over 2n Lagrangian trajectories as$

where the sum is over all the possible permutations $fi_1; ...; i_n; j_1; ...; j_n g$ of the indices f1; ...; 2ng. The Lagrangian separation R_{ij}(t) satis es the Langevin equation associated with (3) and the two Lagrangian particles are initially located at r_i and r_j , respectively. T stands for the time of evolution and should tend to innity for the system to attain the stationary state. The statistics of the whole set of d Lyapunov exponents is required to reconstruct the Lagrangian dynam ics of a general d dimensional structure. However, to analyze the

structure functions of the scalar (or multi-points correlation functions where all the points are elongated on a straight line), we do not need to go into the heavy details of subleading Lyapunov hierarchy. The point is that, modulo the dissipation that will be discussed later on, the collinear geom etry is preserved by the dynam ics [11,17]. This issue actually deserves som e m ore detailed explanation. For the incompressible case, it has been found that the transition from collinear to slightly o collinear con qurations is not smooth [17]. This im plies, in particular, that the subleading Lyapunov exponents statistics is needed to describe the correct rate of exponential decay for the far tails of the scalar PDF [18]. Being aware of this important e ect, in the present letter we focus on the quantities that can be analyzed by collinear considerations. The study of the o -collinear e ects is reserved for future publications. Here, we shall therefore consider only collinear geometry $r_i = nx_i$, with all the distances large enough for dissipative e ects to be negligible. The 2n-order structure function $S_{2n}(x)$ can be easily reconstructed from the 2n-th order correlation function h! $(T; r_1)$!2(I) irof the scalar gradient ! (t;r_i) $(\mathbf{t}; \mathbf{r}_i)$; in the collinear geometry. This is simply done integrating all the coordinates x_i from 0 to x and the nalresult for $S_{2n} = h(x)$ (0)²ⁿ i is

where the averaging with respect to is xed by (4). The regularity of the pumping (x) at the origin has been exploited in (6) and the integrations over the x_i 's have been cut from below by the di usive scale $r_d =$ We will indeed see that in those cases when the cuto is in portant, the resulting dependence on r_d is logarithm ic, thus justifying the used regularization. The generating function Z (r=L;q) (Fourier transform of the respective PDF) of scalar di erences is simply restored from (6) in the form of a matrix element over an auxiliary quantum mechanics (see [13] for more details) with the Hamilto $n ian_{h} \hat{H} = \frac{2}{2} e^{2} + q^{2} [e = Pe]$ (er=L)]. Indeed, $Z = e^{T^{-2} = (2^{4})}$ (T;) , where the wave function = 0 b i h satis es the Schrodinger equation $\ \ensuremath{\mathbb{Q}}_{\mathbb{T}}$ + H $\$ = 0, w ith

the initial condition $(0;) = e^{-2}$. The asymmetry between negative and positive clearly emerges in the di erent asymptotic behaviors of . For negative , the nonvanishing at ! 1 initial condition exp[-2]will survive in the stationary (T ! 1) limit, since the potential part of the H amiltonian (q^2) is also vanishing at ! 1. A nalogous consideration of the positive case, xes the same boundary condition for , but in the opposite limit ! +1 (worth mentioning that a nite di usivity is needed for this). We thus arrive at the Fokker-P lanck equation

Here, should be considered as a y-independent param – eter to be replaced by $r_d=r$ after integration of (7).

Note that the Fokker-P lanck equation (7) is the same as the one found directly from (1), taking two replicas, averaging with the appropriate weight and discarding the contribution of the molecular diusivity term . If the latter term is kept, the so-called anomaly term appears (following the eld-theoretical term inology introduced by A. Polyakov in [19]) and the equation is not closed. In turbulent system s, it is generally expected that the anom aly term, accounting for the e ects of m olecular di usion onto the convective interval range (for a discussion of the Polyakov theory in the context of the present passive scalar model, see [20]), does not vanish in the zero di usivity lim it. The absence of the anom aly term is therefore neither a trivial nor a general fact. Deriving (7) dynam ically within a multi-points approach with an accurate fusion of points, we thus proved the absence of anomaly in the present model.

Let us nally show how to get from (7) and (8) or (9) the scalar di erences PDF, with a special accent on the issue of universality. The PDF is indeed not globally universal, in the sense that it will generally depend on the explicit form of the pumping function (x). A relevant question to ask is then : what is universal in the PDF? There are two di erent universality issues which m ay be discussed in this respect. A kind of universality, typical of the case of positive Lyapunov exponents both at large and sm all scales, suggests that the only relevant param – eter is the ux of 2 ((0)) pumped into the system at the integral scale [14]. Indeed, at > 0 the asymptotic solution of (7) can be found replacing (0) (x=L) by

(0). Using (9) and the fact that is the smallest value in the problem, one gets an algebraic form for the generating function $Z = (r_d = m \inf r; Lg)^a$, with the exponent $a = \frac{1}{2} = \frac{4}{2} + 2q^2$ [D]= $2 = \frac{2}{2}$. Calculating the Fourier integral for the PDF in the saddle-point manner (the large parameter is $r=r_d$), one gets the Gaussian behavior at j rj ln [k]

where x m infr; Lg= r_{d} . For very large values j $_{r}$ j ln [x], the Gaussian behavior transform s into an exponential tail [14,21]. The detailed form of the tail requires

however the know ledge of the whole hierarchy of Lyapunov exponents and cannot be calculated within the collinear approach used in the present letter [18] at d > 2. The unknown exponential tail does not a ect the behavior of the structure functions of order n ln [x], that are equalto $(2n \quad 1)! \ln 2^n \ln^n [x]^n [0] =$. This kind of universality (and the corresponding restrictions on collinear considerations) can be easily extended to the case of negative Lyapunov exponents for r L. To this aim, we replace again (0) (x=L) by (0) in (7), impose the boundary condition (8) and perform the saddle point integral, as it han been discussed above. We arrive nally at the expressions for the PDF and the structure functions (valid for r L and negative), which are identicalto (10) with the replacements of minfr; Lg= r_d by r=L and by jj.

For negative , another kind of universal behavior is found at scall scales r L. In the vicinity of the origin, the PDF depends only on the second derivative of the pumping $^{(0)}(0)$. This part of the PDF is indeed form ed at the largest q 1, where one can keep only the rst term of the expansion of (x=L) in the \potential" of (7). We arrive then at the following expression for the PDF at j_rj 1 and r L

c = [1=2 - 2] = ([-2] - 2]. The expression (11) shows that all the structure functions S_n (r) of low orders $1 < n < \overline{2} =^2$, are controlled by (11) and rⁿ. The behavior of the PDF at valscale normally ues larger than those where (11) holds, is not universal, i.e. it depends on the whole form of (x=L). For very large values r 1 and at sm all scales r L, it is however possible to show, from the expression of (7, 8) at q < 1 and y = 1, that the far tail is exponential, P $[r=L]^{2} = \exp(\frac{p}{j_r + j_r})$. The nonnential, P universality em erges via the dim ensional constant , that depends on the precise shape of the source function (for detailed explanations on the asym ptotics, see [13], where the tail was fully determ ined in the one dimensional case for a specic form of the pumping). The form of the tail, along with (11), shows that the structure functions of order larger than 2 = 2 all scale in the same way $(r=L)^{2} = {}^{2} at r$ L. This collapse of the S_{2n} (r) high-order structure functions scaling exponents should be contrasted with the G aussian norm alscaling observed for the direct cascade. These di erent scalings are an illustration of the profoundly di erent behaviors that have been found for the model below and above its threshold of compressibility where the direction of the cascade is reversed.
