Lasing Threshold and Mode Competition in Chaotic Cavities

The lasing threshold is studied of a multim ode chaotic cavity (linear size D wavelength) coupled to the outside through a small hole (linear size d). For su ciently weak absorption by the boundaries, the statistical distribution of the threshold is wide, its mean value being much less than the pumping rate needed to compensate the average loss. The average number $hN_{\,\mathrm{nc}}i$ 1 of non-competing excited modes is proportional to the square root of the pumping rate. We use the classical model of spatial hole burning to account for mode competition and nd a reduction in the average number of excited modes to hN i = $3^{1-3}hN_{\,\mathrm{nc}}i^{2-3}$.

I. IN TRODUCTION

Incorporation of quantum opticale ects is a necessary and interesting extension of active ongoing research on multiple scattering of electrom agnetic waves in random media [1]. It becomes particularly important when the m edium is active, as is the case in experim entally realized \random lasers" [2{4]. Quantum e ects have been largely ignored in many publications devoted to propagation in disordered amplifying waveguides [5{8], in which only am pli ed stimulated em ission of external incom ing ux but not of spontaneously em itted internal noise was taken into account (Ref. [9] being a notable exception). Am plied internal noise can lead to excitation of low-threshold lasing modes of the waveguide, making practical use of am plifying waveguides problem atic. The diculty of the waveguide geometry is the onset of localization. In this paper we consider a simpler cavity geometry, which does not show localization, but retains two essential features of the problem: large sam ple-to-sam ple uctuations and spontaneous em ission.

A complete description of the uctuations is possible in the universal regime characterized by a chaotic pattern of classical trajectories. We assume that the cavity (volume V' D³) is conned by conducting walls, lled with a lasing medium (central frequency of the gain prole $!_0$), and coupled to external detectors via one or several small holes. It was demonstrated recently that a nonintegrable shape of the resonator can signicantly a ectits lasing properties [10]. Chaoticity of classical trajectories can be achieved either by a peculiar shape of the resonator [11{13}], or by a small amount of disorder scattering. We will speak about \chaotic cavities," meaning any of the two mechanisms responsible for the onset of chaos.

We restrict ourselves to the case of well-resolved cavity modes, which means that 1) resistive loss in the cavity walls is less than the mean modal spacing

so that $_0$ = $_0$ ' (d= $_0$)6 1. Note that the loss (1) is not proportional to the area of the hole. It is in fact much smaller than one might guess by extrapolating the dependence $_0$ ' cd^2 =V valid for d $_0$. The elect of sample-to-sample uctuations is pronounced only if $_0$. This regime is experimentally accessible, as was demonstrated by a recent series of experiments on microwave cavities with superconducting N iobium walls [12,13].

Each act of spontaneous emission in a pumped cavity is a source of radiation into some cavity mode. Classical condition of the lasing threshold in a given cavity mode is satis ed if the gain due to stimulated em ission equals the loss. Threshold for the cavity is the smallest value of the pum ping rate at which threshold is attained for one of the modes. The questions we ask are: What is the threshold rate of pum ping? How many lasing modes can coexist for a given pumping rate above the threshold? The problem of spectral content of outgoing radiation has been widely studied for integrable cavities of de nite shape. Considering arrays of chaotic cavities of slightly varying shape or with dierent con gurations of scatterers we address the problem statistically and compute the probability of lasing, the distribution of the threshold, and the average num ber of excited modes.

Trivially, gain greater than mean loss $_{0}$ will be on the average su cient to ensure lasing, while gain smaller than will never suce. The mean loss from a tiny hole is small. We argue that the actual average threshold can still be many orders of magnitude smaller. Each individual cavity exhibits a well-de ned threshold but its statistical distribution is wide. In Section II we compute

this distribution for the idealized case = 0. E ects of non-zero resistivity of the walls are discussed in Section III. Section IV is devoted to the computation of the average number of excited modes above the threshold. We conclude in Section V.

II.D ISTR IBUTION OF LASING THRESHOLD

We assume that the line of spontaneous emission is homogeneously broadened and has Lorentzian shape with central frequency $!_0$ and width 2. Let $_i$ (r) be the amplitude of a mode of the closed cavity at frequency $!_i$, normalized according to dr_i^2 (r) = V. (For simplicity we neglect polarization dependent phenomena and work with real scalar eld amplitudes.) In the presence of weak coupling to the outside world the modes acquire nite widths, $_i$. We assume two sets of conditions:

An especially important role is played by the inequality $_0$!0, which is implied by d $_0$. It ensures that the modes of the open cavity are well-de ned and do not dier signicantly from those of the closed one. In this Section we consider the idealized case in which there is no loss in the walls of the cavity (=0).

In a chaotic cavity the modes $_{i}$ (r) can be modeled as random superpositions of plane waves [15]. (Validity of thism odelhas been checked experimentally in microwave cavities [12,16].) This implies a Gaussian distribution for $_{i}$ (r) at any point r. The corresponding distribution for $_{i}^{2}$ (r) is called the Porter-Thomas distribution [17]. Loss from a small hole located at r is proportional to $[r_{n-i}(r)]^2$ (with $r_{n-i}(r)$) the derivative in the direction normal to the surface of the hole) and has the same Porter-Thomas distribution, which was directly probed in the experiments of Ref. [12]. More generally, the distribution of normalized modal widths $y = _{i} = _{0}$ in a cavity with holes is given by the 2 -distribution with degrees of freedom (normalized to 1),

We assumed that loss from dierent holes is independent, which is true provided their separation is larger than $_0$. For small integer , the distribution (3) is wide. The single-hole case = 1 looks especially promising from the point of view of low-threshold lasing because $P_1(y) = \exp(-y=2)^{\frac{1}{2}} \frac{1}{2} \frac{1}{y}$ grows with decreasing y.

To grasp the picture we rst con ne ourselves to a subset of cavity m odes located near ! $_0$. We neglect uctuations of their frequencies and assume that the m odes are equidistant, ! $_m$ = ! $_0$ + ! $_0$ m , m = 0; 1; 2;::: We denote by R $_{p_0}$ a reference pumping rate necessary to provide gain equal to the mean loss $_0$ at frequency ! $_0$,

and introduce the reduced pumping rate " = $R_p = R_{p_0}$, assumed 1. Loss of dierent modes is uncorrelated and distributed according to Eq. (3) while gain diminishes with increasing dierence j! !0 jaccording to the Lorentzian

It follows that the probability p (") of there being no lasing mode at the pumping rate " is given by

For " 1, the upper lim it of the integral is also 1, and we can replace P (y) by its leading behavior at small y, P (y) / y $^{1+}$ $^{-2}$, which yields

Because the sum m and decays as m we nd that for > 1 the leading behavior of the probability of no-lasing is determined by the modes with $jn j^{<} = !_0$,

Here $\mathcal{C} = {}^{\mathbf{p}} - {}_{\mathbf{C}}$ ((1)=2)= (=2) for > 1 (below we will separately de ne \mathcal{C}_1). Modes far from $!_0$ have negligible chance to get excited and need not be taken into account. On the contrary, for = 1 all cavity modes, including those very far from $!_0$, contribute to the probability.

To treat the contribution of distant modes for = 1 correctly, we must account for several factors which we could ignore for > 1. 1) The spectral density cannot be replaced by its value $_0 = 1 = !_0$ at $! = !_0$. Instead $(!) = _0!^2 = !_0^2$. 2) The mean loss is frequency dependent, $(!) = _0!^4 = !_0^4$, cf. Eq. (1). 3) The Lorentzian (4) for the amplication rate is an approximation valid only in the vicinity of $!_0$. A correct expression for the gain g(!) must be even in ! to comply with the symmetry (!) = (!) of the dielectric susceptibility . It includes contributions of both poles $!_0 + i$ and reads

Taking these three factors into account and replacing the discrete sum by an integral, the probability of nolasing is given by

For > 1 this leads to Eq. (8), the ultraviolet cuto $!_{m \text{ ax}}$ being irrelevant. For = 1 we get




FIG. 1. Probability of lasing 1 p (") versus reduced pumping rate " with p_1 (") given by Eq. (11) (! $_0$ = = 10, = ! $_0$ = 10). Thick lines are for di erent ratios D =d corresponding to di erent numbers M ' (D =d) 3 of relevant cavity modes (dot-dashed line M = 10^2 , dashed line M = 10^3 , solid line M = 10^4). Left inset shows an example of chaotic cavity. Chaotic behavior of classical trajectories in this particular \die" shaped cavity was shown in Ref. [11]. Radiation is conned inside by means of ideally conducting walls and can leave the cavity only through a tiny hole. Right inset shows the probability distribution of the lasing threshold T (x) = $(=2)x^{1+}$ = $(=2)x^{2}$, with x related to "by x = "(C" = $(=2)x^{2}$), for different number of holes = $(=2)x^{2}$.

where $\operatorname{erf}(z) = (2^{-1})_{0}^{R_{z}} \operatorname{dx} \exp(x^{2})$ is the error function. The main logarithm ic contribution of type d!=! to the integral in Eq. (11) comes from large values of!. The ultraviolet cuto $!_{max}$ ' 2 c=d appears because loss ofhigh frequency modes with < dno longer exhibits the strong uctuations of Eq. (3). Beyond the cuto classical ray optics applies, leading to a narrow ly peaked distribution of the loss around the value $cd^2=V$ we are considering the case " 1 in which the gain is much smaller than the average loss o, the high frequency modes cannot be excited. It follows that the only relevant cavity modes are those with frequencies smaller than $!_{max}$. Their num ber M $!_{m,ax}^3 = 3!_0^2 !_0 ' (D = d)^3$ is 1. From Eq. (11) the probability of no-lasing p_1 (") can be cast in the form of Eq. (8) with the coe cient $C_1 = (8=)^{1=2} \ln (!_{max}=)$ weakly dependent on the frequency cuto $!_{max}$. Fig. 1 shows that the probability of lasing 1 p (") can be reasonably large even for extrem ely sm all values of the reduced pum ping rate ".

The quantity 1 $\,$ p (") is the fraction of lasing cavities in an array at a given pumping rate ". It is directly related to the probability distribution T (") of the lasing threshold. O by iously $_0^{\rm u}$ d"0T ("0) = 1 $_{\rm p}$ ("), hence T (") = dp (")=d". We not from Eq. (8) that

(Deviations which arise at " > 1 are unimportant.) The distribution is wide and in the single-hole case = 1 diverges as "! +0 (see right inset of Fig. 1). The average reduced threshold reads h" i = (1 + 2 =) (" = !0) 2 : It is smallest for = 1 and is indeed much smaller than 1.

III. EFFECTS OF NON-ZERO W ALL RESISTIVITY

A non-zero loss from the resistivity of the cavity walls modi es the functions (10{12}) by suppressing lasing for " < $= _0$. The distribution of the lasing threshold remains wide, as long as $= _0$ 1, as we now show. Instead of Eq. (10) we have

where ! < ! + are the two positive frequencies such that g(!) = .A non-zero value of reduces the relevant frequency range to a narrow window around ! 0. Therefore, the modi cations 1)-3) of the previous Section become unnecessary even for the case = 1. U sing the simple Lorentzian (4) for g(!), instead of the more complicated expression (9), we not ! = ! 0 (" 0 = 1) 1-2. Neglecting the !-dependence of (!), (!) and using the small-argument behavior of the probability function P (y), we reduce Eq. (13) to




FIG. 2. Probability distribution of the lasing threshold in a cavity with small absorption in the boundary and a single hole (= 1), computed as dp(")=d" from Eq. (14). We chose = ! $_0$ = 10 and took three values of = $_0$ such that = $_0$ is much smaller, equal, or much greater than (! $_0$ =) 2 = = 10 2 .

can be expressed in terms of a hypergeom etric function. In Fig. 2 we have plotted the distribution of the lasing threshold, T (") = dp (")=d", for = 1 and di erent values of = 0. We will analyze two limiting regimes.

In the regime " $_0$ = 1 and for > 1 we recover the expression (12) with the same constant C°. The value of C′ $_1$ = C $_1$ ln (" $_0$ =) is different because of the different cuto mechanism. Instead of having a weak logarithm is dependence on ! $_{\rm max}$ it exhibits a weak logarithm is dependence on the pumping rate ". This limiting case is statistically dominant if = $_0$ (! $_0$ =) 2 , because then the corrections to Eq. (12) at " < = $_0$ have negligible statistical weight.

In the opposite regim e, " $_0$ = 1 1, the threshold distribution di ers signi cantly from Eq. (12),

nant if = 0 ($!_0 =)^{2} = 0$. The m ean value of threshold is now close to = 0, but there are large uctuations towards larger ".

IV.AVERAGE NUMBER OF EXCITED MODES

In this Section we focus on the number of lasing modes beyond the lasing threshold for =1 assuming =0. We assume that the parameters are such that many modes are above the threshold. This requires, in particular, " $_0\!=\!1$. In this case a non-zero value of only leads to a rede nition of \mathcal{C}_1 because of the dierent cuto mechanism. If the modes did not compete we could compute the average number of excited modes hN $_{\text{nc}}$ i as

For " < 1 it is given by hN $_{\rm n\,c}$ i = C_1 (= $!_0$)"¹⁻². However, the modes do compete for a homogeneously broadened line because one of the modes can deplete the inversion, preventing anothermode from being excited [18]. Multimode operation is still possible if dierent excited modes deplete the inversion in dierent spatial regions of the cavity [19,20]. We assume this mechanism of multimode generation, called spatial hole burning [21].

Let n_i , N (r) denote the number of photons in the mode i and the density of population inversion between the lasing levels. Sem iclassical rate equations read

Here w is the non-radiative decay rate and W $_{\rm i}$ is the rate of stimulated em ission into mode i. The constant W $_{\rm i}$ is related to the gain (9) in the corresponding mode, W $_{\rm i}=$ w g (! $_{\rm i})=$ "R $_{\rm p_0}$.

We restrict ourselves to a steady state solution. E \lim inating the equilibrium population inversion density N (r), we get the following set of equations for the equilibrium mode populations n_i ,

Vanishing n_i 's correspond to non-excited modes. Let there be N excited modes, $i_1; i_2; \ldots i_N$. We assume that we are not far beyond threshold, so that w $_j$ W $_j$ n $_j$ $_j^2$ (r), and we may expand the denominator in Eq. (20). We arrive at the following system of linear equations (k = 1;:::N)

They are self-averaging quantities with negligibly small uctuations around their mean hA $_{i_k\,i_l}\,i=1+2$ $_{i_k\,i_l}$, which follows from the independent G aussian distributions for $_i$ (r) [22]. Because the correlations between A $_{i_k\,i_l}$'s and $_{i_s}$'s are also negligibly small, we may substitute A $_{i_k\,i_l}=1+2$ $_{i_k\,i_l}$ in Eq. (21). Without loss of generality we can assume that $_{i_l}=g(!)$ $_{i_l}=g(!)$

The number of excited modes N $\,$ is restricted by the requirement that all $n_{\,i_k}$'s should be positive. A necessary and su cient condition is

Eq. (24) can be used to determ ine the probability distribution of the number of excited modes, using the Porter-Thom as distribution (3) for the statistics of decay rates $_{\rm i}$. In the region of parameters where hN i 1 this mean value can be found analytically from the continuous approximation of the condition (24),

The general form of this result for any can be derived in a similar way, leading to $hN_{nc}i = C' (= !_0)^{n-2}$,




FIG. 3. A verage num ber of excited m odes hN i versus dim ensionless pumping rate " (sam e param eters as in Fig. 1). The solid lines are the analytical result (27), the data points are a M onte C arlo average. The main plot corresponds to = 1, M = 10^2 (circles), M = 10^3 (squares), M = 10^4 (diam onds). D ashed lines represent the average number hN $_{\rm nc}$ i of non-competing modes. The inset shows the case = 2 for M 1. Note a drastic reduction in the number of excited modes.

To test num erically the analytical results for hN i, we did a M onte C arb average over the P orter-T hom as distribution. For each of 2000 realizations, we ordered the m odes in increasing order of the ratio loss over gain and found m axim alN satisfying Eq. (24). Results for hN (") i are in excellent agreement with the continuous approximation down to hN i 1 (Fig. 3).

V.CONCLUSION

To sum marize, we have considered lasing of a chaotic cavity coupled to the outside world via smallholes. We assumed that the broadening of the cavity modes (due to leakage through the holes and absorption by the cavity walls) is less than their spacing and used a simple criterion \modal gain modal loss" as the condition for a given mode to be excited. Natural unit of the pumping rate R_{p_0} is dened such that \maximalgain = mean loss." Because of strong uctuations of modal widths, the probability of lasing can be signicantly large for much weaker pumping rates than R_{p_0} . The distribution of the lasing threshold turns out to be wide, with the mean much less than R_{p_0} . We have described the multimode operation as a result of spatial hole burning and found

that the average number of excited modes is proportional to the power = (+2) of the pumping rate.
