## C ritical states of transient chaos


O ne-dimensional maps exhibiting transient chaos and de ned on two preimages of the unit interval [0,1] are investigated. It is shown that such maps have continuously many conditionally invariant measures scaling at the xed point at x = 0 as x, but smooth elsewhere. Here should be smaller than a critical value  $_{\rm c}$  that is related to the spectral properties of the Frobenius-Perron operator. The corresponding natural measures are proven to be entirely concentrated in the xed point.


#### I. IN TRODUCTION

Transient chaos has attracted an increasing interest in the last decade due to its connection to di usion  $[1{4}]$ and chaotic advection [5,6]. Transiently chaotic behavior develops often in a tim e period preceding the convergence of the trajectories to an attractor, or their escape from the considered region of space as is the case of chaotic scattering. The length of this tim e-period depends on the starting point of the trajectory and is unlimited, there are trajectories (though with Lebesgue measure zero) that never escape. The behavior of the very long trajectories is governed by the properties of the maxim al invariant set, the chaotic repeller and the natural measure on it [7]. This measure is related to the conditionally invariant m easure [8], namely the form er one is the restriction of the latter one to the repeller accompanied with a normalization to unity there (see for reviews [9,10]).

Transient chaos is much richer in possibilities than the perm anent one. Regarding e.g. the frequently studied chaotic systems, the 1D maps, there are rigorous theorem s stating that in case of everyw here expanding m aps exhibiting perm anent chaos there exists a unique absolutely continuous invariant m easure. How ever, this is not any more valid in case of transient chaos for the conditionally invariant measure [11], which in many respects takes over the role of an invariant measure. The main purpose of the present paper is to further investigate this question. It will be shown that one has to distinguish between normal (non-critical) and critical conditionally invariant measures. W hile the rst is typically unique, there are continuously many critical conditionally invariant measures. The latter ones deserve their nam e since their corresponding naturalm easure is degenerate. Namely, it is non-zero only on a non-fractal subset of the repeller, on a xed point in case of 1D m aps, we are going to study in the present paper.

The map generated by the function f(x) is assumed to map two subintervals  $I_0$  and  $I_1$  of [0;1] to the whole [0;1] (see Fig. 1). It is monotonically increasing in  $I_0 =$ [0; $x_0$ ] and decreasing in  $I_1 = [x_1;0]$ , f(0) = f(1) = 0 and  $f(x_0) = f(x_1) = 1$ . The value of f is unde ned in  $(x_0; x_1)$ , and we consider the trajectory being in this interval to escape in the next iteration. We assume f is smooth and hyperbolic  $(1 < jf^0(x)j < 1)$  in  $I_0$  and  $I_1$ , or we allow singular behavior with in nite slope in  $x_0$ ,  $x_1$ , and x = 1.





Instead of treating the Frobenius-Perron operator for the density P<sup>(k)</sup>(x) we deal with the measure<sup>(k)</sup>(x) =  $\binom{(k)}{(k)}([0;x])$ , where<sup>(k)</sup>( $[x_1;x_2]$ ) =  $\binom{K_{x_2}}{x_1}$  P<sup>(k)</sup>(x) dx. Note that<sup>(k)</sup>(x) is a monotonically increasing function. The upper index refers to the discrete time. The equation of time evolution for the measure can be written as

 $f_0^{-1}(x)$   $(f_1^{-1}(x))$  denotes the lower (upper) branch of the inverse of f(x). Since a portion of the trajectories escapes in every step, norm alization is necessary to ensure that the iteration converges to a certain m easure [8{10], which is then an eigenfunction of T, namely

The measure is called conditionally invariant measure (the notation without an upper index always refers to that in the present paper), and is the escape rate. The aforem entioned de nition of the natural measure yields its connection to . Namely, the natural measure [7] of a non-fractal set A ((A) > 0) is given by

The paper is organized as follows. The in nity of the coexisting conditionally invariant measures and the general condition for criticality are presented in Section 2. To get a deeper understanding of the conditionally invariant measures we study the spectrum of the Frobenius-Perron operator in Section 3. In Section 4 we show how maps with critical state are connected to each other by singular conjugation, thereby the singular measures are brought into connection with nonsingular ones. In Section 5 it is shown that the natural measures corresponding to critical states are fully concentrated to the xed point at x = 0, which is the main property of criticality. Section 6 is devoted to demonstrate some of the results on examples with further discussion.

### II. CONDITIONALLY INVARIANT MEASURES

First we assume that f is nonsingular in  $I_0$  and  $I_1$ , and in the second part of this section we shall study the case when the map may be singular with in nite slope in  $x = \hat{x}_0; x = \hat{x}_1$  and/or x = 1. We shall see that even in the rst case there are continuously many conditionally that have di erent power law beinvariant m easures x with > 0 at x = 0. In order to show havior this we study what a measure do we get asymptotically when we start with an initial measure (0) that is smooth but scales as  $^{(0)}(x)$  ax for x 1. (The simplest possibility is to choose  $^{(0)} = x$ , which will be used in the num erical calculations. Note that = 1 corresponds to the Lebesgue m easure.) The escape rate obtained in the asymptotics shall be denoted by . First we study the action of the term s  $T_i$  of T on <sup>(0)</sup> separately (see Eqs. (1),(2)). It can easily be seen that the leading term of  $T_0$  <sup>(0)</sup> is

where  $_0 = \log (f^0(0))$  is the local Liapunov exponent at the xed point. On the other hand, since  $T_1$  does not take values of  $^{(0)}$  from the vicinity of x = 0,  $T_1$   $^{(0)}$  is smooth with linear behavior

Therefore  $T_0$  <sup>(0)</sup> dom inates in  $T_0$  <sup>(0)</sup> +  $T_1$  <sup>(0)</sup> if < 1, and  $T_0$  <sup>(0)</sup> and  $T_1$  <sup>(0)</sup> both scale linearly near x = 0 if = 1. So the scaling of  $^{(0)}$  at x = 0 is retained if 1. That is why we expect that the conditionally invariant m easure and the corresponding escape rate m ay depend on .

Turning to the asymptotics for large time we rewrite the n-th iterate as

It can be seen from Eq. (5) that the rst term on the r. h.s. of (7) gives a contribution ae  ${}^{\circ n}x$  for small x. The similar factor in the sum can also be estimated as  $T_0^{n \ k}$  (0) as  ${}^{\circ (n \ k)}x$ . Acting on this function by  $T_1$  a function is created that is proportional to x in the vicinity of x = 0, similarly to (6). Therefore  $T_1T_0^{n \ k}$  (0) yields an asymptotics e  ${}^{1k}$  for large k under the action of  $T^{k \ 1}$ . Since for large n at least one of n k and k is large we obtain

Consequently, in case  $_0 < _1$  ( $_0 > _1$ ) the rst (last) term dominates for large n and smallx and T<sup>n</sup> (<sup>0</sup>) behaves asymptotically as e  $^{\circ n}$  (e  $^{1n}$ ). That means, there is a critical value  $_c = _1 = _0$  such that for every  $< _c$  in the limit n ! 1 with normalization in each step we obtain a conditionally invariant measure with leading term proportional to x at x = 0, while in case  $> _c$  we obtain 1. It is easy to see applying T on 1 that  $_1 < _0$ , i.e.  $_c < 1$ . The corresponding escape rates are

So the escape rate in case  $< _{\rm c}$  is determ ined by the slope taken at the xed point x = 0. We consider the system to be critical with respect to if  $< _{\rm c}$  since the density of the corresponding natural measure is a D irac delta function located at the origin, as will be shown in Section 4. Deeper understanding of Eqs. (9), (10) shall be reached in the next section by studying the spectrum of T.

In the second part of this section we allow singularities of f at the maximum points  $\hat{x}_i = f_i^{-1}(1)$  with i = 0;1 and/or at x = 1. Namely, the inverse branches behave as

where 1 and ! 1. If > 1 (! > 1) the map has in nite slope at the maximum points  $x_0; x_1$  (at the point x = 1). Studying the e ect of one iteration on a monotonic function (x) that is smooth in (0;1) and obeys scaling (x) ax at x = 0 we see that Eq. (5) remains valid.  $T_0$  (x) and  $T_1$  (x) have leading terms with exponent at x = 1,

W e start with a <sup>(0)</sup> in a class given by Eqs. (15), (16) and investigate Eq. (7) sim ilarly to the case of maps nonsingular in I<sub>0</sub>; I<sub>1</sub>, which maps correspond to the case = 1. By Eq. (5) we obtain again that  $T_0^{n}$  <sup>(0)</sup> ae ° <sup>n</sup>x and  $T_0^{n k}$  <sup>(0)</sup> ae ° <sup>(n k)</sup>x near x = 0. A coording to Eqs. (13) and (14)  $T_1T_0^{n k}$  <sup>(0)</sup> belongs to the class of functions de ned by Eqs. (15) (16) with = . Its iterates by T<sup>k 1</sup> decay proportionally to e <sup>k</sup> for large k. Since for large n either k orn k is large, we nally estim ate T<sup>n</sup> <sup>(0)</sup> using Eq. (7) as

That means, the border value of is now  $_{\rm c}$  = =  $_0$ . In case <  $_{\rm c}$  we obtain a conditionally invariant measure

belonging to the class of functions given by Eqs. (15), (16), while in case  $>_{\rm c}$  we obtain the conditionally invariant measure , which belongs to the class given by (15), (16) with = . Applying T on one can easily see that  $<_{0}$ , i.e.  $_{\rm c} <$  . The corresponding escape rates are

A gain the escape rate in case  $< _{c}$  is determ ined alone by the slope of the m ap at x = 0 and the m easure belonging to such a represents a critical state. Let us emphasize that while there is a continuum in nity of critical conditionally invariant m easures the noncritical one is unique.

It seems to be impossible to determ ine the full basin of attraction of the conditionally invariant measures. In the class of functions that are monotonic and smooth in (0;1) those belong to the basin of attraction of with < c that

The basin of attraction of consists of the functions that scale faster than  $ax_c$  at x = 0 and faster than  ${}^{(0)}(1)$  b $(1 x)^{c^{-1}}$  at x = 1.

N ote that the possible singular behavior of the noncritical conditionally invariant measure is determined com – pletely by the map. The behavior of critical conditionally invariant measures on the right hand side is also determined by the map. By this reason we classify these critical measures by the behavior near x = 0. Their leading term at x = 0 is analytic when is integer. The number of such measures is  $[_c]$ , where [] denotes integer part. If = ! = 1 then  $[_c] = 0$ .

#### III.EIGENVALUE SPECTRUM

The conditionally invariant m easures obtained in the previous section are particular eigenfunctions of the operator T (see Eqs. (1,2)), namely, they are monotonous (positive de nite) functions. To get further insight into the appearance of the upper value  $_{\rm c}$  of the parameter

specifying the critical measures we study more general eigenfunctions of the operator T. We allow that f may have singularity at  $x = \hat{x}_0$ ,  $x = \hat{x}_1$  and/or in x = 1, as in the second part of the previous section. However, for sake of sim plicity here we also assume that the inverse branches of them ap are analytic, so and ! in Eqs. (11), (12) (and thereby in (14)) are integers. We also assume, as it is typical, that there is a discrete spectrum of the Frobenius-Perron operator in the space of analytic functions. This has been proved for certain one-parameter fam ilies of maps [12{14,10].

We shall see that for any value of an expansion in terms of the basis functions  $T_0x^{+n}$  and  $x^{+n}$  with n = 0;1;::: is convenient for the search of eigenfunctions. Therefore we start from the form

where N ( ) = if is integer, and N ( ) = 1 otherwise. The limitation by N ( ) is necessary if is integer, since  $T_0\,x^{\,+\,n}$  can be expanded on the basis functions  $x^{\,+\,1}$  if  $\,+\,n$  is an integer greater or equal to  $\,$ . Note that

C learly, the basis functions in the second sum of Eq. (20) are transformed by T in the way

As seen from Eqs. (24), (25) and (26) the iteration of the vectors  $c_i$ d form ed from the expansion coe cients in Eq. (20) under the action of T can be described as

where G is a matrix constructed from the coe cients  $g_{mn}$  but with truncation to size N ( ) N ( ) if is integer.

In case c = 0 only Q is in e ect, so the eigenvalue problem yields the eigenvalues  $i_n$  of Q and corresponding eigenfunctions  $i_n$ , whose expansion starts with x . On the other hand, since G is a triangular matrix its leading eigenvalue is e  $i_n$  (see Eqs. (22), (23)) that belongs to an eigenvector denoted by c . Finally, an eigenfunction

of T with an x scaling at x = 0 can be obtained in the form of (20) with eigenvalue and coe cients

where  $= g_{00} = e^{-0}$ , except the special cases when is an integer greater or equal to or coincides with an eigenvalue <sub>in</sub> of Q. Thereby we have obtained besides the assumed discrete spectrum of analytic eigenfunctions an alm ost continuous spectrum of T. M ost of these eigenfunctions have nonanalyticity due to noninteger value of

The next important question is, how the conditionally invariant measures can be selected from these eigenfunctions. A measure should be nonnegative for any set, so the condition is that (x) should be monotonous. This is ensured when it can be generated starting from a monotonous  $^{(0)}(x)$  as the lim it of iteration  $T^{n}(0)(x)$ , normalizing it in each step. We can study this condition using the above results. A fter one iteration of a general monotonic  $^{(0)}$  with O (x) scaling at x = 0 the iterate T<sup>(0)</sup> is a linear combination of the basis functions  $T_0 x^{+n}$  and  $x^{+n}$  with n 0. Therefore the lim it of in nite iterations yields the eigenfunction that has the largest eigenvalue am ong the eigenfunctions that can be expanded on this basis. That one is the eigenfunction if = e ° > ;0,i.e. <  $\log((1_{0})) = 0$ .

On the other hand, when starting with an initial (0)

with O (x ) scaling at x = 0 we do not get term s with any smaller exponent, thereby we obtain the eigenfunction ;0. Therefore the correspondence between these eigenfunctions and the conditionally invariant measures and between the eigenvalues and escape rates can be described as

The spectrum of the Frobenius-Perron operator allowing singular eigenfunctions has been studied for piecewise linearm aps by M acK eman and N icolis [15]. Except the tent m ap, they considered eigenfunctions singular at internal points of the interval. They pointed out the existence of the continuous parts of the spectrum, but did not raise the question of the possible m onotonous property of the eigenfunctions for a region of eigenvalues, which has been our main concern here.

Finally we note that singular eigenfunctions of the generalized Frobenius-Perron operator have been of importance in the therm odynamic form alism to describe phase transition like phenomena, where the "tem perature" has played the role of the control parameter [16,17].

#### IV . C O N JU G A T IO N

It can be seen that all critical system s can be brought to the same form by the application of sm ooth conjugation. For this purpose a conjugation function u has to be introduced, which is sm ooth everywhere except in x = 0and x = 1, where it may be singular. These singularities can be characterized by the exponents and :

By de nition, the conjugation transforms the map and the measure in the following way:

To see how the conjugation changes the exponents in portant from the point of view of criticality, transform ation (34) has to be applied to the conditionally invariant m easure, and transform ation (33) to the branches of the inverse m ap. The conditionally invariant m easure is in the class of functions given by Eqs. (15,16) and the branches of the inverse m ap are described in Eqs. (11,12). The conjugation results in the following transform ation nules for the characterizing exponents:

From these transform ation rules it is clearly seen that by the application of the appropriately chosen u any two of the three quantities ,! and can be set to unity. This m eans all critical system s can be brought to the same form, which shows that criticality is the same, regardless it is caused by the singular measure or the singularity of the m ap in  $x = x_0$ ;  $x = x_1$  and x = 1.

It is worth noting that any conditionally invariant measure can be chosen as conjugating function. The conjugation in this case results in the equivalent map, which has the Lebesgue measure as a conditionally invariant one. Such maps will be called Lebesgue maps in the following. The equivalent Lebesgue map will be denoted by  $f^{(\ )}$ , if the conditionally invariant measure chosen for the conjugation is , i.e. the measure decaying at x=0 with the exponent . Naturally, the Lebesgue measure is not singular in x=0, so  $\sim = 1$ . Moreover, since the conditionally invariant measure is asymptotically proportional to  $(1 \ x)$  in x=1, the conjugation both  $\sim$  and  $\sim$  are equal to unity. However, if criticality is in existence, i.e.

<  $_{\rm c}$ , than  $\frac{1}{2}$  will be greater than one, i.e. the equivalent Lebesgue map is singular in x = 1. It is obvious that the map has as many equivalent Lebesgue maps as conditionally invariant measures.

### V.PROPERTIES OF THE NATURAL M EASURE

During the investigations of the piecew ise parabolic map it was found that the natural measure of the xed point at x = 0 is positive when the Lebesgue-measure as initial measure was iterated [18]. Numerical results suggested, and later it was supported by analytical considerations that this measure is not only positive but is equal to unity [18,19]. We shall prove here that this phenomenon is quite a general property: for any map with critical conditionally invariant measure the natural measure of the xed point at x = 0 is equal to unity.

Since  $f_0^{-1}$  has a nite slope  $e^{-0}$  at x = 0,

where  $0 < C_1 \ (x) < 1$  . Furtherm ore, the critical conditionally invariant measure  $\;$  is asymptotically proportional to x , that is

where  $< {}_{\rm c}$  and M is nite and positive. We introduce the following notation for the set of the preimages of the unit interval I = I<sub>0</sub><sup>(0)</sup> = [0;1]. The rst two preimage intervals are  $I_0^{(1)} = f_0^{-1}(I)$  and  $I_1^{(1)} = f_1^{-1}(I)$ . Sin ilarly, the (n + 1)-th preim ages can be generated from the n-th ones as  $I_i^{(n+1)} = f_0^{-1}(I_i^{(n)})$  and  $I_{2^n+i}^{(n+1)} = f_1^{-1}(I_i^{(n)})$ . The set of all the n-th preim ages of I is denoted by  $I^{(n)} = \sum_{i=0}^{2^n-1} I_i^{(n)}$ . We want to determ ine the natural invariant measure of a single point, the xed point located at x = 0, a series of intervals containing this point m ust be found, whose lim it is the xed point itself. The naturalmeasure of the xed point is equal to the lim it of the series of the naturalmeasures of these intervals. The series of the leftm ost intervals of the k-th interval sets is an appropriate and convenient choice, so the natural measure of x = 0 is

Since  $I_0^{(k)} \setminus I^{(n)} > I_0^{(n)}$ , k < n, we estimate the natural measure from below by keeping only the leftmost interval. From the criticality and Equations (40) and (39) follows

so the positive natural measure of the xed point is proven.

It can also be shown that this measure is equal to unity. For this purpose the features of the conjugation to an equivalent Lebesque m ap have to be used. Let us choose as the conjugating function the non-critical conditionally invariant measure , where = !. The conjugation results in the map  $f^{()}$ , which is characterized by exponents  $\sim$  = 1 and  $\frac{1}{2}$  = . The index ( ) in the following will be om itted. Any conditionally invariant m easure transforms into  $\sim_{\sim}$ , where  $\sim = =$ . Neither nor its conjugated pair, the  $\sim_1$  Lebesgue measure are critical, so ~ < ~\_c < 1 must hold for any critical ~\_ m easure. Since  $\sim_1$  is Lebesgue m easure, the  $\sim 1^{(n)}$  total length of the n-th preim age set of the unit interval I is equal to its measure with respect to  $\sim_1$ . This fact makes the exact determ ination of  $\tilde{r}$   $\Gamma^{(n)}$  possible. Since  $(f^{n}(A)) = T^{n}(A) = e^{n}(A)$  for any set A I and conditionally invariant m easure

holds. Now we can calculate the natural measure concentrated in the xed point at x = 0 for  $\sim_{\sim}$ , < c critical conditionally invariant measures. For this purpose

we can use Eq. (41). Since, provided that k < n,  $I_0^{(k)} = [0; f_0^{k} (1)]$  and  $I^{(n)} = [0; f_0^{k} (1)] \setminus I^{(n)} [ [f_0^{k} (1); 1] \setminus I^{(n)}$ , we can write that

The expression ~~ ([f<sub>0</sub><sup>k</sup>(1);1] \  $\Gamma^{(n)}$ ) is the measure of an interval set located in [f<sub>0</sub><sup>k</sup>(1);1] with total length not greater than e  $^{-1^n}$ , which is the length of the n-th preim age interval set. This measure is not greater than the maximum of the measure of such interval sets. Since for any xed value k there exist a  $^{0}_{-max}(k)$  nite upper bound of the derivative of the conditionally invariant measure in [f<sub>0</sub><sup>k</sup>(1);1],

whenever  $\sim_{\sim}$  is a critical conditionally invariant m easure. Now we prove that not only the conjugated natural measure, but the original one is concentrated in the xed point, too. We have already seen that for any xed k

Since the conjugation does not change the m easure of any single interval, i.e.  $(I_i^{(n)}) = \sim_{\sim} (I_i^{(n)})$ , the same equation applies for the non-conjugated m ap, which m eans

By using this critical measure as conjugating function one can get the equivalent Lebesgue map  $f^{()}$  where the Lebesgue measure represents the critical state. The density of its corresponding natural measure is (x + 0). In this Lebesgue map the density of the measure of the coarse grained repeller  $I^{(n)}$  is given by the n-th iterate of P  $^{(0)}(x) = 1$  by the adjoint of the Frobenius-Perron equation:

This equation has (x + 0) as eigenfunction with eigenvalue  $e = \frac{d}{dx} f^{(\ )}(x)$ . Our result (47) amounts to proving that  $L^{+ n} P^{(0)}(x)$  converges to (x + 0) when n ! 1. This convergence property has been assumed previously supported by num erical calculations and also som e of its consequences have been exploited [18,19,11].

From Equation (49) follows that  $_0 =$ , where is the average Liapunov exponent, and the Kolm ogorov-Sinai entropy K is zero for the natural measure in the critical case. The equations

valid for the critical states are the counterparts of the generalized Pesin relation

valid for noncritical states, obtained by K antz and G rassberger [7,20].

F inally we note, that them ap f can be considered to be the reduced m ap of a translationally invariant m ap of the realaxis [21{23,2,4]. Then the di usion coe cient can be written as an average over the natural measure of the reduced m ap [11]. This in case of critical state obviously results in a zero di usion coe cient. In the noncritical state there are important connections between the di usion and the form ula (52) [1,24,25].

# VI.EXAM PLES

In this section we dem onstrate the properties we have found along with further discussion. As an example consider the m ap whose inverse branches are

where R > 1 and 1 < d  $1 \mod 1$  d. The case d = 0corresponds to the case of the tent m ap and the eigen-= (2R) has been already given by [15]. Eq. value (29) for d = 0 shows in which region one can connect this eigenvalue with the escape rate. The map is conjugated to the sym m etric piecew ise parabolic m ap [26,18,19,11]. For the sake of sim plicity we lim it our discussion to nonnegative values of d. Substituting the inverse branches into the Frobenius-Perron equation, one can immediately see that the Lebesque measure is a conditionally invariant measure with the escape rate  $1 = \log R$ , independently of the value of d. Sim ilarly, the exponent is equal to unity for any 0 d 1. However, ! and consequently = ! have two possible values depending on d. This

makes it sensible to analyse this map in two parts, according to the value of . Let us start with 0 d < 1, when = ! = 1. The value of  $= _1 = \log R$  is exactly known, therefore




FIG.2. Numerical results for in case of the map (53) with R = 1.5 and d = 0 (+), d = 0.5 ( ), d = 1 (3); and the theoretical results (9), (10), (18), (19) (dashed lines) for the same values of d.

Numerical results for t to Eqs. (9), (10), as seen in Fig. 2. Fig. 3 shows some of the numerically obtained conditionally invariant densities.

In the case d = 1 obviously = ! = 2. Then is not known exactly, but it can be determined numerically. Numerical calculation for R = 1:5 gave 0:60 and  $_{\rm c} = = \log R$  1:48. A coordingly to the results of Section 2 conditionally invariant measures were found for  $< _{\rm c}$  and values of t to Eqs. (18), (19) (see Figs. 2 and 3). How ever, critical slowing down of convergence is seen near  $_{\rm c}$ .




FIG.3. The densities of the conditionally invariant measures of the map (53) with d = 0; = 02 (dotted line); d = 0.5; = 0.4 (short dashes); d = 1; = 12 (long dashes); d = 1; = 2 (solid line); and the constant density of the Lebesgue measure obtained numerically for = 1 and all the three values of d (dashed dotted line).

A nother m ap was constructed for that = 1 and = ! = 4. Its inverse branches are




FIG.4. Numerical (3) and theoretical (dashed line) results for in case of the map (55).




FIG.5. The conditionally invariant densities of the map (55) with = 0.5 (dotted line), = 1 (dashed dotted line), = 2 (short dashes), = 3 (long dashes), and = 4 (solid line).

where R > 1 and 0 4R. In the num erical calculations R = 1.25 and Q = 40 was used. The Lebesgue measure is again one of the conditionally invariant m easures with escape rate  $1 = \log R$ . From the num erical value  $= \log R$ 3:27. Num erical 0:730 follows that  $_{\rm c}$  = values of are compared to the theoretical values in Fig. 4. Presence of the conditionally invariant measure that is smooth at least in the inside of [0;1] was checked num erically at several values of with  $< _{c}$  and at = . Among them the ones with integer have analytic leading term at x = 0. The densities of the latter ones together with a singular one are seen in Fig. 5.
