# Fractional Langevin equation to describe anom abus di usion.

#### Abstract

A Langevin equation with a special type of additive random source is considered. This random force presents a fractional order derivative of white noise, and leads to a power-law time behavior of the mean square displacement of a particle, with the power exponent being noninteger. More general equation containing fractional time di erential operators instead of usual ones is also proposed to describe anom alous di usion processes. Such equation can be regarded as corresponding to system swith incom plete H am iltonian chaos, and depending on the type of the relationship between the speed and coordinate of a particle yields either usual or fractional long-time behavior of di usion. C orrelations with the fractional Fokker-P lanck equation are analyzed. Possible applications of the proposed equation beside anom alous di usion itself are discussed.

#### 1 Introduction

In recent years, growing attention has been focused on the processes that take place in random disordered media, and in dynamic systems demonstrating chaotic behavior. A special place here is taken by the system s with incomplete H am iltonian chaos, which trajectories in the phase spacecan be portrayed as a set of "islands around islands" with self-sim ilar (fractal) structure. In such systems the lifetime of any state of regularmotion is also random. Incomplete chaos results in a few interesting phenomena that, among others, include anom alous properties of transport processes. That is associated with the fact that the islands of stability in this case become to act as a system of traps with a certain given distribution of the trapping time. For example, well known is the phenomenon of anomalous di usion that is characterized by the time function of the mean squared displacement of a di using particle, which is described not by the Einstein's law but by an power function with fractional exponent [1, 2].

In most cases, such behavior is considered to be connected with self-sim ilar properties of the di usion medium. As this takes place, the Fokker-P lanck equation describing such di usion process was shown to involve the integradi erential R iem ann-Liouville operators I and D of fractional order [3] (see Appendix A). Possible interpretation of the physical meaning of these operators was o ered in [4, 5], and assumes that a system described by equations with fractional derivatives or integrals possesses a "selective" mem ory that acts only in the points within a set of dimensionality , and is in accordance with the ideas about a certain self-sim ilar (say, Levy-type or fractal) distribution of traps and waiting times [5]. Fractional Fokker-P lanck equations were studied in [5]-[9], and proved to be quite useful to model anom abous di usion processes. The most general form of such equations was introduced in [5, 8, 9] and in a simple case boks

where n is the concentration of di using substance and the fractional differential operators on the right-hand side and on the left-hand side are either fractional R iem ann-Liouville derivatives [5]-[8] or so called local fractal derivatives [9]. A nother m ethod of the anom abus transport properties description refers to their m icroscopic m otion and involves introducing fractional derivatives into a stochastic process that characterizes the B rownian m otion. As the starting point to be changed the W iener stochastic process that de nes the displacement of a particle with time is taken

where F (t) is the the G aussian white noise (the brackets here m ean averaging over the possible realizations of the process),

and the fractal B row nian m otion is obtained by substituting the R iem ann integral for a fractional one [10]-[13]

The fractional integral of the white noise was named the fractional noise. This noise is Gaussian but nonstationary. Its correlation function has the form

In principle, this noise can be made stationary, but only provided that 1 is taken in Eq.(2) as the lower lim it of integration instead of 0. However, in this case one has to som ewhat modify the power kernel in order to provide the convergence of the integral. We will brie y discuss this below, at the end of the Section 2.

Fractal B rownian motion is of great interest not only from mathematics and theory of stochastic processes points of view but also in terms of physical applications. It can be used in describing polymer chains, electric transport in disordered sem iconductors, di usion on comb-like structures, and so on. However, it is well known that in many cases the most convenient way of describing the Brownian di usion of particles is not the W iener process but rather the O mstein-U hlenbeck process (or Langevin m ethod [2, 14, 15]) that is based on the solution of stochastic di erential equation

where v is the velocity of a Brownian particle, means the factor of liquid friction, and F (t) is the random source characterizing the properties of medium where di usion occurs. Displacement of a particle and its path are determ ined not directly but through the integration of the instant velocities. A part from the problem of Brownian motion itself, this method is widely applied to describe various system s subjected to external noise. This brings up the question of whether the Langevin equation can be written for anom alous di usion as well, and if so, what will be the structure of the corresponding random source in it. In principle, if the Fokker-Planck equation is known then the Langevin equation can be derived from it. However, this method involves certain di culties, and gets even more complicated because of the intricate structure of fractional integrodi erential operators. So, we shall postulate the form of such equation in further sections of our paper. A ctually, we shall consider three form s of such equation that have in comm on the m ethod of introducing the m em ory by m eans fractional derivatives yet di er in the properties of medium and in the ways of setting up the problem.

## 2 Langevin Equation with FractionalD erivatives

a. As it has been mentioned above, introducing the fractional di erential operators into the Fokker-P lanck equation makes it possible to describe the anom alous transport process quite correctly. Therefore, let us consider the following equation that di ers from the usual Langevin equation by replacing the rst derivative with respect to time by the fractional derivative of order

Applying the fractional integral operator to both left-hand and right-hand sides of this equation, one has

Expressing the fractional integral in the explicit form, we rewrite it as follows

This equation can be easily solved by standard techniques for Volterra integral equations, and its solution has the form

If F (t) is taken, as usual, to be a Gaussian -correlated source with zero m ean, then the velocity correlation function has the form

The integral from the right-hand side can be taken in the explicit form only if we introduce  $t_{>}$  and  $t_{<}$  from Eq.(3), which is rather inconvenient. How – ever, we can obtain several important results without having to calculate

the integral directly. It is only essential that the integral is a symmetrical function of its arguments  $t_1$  and  $t_2$ . Further, let us not the corresponding mean squared displacement of the particle, which motion is described by the equation Eq.(5). It follows the expression

At large values of the argum ent E<sub>1</sub>; ( t) / E<sub>2</sub>; ( t) / 1= t. Therefore, the integral in Eq.(11) necessarily converges att! 1 for 1=2 <, and the leading term in the asymptotics is

just as it is the case for the classical Langevin equation with the st derivative with respect to time. Even when < 1=2 and the integral diverges, it increases more slow by then the st term and the linear asymptotics remains. Leaving the discussion of this point for later, we shall try to modify somehow the initial equation.

b. First, it must be noted that in Eq.(11) we assumed that, as usually, the velocity v was dened as the rst derivative of the coordinate with respect to time and, therefore,  $x = \int_{0}^{t} v(t) dt$ . A ctually, it makes sense to consider a more general relationship

that corresponds to the most complete possible description of the system memory by means of the fractional integrals - the particle's displacement is

de ned by velocity only in the points within a time interval of dimension

. Though in this case the physical meaning of the corresponding inverse de nition of velocity as a fractional derivative of the coordinate with respect to time needs to be explained. In order to clear this point, let us recollect that m icroscopic motion of a di using particle represents a twisted and everywhere nondi erentiable curve. For such curve, how ever, one can often

nd a derivative of fractional order [19] that, in fact, is a derivative of the trajectory, averaged with a power weight, and the observed motion of the particle is the thus averaged motion. In terms of memory, it means that for fractal paths (which are even the paths of classical Brownian particle) some of the instant velocities and displacements do not contribute into the resulting macroscopic motion. As this occurs, the behavior of the solution changes, and di usion becomes anomalous. In this case instead of Eq.(11) we obtain

At large times the rst term tends to  $\sqrt[2]{e}^2$ , and the series in the second term converges (see Appendix C). Therefore we nally have

that coincides with the asymptotics obtained in [8, 9] for the generalized equation of fractal di usion Eq.(1) if = 1, and with the asymptotics of fractional B rownian motion [10]-[13]. The larger the faster the particle moves. M ore accurate estimations of factor N can be obtained either follow - ing the method similar to that stated in the Appendices B and C (which in this case would be quite a challenge) or numerically.

c. Let us now investigate separately the in uence of memory and fractal behavior on the regular and random components of the force acting on a particle. It turns out that the same fractal asymptotic behavior can be demonstrated by taking into account only the memory for the random force component in the initial Langevin equation, which has a more clear physical m eaning (cf. Eq.(7)):

In fact, it means that in Eq.(4) the random source is not -correlated but represents the fractional derivative of the -correlated process g(t), which can be taken in the sense of the generalized functions [18]

Sim ilar equation was actually considered in [20]. It was shown numerically there that when in the Langevin equation G aussian white noise is replaced by the fractional G aussian noise [10, 11] it can yield the spectra for hom ogeneous Eulerian and Lagrangian turbulence. However, equation Eq.(16) can be easily solved analytically, and the solution reads

which agrees with Eq.(15) up to the constant multiplier.

d. Finally, let us consider the third case, that is when the memory is taken into account only for the friction force

where F (t) is again the Gaussian white noise (cf. Eqs.(7), (16)). It means that now it is the dissipative force that is proportional to the fractional derivative of velocity  $f_{diss} = {}_{0}D_{t}^{1}$  v(t). Its solution is

The contribution from the second term in the mean squared displacement results in the power function of time in the following form

It should be noted here that, unlike the previous two cases, here no limitations are imposed on the value of , and depending on whether it is greater or less than 1, we can obtain either subdi usion with the power exponent less than 1, or superdi usive behavior with the power exponent greater than 1, observed, for instance, for a phase for wave propagation in nonlinear or random media. The greater is , the slower the particle moves (it was the other way around in the previous cases), because at > 1 the corresponding dissipative force is no longer a fractional derivative of the velocity but a fractional integral, and, hence, its in uence increases. At > 3=2, the mean squared displacement Eq.(24) tends to zero with time increasing, which corresponds to a stop in the particle motion since the terms neglected in Eq.(24), as well as in Eqs.(14)-(15), are either vanishingly sm all or constant,

and m eans that particle energy dissipates faster than it is pumped. On the other hand, limitations 1=2 < < 1 were used in the previous cases only to simplify the estimations for the sum swhich were shown to be convergent and therefore in principle it must not a left the main results and they also can give sub-and superdi usion behavior. But because of the fact that prehistory in uences only on the dissipative force, now di usion is impeded when we increase the value of .

Let us now analyze the results obtained. If we substitute the st derivative in the Langevin equation for the fractional one but use the same relationship for velocity and coordinate, then the solution possesses the same linear asymptotic behavior as the initial solution does. This means that taking into account the memory for the friction force and random force at the same moments of time does not a ect the particle's motion at large times but only in the beginning of the motion. In a sense, this is quite reasonable, since a random source provides a particle with an additional energy, and friction results in its dissipation. At larger times, when the system arrives at the stable state, these two processes compensate each other, but only provided that they have the same duration.

U sing the relationship Eq.(13) m eans that the particle's m otion equation written in the Newtonian form reads

and is the most general in the sense of memory calculation - every derivative with respect to time becomes fractional. Then anom abus properties of the di usion arise from fractional integration of velocity, that is, from the assumption only part of instant velocities contribute to the nalpath.

The anom abus di usion is also the result of the Langevin equation with a source that is a fractional derivative of the white noise. The autocorrelation function of such noise, just like that in Eq.(2), has a power behavior yet negative values of the exponent and therefore appears to be a generalization of the icker-noise (see [2]). It should be noted that a stationary noise can be obtained only by using the Liouville fractional derivative with the in nite lower limit. However, when used directly in the equations Eqs.(7), (16), (22), these derivatives would lead to the divergences because of the power integrands. Besides, this is not quite reasonable, since in real situations there is always a moment at which them otion starts, and assuming thism oment as in nitely distant is possible only in a system where characteristic relaxation

scales exist. Fractional B row nian m otion, however, can not be assigned to such processes – its m em ory is described by a power function and leads to the long-range correlations having no time scale of their own. Nevertheless, the nonstationary of the noise should not lead to a m isunderstanding. A swe shall illustrate below, such process can be regarded as stationary only in a wide sense (the corresponding transition probabilities depend uniquely upon the duration of the transition t) only for small t, that is for t << t.

The absence of stationarity is an important and rather obvious property of anom alous di usion, although it is not always given proper consideration. Here it is relevant to note the following. Normally, the Brownian motion can be described with two di erent stochastic processes. The 0 mstein-U hlenbeck process is strictly stationary but does not have independent increm ents. Moreover, its increm ents are not even uncorrelated. The W iener process, which is the integrated 0 mstein-Uhlenbeck process in the limit of intense friction and noise, has stationary independent increments, but is neither strictly stationary nor a wide-sense stationary. The process under investigation with a fractional derivative of the white noise seems to be an interm ediate process that does not have stationary increm ents but is asymptotically stationary in a wide sense. The fractal nature of motion leads to the fact that even this kind of stationarity is observed only within short periods of time, which means that the process becomes quasistationary. This conclusion is in a good agreem ent with the notion that anom alous di usion is just an interm ediate asymptotic behavior for system s of certain types.

Finally, if the prehistory a ects only the dissipative force acting on a particle, its behavior also becomes anom alous.

### 3 Probability distributions

Let us now study the probability distributions that arise from the stochastic processes described above. For the sake of convenience, let us consider only the process with the noise that is a fractional derivative of the white noise Eq.(16). The other cases are considered in perfect analogy to this one and give sim ilar results.

The distribution of the particle coordinate will be G aussian. It follows from the fact that the equations are linear both with respect to the external additive noise and the stochastic variable. In order to determ ine the transition probability P(x;t+t;y;t) let us consider transition m om ents at large

The second terms that appeares in Eq.(27) after the substitution  $t_1 ! t_1$ t;  $t_2 ! t_2 t; t^0 ! t^0 t$  reduces to the mean squared displacement given by Eq.(21) during time t

and follows from the fact that if we take y = 0;  $t_0 = 0$  as the initial point of transition, then the  $I_2 = 0$  holds disregarding the value of t. Therefore, at large times the described process becomes quasistationary in a wide sense, that is, the probability of transition during a small time interval t depends on the value of t only. However, if the condition t << t is not fulled, then  $I_2$  can no longer be given with the simple expression like Eq.(28) and thus can not be neglected as compared to  $I_1$ . It should also be noted that such process on any time scales is not M arkovian since the equations Eqs.(29)-(30) do not comply with the Chapmen-K olm ogorov equation

It is worth to note that in this case the property of wide-sense stationarity is lost for all time scale.

Non-M arkovity is a consequence of the memory of the past process existence. If for a M arkovian process the future is uniquely determ ined by the present, then in the initial equation Eq.(16) the behavior of a particle in the next moment of time is, generally, dependent on the whole previous history starting from the very beginning of them otion, and the transition probability P (x;t+ t;y;t) does not depend on the time t only when t! 0. In this connection the question of transition from Eq.(16) to the Fokker-P lanck-type equation still remains to be solved. Indeed, the proposed in [5, 9] m ethod is based on the fractional Taylor series expansion of the transition probabilities in the Chapmen-K olm ogorov equation. For example, according to [5], the fractional Fokker-P lanck equation for the transition probability given by Eq.(29) takes the form

Solution of this equation was obtained in [8, 21] and shown to be

where  $H_{1;1}^{1;0}$  is the so-called Fox function [17, 22]. However, according to Eq.(30)

Therefore, the solution Eq.(33) does not satisfy Eq.(31) though the time and the coordinate of a particle appears in its solution in the "correct" combination  $x^2=t^2$ <sup>-1</sup>. However, as the stochastic process under consideration is not globally stationary, this fact seems to in uence the structure of the corresponding Fokker-P lanck equation. In particular, such equation m ay also include the terms that characterize the sources and drains of probability, and therefore its structure will no longer be as simple as in Eq.(31). Probably this problem m ay be solved by studying the waiting time probabilities and then writing down the equations similar to those used in [7].

The average kinetic energy of a particle can be obtained as

Substituting here the expression for the velocity correlation Eq.(19) and taking into account that at large times, when the motion becomes stable, the particle "forgets" the initial velocity and we can neglect the rst term in it (see also Eq.(26)), yields

Since when t ! 1  $E_{i1}()$  / 1= and in the vicinity of zero the M ittag-Le eur function is bounded, for 1=2 < the integral in Eq.(35) converges. Therefore (see [14], the velocity of the moving particle will obey the M axwellian distribution.

P robability distribution for the processes described in the paragraphs 2b (Eqs.(7) and (13)) and 2d (Eq. (22)) are obtained in the same way. Velocity distribution obeys the M axwellian law, and the coordinate distribution W (x;t) and transition probability P (x;t+ t;y;t) at large times t and sm all t follow the G aussian law with the dispersion determ ined by the mean squared displacement over times t and t, respectively.

#### 4 Conclusion

To conclude, we would like to note the follow ing. The equations and m odels proposed in this paper are quite general and, represent a way to introduce and describe a certain class of G aussian non-M arkovian stochastic processes. P rocesses of this type are featured with the "selective" m em ory acting only in the m om ents of tim e distributed over a C antor-type fractal set and taken into account by m eans of fractional derivatives, and show prom ise in describing stochastic processes in fractal m edia and system s with incom plete H am iltonian chaos. One of such processes is anom alous di usion, observed in a wide variety of system s. The m ethod developed in this paper is an alternative to that utilizing the fractional Fokker-P lanck equations, although we could not trace fully the relation between these two approaches and it still rem ains to be explored. Nevertheless, the two approaches give sim ilar results, and choosing between them should probably be determ ined by a type of problem to be solved and by practical convenience of calculations. Earlier the fractal Brownian motion was represented only as a W iener stochastic process of fractional order (the integral of order from the white noise or, which is the same, the integral of the rst order of the noise which is a fractional derivative of order 1 of the white noise). As shown in the present paper, the 0 mstein-U hlenbeck process with fractional noise leads to sim ilar results and allows to obtain more general probability distributions in an easier way, as compared to the path integrals [13]. The equations proposed can also be easily generalized by adding linear and nonlinear terms, and be used for calculation of various statistic characteristics of real stochastic dynam ic system s.

#### A Fractional dervatives

There are about two dozens of di erent de nitions for fractional derivatives that are in one way or another adapted to various features of classes of functions for which they are de ned. The most comprehensive description of the mathematical aspects of the issue is given in the monograph [3]. In physics the R iem ann-Liouville fractional derivative is the most commonly used. Its de nition goes back to the well-known C auchy formula formultiple integrals

Substituting the factorial for the Euler gam ma-function, we can generalize the formula by introducing the fractional exponent  $\$  as follows

This expression is referred to as the Riem ann-Liouville fractional integral. The fractional derivative is then de ned as an ordinary derivative of the integral of fractional order

Fractional derivative can also be treated in the form of convolution with power function, and in this sense the de nitions in Eqs.(A.1)-(A.2) can be easily transferred onto generalized functions.

## B Calculation of the mean squared displacement

The mean squared displacement of a particle during time t is de ned as

#### C The sum evaluation

We can d the asymptotic behavior of the double sum in Eq.(14) (we designate it as  $S_1$ ) in the following way. First, let us d the upper boundary for this sum. To do this we substitute the second cofactor ( > 1=2; k; 1)

Therefore,  $S_1 < 1 = ()$  when t! 1. In order to get the low erapproximation for the sum (for 1=2 < < 1) we shall multiply it by t and dimensionet twice. Reducing the argument in the gamma-function in the numerator by < 1and increasing the denominator by  $(2 \ 2) < 1$  we then get
