Forced Burgers Turbulence in 3{D im ensions

W e investigate non-perturbative results of inviscid forced B urgers equation supplemented to continuity equation in three-dimensions. The exact two{point correlation function of density is calculated in three-dimensions. The two{point correlator $\langle (x_1) (x_2) \rangle$ behaves as $jx_1 x_2 j^{-3}$ and in the universal region $_3 = 7=2$ while in the non-universal region $_3 = 3$. In the non-universal region we drive a K ram ers-M oyal equation governing the evolution of the probability density function (PDF) of longitudinal velocity increments for three dimensional Burgers turbulence. In this region we prove Yakhot's conjecture [Phys. Rev. E 57, 1737 (1998)] for the equation of PDF for three dimensional Burgers turbulence. We also derive the intermittency exponents for the longitudinal structure functions and show that in the inertial regime one point $U_{\rm rm s}$ enters in the PDF of velocity dimension.

I. - IN TRODUCTION

Recently, trem endous activity has started on the nonperturbative understanding of turbulence [1-22]. A statistical theory of turbulence has been put forward by Kolm oporov [23], and further developed by others [24{26]. The approach is to model turbulence using stochastic partial di erential equations. The simplest approach to turbulence is the K olm ogorov's dim ensional analysis, which leads to the celebrated k $^{5=3}$ law for the energy spectrum. This is obtained by decreeing that the energy spectrum depends neither on the wavenum berwhere most of the energy resides, nor on the wavenum ber of viscous dissipation. Kolm opprov conjectured that the scaling exponents are universal, independent of the statistics of large{scale uctuation and the mechanism of the viscous damping, when the Reynolds number is su ciently large. In fact the idea of universality is based on the notion of the "inertial subrange". By inertial subrange we m ean that for very large values of the Reynolds num ber there is a wide separation between the scale energy input L and the typical viscous dissipation scale at which viscous friction become in portant and the energy is turned into heat.

In turbulent uid ow s, the physical quantities of interest, such as the velocity and density elds, display highly inregular uctuations both in space and time. To study such processes, using a statistical approach is most natural. The statistics of any uctuating quantity are described by its probability density function (PDF). One would, therefore, hope to be able to calculate the PDF's of the turbulent quantities directly from the equations of motion, i.e. for example to calculate the PDF of velocity uctuations from Navier-Stokes equation. How -

ever this task is highly nontrivial and as of today has not been accomplished not even for the relatively simpler problem s. The striking feature of developed turbulence is its interm ittent spatial and tem poral behavior. The structures that arise in a random ow manifest them selves as high peaks at random places and at random times. The intervals between them are characterized by a low intensity and a large size. Rare high peaks are responsible for PDF tails while the regions of low intensity contribute PDF near zero. A nalytically the following properties manifest them selves in the nonlinear bahavior of the scaling exponents in the velocity di erence structure functions (transvers and longtudinal) S_n (r) i.e. < $(u(x + r) u(x))^n$ >. It is known that $S_n(r)$ behaves as r^n , where n is a non-trivial function of n. This behaviour leads to stongly non-gaussian (interm ittent) probability distribution functions of velocity di erence [27].

On the other hand Burgers equation, which describes the potential ow of the uid without pressure, provides a wonderful laboratory for testing new ideas and techniques in view of the study of fully developed turbulence in the Navier { Stokes turbulence. These are two cases of non { linear stochastic equations which share in the same structure of the non { linearity. The important di erences com e from the nature of interaction (i.e. locality and nonlocality) and the large scale structure. In the case of incom pressible turbulence the interaction is non { local that is the very existence of the pressure causes the far regions of the ow to be coupled with together [11] and leads to e ective energy redistribution between com ponents of the velocity eld, while in the case of Burgers equation the pressure e ects are absent. The non-linear term (v r)v in the N avier-Stokes and B urgers equations tends to form

shocks and enhance interm ittency while the additional pressure gradient term in N-S equation depresses intermittency. This senario has been given addressed by V. Yakhot [11]. for constructing an approxiam te dynam ical theory for N-S equation. In multi-dimensional Burgers turbulence the presence of large scale structures (shocks) form ing a d-dimensional forth-like pattern is responsible for extrem e case of interm ittency causing the saturation of the intermittency exponent to n = 1. Large scale structures in "true" turbulence are sim ilarly thought to be the origin of the experimentally observed intermittency, which is how ever much milder. The deep reason of this di erence is thought to be probably related to the "dim ension" of the large scale singularities, which is d 1 in the d-dimensional Burgers turbulence and only 1 for votex lines in hydrodynam ical turbulence.

The problem of forced and un-forcerd Burgers turbulence [28-30] has been attacked recently by various methods [2,4{6,8{19}}. The Burgers equation describes a variety of non-linear wave phenom ena arising in the theory of wave propagation, acoustics, plasm a physics, surface grow th , charge density waves, dynam ics of the vortex lines in the high T_c superconductor, dislocations in the disordered solids and form ation of large{scale structures in the universe [30{32}. A coording to the recent theoretical [4,5,11,17,18] and num erical works [33], it is know n that the PDF for the velocity di erence behaves di erently in universal and non-universal regions. In the universal region i.e. the interval j uj< Urm s and r << L, the PDF can be represented in the universal scaling form

where F (x) is a norm alizable fuction and the exponent z is related to the exponent of random force correlation as $z = \frac{+1}{3}$. In the region for $x = \frac{j \ u \ j}{r^2} > 1$ the universal scaling function F (x) is given by the expression F (x) exp (x^3), where is some constant in one-dimension and it depends on the cosine of angle between the vectors u and r in the higher dimensions. On the other hands

the PDF in the interval j uj>> $U_{rm s}$ behaves as:

which depends on the single-point $U_{\,\rm rm\ s}$ and therefore is not a universal function.

In this paper we consider the inviscid forced Burgers equation in $3\{\dim ensions \ supplm ented \ to \ continuity equation. We note the exact two{point correlation functions of density in three-dimensions and show that <$

 (x_1) (x_2) > behaves as jx_1 $x_2 j$ ³, where $_3 = 7=2$ in the universal region i.e. ju(x) $u(x^0) j < U_{rm s}$ where $U_{rm s}$ is the rm s value of velocity uctuations. In the non-universal region i.e. ju(x) $u(x^0) j > U_{rm s}$ we drive the exact K ram ers-M oyal equation governing on the evo-

lution of the probability density function (PDF) of longitudinal velocity increm ents for three dim ensional Burgers turbulence. In this region we prove the Yakhot conjecture [11] for equation of the PDF in multi-dimensional Burgers turbulence and prove the existence of the A-term and B-term in the equation for the PDF of longitudinal velocity di erence. W e also derive the interm ittency exponents for the longitudinal structure functions and show that how the U_{rm s} enters in the PDF of the velocity difference and breaks the G alilean invariance. Furtherm ore we refer to the zero viscosity lim it of 3D forced Burgers turbulence. We claim that at least when the simplest term s satisfying the basic sym metries of the problem are introduced for closing the disspiation term the requirem ents of the hom ogeniety and isotropy would force the coe ecient of the proposed terms to vanish. So within this approximation the viscous term in the vanishing viscosity limit do not contribute in the equation for the PDF's of velocity di erence in the inertial range.

The paper is organized as follows: In section 2 we derive the density-density correlators exponent in invicid Burgers turbulence and the generating function for longitudinal velocity di erence in the universal part of the PDF. In section 3 we determ ine the small scale statistics of longitudinal velocity di erence and derive the exact equation for the PDF's of longitudinal velocity di erence in the non-universal part of the PDF and derive the exact act value of interm ittency exponents in longtidinal structure functions. We show that the interm ittency problem in these systems can be investigated non-perturbatively and derive the deform ation of PDF is in length scales. It is shown that deform ation of PDF from large to small scales are completely described by K ram ers-M oyal equation.

II.-PDF'S OF 3D BURGERS TURBULENCE IN THE UN IVERSAL REG ION

O ur starting point is the 3D {B urgers equation supplem ented to continuity equation:

for the Eulerian velocity u(x;t) and viscosity and density , in 3{dimensions. The force f(x;t) is the external stirring force, which injects energy into the system on a length scale L. M ore speci cally one can take, for instance a Gaussian distributed random force, which is identied by its twomoments:

where ; = x;y;z. The correlation function k (r) is norm alized to unity at the origin and decays rapidly enough where r becom es larger or equal to integral scale L. The quantity k(0) measures the energy injected into the turbulent uid per unit time and unit volume. f(x;t) provide also the energy ux in the k th shell as $(r = k^{-1})'$ $\int_{1=L}^{\kappa} < f(k) f > , where r belongs$ _k = to the inertial range.

Eqs.(3) and (4) exhibit special type of nonlinear interactions. It is hidden in the nonlinear term (u r)u.The advective term couples any given scale of motion to all the large scales and the large scale contain most of the energy of the ows. This means that the large { scale uctuation of turbulence production in the energy { containing range couple to the sm all{scale dynam ics of turbulence

ow. In other words, the details of the large{scale turbulence production mechanism are important, leading to the non {universality of probability distribution function (PDF) of velocity di erence. However in the case that $j_{\mu}(x)$ $u(x^{0}) j < U_{rm s}$ it is believed that the PDF for the velocity di erence is not depended to $U_{rm s}$ and therefore the one-point U_{rm} s does not appear in the velocity di erence PDF.This region is known as the Galilean invariant (GI) region.

Now let us consider the invisid 3D forced Burgers turbulence that is we intend to neglect from the viscosity contribution in eq.(3). The problem is to understand the statistical properties of velocity and density elds which are the solutions of eq.(3) and (4). We consider the follow ing two {point generating function:

To derive an equation for F_2 , we write the eq.(3) and (4) in two points x_1 and x_2 for $u_1; u_2; u_3$ and (x) and multiply the equations in (x_2) , $_{1x}$ (x_1) (x_2) , $_{1z}$, (x $_1$) (x $_2$) and (x $_1$), $_{2x}$ (x $_1$) (x $_2$),

 $_{2z}$ (x₁) (x₂), respectively. W e add the equations and multiply the result by $\exp(1 \mathfrak{u}(\mathbf{x}_1) + 2 \mathfrak{u}(\mathbf{x}_2))$ and m ake average with respect to external random force, so we nd:

where we have used the Novikov's theorem . The above equation is rst driven by Polyakov [5]. It is noted that the advection contributions are accurately accounted for in this equation. Also we suppose that k has the following form :

In homogeneous and isotropic Burgers turbulence, with stirring correlation as k (r) 1 r (where in the our case i.e. eq.(8) we have = 2), we consider the universal scale { invariant solution of eq.(9) in the following form :

Substituting the following form for the generating function xes the exponent as $=\frac{+1}{3}$ (In our case using eq.(8) we nd = 1). Invoking to the scaling invariance of the inviscid Burgers equation and continuity equation, we assume the existence of the density-density correlators with the scaling form of introduced in (10). $_3$ is the exponent of two point correlation and the two point correlation of the density can be found by the generating function in the limit of ! 0. Therefore it is neces-> m eans an average over various ary to nd such a solution for F (r) which tends to a constant in the limit of ! 0. Proceeding further we focus our attention to the longitudinal velocity com ponents, i.e. s = 1, and hence accept the scaling ansatz F(r;s) = F(rs). The proposed form of the argu-In ents will garantee that S_n (r;s) $s^n S_n$ (r) when n < 1. Rewriting eq.(9) in terms of the variable z = rs, the following equation is obtained in the limit of s! 1:

It is interesting that the above equation was st derived by Polyakov [5] for the problem of one dim ensional Burgers equation in the inviscid limit. In that work the e ect of the viscose term is found in the limit of ! 0 L by appeal to the self-consistent conjecture of and r operator product expansion. It is found that there are only two terms generated by the viscose term which are consistent with the sym m etries of the problem . These two anom aly term swillm odify them aster equation governing over the generating function in a way such that a positive

an

, nite and renorm alizable PDF can be found [5]. A simple analogy between eq.(10) and Polyakov's result will reveal that the coe cient of b-anom aly is replaced with the scaling exponent of density-density correlation through a simple linear relation. In the problem of one-dimensional Burgers equation in the zero viscosity limit the presence of the b-anom aly generated by viscosity term is crucial for nding a positive PDF for velocity increments in the universal regime and the requirement of positivity will

x the value of anomaly coe cient [5]. Boldyrev [18] shows that one could nd a fam ily of solutions for different values of the b-anom aly coe cient if one relaxed the hom ogeniety condition for the universal part of the PDF. The value of this coe cient is related to the algebraic decay of the left tail of PDF in the universal regime. D eterm ination of that decay exponent has been a controversial subject for which other methods have been developed and among them recent rigorous methods should be mentioned within which it is xed to 7=2 [15,16]. The interesting point is that our calculations in three dim ensions show that when density uctuations are taken into account there is no more any need to the viscosity term for obtaining a positive PDF and even in the inviscid problem it is possible to nd a positive solution for the longitudinal velocity increment PDF. It is easy to show that the requirem ent of the positivity on the PDF will x the density-density scaling exponent to $_3 = 7=2$. There are some strong constraints which would be considered for any non-perturbative dynam ical theory constructed for describing the interm ittent behaviour of the structure functions in the homogenious and isotropic turbulence ows. The most vital constraints are the hom ogeniety

and isotropy which dictate the average of the velocity increment to be vanished. Now it is straight forward to show $\langle u \rangle_s = 0$, where $u = u(x_1) = u(x_2)$ [19].

We have also extended our analysis to two {dimensional Burgers turbulence. We de ne the variables as: $x = x_1 \quad x_2, \quad + = \quad _1 + \quad _2$ and $= \quad _2 \quad ^2$ and consider the polar coordinates, so that x : (r;) and : (;'). Now one can show that for isotropic and hom ogeneous Burgers turbulence, two{point generating function F_2 satis es the following equation:

where $s = \cos($ '). Similar to three{dimensions, we propose the scale invariant solution for F_2 as $F_2 =$ g(r)F(z;s) where $g(r) = r^{-2}$ and z = r. In the limit of s = 1 once again it would be natural to seek the scaling solutions as F(r;s) = F(rs). It will be straightforw and to nd that the eq.(11) will again governs over F_2 (rs) and the only dimension or signates from the coencient of rst derivative with respect to z = rs which in this case is 2 _2. Using the positivity and normalizability condition of PDF we nd F (rs) = $\exp(z)$ and show that _2 = 5=2 and = 3=2. The exact values of the densitydensity exponents i.e. _2 and _3 are the main results of this part of our work which is derived self consistently.

Since the velocity di erence PDF is the Laplace transform ed of F, one can readily deduce the right tail of the PDF as $\frac{1}{rs} \exp((\frac{u}{rs})^3)$ (for s = 1) in two and three dim ensions and in the lim it $\frac{u}{r}$! +1. This tail has been con med by several other approaches [8,9,15]. Left tail of the PDF is sensitive to the scaling exponent of the density-density correlator and is given by $\frac{1}{(-1)^{(-3-1)}}$ when $\frac{u}{r}$! 1 . At this stage we can not derive the PDF of density uctuation. The reason is that we have only twopoint correlation functions of the density eld while all of m om ents of density eld are needed for this purpose. In the one dimensional decaying Burgers turbulence it has been claim ed that the density PDF would have som e power law tail [12] but this problem is open for the forced case.

III.-PDF'S OF 3D BURGERS TURBULENCE IN NON {UN IVERSAL REGION

In this section we consider the 3{dimensional Burgers turbulence in the non {universal region i.e. ju (x) $u(x^0) j >> U_{rm s}$, and derive the PDF of the longitdinalvelocity di erence and therefore the exponent of velocity structure functions. As mentioned in the introduction recent works [4,5,11,17,18] indicate that in the non-universal region the PDF of velocity di erence depends on the one-point U_{rm s} and therefore is not universalwhich is meant to be sensitive on the details of large scale forcing. This problem is known as the break down of Galilean invariance in the non-universal region. The force free Burgers equation is invariant under space{tim e translation, parity and scaling transform ation. A lso it is invariant under G alilean transform ation, x ! x + V t and v! v+V, where V is the constant velocity of the moving fram e. B oth boundary conditions and forcing can violate som e or all of sym m etries of force free Burgers equation. However it is, usually assumed that in the high Reynolds num ber ow all symmetries of the Burgers equation are restored in the limit r ! 0 and r > >, where is the dissipation scale where the viscous e ects become im portant. This means that in this lim<u>pit the root</u>{mean square velocity uctuations $U_{rm s} = \sqrt[r]{\langle v^2 \rangle}$ which is not invariant under the constant shift V, cannot enter the relations describing moments of velocity di erence. Therefore the e ective equations for the inertial { range velocity correlation functions must have the sym metries of the original Burgers equations. For many years this assumption was the basis of turbulence theories. But based on the recent understanding of turbulence, som e

of the constraints on the allowed turbulence theories can be relaxed [5,11,17,18].

A coording to recent Yakhot m odeling of Burgers and N {S turbulence this symmetry breaks in a hard way i.e. the $U_{\rm rm\ s}$ is entered explicitly in the equation of PDF for velocity di erence. In the following we aim to show how this sym m etry breaks in the sense that the one-point U_{rm s} enters in the argum ent of the PDF in non-universal region. Also since we are interested in the scaling of the longitudinal structure function $S_q = \langle (u(x + r)) \rangle$ $(\mathbf{x})^{q} > \langle \mathbf{u}^{q} \rangle$, where $\mathbf{u}(\mathbf{x})$ is the x-component of the three-dimensional velocity eld and r is the displacement in the direction of the x-axis and the probability density P (u;r) for hom ogeneous and isotropic turbulence. In the non {uiversal region using the eq.(11) one can observe that the PDF for the velocity di erence in the invicsid Burgers turbulence in two and three dimensions satisfy the following closed equation:

where s equal to $\cos($ ') in two-dimensions and $s = \cos = \cos \cos^0 + \sin \sin^0 \cos($ '') in threedimensions. For determining the statistics of the smallscale and the behaviour of PDF in the inertial range, i.e.

<< r << L, we can ignore the forcing term in eq.(19).
The reason for neglecting the force term is that the forcing contribution is in the order of $r^2 = L^2$ so in the inertial
range we can safely drop the corresponding term . How ever we need to consider the e ect of forcing by m atching
the PDF in the inertial range with the PDF in the integral scale. Since we are interested in equation of the
longitudinal PDF we have to consider the above equation in the limit of s ! 1. This limiting is not trivial and
needs to be considered m ore carefully. The contributions
of di erent terms of the PDF equation in the limiting
when s ! 1 is determ ined by the corresponding equation
of the structure function.

A ssum ing that the all of the m om ents of velocity difference exist, the structure functions S_n for given angle (or $s = \cos()$) satis es the following closed equation:

The forcing contribution to the above equation is the last term i.e. $r^3n(n-1)(n-2)(1+2s)S_{n-3}$ and this term has not any contribution in the exponent of structure function. However the amplitude of the structure functions

do depend on the details of forcing. We mean that the scaling (multifractal) exponent of the structure function is not related to the forcing term and is related to the structure of non-linearity and the transverse contributions in the Burgers equation. For solving the eq.(20) one can separate the angular and scale dependent parts of S_n (r;s). The calculations give rise to the result that for s! 1 the structure functions have the following form

where $S_n(r) = \langle u(x+r) u(x) \rangle^n \rangle \langle u^n \rangle$. Factorizing the angle and scale dependences is known also for the N {S turbulence too [11,24]. The proposed form for structure functions dictates that in the limit when s! 1 the probability distribution of velocity increments satis es the scaling form, P (r;u;s) ! $\frac{1}{s}P(r;u=s)$ in a su cient way. It is clear that when s! 1, P (r;u) = P (r; u) and it satis es the following equation in d= 2 and 3-dimensions.

where P is the longtudinal velocity di erence PDF, and B approaches to zero as 0 $(1 \quad s^2)$ and giving address to $_3 = 1$ would give A = 1. The above equation is correct for three and two dimensions and it does not depend on the dimensionality. This form of equation for the PDF has been conjectured recently by Yakkot for the multidim ensional Burgers turbulence [11]. It is noted that the forcing contribution in the above equation is $3r^2 \theta_{11}^3 P$ and it is irrelevant in the sm all scale r ! 0. W e w ill dealw ith the forcing contribution as a boundary condition of PDF in the large scales and this term is responsible for the breakdown of the Galilean invariance. A lso in the nonuniversal region we nd the density-density exponent to be d = d in the two and three-dimensions. Now it is easy to see that the eq.(8) can be written as a scale{ordered exponential:

where L_{KM} can be obtained by computing the inverse operator [34]. Using the properties of scale{ordered exponentials the conditional probability density will satisfy the C hapm an-K olm ogorov equation. Equivalently we derive that the probability density and as a result the conditional probability density of longitudinal velocity increments satis es a K ram ers-M oyal evolution equation:

W here D ⁽ⁿ⁾ (r;u) = $\frac{n}{r}u^n$ [34]. We nd that the coe cients n depend on A and B through the relation $n = (1)^n \frac{A}{(B+1)(B+2)(B+2):::(B+n)}$. The same equation (i.e. eq.(23)) obviously governs over the conditional PDF too but with another boundary condition, i.e. $P(u;rju^0;r) = (u \quad u^0)$. For a simple case we proceed to nd velocity di erence PDF P (u;r) just by using the same line of reasoning and the well known B ayesian rule. So

where P $(u^0;L)$ is assumed a Gaussian in the integral scale. Since

The proposed K M operator has an important property, i.e.

where $_{m}$ is the scaling exponent of the longitudinal velocity di erence S_{n} . Plugging the scale ordered form of the conditional PDF in the eq.(24), we will get:

Expanding the assumed gaussian form of P (u;L) in term s of u and using (26) ends with,

where j = 1. We should stress that the same structure is tractable for the other PDF's in the integral scale other than the simple G aussian form. This result could be derived from eq.(22) by direct calculations even without consulting the KM form of the evolution operator too. This form veri es the proposed form of the PDF in the inner scales where << r << L and resonates with num erical observation in the one dimensional Burgers turbulence [33], where the non-universal part of the PDF

ts with P (u;r) = $rG \frac{u}{b_{rms}}$). The same results was derived recently with additional assumption by Yakhot [11]. An interesting point with respect to the possible G I breaking mechanisms should be referred. In our calculation we have shown that U_{rms} and the one point information has revealed itself because of the matching between the inertial range velocity increment PDF and the integral scale velocity increment PDF. Because the the variance of the velocity increments PDF in the integral scales and for the large L is in the order of the

variance of the one point PDF we observe such a breakdown mechanism even with the lack of the forcing contributions in the L_{KM} . This way of breaking which we would like to call as soft GI breaking can be accompanied with the e ects of the forcing where $U_{rm s}$ will be entered ($U_{rm s} = (k(0)L)^{1=3}$) in the equation of the PDF itself. So the second way of the GIbreaking which may be refered to as a hard GI breaking is linked to the explicit dependence of L_{KM} to k (0). These parts of the K ram ers M oyal operator causes som e scale dependence for the K ram ers-M oyal coe cients and the explicit calculation of the velocity increment PDF in terms of the conditional ones is not a trivial task. The intricate part of the manipulations is related to the non-com mutativity of the GI breaking parts of the evolution operator with the GI invariant parts so that the scale-ordered exponential can not be simply operated on the integral scale PDF.However it has been shown that these parts would cause non-universal behaviours of the amplitudes in the velocity increm ent structure functions. That is for r ! 0,

where $n = \frac{An}{(n+B)} = 1$. This leads to the non-universality of the PDF shapes in the inertial range [11]. In general both of these mechanism sm ay be relevant for the scaling of the inertial range PDF with $u=u_{rm s}$ but their clear roles would be determined by explicit calculations.

The A coe cient in eq.(22) is responsible for the scaling of the structure functions while the B term is an in nitesimal coe cient which its value is responsible for n independence of the scaling exponents. One should note that according to our calculations we have derived the following terms just by writing the whole equation which is governed over the PDF and then taking all the source term s which are proportional to the derivatives of the PDF with respect to the angle s. So it is the most in portant result of our calculations which resembles that without consulting to the conjectures for introducing the scaling terms in the PDF equation all the conjectured terms [11] could be driven just by carefully writing the s dependence of PDF and then taking the $\lim it s ! 1$. So the A term comes out to be d (d 1) = 1 and B term approaches to zero as $1 \quad s$. These are in complete coincidence with the proposed values which was derived in Yakhot theory for the Burgers turbulence [11]. Using the above equations one can show that the S_n (r) scales with rasrⁿ where n = d(d 1) = 1.

A coording to Eq.(16) for the universal part in the three dimensions we have found $_3 = 7=2$ while in the nonuniversal part we have got $_3 = 3$. Comparing the value of the density-density exponent d in universal and nonuniversal regions show sa sm all deviation in the two parts. The dependence of the density density exponent to the speci c parts of the velocity increment PDF would be revealed if one takes a closer look at the original generating function. Considering the eq.(10), g(r) is referring to density-density correlation function conditioned on a

xed value of the velocity increment. So it's scaling exponent should depend on the behaviour of the velocity increment PDF too.

IV . - D ISC U SSIO N

The rst point which we wish to address is the role of viscosity when ! 0 instead of the inviscid limit. It is well known that the viscosity contributions makes the generating function equation to become unclosed . To our know ledge the only method for dealing with the viscosity contribution is the groundbreaking method of Polyakov [5] in the one dimensional forced Burgers turbulence. In this method the overall contribution of the viscosity is assumed to generate some other terms consistent with the sym m etries of the original equations and their presense just renorm alises the term s contributed by advective derivative in the equation of generating function. Boldyrev [18] generalised the Polyakov's method for the Burgers turbulence supplem ented with continuity equation in one dimension by invoking to the same strateqy from which behaviour of the PDF tails in one dim ension was given. Keeping the viscous term in the three dim ensional Burgers equation and with continuity equation we have exam ined the same closure for the viscous contribution. The only relevant term consistent with the symm etries developed as a generalisation of the Boldyrev work [18] is $D_2 = aF_2$ (see [18,19] form ore detail). How ever one can prove that in this fram ew ork the strong constraint of hom ogeniety, i.e. $\langle u \rangle = \langle u (x_1) u (x_2) \rangle =$ 0 will x the value a = 0 [21]. So at least this closure has no contribution in PDF equation and the results will not be di erent from the inviscid calculations.

The second problem which we want to discuss about is related to the density probability function in general. As far as we know there is one simulation being done by G otoh and K raidhnan [12] for nding the tail of the density PDF in one dimension and for the decaying burgers turbulence. For the high density regime they have found a power law tail for the density PDF. It is generally accepted that in one dimension the mass accumulates in the shock regim es and the shock statistics will determ ine the density pro le in the stationary regime. How ever we are not aware of such simulations for the forced problem even in one dimension. In higher dimensions because the nature of the singularities in the velocity ow are m ore involved [30] the simple picture in one dimension regarding the mass accumulation in the singularities of the velocity pro le can not be conducted in a trivial way. A part from the density PDF there is not any simulation for investigating any multi-point corralation function of

the density in higher dimensions. For d = 1 Boldyrev [18] has reported about a simulation on which the exponent of the two point correlation function of the density has predicted to be 2. Any attempt for simulating the forced Burgers equation with the continuity equation would be valuable for clearing out the outcomes of our paper.

In this paper we have proved the Yakhot conjecture about the PDF equation for the multi-dimensional Burgers turbulence. However he has shown that considering В 20 and using the exact result $_3 = 1$ as a boundary condition over nal PDF, the incompressible fully developed turbulence can be modeled [11]. From his theory he nds the multiscaling of fully developed turbulence compatible with the experimental and simulation results. In the centrepiece of that work it is emphasized that the e ect of pressure just renorm alises the values of B and creates the A term which bahave as source and sink. According to our results we have shown that the A term could be generated just by considering the angular dependences of PDF and even without pressure nite scaling exponents are derived and the term s responsible for scaling are present in the equation of the stationary PDF. It would be illum inating to seek whether, entering the e ect of pressure just renorm alises the values of A and B coe cients without adding any new terms in the PDF equation. We beleive that the e ect of pressure in the velocity intermittency can be followed if all the inform ations inherent in the correlations of di erent moments of density eld are given . O ther important perspective which we are pursuing is related to the deformation of transvers structure functions and a clear picture about the transition between the longitudinal to transverse PDF. Consequently this would give a thorough underestanding about the issue of interm ittency in the transverse structure functions [35].

O ur exact results are also appliciable to the description of fractal{nature of Interstellar M edium (ISM) if we accept that the Burgers equation supplemented with continuity eqaution is a good candidate for modelling it [32]. In the framework of the Burgers{turbulence theory of interstellar medium we derive the scaling relation M (R) R^{d_H} for the mass on a region of size R, and the value of the d_H can be predicted in this fram work which is d_H = 3=2. The possible relation of ISM and Burgers turbulence will be disscused elsewhere [36].
