A bstract

In this work we address the feasibility of estimating and isolating the stationary and deterministic content of observational time series, O ts, which in general have very limited characteristics. In particular, we study the valuable earth's surface mean temperature time series, T ts, by applying several treatments intended to isolate the stationary and deterministic content. We give particular attention to the sensitivity of results on the dimentionary and deterministic content. We give particular attention to the sensitivity of results obtained to estimate the stationarity of time series. In order to strengthen the significance of the results obtained we have created a comparative framework with seven test time series of well-know origin and characteristics with a similar small number of data points. We have obtained a greater understanding of the potential and limitations of the diment methods when applied to real world time series. The study of the stationarity and deterministic content of the T ts gives useful information about the particular complexity of global climatic evolution and the general in portant problem of the isolation of a real system from its surroundings by measuring and treating the obtained observations without any other additional information about the system.

1 Introduction

C orrelations in time series have diement origins. The origin of short term correlations of real systems with low-frequency divergences, called 1/fnoise or colored noise, is unknown [1,2]. A rti cial colored noise time series can be generated by introducing in some manner short term correlations into an otherw ise uncorrelated stochastic time series [3]. Strong correlations at all time scales are typical of B row nian motion and can be articially constructed by integrating a stochastic time series that has a G aussian distribution. These diement correlations are very common in nature and compete with the expected correlations generated by determ inistic rules from the continuous processes underlying an O bservational time series (O ts). O ts have in general several important limitations such as a small and sparse number of data points, poor resolution and accuracy, dynam ical and measurement

noise contam ination. Dynam ical noise a ects each time step which may change the nature of the dynam ics itself. C ontam ination with colored noise reinforces low frequencies in the power spectrum producing sim ilar di culties as those encountered when the time span of observation is too short to cover all the characteristic times of the system. W hen contam ination comes from B rownian motion the time correlations extend to most of the data points of the time series and there is no time scale at which the static properties can be estimated. Therefore, the lack of stationarity in 0 ts is a very common problem although, it is in general an implicit condition for the application of most of the methods used to identify and characterize determinism in time scale of observation within which all the relevant processes are followed and su ciently sampled.

The mentioned limitations of most 0 ts combined with the actual complexity of the observed process and the strength of the interactions with other systems, frequently produce e ects that can be seen as contam inations and lack of stationarity. These artifacts of the observation m ay be cleaned in som e extent and hence, important dynam ical inform ation of the process m ay be isolated, characterized and eventually modeled.

From a dynamical point of view nonstationarity may correspond to nonautonom ous systems, changes of the evolution equations, changes of parameters with time, or even changes of the shape of the attractor electively leaving unchanged the dynamical invariants. Therefore, we may be interested in the problem of extracting a meaningful stationary deterministic time series from the original 0 ts. In order to achieve this goal we rst must be able to estimate the stationarity of an 0 ts. Since 0 ts are irreproducible, the importance of stationarity in 0 ts corresponds to the integrity and permanent identity of the system within the time it is observed with respect to the time resolution in which it is observed. Since we do not know a priori the deterministic rules and parameters characterizing the observed system, the 0 ts is considered stationary if probabilities of transition between di erent states of the system are constant during the observed period of time [4]. From a practical point of view stationarity ensures the feasibility of a statistical analysis, since the probabilities are well de ned as occurrence limits [1]. How ever, linear statistics of chaotic time series such as the variance and mean do not approach nite values since they do not have renorm alizable probability density distributions. U sually, 0 ts have small a number of data points and the statistical analysis has in general additional limitations.

An appropriate period of time and frequency of sampling may adequately manage the complex compromise between the system and the observational characteristics and we may consider the 0 ts stationary in practical terms. Unfortunately such particular time \lens" is not easy if ever possible to determ ine, as several coexistent and nonseparable time scales may be involved.

The earth's mean surface temperature time series, Tts, is a particularly complicated case of 0 ts in two ways. As a time series it is a highly contam inated and relatively small set of low resolution data points. From the point of view of the system that Tts represents, the complexity of the underlying process m ay be excessive to be able to be characterized with the available data and the capability of the existing m ethods. However, the fact that each data point is a monthly earth's surface m ean, considerably reduces the space and time scales concerned. Under such conditions m any tem poral and local complex processes of the earth's surface are conveniently rounded out. In this context it m ay be possible to identify certain global low dimensional dynam ics where several complex processes m ake contributions without being direct determ inistic aspects (active degrees of freedom) of such global dynam ics. This perspective perm its to exploit some potential inform ation about the earth's climatic evolution contained in this valuable time series obtained in more than a hundred years of m easurem ent and data processing e ort. Nevertheless, if there is not a particular set of scales and certain treatments perm itting to obtain a time series where the \signal" dom inates the di erent \contam inations" the system is not observable.

Stationarity is a property which can never be positively established in a nite time series. In practice there are some methods which give us partial measures of how strong is the violation of stationarity of a given time series. Contam ination and nonstationarity are not disconnected problems in particular for nonlinear dynam ical systems. In general, for nonlinear time series it is not possible to liter out contam inations without a ecting the actual dynam ics because in some sense most of them are part of the dynam ics itself. Consequently, we must try to measure how robust the dynam ics is to external e ects, how discernible these e ects are from the actual signal and thus, estimate to which extent such dynam ics can be extracted from the 0 ts. For nonlinear system s when nothing substantial is known about the signal nor about the contam ination, we need to characterize the signal and/or the contam ination in some fashion which allows us to di erentiate them by making certain assumptions. However, this goal has not been as successful as in the case of linear system s. There are only general criteria which can be used to distinguish which assum ptions are better than others. For example, in 0 ts of natural phenom ena where in general colored noise is present, it is more e cient to make a local low pass. Iter than to assum e white noise [5].

M ost of the m odem m ethods of nonlinear dynam ics used to study time series involve a reconstruction of the scalar time series into m -dimensional data points in a Euclidean space. A norm is then used to measure distances and geometrical properties of such reconstruction. Embedding is a m ethod to reconstruct the attractor of a system by transforming the scalar time series of observations x_i , i = 1; ...; N, where N is the total number of data points, into m -dimensional reconstructed vectors or points $x_i = (x_i; x_{i+}; ...; x_{i+} (m-1))$, where i + (m-1) = N [5] {[10]. Such a reconstructed vector, , and the embedding dimension m. The demands on are not precisely de ned by the embedding theorem. In practice, for 0 ts, the choice of a correct m ay be very in portant because of the comprom ise between the relevant time scales of the system and the characteristics of the time series. W hen the attractor is correctly reconstructed any static geometrical characteristic of the system can be estimated. The embedding theorem is based on correlations from determ inistic rules

of the system that in principle exist in any macroscopic physical process. In the case of a chaotic system the trajectories remain connect to the attractor after temporal behaviors have died out. This attractor is a static structure, but when the temporal deterministic correlations are a ected by parameter variations or changes in the deterministic rules of the dynamic or any other disturbing correlation, the stationarity of the system may be destroyed and the attractor is not static; it cannot be dened. The maximum norm takes the absolute value of the maximum component as the norm of the vector orm -dimensional point. The maximum norm is very economic in computational time but may involve certain di culties when m is small and the characteristics of the time series are limited as used to be the case for 0 ts. This problem will be discussed within the application of some nonlinear methods to identify nonstationarity in a time series.

The characteristics of the system itself and those of the corresponding 0 ts determ ine how successful and how complicated could be the process of obtaining a meaningful stationary and determ inistic time series from an 0 ts. For nonlinear time series the success in such process has been very limited although, it is in constant development. In order to attempt such isolation for the T ts we have chosen those methods with more general applicability or especially designed for nonlinear time series. Methods based on strong assumptions may generate articial results when applied to 0 ts. A particular limitation of 0 ts is that we cannot manipulate certain parameters such as the sampling time and time span in order to improve stationarity without compromising the number of data points for statistical su ciency and/or reducing the frequency of observations introducing contam inating elects. The methods used to obtain a meaningful stationary-determ inistic time series from an 0 ts can be classified in two groups. First, the methods applied in the time domain:

-Polynom ial detrending which is natural to the time series and do not assume nonstationarity produced by low frequencies as is the case for detrending with dom inant frequencies.

-Low-frequency lter by introducing a decaying m em ory function in an integral-di erential em bedding [11, 12].

-Sm oothing with a di erent num ber of neighbors, or other moving average or FIR Iters, which do not have a direct e ect on stationarity but increase resolution and reduce fast variations [5, 13] { [16]. -F irst di erences of data points removes slow ly varying trends in the time series.

-The method of the correlation matrix liters out noise in the time domain in particular high frequency contaminations [11, 17] [20].

-Noise reduction by nonlinear methods or local maps using neighborhood to neighborhood inform ation [4, 5, 14, 21] [27].

Secondly, methods applied in the frequency domain:

-W indowing or low and high frequency Iters are extensively used [12].

-Hilbert transform by using the FFT which is like the generalized zero derivative also used to interpolate sm all time series [11].

-M aximum entropy or all poles method, also used to detrend time series, estimates the power spectrum by representing the data in terms of a nite number of complex poles of discrete frequency instead of the essential polynomial tused by the Fourier transform, especially useful when the data books very noisy [28].

-Fourier interpolation perm its to extend and clean out the data sets [11, 12].

The most appropriate method or combination of methods which best isolates the stationary determinism potentially contained in a given 0 ts, minimizing the damages of the dynamical information, is not easy to nd and strongly depends on each particular case. For example, if the power spectrum is not small near the N yquist frequency, frequency domain processing is a bad idea and should be abandoned [11]. We may economize a lot of e ort if we make the assumption that the outcom e of the temperature measurem ents of the T ts, or any other 0 ts, is a random variable implying a probabilistic approach which turns out to be very fruitful. However, it will not give as much information of the underlying mechanism s as a deterministic model may give.

G iven the strong di culties to de ne a de nitive method to measure and isolate stationary and determinism in 0 ts, we have performed a comparative analysis of the T ts and several treated T ts altogether with some representative test time series of the same length and well known characteristics. In section 2 we describe the T ts and the test time series. In section 3 we make a short presentation of several methods used to estimate stationarity in nite time series placing particular attention on the problems generated by the limiting characteristics of the 0 ts. In section 4 we present the results of applying several methods of litering and detrending to the T ts. We then, use a weak stationarity criterion in order to choose the most promising treated T ts (T T ts). In section 5 we apply the di erent methods presented in section 3 to the T ts, the test time series and the chosen T T ts obtained in section 4. In section 6 the results are summarized and discussed. In section 7 we present some conclusions.

2 The Tem perature time series (Tts) and test time series

OAK Ridge National Laboratory provides synopsis of frequently used global change data [29]. Of this valuable information, we will use the global temperature anomalies obtained from instrumental surface air temperature records compiled by K.Ya.Vinnikov, P.Ya.Groisman and K.M.Lugina. This data has been mainly taken from the world W eather Records, M onthly C limatic D ata for the W orld, and M eteorological D ata for Individual Years over the N orth H em isphere Excluding the USSR.This information was completed and improved using other data and m ethods that are explained and referred to in reference [29]. The original time series of 1356 data points corresponds to the 12 m onthly m ean tem peratures from 1881 to 1993, in chronological order. This data is given with two decim aldigits of accuracy. For a more detailed discussion of the data and its limitations, noise and possible elects on the estimated averages the reader is referred to the original article of Jones, W igley and K elly [30].

We are going to use seven test time series that willbe identied by the names: Noise, R andom, P noise, C haos, B rownian, E eg and E kg. These test time series, all with the same 1356 data points, have been obtained from CDA pro, a software for nonlinear analysis of time series [31] where m ore details of the test time series can be consulted. Noise is a time series of random numbers with G aussian or normal distribution centred on zero and a standard deviation of 1 called G aussian or white noise. R andom is a time series of random numbers uniform ly distributed. P noise is a time series of random numbers with G aussian distribution centred on zero with 1/f power law. C haos is a time series of the x variable of the Lorenz attractor. B rownian is a Brownian time series generated by the integral of a G aussian noise time series. E eg and E kg are two real world time series with expected nonstationarity. The rst consists of measurements of the voltage in the electrodes of an electrocencephalogram. The second consists of the intervals between successive interbeats of an electrocardiogram.

The 0 ts are real world time series corresponding to measurements of a particular observable of a natural system which in many cases are not repeatable and are irreproducible. They dier from experimental time series because they are not produced by an experimental set up which can be controlled to some extent, and from numerical time series because we do not know the equations which generate them . M any 0 ts, in particular T ts, correspond to system s that never will be in the same circum stances and therefore we have to limit ourselves to observe them as they evolve. We know that no real world system can be completely isolated from its surroundings; to som e extent the environm ent and the observation process are part of the system itself. Sim ilarly, no particular time scale can be completely isolated from the others. Dierent parts of the system evolve at di erent frequencies with complex interrelations but conform ing the sam e dynam ics. In the case of the T ts we have an external periodic forcing force of astronom ical origin, that of the seasonal oscillation determ ined by the earth's orbit around the sun and the tilt of the rotation axis (precession). It is known that strong periodicities tend to hide underlying fractal structures [1, 32] and important nonlinear and potentially chaotic dynamics may not be easily detected. Form ally speaking, a periodic external force acting on the system may be included as a variable recovering a stationary point of view of the system. The importance of the periodicity observed in local seasonal variations of the tem perature is evident. W hat is not so evident is how strong it is in the sense of global earth's surface m ean tem peratures. From the point of view of global m eans these seasonal cycles are indirectly generated by the asymmetry of those geological masses of the earth which perm it the transform ation of the incoming solar energy into therm all energy on the surface of the earth. The most important of such geological masses are earth, sea, ice, clouds and som e factors

related with the existence of life and particularly with hum an activities. These di erent m asses and di erent activities strongly interact in complex ways.

3 Linear statistics and weak stationarity

O ne reason for the actual incapacity to precisely measure the stationarity of a time series is that there is no uniform de nition of stationarity. Loosely speaking, physical stationarity means the constancy of the main features of the system, dynamical stationarity means constancy of equations and parameters involved in an autonom ous dynamical system, and statistical stationarity is de ned for stochastic processes when joint probability functions are independent of time shifted realizations [4, 5]. Nevertheless, these di erent perspectives of stationarity have close links. The determ inistic aspects of a physical system are not condictive with the contemplation of its signal as a realization of a stochastic process on which the statistical stationarity is based. In the language of dynam ical system s statistical stationarity is equivalent to the existence of an invariant ergodic measure [33, 34]. If linear statistics like the mean, standard deviation and variance, estim ated from di erent parts of a time series do not vary beyond statistical uctuations, the time series may be a useful rst indication of it [35, 36]. V ice-versa, weak nonstationarity not necessarily in plies dynam ical nonstationarity, it may be produced for example, by a variety of artifacts in the processes of acquisition and manipulation of data.

We cannot be certain of the e ects of most of the detrending and cleaning treatments on the potential nonlinear dynamical information contained in a Ots. However, we may consider weak stationarity as an initial criterion to assess the elects of dilerent treatments applied to the Tts. W e use the variance V, as the linear statistics which is m ore sensitive than the m ean, m ean deviation and standard deviation but not too sensitive to statistical changes in the time series. The sensitivity of the linear statistics is in portant because of the limited number of data points but can become a problem if the time series is highly contam inated. In order to test weak stationarity we divide each time series in three consecutive and nonoverlapping segments of equal num ber of data points. Comparing the rst with the second segment of the T ts we observe that V changes in 53%, and com paring the second with the third segment and the third with the rst segment, the absolute changes of V are 70% and 26% respectively. These results represent an important weak nonstationarity of the T ts. The time series C haos present good weak stationarity with unimportant variations of V for the three segments of the data. The time series N oise and R andom present sim ilar results. This is expected because these three time series are stationary, determ inistic and stochastic respectively. The time series P noise presents m ild absolute variations of V as expected because of the short term correlations of this stochastic time series. The time series E eg and E kg give the expected weak nonstationarity m ore rem arkable in the second case but, in both cases, it is

considerably sm aller than that of T ts. Table 1 sum m arizes these results.

W ithin this context we have applied several methods to the T ts in order to obtain Treated Tem perature time series, T T ts, with improved weak stationarity. All of the T T ts were divided in three segments and analyzed as mentioned above. Those T T ts which present certain reduced absolute variations of V compared with the corresponding values for T ts, are considered T T ts with improved weak stationarity. We have considered six methods which do not need to make strong assumptions about the system and contam ination of the time series. The rst three methods mainly treat the noise contam ination. The following two methods mainly treat the trends of the time series and, the last method removes slow trends and reduces some noise contam ination. The six methods used (and their parameters) are:

i) Itering with a correlation matrix (the size of the matrix),

ii) sm oothing (num ber of neighbors and variable intensity for dierent parts of the time series),

iii) nonlinear lters (, m and num ber of neighbors),

iv) detrending with the maximum -entropy or all poles method (number of poles),

v) polynom ial detrending (degree of the polynom ial),

vi) and rst dierences.

From an extensive list of more than seventy TTts obtained by di erent combinations of the six methods with di erent values of the parameters involved, we have chosen the 21 TTts with most important improvement of weak stationarity. These 21 TTts are described below from 2 to 22 leaving 1 for the original Tts. The results of weak stationarity are presented in table 1.

T T ts 2 is T ts smoothed with one neighbor considering a decreasing factor from 1 to 0.001 to compensate the assumption that the quality in obtaining and processing the T ts has been im - proved with time.

T T ts 3 is T ts detrended with the maximum -entropy m ethod using 128 poles.

T T ts 4 is T ts ltered with the correlation m atrix where the three dom inant m odes have been used.

T T ts 5 is T T ts 3 sm oothed with the decreasing factor.

T T ts 6 is T T ts 4 sm oothed with the decreasing factor.

T T ts 7 is T T ts 4 detrended with the m ethod of the m axim um -entropy using 128 poles.

T T ts 8 is T T ts 4 detrended with the m ethod of the m axim um -entropy using 128 poles and nally sm oothed with the decreasing factor.

TTts 9 is Tts ltered with the nonlinear method in one dimensional embedding and using two neighbors.

TTts 10 is Tts ltered with the nonlinear method in six dimensional embedding and using four neighbors.

T T ts 11 is T ts detrended with the m ethod of the m axim um -entropy using 128 poles and then litered with the nonlinear m ethod in one dimensional embedding and using two neighbors. T T ts 12 is T ts detrended with the m ethod of the m axim um -entropy using 128 poles and then litered with the nonlinear m ethod in one dimensional embedding and using four neighbors. T T ts 13 is T ts detrended with the m ethod of the m axim um -entropy using 128 poles and then litered with the nonlinear m ethod in one dimensional embedding and using four neighbors. T T ts 13 is T ts detrended with the m ethod of the m axim um -entropy using 128 poles and then litered with the nonlinear m ethod in six dimensional embedding and using four neighbors. T T ts 14 is T ts detrended with a polynom ial of order 2. T T ts 15 is T ts detrended with a polynom ial of order 3. T T ts 16 is T ts sm oothed once and then detrended with a polynom ial of order 2. T T ts 17 is T T ts 4 detrended with a polynom ial of order 2. T T ts 18 is the rst di erences of T ts. T T ts 19 is T ts with a nonlinear liter with embedding 1 and 1 neighbor. T T ts 20 is T ts with a nonlinear liter with embedding 3 and 2 neighbors. T T ts 21 is T T ts 19 detrended with a polynom ial of order 2.

T T ts 22 is T T ts 20 detrended with a polynom ial of order 2.

Som e com m ents about the results of all the T T ts studied are in order to justify the 21 selected T T ts. The best results of weak stationarity using polynom ial detrending are obtained for polynom ials of order two and three, for higher order polynom ials the weak stationarity degrades very fast. Sm oothing degrades weak stationarity when we use m ore than one neighbor. This is an expected result because sm oothing m ainly cleans up hom ogeneously distributed contam inations which is not necessarily the case for nonstationary e ects. In principle the rst di erence of the tim e series gives greater density in phase space and clari es nonlinearities reducing the elects of any short-time linear correlation giving som e tim es the sam e results than the original tim e series [23]. For T ts it clearly in proves weak stationarity but other undesirable e ects are produced by the low accurate and other limitations of such 0 ts. Nonlinear liters have been conceived for potentially chaotic time series and they do not assume any particular know ledge about contam ination. However, the scalar time series have to be reconstructed by an embedding procedure which dem ands inform ation about the dynam ics involved, in particular the embedding dimension which is not easy to estimate for Ots. We have explored nonlinear Iters of Tts with embedding dimensions from 1 to 6. The T T to obtained with a nonlinear liter present in proved weak stationarity for sm all em beddings, in particular for dimension 1 and 3, and for sm all number of neighbors, 1 and 2. For larger values of these two parameters the results degrade quickly. T T ts obtained by combinations of di erent methods in general do not improve the results because of the low resolution and highly contam inated data points constituting the original T ts. The di culty to discrim inate between signal and noise is exacerbated when the T ts is manipulated repeatedly and round-o errors propagate indiscrim inately. Therefore, the pretention to isolate the stationary determ inistic content of a 0 ts by

applying successive treatments on the data may produce the opposite e ect hiding most of such relevant and valuable information.

4 M ethods to estimate stationarity in nite time series

In accordance with the di culties presented above we cannot expect a simplem ethod to diagnose the stationarity of a given 0 ts. Practical and conceptual problem s are all related with the comprom ises between the relevant scales of the observed system and the process of observation. Together with linear statistics, used to estimate weak stationarity, we apply some of the most important methods to identify and estimate the stationarity of a nite time series. We succintely describe these methods giving particular attention to the problem s encountered when we applied them to 0 ts:

1-<u>Polynom ial Fit</u>: The most natural method to identify nonstationarity is the direct inspection of the tim e series, we may identify the presence of trends and bursts. Bursts are very short tim e and large am plitude changes. Such bursts may correspond to faster dynam ics than the tim e resolution of the present tim e series and are only captured occasionally as eventual coincidences. A lternatively, the tim e series under study may have some dynam ical inform ation that can only be captured with a longer period of observation where a su ciently large number of such bursts are included. An evident trend on the plot of the tim e series may correspond to slow variations that cannot be resolved by the tim e spanned by the 0 ts. Trends of a tim e series can be quantitatively estim ated by a polynom ial t and then the tim e series can be detrended by subtracting such t. For an 0 ts we do not know the appropriate order of the polynom ial to be used and we are not certain of the e ects on the nonlinear inform ation of the tim e series.

2-<u>The correlation function</u> or autocorrelation function C (t), is a measure of time correlations between the di erent data points of a time series. C (t) is a linear measure of tem poral correlation in the sense of least squares prediction of data points at time t from the know ledge of data points at a previous time [1, 5]. The correlation time t^0 , is commonly considered the time at which C (t) goes to 1=3 or 1=e of its value at t = 0. When t^0 is larger or on the order of the duration of the time series, it indicates certain nonstationarity. The linear correlation measured by t⁰ is not necessarily the most relevant correlation in a nonlinear dynam ical system [37]. Uncorrelated stochastic time series present the expected t^0 0. The short term correlations introduced into an otherwise stochastic uncorrelated time series to produce articial colored noise time series, is detected by C (t) giving a non negligible t^0 . The continuity and derivativity of dynam ical system s of di erential equations generate time series with strong correlations which correspond to large values of t^0 . These characteristic results strongly depend on the sam pling time or frequency of measurem ents. Chaotic time series obtained from nonlinear systems of dierential equations show in general relatively large t^0 of the order of the inverse of the Lyapunov exponent. However, the corresponding C (t) decreases very fast consistently with the divergent nature of chaotic behavior. The value of t⁰ for 0 ts depends

In some cases C (t) also perm its to identify certain nonstationarities associated with interm ittency if such interm ittency is captured by time correlations of tem poral neighbors in the form of striking recurrent revivals while decaying on the average.

3-The power spectrum (PS), is closely related with C (t). The information provided by these two methods may be very similar in particular for long-time regimes [38]. In the case of 0 ts, the long-time regime is rarely achieved and each method may give dierent information about certain stationary aspects of the underlying system. The standard power spectrum de ned by the squared Fourier transform of the time series can also be de ned in term s of C (t) and both de nitions coincide undermild restrictions given by the Wiener-Khinchin theorem [1]. This coincidence permits to relate fast decreasing behavior in a wide but nite frequency range of PS with slow ly decaying C (t) which is characteristic of long-range m em ory. For this decreasing range, Chaotic tim e series som etim es present exponential behavior while stochastic tim e series present power law behavior [39]. For nite time series this distinction is in general very di cult, in particular for certain colored noise time series because the power spectra is not sensitive to the phase information of the Fourier transform and cannot provide a full characterization of the dynamics. There is not a satisfactory explanation for this behavior of the power spectrum of colored noise [1]. The sam pling theorem due to Nyquist [40] and Shanon [41], gives the conditions under which a continuous signal is completely determ ined by the discrete sampled values constituting the time series. The power of frequencies higher than the Nyquist frequency de ned as the reciprocal of twice the sam pling time must be zero, otherwise the problem of "alising" will be present [42]. To avoid alising we may use a low-pass lter removing high frequencies or, alternatively, increase the sampling frequency. The sam pling frequency m ay be augmented by means of an interpolation method in the time domain or fast Fourier transform -based interpolation [11, 12]. These methods are not strongly recommended for potentially nonlinear time series. Since PS re ects the contribution of all periods from the sam pling intervalup to the total tim e covered by the tim e series and the 0 ts are com m only highly contam inated, it is norm alto have the N youist and higher frequencies sm allbut di erent from zero. This may correspond to a contam ination amplitude from dierent noise sources and not necessary to under-sam pling. Random (in nite) time series such as experimental error and numerical roundo, have an absolutely continuous PS [1]. On the other hand, colored noise has most of its power concentrated in low frequencies. Nonstationarity is commonly present when a considerable part of the spectrum of a time series is in low frequencies in plying that most of the variations of the system have very few oscillations during the observation time, i.e. many relevant times scales of the dynamics are of the order of the total observation time. The low frequencies of the PS can also be a ected by low resolution and slow forcing forces. If this behavior is persistent down to zero frequency, the system will present a singularity of the power spectrum. This nonintegrable PS, whose integral is proportional to the average energy of the system, im plies a nonstationary system

because it is obtaining energy from the outside. However, dissipation may provide the mechanism to generate a stationary low dimensional attractor in state space. The high frequencies of the PS can also be a ected by white noise, short time e ects, fast forcing forces and sub-harmonics. Thus, to improve the stationary dynamical content of a O ts, we should in principle, Iter both extrem es of the power spectrum reducing all possible contam inations and nonstationarity. It is important to remember that for chaotic time series most of the interesting frequencies are low frequencies around the characteristic cycle times and Itering out frequencies a factor of ten greater and a factor of ten smaller than the frequency corresponding to such cycle will work at least qualitatively well most of the time. Such cycle times are unknown in the case of a O ts and are di cult to identify before improving the stationary determ inistic content of the time series.

 $4-\underline{N}$ onlinear Statistics and complexity measures: The convergence of nonlinear statistics is not very well known apart from its very slow convergence making it very di cult to obtain meaningful results for sm all 0 ts. The correlation dimension D_2 [4, 5, 43, 44], is particularly sensitive to nonstationarity from parameter drift and in particular to insu cient sampling. This sensitivity could be useful to estimate the stationarity of a given time series. However, estimates of D_2 are also very sensitive to contamination, accuracy and size of the time series. Estimates of D_2 for sections of sm all 0 ts are therefore very inaccurate and no useful information for stationarity may be obtained from them. The capacity dimension D_1 [4, 5, 45, 46], is less sensitive to the limitations of 0 ts than D_2 . On the other hand, it is not as good an estimate of the attractor dimension. This is because D_1 only captures geometrical information while, D_2 captures geometrical as well dynamical information of the attractor. Initially we have used ve dimensions to obtain a better statistical meaning of the results. The venonlinear statistics are:

i) capacity dimension, D $_1$,

ii) largest Lyapunov exponent, Le [47, 48],

iii) algorithm ic com plexity measured by the Lem pel-Ziv method, LZ [49, 50],

iv) and BDS statistics which measures deviation from pure random ness [51],

v) Hurst exponent, H e, which is a measure of self sim ilarity [52] [56].

5-<u>R ecumence D ensity P lots</u> (RDP): Recurrence plots were introduced to identify nonstationarity in a time series when the underlying dynam ical system is not autonom ous (time appears explicitly in the evolution equations), and when the characteristics times of such systems are of the order of the length of the time series [57]. Later works have extended the utility and applicability of such plots [58]{ [60]. In particular there is strong evidence, although not yet form ally proved, that m ost of the qualitative as well as quantitative results do not depend on the embedding parameters at least for

em bedding dim ensions sm aller or equal to 3 [59, 61]. This is a very interesting result because good estim ates for the embedding parameters are not easily determined from Ots. We have veried this hypothesis with the time series C haos with embedding dimensions from 1 to 5, and with the T ts for embedding dimension from 1 to 4 and time delays 1 and 9 sampling times where 9 corresponds to the rst m in in um of the average m utual inform ation [5, 62]. Only sm all num erical variations have been observed. The density of distances, trend or recurrence density plot RDP [57, 58], is a kind of recurrence plot which measures the number of pairs of points within a threshold distance (10% of the range of the time series), as a function of their tem poral separation. The RDP is particularly useful for 0 ts because their characteristic sm all num ber and low accurate data points m ake it very di cult to observe patterns and varying densities in a traditional two dimensional recurrence plot. For an autonom ous system with short characteristic times compared with the length of the time series, RDP must look globally constant. This global behavior may be superimposed to a smaller time scale structure which would correspond to cycles of the system. These cycles must be much sm aller than the length of the tim e series in order to indicate stationarity. For a nonstationary tim e series RDP would present an overall decreasing behavior.

6-<u>Cross Prediction Error</u> (CPE): The nonlinear cross prediction method was introduced by Schreiber in 1997 [63]. Thism ethod has a very in portant conceptual contribution because it is based on the sim ilarity between sections of the time series itself rather than sim ilarity of certain statistics estim ates from di erent sections of the tim e series. Thism ethod m ay be qualitatively independent of the particular statistics used. This method is particularly useful when the nonstationarity emerges from changes of the shape of the attractor while dynam ical invariants remain e ectively unchanged [4, 63]. Thism ethod has the practical advantage of a sm all dem and of data and m ore robustness to contam ination. This is because it com pares the data with itself using all of the data points and may use nonlinear predictions which dem and rather short segments of data points. The nonlinear cross prediction m ethod generates a plot of nonlinear C ross P rediction E rrors (CPE), with two indices indicating the predicted and predictee segments of the time series used in each estimate. In this context the predicted segment is used to construct m -dimensional vectors and the predictee segment is used to construct the neighborhood for a locally constant approximation [63]. The whole time series is divided into equal, consecutive and nonoverlapping segments of length 1. 1m ust be larger than the characteristic times of the process where all the typical cycles of the system are completed several times. For stationary time series and an appropriate length for 1, we expect that CPE is independent of the indices. A purely random time series must present large and hom ogeneous CPE for all combinations of segments. Time series with correlations from deterministic, or any other origin, may present certain patterns in the CPE which depend on l and indicate the time length of such correlations. This method has the disadvantage of having four parameters and the results of the method may be very sensitive for some ranges of their values when applied to 0 ts. These four parameters are the size of the segments 1, in which the time series is divided, the distance to

determ ine the neighbors of a given data point, , and the two reconstruction parameters, the time lag , and the embedding dimension m. The sparseness and resolution of the data are very important for the rst two parameters. The range of CPE evidently depends on the range and resolution of the data points. The compromise between and the density of data points is important because it determines the number of neighbors from which the prediction is going to be made. If is small and the time series is dense the situation is ideal but, if the data is sparse we may not nd close neighbors. If and lare large and the data is dense we may be using neighbors from dynamically di erent parts of the system and confusing results can be obtained. O ts are in general sparse time series therefore, cannot be small and 1 cannot be large and we cannot easily reduce the risk of making predictions with points from dynam ically di erent periods of the time series. If is too large the predictee interval dom in the results of CPE and no inform ation is obtained from the predicted interval. When the studied time series is from a known system these problems can be avoided by considering the characteristic cycles involved.

7-The Space Time Separation P lot (STSP), was introduced by Provenzale et al [3]. It can be used to estim ate the correlation time of a scalar time series. This is made by comparing geometrical and tem poral correlations giving inform ation about the stationarity of the time series. ST SP is robust to most of the limiting characteristics of 0 ts and has been used to obtain good geom etrical estimates such as the correlation dimension. ST SP measures the elects of time correlations on the probability of nding two points within a given distance. In practice, ST SP estimates the correlation times existent in a time series by measuring the spatial distance to be covered in order to nd certain predeterm ined proportion of points for di erent tim e separations [4]. If such spatial distance does not saturate for increasing time separation, all the data points of the time series are temporally correlated and no stationarity can be obtained for any time scale. If saturation is obtained for a certain time separation the time series can be considered stationary for time scales larger than this time separation. Despite the general robustness of ST SP with respect to the conditions in posed by 0 ts, the method is very sensitive to the percentage of points and the size of the spatial partition. These two parameters give the resolution of the plot to resolve the actual behavior from numerical variations. As a scatter plot of the spatial separation versus the time separation between points, ST SP must not depend strongly on the embedding dimension m [59, 61]. It was rst veried with the results for the time series C haos where only small num erical variations were observed as m was varied. The cycles of the Lorenz attractor around the two xed points are seen as certain periodicity of the STSP on the order of 14 sam pling times, see gure 5a. For 0 ts with low sam pling rates we can eventually nd near returns closer to a given point than its dynam ical next neighbor. In this situation the nonstationarity of the time series given by long term correlations cannot be detected by the ST SP, i.e. the plots saturate fast and rem ain constant for any value of time. For O ts with low resolution data points it is still easier to nd return points and even in the case of short 0 ts the ST SP m ay not be able to detect nonstationarity for long correlation times.

We now mention some other important methods that are not going to be used in this work:

i) C om parison of di erent linear or nonlinear tests for several consecutive and overlapping segm ents of the tim e series increases the number of data points but the independence of each segment is reduced [34, 64, 65]. These strategies m ay not give useful results when applied to 0 ts with a sm all number of data points.

ii) The concepts introduced by the nonlinear cross prediction m ethod can be applied in di erent form s and w ith di erent statistics. For exam ple, the identi cation of neighbors to m ake the nonlinear prediction can be weighted w ith di erent criteria [23, 66]. How ever, these criteria are not general and m ay work for particular situations which m ust be identi ed in advance depending on the know ledge of the system which is not available for m ost 0 ts.

iii) The surrogate data m ethod to evaluate the results of nonlinear analysis of time series has been tested against non-stationarity, in particular for cyclostationarity [67]. Surrogate data is a robust m ethod of general applicability that could be exploited in order to test m ore directly the stationarity of 0 ts.

iv) An important method to test stationarity in time series that has not been applied in this work uses the information in the time distribution of points in a state space reconstruction [68]. The need of accurate estimates of the embedding parameters makes this method potentially problematic for 0 ts. Another related method based on time domain information in reconstructed phase space [69], presents no qualitative dependence on the embedding parameters and seems to work well for small time series. These are two important desirable qualities for a method used to estimate stationarity of 0 ts. These methods have to be included in further analysis to understand 0 ts and in particular T ts. However, it is important to measure their sensitivity to contamination, data resolution and other important limitations of 0 ts.

v) Two novelm ethods to test stationarity in time series may give relevant results when applied to 0 ts. They involve wavelets multi-scale ideas which are natural tools to study stationarity [70] and, powerful and well-studied data compression techniques which are robust to noise [71]. W avelet transform s can also be used to remove nonstationarity from time series that were a ected at certain species that were a scales of time scales by some particular circum stance [72]{ [74].

5 Results

The results obtained with the test time series give validity to the algorithm sused for each method. These results also contribute to de ne a practical framework for the interpretation of the sensitive results corresponding to T ts and the diment T T ts.

<u>Polynom ial</u> t: The value of the linear and quadratic constants in a polynom ial t give a quantitative m easure of the trend of the analyzed time series. If these values are large com pared to the range of the time series, the linear and quadratic corrections are important com pared with a detrended behavior. The stationary stochastic tim e æries N oise and R andom present the expected sm all values and no evident trend is observed. The real world tim e æries E eg and E kg do not present clear trends, only in the second case a sm all trend is observed. The stationary chaotic tim e series C haos presents a negligible trend probably caused by the sm all size of the tim e series. The nonstationarity of the tim e series P noise and B row n ian is evident with large linear and quadratic constants. N o trends are observed for the T T ts 2,3,7,8,11,12,13,14,15,16,17,18,21 and 22. Evident trends exist for T ts and T T ts 4,9,10,19 and 20 which were not detrended by any m ethod, only

Itered. T T to 5 and 6 present less evident trends. In table 1 column 5 we give a quantitative measure of the trends for all of the studied time series consisting on the maximum di erence between the average value of the time series with the polynomial t. This value is given as a percentage of the total range of the data of the corresponding time series. A part from the time series B row n ian and P noise which present very large constants in the quadratic term of the polynomial t, all other time series studied present alm ost linear trends when nonnegligeable.

<u>Correlation function</u>: In table 1 column 6, we present the results of the correlation time t^0 in units of the sam pling time, for the seven test time series, the T ts and the 21 T T ts. The continuous determ inistic origin of the time series C haos generates a correlation, $t^0 = 5.99$, which is small enough to be consistent with the chaotic nature of the time series. The real world time series E eg and E kg present sim ilar values t^0 = 5.62 and 7.12, respectively. The correlation time of the stochastic but tem porally correlated time series P noise is of the same order of magnitude with a slightly larger value, $t^0 = 11.33$. The tim e series B row n ian presents a very large correlation tim e, $t^0 = 169.37$, consistent with the construction of such stochastic time series. The stochastic and uncorrelated time series R and om and N oise present the expected result t⁰ 1 and C (t) 0 for all t > 1.T ts presents a large correlation time $t^0 = 76:58$. The low resolution of the data points of T ts m ay produce apparently long term correlations as measured by C (t). The TTts 2,3,5,6,7,8,11,12,130 for allt > 1. Theand 18 have all stochastic uncorrelated-like behavior with t^0 1 and C (t) treatments to obtain TT ts 4 and 10 increase the value of t⁰ obtained for T ts and that of TT ts 20 leaves it unchanged. The rest of the TTts: 9,14,15,16,17,19,21 and 22 present t⁰ values close to those of the time series C haos, P noise, E eg and E kg.

<u>Spectral analysis</u>: The ve test time series C haos, P noise, B rownian, E eg and E kg, and the T ts present very sm all or zero dominant frequency depending weakly on the number of poles used in the minimum entropy method. The time series N oise and R andom do not present a dominant frequency. M ore quantitative information is obtained from the cumulative periodogram which is the integral of the power spectrum over frequency. A cumulative periodogram following the 45-degree line, as is the case for the two uncorrelated stochastic time series N oise and R andom, indicates the atness of the spectrum. The other ve test time series present far from 45-degree line periodogram s except for the tem porally correlated time series P noise which is clearly closer but not along this line. The periodogram for T ts is far from the 45-degree line being an important

qualitatively di erence with the tim e series P noise. The T T ts 2,3,5,6,7,8,11,12 and 13 present a at power spectrum veried by the cumulative periodogram following the 45-degree line characteristic of uncorrelated stochastic time series. The procedures generating the T T ts 4,10,19 and 20 do not produce any identiable di erence of the power spectrum compared with that of the Tts. The power spectrum of the remaining TT ts 9,14,15,16,17, 21 and 22 present sm all changes com pared to that of the T ts with the exception of T ts 18 where the periodogram is inverted. In table 1 column 6 we summarize these results qualitatively by using C for curved or far from the 45degree line periodogram s and //" for periodogram s along this line. W hen the periodogram of a T T ts gets closer to the 45-degree line than the periodogram of the T ts, this m ay indicate that the corresponding treatment generates some losses of the potential dynamical information contained in Tts. The case of Tts 18 presents a strongly dam ped power spectrum in low frequencies with most of the power concentrated in high frequencies. This increases the possibilities of stationarity but also indicates an increase of contam ination probably introduced by num erical round-o and the low accuracy of T ts. The dom inant frequency remains zero only for the T T ts 4,9,10, 19 and 20. The T T ts 14,15,16,17,21 and 22 have a dom inant frequency 1=50 of the Nyquist frequency. Except for TTts 18, the remaining TTts present no dominant frequency and a at PS. The dominant frequencies are presented in table 1 column 8. The linear decay in a log-linear scale of the power spectrum corresponds to exponential decay in linear-linear spectrum frequently associated with a chaotic time series which is clearly observed for the time series C haos. This characteristic is hard to precise objectively for 0 ts but certain tendency can be identi ed. The TT ts 4,14,17, 21 and 22 present an improved linear decay compared with that of the Tts. For the test time series the two extrem es are clear, linear decay for the time series C haos and a at PS for the uncorrelated stochastic time series N oise and R andom . For the correlated stochastic time series P noise, T ts and the real world E eq and E kq the behavior of PS is between these two well de ned behaviors with a certain power law or 1/f spectrum. The problem of alising and therefore, the applicability of the sampling theorem, has been apparently solved for all of the studied time series except for T T ts 18. As far as stationarity is concerned we are more interested in the low frequency part of the power spectrum where we can observe indications of the problem s of low sampling and slow trends.

<u>Nonlinear statistics and complexity measures</u>: A s anticipated, the small size of the time series studied in this work do not perm it to obtain signi cant results for stationary analysis using nonlinear statistics on sections of such small time series. Only for the Lem pel-Z iv complexity measure (LZ), Hurst exponent (H e), and the BDS statistics (BDS), we have obtained certain results that deserve to be mentioned. The seven test time series present the expected results with acceptable accuracy giving some validity to the results obtained for the T ts and the T T ts. These results are presented in table 2 for the whole time series and the corresponding rst and second halves indicated by I and II respectively. The uncorrelated stochastic time series N oise and R andom have LZ 1,

Нe 0 and BDS << 0. The correlated time series Phoise has LZ 0:8, H e 0:16 and BDS 0.5 which indicates a less complex time series, more self-similar and less stochastic than the two previous time series. The long term correlations of the time series B row nian reduce the com plexity of the otherwise uncorrelated stochastic time series to LZ 02, increases self-sim ilarity 0:5 and destroys its stochastic or random nature to BDS 2:0. The time series C haos is toНе 02, strongly self-sim ilar H e 0:5 and clearly nonrandom BDS 0:6 > 0.much less com plex LZ The two real world time series E eg and E kg give sim ilar results with m ild com plexity LZ 0:5, relatively strong self-sim ilarity H e < 0:4 and clearly nonrandom BDS 0. The di erent results for the whole time series and the corresponding two halves are consistent within (large) statistical variations. However, the small number of data points used in all cases, in particular when half time series are considered, do not perm it to resolve the sensitivity of these statistics to stationary changes from the statistical variations. The results for T T ts 2, 3, 5,6,7,8,11,12,13 and 18, and less clearly for T T ts 9,19,20,21 and 22, present very close results to those characteristics of stochastic time series. That is LZ 1,He 0 and B D S 0 for the three values corresponding to the whole and two halves of each TTts. The Tts and TTts 4, 10,14,15,16 and 17 de nitively survived the stochastic classi cation from the nonlinear statistics point of view.

<u>Recurrence Density Plots</u> (RDP): The test time series C haos, P noise, N oise, B row nian and R andom present the expected results for the RDP. The stationary time series C haos presents constant global behavior superim posed to a fast oscillation of large am plitude and period of 14 sam pling times. This oscillation corresponds to the wandering of the trajectory from one symmetric spiral to the other around the two xed points of the Lorenz attractor. The time series N oise and R andom present also a constant RDP but no structure of any scale can be identified aside from random and fast variations of sm all am plitude. The time series B row nian presents very large RDP for short times with a very fast decreasing am plitude as time increases, as expected from the correlations of such time series. The time series P noise present a decreasing RDP revealing the tem poral correlations introduced in this otherwise stationary stochastic time series. The two other real world time series E eg and E kg present an overall constant RDP which corresponds to stationarity from the point of view of this analysis. In both cases, although m ore evident in the case of E eg, a sm aller structure is superimposed without well de ned cycles or periods. Som e representative RDP of the test time series are presented in gure 1.

The RDP for the T ts presents very clear nonstationarity with monotonic decreasing behavior superimposed to a small structure with no clear periods. The twenty one T T ts can be divided in three qualitatively similar groups. The rst group conformed by T T ts 2,3,5,6,7,8,11,12 and 13 present a stationary-like RDP with some superimposed structure more evident in some cases than in others. This small structure is particularly evident in T T ts 6 with a relatively well de ned period of 100 sampling times or monthly measurements, i.e. between 8 to 9 years. From this group of nine apparently stationary time series the short time structure is particularly noise-like for the

T T ts 7, 8 and 13. The T T ts 18 has slow decreasing RDP with a strong noise-like sm all variations. The second group is given by T T ts 4,9,10,19 and 20 which seem s clearly nonstationary with m inor di erences compared to the corresponding RDP of the T ts. The third and m ost interesting group is given by T T ts 14,15,16,17,21 and 22. These six time series present good stationarity from the RDP point of view, in particular for T T ts 21. The other ve T T ts present slightly decreasing trends. A ll six T T ts of the third group present relevant sm all structure without well de ned periods but clearly discrim inable from noise-like behavior. Representative RDP of the three groups of T T ts and T ts are presented in gure 2.

<u>Nonlinear Cross Prediction Error</u> (CPE): Nonstationarity in a determ inistic time series may be identied by overall trends in the CPE, as the predicted and predictee segments correspond to more and more distant parts of the time series. The time series B row nian shows the largest range of values and variability of CPE. For the time series N oise and R andom, we get large CPE with a hom ogeneous random appearance. These two characteristics of CPE are representative of uncorrelated stochastic time series because it is irrelevant which seem ents are used as predictee and predicted. In the case of the time series P noise and B row nian CPE is in general large with clear patterns of valleys and crests indicating the corresponding correlations, which are more remarkable in the second case. For the tim e series C haos CPE is in general small with regular patterns indicating perm anent correlations due to stationary determ inism . Increasing trends indicating param eter drifts or changes in the form of the attractor are not observed in the time series C haos, as expected. In all cases the results are not qualitatively a ected by the values of the embedding dimension from 1 to 6. The realworld time series E eg and E kg present the determ inistic characteristic of patterns with general small CPE and do not present clear evidence of nonstationarity like increasing trends as predicted and predictee segments get further apart. However, for these two time series the results are much more sensitive (than the other test time series), to the parameter and the uncorrelated stochastic appearance is easily obtained. For T ts the results are also very sensitive on the param eter although, strong indications of the mentioned determ inistic characteristics persist. The CPE plot for T to presents four characteristic regions determ ined by the two halves of the T to when we use them as a prediction or to be predicted alternatively. The st half is not good for prediction and sim ilarly bad predictions of it are obtained. The second half is good to make predictions and good predictions (sm all CPE) of it are also obtained apart from the last two or three segments which present larger CPE. These are consistent results with the fact that the rst half of T ts is m ore contam insted than the second, and the last part of the second halfm ay present strong trends. These results are also consistent with those of nonlinear statistics which give indications of less determinism for the rst half of T ts.

For all time series studied with 1356 data points, we have used 20 nonoverlapping sections which corresponds to 1 67 data points. For the time series C haos 1 67 data points is a time length larger than the \coherence time" of the Lorenz attractor, 14 sam pling times identied by the RDP.

For the rest of the studied tim e series 1 67 data points seem s to be a good com prom ise between the sam pling tim e and the length of the tim e series. Sim ilarly to T ts, the two groups T T ts 4, 9, 10,16, 17 and 19, and T T ts 14, 15, 18, 20, 21 and 22 present relatively large ranges of CPE with clearly sm all regions. The second group looks slightly m ore stationary with less trends and is less sensitive to . The remaining T T ts 2, 3, 5, 6, 7, 8, 11, 12 and 13 give CPE with hom ogeneous random variability with no patterns and no predom inantly sm all regions, i.e. uncorrelated stochastic-like behavior. From the point of view of the CPE, several of the treatments applied to T ts to isolate the determ inistic inform ation produces the contrary e ect and noise-like tim e series are obtained as mentioned above. W hen this was not the case, the apparently nonstationarity of T ts was in som e cases reduced, in particular for T T ts 9, 10, 14 to 22. In gures 3 and 4 we present representative CPE plots for T ts, som e test tim e series and som e T T ts.

For all time series studied in this work the sensitivity on seems to depend strongly on the complexity of the system as well as on the characteristics of the time series. A smore determ inistic or correlated and contam inated is the time series more sensitive to it is and more easily it gives uncorrelated stochastic-like results. However, = 40% of the range of the time series, works in general well and allows as to compare all of the time series on equal footing. The results of CPE were in all cases weakly dependent on small values of m, between 1 and 3, when = 1 [61].

Space T in e Separation P lot (STSP): The stationary and determ inistic time series C haos num erically generated with well known geom etrical and dynam ical characteristics, using an appropriated sam pling time and good resolution of eight digits data points perm its to su ciently sam ple the attractor avoiding large tem poral correlations. For the tim e series C haos all the curves of the STPS corresponding to di erent percentages, start at zero and then a regular oscillation, without any trend, is observed for increasing time. Since the cycle length of 14 sampling times, is much smaller than the observation period, 1356 sampling times, the oscillation is harm less. We are interested in the steps where the plots increase consistently revealing the length of the tem poral correlations [3, 4]. The time series N oise, R and om and P noise show the expected saturated behavior corresponding to stochastic uncorrelated time series. In these last three cases the ST SP saturates very fast and no other relevant behavior apart from num erical oscillations is observed. The only observable di erence is for the STSP of the time series P noise with a slightly slower saturation behavior which corresponds to the short time correlations involved in such time series. The STSP for the time series B row nian present small num erical variations and no saturation at any time is obtained representing the long term correlations of this time series. The results for the time series C haos are qualitative invariant under changes of the embedding param eters for m = 1 to 7 with m = 1, for m = 1 to 4, for m = 2 to 4, and a wide range of distances used to de ne neighbor points.

The ST SP analysis of the time series E eg and E kg does not show clearly the otherw is expected nonstationarity because the sampling time and time span of these time series have been controlled

for this purpose. The corresponding plots saturate relatively fast but slower than the time series Noise and Phoise representing certain correlation present in these real world time series. The ST SP for the T ts shows good stationarity after a correlation on the order of 10 to 15 sam pling times, corresponding approximately to one year. The relatively long time between measurements and low resolution of the T ts m ay be important reasons for such short time correlations. The results of the ST SP for the T ts are also robust with respect to di erent embedding dimensions and small values of the time delay . For 3 the results are strongly altered which is expected for these sparse time series because the time scales are importantly changed when becomes large. For all T T ts the results of ST SP are similar to those of T ts. In the cases where T T ts were obtained by treatments which explicitly damp high frequencies or short term correlations as TT ts 3,7,8,11,12 and 13, STSP presents faster saturation although, those STSP are di cult to di erentiate from those corresponding to uncorrelated stochastic time series. In gures 5 and 6 we present some representative STSP and the approximately saturation times of all the studied time series are presented in table 1 column 9. Since we are mostly interested in the qualitative behavior, we chose a set of param eter values around which the results of ST SP are robust to param eter variations and represent well the characteristics of the corresponding time series. We can then compare the results of the dierent time series on similar footing. For gures 5 and 6 we have x = 1, m = 1 and 1=10 of the maximum number of spatial partitions that each time series supports (given by the range of the data points divided by their resolution), as the spatial partition used to select near neighbors.

Form ally speaking, for a strongly stationary time series the results obtained with dimensional odds that use some kind of statistics to estimate stationarity, must not depend on the embedding parameters. This is because in dynamical systems strong stationarity means that in each conceivable embedding space the statistical properties of the phase ows referring to dimensional valuable stationarity, the estimates of such stationarity may depend on the embedding parameters (at least for values beyond certain ranges), among others aspects of the particular system and the time series at hand.

6 Summary and Discussion

From inspection of the plot of the data points as a function of time and from all the seven methods applied to estimate stationarity, none of the studied time series presented indications of bursts as evidence of possible intermittency. Of the seven test time series only P noise, B row nian, E eg and E kg presented trends measured by a polynomial t of order two. Indications of nonstationarity given by relatively large t⁰, larger than 10 sampling times, are evident for the time series P noise and B row nian. The real world test time series E eg and E kg have t⁰ similar to that of the time

series C haos which may be representative of certain determ inism. Indications of nonstationarity represented by dom inant low frequencies persistent to zero frequency in the power spectrum (PS), are observed for the test tim e series B row n ian and less clear for the tim e series P noise, E eg and Ekg. The dom inant low frequency PS of the time series C haos is not persistent to frequency zero corresponding to a stationary-like nondivergent PS. The time series N oise and R and om have the expected at PS with no dom inant frequency and present the stochastic characteristic t^0 1 and 0 for all t > 1. Qualitatively, PS for the time series E eq and E kg seems to be between C (t) the power law behavior of the time series P noise and the exponential behavior of the time series C haos with a nonzero dominant frequency. Its present clear evidences of nonstationarity with a marked trend and a large correlation time t^0 76 sampling times. The power spectrum of the T ts is very sim ilar to that of the tim e series P noise and persistent to zero frequency as another strong indication of nonstationarity. However, the periodogram of the T ts di ers im portantly from that of the time series P noise although, in the direction of the time series B row nian. We recall that these two correlated stochastic time series are very common in nature and can dom inate the dynamical information of 0 ts.

The twenty one T T ts selected by their in proved weak stationarity compared with T ts, present interesting and varied results. T T ts 4,9,10, 19, and 20 were not explicitly detrended by any method and present the expected similar nonstationary results to T ts with evident trends and t⁰ larger than 10 sam pling times. T T ts 14, 15, 16, 17, 21 and 22 have $1 << t^0 < 10$ indicating better stationarity and determ inistic-like correlations. The remaining ten T T ts have t⁰ 1 and C (t) 0 for all t> 1 characteristic of uncorrelated stochastic time series. The periodogram s of the T T ts 2, 3, 5, 6, 7, 8, 11, 12 and 13 are all along the 45-degree diagonal also characteristic of uncorrelated stochastic time series. From the remaining T T ts only T T ts 4, 10, 19 and 20 present dominant low frequencies persistent to zero frequency which is an indication of nonstationarity. Therefore, the T T ts 14, 15, 16, 17, 18, 21 and 22 seem to be determ inistic and stationary from a linear point of view given by PS and C (t).

The results of the nonlinear and com plexity measures of such small test time series verify but do not demonstrate the corresponding stationary and determinism or stochastic nature of the vetest time series C haos, N oise, P noise, B row nian and R andom. The real world test time series E eg and E kg present indications of determinism and in the rst case certain stationarity depending the method used. In the qualitative framework de ned by these results of the nonlinear statistics for the test time series, T ts presents indications of determinism, or at least indications of correlated nonstationary time series with in portant di erences between the rst and second half. Notably, the rst half of T ts is more uncorrelated and the second half is less stationary. The two groups T T ts 2, 3, 5, 6, 7, 8, 11, 12, 13 and 18, and T T ts 9, 19, 20, 21 and 22, present uncorrelated stochastic-like results which are less evident for the second group. The remaining T T ts seem more deterministic but their indications of stationarity vary and depend on the nonlinear statistic used.

Nom eaningful conclusions of stationarity can be made from the results of nonlinear statistics.

The nonstationarity originated by nonautonom y or by characteristic tim es of the system of the order of the tim e span of the tim e series specially identied by RDP, are not observed for the tim e series C haos and the expected overall constant RDP is obtained. A part from the real world tim e series E eg and E kg, the other four test tim e series also present the expected results. The stationarity of these two real world tim e series has been in proved by choosing a short enough tim e span of the tim e series to reduce nonstationary e ects of larger tim e variations. For T ts we do not have the possibility of adjusting the tim e span without reducing the already small number of data points. Therefore, the clear nonstationarity observed in itsm onotonically decreasing RDP cannot be avoided nor even reduced in this way, the tim e series has to be treated. The apparently stationarity observed in the RDP of the T T ts 2, 3, 5, 6, 7, 8, 11, 12, 13 and 18 corresponds to the uncorrelated stochastic-like tim e series to which T ts was reduced to by the corresponding treatments. In the case of T T ts 4, 9, 10, 19 and 20 the nonstationarity of T ts has not been in proved from the point of view of the RDP. The remaining T T ts 14, 15, 16, 17, 21 and 22 present in proved stationarity without becoming uncorrelated stochastic-like tim e series.

The comparison of the results of CPE for the seven test time series with those of the T ts, permits us to interpret the CPE corresponding to T ts as a possibly determ inistic but nonstationary time series in its second half. The rst half has strong indications of weakly correlated stochastic time series as a possible consequence of dom inating contam inations. The T T ts with better stationary determ inistic indications from the point of view of the CPE are 14, 15, 18, 20, 21 and 22. In all of these cases the nonstationarity of the T ts has been reduced in 50% to 80% by comparing values of CPE.

From the point of view of the ST SP and with the exception of the time series B row nian which does not saturate at any time, the remaining six test time series can all be considered stationary when temporal correlations smaller than 20 sampling times are nuled out. Very small saturation times are characteristic of uncorrelated stochastic time series. ST SP identify short term correlations but it does not easily identify long term correlations mostly generated by oversampling and certain contaminations. Thus, the long sampling time and low resolution of the T ts may be some of the reasons why the corresponding ST SP does not saturate for longer times. The results of ST SP for all T T ts are therefore very similar to those of the T ts.

7 Conclusions

The limited capacity of obtaining good estimates of stationarity with the dimentering applied to T ts, has been qualitatively improved by the framework of reference given by the test time series and the T T ts. The characteristic limitations imposed by 0 ts and in particular by T ts, do not permit to obtain quantitative and precise meaningful results from a detailed analysis of such

time series with any particular method. Therefore, the construction of a qualitative criteria with increasing accuracy as more information is acquired, may provide a quantitative measure with a de ned accuracy as is the spirit of the statistical perspective. The formal and intuitive arguments relating the problem s of contamination and stationarity has been observed in the concrete case of T ts. The intended goal of obtaining a meaningful stationary and deterministic time series from an O ts, in particular T ts, becomes a conlict between the two desirable qualities of the treated time series. This problem becomes evident when we lose deterministic content by applying some treatments to liter noise and in prove the stationarity of the T ts. The T T ts 2, 3, 5, 6, 7, 8, 11, 12 and 18 are clear cases of this situation as indicated by most of the analysis performed. The most successful results have been obtained by combinations of polynomial detrending with smoothing,

Itering with a correlation m atrix and in particular with nonlinear local Iters. The combination of m ethods which give the best results correspond to T T ts 21, 22, 15, 14, 17 and 16 with decreasing quality as indicated by m ost of the m ethods utilized. From these results we corroborate that weak stationarity is not always a clear indication for all the possible origins of nonstationarity considering the strong limitations in posed by the characteristics of 0 ts and particularly for T ts.

On one hand, the conjective problem of improving stationarity and reducing contamination in a O to is closely related with the complexity of the underlying process, its interactions with other processes and the variety of time scales involved. It may not be possible to solve this problem appropriately. On the other hand, such a conjective situation could strongly depend on the process of observation, in such a case certain treatments of the O to under study may produce a meaningful deterministic and stationary time series with important dynamical information about the underlying dynamics.

The stationary and determ inistic content obtained for som e T T ts is not completely clear and de nitive but, it has been in proved compared with T ts. The interpretation of the di erent T T ts, and to which extent they are meaningful in provem ents of the dynam ical information of the original T ts, are not problems that can be solved without a deep understanding of the phenom enology of the system involved. The goal is to reduce the possible explanations from a point of view which manages to capture certain exploitable determ inistic characteristics of the O ts under study; the T ts is the illustrative case. This perspective may provide new and complementary information looking toward a progress in the understanding of such complex system s and their corresponding O ts. The use of new and in proved already existing methods to measure determinism and stationarity in apparently stochastic time excise, will eventually uncover characteristic features of a particular O ts. This work is an initial e ort intended to contribute in the de nition and limitations of such an ambitious goal as a part of m any e orts currently in progress with di erent perspectives. This new perspective pretends to create a meaningful fram ework of applicability of in portant and mature methods to O ts which have been extensively tested in situations where in portant know ledge of the system and good quality of the corresponding time series are available. In such cases the correct application

and interpretation of results of the di erent m ethods are fairly unam biguous although, there are a lot of im provem ents and new ideas to be developed.




Figure 1: Recurrence Density Plot (RDP), for some test time series. The plot indicates the proportion of points encountered at a given spatial distance as a function of the time between such points. a) Time series C haos, b) time series P noise, c) time series B row nian, and d) time series E kg. The time series E eg, N oise and R andom present similar RDP to that of the time series E kg in the sense of an overall constant behavior. However, the two stochastic and stationary time series present sm aller and m ore random -like am plitude oscillations with a faster initial decreasing behavior.




Figure 2: RDP for T ts and some characteristic T T ts. The plot indicates the proportion of points encountered at a given spatial distance as a function of the time between such points. a) T ts. b) T T ts 6, representative of stochastic-like behavior, i.e. initially sm all and overall constant density: T T ts 2, 3, 5, 6, 7, 8, 11, 12 and 13. In the particular case of T T ts 6 certain periodic superim posed structure is observed which is not at all the case for the rest of the T T ts of this group. c) T T ts 19, representative of clearly nonstationary RDP: T T ts 4, 9, 10, 19 and 20. d) T T ts 21, representative of nonstochastic stationary RDP, e.i. initially large and decreasing density followed by an overall constant density: T T ts 14, 15, 16, 17, 20, 21 and 22. The short but not negligeable initial decreasing behavior of RDP, characteristic of nonstochastic time series, is not clearly observed on the RDP since we are mainly interested on the long term overall behavior of RDP needed to assess the stationarily of the time series.





Figure 3: Cross-Prediction Errors, (CPE). The two horizontal axes indicate the index of the segments used to predict and to be predicted. The CPE values are given in arbitrary units proportional to one half of the range of values of the corresponding time series. For clarity, we have xed CPE to the maximum possible value (one half of the range of the range of the time series) for the point (0;0) and to zero for the rest of the pairs (predicted;0) and (0; predictee). a) CPE plot for time series C haos, b) CPE plot for time series N oise, c) CPE plot for time series B row nian, and d) CPE plot for time series P noise.




Figure 5: STSP for some test time series. The curves indicate the spatial distance obtained as a function of the temporal separation in order to obtain a xed fraction of pairs of all the possible pairs. The three curves in each plot represent respectively, from bottom to top, 10, 50 and 90% of all possible pairs of points. Each curve was calculated up to 300 orm ore sampling times to make sure of the overall saturation when present. We show only the rst 100 or less sampling times, as indicated by the horizontal axis, in order to clarify the behavior before saturation.




Figure 6: Space Time Separation Plot (STSP), for Tts and some representative TTts. The interpretation of the plot and parameter values are explained in gure 5. a) Tts. b) TTts 5, representative of those TTts with uncorrelated and stochastic-like plots: 2,3,5,6,7,8,11,12,13 and 18. c) TTts 21, representative of those TTts with indications of determ inism and stationarity: 9,19,20,21 and 22. d) TTts 4, representative of those TTts with more clear determ inistic and stationary results: 4,10,14,15,16 and 17.
