#### Abstract

W e analyze a class of piecew ise linear parabolic $m$ aps on the torus, nam ely those obtained by considering a linear $m$ ap $w$ ith double eigenvalue one and taking $m$ odulo one in each com ponent. $W$ e show that $w$ ithin this tw o param eter fam ily ofm aps, the set of noninvertible $m$ aps is open and dense. For cases $w$ here the entries in the $m$ atrix are rational we show that the $m$ axim al invariant set has positive Lebesgue $m$ easure and we give bounds on the $m$ easure. For several exam ples we nd expressions for the $m$ easure of the invariant set but we leave open the question as to whether there are param eters for which this $m$ easure is zero.

## 1 Introduction

W e consider a class of $m$ aps of the torus $X=[0 ; 1]^{2}$ of the form

where $(x ; y) 2[0 ; 1]^{2}$. This can be thought of as a map $f=g \quad M$ where

(we also write $M=(a ; b ; c ; d)$ for convenience) and $g(x)=x \quad b x c$ is a $m$ ap that takes modulo 1 in each com ponent. A though such $m$ aps are linear except at the discontinuity induced by the $m$ ap $g$, their dynam ical behaviour can be quite com plicated. D epending on the eigenvalues $1 ; 2$ of M we refer to the m ap as elliptic ( $1_{1}={ }_{2}{ }_{1}$ ), hyperbolic $\left({ }_{1}>2\right)$ or parabolic $\left(1_{1}=2\right)$. In this paper we focus on the area-preserving parabolic case $w$ ith determ inant $a d \quad b c=1$ and trace $a+d=2$. Such $m$ aps arise naturally on exam ining linearm apsw ith a periodic over ow. In particular, suppose that one w ould like to titerate a $m$ atrix using a digital representation $w$ ith very sm alldiscretization error but a nite range which we set to be $(0 ; 1)$. In this case $f$ is a piecew ise continuous $m$ ap of $T^{2}=R^{2}=Z^{2}$ to itself that is areapreserving and such that the linearization is at alm ost every point in $T^{2}$ is $M$. $T$ his $m$ atrix has two eigenvalues equal to one. Them ap is continuous everyw here on the torus except on a one-dim ensional discontinuity $D$ in $T^{2}$. The behaviour of $f$ on $D$ does not a ect a fullm easure set of $X$.

P arabolic area-preserving $m$ aps are not typical in the set of alm ost-everyw here linear $m$ aps on the torus $\left.{ }_{15}^{15}\right]$. H ow ever, their dynam ical properties are of a particular interest, since such $m$ aps can be considered as an interpolating case betw een the hyperbolic $m$ aps ( $\mathrm{Jj}>$ 2) and the elliptic $m$ aps ( $\mathrm{fj}<2$ ) in the area-preserving case. They are in some

 sections, our results use the fact that for rational coe cients of $M$ the $m$ ap (1) $\left.{ }_{1}\right)_{1} m$ ay be decom posed into a one-param eter fam ily of 1 dim ensional interval translation $m$ aps.

H yperbolic area-preserving $m$ aps are characterized by a positive Liapunov exponents, and are often studied as model chaotic area-preserving dynam ical system $s$ (see eg. 冨, [14i'] and the Baker's transform ation). Elliptic area-preserving maps correspond (in an appropriate eigenbasis) to rigid rotation, w here the presence of a discontinu ity caused by $g$
 linearm aps on the torusw as studied by A m adasiand C asartelli $[\underline{11}]$, while certain properties of linear parabolic $m$ aps were analyzed in [ $\bar{I}_{1} \bar{\eta}_{1}$. In particular, a generic parabolic m ap displays som e sort of sensitive dependence on in itial conditions. H ow ever, this property is not related to the Lyapunov exponents (w hich are alw ays zero for parabolic m aps), but is due to the discontinuity of the $m$ ap.

### 1.1 Sum $m$ ary of $m$ ain results

W e param etrize the set of parabolic area-preserving maps by A and , nam ely

which by the previous result is strictly sm aller than $X$ for $m$ ost ( A ; ). N ote that any A $\quad X$ with $f(A)=A$ will have $A \quad X^{+}$and so in this sense the set is $m$ axim al.
$W$ e say a $m$ ap $(\underline{2})$ is sem irational if is rational. It is rational if both $A$ and are rational. If f is not sem irational we say it is irrational. N ote that the m ap is rational if and only if $a, b, c$ and $d$ are rational.

We investigate the two dim ensional Lebesgue measure '( ) of this set, show ing in Theorem and upperbounds for ' $\left(X^{+}\right)$depending on $A$ and .

W e discuss two particular exam ples of rational maps where we can compute ' ( $\mathrm{X}^{+}$), nam ely w th $A=\frac{1}{2}$ and $=1$ or $\frac{1}{2}$. In the form er case we show that ${ }^{\prime}\left(X^{+}\right)=\frac{1}{2}$ and in the latter case we show that $\left(X^{+}\right)=\frac{1}{2} \quad \frac{{ }^{\frac{1}{3}}}{72} \quad \frac{1}{8} \ln 3 \quad 0.28710$. In som e special cases, e.g., $1<0$; $\AA$ j 1 and $A=1 ; 0 \ll 1$, we can compute $X^{+}$, and thus we can obtain exact values of ' $\left(X^{+}\right)$. O ther than these cases we have not been able to com pute exact values of ' $\left(X^{+}\right.$) other than by num erical approxim ation, even for rationalA and . $W$ e suspect that for $m$ any $>0$ and $A>0$ (both irrational) then ${ }^{\prime}\left(X^{+}\right)=0$, whereas $'\left(X^{+}\right)>0$ for rational. Section 'í' brie $y$ discusses exam ples of nonlinear parabolic m aps, and we conclude w th som e rem arks on open problem $s$ in Section 点.

## 2 Invertibility of linear $m$ aps on the torus

C onsider a m atrix M corresponding to a parabolic m ap on the torus (1-1). A part from the special horocyclic [īi] cases

### 2.1 N on invertibility of generic parabolic m aps

The next lem m gives necessary and su cient conditions that ( $\overline{4}$ ) is invertible (ignoring points that land on the discontinuity). W e say them ap is invertible ifthere is a fullm easure subset on which it is invertible. Since the $m$ apping is a com position of an invertible linear m ap and a discontinuous m ap that m aps open sets to open sets, both of which preserve Lebesgue $m$ easure, a $m$ ap is non-invertible if and only if there is an open set of ( $x ; y$ ) that has two orm ore preim ages. Let $a ; b ; c ; d$ be de ned as previously.

Lem mal Anymap (in $\overline{1}_{1}^{\prime}$ ) with ad bc= 1 willbe noninvertible on an open set if and only if there are $(K ; L) 2 Z^{2} n(0 ; 0)$ integers such that

Rem ark 1 It is quite possible that there are sim ultaneously $m$ any solutions to the inequal ities of Lemma a for example, near $A=1$ and large one can nd anbitrarily large num bers of integers ( $K$; L) satisfying both inequalities.
$U$ sing the previous Lem $m$ a we obtain the $m$ ain result of th is section.
Theorem 1 The only invertible parabolic $m$ aps $f$ have $M$ equal to one of
where $(k ; l)$ are integers and $b$ is real.
Proof The square $V=(1 \quad ; 1+\beta$ is a convex region sym $m$ etrical about the origin w ith area $4(1+)^{2}$. A variant of $M$ inkow ski's theorem [1] 1 $>0$ there $w i l l$ be a point on the lattice $=f(K C L a ; K d L b):(K ; L) 2 Z^{2} g$ other than zero inside $V$, if the lattice has determ inant $=\operatorname{ad} \mathrm{bc} 1$. Taking the lim it ! 0 and using com pactness we see that there $m$ ust be a point (; ) 2 other than zero in $\overline{\mathrm{V}_{0}}$.

If there is a lattice point $(;)$ in the interior of $V_{0}$, we are done. If not, assume w thout loss of generality that ( ; ) = (1;y) w ith $\mathrm{j} j 1$. Thus exactly one point in the line segm ent from (but not including) ( $1 ; 1 \quad y)$ to $(0 ; 1)$ that is in the lattice (one can
generate the sam e lattice by adding $m$ ultiples of $(1 ; y)$ to any lattice point generating the lattice w ith $(1 ; y))$. T herefore there $w$ illbe a point in the lattice in the interior of $V_{0}$ unless this other point is $(0 ; 1)$. T herefore (considering the other case by interchanging $x$ and $y$ ) there willbe integers $K$ and $L$ such that either

Thus, in the invertible case the $m$ atrix $M$ is determ ined by whidh of these cases occurs. O ne can easily solve to show that either of these cases can occur. Ifk = 1 or $1=1$ then the other (horocyclic) cases occur.

It follow $s$ from this result that $m$ ost parabolic $m$ aps are noninvertible in the follow ing sense:

C orollary 1 T he set of noninvertible m aps is open and dense within the set of parabolic m aps.

Because the $(m$ od 1$) \mathrm{m}$ ap $g$ com $m$ utes $w$ th integer $m$ atrix and $g^{2}=g$, all conjugations of parabolic m aps w ith integer coe cients by autom onphism sof the torus $\mathrm{T}^{2}$ rem ain integer parabolic m aps. For an integer parabolic m ap w ith rational $=r=s$, where ( $\mathrm{r} ; \mathrm{s}$ ) $=1$, since there exist $\mathrm{m} ; \mathrm{n} 2 \mathrm{Z}$ such that $\mathrm{m} r+\mathrm{ns}=1$, there exists an autom orphism whose GL ( $2 ; Z$ ) m atrix has bottom row ( $r ; s$ ). C on jugation by this autom onphism gives a parabolic $m$ ap whose $m$ atrix has bottom row ( 0 ; ). Since conjugation preserves integrality, trace and determ inant, the resulting $m$ atrix $m$ ust be of the form $(1 ; B ; 0 ; 1)$ for som e B. Therefore we conclude that all parabolic $m$ aps $w$ ith integer coe cients can be reduced to one of the horocyclic cases.

## 3 M axim al invariant sets

By Poincare recurrence the $m$ axim al invariant set $X^{+}=X \quad$ (up to a set of zero $m$ easure) if and only iff is invertible at alm ost every point. In fact the maxim alinvariant set $X^{+}$is an upper sem icontinuous function of the system param eters $A$; in the $H$ ausdor $m$ etric. H ow ever, the $m$ easure (and dim ension) of $\mathrm{X}^{+}$can (and does) change discontinously w ith param eters; see P roposition '1'.

W e now consider the structure ofX ${ }^{+}$for the sem irational case (ie rational). C onsider the fam ily of lines $L_{B}$ de ned by

### 3.1 Sem irational and rational parabolic m aps

For sem irationalmaps ( $=r=s>0)$ and for any given value of $B$ the set $L_{B}$ consists of $r+s$ (or exceptionally r $+s 1$ if it contains the origin) intervals that are parallel to the eigenvector $v=(1 ; \quad)$ of the $m$ atrix $M . W$ e can param etrise any particular $L_{B}$ by
$2[0 ; \mathrm{s})$. W ew ill consider $>0$ from here on. M ore precisely we re-param etrize X by

For $2[0 ; s)$ and $B 2\left(\frac{s}{s} ; 1\right)$ the mapping $(x ; y) \$(; B)$ is oneto-one and has unit Jacobian everyw here.

Since each $L_{B}$ is invariant the $m$ axim al invariant set $m$ ust nontrivially intersect $L_{B}$ and so no single tra jectory is dense in $\mathrm{X}^{+}$. In this case we need to approxim ate $\mathrm{X}^{+}$using a distribution of trajectories on a dense set of lines.

The relation between and $x$ is $x=\quad[\quad]: T$ he variable $y$ is related to and B by the relation $y=B \quad \mathbb{B} \quad$ ]. So the point $(; B) m$ aps to

Because the variable $B 2\left[\frac{1-s}{s} ; 1\right)$ is invariant during the dynam ics it is treated as a param eter. A gain, the slope of these 1D m aps is equal to one im plying that all Liapunov exponents are zero.

In the case of a rationalm $a p$, ie where both $A=p=q$ and $=r=s$ are rational $w$ ith $(r ; s)=(p ; q)=1$ we can understand a lot about the $m$ apping $T$ using the follow ing factor m ap. Let

$T$ he previous Lem $m$ a relies crucially on the fact that $S$ is invertible. T he next result im plies that the num ber of points in $N$ is a constant alm ost everyw here. Let

$P$ roof It is a standard result that $S_{B}$ is ergodic for Lebesgue $m$ easure if and only if $B$ is irrational. If we look at the set of that give a certain value of N ( ) this is invariant and therefore $m$ ust have Lebesgue $m$ easure 0 or 1 .

O ne consequence of this is that the $m$ easure of $X_{B}^{+}$can only take a nite number of values. W ewrite $\hat{N}(B)$ to show the dependence on $B$ explicitly.

Theorem 2 Suppose that $A=p=q$ and $=r=s$. For Lebesgue alm ost all $B$ we have

Since $T$ willbe invertible on $X_{B}^{+}$, if there is an intervalw ith m ore than one preim age, only one of these willbe in $X_{B}^{+}$and hence $\hat{N}(B)$ grs $+1 \quad L$ where $L$ is the number of preim ages.

W e can now prove the $m$ ain result in this section.

Theorem 3 Suppose that $=r=s$ and $A=p=q$ are both rational, with $(r ; s)=(p ; q)=1$. Then the maxim al invariant set $X^{+}$has $H$ ausdor dim ension 2 and positive Lebesgue $m$ easure, $m$ ore precisely, if there is an open set on which $f$ has $K$ preim ages then

C orollary 2 For any rationalm ap, alm ost all $B$ and all $x 2 L_{B}$, ! ( $x$ ) consists of a set $w$ ith positive one-dim ension $m$ easure in $L_{B}$. C onversely, for a countable set of $B$ and all $\mathrm{x} 2 \mathrm{~L}_{\mathrm{B}}$, the trajectory going through x is eventually periodic.

Proof In the proof of $T$ heorem $\overline{13}$, the reduced $m$ ap $S_{B} w$ ill be an irrational rotation for all irrational $B$ and a rational rotation for all rational $B$. T he result follow s .

D ensity of irrational B sim ply im plies the follow ing result for the originalm ap .

C orollary 3 For any rational parabolic $m$ ap, the preim ages of the discontinuity are dense in $X^{+}$.

W e do not have a precise analytical expression for ' ( $X^{+}$) even for rational parabolic $m$ aps. $N$ um erically one can approxim ate the $m$ easure and obtain various values of ' $\left(X^{+}\right)$; see for exam ple $T a b l e$ ' 111 . In certain sim ple cases one can obtain exact values of ' $\left(X^{+}\right)$by constructing the $m$ axim al invariant set explicitly.

Proposition 1 O ne can com pute

The invertible case is trivial, while the cases where $A=1$ follow because the $m$ ap reduces to an invertible $m$ ap on a strip height. The appendix gives a constructive proof for the case $0<A \quad 1,1<0$. Because $f_{A} ; 1$ is con jugate to $f_{A} ; 1$ by interchanging $x$ and $y$ we have
$N$ ote in particular that there is a discontinuity in ${ }^{\prime}\left(X^{+}\right)$at $(; A)=(1 ; 0)$.
$T$ he follow ing exam ples (especially that in Section if it can be obtained, is likely to be non-trivial.

### 3.2 Exam ple I

The sim plest nontrivial rationalm ap is de ned by $A=1=2$ and $=1$. In this case, we can approxim ate the $m$ axim al invariant set num erically as in Figure $\overline{111}$.

where $(x ; y) 2 x=[0 ; 1]^{2}$. In this case, as noted in $\left[\overline{1} \bar{Z}_{1}\right]$, there appears to exist a sym $m$ etry betw een $X^{+}$and its com plem ent. In fact, we can use the results in Section $13-1$ to get the result directly.

Proposition 2 For the $m$ ap $(\underset{\sim}{\bar{q}})$ with $A=\frac{1}{2}$ and $=1$, we have ${ }^{\prime}\left(X^{+}\right)=\frac{1}{2}$.
Proof $N$ ote that $r=s=p=1$ and $q=2$. $M$ oreover, on $L_{B}$ the $m$ ap ( $(\bar{q})$ can be w ritten

and this $m$ ap is two-to-one on an open set of for alm ost all B. Therefore, for alm ost all $B$, the upper and low er bounds of $T$ heorem ${ }_{2}^{2}$ agree and

### 3.3 Exam ple II

$W$ e now consider the case $A=\quad=1=2$; this shows that ${ }^{\prime}\left(X^{+}\right) m$ ay be irrational for a rationalm ap . In this case the m ap is

$T$ he $m$ axim al invariant set $X^{+}$for the $m$ ap $(\underline{\overline{9}})$ is show $n$ in $F$ ig. 2. The results in Theorem 'i-1-1 im ply that

but this is clearly not very precise.
W e have obtained a num erical estim ate by terating a grid of in itialpoints distributed uniform ly on the square, dividing the unit square into boxes and counting the occupied cells. To avoid the transient e ects som e num ber (say, the rst hundred) of im ages are not $m$ arked on the graph. Applying this $m$ ethod we obtained $V \quad 0: 287$, how ever the precision of this result is lim ted by a highly com plicated structure of som e fragm ents of the invariant set and a very slow convergence of transients.

By using the structure noted in Section we show num erical approxim ations of $X_{B}^{+}$ as $B$ changes in the $m$ ap (1-1 $)$ are show $n$ in $F$ igure.

These values agree w ith the predictions of $T$ heorem that ' $\left(X_{B}^{+}\right) 2 \frac{1}{4} f 1 ; 2 ; 3 g$. M ore generally for any n 2 N we observe that

Thus we can obtain a series expression for the $m$ easure and in this case we can sum it explicitly. U nfortunately we have not been able to extend this m ethod to one that applies generally.

### 3.4 Irrational parabolic m aps

W e have not yet obtained any signi cant results for irrational parabolic area-preserving m aps and, in fact, for the all cases where we can com pute it, the m axim al invariant set has positive $m$ easure. $N$ onetheless, there is num erical evidence ( $\left.\left[\overline{1}_{1} \bar{T}_{1}\right]\right)$ that suggests that

There are ( ;A) forw hich the $H$ ausdor dim ension ofX ${ }^{+}$is less than 2 (in particular, such that ${ }^{\prime}\left(\mathrm{X}^{+}\right)=0$ ). By results here, this can only occur in cases where both param eters are irrational.

This is com m on for $\mathrm{A}>0$ and $>0$.
N ote that not all irrational parabolic m aps have zero m easure; for exam ple P roposition show sthat there are open regions in (A; ) w th $<0$ where ' $\left(X^{+}\right)>0$. For sem irational cases ( $=r=s$ ) we can reduce to $m$ aps of the form ( $(\overline{6})$, , how ever we cannot nd factors that
 $X^{+} m$ ay vary betw een 1 and 2. The H ausdor dim ension is a rather subtle characteristic of a set. For exam ple, tw o sets $m$ ay be arbitrarily close in the sense of the $H$ ausdor $m$ etric, but their dim ensions $m$ ay di er by an arbitrarily large num ber. T herefore, sm all changes
of the param eter, which do not change much the structure of the $m$ axim al invariant set (in sense of the $H$ ausdor $m$ etric) $m$ ay induce $w i l d$ uctuations of its dim ension. N ote also that the cases $>0$ and $<0$ seem to be fundam entally di erent; we do not have a way of con jugating one w ith the other.

## 4 N on linear parabolic m aps

O ne can also construct nonlinear parabolic $m$ aps that display sim ilar structure in their $m$ axim al invariant sets as the piecew ise linear case. C onsider the tw o param eter fam ily of the $m$ aps on the tonus de ned by

For any non-zero values of the real param eters and the Jacobian $@\left(x^{0} ; y^{0}\right)=@(x ; y)$ is constant and equal to one. M oreover, for any point ( $x ; y$ ) the trace of the $m$ ap $t$ is equal to 2, which $m$ akes the above $m$ ap sim ilar to the linear case (1긴) . O bserve that the diagonal of the unit square $y=x$ is invariant $w$ ith respect to this $m a p$. $T$ his $m$ ap acting on the plane transform s the unit square into a set con ned betw een four exponential functions. A fter folding it back into the unit square som e fragm ents of it w ill overlap as (111) is typically non invertible.
$F$ igure ' $\overline{4} \overline{1}$ ' show $s$ the invariant set of the nonlinear $m$ ap in the case $=\quad=1$. There is num erical evidence that the $m$ axim al invariant set has positive volum e in this case even though the Jacobian changes betw een being a rational and an irrational parabolic $m$ ap at di erent points.

## 5 D iscussion

In this paper we have considered som e basic properties of the maps $(\underset{\underline{1}}{1})$ in the parabolic area-preserving regim $e$, and show a surprising degree of sensitivity of the dynam ical behaviour on rationality of the param eters and A. O ur investigations raise som e intriguing questions conceming how the Lebesgue $m$ easure of the $m$ axim al invariant set varies $w$ th param eters. For several exam ples do we have analytical values of this measure. For general rational parabolic $m$ aps we do have a result that gives upper and low er bounds for this m easure. H ow ever, these bounds becom e weak as one exam ines higher denom inator rationalm apsand do not easily give insight into the $m$ easure for irrationalparabolic $m$ aps.

It would be very inform ative to understand the structure of invariant $m$ easures of the $\mathrm{map}{ }_{(1 \overline{1})}^{(\overline{1})}$. N ote that '(:) (Lebesgue m easure) restricted to $\mathrm{X}^{+}$is invariant under this $m$ apping but it is not ergodic. In particular, it $m$ ay be the case that this restriction is trivial in which case em piricalm easures can still be de ned; by analogy w ith the Interval Translation $M$ aps of $4 \hat{0}, 1,1[1]$ we sum ise that there are cases where a $H$ ausdor $m$ easure restricted to $\mathrm{X}^{+}$is invariant, in particular in cases where ${ }^{\prime}\left(\mathrm{X}^{+}\right)=0$.

The union of the two triangles is invariant as the dotted im ages ODB and CSQ show, as is the line of xed points OS. Hence in this case we have
