M ixing property of triangular billiards

W e present num erical evidence which strongly suggests that irrational triangular billiards (all angles irrational with) are mixing. Since these systems are known to have zero K olm ogorov-Sinai entropy, they may play an important role in understanding the statistical relaxation process.

A fler the pioneering paper of Ferm i, Pasta and U lam [1] and the mathematical works of Kolm ogorov school, the modern ergodic theory can now account for the rich variety of di erent statistical behaviours of classical dynam ical system s. These properties range from complete integrability to determ inistic chaos. The relatively few rigorous results so far available have provided a m quide for a large am ount of analytical and num erical work which gave a strong in pulse to the eld of nonlinear dynam ics. Needless to say, several problem s rem ain to be solved. For example it is known that mixing property guarantees correlations decay and relaxation to statistical equilibrium. It is how ever not known whether or not this property is su cient for a meaningful statistical description of the relaxation process or whether the strongest property of positive KS entropy is required. Even much less clear is the situation in quantum mechanics. For example, to what extent the statistical distribution of energy levels of a quantum conservative ham iltonian system, is related to the di erent properties in the ergodic hierarchy is, as far as we know, an open question.

E xam ples of classically com pletely integrable or determ inistic random system shave been widely studied in the literature. However, to our know ledge, there are no physical exam ples of system s which possess the m ixing property only (with zero K S entropy). In this respect, the best candidates are billiards in 2-d triangles but, in spite of 30 years of investigations, no de nite statem ent can be m ade concerning their dynam ical properties [2]. M oreover, [3] \a prevailing opinion in the m athem atical com m unity is that polygonal billiards are never m ixing, but this has not been established".

In this paper we provide strong numerical evidence that generic triangular billiards, with all angles irrational with , are mixing. This result can play an important role in the understanding of non-equilibrium statistical mechanics since it lls a gap in the ergodic hierarchy. Moreover, since the local dynamical instability in these systems is only linear, they have zero algorithm ic com - plexity. Thism eans that, even though it may be very difcult, their analytical solution is not im possible in principle and this may prove to be very im portant for the future development of nonlinear dynamics.

We consider the motion of a point particle, with unit velocity, inside a generic triangular billiard (with all angles irrational with , in general). Let us introduce cartesian coordinates (x;y), and align one side of the triangle along the x axis (y = 0), starting at the origin x = 0, and let us choose its length to be unity. We denote the angle at the origin (0;0) by and the angle at (1;0) by . Hence the other two sides of the triangle are given by the eqs. y = (tan)x, and y = (tan)(1 x).

We would like to draw the attention to the following fact: the dynamics of a point particle in a triangular billiard is equivalent to the motion of three particles on a ring with di erent m asses, m₁, m₂, and m₃. Let the ring have circum ference 1. The motion of 3-particles 1d gas with coordinates $q_1;q_2;q_3$ (q_1 q_2 q_3 $q_1 + 1$) is governed by the ham iltonian H = $\frac{1}{2}m_1q_2^2 + \frac{1}{2}m_2q_2^2 + \frac{1}{2}m_3q_3^2$, with elastic collisions at $q_1 = q_2$, $q_2 = q_3$, and $q_3 = q_1 + 1$. Introducing the notation

and the orthogonal transform ation

with $M = m_1 + m_2 + m_3$, the ham iltonian writes: $H = \frac{1}{2} (\underline{x}^2 + \underline{y}^2 + \underline{z}^2)$ where, as can be checked by straightforward calculations, the motion in the (x;y) plane is bounded by specular re ections from the sides of the triangle with angles

The motion in the z coordinate trivially separates and corresponds to the center-of-mass motion in the 3particles 1d gas.

N otice, how ever, that triangular billiards with one angle larger than =2 cannot be related to the 3-particles ld gas, since from the above form ula it follows that ; ; < =2. A particular case is given by the isosceles triangle which is dynam ically equivalent to the right triangle billiard, with e.g. = =2. The latter corresponds to $m_3 = 1$, i.e. to the ld motion of two particles with m asses m_1, m_2 between hard walls [5].

The dynamics of triangular billiards can be divided into three classes:

(A) All angles rational with . The dynamics of such triangles is not ergodic; in fact it is pseudo-integrable, i.e. it possesses 2d invariant surfaces of high genus in 4d phase space.

(B) Only one angle rational with . Such are generic right triangles, for example. In recent num erical experiments evidence has been given that right, irrational, triangular billiards are ergodic and weakly mixing [4].

(C) A llangles irrational with . Surprisingly, to the best of our know ledge, this generic class of triangles has been som ehow overlooked in previous num erical studies and will be the main object of the present paper. It is within this class that one may now hopefully look for ergodic and m ixing behaviour.

From the rigorous point of view not m uch is known beyond the fact that the set of ergodic triangles is a dense G (intersection of a countable number of dense open sets) in a suitable topology. We recall that a dynam ical system $T^{t}: \mathbf{x}(0) ! \mathbf{x}(t)$ with invariant measure (\mathbf{x}) in phase space M is mixing if, for any L^{2} pair of observables in phase space, their time correlation function asymptotically vanishes

The map T^t may represent a continuous ow (t real) or a discrete map (t integer). In this paper we shall mainly consider the dynam ics given by a discrete Poincare map which corresponds to the collisions of the orbits with the horizontal side y = 0. The reduced phase space | surface of section (SOS) | is a rectangle, parametrized by the coordinate 0 x 1 and by the corresponding canonical momentum 1 $p_x = \sin \# 1$ (# = angle of incidence), with the invariant measure d = dxdp_x.

As a rst step we have performed an accurate check of ergodicity. We have done this in two independent ways:

(i) By dividing the phase space (SO S) in a large number $N = N_1 N_1$ of cells and then computing the number n(t) of cells which are visited by a single orbit up to discrete time t [9]. Then we computed the average relative measure r(t) = hn(t)=N i of visited phase space up to time t where hi denotes phase space average over succently many random ly chosen initial conditions. As it is known, for the so-called random model of completely uniform (ergodic) and random dynamics, one can derive the simple scaling law [9]

 $r(t) = r_{RM} (t) = 1 \exp(t - N)$: (2)




FIG.1. The relative measure r(t) of the visited phase space as a function of discrete time t. The full and dashed curves refer to di erent discretizations of phase space, namely to $N = 10^6$ and $N = 10^4$ cells, respectively. The two upper curves refer to the generic triangle C whereas the two lower curves refer to the golden right triangle B (see text for details). The random model, expr.(2), is given by the dotted-dashed curve which is almost indistinguishable from the numerical curve for the triangle C at $N = 10^6$. In order to better display the excellent agreement with expr.(2), we plot in the inset the function 1 r(t) for the generic triangle C in the sem i log-scale. At $N = 10^6$, and $N = 10^4$, averages over 200, and 4000 orbits with random ized initial conditions have been used, respectively.

Expression (2) (for arbitrary but su ciently nemesh N) should be considered as a su cient but not necessary condition for ergodicity. In fact, the dynamics would obey the law (2) only when the system does not possess any non-trivial time scale. In Fig.1 we show the results of num erical com putations for triangles of class (B) and (C). W e take for example a right triangle B with angles = $\begin{pmatrix} 1 & 5 \\ \overline{5} & 1 \end{pmatrix}$ =4; = =2 j = =2 and a generic triangle C with angles = $\begin{pmatrix} 2 & 1 \end{pmatrix}$ =2; = $\begin{pmatrix} \overline{5} \\ \overline{5} \end{pmatrix}$ 1) =4; = : It is seen that there is a drastic di erence between the two cases: the generic triangle C excellently follows the law (2), whereas the right triangle B, even though ergodic, [4] strongly deviates and explores the phase space extremely slowly, with a hierarchy of long tim e-scales related to a strong sticking of the orbit in momentum (p_x) space.




FIG.2. The velocity autocorrelation function C_{px}^{p} (t) in log-log scale for the generic triangle C (full curve), which is obtained as the average over 12 10⁶ di erent orbits of length 32768. The dashed line gives the slope 1:00. The dotted curve gives the estim ated statistical error of the correlation function, while the dots mark the di erence between the phase averaged and the time averaged correlation function $\int_{p_x}^{p}$ (t) C $_{p_x}^{t}$ (t) j where the time average is computed from a single orbit of length T = 32768 12 10⁶ with initial condition $x_0 = 0.23456$; $p_{x0} = 0.34567$. The statistical error is estim ated as the standard deviation of a sequence of M = 1000 partial averages of length T /M each.

(ii) By comparing the time averaged correlation function for a single, but very long orbit, $C_a^t(t) = \lim_{T \to 1} \frac{1}{T} \prod_{n=1}^{T} a(n)a(n + t)$ with the phase averaged correlation function $C_a^p(t) = ha(0)a(t)i$ which is computed by monte-carlo averaging over m any short orbits with di errent random ized initial conditions. In Fig.2 we plot the di errence between the two curves for the generic triangle C which turns out to be of the sam e order as the statistical error.

The above num erical results are suprisingly much more clear than expected; they demonstrate ergodic behaviour and they make reasonable to expect mixing behaviour also. We now turn our attention to the latter question.




FIG. 3. The velocity (a) and position (b) correlation function, $C_p^t(t)$ and $C_{x^0}^t(t)$, for an orbit of length 10^{11} in the generic triangular billiard D. Initial condition: $x_0 = 0.23456$; $p_{x0} = 0.34567$.

We have performed extensive numerical computations of autocorrelation functions of di erent observables, namely, momentum (horizontal component of velocity) $v = p_x$, symmetrized position $x^0 = 2x$ 1, and also characteristic functions of sets in phase space. In all cases we have found clear num erical evidence of powerlaw decay of correlation functions over about 4 orders of magnitude. For a given triangle, correlation functions of di erent observables, decay with the same empirical exponent which is typically very close to 1. In Fig2 we show the velocity correlation function of the triangle C, which decays with exponent with the tted value 0:90 0:02. However, since the triangle C is not too far from the right triangle we have chosen another, sim jlar generic triangle D with the irrational angles = $(2 \ 1) = 2; = 1; =$ and show in Fig.3 its velocity and position correlation function which decay with empirical exponent 0**:**94 0:04.We = have perform ed extensive num erical calculations of correlation functions for m any di erent generic triangles, and the exponent of decay have always been very close to

1. There are even cases where the tted decay exponent seems to be slightly below 1 (> 1), however in such cases, correlation functions appearm uch m ore noisy and it is di cult to make precise statem ents.

Finally, we have performed a di erent and powerful statistical test, namely we have computed the Poincare' recurrences or the return time statistics, i.e. the probability P (t) for an orbit not to stay outside a given subset A M for a time longer than t. It has been conjectured [6,7] (see also [8] for accurate de nition and furpher references) that the integrated probability $P_i(t) =$




FIG.4. The return probability P (t) (full curve), and the integrated return probability $P_i(t)$ (dashed curve), for the same orbit (triangle D) as in Fig.3. The dashed-dotted lines have slopes 2 and 1 respectively.

 $_{t^0=t}^{L}P$ (t⁰) should be intimately connected to the correlation decay. M ore precisely, if the correlation function decays as a power-law with exponent , then the integrated return probability should decay with a similar t ¹;P₁(t) t, where = . In exponent P (t) Fig.4 we show the recurrence probability P (t) and the integrated probability P_i(t) computed w.r.t. half-space $A = f(x;p_x);p_x > 0g$ for the same data as in Figs2,3 (triangular billiard C).W e have found that num erical results are perfectly consistent with = = 1, i.e. with $1=t^2$ decay of return probability P (t).

To sum marize, the numerical obtained value of exponent is close to -1 but in some cases is slightly less and in other cases slightly larger. We attribute this fact to long transient times which are caused by the intricate interplay of arithmetic properties of angles , , and by the presence of periodic orbits. In this connection we

would like to mention that we have numerically investigated the existence of periodic orbits and we have found that their number increases very slow ly with their period. The number of non-equivalent periodic orbits with lengths up to 1 (collisions with the boundary) typically increases slower than 1.

A qualitative argument which leads to the 1=t decay of correlations reads as follows: let us consider a xed, su ciently sm all, region A in phase space around a periodic orbit and study the literates of the Poincare map, where 1 is the period of the orbit. Due to the linear (in) stability, the orbit which starts in a small square a of side centered on the periodic orbit and contained in A, will remain in A for a time t 1= . It follows that the probability P (1=) for an orbit to stay in the region A for a time t 1= is proportional to the probability of the orbit to visit the square a . Now, the linear instability in plies that an orbit which enters the square a will remain inside a for a constant time which does not depend on as ! 0. As a consequence, from the Liouville theorem it follows that the probability for an orbit to visit the square a will be proportional to its area 2 . This is the probability P(1=) to remain in the region A for a time t 1= . This leads to the relation P (t) / $1=t^2$ as con med by num erical results.

Since the question discussed in this paper is a very delicate one, we have put particular attention to the accuracy of our num erical com putations. Am ong the several di erent tests, we have developed two independent com – puter codes, one based on the billiards dynam ics in a 2d plane, and the other based on the three particles 1d gas dynam ics: the results agree. M oreover, since the instability here is only linear in time, and the machine precision is 10^{-16} , the num erical errors are always below the statistical errors.

The central question is to what extent the results presented here can be considered as a de nite or convincing

evidence for the mixing property of generic triangular billiards. The correlation decay of som e particular class of functions is certainly compatible with a weaker property than mixing. However, in this paper we have compared the correlations decay of di erent variables (velocity, position, characteristic functions of phase space sets etc). W e have also considered the dynam ics given by the discrete Poincarem ap relative to di erent sides of the sam e triangle: all these correlations exhibit a power law decay with exponent very close to 1, and make very plausible the conjecture that correlation functions in generic triangles decay as / 1=t. Of particular signi cance is the behaviour of the return probability P (t) which decays with the expected power law $/ 1=t^2$. All the above results (including those described in Fig.1) lead to the conclusion that, outside any reasonable doubt, generic irrational triangles are mixing. The particular case of isosceles or right triangles is much less clear. The behaviour of correlations in such case is noisy and the exponent of the decay is too sm all to allow for any de nite conclusion.

The fact that generic triangles have zero K olm ogorov-Sinai entropy and yet they have a very nice m ixing behaviour without any time scale, may prove to be very useful for understanding the dynam ical basis of the relaxation process to the statistical equilibrium . M oreover, the analysis of their quantum behaviour will contribute to the current e orts for the construction of a statistical theory of quantum dynam ical system s.
