Chaotic Properties of Subshifts Generated by a Non-Periodic Recurrent Orbit

A bstract

The chaotic properties of some subshift maps are investigated. These subshifts are the orbit closures of certain non-periodic recurrent points of a shift map. We ret provide a review of basic concepts for dynamics of continuous maps in metric spaces. These concepts include nonwandering point, recurrent point, eventually periodic point, scrambled set, sensitive dependence on initial conditions, Robinson chaos, and topological entropy. Next we review the notion of shift maps and subshifts. Then we show that the one-sided subshifts generated by a non-periodic recurrent point are chaotic in the sense of Robinson. Moreover, we show that such a subshift has an in nite scrambled set if it has a periodic point. Finally, we give some examples and discuss the topological entropy of these subshifts, and present two open problems on the dynamics of subshifts.

1 Introduction

Periodic and chaotic behaviour are the two poles of dynam ical behaviour of a nonlinear system. These two poles, however, are closely related. An early paper discussing this topic is Li and Yorke's work \Period three implies chaos" [21]. They proved that for a one-dimensional continuous map on an interval, if it has a periodic point with period 3, then it is chaotic in a strong sense that they dene. Related and similar work was also published even earlier by Sharkovskii [29]. There are other similar results for higher dimensional continuous maps; see, e.g. [23, 22, 7, 5].

D iscrete dynam ical systems have been used as simplied prototypical models for some engineering and biological processes, e.g. [24, 9, 6, 16, 32]. Through the Poincare maps, discrete dynamical systems have also been used to show \chaos" in continuous dynamical systems, e.g. [14, 33].

In this article, we rst review basic concepts for dynam ics of continuous maps on metric spaces (Section 2). These concepts include nonwandering point, recurrent point, eventually periodic point, scrambled set, sensitive dependence on initial conditions, Robinson chaos, and topological entropy. Then we recall the denition of shift maps and their closed invariant subsets, called subshifts (Section 3). Our primary interest is in one-sided subshift maps generated by a non-periodic recurrent point. We demonstrate that these subshifts are chaotic in the sense of Robinson (Section 4). Moreover we show that such a subshift has an in nite scrambled set if it has a periodic point (Section 5). Finally, we give some examples and discuss their topological entropy, and present two open problems on the dynamics of subshifts (Section 6).

2 Principal concepts

In this section we review the principal concepts in the theory of the dynamics of continuous maps on metric spaces, and introduce related notations.

Let F:M! M be a continuous map, de ned on a metric space M with metric . A point x 2 M is called nonwandering if for any neighbourhood U of x, there exists n>0 such that $F^n(U)\setminus U\in {\cal F}$. A point x 2 M is called a periodic point of F, if $F^n(x)=x$ for some n>0. The minimal such n is called the period of this periodic point. A point y is called an eventually periodic point of F if there exists n 0 such that $F^n(y)$ is a periodic point of F. A point x 2 M is called a recurrent point of F, if for any neighbourhood U of x, there exists n>0 such that $F^n(x)=x$. The !—lim it set of a point x under F is

In the following, we denote by (M;F), P(M;F), EP(M;F) and R(M;F) the sets of nonwandering points, periodic points, eventually periodic points and recurrent points, of F on M, respectively.

There are many de nitions of chaos (e.g. see the discussions in [19, 26]). We introduce three principal ones:

1. In nite scram bled set: Two points a; b in M form a chaotic pair [34] for the map F, if a and b are nonwandering and non-periodic points, and the following conditions hold:

(i)

A subset S M is called a scram bled set [30], if for any a; b 2 S, with a $\{6\}$ b, then (a;b) is a chaotic pair. Our rst notion of chaos is possession of an in nite scram bled set. This is closely related to that used in [21], but they did not require chaotic pairs to be non-wandering; instead they required an uncountable scram bled set and also a relation to P (M;F) which we will not give here. Our feeling is that Li and Yorke's de nition of chaos was of historical importance but is not general enough.

- 2. Robinson chaos: A map F is said to have sensitive dependence on initial conditions (SD IC) on M if there exists > 0 such that, for any $\times 2$ M and any neighbourhood U of x, there exists y 2 U and n > 0 such that $(F^n(x); F^n(y)) >$ A map F is said to be topologically transitive on M if for any two open sets M , there exists an integer n > 0 such that $F^n(U) \setminus V \in A$ n equivalent de nition is that there is a dense orbit. This condition m ight not apply directly to F but often applies to the restriction of F to some closed invariant subset. A map is called chaotic in the sense of Robinson [26] if it has sensitive dependence on initial conditions and is topologically transitive. This de nition is based on one of Devaney [8], who also required the periodic points to be dense, but as argued by Robinson, this does not seem to be intrinsic to the phenomenon of chaos, so we leave it out. A curious twist, incidentally, is that Banks et al [4] realised that topological transitivity plus density of periodic points imply SDIC, so that SD IC can be left out of D evaney's de nition with making any change to his concept. Finally, note that Wiggins [33] de nes chaos to mean SD IC plus M has more than one orbit.
- 3. Positive topological entropy:

Topological entropy [1, 3, 15] was rst de ned by C.E. Shannon [28] in 1948 and called by him noiseless channel capacity. Engineers prefer this term while mathematicians like the term topological entropy. It is an important quantity measuring the rate of growth of the complexity of the orbit structure of a dynamical system with respect to time. In the case where M is compact, which su ces for this paper, it is most simply de ned as follows. Given > 0, say two orbit segments $(x_0; :::; x_n)$ and $(y_0; :::; y_n)$ of length n > 0 are -distinguishable if there exists

j 2 f0;:::;ng such that $d(x_j;y_j) > .$ Let N (n;) be the maximum size of a set of -distinguishable orbit segments of length n (which is nite by compactness). Then the topological entropy of F is

ent(F) =

We say F has topological chaos if its topological entropy is positive.

3 Shift Maps and Subshifts

We now recall the de nitions of shift maps and subshifts, and de ne the class of subshifts to be studied in this paper.

Let X be a metric space with metric d. The basic example to bear in mind is X = f0; :::; N 1g (often denoted just by N) for some integer N > 1 with the discrete metric:

 $d(m;n) = \begin{pmatrix} 0; & m = n \\ 1; & m \in n \end{pmatrix}$

Denote by X the space consisting of one-sided sequences in the metric space X (it can alternatively be written as X $^{Z_{+}}$). So x 2 X may be denoted by x = $(x_{0}; x_{1}; :::; x_{i}; :::)$, x_{i} 2 X , i 0. Let X be endowed with the product topology. Then X is metrizable, and the metric on X can be chosen to be

$$(x;y) = \sum_{i=0}^{x^1} \frac{1}{2^i} \frac{d(x_i;y_i)}{1 + d(x_i;y_i)}; \quad x = (x_0;x_1;...;); \quad y = (y_0;y_1;...;) \quad 2^{-x}$$

is continuous. If X has more than one element, the shift map is chaotic in all three senses that we have de ned. A two-sided shift map can be de ned similarly, acting by the same formula but on doubly in nite sequences of elements of X. We shall consider only one-sided shifts in this paper.

As an aside, when X is a vector space, X becomes a vector space in the natural way. If X is a nontrivial vector space, X is in nite dimensional. Fu and Duan [11] have shown that the shift map induces an in nite dimensional linear chaotic discrete-time system. Furthermore, this shift map has been used to demonstrate the chaotic behaviour of a quantum harmonic oscillator by Duan et al [9].

A closed —invariant subset of $_{\rm X}$ is called a subshift. Restricting attention now to the case of a set X with the discrete topology, a subshift is said to be of nite type if it can be completely specified by giving a nite list of excluded words, i.e. nite strings of elements of X that do not occur in any of the sequences of the subshift. The topological

entropy of a shift or subshift with X discrete is equal to the exponential growth rate of the number of dierent blocks of length noccurring in the symbol sequences. For a shift this is just logN, where N is the size of X. For subshifts of nite type, it reduces to computing the largest eigenvalue of an associated transition matrix, and is positive if the subshift does not consist only of periodic and eventually periodic points. In this case, the subshift of nite type is also chaotic in the other two senses. We call shifts and subshifts symbolic dynamics systems. Symbolic dynamics is a powerful tool to study more general dynamical systems, because the latter often contain invariant subsets on which the dynamics is equivalent to a shift map or subshift. Readers are referred to a recent book [20] for more background and details on symbolic dynamics.

For the rest of the paper, we will concentrate on subshifts that arise by taking the closure of a single orbit of a shift. These are not necessarily subshifts of nite type, and this is why their study is interesting and non-trivial. The study of orbit closures goes back at least to M orse, who studied the closure of the fam ous M orse sequence under the shift, which yields what we now call an \adding m achine". We refer to [13] for an early source discussing orbit closures. Denote by (a) the closure of the orbit starting at point a 2^{-X} , i.e.,

(a) =

It is easy to show that ((a)) (a), and it is closed by construction. So ((a);) is a subshift. We call ((a);) the subshift generated by the orbit starting at point a, or, in short, by the point a.

In the following, we discuss dynamical behaviour of the subshift ((a);).

4 Properties of Subshift ((a);)

We now discuss the dynam ical properties of the subshift ((a);) generated by a point a 2 $^{\rm X}$. Initially, X is an arbitrary metric space, but we shall rapidly specialise to the case X = N. The results of this section are elementary but we spell them out for pedagogical purposes.

Suppose x 2 X is recurrent but non-periodic, i.e., x 2 R (X ;) P (X ;). Since x 2 R (X ;), there exist $fn_{i}g$, n_{i} ! +1 as i! +1 , such that when i is big enough, $^{n_{i}}$ (x) enters any neighbourhood of x. Since x $\not\supseteq P$ (X ;), $^{n_{i}}$ (x) $\not\in$ x, 8i 1. So n_{i} can be chosen such that $^{n_{i}}$ (x), i = 1;2;:::; are all di erent, and thus f n (x); n 0g is a countably in nite set. This implies that x $\not\supseteq EP$ (X ;). So we have the following result

Proposition 4.1 Non-periodic recurrent points of are not eventually periodic points, i.e., $(R(^{x};)) P(^{x};)) \setminus EP(^{x};) = ;$.

Now suppose a 2 R ($^{\rm N}$;) P ($^{\rm N}$;). Because (a) is a closed subset of the compact space $^{\rm N}$, (a) is compact. A lso, since $^{\rm N}$ is totally disconnected, its subset

(a) is also totally disconnected. From a 2 R ($^{\rm N}$;), we have $^{\rm n}$ (a) 2 R ($^{\rm N}$;), 8n 0. By Proposition 4.1, $^{\rm n}$ (a) $\not\geq$ P ($^{\rm N}$;). Therefore, $^{\rm n}$ (a) 2 R ($^{\rm N}$;) P ($^{\rm N}$;), 8n 0. So there exist ${\rm fn_ig;n_i}$! +1 as i! +1, such that $^{\rm n_i}$ ($^{\rm n}$ (a)), i= 1;2;::: are all di erent, and $^{\rm n_i}$ ($^{\rm n}$ (a)) enters any neighbourhood of $^{\rm n}$ (a). These imply $^{\rm n}$ (a) 2 (f $^{\rm m}$ (a);m 0g)0, 8n 0, where for a subset S of a topological space, S of denotes its set of limit points. So f $^{\rm n}$ (a);n 0g ((a))0. So ((a))0 = (a), i.e., (a) is perfect, and (a) is homeomorphic to a Cantor set [33]. We sum marize this result as

Proposition 4.2 If a is a non-periodic recurrent point for , i.e., a 2 R ($^{\rm N}$;) P ($^{\rm N}$;), then (a) is homeomorphic to the Cantor set.

In particular, if a 2 R ($^{\rm N}$;) P ($^{\rm N}$;), then (a) is uncountable. M oreover, for a 2 R ($^{\rm N}$;), we have (a) = ! (a;) (the !—lim it set of the orbit from a). The converse is also true. So a 2 R ($^{\rm N}$;) if and only if (a) = ! (a;).

W e further have the following conclusion

Proposition 4.3 If a is a non-periodic recurrent point for , i.e., a 2 R ($^{\rm N}$;) P ($^{\rm N}$;), then has sensitive dependence on initial conditions on (a).

This can be shown as follows. Take $_0=1=2$. For x 2 (a), let V be an arbitrary neighbourhood of x in (a). If there exists y 2 V, such that y \in x, then taking k=m infn $0:x_n\in y_ng$, we have

So we only need to show the existence of y.

If there exists n such that $x = {}^n$ (a), then from Proposition 4.2, $x \cdot 2 \cdot R$ (N ;) P (N ;). Therefore, there exist $fn_ig \cdot 1$, such that ${}^{n_i}(x)$, i = 1;2;:::, are all dierent, and $\lim_{i! \to 1} {}^{n_i}(x) = x$. So we can take $y = {}^{n_i}(x)$ (i large enough). A lternatively, if n (a) \bullet x for all n 2 Z_+ then there exist fm_ig , $m_i \cdot 1$, such that $x = \lim_{i! \to 1} {}^{m_i}(a)$, and hence we can take $y = {}^{m_i}(a)$ for i large enough.

This completes the proof of Proposition 4.3. The important ingredient was that the shift on one-sided sequences is expanding, meaning that there exists > 0 such that for all pairs of distinct points x;y there exists n 0 such that $\binom{n}{x}$; $\binom{n}{y}$. The result does not apply to the two-sided shift.

We now discuss the image and nonwandering set of the subshift. Let a be a recurrent point, i.e., a $2 R (^{X};)$. It is easy to verify that ((a)) = (a). Since the orbit of a is dense in (a), is topologically transitive on (a). Thus every point is nonwandering. We thus obtain the following conclusion.

Proposition 4.4 Assume that a is a recurrent point, i.e., a 2 R (x ;). Then ((a)) = (a), (j (a)) = (a).

For a 2 R ($^{\rm N}$;) P ($^{\rm N}$;), P roposition 4.3 claim s that has sensitive dependence on initial conditions on (a). A snoted in the proof of P roposition 4.4, is topologically transitive on (a). So we have

Theorem 4.5 If a is a non-periodic recurrent point for , i.e., a 2 R ($^{\rm N}$;) P ($^{\rm N}$;), then the subshift ((a);) is chaotic in the sense of Robinson.

5 Further Properties of Subshift ((a);) When It Has a Periodic Point

The above discussion shows some interesting properties of subshifts generated by non-periodic recurrent points. In particular, Theorem 4.5 declares that all these subshifts are chaotic in the sense of Robinson. In this section we will show that if (a) contains a periodic point, then there exist in nitely many chaotic pairs in (a); in particular, if (a) contains a xed point, then there exists an in nite scrambled set which is dense in (a).

Whenever $m_1 \in m_2$, there exists a subsequence fn_ig such that $\binom{km_1}{a}\binom{a}{n_i} \in \binom{km_2}{a}\binom{a}{n_i}$, where subscript n_i denotes the n_i -entry. For suppose that this claim is not true. Then there would exist N > 0, such that $\binom{km_1}{a}\binom{a}{a} = \binom{km_2}{a}\binom{a}{a}$. Without loss of generality, we assume that $m_1 < m_2$. This proves condition (ii) in the de nition of a chaotic pair in Section 1. So any pair of distinct points x; y in S is a chaotic pair. This completes the proof of Theorem 5.1.

We remark that if has a xed point (a periodic point with period k=1), the chaotic pair set S is even more special. Recall the construction of S in the proof of Theorem 5.1, $S=f^{kn}$ (a); n Og, where k is the period of some periodic point in (a) \ P(N ;). If (a) \ P(N ;) contains a xed point of , then we can take k=1, so $S=f^{n}$ (a); n Og. Therefore S is dense in (a) and (S) S. So we have

Theorem 5.2 Assume that a is a non-periodic recurrent point and that (a) contains a xed point (a periodic point with period 1) of . Then the subshift has a dense invariant scram bled set S (a).

6 Examples, Discussions and Open Problems

The subshifts of the form ((a);) are common and fundamental, because the full shift ($^{\rm N}$;) and any subshift of nite type ($_{\rm A}$; $_{\rm A}$) with an irreducible transition matrix A can be generated by a point in R ($^{\rm N}$;) P ($^{\rm N}$;). In particular, any topologically transitive subshift can be written in the form of ((a);), and by de nition a chaotic

subshift should be topologically transitive. Also it is obvious that any subshift contains subshifts of the form ((a);).

M oreover, m any subshifts of in nite type can be generated by points in the subset R ($^{\rm N}$;) P ($^{\rm N}$;). The following are three examples.

Exam ple 6.1. ([12]) G iven sequences s_i of 0 and 1 as follows: $s_0 = 00110$, $s_1 = t_0s_0$, $s_2 = t_1s_0s_0s_1$, ..., $s_n = ts_0 {\atop 0} s_0s_2 {\atop 0} s_0s_2 {\atop 0} s_0s_2$, ..., where $t_0 = 00000$, $t_1 = 11111$, $t = t_0$ when n is odd, and $t = t_1$ when n is even, take $a = (s_0s_1s_2 {\atop 0} s_1s_2 {\atop 0} s_$

Exam ple 6.2. ([12]) Take sequences $s_0 = 00110$, $t_1 = 11111$. Form a symbol sequence b 2 $^2$ by concatenating all words of nite length formed from s_0 and t_1 . Then b 2 R ($^2$;) P ($^2$;). ((b);) is a subshift of in nite type. (b) is homeomorphic to the Cantor set; (j_(b)) = (b); ((b);) is chaotic in the sense of Robinson. Because the xed point (11 $$) 2 $$ (b); n $$ 0g is a dense invariant scram bled set (according to Theorem s 5.1 and 5.2).

Now we discuss the topological entropy of the above subshifts. For the subshifts constructed in Examples 6.1-3, we can calculate their topological entropies [12]:

It is som ewhat surprising that ((c);) has zero entropy, despite having both Robinson chaos and an in nite scrambled set. One may ask if there exists a subshift of in nite type with positive topological entropy but no in nite scrambled set nor Robinson chaos. Of course, there are many examples of the latter, because ent(j) > 0 does not imply that (;) is topologically transitive, but we could ask instead for a closed invariant subset with Robinson chaos. For one—and two-dimensional smooth maps, [17] shows that positive entropy in plies existence of a subshift of nite type, but we do not know the answer in the general context.

Finally, we present two open problems which are closely related to the topics of this paper:

Problem 1. Suppose a 2 R ($^{\rm N}$;) P ($^{\rm N}$;), (a) \ P ($^{\rm N}$;) $\stackrel{\leftarrow}{\bullet}$;. Take p 2 (a) \ P ($^{\rm N}$;), and denote its period by k. Does the set clf $^{\rm kn}$ (a);n 0g contain an uncountable scrambled set?

Problem 2. Can Theorem 5.1 be strengthened to give an uncountable scrambled set?
