## 1. Introduction

T he present paper introduces a m ethod of analysis of one dim ensional system s . Its application to study ofP oincare recurrence tim e ow is considered. $T$ he approach suggested consists of reducing the research of a given system 's orbits $X=\left(X_{i}\right)_{i=1}^{1}$ to analysis of altemations of the $m$ onotone increase and decrease of higher order absolute nite di erences, taken from X. Through som e special representation of nite orbits, we associate with X some nu$m$ erical sequence, is called the con jugate orbit. W e form ulate tw o conditions, when the study of the $X$ is reduced to analysis of the special orbits' asym ptotical intersections w ith som e base set from num erical interval ( $0 ; 1$ ) of zero Lebesgue $m$ easure. H enœ, the approach can be characterized as an "asym ptotical" analogy of P oincare's classical "section"m ethod.

Them ethod distinguishes two cases: the continuous, when som e num ericalquantities can take arbitrary values from interval $(0 ; 1)$, and the discrete case, when all of them belong to a nite set. The continuous was applied in Ref. 1 to study ofneuralactivity. In the present work, we are m ore interested in the discrete case, which has an additional speci c. Thus, as soon as we have stated the $m$ ethod's applicability, the $m$ echanism generating tim e series $X$, is replaced by the retum $m$ ap $R$, generating the conjugate series. $W$ hile the actual exact description of this $m$ echanism $m$ ay rem ain unknown (e.g., for earthquake tim e series or neuron spike trains), the function $R$ does not depend on it and has a sim ple analytic shape.
$T$ his approach is applicable to the study of various tim e series, arising in m odem applied science (e.g., m edicine, astronom y). The innovation consists of a new way to $m$ easure the fast oscillating tim e series $\{$ this $m$ easure is the H ausdor dim ension of som e thin spaces A, to which the con jugate series are attracted. A s an exam ple of such an application, the com putational analysis of the sequences of fractional parts is presented. W e show that the results obtained testify on the possibility of C antorian structure of our usual time ow. In this context, we recall som e well known (qualitative) conclusions on irregular and intricate tim e ow, as indicated in Bergson's philosophical
treatm ents [ [1] and in som eworks on quantum physics [3, 4].
2. D escription of the $M$ ethod
2.1 F in ite di erences and con jugate orbits

W e dealw th one dim ensional, determ inistic or stochastic system s, generating num erical sequences $X=\left(x_{i}\right)_{i=1}^{1} \quad\left(0 \quad x_{i} \quad 1\right)$. W e im pose no restrictions on the system, and it $m$ ay also possess di erent inner states changing $w$ th tim $e$. Below, we set two conditions on a given orbit $X$, under which it should be regarded as chaotic. W e introduce the notion of con jugate (w ith X) orbit , in term $s$ of which the irregular nature of $X$ can be established and studied.

Let us rst give som e special representation of nite orbit $X_{k}=\left(X_{i}\right)_{i=1}^{k}$, which re ects its higher order di erential structure. For the sequence $X_{k}$ and number 1 s 1 we let

From Eq. (1) it is easy to see, that if for a given $m, 0 \quad m \quad k$ all of the nite binary sequences

are know $n$, one can com pletely restore the initial nite orbit $X_{k}=\left(x_{i}\right)_{i=1}^{k}$. H ence, it follows from (1), we can consider that nite orbits with length $k$ are given nam ely in the next special rep resentation

It is easy to see, that after applying the recurrent procedure (1) the sequence $\mathrm{X}_{\mathrm{k}}$ is com pletely recovered by k . N ow , we can introduce the basic tool of the $m$ ethod $\{$ the notion of conjugate orbit: we say, that num erical sequence $=(s)_{s=1}^{1}$ is the conjugate orbit, associated with the given orbit $X=\left(X_{i}\right)_{i=1}^{1}$, if for each $s \quad 1$ the term $s, s$ are de ned as follow $s$

Let us introduce a thin set $B$ and its subsets $B_{k}$, are the base sets, $m$ entioned in Sec.1. We consider the num bers $0<\mathrm{x}<1$ represented in the form ofbinary expansion,

Let us now suppose, that the orbit $X$ is such, that each of the sequences

where $s$ is xed, has bounded lengths of series $w$ th the sam e binary sym bol. In other words, we assum e that for increasing sequence of indeces $n_{i}^{(s)}$, des ignating all of those positions in natural series, where the changes of binary sym bol occur, $\underset{n_{i+1}^{(s)}}{(\mathrm{s})}=1 \underset{n_{i}^{(s)}}{(\mathrm{s})}$, we have

D iscrete C ase. In this case we dealw ith one dim ensional tim e series with upper bounded term $s$ and w th restricted $m$ easurem ent accuracy, know $n$ in advance. If it is som e num ber of the form $10{ }^{\mathrm{m}}, \mathrm{m} \quad 1$, then $\mathrm{m} u l t i p l y i n g$ all of the term s of our series by this quantity, we will obtain som e tim e series X , consisting of natural num bers bounded by a pregiven N ,

In otherw ords, we dealw th the random sequences [5]; particularly, such kind of sequences arise as a result of the realizations of hazard gam es. H ow ever, we consider only a special class of sequences (9) \{ as above, we im pose two lim itations (below $d \quad 1$ is som e natural num ber; we may assum ed $=1$ ) on the di erential structure of the series X :

It should be notioed, that condition $\left(\mathbb{D}_{1}\right)$ (and $\left(C_{1}\right)$ ) im plies the dim ensionality lim itations (see next section), while the ( $\mathrm{D}_{2}$ ), an analogy of $\left(\mathrm{C}_{2}\right)$, is a requirem ent on certain regularity of the process, generating $X$.

The restriction $\left(D_{2}\right)$ means, that we consider such proœsses (9), which are reduced to binary processes $X$ ( w th com ponents $\mathrm{x}_{\mathrm{i}}=0 ; 1$ ). Let us call the binary sequence $X$, satisfying the conditions $\left(D_{1}\right)$ and $\left(D_{2}\right)$ as ${ }_{k}-$ sequence and denote $\hat{\mathrm{B}_{\mathrm{K}}}$ the collection all of the numbers $\times 2(0 ; 1)$ for
which its binary expansion $x$ is $k$-sequence. From the de nition, we have the next characteristic of these sets; below $\mathrm{x}_{\mathrm{n}}={ }^{(n)}(\mathrm{x})$ and is the shift transform ation (or the "tent $m$ ap", see Ref. 6) :

A coording to P oincare recurrence theorem (see, e.g., Ref. 6), the relation

In the case $\mathrm{K}_{\mathrm{p}} \mathrm{K}$ the condition (10) m eans recurrence break (by analogy with "ergodicity break" from Ref. 7) for all points $x_{n}$. Hence, all the sets $\hat{B_{k}}$ are found within exceptional set, $m$ entioned in just quoted Poincare theorem. N ote also certain resem blance of the relation (10) w ith the basic inequalities in Li-Yorke known theorem s 㔽].

### 2.2 C on jugate attractor and return m ap

Let us now denote A the closure of con jugate orbit $(s)_{s=1}^{1}$, i.e. A $[0 ; 1]$ is the union of the set $f s: s \quad 1 g$ with the collection of all its chuster points. Then this orbit should be considered as a chaotic one, whenever A lls in either an interval or C antor set. W e note, that for the m ost actual system s the constants from Eq. (6) for all s 1 are upper bounded by the sam e num ber K 2 and, consequently,

H ence, just m entioned criterion of chaosity sim ply $m$ eans that A is a C antor set. If A appears to be the sam e set for alm ost each orbit X , then we can conclude that A is the attractor of the system. The num erical values of

H ausdor dim ension of the sets $B_{k}\left(\begin{array}{lll}2 & k & 1\end{array}\right)$ can be obtained from the formula ${ }^{[1]}$

$O$ ne can nd (in the operator form ) the fiunction $R$ in Sinai's early constructions on weak isom orphism of dynam ical system s [19, 11]. For m ore details on this function $\operatorname{Ref}$. 9, where a fractal dynam ical system is introduced.

## 3. Sequences of Fractional $P$ arts and $T$ im e $F$ low

Some works in quantum mechanics [] introduce the concept "Cantorian Spaœ-T im e". The com putationalstudy of the ow ofour usual (but in som e sense discretized) tim e, im plem ented in this section, con m s again the possibility of such a concept. W e are based on the $m$ ethod introduced $\{$ an approach com pletely di erent from those considered in other works on tim e ow 7, 12, 13].

Let us start from the statem ent and com putationalanalysis of the follow ing num ber-theoretical problem. Let us have two num bers $0<;<1$, is irrational and let

be the sequence of the fractionalparts, generated by (hereafter fxg denotes the fractional part of number $x$ ). We are interested in the behavior of the
tim e series

A coording to H.W eyl theorem [19, 14] the sequence (12) is uniform ly distributed in the interval $(0 ; 1)$, so that we have in nite num ber of $m_{k}$, satisfying (13). If we take into attention the ergodicity of the transform ation

this statem ent can also be deduced (for a.e. irrational ) from Poincare's recurrence theorem. From num erous theoretical results on the sequences of fractional parts (see details in Ref. 14), we note the follow ing Slater $\mp$ lorec theorem : for given irrational there exist two natural num bers $p$ and $q$, such that for all $k \quad 1$ we have $n_{k} 2 \mathrm{fp} ; q ; p+q g$. W e may also note a formula, obtained in Ref. 15 \{ it expresses the exact value of the total num ber of indeces $m_{k}$, satisfying (13) and not exceeding a given $N$, through the coe cients of som e expansions of the num bers N and .

O urbasic conclusion in the problem stated, deduced from com putational experim ents, can be form ulated in the next form : for each irrational0 $\ll$ 1 there exist the numbers $0 \ll 1$ such that the conjugate to X orbit is asym ptotically close to a C antor set; and conversely, for each $0 \ll 1$ there exist irrational num bers $0 \ll 1$, such that the con jugate to $X$ orbit is asym ptotically close to a C antor set.
Som e of these com putational results, on the $F$ ig. 2 are presented. H ere, the num erical value $=0: 13$ and several values of param eter are considered. In dependence of control param eter the conjugate orbits dem onstrate all possible types of m otion: the periodic, when they are attracted to som e nite set, C antorian, when the attractor A has C antorian self-sim ilar structure, and the com pletely chaotic $m$ otion, when the orbits 11 in an interval from $(0 ; 1)$. For instanœ, for $=0: 1250002$ the $C$ antorian attractor in $F$ ig. 2 b is show $n$. The graph $F$ ig. 2 a has been obtained for the value
$=0: 124999$; in this case the orbit consists of 13 straight lines (som e of them are not shown). In som e respect, the behavior (in dependence of control param eter ) of con jugate orbits in this problem rem inds Feigenbaum 's
transitions (see e.g., Ref. 6), and this needs further detailed com putational study.

To end, let us consider the follow ing interpretation of the above introduced num ber-theoretical problem; in particular, this w ill explain the title of present section. Let us have in a two dim ensional plain a circle E and a point $S$, situated outside of disc, bounded by E. Let! be the angle, under which the circle $E$ from the point $S$ is seen, and let also $L$ be an arc of $E$ $w$ ith the length $\mathrm{j} j=<$ ! $w$ th the center at the point of intersection of circle $E$ w ith the rectilinear segm ent, connecting its center $w$ ith $S$. Let us assume that the point M 2 E is rotated in discrete time $\mathrm{T}=\mathrm{f1;2;3;::::gg}$ $w$ ith the frequency. Then, the consecuitive $m$ om ents of falling the point $M$ in the arc $L$ constistute a sequence of natural num bers $m_{k} 2 \mathrm{~T}$, coinciding w ith the sequence X from Eq. (13). A lso, it is not di cult to see, that the sequence of fractional parts (12) coincides $w$ th the sequence of iterates of the function $(x)$ from Eq. (14), i.e.

and, consequently, the num bers $m_{k}$ represent the Poincare recurrence (of point $M$ into the arc L) time. Now, let us interpret E as "E arth" and $S$ as "Sun". Then, replacing the continuous rotation of E arth by discrete $m$ otion, we obtain that $m_{k}$ appears to be an approxim ate of the ow of our usual tim e. In such a way, the above described com putations dem onstrate, that in principle, it is possible that our tim e possesses the $C$ antorian structure. The num erical values of the quantities , , and ! can be speci ed for this "astronom ical" case, but here we do not dw ell on this point.

## 4. Som e Rem arks and D iscussions

Let us discuss two problem s, relating to the brain activity. In the paper Ref. 1, through the $m$ ethod above, applied to experm ental data of actual neurons, the C antorian strucuture of brain activity has been deduced. The $m$ ethod perm its further developm ent [G] by $m$ eans of introducing som edy nam ical system $F=(A ; T$; ) on the $C$ antor spaces A. The evolution operator $T$ is easly expressed through the retum $m$ ap $R$, while the attractor $A$ and invariant (singular) $m$ easure rem ain the $m$ ain quantities, distinguishing different processes. In practical applications, the measure can be calculated through frequency analysis, accepted in $m$ athem atical-linguistic works (see,
e.g. Ref. 5). H ence, we can operate w th the theoretical-inform ation characteristics of system F. W hether there exists an analogy of known B illingsleyEggleston form ula 19]
D im ension = E ntropy;
relating to Eggleston thin spaces, for the fractaldynam ical system sF ? N ote also M andelbrot's w ork [16], who considered the applications of this form ula to problem s of turbulence.

W e know [17], that there exists som e m echanism of tim e peroeption in the brain. Its activity, it follow sfrom our previous results [1], $m$ ust be found in som e thin ( $m$ ultidim ensional) Cantor space. How to relate the $m$ easurable spaces $F_{t}$ and $F_{p}$, which correspond to tim e ow and tim e perception, w th each other? Partioularly, can we com pare the values of dim $\left(A_{t}\right)$ and $\operatorname{dim}\left(A_{p}\right)$ ?

It seem s , these problem s can be resolved after detailed com putational frequency analysis, in order to com pute the invariant $m$ easures (and hence another characteristics, say, entropy) ofboth time ow and brain activity.
