Two-Particle D ispersion in M odel Velocity Fields

We consider two-particle dispersion in a velocity eld, where the relative two-point velocity scales according to $v^2(r) / r$ and the corresponding correlation time scales as (r) / r, and x = 2=3, as typical for turbulent ow s. We show that two generic types of dispersion behavior arize: For =2+ < 1 the correlations in relative velocities decouple and the di usion approximation holds. In the opposite case, =2+ > 1; the relative motion is strongly correlated. The case of K olm ogorov ow s corresponds to a marginal, nongeneric situation.

Since the sem inal work of Sir L F R ichardson on particles' dispersion in atmospheric turbulence [1] a large amount of work has been done in order to understand the fundamentals of this process (see [2] and [3] for reviews). Based on empirical evidence, R ichardson found out that the mean square distance R^2 (t) = r^2 (t) between two particles dispersed by a turbulent ow grows proportionally to t^3 . The works of 0 bukhov and B atchelor have shown that R ichardson's law is closely related to the K olm ogorov-0 bukhov scaling of the relative velocities in turbulent ows. Scaling arguments based on dimensional analysis allow then to understand the overall type of the behavior of R^2 (t), but a full theoretical picture of the dispersion process is still lacking [3].

The theoretical description of dispersion processes typically starts from models, in which one xes the spacial statistics of the well developed turbulent OW (Kolm ogorov-O bukhov energy spectrum), and discusses di erent types of tem poral behavior for the ows [3]. Three situations have been considered in-detail so far. Here, the white-in time ow s represent a toy model which allows for deep analytical insights [4-6]. In connection with "real" turbulence two other cases are widely discussed. One of them supposes that the tem poral decorrelation of the particles' relative m otion happens because the pair as a whole is moving with a mean velocity relative to an essentially frozen ow structure (as proposed by a Taylor hypothesis) [7,8]. Another premise connects this decorrelation with the death and birth of ow structures ("eddies"), whose lifetime is governed by Kolm ogorov's universality assumption [8,9]. Both these situations are extrem ely aw kw ard for theoretical analysis.

In the present letter we address the follow ing question: W hat are the generic types of two-particle dispersion behavior in a velocity eld whose statistical spatial structure is xed (and similar to that of a turbulent ow), if its tem poral correlation properties change. This question will be discussed in the fram ework of num erical simulations and scaling concepts. A swe proceed to show, two generic types of behavior arise. Thus, the white-in-tim e

ow and the Taylor-type situation belong to the classes of di usive and ballistic behavior, respectively. The case of K olm ogorov tem poral scaling represents a borderline situation.

Let us consider modes of particles' separation in a velocity eld whose two-time correlation function of relative velocities behaves as hv (r;t_1)v (r;t_2)i / v^2 (r) g [(t_2 t_2)= (r)], where (r) is the distance-dependent correlation_{R1} e. The g-function is de ned so that g(0) = 1 and $_0^0$ g(s)ds = 1. The mean square relative velocity and the correlation time scale as

O ne can visualize such a ow as being built up from several structures (plane waves, eddies, etc., see Ref.[3]), each of which is characterized by its own spatial scale and its scale-dependent correlation time. In well-developed turbulent ow s one has $\sqrt[2]{r}$ (r) / $2^{=3}r^{2=3}$, where is the energy dissipation rate, so that = 2=3. The white-in-time ow corresponds to = 0. K olm ogorov scaling im - plies = 2=3 and Taylor's frozen- ow assumption leads to = 1.

In our simulations we model the two-particle relative motion using the quasi-Lagrangian approach of Ref.[9]. Parallel to Ref.[9] we con ne ourselves to a twodimensional case, which is also of high experimental interest [12, 13]. The relative velocity v(r;t) = r (r;t) is given by the quasi-Lagrangian stream function . This function is built up from the contributions of radial octaves:



where $k_i = 2^i$, and the ow function for one-octave contribution in polar coordinates (r;) is given by $_i(k_ir;t) = F(k_ir)(A_i(t) + B_i(t)\cos(2 + i))$. The radial part F(x) obeys F(x) = $x^2(1 - x)$ for 0 x 1 and F(x) = 0 otherwise, and i are quenched random phases. M oreover, A_i (t) and B_i (t) are independent G aussian random processes with dispersions A² = B² = v₀² and with correlation times $_{i} = 2^{i}$ 0. At each time step these processes are generated according to X_i(t+ t) = $P \frac{1}{1} (t=_{i})^{2} X_{i}(t) + (t=_{i})v_{0}^{2}$, where X is A or B; and

is a G aussian random variable with zero m ean and unit variance. The values of $_0$ and the integration step t are to be chosen in such a way that $_N > t$. Typically, values of t 10⁴ are used. For the noncorrelated ow (= 0) the values of A_i (t) and B_i (t) are renewed at each integration step t. In the present simulations N = 16 was used. The value $v_0 = 1$ was employed in the majority of simulations reported here, so that only the use of a di erent v_0 value will be is explicitly stated in the following.

The values of R^2 (t) obtained from 3000 realizations of the ow for several values of 2 [0;1] are plotted on double logarithm ic scales in Fig.1, where $_0 = 0.15$ is used. One can clearly see that for all a scaling regime R^2 (t) / t appears. We note moreover that the curves for = 0.67; 0.8; 09 and 1.0 are alm ost indistinguishable within statistical errors. The values of as a function of

are presented in the insert, together with the theoretically predicted form s, vide infra.

The regimes of dispersion found in simulations can be explained within the fram ework put forward in Ref.[10]. The discussion starts by considering $l(r) = v\left(r\right)$ (r); the m ean free path ofm otion at the distance r. If this m ean free path always stays small compared to r, the relative m otion exhibits a di usive behavior with a position-dependent di usion coe cient, K (r) / $\hat{1}$ (r)= (r) / r $^{+}$. Taking as a scaling assumption r / r^{2} (t) $^{1=2}$ = R, one gets that the m ean square separation R grows as R 2 / t with

On the other hand, if l(r) is of the order of r, the m ean separation follows from the integration of the ballistic equation of motion $\frac{d}{dt}R = v(R) / R^{=2}$, see Ref.[11]. Thus, in a ow where a considerable amount of ow lines of relative velocity are open, one gets R^2 / t ; with

The occurrence of either regime is governed by the value of the (local) persistence parameter of the ow,



Sm all values of P s correspond to erratic, di usive m otion, while large values of P s im ply that the motion is strongly persistent. The value of the persistence param eter scales with r as P s(r) / r $^{=2+}$ ¹. Since under particle's dispersion the mean interparticle distance grows continuously with time, the value of Ps decreases continuously for =2 + < 1, so that the di usive approxin ation is asymptotically exact. For =2 +> 1 the lifetim es of the structures grow so fast that the di usive approximation does not hold. This situation is one observed in our simulations for > 2=3. The strong ballistic component of motion implies that the velocities stay correlated over considerable time intervals. The results of Fig.1 con m that () behaves accordingly to Eq.(4) for < 2=3 and Eq.(5) for > 2=3. W e note here that the

param eters of the simulations presented in Fig.1 ($v_0 = 1$; $_0 = 0.15$) were chosen in a way that allows to show all curves within the same time-and distance intervals. This leads to a somehow restricted scaling range and to slight overestimate of -values in the di usive domain.


Strong di erences between the di usive and the ballistic regim es can be readily inferred when looking at typicaltra jectories of the motion, such as are plotted in Fig.2 for the cases = 0:33 and = 0:67. The di erence between the trajectories is evident both in the (x;y)-plots and in the r(t)-dependences. The curves for = 0:33 exhibit a random -walk-like, erratic behavior, while the curves for = 0:67 show long periods of laminar, directed motion. In order to quantitatively characterize the strength of the velocity correlations we calculate the backwards-in-tim e correlation function (BCF) of the radial velocities, as introduced in R ef.[12]. This function is de ned as $C_r() = hr_r(t)$ (t) i= $v_r^2(t)$ and shows, what part of its history is remembered by a particle in motion. The function is plotted in Fig.3 against the dimensionless parameter # = = t. The functions (obtained in 10⁴ realizations each) are plotted for 4 dimensionless of parameters. Here the dashed lines correspond to

= 0.33, in the di usive range, for $t = 10^{2}$; 3 10^{2} ; 10^{-1} and 3^{-1} . These BCF do not scale and are rather sharply peaked close to zero, thus indicating the loss of m em ory. The two sets of full lines indicate C_r() in Kolmogorov ows, fort = 10^2 ; $3 10^2$; and 10^1 . The lower set corresponds to the value $_0 = 0.05$ and the upper set to the value $_0 = 0.15$. In both cases the functions show scaling behavior. No considerable changes in the BCF's form occur when further increasing the value of 0 up to $_0 = 1$, thus indicating that the data $_0 = 0.15$ correspond already to a strongly correlated regime. The form of these curves resembles closely the experimental ndings of Ref. [12]. The BCFs for = 1.0 show an overall behavior very sim ilar to the one in Kolm ogorov's case. Note that as the time grows the curves for = 1:0 approach those for = 2=3 and probably tend to the same lim it. The curves for = 1.0 and $_0 = 1$ (not shown) fall together with those in Kolm opprov's case with $_0 = 0:15$.

The similarity in the properties of dispersion processes in a K olm oporov situation with larger P s (larger $_0$) and in ballistic regime can be explained based on the behavior of the elective persistence parameter. In the diusive regime we supposed that the correlation time of the particles' relative velocity scales in the same way as the Eulerian lifetime of the corresponding structures. On the other hand, in the ballistic regime, > 1 = 2, the lifetimes of the structures grow so fast that no considerable decorrelation takes place during the time the particles sweep through the structure. The Lagrangian decorrelation process is then connected not to Eulerian decorrelation, but to sweeping along open ow lines. The e ective correlation time then scales according to $_{\rm s}$ (r) / r=v(r) / t¹ =², and the e ective value of stagnates at = 1 =2. Thus, all long-time correlated cases belong to the same universality class of strongly-correlated ow s, as the Kolm ogorov ow s with large P s, for which Eq.(4) and (5) coincide.





ows the ballistic and the di u-For Kolm ogorov sive mechanisms lead to the same functional form of R^{2} (t)-dependence. The functional form of the dependence of R^2 (t) on parameters of the ow is R^2 / $v_0^2 = r_0^+$ t in the di usive situation (P s 1) and $R^2 / v_0 = r_0^{=2}$ t in the ballistic case (P s 1). Assum ing that Ps is the single relevant parameter goveming the dispersion we are lead to the form R^2 (t) / $f(P s) v_0 = r_0^{=2}$ t, where f (Ps) is a universal function of Ps, which behaves as Ps for Ps 1 and tends to a constant for Ps 1. Thus, for a xed spatial structure of the ow, the following scaling assumption is supposed to hold:

which scaling can be checked in our case by plotting $R^{2}(t) = (v_{0}t)^{3}$ against v_{0} . The corresponding plot is given in Fig. 4, where we x t = 0:1, and plot the results in three series of simulations. Each point corresponds to an average over 5 1^{4} Oruns. Here the squares correspond

to $v_0 = 1$ and to the values of $_0$ ranging between 0.01 and 0.15, the triangles correspond to $v_0 = 0.3$ and th $_0$ between 0.033 and 0.5, and the circles to $_0 = 0.1$ and to values of v_0 between 0.1 and 1.5. The error bar indicates a typical statistical error as inferred from 5 sim ilar series of 5 1⁴0 runs each. The scaling proposed by Eq.(7) is well-obeyed by the results. Some points outside of the range of Fig.4 were also checked. Thus, for larger values of v_{0-0} the values of R^2 (t)=(v_0 t)³ seem to stagnate. On the other hand, increasing v_{0-0} to values larger than 0.3 (i.e. approaching the frozen ow regin e) leads to a strong increase in uctuations, making the results less reliable.

Let us sum m arize our ndings. Thus, we considered two-particle dispersion in a velocity eld scaling according to v^2 (r) / $r^{2=3}$ and (r) / r. We show that two generic types of behavior are possible: For =2 +< 1 the di usion approximation holds and the increase in the interparticle distances is governed by the distancedependent di usion coe cient K (r) / r⁺ . In the opposite case =2 +> 1 the relative velocities stay strongly correlated. The transition between the two regim es takes place exactly for the Kolm ogorov ow, for which =2 += 1. In this case the properties of the dispersion process depend on the persistence parameter of the ow.
