Spectral Properties of A tom s in Fields: A Sem iclassical A nalysis

We develop a sem iclassical theory for the spectral rigidity of non-hydrogenic Rydberg atom s in electric elds and evaluate the signi cant deviations from the well-known Poissonian behaviour in the hydrogenic case. The resulting formula is shown to be in excellent agreement with the exact quantal result. We also investigate diam agnetic atom s; we nd that, in contrast to the classically integrable atom s, di raction has a smalle ect on the spectral rigidity in the classically chaotic atom. We show our predictions can also be of use in the mixed phase space regime.

The short-range spectral properties of non-hydrogenic Rydberg atom s in external elds were recently found to have an unexpected character [1], the nearest neighbourdistribution was neither Poisson nor W igner-Dyson, but close to a new generic intermediate class known as half-Poisson. These ndings have been investigated experimentally for helium atoms in electric elds [2], following much interest in the dynamics of non-hydrogenic atom sin weak elds and the e ects of core-induced chaos [3{7]. Concurrently, there has also been much interest in such intermediate Nearest Neighbour distributions [8,9] with broad application in problem s such as electronelectron interactions in closed m esoscopic devices [9,10], the metal-insulator transition [11], intruder states in nuclear physics [12], and inclusions in billiards [8]. These studies of intermediate statistics have exclusively employed quantum calculations.

Here we obtain spectral rigidities of non-hydrogenic Rydberg atoms in electric and magnetic elds from an accurate quantal calculation. We nd interesting and substantial deviations from Poissonian (hydrogenic) behaviour in the integrable (electric eld) and near integrable (weak magnetic eld) case. We develop a sem iclassical theory for Stark spectra which is in good agreem ent with the quantal results and shows that one-scatter di ractive orbits account for most of the e ect. In contrast we nd a comparatively smalle ect in the case of fully chaotic Rydberg atom s. To our know ledge this is the rst analysis of the curve-form of the spectral rigidity for a generic atom, which we derive from classical dynam ical information. Our sem iclassical analysis should be extendable to the mixed phase space Kolm ogorov-A mold-Moser (KAM) case.

The spectral rigidity, de ned as

where N (E) is the spectral staircase function, is the density of states (assumed constant over the range of L to be considered) and $h::i_E$ denotes averaging over the spectrum, was rstanalysed sem iclassically for classically integrable and chaotic system s by B erry [13]. It provides a measure of long-ranged deviations from the W eyl rule for spectral density, and for di raction-free systems is

controlled (for L > 0 (1)) by classical dynam ical correlations. For L < 0 (1) it converges universally to the form (L) = L=15 for symmetry reduced spectra.

The hydrogen atom in a static electric eld (of strength F) or in a magnetic eld (of strength B) provided som e of the cleanest illustrations of integrability, m ixed phase space and chaos in a real system [14]. The dynamics of the electron is two-dimensional and has a useful scaling property: the classical dynam ics depends only on a scaled energy = E^{2} , where = $F^{1=4}$ for the electric eld case and $= B^{1=3}$ for the magnetic eld case. This property is exploited in both experiment and theory. Spectra are obtained at xed and the corresponding eigenvalues i represent e ective values of h⁻¹ with xed classical dynam ics. Hydrogen in a magnetic eld is near-integrable for < 0.5; as the eld is increased it makes a gradual transition to full chaos at ' 0:1. The Ham iltonian for hydrogen in an electric eld is always separable. We consider eld values where the eigenvalues are well below the ionization threshold at = 2,50 the system may be considered integrable and bound.

M ost experim ents in fact investigate atom s other than hydrogen (typically He, Lior Rb). The useful scaling property may still be exploited but the inner core of electrons yields non-trivial e ects: additional weak spectral modulations and spectral statistics near the W igner-Dyson lim it even for the integrable/near integrable regime [4{6]. Hence the interest in so-called core-induced chaos. The additional modulations are accurately described by D i ractive Periodic O rbit Theory [7]. An investigation [1] of the NNS statistics for the low est 40,000 eigenvalues show ed that they are only near W igner-D yson for the low est 1000 states. For sm all h they were found to make a transition to an interm ediate se^{2s} with (distribution P (s) 3 4), near to the Half-Poisson distribution (for which = 4).

Rydberg atom s and m olecules are well described by Q uantum D effect Theory, one of the most widely used theories in atom ic physics [14,3]. The core is described by a set of phaseshifts (quantum defects) $_1$ in each partial wave, quantifying the departure from pure C oulom b behaviour. We consider the s-wave scattering case, where $_0$ is the only non-zero phaseshift, which describes lithium ($_0$ ' 0:41) and helium ($_0$ ' 0:3 for triplet and

 $_0$ ' 0:14 for singlet helium) extremely well.

The insertion of a single scattering channel can be represented as a perturbation by a projection operator. In this case, it has been shown [1,8,9,12] that the eigenvalues of the perturbed system remain trapped between the unperturbed eigenvalues. This trapping puts a strong restriction on perturbations to long-range spectral correlations; indeed, in the lim it h ! 0; L ! 1, the perturbed spectral rigidity can di er from the unperturbed one by at most som e value, bounded by 0 and 2.




FIG.1. Rigidities calculated from quantal spectra of hydrogen and lithium-like atom for = 3. The elective values of h⁻¹ (ie the) are indicated. The straight line indicates the L=15 Poisson limit. The gure shows that the non-hydrogenic rigidities follow a signi cantly dierent curve. Surprisingly, given the h dependent nature of the diractive process, the perturbed curves are essentially independent of h below the saturation value of L L_{max} . The curves from our nal sem iclassical form ula, Eq.(9), corresponding to both the SC (= :16) and QM (= :21) values of the constant shift are superposed on the = 600 non-hydrogenic quantal rigidity, show ing the excellent agreem ent and the relatively m odest e ect of the uncertainty in the shift.

W e have calculated the low est 36000 states of the Stark spectrum for magnetic quantum number m = 0, = 3 and a range of quantum defects. The results for $_0 = 0$ (hydrogen) and $_0 = =2$ ('lithium') for values of the e ective h ¹, < 600 are shown in Fig 1. These values span and go well beyond typical experimental values. (the experimental NNS statistics [2] correspond to 130 150). Fig 1 shows that for our < 600 range, deviations from Poissonian/hydrogenic ($_0 = 0$) behaviour are substantial. Even for such sm all values of the e ective h though, it is evident that the perturbed curves are not obtained by a simple constant shift.

The electronic core yields a combination of C oulom b and s-wave scattering. The C oulom b scattering generates G utzw iller Periodic O rbits (PO s): geometric orbits. The e ect of the s-wave $\int \underline{0}$) scattering is to generate di ractive trajectories, O (h) in amplitude weaker than isolated geometric PO s. For atom ic core-scattering orbits which close at the nucleus corresponds to either periodic or half-periodic orbits : hence -for chaotic or regular dynam ics- every di ractive orbit resulting from a single scattering is paired with a geometric periodic orbit or a half-periodic orbit of the same action. In the Stark case there are no half-period contributions; in the m agnetic eld case there are half-period di ractive contributions (the 'D' orbits seen in [7]). A llmultiple scattering di ractive orbits can likew ise be associated with a given com bination of geom etric periodic or half-periodic orbits. In contrast, in billiard system s di ractive orbits are generally unrelated to the geom etric periodic orbits. Their proliferation relative to geom etric orbits in the chaotic regim e is not restricted by this 'pairing'. It results in a non-vanishing sem iclassical contribution [17].

For integrable atom ic spectra, the geom etric contribution to the staircase function N_G () = N_G^{s} () + N_G^{osc} () includes a sum over contributions [18] from integrable tori. In the scaled atom ic spectra, N_G^{osc} () $P_{j}^{-1}(A_j=T_j)e^{i(S_j - j^{-2})}$ The amplitudes A_j are the Berry-Taboram plitudes for resonant toriwhich, in action angle variables is $A_j = 2 = j! \ \mathfrak{L}_j = \mathfrak{C}_j p$ etf $\mathfrak{C} = \mathfrak{C}_j \mathfrak{g}$ All tori contain just one PO that collides with the nucleus. 


FIG.2. Fourier transforms of scaled spectra for hydrogen and a lithium-like atom (= 0.5) for = 3 from a fully quantal calculation. The inset am pli es the region around S 17. The am plitudes of the di ractive orbits m ay be obtained from the (com plex) di erence of the hydrogen and lithium traces. The am plitudes of multiple-scattering di ractive orbits O ($h^{n=2}$) are relatively weak, but in the very large S regime (L 0 (1)) the proliferation in the number of n scatter orbits with increasing action m eans that the n = 1 contribution ceases to be predom inant.

Hence the C_j are independent of and do not scale with orbit length. They are nearly constant and uctuate weakly about an average value [16]. From the Fourier transforms of scaled spectra , we can con rm this behaviour. The $A_D = A_G$ ratios and hence the C_j statistics are obtained num erically from the rst 50 pairs.

Since the ratio of the one-scatter di ractive orbits to the resonant tori contributions is O (S=), which in the unscaled spectra is O (hT), on classical time escales di raction has a very small e ect, but on quantum timescales (T 1=h) both contributions are of the same order. We show that a sem iclassical analysis of the rigidity is su - cient to reproduce such essentially quantum phenomena.




FIG.3. Comparison between exact diagonalisation (QM) and Eq.(9) (SC) for the integrable case of atom s in electric elds for scaled eld = 3 for 600, = 21. In order to expose the approxim ately logarithm ic nature of the di ractive correction here we plot the di erence between the hydrogenic and di ractive rigidities. The inset shows the corresponding (quantal only) results for atom s in magnetic elds for the near-integrable/m ixed case (solid line, = :6. 150)which is qualitatively sim ilar to the integrable case and the fully chaotic rigidity di erences (dotted line = :1, 125) which are 0.

W e have also calculated the lowest 10000 states of the diam aquetic problem = 0:6 (near-integrable), and 0:1 (chaotic). The results are in Fig 3 (inset). = In the chaotic case we nd almost no perturbation of the hydrogenic result. Isolated hyperbolically unstable orbits contribute like j2 TrM j¹⁼², which vanishes exponentially with the orbit period. In such a system, m_{12} typically diverges with the same Lyapunov exponent as ${\tt TrM}$. Hence $A_D^j = A_G^j$ is O(h) regardless of trajectory length. Proliferation of di ractive orbits relative to geometric ones is restricted to additional half-period contributions by some orbits, in contrast to the billiard result [17], where any fraction may contribute. We conclude that, in the accessible h range, the di ractive e ect remains sm all for the chaotic atom, but represents a substantial e ect in the integrable case, on quantum tim escales.

In the KAM system, deviations qualitatively similar in form to the integrable case occur. We do not attempt a rigorous analysis of systems with a mixed classical phase space, but the numerics support the notion that the structure of the Berry-Tabor form ula [18] is retained for near-integrable KAM systems [19], and that our analysis could also not application in such systems.

The preceding arguments are of course incomplete for the rigorous development of a semiclassical limit, as we do not consider multiple scattering e ects such as the creation of the combination orbits. However, we will see that in the numerically accessible regime (and indeed far beyond experimental resolution) it is not necessary to consider such e ects to accurately reproduce the diractive corrections to the spectral statistics for L > 0 (1), up to a sm all constant correction.

We now analyze the case of a non-hydrogenic Stark atom. Since we will only be interested in long orbits, for which the uniform ity principle [20] can be invoked to connect period with action, we can write the Berry-Tabor form ula as a sum over all periodic orbits j (including retracing to negative tim e) in the form :

Here S_j , j, are the scaled action and the M aslov index, A_j is the scaled amplitude factor from [18], ¹ = $(N^{s}=0)$, and ¹ = $(N^{s}=0)$. Note that = scales as .

The contribution to the spectral staircase from the corresponding single-scatter di ractive periodic orbits yields a sum over the same set of periodic orbits as in Eq.(2):

where the phases hift $_0$ is positive for forw and time tracings, and negative for negative time retracings.

The rigidity formula (1), which is easily adapted for the problem in hand where the levels are the $_{\rm i}$, leads to integrals involving the products hN $_{\rm G}$ N $_{\rm G}$ i , hN $_{\rm G}$ N $_{\rm D}$ i and hN $_{\rm D}$ N $_{\rm D}$ i . These products involve m any rapidly oscillating term s, which, following Berry [13], we assume to vanish upon averaging. This approximation is usually known as the diagonal approximation, but here we retain di erent (o -diagonal) trajectories with identical action, which occur due to di raction.

The resulting equation for the rigidity can be written

). We have had to introduce an upper cut-o (v to the integrals, which will be seen to diverge. This divergence is a direct result of neglecting the rapidly oscillating term s, and will be discussed further below . W e now concentrate on evaluating the integrands of (5) and (6). For long orbits, we invoke the Hannay-O zorio de Almeida sum rule [20], which can be expressed as $_{1}A_{1}^{2}$ (S S₁) = (= 2)=2 3 which is inlim_{s!1} dependent of . We consider this to be accurate for S > S, so that our result for (4) will only be accurate for L < $L_{m\,\,ax}$ = 2 = $\,$ S $\,$. Indeed $L_{m\,\,ax}$ also m arks the onset of non-universal deviations of the non-di ractive result from the simple L=15 dependence [13]. Inserting the sum rule into (5) and (6), averaging over the distribution of C₁ and evaluating the integrals, leads to closed form solutions that can be expressed in terms of special functions [16]. Here, we only write out the asymptotic approxim ations to the solutions:

where $_{\rm E}$ is Euler's constant. is a constant, independent of and 2 for our Stark spectra. The result is valid for L > L_c, and the ambiguity in L_c leads to an ambiguity in the constant term. For L $_{\rm L_c}$ both

^{D D} and ^{D G} vanish. To proceed, one should invoke the sem iclassical sum rule due to Berry [13]. It is natural to then identify L_c as $2 = S_c$, (eg L_c :94 for the case in Fig. 3) where S_c is the point where the sem iclassicaland quantum asymptotes for the form factor coincide. Since we have neglected both o -diagonal corrections and higher order scattering contributions, we cannot expect to be able to evaluate the constant term correctly. In this case we can simply set L_c to unity, and accept that our result m ay not be accurate around L ' 1. We note that in the GOE case it is not possible to evaluate the constant term sem iclassically either [13].

The nal result for the rigidity is then

for $L_{max} > L > 1$, where is the constant shift. For L < 1, $\circ (L) = L=15$. The nalform ula hence does not contain the e ective P lanck's constant, proving the most surprising feature of Fig. 1 namely that despite the h-dependent nature of the diractive corrections, our quantal results (below L_{max}) are essentially h-independent.

0.21. The correction required can be attributed to the neglect of both higher order scattering, and o diagonal contributions.

Our result is compared with the fully quantal values shown in Fig. 1, and the quantal and sem iclassical rigidities are plotted in Fig. 3. The agreement (to within the small correction to $\,$) is extremely good up to $L_{m\,ax}$, where the breakdown was expected. The divergent nature of Eq.(9) for L $\,<\,1$ is clearly seen. The \sin^2_{0} dependence has been veried by considering several different defect values (not shown) [16].

To sum m arise, we have com bined the sem iclassical theory of di raction and atom ic Q uantum D effect Theory with the Berry-Tabor trace form ula to give di ractive corrections to the spectral rigidity of atom s in elds. W e show that within a sm all constant shift, the sem iclassical one-scatter results agree extrem ely accurately with the fully quantal results.
