# Extraction of inform ation about periodic orb its from scattering functions

#### Abstract

A s a contribution to the inverse scattering problem for classical chaotic system s, we show that we can select sequences of intervals of continuity, each of w hidh yields the inform ation about period, eigenvalue and sym $m$ etry of one unstable periodic orbit. In the fram ew ork of the study of the inverse scattering problem for classical chaotic scattering in two dim ensions, the attention has been focussed on the topology of the chaotic saddle $[1,2]$ and on the de nition of an appropriate partition [3]; therm odynam ic quantities were also discussed $m$ arginally [1]. In none of these approaches the speci c properties of the unstable periodic orbits were explicitly searched for. Y et know ledge of these, goes a long way tow ards understanding the chaotic saddle. U sually the shortest onbits overshadow the chaotic set or, in other words, they form the skeleton of the globally unstable com ponent of the invariant set. A s far as sem i-classical approxim ations are concemed, these orbits form the backbone of all considerations that lead to trace form ulae [4\{6]. The $m$ ost usefiul inform ations are their periods and Lyapunov exponents. These can be used to determ ine the hierarchical order in the pattem of intervals of continuity (henceforth abbreviated to IO C) in the scattering functions, but at the sam e tim e it is this very pattem, which allow s us to leam som ething about the periodic orbits from scattering functions.

In this article we shall focus on the latter part, i.e. on obtaining the periods and the Lyapunov exponents of unstable periodic orbits from regular pattems of the IOC of scattering functions. The latter we de ne as a function of the points on a line in the space of initial conditions, that gives som e property of the scattering process such as e.g. tim e delay or scattering angle (cf g.1).

A fter recalling som e know n results [7] conceming the extemal periodic onbits we present twomethods to achieve our goal for periodic orbits that are both fairly short and not too unstable. W e ilhustrate these $m$ ethods by scattering a charged particle 0 a $m$ agnetic dipole. The reader $m$ ay $w$ ant to refer to the gures of the exam ple while reading the description of the generalm ethod.

The trajectories belonging to one IO C of a scattering function all leave the interaction region crossing the sam e extemal orbit i.e. leaving through the sam e saddle or \doorway". W hen the intial condition approaches one of the boundary points of the IO C from the inside, the scattering tra jectory executes an increasing number of revolutions along the saddle orbit before it nally leaves the interaction region. For each revolution we expect an oscillation of the scattering angle (cf g.2).T he frequency of this oscillations increases with the diverging tim e delay. A n asym ptotic observer can detem ine a sequence of in itial conditions from w ithin one and the sam e IO C , which are separated by a full oscillation of the scattering angle. This sequence converges to the boundary of the IO C in such a way, that, in the lim it, the distance from the boundary point decreases by a factor determ ined by the eigenvalue of the saddle orbit. In the sam e lim it the tim e delay increases by the period of this orbit, when going from one $m$ ember of this sequence to the next. From these two quantities the Lyapunov exponent can be calculated. If there are several extemal orbits we can investigate each of them separately, choosing an appropriate IO C, where the outgoing scattering tra jectories cross exactly this onbit before nally leaving the interaction region. Inform ation about any of the intemal orbits cannot be obtained in this way.

Based on this result we propose two m ethods to obtain both periods and Lyapunov exponents for inner periodic orbits. The rst will use the tim e delay function only whereas the second exploits in addition the other scattering functions. To achieve this we analyze how the inner onbits in uence the hierarchical pattem of IO C .

T he basic idea for ourm ethod is provided by the follow ing property of chaotic scattering: To each periodic orbit ,which can be reached from the outside, there exist in nitely $m$ any sequenœes of 10 C (cf g.1) of the scattering functions. The com $m$ on feature of these sequences is the follow ing: A s we m ove along the sequence, sooner or later one step im plies precisely one revolution of the trajectory close to the periodic orbit . The central problem will.be to identify a sequence which is clearly associated w ith one periodic onbit. If we knew such sequences in advance, then it would be easy to nd the period and the Lyapunov exponent of the periodic orbit .

W e label the IO C form ing the selected sequence by $\mathrm{fI}^{(k)} g_{\mathrm{k} 2 \mathrm{~N}}$ where k labels the order of the elem ents of the sequence, $L\left(I^{(k)}\right)$ indicates the length of the IO C and $t\left(I^{(k)}\right)$ a typical tim e delay for this $I O C$ which we obtain by choos-
ing a representative trajectory for each IO C. It is convenient to choose the representatives to have the absolute $m$ inim altim e delay within an IO C .

At large tim e delays two consecutive representatives di er only in one additional revolution along the unstable periodic orbit. In order to extract periods and Lyapunov exponents of unstable periodic orbits from the tim e delay function, we need to know the representative tim e delays and lengths of as $m$ any IO C as possible. W e determ ine the ratio ${ }^{\sim(k)}=L\left(I^{(k)}\right)=L\left(I^{(k+1)}\right)$ of the lengths of consecutive pairs of IO C and the di erence of their representative tim e delays $T^{(k)}=t\left(I^{(k+1)}\right) \quad t\left(I^{(k)}\right)$. W e also de ne

If the sequence was chosen appropriately, $T^{(k)} \mathrm{w}$ ill converge to the period $T$ of the orbit,$\sim^{(k)}$ to its eigenvalue and $\sim^{(k)}$ to its Lyapunov exponent .

A s m entioned above the choige of the sequence is critical and di cult. W e therefore proceed to show how this choige can be partially avoided sim ultaneously w ith the approxim ative evaluation of the quantities above. If we plot either ${ }^{\sim(k)}$ or ${ }^{\sim(k)}$ against $\mathrm{T}^{(k)}$ we should nd an accum ulation point near the correct value of ( ,T ) or (,$T$ ) respectively. $N$ ote that each of the in nitely $m$ any sequences associated to one periodic orbit $w$ ill approach the sam e accum ulation point. Furthem ore points ( $\sim 0, T_{0}$ ) or ( $\sim 0, T_{0}$ ) erroneously taken because they belong to a sequence for a di erent periodic onbit w ill have different accum ulation points, except if both period and eigenvalue for the two orbits coincide. If the error is such that the pairs are obtained from IO C of sequences that belong to di erent periodic orbits no accum ulation points are expected. It is thus tem pting to perform this plot using points generated for all pairs of IO C available.

In principle we should then nd accum ulation points form any periodic onbits. $T$ his $w$ ill not be im plem ented easily because if we have su cient IO $C$ to expect reasonable convergence along one sequence, the plot w ould have so many points that it would be very di cult to identify these accum ulation points. E ven w orse, the discrete num ericsm ay sim ulate structures that do not exist. In order to identify the accum ulation points, only pairs of IO C that m ight belong to the sam e sequence have to be taken into account. A ppropriate strategies to achieve this goalm ust be developed. A $n$ inspection of the hierarchical stnucture corresponding to the tim e delay function show s that successive IO C have to be connected by pieces of equal or higher hierarchical order. T herefore only pairs of IO C are tested w ith no intervening IO C possessing low er tim e delays. Further ltering $m$ ay well be necessary.

Ifw e proceed using the tim e delay function as the only souroe ofinform ation,
we can start to look form ultiplets of IO C which apparently belong to one sequence. Each of its $m$ embers should have a higher representative tim e delay than its predecessor w ithout intervening IO C w th low er tim e delays. If such a multiplet belongs to a single sequence its successive IO C should show roughly the same di erences in time delay and ratios of successive lengths (cf $g .3$ ). By narrow ing the lim its for the allowed di erences in time delay and ratios of the multiplets, im proved convergence tow ards a periodic orbit can be prom oted.
If other scattering functions are also available, pairs of IO C that belong to a sequence can be identi ed by com paring their representative nal conditions. A gain only pairs of IO C w ithout intervening IO C w th lower representative tim e delays are taken into account. Since the nal conditions of representative trajectories converge in the lim it of high tim e delays to a point, tw o successive IO C can be tentatively identi ed by looking for those w ith close representative nalconditions.

B oth $m$ ethods yield not only the basic periods but also, in a dim inished extent, integer multiples thereof.

To illustrate these $m$ ethods we use the scattering of a charged point particle o a m agnetic dipole. This model is also know n as the Storm er problem [8]. A fter elim inating the rotational degree of freedom and a suitable rescaling in cylindrical coordinates one is left w ith a H am iltonian of the form :

Here ( $p ; p_{z}$ ) are the $m$ om enta conjugate to ( $; z$ ). It is well known that the resulting phase ow represents a chaotic scattering system [9,10]. An analytical proof for its non-integrability is given in [11]. Every scattering tra jectory is uniquely determ ined in the asym ptotic region by the im pact param eter $b_{\text {in }}$ and the angle in between its velocity vector and the negative -axis. A detailed description of the chaotic dynam ics of this system for the energy range [0:031; 0:081] can be found in [10]. The two fundam ental periodic orbits of the binary horseshoe will be called A and C. The outer orbit C is accessible from the outside for all energies whereas the inner one A m ay be at the center of an elliptic island for som e energies.
For illustration we will consider the hyperbolic case at an energy $\mathrm{E}=0: 062$ and show how to extract inform ation on A and other inner periodic orbits. N ote that hyperbolicity is no prerequisite for the $m$ ethods presented here. For the integration of the equations ofm otion a Bulirsch-Stoer algorithm [12] has been used. The smulation takes place in a disk of radius 1000 around the origin of the ( ;z)-plane.
A part of a typical sequence whose tra jectories come close to A is shown as

IO C in a time delay function in 9 . 1. In $g .2$ the nal angles out of the trajectories from the $I O C f_{A}^{(k)} g_{1} k \quad 5$ are plotted against their corresponding tim e delay values.

In this plot several essential features can be seen.
(1) A s the tim e delay increases the period of the curves converge tow ards the period of the outer periodic orbit C.This is a direct consequence of the additional revolutions near $C$ w ith initial conditions near the boundary of an IOC.
(2) The di erences of the representative ( $m$ inim al) tim edelays $t\left(I_{A}^{(k)}\right.$ ) of consecutive IO C converges tow ards half the period of the inner periodic orbit A.
(3) The lower end of the curves of every second IO C point in the sam e direction. This e ect has its origin in the com $m$ on re ection sym $m$ etry on the -axis of A and the Ham iltonian. If A and the Ham iltonian had no com $m$ on sym $m$ etry

would not be full led. In such a case there w ould be tw o sequences w hose m em bers w ere separated by the fill period of the corresponding periodic orbit. This show s that by using only the tim e delay function as a source of inform ation it $m$ ight be unclear whether we $m$ easure the whole period of a periodic onbit $w$ ithout sym $m$ etries or its $n$-th part of an periodic onbit $w$ th a cyclic sym metry group of order $n$. U sing additional inform ation provided by other scattering functions as out and bout can give helpful hints to the answer of this question.

In order to resolve about 608 IO C we scatter $10^{7}$ trajectories with in $=0$ and $b_{\text {in }}$ evenly distributed on the interval [1.3049,1.3065]. If we apply the Iter that respects the hierarchical structure and look for triples of IO C $\left(I^{(k}{ }^{1)} ; I^{(k)} ; I^{(k+1)}\right)$ w th the property

we end up with 64 of such triples. Each triple of IOC yields two points $\left(^{(k)} ; T^{(k)}\right)$ in 9.3 . $N$ ot all 128 points are located in the area show $n$ in this gure but the chosen resolution of $10^{7}$ points was too poor for a m eaningful prediction of orbits $w$ th sym $m$ etry reduced periods longer than $T=15$. The m ore dots are clustered in a group the likelier it is to nd a periodic orbit w ith roughly these values for its sym $m$ etry reduced period and Lyapunov exponent. In g.3, apart from the tim es for one revolution around a sym m etry reduced
periodic orbit ( $A^{1=2} ; C^{1=2}$ ) integer $m$ ultiples of these tim es are also recognizable ( $\mathrm{A} ; \mathrm{C}$ ). A $m$ ong the periodic orbits ofour system shown in g .4 only three orbits ( $A, C$ and I) rem ain invariant under a re ection on the -axis. T he rest of the orbits either change their direction of rotation ( $B, D, F, G$ and $H$ ) or are $m$ apped onto their $m$ irror im age ( $E$ ). Thus for orbits A , $C$ and I the half periods show up besides the full ones in 9.3.

A ltematively we m ay use pairs with sim ilar nal conditions retaining the restriction derived from the hierardical structure of the tim e delay function. W e accept pairs of IO C whose representative trajectories di er in outgoing angle by less than 0:1 and in the outgoing im pact param eter by less than $0: 01$ in our scale. W e plot the 115 obtained points in g .5 sim ilar to g .3. $N$ ow half periods w ill not appear because we did not sym $m$ etrize the outgoing asym ptotic param eter. C om paring the two gures we see that the second m ethod allows to identify m ore periods. W hile in g .3 accum ulation points are not very obvious in 9.5 they appear rather clearly in a few instances. W here they appear the Lyapunov exponent indeed seem s to converge tow ard the exact value. $N$ ote the di erence in scales for tim e delay and exponents. C onsidering that the Lyapunov exponent is an average, once identi ed, the points belonging to one period can be averaged. Table 1 show s that for the points in $g .5$ the average $m$ atches the exact value quite well.

Sum $m$ arising we have presented a new approach to the inverse scattering problem for chaotic H am ittonian system s . In distinction to earlier work [1\{3] we do not require the system to have an intemal or extemal clock. Furtherm ore we are able to extract $m$ ore detailed inform ation about the properties of the m ost im portant periodic orbits. The possibilities inherent to this approach are much larger than what was presented in this letter. M ore extensive research on the ltering techniques $m$ ust be done and the optim al approach $m$ ay well depend on the problem. A lso much larger num bers of intervals of continuity $m$ ust be generated to be able to analyze the structure of the ( $\sim ; T$ )-plane. Finally the possibility to obtain quite easily the periods of the shortest periodic orbits $m$ ay be used to provide an inner clock that alw ays exist for the $m$ ethod proposed in [1].
