## Determ ining the W iedem ann-Franz ratio from the therm al H all conductivity: A pplication to C u and YBa<sub>2</sub>Cu<sub>3</sub>O<sub>6:95</sub>.

The W iedem ann-Franz (W F) ratio compares the therm al and electrical conductivities in a metal. W e describe a new way to determ ine its value, based on the therm al H all conductivity. The technique is applied to copper and to untwinned YBaCuO. In the latter, we uncover a T-linear dependence and suppression of the H all-channel W F ratio. W e discuss the implications of this suppression. The general suppression of the W F ratio in systems with predom inant electron-electron scattering is discussed.

The electron uid in a metal is an excellent conductor of both electric charge and entropy. In familiar metals such as Au, Pb and Cu, the therm al conductivity of the electrons is so large that the phonons account for less than one percent of the heat current at any temperature T.W iedem ann and Franz (W F) observed that the ratio of the therm al and electrical conductivities is very nearly the same in many metals [1]. This ratio is expressed as the Lorenz number, which is conveniently written in dimensionless form as

$$L = \frac{e}{T} \left( \frac{e}{k_{\rm B}} \right)^2 ; \qquad (1)$$

where e is the electronic therm al conductivity, the electrical conductivity, e the elementary charge, and  $k_{B}$ is Boltzm ann's constant. In standard transport theory, L equals the Som m erfeld value <sup>2</sup>=3 if the m ean-free-paths (m fp) are assumed identical for charge and heat transport. Indeed, in all conventional metals, the observed L is rather close to this num ber above 273 K [2]. How ever, below 273 K, the observed L falls signi cantly below this value, im plying that the heat current is more strongly scattered relative to the charge current. B ecause L com pares directly the charge and entropy currents, it has contributed strongly to our current understanding of how charge and entropy currents are a ected by distinct scattering processes in conventionalm etals [3].

In solids, the observed therm al conductivity is the sum of the electronic and phonon conductivity  $_{\rm ph}$ , viz. =  $_{\rm e}$  +  $_{\rm ph}$ . In conventional metals where  $_{\rm ph}$  e, one may use instead of  $_{\rm e}$  to evaluate L with negligible error. However, in conductors with relatively small carrier densities,  $_{\rm ph}$  is often much larger than  $_{\rm e}$ . These conductors (with resistivities exceeding 100 cm ) include m any interesting conductors such as the cuprates, doped fullerenes, quasicrystals, and new erm aterials such as C aB<sub>6</sub> [4]. Recent theoretical discussions of charge versus entropy currents are most applicable to these conductors. Ironically, their W F ratio seem s experimentally inaccessible using conventional techniques. Hence, a fresh experimental approach is desirable.

The therm al H alle ect provides a rather e cient way to screen out the phonon heat current (even when it is dom inant). In zero eld, the observed therm al current  $J_Q$  is parallel to the tem perature gradient r T (applied k  $\hat{x}$ ). A eld H k  $\hat{z}$  generates a Lorentz force that acts only on the electronic component of  $J_Q$ . This produces a transverse H all current parallel to  $\hat{y}$  (depending on the sign of the charge carriers). Thus, the transverse H all conductivity xy involves only the electrons (the phonon current is strictly una ected by H). By form ing the ratio in Eq. 1 with xy and the electrical H all conductivity xy, we may measure directly the H all' Lorenz number  $L_{xy} = [x_y = T_{xy}](e=k_B)^2$ . At su ciently high T,  $L_{xy}$  approaches the Som merfeld value [8].

We have applied the technique to a detwinned crystal of optimally-doped cuprate YBa<sub>2</sub>Cu<sub>3</sub>O<sub>6:95</sub> (YBCO) with a critical temperature  $T_c = 93.3$  K, and to elemental Cu. A longitudinal gradient  $Q_rT$  ( 2 K) is applied k a of the YBCO crystal, and the transverse gradient  $Q_rT$  is measured using a pair of therm occuples (chrom el-constantan) versus eld (H k c). The Hall signal  $Q_H T$  is the eld-odd component of  $Q_rT$  [9].  $x_Y$  is computed as  $[Q_H T = Q_x T](x_X b = a)$ . We measured  $a = x_X$ , and used the anisotropy b = a previously measured in another crystal from the same batch (see Ref. [10]). The copper sam ple was cut from oxygen-free high-conductivity (OFHC) stock, but was not vacuum annealed to further reduce lattice disorder.

First, we discuss the T-dependence of  $_{xy}$  in Cu, and compare  $L_{xy}$  with the standard Lorenz number (see Ref. [7] for early data on  $_{xy}$ ). Figure 1 displays traces of  $_{xy}$  versus H between 60 and 350 K m easured in Sample 1. In order to calculate L and  $L_{xy}$ , we have also measured its electrical conductivity and Hall conductivity  $_{xy}$ . (Below 50 K, where  $_{xy}$  and  $_{xy}$  display increasing curvature vs. H,  $L_{xy}$  is obtained from their values in the lim it of weak- elds.)

A gradient  $_x T = 0.4 \text{ K}$  is applied along the sample length (k %). In the lowest curve (350 K), the value of  $x_y$  at 14 T corresponds to a Hall' temperature di erence  $_y T$  across the sample width of 1:6 mK.

The values of vs. T in Sample 1 are in close agreement with a compilation by Powellet al. [5]. However, in samples that have been carefully annealed, the peak value (at 20 K) may be twice as large [see Berm an and M acD onald (BM) [6]].

Figure 2 shows that L and  $L_{xy}$  in our sample start at values slightly higher than the Sommerfeld value at 350 K, and decrease with falling T, with  $L_{xy}$  decreasing slightly faster. In Cu, the Debye temperature  $_D$  is 343 K.Both Lorenz numbers reach a minimum near 60 K, and increase again at lower T.For comparison, we show (broken line) L reported by BM [6]. The minimum is deeper and occurs at a lower T (20 K). As discussed later, this is consistent with its higher purity.

In conventional metals, electronic currents are limited by scattering of electrons by phonons (at nite T). Largeangle scattering involving phonons with large wavevectors q (q >  $k_F$  , the Ferm i wavevector) are equally disruptive of the charge and heat currents. By contrast, small-angle scattering (q  $k_{\rm F}$  ) relaxes only the heat current, leaving the charge current relatively una ected [3]. In terms of  $'_{\rm S}$  and  $'_{\rm e}$  (the mean-free-paths for entropy and charge transport, respectively) we may express L as  $(^{2}=3)h'_{s}i=h'_{e}i$ , where h the Ferm i Surface FS. At high tem perature (T <sub>D</sub>), 'e because large-angle scattering is dom iwe have 's nant. As T decreases below  $_{\rm D}$  , the phonon population is increasingly skewed towards the small-q lim it, so that  $'_{\rm e}$  increases relatively faster than  $'_{\rm S}$  .

This accounts for the decrease in L in Fig. 2. At very low T, when elastic scattering from in purities dom inates,  $`_{\rm e}$  and  $`_{\rm S}$  are again equal, and L returns to the Sommerfeld value. In our sample, this turnaround occurs near 60 K, whereas in the cleaner sample of BM, it occurs at 20 K.

The inset shows the T dependence of  $_{xy}$ =B m easured in the lim it B ! 0. The dash line varies as 1=T.

In comparing L with  $L_{xy}$ , we display a minimum at nearly the same T. However, on the high-T side,  $L_{xy}$  falls faster with decreasing T. The two rates are compared via  $a_L \qquad L^2=L_{xy}$ . The near constancy of  $a_L$  is consistent with the expectation [8] that L  $h_S^{*}$  i=h\_e^{i}, whereas  $L_{xy} \qquad h_S^{*}$  i^2=h\_e^{i^2}. Hence,  $L_{xy}$  falls faster because it involves the squares of the m fp's. In Cu, the Hall-Lorenz number approaches the same W F ratio at high T, so that it provides inform ation comparable to L. M oreover, additional inform ation on scattering processes may be derived from its low T behavior.

Them al conductivity measurements have produced a i denotes averaging over ealth of information on the superconducting state of the cuprates. In YBCO, they provided early evidence favoring an unconventional pairing symmetry [11,12], and long lifetimes for the quasiparticles at low temperatures [13]. The contributions of the chains to [10], and the elect of hole doping [14] also have been investigated. Above  $T_c$ , how ever, the problem of estimating ph has been a serious obstacle to the extraction of e. In fact, neither the magnitude nor the T dependence of  $_{\rm e}$  in the normal state m ay be regarded as experimentally established. Hence, the present technique is especially appropriate. W hile the behavior of  $_{\rm xy}$  in YBCO was investigated previously [13,15,16] in the superconducting state, the rapid attenuation of the thermal Hall signal precluded measurements above 100 K. The improved resolution now allows  $_{\rm xy}$  to be determined reliably up to 320 K.

Figure 3 displays the H -dependence of  $_{xy}$  at selected tem peratures from 95 to 320 K. It is worth a second remark that, as  $_{xy}$  derives no contribution from the phonons, the raw experim ental curves directly m irror the electronic heat current. We proceed to compare it with the charge current. In the normal state of YBCO,  $_{xy}$ is known to vary as 1=T<sup>3</sup>. This produces the anom alous T dependence of the Hall coe cient R<sub>H</sub> that is so characteristic of the cuprates [17]. It is interesting to ask if the same dependence is observed in  $_{xy}$ =T (dividing by T to remove the heat capacity contribution). As shown in Fig. 4 (open symbols), the T dependence of the  $_{xy}$ =B is well- tted to T<sup>1:2</sup>. Hence, we nd that  $_{xy}$ =T actually has a weaker dependence than  $_{xy}$ .

W hen we calculate  $L_{xy}$ , we define that it varies linearly with T (solid circles in Fig. 4). In addition to this unusual T dependence, its value from 95 to 320 K is significantly smaller than the Sommerfeld value.

In som e previous reports, values of L (offen close to the Som m erfeld value) were obtained using a variety of arguments to subtract  $_{\rm ph}$  from . However, these arguments are suspect for the following reasons. In the cuprates,  $_{\rm ph}$  is strongly decreased by lattice disorder associated

with dopants ( is 2 to 4 times larger in the pristine parent compound  $La_2CuO_4$  compared with doped com – pounds [14]). M oreover, within the plane, ph is strongly anisotropic. In both YBa<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> and its two-chain variant YBa<sub>2</sub>Cu<sub>4</sub>O<sub>8</sub>, ph is signi cantly larger along b (the chain axis) compared with a, because of the anisotropy in elastic constants [18]. These factors make comparisons between doped and undoped crystals, or between

m easured along the axes a and b in the sam e sam ple, quite unreliable. A di erent approach is to extrapolate the value of  $_{\rm e}$  of quasiparticles in the superconducting state to tem peratures just above  $T_{\rm c}$ . A recent experiment [15] reports extrapolated values of  $_{\rm e}$  in the range 0.8–1.0 W /mK at  $T_{\rm c}$ . W ith  $_{\rm a}$  = 100 cm, this gives L = 1.1–1.4, which is closer to our  $L_{\rm xy}$  than to the Sommerfeld value.

A side from the overall suppressed scale, the nom inally T-linear dependence of  $L_{xy}$  is also unusual. An extrapolation (broken line in Fig. 4) shows that it intersects the Som m erfeld value near 500 K. We note that, the acoustic phonons in YBCO have a maximum energy of 20 mv. A bove 200 K, the dom inant acoustic phonons should have su cient momenta to span the full FS ( $_D = 420$  K is higher because of the large unit cell). Certainly, by 320 K, we should have  $h'_S i = h'_e i$  if electron-phonon scattering is the dom inant mechanism for relaxing the two currents. Hence, the small values of  $L_{xy}$  and the high

tem perature scale at which it attains the Sommerfeld value (500 K) seem incompatible with dom inant electron-phonon scattering.

In contrast, a suppressed W F ratio may be expected in system s with dom inant electron-electron (ee) scattering. A discussion of this point illustrates how norm al (N) and Um klapp (U) scattering processes in uence the W F ratio. As in the case of lattice therm al conduction [19,20], N processes leave the total momentum of the electron gas unchanged, so that the charge current cannot relax without U processes. However, (unlike lattice conduction) N -process ee scattering does relax the heat current because it causes a redistribution of energy between hot and cold electrons [21]. This distinction in plies that systems in which ee scattering is dom inant have a strongly reduced Lorenz num ber. M oreover, because the relative weights of N versus U processes are not determined by

 $_{\rm D}$  in ee scattering, this reduction could prevail to very high T. These issues are intimately related to behavior of the W F ratio. Hence, the T dependences of  $_{\rm XY}$  and  $L_{\rm XY}$  displayed in Fig. 4 should place strong constraints on transport m odels for YBCO.

In sum m ary, we have described m easurem ents of the Hall-Lorenz number, obtained as the ratio of  $_{xy}$ =T to  $_{xy}$ . In Cu, this m ethod gives results comparable to direct m easurem ents of L. How ever, in system s in which lattice conduction is not small, the Hall-Lorenz experiment provides a direct comparison of the heat and charge currents of the charge carriers. A quantitative understanding of the inform ation derived from  $L_{xy}$  awaits comparison with m icroscopic calculations. In view of the increased interest in system s with dom inant ee scattering, we expect high-tem perature W F ratio to play an increasingly prom inent role.

This implies a very large charge current. The associated Peltier heat current is negligibly sm all because the particle heat current is opposed by a hole counter ow (hence it vanishes with strict particle-hole sym metry). In an experin ent that m easures  $% f({\rm J}_{\rm e})$  , the boundary condition (J  $_{\rm e}$  = 0) produces an undisplaced FS with a skewed Fermidistribution. This leads to a heat current that is far larger than the Peltier current, but sensitive to relaxation by N processes. By contrast, in lattice conduction, the absence of U processes leads to a rigid displacem ent of the Bose-E instein distribution, but there is no cancelling back ow corresponding to the hole current. Phonon heat conduction is convective, while the electronic current is particlenum ber conserving. See R ef. [3].
