Spinning up and down a Boltzm ann gas

U sing the average method, we derive a closed set of linear equations that describes the spinning up of an harm onically trapped gas by a rotating anisotropy. We nd explicit expressions for the time needed to transfer angular momentum as well as the decay time induced by a static residual anisotropy. These dierent time scales are compared with the measured nucleation time and lifetime of vortices by the ENS group [4]. We nd a good agreement that may emphasize the role played by the non-condensed component in those experiments.

INTRODUCTION

Super uidity of a Bose-Einstein condensate is naturally investigated by its rotational properties [1,2]. So far, two experimental schemes have been successfully applied to gaseous condensates in order to generate quantized vortices [3,4]. The rst one uses phase engineering by means of laser beams whereas the second one is the analog of the \rotating bucket" experiment, initially suggested by Stringari [5,6].

In the latter, atom s are rst con ned in a static, axially sym m etric Io e-P ritchard m agnetic trap upon w hich a non-axisym m etric attractive dipole potential is superim posed by means of a strirring laser beam. In this paper, we address the question of the behaviour of the noncondensed component for this experiment. We investigate the transfer of angular momentum to an ultracold harm onically con ned gas by such a time dependent potential. We also study possible mechanisms for its dissipation. First (Sec. I), we recall the Lagragian and the Ham iltonian formalism for a single particle in a rotating fram e. Then in Sec. II, we give the expression for the rotating potential that has been used in our study. We brie y expose analytical results for the single particle trajectory in this potential in Sec. III. The rest of the paper deals with the crucial role played by collisions. A classicalgas that evolves in this potential them alizes in the rotating fram e, leading to a nite value of its mean anqular m om entum. W e investigate this equilibrium state in Sec. IV. In Sec. V, we derive the analytical expression for the time needed to spin up a classical gas with an approach based on the averagem ethod [7]. We evaluate the tim e needed to transfer angular m om entum and thus we deduce the characteristic time for vortex nucleation via angularm om entum transfer from the uncondensed to the

condensed component. Finally, in Sec. VI, we consider a related problem: what is the time needed to dissipate a given angular momentum by a static residual anisotropy? We have in mind the role of the axial asymmetry of a magnetic trap (To e-Pritchard or time-orbiting potential traps) induced by the presence of gravity. We show that this elect may explain the nite lifetime of vortices.

I.A REM INDER ON THE ROTATING FRAME

In this section, we recall the ham iltonian for a classical particle in a rotating frame characterized by the xed rotation vector . W ithout loss of generality, we choose a rotation around the z axis = e_z and the same origin for the rotating frame $<^0$ as the one of the laboratory frame < (see Fig. 1). In the following, quantities with a prime are evaluated in the rotating frame. Coordinates in $<^0$ are linked to coordinates in < just by a rotation of angle = t:

The lagrangian for the single particle movement in the rotating frame reads [8]:

where $V_{\rm ext}$ is the potential energy that describes the role of external forces. The correspondance between the laboratory and rotating fram es form om entum, angularm om entum and the ham iltonian is given by:

Note that the angular momentum as well as the momentum are the same in both frames, but the link between the momentum and the velocity diers. Using the ham iltonian formalism, one can easily extract the equation of motion in the rotating frame:

where F $_{\rm ext}$ refers to the external force derived from the potential $V_{\rm ext}$, F $_{\rm cen}$ is the centrifugal force:

Note that all formulas of the system (3) are still valid even for a time-dependent rotation vector \cdot .

II. THE ROTATING TRAP

In Bose-E instein condensation experiments, the magnetic con nement is axially symmetric. In order to spin up the system, one possibility consists of breaking this symmetry by superimposing a small rotating anisotropy as initially suggested by S. Stringari [5]. This breaking of the rotational invariance of the external potential can be carried out experimentally by adding a rotating stirring dipolar beam to the magnetic eld of the trap [4]. This combination of light and magnetic trapping induces the following harmonic external potential (see Fig. 1) [9]:

where we have de ned the geometric parameter = $!_z=!_0$, which is responsible for the shape of the cloud. For instance, if we set = 0, the trap is isotropic for = 1, cigar-shaped for 1, and disk-shaped for 1. The potential (7) is time-dependent if expressed with laboratory coordinates (x;y;z), but static in the rotating frame, i.e. in terms of $(x^0;y^0;z)$.

III. SINGLE PARTICLE TRAJECTORY

Let us rst investigate the single particle trajectory. Equations in the laboratory frame and for the transverse coordinates are given by:

In the rotating frame, the corresponding equations are time independent. They can be rewritten by means of the complex quantity: $^{0} = x^{0} + iy^{0}$:

where denotes the complex conjugate of . The second term in Eq. (9) accounts for the Coriolis force, the centrifugal force leads to a reduction of the harm onic strength (third term), and the last term is the contribution of the asymmetry. The stability of the single particle movement is extracted from the dispersion relation of (9).

We nd a window of instability around the value $p = \frac{!}{0}$, i.e. for $2 [!]_0 1 ;!_0 1+]$. For $4 !]_0 1 ;$ the stability is essentially ensured by the ham onic trapping even if reduced by the centrifugal force, whereas for $4 !]_0 1 + 1$ the Coriolis force plays a crucial role in the stabilization of the trajectory. The latter e ect is similar to magnetron stabilization in a Penning trap for ions [10].

IV.EQUILIBRIUM STATE OF THE GAS

In practice, experim ents are carried out in the so-called collisionless regime, since on average an atom undergoes less than a collision during a transverse oscillation period. However, collisions are of course essential to explain the dynam ics of the gas induced by the potential (7). We consider the situation in which a gas at a given temperature T_0 is initially at rest in the lab fram e, and at t = 0the axial asym metry is spinned up at a constant anguas explained above. If $< !_0$ 1lar velocity expects that elastic collisions will ensure the therm alization of the gas in the rotating fram e. This equilibrium state is de ned since a m in im um of the e ective potential $V_e = V_{ext} + V_{cen}$ always exists in this range of values for . In Fig. 2, we com pare the stability of a single particle (upper part of the diagram) with that of the interacting gas. In the rotating fram e, one can com pute equilibrium quantities by means of the Gibbs distribution reads [11]:

As regards statistical properties of the gas, the rotation is equivalent to a reduction of the elective transverse frequencies of the trap due to the contribution of the centrifugal force. The C oriolis force plays no role for the equilibrium state. During the thermalization, the mean angular momentum per particle increases from zero to its asymptotic value hL_zi . This last quantity is easily derived from the G ibbs distribution (10):

For typical experim ental param eters ! $_0$ =2 = 200 H z, = ! $_0$ =2, = 0:05 and T $_0$ = 1 K, the angular m om entum per particle hL $_z$ i=~ $^\prime$ 150 unlike the super uid part for which for instance the angular m om entum is equal to ~ per particle in the presence of one vortex.

To check that the gas undergoes a full rotation, one can search for a displacem ent of the critical tem perature induced by centrifugal forces [6], or perform a time-of-ight measurement. In the latter case, one expects that the ratio between x and z size scales as $(1 \quad ^2=!\frac{2}{0})^{1=2}$ for long time expansion.

In this section we derive the expression for the time tup needed to reach the equilibrium state in the rotating coordinate system . In other words, $t_{\rm up}\,$ corresponds to the tim e needed to build correlations between x, v_y , y and $v_{\rm x}$. To estim ate this time, we use the classical Boltzm ann equation. Our analysis relies on the use of the average method as explained in [7]. For instance, the equation $\hat{y}v_{x^0}$ i involves hx^0y^0 i which itself is coupled to $hx^0v_{y^0} + y^0v_{x^0}i$ and so on. Terms that do not correspond to a conserved quantity in a binary elastic collision lead to a non zero contribution of the collisional integral. For instance, a mean value such as $hv_x \circ v_y \circ i$ involves the occurence of quadrupole deform ations in the velocity distribution which make the contribution $hv_x \circ v_y \circ I_{coll} i \in 0$. Here, I_{coll} stands for the collisional kernel of the Boltzm ann equation [12]. At this stage, we perform a gaussian ansatz for the distribution function. A fter linearization this quadrupolar contribution results in the so-called relaxation time approximation [12,13]:

This method leads to a closed set of 13 13 linear equations (see Appendix), and provides furtherm ore an explicit link between the relaxation time and the collisional rate in the sample.

It is worth emphasizing that the dynamic transfer of angular momentum to a classical gas by rotating a superim posed axial anisotropy involves a coupling between all quadrupole modes. The average method is fruitful in the sense that it yields a closed set of equations when one deals with only quadratic moments, namely: monopole mode, scissors mode, quadrupole modes, ... Non-inertial forces are linear in position or velocity, and thus give rise only to quadratic moments using the average method.

A lthough unimportant for equilibrium properties, the Coriolis force plays a crucial role for reaching equilibrium. Fig. 3 depicts a typical therm alization of the gas in the rotating frame, leading to the equilibrium value (12) of the angular momentum, obtained by a numerical integration of the 13 13 set of equations. After a tedious but straightforward expansion of the dispersion relation, one extracts the smallest eigenvalue that drives the relaxation for a given collisional regime. First we focus on the regime in which experiments are performed: collisionless (! o ' 10) and with 2 2 =! 2_0 . Denoting $^{\rm CL}_{\rm up}$ as the time needed to spin up the gas in this regime, we nd:

The result is independent of the geom etrical aspect ratio of the trap as physically expected. Using the same num erical values as in the previous, we deduce that this

time is very long $t_{\rm up}^{\rm C\,L}$ ' 15 s. Note that to transfer just ~ of angularm omentum perparticle, one needs only 100 m s. This time is on the order of the nucleation time for vortices that has been experimentally observed by the ENS group [14]. One should nevertheless be carefull since the non-condensed component is actually a Bose gas rather than a classical one that evolves in a non harm onic potential because of the mean eld potential due to the condensed component.

In the hydrodynam ic lim it, the characteristic time for spinning up is:

So far this regim e is not accessible for ultracold atom experim ents since inelastic collisions prevent the form ation of very high density samples. We recover here the special feature of the hydrodynam ic regime, i.e. the time needed to reach equilibrium increases with the collisional rate. In Fig. 4 we have reported the evolution of $t_{\rm up}$ as a function of $t_{\rm 0}$ from a numerical integration of the 13 13 system. The smallest value is obtained between the collisionless and hydrodynam ic regimes, as is usual for the relaxation of a therm algas [7].

VI.TIM E NEEDED TO DISSIPATE A GIVEN ANGULAR MOMENTUM

Consider a gas with a given angular momentum, obtained for instance as explained before. If this gas evolves in an axially sym m etric trap, the angular m om entum is a conserved quantity. In contrast, if a small asym metry exists between the x and y spring constants, the angular momentum is no longer a conserved quantity and it is thus dissipated. We call tdown the typical time for the relaxation of the angular momentum. This problem is very dierent from the one we faced previously since the rotating fram e is not an inertial fram e. W e thus expect t_{down} € t_{up}. As in the previous treatment, this problem can be computed with the average method. The corresponding equations are nothing but the scissors mode equations [2], i.e. a linear set of 4 equations involving hxyi, hxv_y yv_xi , hxv_y + yv_xi and hv_xv_yi (see Appendix). Searching a solution of this system of the form exp (one nds

where the critical anisotropy is related to and $!_0$ by $_c=1=(4!_0)$. In Fig. (5), we plot dierent curves for the relaxation of angular momentum depending on the value of with respect to $_c$. For $<_c$ (long dashed line), one has a purely damped relaxation; in the limiting case $_c$, $t_{\rm down}$ ' $1=(2^2!_0^2)$. On the contrary for $>_c$ (solid line), one has a damped oscillating behaviour; in the limiting case $_c$, $t_{\rm down}$ ' 4 , and the oscillating frequency is equal to $!_0$. Moreover, as we use

a linear analysis, this decay time does not depend on the speci c initial value of the angular momentum. For the experiment described in [4], the axial symmetry induced by gravity is on the order of 1% and the collisional rate is such that $!_0$ ' 10. The corresponding decay time of the angular momentum is then evaluated from Eq. (14) to be 500 ms. This value matches surprisingly well the typical observed lifetime of a vortex. Therefore, one possible interpretation may be that the them alpart acts as a reservoir of angular momentum and thus ensures the stabilization of the vortex as long as this thermal part is itself rotating signicantly. On the opposite when the angular momentum of the thermal part is zero, the vortices disappear.

CONCLUSION

In this paper we have investigated the dynamic of transfer and dissipation of angular momentum for a classical gas and in all collisional regimes. We derive very dierent time scales for both processes. The short time deduced to dissipate angular momentum suggests a high sensitivity of the experiment described in [4] to residual static anisotropy (see dierent time scales between Figs. (3) and (5)). In practice, as underlined above one cannot avoid residual xed anisotropy due for instance to gravity. The competition between a rotating and a static anisotropy may explain why no evidence for a full rotation of the classical gas was experimentally reported in Ref [4].




FIG.1. Rotating frame with respect to laboratory frame.





FIG. 2. Stability diagram for the single particle and for an interacting gas in the potential with a rotating anisotropy.



 ${\tt FIG}$.3. M ean angularm om entum perparticle as a function of ${\tt tim}$ e.




FIG .4. Tim e needed to reach equilibrium by rotation of a small anisotropy. A minimum of $t_{\rm up}$ is obtained in-between the collisionless and the hydrodynam ic regimes.




FIG .5. Decay of angular m om entum due to a small residual anisotropy. We distinguish three dierent regimes: > c damped oscillations (solid line), = c (small dashed line) the frontier with the region of purely damped decay (< c, long dashed line).

One can show from the gaussian ansatz that the relaxation time is the same for all quadrupolar contributions. In this system, linear terms in account for the Coriolis force whereas quadratic terms in are due to centrifugal force contributions. All quadrupolar modes are involved in this system. In order to enlight the physics of this system, let us consider some limiting cases. One can check the conservation of energy in the rotating fram e dhH 'i=dt = 0. Finally, one can recover the scissors mode equations for a classical gas by considering the case = 0 and $\frac{6}{9}$ 0 [2]: eqs A 1, A 5, A 6, A 10.
