Collective excitations of degenerate Ferm i gases in an isotropic parabolic traps

We investigate the hydrodynam ic low-frequency oscillations of highly degenerate Ferm i gases trapped in anisotropic harmonic potentials. Despite the lack of an obvious spatial symmetry the wave-equation turns out to be separable in elliptical coordinates, similar to a corresponding result established earlier for Bose-condensates. This result is used to give the analytical solution of the anisotropic wave equation for the hydrodynam ic modes.

I. IN TRODUCTION

A fler the spectacular realization of B ose{E instein condensation in evaporatively cooled m agnetically trapped alkali vapors half a decade ago [1] the experimental realization of a degenerate (i.e. mean particle distance smaller than the de Broglie wavelength) Ferm i gases like 40 K [2] and 6 Li [3] has also been achieved. One of the most useful experimental tools to probe the properties of the B ose-condensates has been the excitation of their collective modes in the collisionless regime [4,5]. It has turned out that within the dynam ic T hom as Ferm i approximation these modes could be calculated analytically by solving the G ross-P itaevskii equation, linearized around the static T hom as Ferm i solution. This was done rst [6,7] for isotropic parabolic traps, where the symmetries are su cient for integrability, then for anisotropic axially symmetric parabolic traps [6,8,9], where an additional hidden symmetry could be identied [8], and nally also for completely an isotropic parabolic traps [10], where the resulting wave-equation could be related to various integrable dynam ical systems and the Lam e equation.

In view of these successful experimental and theoretical developments for the Bose-systems, it seems to be of considerable interest to apply similar methods also to degenerate Ferm i systems [11,12]. On the one hand these systems seem to be very dienent from their bosonic counterparts. Indeed, barring the possibility of Cooper pairing at extremely low temperatures, condensates may not appear there. However, a degenerate Ferm i gas may appear, instead. Therefore a great similarity between both kinds of systems remains, because in the strongly degenerate case the particles move in the trap-potential and strong mean-elds coming from their elds interactions, either with the condensate in the bosonic case, or via the Pauli exclusion-principle with the degenerate gas, in the case of ferm ions.

In the present paper our goal is to analyze the wave-equation of the collective modes of the degenerate Ferm i gas in a completely anisotropic (i.e. with three di erent trap-frequencies) parabolic trap. More symmetric special cases of this problem have already been analyzed in the literature.

For the special case of an isotropic parabolic trap the wave-equation for hydrodynam ic modes in trapped Ferm i gases was solved by B nuun and C lark [12] both in the high- and low -tem perature lim it. In the high-tem perature lim it the e ects of quantum statistics become irrelevant and one obtains the same results as for Bose gases, which were considered earlier, for isotropic traps, and even for som e modes in axially sym metric traps by G ri n et al. [14]. U sing a sum-nule approach V ichi and Stringari [11] analyzed interaction e ects on the collective oscillations of Ferm i gases trapped in parabolic potentials of rotational or axial sym metry. A monuso et al. [13] also investigated the collective excitations of trapped degenerate Ferm i-gases both in the hydrodynam ic and the collision less regime for isotropic and, for som e dipolar and quadrupolar modes, also for axially sym metric parabolic traps. New in the present work is the treatment of the com pletely anisotropic case, where we follow the lines of our earlier treatment of the bosonic case [10]. The paper is organized as follow s.

In section II the hydrodynam ic equations are form ulated and the wave-equation for sm all density perturbations in the lim it T ! 0 is derived. In section III the wave-equation is solved in the axially symmetric case by separation in cylindrical-elliptic coordinates. We also construct the conserved operator commuting with the wave-operator, whose presence is responsible for the integrability. In section IV we proceed to the triaxially anisotropic case and separate the wave-operator in three-dimensional elliptic coordinates, exhibiting two conserved operators commuting with the wave-operator. A nalytical expressions for the mode-frequencies and -eigenfunctions are given. Finally, we summarize our conclusions.

The hydrodynam ic equations of motion of an ideal gas in local therm odynam ic equilibrium with energy-density " $(x;t) = \frac{3}{2}P(x;t)$, where P denotes the pressure, are given by [15,14]

Here is the total density of the gas of ferm ions, which we assume to be present in (2F + 1) dierent hyper nestates, which all see the same trapping potential and between which s-wave collisions are not suppressed by the Pauli-principle. We shall not consider here additional hydrodynam ic modes connected with the internal degrees of freedom of the ferm ions, like spin-waves.

The existence of these conserved operators is the reason for the solvability of the wave-equation despite the absence of any apparent symmetries of the anisotropic potential. In order to construct \hat{A} and \hat{B} we replace in (4.5) A and B by their operators and solve these three equations for \hat{A}' and \hat{B}' . A flerwards we transform back to Cartesian coordinates. We obtain in this way after some calculation

To nd the minima of the potential (4.18) is a problem in the 2-dimensional electrostatics (because of the logarithm ic potential) of n+4 point-charges on a line: The equilibrium positions i of the n-charges of unit strength between the 4 xed charges of strength 3=4 at =0; $(\frac{1}{2}+\frac{1}{4})$ at $=a^2$; $(\frac{1}{2}+\frac{1}{4})$ at $=b^2$, and $(\frac{1}{2}+\frac{1}{4})$ at $=c^2$ determ ine the eigenfrequencies via eq.(4.13). The solutions can be classified by the numbers $n_1; n_2; n_3$ of charges between c^2 and 0, b^2 and c^2 , and a^2 and b^2 , respectively, which are the three quantum numbers labeling the eigenvalues and eigenfunctions. We shall not present numerical results here, since these depend on the ratios a=b; a=c as an input. For a further discussion we can refer to [10], however, where the bosonic case is analyzed further by numerically solving the equivalent electrostatic problem for a speci c experimentally realized trap-geometry.

V.CONCLUSIONS

In the present paper we have analyzed the hydrodynam ic equations of an ideal and highly degenerate Ferm i-gas trapped in a generally anisotropic harm onic potential. Despite the absence of any obvious spatial sym metries in the triaxially anisotropic case, or of insu cient spatial sym metry in the axially sym metric case, the wave-equation turns out to be separable just like in the bosonic case. In fact, from the point of view of dynam ical system s the characteristics of the wave-equation (i.e. the rays described by the H am ilton-Jacobi equation obtained in the eikonal lim it [20]) are the same for the bosonic and the ferm ionic case; i.e. the wave-equations for the two cases can be considered as di erent quantizations' of the same classical' dynam ical system, which was analyzed in [10], and which turned out to be integrable.

The frequencies of the lowest-lying modes the n = 0 modes (4.14), (4.15) (but not the mode-functions for (火)) turn out to be the same in the bosonic and the ferm ionic case. The reason for this coincidence is the fact that the velocity-potential' of these modes satisfies $r^{2} = 0$, which implies the incompressibility condition \tilde{r} u = 0. For incom pressional modes the only term s depending on the quantum -statistics drop out from the wave-equation (2.18) for the velocity-eld, as was already noted by Grin et al. [14]. However, the frequencies of the higher-lying modes dier, in general, between the Bose- and the Ferm i-system s. In the axially symmetric case we have given all the m ode-frequencies with at most 1 node in radial or axial direction, and with arbitrary axial angular momentum. In the completely anisotropic case useful explicit results for compressional modes with \tilde{r} u 6 0 can only be given in num erical form . However, as a central result of the present work we have reduced the num erical task to a very straight-forward one, namely to the 2-dimensional electrostatics of n movable point-charges of unit strength on a line in the eld of 4 xed point charges of given strength on the same line. This establishes a strong analogy between the ferm ionic case and the bosonic case, which has been reduced to the same problem (with slightly di erent strengths of the xed charges) in [10]. As discussed there this mapping of the eigenvalue problem permits a complete classi cation of the eigenvalues and the eigenfunctions by the three integer quantum -num bers, which give the num ber of m ovable charges between each pair of nearest neighbors of the 4 xed charges.

The physical realization requires the simultaneous trapping of several hyper ne states, in order to allow for the interaction of the di erent ferm ionic species by collisions, which are necessary to maintain local therm odynamic equilibrium. Because the collision-rates in degenerate Ferm i-gases are suppressed by a Ferm i-blocking factor proportional to $(T = T_F)^2$ compared to the classical collision rates [19] it is necessary to use atom ic species with particularly large positive or negative s-wave scattering-lengths or to produce the latter by tuning the system close to a Feshbach resonance.

In view of the recent rapid experim ental progress in this eld [2], $[3] \pm m$ ay be hoped that a m easurem ent of these collective m odes m ay be possible in the near future.
