# B roken $G$ eneralized $K$ ohn $T$ heorem in $H$ arm on ic $D$ ot Lattices due to $C$ oulom b Interaction betw een the D ots: Exact solution of the Schrodinger equation in the dipole approxim ation

#### Abstract

The G eneralized K ohn Theorem in arrays of parabolic quantum dots with C ou lomb interaction betw een the dots is violated, if there are di erent dot species involved. W e solve the Schrodinger equation for cubic lattices w ith two di erent dots per unit cell: i) two di erent circular dots and ii) two elliptical dots, which are rotated by $90^{\circ}$ relative to each other. T he interaction betw een the dots is considered in dipole approxim ation and long\{ wavelength excitation spectra including $F \mathbb{R}$ intensities are calculated. The energy spectrum of the rst case can be expressed as a supenposition of two noninteracting dots with an e ective con nem ent frequency, which includes the e ect of dot interaction. Only in the second case a splitting of degenerate absonption lines and an anticrossing occurs, which is a qualitative indication for interdot interaction. If the interaction becom es very strong and if all lattice sites (not necessarily con nem ent potentials) are equivalent, then the contribution of the dot interaction outw eigh possible di erences in the con nem ent potentials and the $K$ ohn $T$ heorem gradually reentries, in the sense that one pair of excitation m odes (pseudo $K$ ohn $m$ odes) becom es independent of the interaction strength.

## I. IN TRODUCTION

The Generalized K ohn Theorem "I (G K Th) plays a crucial role in quantum dot physics with far reaching consequences. It considers interacting electron system $s$ in a harm onic con nem ent and a constant magnetic eld, and it states that excitations by long wavelength radiation are not e ected by the electron electron (e e) interaction. This statem ent applies to arrays of identicalharm onic dot con nem ents (w ith e e interaction betw een the dots) as well (see A ppendix of ones ( K ohn m odes), and it does not $m$ ean that e e interaction is not im portant for the other excitations. H ow ever, this fact prevents the $e \mathrm{e}$ interaction from beeing seen and investigated e.g. by far infrared ( $F \mathbb{R}$ ) spectroscopy. The $F \mathbb{R}$ absonption spectrum of the whole system agrees exactly $w$ th the spectrum of a single particle. The GK Th does not hold for arrays of di erent dot con nem ents, e.g. periodic dot lattioes $w$ ith two di erent ham onic dot con nem ents per unit celt ${ }^{2}$. Then, all collective $m$ odes are excited by $F \mathbb{R}$ radiation and e ected by e e interaction, or in other words, there is no K ohn m ode. The calculation and investigation of absonption frequencies and probabilities in the latter case is the sub ject of this w ork.
In order to obtain a visual picture, let us rst consider a classicalm odel for the K ohn m ode for vanishing $m$ agnetic
eld. (T his prelim inary consideration $w$ ill be replaced by a rigorous quantum $m$ echanical treatm ent in the follow ing.) C lassically, the charge distributions of all dots oscillate rigidly in \{ phase w ith the bare con nem ent frequency, and the e e interaction contributes only a constant term to the totalenergy (independent ofelongation). If we have m ore than one identicaldots per unit cell, there are additionalcollective m odes, in which the individualdots oscillate out of phase, and which are a ected by dot interaction, but which are not optically active. C onsequently, the dot interaction is not observable w ith $F \mathbb{R}$ spectroscopy in arrangem ents of identical dots. O ne way to trick K ohn's theorem is to include di erent dot species. Then, there is no coherent oscillation mode for all dots, which does not change the e e interaction energy of the system in elongation, because there is no com $m$ on bare con nem ent frequency. As a consequence, all collective $m$ odes (tw o m odes per dot in the unit cell) are e ected by dot interaction and excited by $F \mathbb{R}$ radiation w ith a nite probability. In other words, the $G$ eneralized $K$ ohn $T$ heorem for dopt arrays is broken.

O ne point of this paper is that the GKTh can be broken despite an exactly harm on $\boldsymbol{j}_{1} \mathrm{H}$ am iltonian. A further possibility to observe the e e interaction in the excitations is to consider nite wave lengthit .

## II. M A G NETOPHONON HAMILONIAN

The rst part of the calculation of the eigenstates of the H am iltonian follow sclosely the procedure described in $R$ ef. 는. W e only have to consider that now the con nem ent potentials and electron num bers can be di erent in di erent dots. A fter introducing center\{ of \{ m ass ( cm. .) and relative coordinates in each dot and applying the dipole approxim ation for the C oulomb interaction betw een the dots, we observe that the H am iltonian of all cm. coordinates is decoupled from individual dot H am iltonians in the relative coordinates. That's why all excitations can be classi ed into i) collective (cm.) excitations, and ii) intra-dot excitations. The latter are not considered here because they are not optically active. The H am iltonian in the cm . coordinates $\mathrm{R}_{\mathrm{n}}$; reads in atom ic units $\mathrm{h}=\mathrm{m}=\mathrm{e}=1$ (see also Sect. IV $A$ in Ref. $\overline{\text { hen }}$ )

where $U_{n} ;=R_{n} ; \quad R{ }_{n}^{(0)}$ is the elongation of the $c m$. at lattice site $(n ;)$ and $P_{n}$; $=$ ir $U_{n}$; is the corresponding canonicalm om entum operator. $n$ runs over the unit cells and over the dot species with in a cell. N is the num ber ofelectrons in dot, and $m$ the ective $m$ ass. It is clear already from inspection of $\frac{(\underline{f})}{(\underline{f})}$ ) that the eigenvalues of $H_{c m}$ : do not depend on the explicitly shown electron numbers $N$, because the factors $\frac{N}{N}$ can be considered just as a rescaling factor of the coordinates $U_{n}$; . H ow ever, the eigenfiunctions (and quantities derived from them ) do depend on the explicit N . T he force constant tensor reads

where ${ }^{1}$ is the invense background dielectric constant and the bare con nem ent tensor, which produces a ham onic con nem ent. The dipole tensor is de ned as $T(a)=\frac{1}{a^{5}} 3 a \quad a a^{2} I$ where () denotes the dyad product and I the unit tensor. O bserve that $C$ depends on $N$ im plicitely which e ects the energy eigenvalues.

N ow, we focus our attention to long\{ wavelength m odes (the index $q=0$ is dropped henceforth) and consider a sim ple cubic lattice, altematively occupied by tw o di erent dot species. The minimum unit cell is face centered cubic (see Fig.1) w th lattice constant a. A fter perform ing the lattice sum involved in $\bar{\eta}_{1}$, ) num erically, we obtain the four 22 dynam icalm atrioes

## III. EIGENSTATES

N ow we are going to nd eigenvalues and eigenfunction of ${ }^{\prime}(\mathbf{(})$. For avoiding divergences for $B=0$, we add an isotropic oscillator potential $\frac{1}{2} \quad!{ }_{0}^{2} \mathrm{U}^{2}$ to the kinetic energy in ( $\overline{(6)}$ ) and subtract it from the interaction term. $!0$ is
in principle arbitrary, but we chose the $m$ ean value of the bare con nem ent frequencies included in 1 and 2 . Now we replace the coordinates in ( (G) (for $q=0$ ) by Boson ladder opprators. This is analogous to the usual text book transform ation (see e.g. Ref. ' $\bar{G}$ Sect. 3.3) apart from the factors $\bar{N} \bar{N}$. It is obvious that this modi cation can be taken into account by introducing scaled coordinates $U \quad!\quad U \quad=\frac{P}{N} U \quad$ (what implies $P \quad!\quad P \quad=P=\frac{P}{N}$ ).

The cyclotron frequency is $!_{c}=B=m \quad c$ and ${t_{c}}_{c}=P \overline{!_{c}{ }^{2}+4!{ }_{0}^{2}}$. Firstly, it is clear that the $H$ am iltonian in these ladder operators does not show an explicit $N$ \{ dependence anym ore (apart from that im plicit in the dynam ical $m$ atrix). This implies that the eigenvalues of the H am iltonian do not depend on those N explicitly seen in ( (G)). Secondly, the com mutators of the ladder operators are not in uenced by the N \{factors and agree with those of B osons: $\left[a_{i} ; a_{i}^{+}\right]=1$ and all other com $m$ utators vanish. ( $T$ his is because the com $m$ utators of the $U$ and $P$ agree $w$ ith the com $m$ utators of the untided quantities.) $N$ ow, the total $H$ am iltonian can be written in $m$ atrix notation in the follow ing com pact form

$F$ inding the eigenstates of the B oson $H$ am iltonian ( $2 \mathbf{O}_{1}^{(1)}$ ) is provided by $m$ athem atical physics and described in $R$ ef. in full detail. The goal is to nd a linear transform ation $\begin{gathered}\mathrm{b} \\ \mathrm{b}^{+}\end{gathered}=\mathrm{A} \quad \begin{gathered}\mathrm{a} \\ \mathrm{a}^{+}\end{gathered} \quad$ which preserves B oson com m utators and diagonalizes $H$. $T$ he four eigenvectors belonging to the positive eigenvalues are $w$ ritten in the form $x_{k}=\begin{aligned} & u_{k} \\ & v_{k}\end{aligned}$. The colum $n$ vectors of $\mathrm{A}^{+}$are given by the vectors $\mathrm{x}_{\mathrm{k}}$, and by the vectors $\hat{\mathrm{x}}_{\mathrm{k}}=\mathrm{V}_{\mathrm{k}}$, which are the eigenvectors belonging to $\mathrm{u}_{\mathrm{k}}$, k . ## IV. O SCILLATOR STRENGTH

In form ulae, this m eans $U_{\text {tot }}=\frac{N_{1}}{N_{\text {tot }}} U_{1}+\frac{N_{2}}{N_{\text {tot }}} U_{2}$, where $N_{\text {tot }}=N_{1}+N_{2}$. A fter expressing the vectors $U$ by ladder operators $b_{k} ; \mathrm{b}_{k}^{+}$and using $\left(2 \overline{2}_{1}^{-}\right)$, we obtain the usual selection rules, i.e., only one quantum $w$ th energy $!_{k}$ can be absonped or em itted, so that weobtain only four absonption lines. It is worth pointing out that for equal electron numbers in either $\operatorname{dot}\left(N_{1}=N_{2}=N\right.$ ), the oscillator strength depends explicitly on $N$ (contrary to the optical excitation energies). In all gures presented below the oscillator strength are for $\mathrm{N}_{1}=\mathrm{N}_{2}=\mathrm{N}$.

## V.RESULTS

$N$ ow the tw o sim plest cases are discussed in m ore detail: tw o di erent circles and tw o identical, but rotated ellipses. $T$ he ratio of the tw o bare con nem ent frequencies involved in either case is $1: 1.5 \mathrm{which} \mathrm{m}$ eans, that the two con nem net frequencies in units of the $m$ ean frequency ! o are 12 Ind 0.8 . In our gures, all frequencies (energies) are given in units of the $m$ ean con nem ent frequency $!_{0}$ and the interaction param eters $p$ in units of $!_{0}^{2}$. The magnetic eld is given in term sof the ective cyclotron frequency ! ${ }_{c}$ in units of! (upper scale) and in $T$ esla (lower scale). The conversion betw een both scales is provided by

In our gures we used $!_{0}=0: 2 \mathrm{a} u:=2: 53 \mathrm{meV}$ and m of G aAs for this conversion. ( W e w ant to stress that this param eter choige e ects only the $m$ agnetic eld scale and not the curves.) $T$ he de nitions of the interaction param eters $[\overline{1} \overline{4} \overline{1})$ for $G$ aA $s$ in $m$ ore convenient units reads

For two di erent circular dots with bare con nem ent frequencies ! and ! ${ }_{2}$ and $N_{1}=N_{2}$, the absonption spectrum and the oscillator strength are shown in F ig 2. A though all absonption lines are e ected by the dot interaction (represented by the interaction param eter p ), and all modes are optically active, there is no qualitative e ect of interaction in the position of the absorption lines. T he reason can be understood easily. In this particular case, the four eigenm odes can be calculated analytically providing

(T he upper and lower sign belongs to $!_{\text {eff;1 }}$ and $!_{\text {eff;2 }}$, respectively). C onsequently, if we had to intenpret an experim ental spectrum, we could do this using the form ula (34i) for non $\{$ interacting dots, but with the e ective (i.e. interaction a ected) con nem ent param eters de ned ini ( 35 ). O nly if we take the intensities into account, we see some qualitative e ect. W hereas for non \{ interacting dots ( $w$ ith $p=0$ ) and for $B=0$ the oscillator strength of allm odes agree (for a single oscillator, $f$ is independent of the oscillator frequency), there is a large di erence for interacting dots at $p=0: 5$. This large di erence can be understood as follows. In the lim it $p!1$, the upper pair of $m$ odes develops into the spurious B rillouin zone boundary m ode, which has vanishing oscillator strength and the sum rule has to be ful lled only by the low er pair (see also the discussion below).

In $F$ ig 2 both dot species bare the sam e num ber of electrons. Therefore, only one interaction param eter $p$ is involved. C alculations w ith di erent $N_{i}$ (and $p_{i}$ ) do not show any qualitative di erence. In the lim it of large $p$ (and equalelectron num bers) we obtain from (3픈)

$C$ onsequently, the square of the sm aller e ective con nem ent frequency (which is the only one giving rise to $m$ odes $w$ th a nite oscillator strength for large $p$ ) approaches the $m$ ean value ofboth squared bare con nem ent frequencies, w hereas the larger one grow s continously for large p.
In $F$ ig. 3 and 4 b we show the results for tw o identical, but $m$ utually rotated, elliptical dots. W ithout dot interaction ( $p=0$ ), w e have tw o doubly degenerate lines. $W$ ith increasing interaction strength, we observe a splitting ofdegenerate $m$ odes and an anti-crossing behavior for nite B. As in the case of circular dots, the oscillator strength at B $=0$ for non $\{$ interacting dots ( $p=0$ ) agree for all four $m$ odes. The dot interaction lifts this degeneracy. Additionally, we
observe at $p=0: 5$ that the oscillator strength in the lim its of sm all and large m agnetic elds is considerable only for tw o of the $m$ odes, except in the gap region, where three $m$ odes contribute. By com parison of F ig s 3 a and 4 b we see that the $m$ agnetic eld for $m$ in im $u m$ gap (betw een the second and third $m$ ode) increases $w$ ith increasing $p$, $w$ hereas the gap width decreases. C onsequently, the location and width of the gap provides inform ation on the interaction strength.
By com parison of $F$ ig s 2 and 3 w ith $F$ ig. 4 , and m ore clearly by consideration of form ula (3ँ- and $F$ ig. 5 , it becom es clear that in either case the lower pair of degenerate $m$ odes at $B=0$ converges to a constant (the m ean square bare con nem ent frequency $\overline{\left(!1_{1}^{2}+!{ }_{2}^{2}\right)=2}$, which am ounts to $1: 02!0$ in our num erical exam ple). Even for nite $B$, there are tw o branches, which converge to a nite ( $B$-dependent) value for p! 1 , or in other words, which becom e independent of $p$ in this lim it. At rst sight this looks surprising because the $e$ e interaction does not show any saturation, if we increase the interaction param eter, but it continues to com press the dot state. H ow ever, there is a sim ple visualexplanation for this feature: $G$ enerally, the dot interaction adds an additional second order contribution to the con nem ent, which has the sam e sym $m$ etry as the lattice, i.e. it is circular for a cubic lattice. For large p, this additional term outw eighs the bare con nem ent, and the e ective con nem ent in both dots becom es isotropic and equal. Thus, we approach the case of a lattice of identicaldots, for which a pair of K ohn m odes exists. B ecause these K ohn m odes do not exactly agree w ith the m odes of noninteracting dots, we call them pseudo K ohn m odes. In a sense, the $G$ eneralized $K$ ohn $T$ heorem reentries for dot lattioes $w$ ith strong interdot interaction. In other lattioes $w$ ith lower symmetry, the e ective con nem ent in the strong interaction lim it $m$ ight be elliptical, leading pseudo $K$ ohn $m$ odes $w$ ith a gap at $B=0$. The other pair of $m$ odes ( $w$ hich diverge for $p!1$ ) tums into the in-folded $m$ odes at the B rillouin zone comer (because the units cell halves if all dots becom e equivalent). T hese $m$ odes becom e spurious in the long w avelength and the large\{p lim it and the oscillator strength of them converge to zero.
In $F$ ig s 3 a and 4b we observe an additional qualitative e ect of dot interaction. For isolated elliptical dots we expect a gap between the two excitation branches at $B=0$. H ow ever, for larger ponly the pseudo K ohn m ode m ight be observable, because the oscillator strength of the B Z boundary m ode decrease rapidly. On the other hand, the tw o low er modes for nite $p$ develope out of the degenerate low er $m$ ode for $p=0$, whereby the degeneracy at $B=0$ survíves. Therefore, at $B=0$ it looks as if we had a circular dot. The closing of the gap betw een the two m ost intensive branches at $B=0$ is not a graduale ect proceeding with increasing p, but in itiated by sym m etry. (For a deeper understanding see also the additional gures in Ref. ?.)

## VI.SUM M ARY

We have shown that breaking the GKTh by constructing quantum dot lattioes with at least two di erent dot con nem ents per unit cell has experim entally observable consequences. G enerally speaking, there are no K ohn m odes, i.e. interaction independent $m$ odes, anym ore. In both of the considered cases, the degeneracy in the $F \mathbb{R}$ intensities at $B=0$ between the upper and lower absonption lines is lifted due to dot interaction. For two m utually rotated ellipticaldots (per cell), we observe also a splltting of form erly degenerate absorption frequencies and the appearance of an anticrossing. For two di erent circular dots no qualitative e ect ofe e interaction in the absorption frequencies is observed. Instead, the absorption spectrum can be mim ioed by two noninteracting dots w ith m odi ed (e ective) con nem ents. W ealso pointed out that an extensively strong interaction destroys the e ect of interaction by producing pseudo $\{\mathrm{K}$ ohn m odes. A though this lim it cannot be reached experim entally, it $m$ ight be im portant to take this tendency into consideration.
Only in the case of tw o circular dots there is a sim ple analytical closed form solution. H ow ever, w th the form ulae presented above, the absonption frequencies and oscillator strength for any cubic lattice $w$ ith tw o harm on ic dot species can be easily calculated. The only num ericaltask is to nd the eigenvalues ofan explicitly given non $\{$ Herm itian 88 $m$ atrix and to perform a special sum over the eigenvector com ponents.
