# E xact ground state of the generalized three-dim ensional Shastry-Sutherland m odel

#### Abstract

$W$ e generalize the Shastry-Sutherland $m$ odel to three dim ensions. By representing the $m$ odel as a sum of the sem ide nite positive projection operators, we exactly prove that the m odel has exact dim er ground state. Several schem es for constructing the three-dim ensionalShastry-Sutherland m odel are proposed.

There has been an increasing interest in the Shastry-Sutherland ( $S-S$ ) m odell since it can describe $m$ any aspects fif the two-dim ensional spin gap system $\mathrm{SrCu} \mathrm{u}_{2}\left(\mathrm{BO}_{3}\right)_{2}$ 四 In a series of theoretical investigations various aspects of the $S-S \mathrm{~m}$ odel have been described $4\{8$

The S-S m odel is a tw o dim ensionalsquare lattioe antiferrom agnet w ith additional diagonal interactions in ev ery second square with altemating directions, see Fig. 1. For the square lattioe interaction $J$ and the diagonal interaction $J_{d}$, the $H$ am iltonian can be w ritten as

Shastry and Sutherland have shown that the product of singlet pairs (dim ers) along the diagonal bonds is the ground state of the system for $J_{d} \quad 2 \mathrm{~J}$.

In this paper we generalize the $S-S m$ odel to three di$m$ ensions $w$ ith various types of interactions. Between the di erent planes we can construct the exact ground states of three-dim ensional models and by this increase the num ber of three-dim ensionalm odels $w$ ith the exactly known ground states. W e consider a three-dim ensional cubic lattioe ( $F$ ig 目) constructed from basic cubic units shown in $F$ ig 3 . Each layer in this cubic system is a $S-S$ lattice which is coupled to the next layer by the perpendicular interlayer interaction $J_{\text {? }}$ and the diagonal interaction $J$ connected the diagonalend points to those in the next layer. T hat $m$ eans that the Sharstry-Sutherland diagonals are on top of each other. If we label the dif-
ferent layers by $=1$; ;L and have $N \quad M$ sites per layer, the H am iltonian can be w ritten as

Periodic boundaries in each layer are assum ed and $M$ and N have to be even, while L can be even or odd.

It is instructive to consider two di erent param eter lim its of our model (2): (i) For $J_{\text {? }}=J=0$, the 3D $m$ odel reduces to $L$ independent $S-S$ layers. (ii) For $J=0$ within each layer, the three-dim ensional system decouples to independent $\frac{1}{2} \mathrm{~N} \quad \mathrm{M}$ two-leg spin ladders of length $L$. T he structure of th is ladder is show $n$ in $F$ ig 4 (a). It is know $n$ that such a spin ladder $w$ ith $J_{?}=J$ has exact ground state cem posed of a product of dim ers along the rungs of ladde 12 as long as the exchange interaction along the rung satis es the condition $J_{d} \quad 2 J_{?}$. $T$ his $m$ eans that in both of the special cases, the product of singlet pairs along the inlayer diagonal bonds is the exact ground state of the $m$ odel (2). In the follow ing, we $w$ ill prove that for the general case (but $J_{\text {? }}=J$ ) the ground state of the three-dim ensionalm odel is given by the product of all diagonal singlet pairs

$T$ he rigorous proof is $m$ ade by representing the above m odelasa sum of the positive sem ide nite pro jection operators and the above condition (4) guarantees that $D$ is the ground state of the system. The proof furtherm ore em ploys the fact that the global H am iltonian (2) can be w ritten as a sum ofm any localsubH am iltonians de ned on the basic cubic unit (see F ig $\mathrm{B}^{3}$ ). There are altogether $Q=\frac{1}{2} N \quad M \quad L$ units as localsub $H$ am iltoniansh. $T$ his part of the H am iltonian can be w ritten as

which is just the sum of spin exchange interactions along the bonds represented by bold lines in F ig. B. Those spin interactions represented by thin lines belong to the neighboring cubes.

We now de ne a projection operator $P$ com posed of three one half spins as

which pro jects a state into the subspace w th total spin $3=2$. U sing the projection operators, we can transform our H am iltonian part h which is represented as

It is obvious that, for $J_{d}=2\left(J+J_{\text {? }}\right)$, certain term $s$ in Eq. (7) vanish and thereby the H am iltonian is a sum
of four positive sem ide nite projection operators. The singlet state

has the low est eigenvalue 0 for each of the four projection operators and thus is the ground state of this sub$H$ am iltonian. For larger $J_{d}$ this singlet is also the low est energy eigenstate of the term $S_{1}^{1} \quad$, and hence it is the ground state of the total sub $H$ am iltonian $h$ w ith the ground state energy $\mathrm{E}_{\mathrm{h}}=\frac{3}{4} \mathrm{~J}_{\mathrm{d}}$. A 11 the other sub $H$ am iltonians de ned on other basic units of cube have the same properties as the one explicitly shown in $F$ ig. 3. Therefore, the global ground state of this three-dim ensional $m$ odel is just a product of dim ers for each layer. Such a ground state is essentially an optim um ground state of the global H am iltonian, since it is sim ut taneously ground state of every local sub $H$ am iltonian 9 The corresponding ground state energy is then given by

This general proof actually does not depend on the special coupling param eters betw een the layers we discussed so far. W e see that the $m$ ain condition is that the dim er along the diagonals in the layer should be also the dim ens along the rungs of the corresponding ladders. A nd as long as the vertical spin ladders have dim ers along the rungs as ground states, w e can put them together in three dim ensions. Therefore, generalization of the model (2) is straightforw ard by changing the inter-layer coupling w ay. The rst example is that we couple the di erent layers only along one interlayer diagonal ( F ig 4. (b)). In this case we require $J=2 J_{\text {? }}$ which $m$ eans that the individual ladders are $M$ a jum dar-G osh chains ${ }^{11} T$ he second exam ple is given when the twolds of ladder have di erent interactions ( $F$ ig. (4. (c)) 1213 Ifwe call them $J_{\text {? }}$ and $J_{?}^{0}$, we should have the conditions

Even the lim it $J_{?}^{0}=0$ is allowed and we have vertical saw tooth chains coupled together ${ }^{14} 115$ In the third exam ple, we m ay couple the di erent layers by som e interm ediate spins shown in Fig.5. If this coupling has a strength $\mathrm{J}^{0}$, we should have the condition

and the ground state is still a product of dim ers each layer. There could be of course other constructions. $T$ he $m$ ain point is that we have show $n$ that the ShastrySutherland layer could be coupled to other layers by different $m$ echanism $s$ which only have to $m$ ake sure that these ladders have dim ers on the rungs as ground state.

W e have lim ited our discussion to hom ogeneous m odels in which every basic unit has the sam e structure and exchange strength. W e can also generalize our discussion to inhom ogeneous cases, e.g. to a m odel where the inlayer coupling strength $s, J$ and $J_{d}$, are di erent in each layer. In this case we only have to $m$ ake sure that the constraint

is still full lled.

To conchude, we extend the tw o dim ensionalS-S model to three dim ension and nd the exact ground state of the generalized three-dim ensionals-S m odel. A $n$ exact proof based upon the representation of pro jection operators is given. W e also discuss severalw ays of extending the 3D S-S m odel.
