## Shot Noise at High Tem peratures

We consider the possibility of measuring non-equilibrium properties of the current correlation functions at high tem peratures (and sm allbias). Through the example of the third cum ulant of the current (S<sub>3</sub>) we demonstrate that odd order correlation functions represent non-equilibrium physics even at sm all external bias and high tem peratures. We calculate  $S_3 = y (eV=T)e^2I$  for a quasi-one-dimensional di usive constriction. We calculate the scaling function y in two regimes: when the scattering processes are purely elastic and when the inelastic electron-electron scattering is strong. In both cases we nd that y interpolates between two constants. In the low (high) tem perature limit y is strongly (weakly) enhanced (suppressed) by the electron-electron scattering.

#### I. IN TRODUCTION

Since its discovery by Schottky in 1918, noise in electrical circuits has been thoroughly investigated. Num erous studies over the past decade, both experim ental<sup>1</sup> and theoretical (see Refs.<sup>2;3</sup> for reviews), em phasized the quantum and them esoscopic aspects of noise, addressing quite extensively the issue of non-equilibrium "shot" noise. Shot noise has been employed for probing fundamental physics of interacting electrons in the FQHE regime<sup>4</sup>. Most of previous work focused on current-current correlations, i.e., uctuations derived from second order current current

where  $\hat{I}(t;x)$  denotes the instantaneous current operator integrated trough the entire cross-section (at point x); x is the direction of the ow of the d.c. current. Equilibrium noise is governed by the Callen-W elton relation, also known as Fluctuation D issipation Theorem (FDT). It connects the 0 hm ic part of the conductance G (!) with the equilibrium current noise ( $S_2 = S_2 = \hat{I}^2$ , I  $\hat{H}_1$ )

Let us consider a two-term inal constriction subject to an applied bias, eV, which is equal to the di erence between the chemical potentials of the left and the right reservoirs eV =  $^{\rm L}$   $^{\rm R}$ . The constriction length L is much larger than an elastic mean free path  $l = v_{\rm f}$ (L l). The value of the d.c. electron current through the system is given by 0 hm's law, I = GV. In the absence of electron-electron collisions the second moment of the current uctuations can be expressed in terms of the equilibrium correlation function, eq. (2) (cf. Ref.<sup>5;6</sup>)

Depending on the ratio between the temperature of the system, T, the frequency under discussion, !, and the applied voltage, V, one may distinguish among di erent regimes. In the limit (eV maxfkT;!g) the noise, eq.(3), is essentially non-equilibrium (shot noise), and is proportional to the absolute value of the d.c. electric current. For eV maxfkT;!g S<sub>2</sub> is mostly them al, or N yquist noise. These observations are not system dependent, but rather follow from general considerations, namely the properties of various operators under time reversal transform ation.

Since the current operator changes sign under time reversal transform ation, any even-order correlation function of the current uctuations (e.g.  $S_2$ ) taken at zero frequency is invariant under this operation. A ssum ing that current correlators are functions of the average current, I, it follows that even-order correlation functions depend only on the absolute value of the electric current (and are independent of the direction of the current). In the 0 hm ic regime thism eans that even-order current correlation functions (at zero frequency) are even functions of the applied voltage. Evidently, this general observation agrees with the result eq. (3) for the second-order correlation function  $S_2$  in the di usive junction.

By contrast, odd-order current correlation functions change their sign under time reversal transform ation. In other words, such correlation functions depend on the direction of the current, and not only on its absolute value. Therefore in the 0 hm ic regime, odd-order correlation functions of current are odd-order functions of the applied voltage. This condition autom atically guarantees that odd-order correlation functions vanish at therm al equilibrium.

The present analysis focuses on the simplest, yet nontrivial, example of manifestly out-of-equilibrium correlator, namely the third order current correlation function  $S_3$ . This is the lowest order correlation function which is dominated by non-equilibrium uctuations even in the regin e where the applied bias is small compared with temperature. There are two situations where the study of shot noise under such conditions is called for. Firstly, when the lowering of the temperature of the electron is not facilitated. Secondly, and more interestingly, when one is interested in exploring the correlations in the system above a certain critical (or a characteristic) temperature. On one hand this requires to keep the temperature relatively high. On the other hand, to study low energy features, one is restricted to low values of the voltage.

In this work we argue and subsequently show that for the third order (and in fact all odd order) current cumulant, out-of-equilibrium uctuations are not masked by large equilibrium noise: S3 remains linear in voltage (and tem perature independent) at high tem peratures. The rst part of our analysis (Section II) focuses on the tem perature dependence of  $S_3$ , in the lim it where the inelastic length is much larger than the system 's size. We nd that  $S_3$  is proportional to the the d.c. current at all tem peratures, and calculate how the proportionality coe cient interpolates between the two asymptotic values, 1=15 and 1=3, for T eV and T eV respectively. In the second part of this paper (Section III) we study the e ects of inelastic electron-electron scattering. W e speci cally consider the lim it of  $l_{in}=L$ 1, where  $l_{in}$  is the inelastic electron-electron mean free path and L is the length of the conductor. We nd that as com pared with the elastic case  $S_3$  is weakly suppressed in the high tem perature lim it (by 15% )but is highly enhanced in the low temperature limit (cf. Table I). Similarly to the elastic case S<sub>3</sub> is not masked by thermal uctuations in the high tem perature lim it.

O ur analysis em ploys the recently developed non-linear -m odel{K eldysh technique<sup>8 {10</sup>. This approach has been applied to study non-equilibrium noise in the presence of disorder and electron-electron interactions<sup>10</sup>. The main steps to be followed in the analysis below include nding the saddle point of the e ective action (eqs. 18 and 43 for the elastic and the inelastic cases respectively) and expanding in soft modes around them (eqs. 22 and 80). The saddle point (or the approximate one in the inelastic case) are connected with the single-particle distribution function, while the soft modes describe the dynamics of the density uctuations. Both are signi cantly modi ed by strong inelastic scattering.

There are of course other methods that can be employed to study non-equilibrium uctuations. One appealing candidate would be the Shulman-Kogan<sup>11</sup> version of the Boltzmann-Langevin scheme. This method work successfully when  $S_2$  is studied. In Section IV we present a short discussion which shows, arguably in an unexpected way, that the traditional kinetic equation approach breaks down when higher order cum ulants are addressed. Section V includes a brief discussion.

### II. THE ELASTIC CASE

A shasbeen shown in  $\text{Ref.}^{12}$ , by modeling the measurement procedure as coupling of the system to a \quantum galvanom eter", the emerging mathematical object to be studied is

Here x is a coordinate measured along a quasi onedimensional wire (0 x L) of cross-section A; T is the time ordering operator along the Keldysh contour and  $I_2$  is a quantum component of the current. Since the process we consider is stationary, the correlation function depends only on dimences of time,  $S_3$  (t  $f_t t^0 = t^0$ ). In Fourier space it can be represented as

(Here we have assumed that the frequencies  $!_1; !_2$  are small compared with the inverse diusion time along the wire, such that the current uctuations are independent of the spatial coordinate). We next evaluate the expression, eq. (4), for a particular system, in the hope that the qualitative properties we are after are not strongly system dependent. In the present section we consider non-interacting electrons in the presence of a short-range, delta correlated and weak disorder potential (<sub>f</sub> h, where is the elastic mean free time and f is the Fermi energy). To calculate  $S_3$  we employ the -m odel form alism, recently put forward for dealing with non-equilibrium di usive systems (for details see Ref.<sup>10</sup>). As was stressed in our previous work this approach is a generalization of the Boltzm ann-Langevin kinetic approach<sup>11</sup>. It is comparable to the latter as long as the kinetic approach is applicable to di usive system s.

A direct employment of the kinetic approach, assuming the random force term to be short-ranged correlated in space, does not give correctly the the higher-than-two cumulants of the current. The reasons for that are discussed below (cf. Section IV).

The Ham iltonian of our system of non-interacting electrons in disordered system s is:

where is the density of states at the Fermi energy.

Following the procedure outlined in  $\text{Ref.}^{10}$ , employing the di usive approximation and focusing on the outof-equilibrium system, one can write a generating functional, expressed as a path integral over a bosonic matrix eld Q

Tr represents sum m ation over all spatio-tem poral and K ekdysh components. Here  $a_1$  and  $a_2$  are the K ekdysh rotated classical and quantum components of a. Hereafter we focus our attention on  $a_1$ ,  $a_2$ , the components in the direction along the w ire. The absence of di usive motion in clean metallic leads implies that the di usion propagator must vanish at the end points of the constriction. In addition, there is no current owing in the transversal direction (hard wall boundary conditions). It follows that the component of the gradient of the di usion propagator in that direction (calculated at the hard wall edges) must vanish as well. The correlation functions of the eldsw; w are then given by:

To evaluate  $S_3$  one follows steps similar to those that led to the derivation of  $S_2$ , see R ef.<sup>10</sup>. If all relevant energy scales in the problem are smaller than the transversalThouless energy (E<sub>Th</sub> = D = L<sub>T</sub><sup>2</sup>, where L<sub>T</sub> is a width of a wire), the wire is e ectively quasi-one dimensional. (13)), performing a perturbative expansion in the uctuations around the saddle point solution, eq. (18).




FIG.1. The scaling function y plotted on a logarithm ic scale, cf. eq. (27)

where p = eV=2T. The function y is depicted in Fig.1, where it is plotted on a logarithm ic scale.

Let us now discuss the main features of the function  $S_3$ . In agreement with symmetry requirements  $S_3$ is an odd function of the voltage (the even correlator  $S_2$  is proportional to the absolute value of voltage), and vanishes at equilibrium. The zero temperature result (high voltage lim it) has already been obtained by m eans of the scattering states approach for single-channel system  $s^{13}$ , and later generalized by m eans of R andom M atrix Theory (RM T) to multi-channel system s (chaotic and di usive)<sup>14</sup>. In our derivation we do not assume the applicability of RM T.O ur result covers the whole tem – perature range. We see that at low temperatures the third order cum ulant is linear in the voltage

At high tem peratures the electrons in the reservoirs are not anym ore in the ground state, so the correlations are partially washed out by therm al uctuations. One may then expand y(p), eq. (27), in a series of eV=2T. The leading term in this high tem perature expansion is linear in the voltage

Note that although them al uctuations enhance the noise (compared with the zero temperature limit), eqs.(28) and (29) di er by only a numerical coe cient. For the symmetry reasons alluded to in the introduction (the vanishing of  $S_3$ ;  $S_5$ , etc. at equilibrium), it is tempting to conjecture that allodd order current cum ulants interpolate between two constant values as the ratio eV=kT is varied. The experimental study of these cum ulants provides one with a direct probe of non-equilibrium behavior, not masked by equilibrium them al uctuations.

#### III. IN E LA ST IC CASE

In our analysis so far we have completely ignored inelastic collisions among the electrons. This procedure is well justi ed provided that the inelastic length greatly exceeds the system's size. How ever, if this is not the case, di erent analysis is called for. To understand why inelastic collisions do matter for current uctuations, we would like to recall the analysis of  $S_2$  for a similar problem. The latter function is fully determined by the electron tem perature. Collisions among electrons, which are subject to an external bias, increase the tem perature of those electrons. This, in turn, leads to the enhancement of  $S_2$ , cf. R efs.<sup>15;16</sup>. In the lim it of short inelastic length

the zero frequency and zero tem perature noise is

By comparing with the !;T = 0 lim it of eq. (3) we see that inelastic collisions enhance the current uctuations.

In the present section we consider the e ect of inelastic electron collisions on  $S_3$ .

In the present analysis we assume that the electronphonon collision length is large,  $l_{e\ ph}$  L, hence electron-phonon scattering may be neglected. The H am iltonian we are concerned with is

Though we have failed to nd the true saddle point the linear part of the action expanded around () is zero. It is remarkable to notice that under conditions (46) eq.(44) becomes a quantum kinetic equation<sup>17</sup> with the collision integral being I<sup>ee</sup>fFg. The above procedure consists of an expansion of the action, eq.(40), around its saddle point. The expansion presum es slow uctuations in space and time (though the results obtained, expressing  $S_3$  in terms of the distribution function and the e ective propagator, eq. (79), m ay be valid under less restrictive conditions). Hence this procedure implies that the collision integral, I<sup>ee</sup>, appearing in the quantum kinetic equation, eq.(44), accounts only for electron-electron collisions with sm allm om entum transfer. W e therefore need to ascertain that these are indeed the small m om entum

transfer processes which make the dominant contribution to the electron-electron collision rate. To estimate the relative importance of the small and large momentum processes we compare their respective contributions to the energy relaxation time,  $_{ee}$ . Electron-electron scattering with smallm omentum transfer leads to result<sup>17;18</sup>:

the contribution to the inelastic mean free time coming from scattering with small momentum transfer is dom inant; ignoring it would result in seriously overestimating  $e^{e}$  time (and correspondingly the mean free path  $l_{e}$ ).

C om ing back to our calculations we note that the correlation function of current uctuations is a gauged invariant quantity (does not depend on the position of the Ferm i level). This means that momenta q  $^{12}$  =D do not contribute to such a quantity<sup>19</sup>. In this case the C oulom b propagator is universal, i.e. does not depend on the electron charge. The fact that we address gauge invariant quantities allow s us to represent the generating functionalZ in term softhe eldsQ and r k (rather than Q and ), as in Ref<sup>8</sup>.

O ur calculation was perform ed for a simple rectangular constriction. However, our results hold for any shape of the constriction, provided it is quasi-one dimensional (we have considered a single transversalm ode only).

Finally we discuss the role of an applied magnetic eld. Consider a two-term inal geometry and a non-interacting electron gas. For such a system any current correlation function can be expressed through the channel transm ission probabilities  $fT_ig$ . Onsager-type relations dictate that the transm ission probabilities are invariant under the reversal of the sign of the magnetic ux (\phase locking"), i.e.,  $T_i() = T_i()$ . This implies  $S_3() = S_3()$ . Let us take the zero bias voltage limit. Because  $S_3$  is an even function of the magnetic ux it cannot change its sign under time-reversal operation. On the other hand, by its very de nition, it must reverse its sign under the time reversal operation. It therefore must vanish. We conclude that the magnetic eld alone, while breaking the time reversal symmetry, cannot lead to nite-value odd current correlators.

# IV.W HY THE STANDARD K INET IC EQUATION APPROACH FAILS

The phase coherence is not signi cant for the current uctuations in the weakly disordered m etals (the statem ent remain true for any system for which electron dynam ics is classical). This suggest that the kinetic theory of uctuations may be suitable description of the problem. Here we state, that even though the dephasing length may be short  $(l_{rm ph} L)$  the is no purely classical route to indigin order current correlation functions.

O ne possible way to represent the kinetic theory of uctuations is through Boltzm ann-Langevin equation<sup>11</sup>. The deviation f of the exact distribution function from its coarse-grained) value (f) satis es a stochastic equation with the random additive noise (J):

The lhs. of eq. (84) is the conventional drift term of the kinetic equation; Col is a collision integral. The random ux term J which is added to the standard Boltzm ann equation, induces uctuations of the distribution function f. The correlation of the random uxes can be related in the universal manner to the coarse-grained particle ux in the phase space (which is specil c for each given problem). However the very applicability of the kinetic equation as well as the applicability of kinetic theory of uctuation are controlled by the same parameter (in our case  $_{\rm F}$ ). However, the normalized ratio between high and low order current cum ulants is small by exactly the same parameter.

To see, where the kinetic (K ogan-Shulm an) procedure fails we try to go along the standard way (for the sim plicity for non-interacting electrons). In the di usive approximation one may keep only the lowest harm onics:

eq. (26) (and similarly eq. 79)) are reproduced. Here the function F(F) is related to the singe-particle distribution function (cf. eq. (19)). Eq.(90) shows that the correct high-order correlation functions of the random uxes are non-local in space. This is clearly in contradiction with the assumption made within the K ogan-Shulm an form alism.

In other words, one usually employs the Boltzm ann-Langevin-K ogan-Shulm an approach approximating the actual probability distribution function of the random current ux by a Gaussian distribution. Seem ingly, this is justified because of the large dimensionless conductance g 1. In the scattering states picture, this condition is equivalent to a large number of transm ission channels. We know<sup>13</sup> that each channel provides its own independent contribution to the current noise. A coording to the central lim it theorem, a process that consists of a large number of independent random contributions is characterized by a (nearly) Gaussian distribution function, independently of the distribution function of the individual contributions involved. However, because the value of the dimensionless conductance is indeed large, yet nite, the distribution function of the random current ux deviates from Gaussian. Such deviations are beyond the validity of the Boltzm ann-Langevin approach. S<sub>3</sub> is the lowest order current cum ulant that probes these deviations.

This is not surprising. Indeed, since the distribution function f is a macroscopic quantity, (at equilibrium) it must satisfy the Onsager regression hypothesis<sup>21</sup>. The kinetic theory of uctuations can be viewed as an extension of the this hypothesis for a non-equilibrium situation<sup>22</sup>. Since the Onsager hypothesis is restricted to pair correlation functions only, it is natural to expect that the kinetic theory has the same limitations.

## V.D ISCUSSION

We have noted that due to general symmetry reasons odd order cumulants of the current must be odd functions of the applied voltage and must therefore vanish at equilibrium. Provided these cumulants are analytic functions of V, they must increase linearly with voltage bias when the latter is small, they increase linearly with the latter. Thus, contrary to even order cumulants, they are not masked by a background thermal noise. Even more remarkably, at high temperature, the third order current cumulant approaches a constant value. This is in contradistinction with the second order current correlator which diverges with the temperature. This is the reason why quantities such as  $S_3$  are suitable for the study of non-equilibrium current noise even at relatively high temperatures.

Our results for  $S_3$ , pertaining to both the elastic and the inelastic cases (the high and low temperature limits), are summarized in Table I:

In the elastic limit one can regard the electrons as non-interacting; the problem then is a natural extension of the ballistic multichannel setup. Indeed, at low frequencies one may ignore the dynamics of the electrons within the constriction, which allows us to employ the Landauer scattering states approach<sup>28</sup>. The latter consists of describing the constriction by a quantum transmission matrix, expressing the currents and their correlation functions through

the transm ission coe cients. (It has been noted, though, that coherency is not essential for deriving the leading order contributions to shot-noise in disordered system s, cf.  $\text{Refs.}^{23;24}$ ).

Since odd order current correlation functions vanish at equilibrium, they must be proportional to the di erence between the distribution functions on left and right respectively. But such contributions do not diverge with increasing tem perature, which is a form al reason for the saturation of the odd order correlation functions at high tem peratures.

For disordered system s the transmission coe cients are random variables and their statistical properties are known from R andom M atrix Theory  $(RMT)^{25;26}$ . Employing RMT one may average the scattering states result over the disorder. This reproduces the results we have obtained in the limit  $l_{in}$  L, and in particular eq.(27).

Finally, we brie y comment on the observability of high order current correlation functions. Consider an ameter that detects the net charge transmitted through a given cross-section over a time interval . Under the condition that is su ciently long (n = hIi = 1, where n is the average number of electrons passing through a given cross-section within the time interval ), one may extract the low frequency current uctuations from the statistics of the transmitted charge (known as a counting statistics). Indeed, to describe low frequency current uctuations one has to require h= to be smaller than the relevant energy scale. For tem perature T 100K we require  $10^1$ p sec, the latter condition satis ed for any practical measurements. The more realistic restriction comes from the available electronics, and we estimate 1nsec. For hIi 100 nA we nd n 100.

As we see, in principle a measurement of  $S_3$  is possible. One should note that in this consideration the nongeneric parasitic noise (such as an ampli ers 1=f noises and etc.) had been ignored.

Zero temperature current noise in quantum coherent junctions (i.e. the elastic case)<sup>14</sup> is a manifestation of a stochastic process that follows binom ial distribution. The full counting statistics in the elastic limit has recently been found<sup>14;27;20</sup>. It remains an open problem to nd the counting statistics in the strongly inelastic limit. Our analysis reveals that the asymmetry of the probability distribution function (a measure of which is S<sub>3</sub>) is modified in a non-trivial way (i.e., it is either enhanced or suppressed by the electron-electron interaction, depending on the dimensionless parameter eV=T).
