# 2D RANDOM D IRAC FERM IONS:LARGE N A P PROACH

#### Abstract

W\) e study the sym $m$ etry classes for the random $D$ irac ferm ions in 2 dim ensions. W e consider $\mathrm{N}_{\mathrm{f}}$ species of fem ions, coupled by di erent types of disorder. We analyse the renom alisation group ow at the order of one loop. At $\mathrm{N}_{\mathrm{f}}$ large, the disorder distribution ows to an isotropic distribution and the e ective action is a sigm a m odel.


## 1. Introduction

$R$ andom $D$ irac ferm ions in 2 dim ensions appear in various contexts in condensed $m$ atter physics. $T$ hey w ere used to $m$ odeldisorder in system $s$ $w$ ith degenerate Ferm i surface [2], in the d-w ave superconductors [3, 4] or to investigate the plateau transition in the integer quantum H alle ect [5]. In all these problem $s$, the $m$ ain question concems the localization of quasiparticles, often di erent from the generic A nderson localization.

The universal properties of a system where random ness is present depend largely on the discrete sym $m$ etries, like tim e reversal invariance or spin rotation sym $m$ etry. This principle govems the $W$ igner-D yson classi cation of random herm itian $m$ atrices [1]. C onsidering other discrete sym m etries, like particle-hole or chiral sym m etry, led A ltland and $Z$ imbauer [6] to extend this classi cation. H ow ever, it w as recognized that the physics of 2 d D irac ferm ions is richer than expected from the random $m$ atrix classi cation, in the sense that for the sam e sym $m$ etry class, som e system smay be critical and other not. O ne reason is that in tw o dim ension, the sigm a m odels, which are supposed to describe the universalphysics, can support a topological term. In the form of a theta or W ZW term, they can render the m odel critical [7, 8]. Som etim es, the presence of such a term can be deduced from general considerations $[7,8]$, in other situations it can be obtained exactly [3, 16]. A possible strategy, adopted in $[14,15]$ and applied here to all classes, is to try to
derive the e ective sigm a m odel, topological term included, by chain of controlled approxim ations. T he draw back is that we have to consider a large num ber of ferm ion species $N_{f}$ in order to have a control param eter for the approxim ation. This $m$ eans that the $m$ ost interesting cases, where $N_{f}$ is $s m$ all, are out of reach of this $m$ ethod.

The symm etry classes for $2 d$ random $D$ irac ham iltonians, were recently analysed [9]. T he constraint that the discrete sym $m$ etries should also preserve the form of the $D$ irac operator leads to a re nem ent of the A Hland-Z imbauer classi cation, in which the classes A III, C I and D III, appear each in two di erent form s . H ere, we pursue the characterization of the sym $m$ etry classes for the $D$ irac $H$ am iltonians of [9]. W e com pute the beta function for all the disorder perturbations. W hen the num ber of ferm ion components $\mathrm{N}_{\mathrm{f}}$ is large the ow of the coupling constants generically closes on a single coupling constant, a fact which sim pli es considerably the derivation of the e ective action. This was done for classes D in [14] and for classes C and C I in [15], and we refer to these papers for the details of the $m$ ethod. W thout surprise, we obtain the sigm a m odels de ned on the $m$ anifolds identi ed by $Z$ imbauer [6]. T he two di erent versions of classes A III, C I and D III give rise to sigm a m odels w ith orw ithout a W ZW term.

W e consider random $D$ irac $H$ am iltonians in $2 d$, in the representation

$T$ he discrete sym $m$ etries preserving the form of the $D$ irac $H$ am iltonian are [9]

T he rst condition w illbe called chiral sym $m$ etry, while the second one could be called particle-hole sym $m$ etry when $c=1$ and tim e reversal sym $m$ etry (or spin rotation invariance) when $c=+1$. The sym $m$ etry conditions im pose constraints on the $m$ atrix elds $V, M, A_{z}$ and $A_{z}$, which are listed in [9]. W e consider gaussian probability distribution for the disorder, com patible $w$ th the sym $m$ etry conditions.
$T$ he spectral properties of the $H$ am iltonians 1 can be analysed using the supersym $m$ etry [10] (or replica) $m$ ethod, in which products of $G$ reen functions are represented by gaussian integral over equal num bers of
ferm ionic and bosonic D irac elds. A verage over gaussian random ness introduce e ective coupling betw een the bosonic and ferm ionic elds, the coupling constants being the disorder variances.
$T$ he rst step of our analysis is the renorm alisation group ow for the e ective coupling constants. T he analysis can be eventually perform ed at all orders [11]. In the section 3 we give the one loop beta functions for all the clases and for any $\mathrm{N}_{\mathrm{f}}$. Generically, at large $\mathrm{N}_{\mathrm{f}}$ the ow closes on a single coupling constant, corresponding to equalvariances for di erent types ofdisorder. ${ }^{1}$ In this case, thee ective interaction, quartic in the the D irac elds, can be decoupled via a H ubbard-Stratonovich transform ation using a (super)m atrix eld Q whose dim ension does not depend on $N_{f}$. The num ber of com ponents of the D irac elds appear as an overall factor and it can be used as controlparam eter for a saddle point approxim ation.

T he e ective action for the eld $Q$, hence the saddle point equation, has global invariance, described by a group G. T he solutions of the saddle point equation break the invariance to a subgroup $H$, so that the m anifold of saddle points is given by $\mathrm{G}=\mathrm{H}$. T he low energy behaviour is obtained by taking slow ly varying con gurations of the eld on $G=H$ (G oldstonem odes) and evaluating the action for thesem odes. $T$ he result is a sigm a $m$ odel on som e sym $m$ etric (super) space. G iven the fact that in two dim ensions sigm a models can support a topological term, wem ay obtain a theta term or a W ZW one. In the last section, we give a list of bilinears in D irac elds to which couple the eld $Q$, the invariance group $G$ of $Q$, as well as a diagonal solution of the saddle point equation qo together w ith its stabiliser H. Together w ith the coupling constants, these are the basic ingredients to characterize the sigm a m odel for each sym $m$ etry class.

## 2. D isorder perturbations

W e use notations sim ilar to [14] . To obtain a com pact notation, we introduce superm ultiplets

and sim ilarly for , ${ }^{t}$, where + and are ferm ion multiplets $w$ ith $N_{f}$ com ponents while + and are bosonic ghostsw ith the sam e num ber of com ponents. T he superscript $T$ denotes transposition.

In the absence of disorder, the action for the D irac elds is w ritten

and it corresponds to a conform al eld theory w th central charge $\mathrm{c}=0$. From the holom onphic (antinolom onphic) elds ( ), one can construct the current algebra $\operatorname{OSp}\left(2 \mathrm{~N}_{\mathrm{f}} \mathfrak{Z} \mathrm{N}_{\mathrm{f}}\right)_{\mathrm{k}=1}$ [16].

## 3. The one loop beta functions

To study the renorm alisation group ow for the coupling constants, we need the corresponding beta function. T hey can be derived from the operator product expansion of the perturbing operators $O_{i}$

The results for di erent classes are listed in the rem aining of this section.
T he non-ch iral classes
C lass 0 (A)

This class do not posses neither chiral invariance, nor particle-hole/ tim e reversalsym $m$ etry $W$ e set $N_{f}=N$ and consider only disorder which do not break parity invariance of the action. The disorder elds A, $V$ and $M$ belong to $g l(\mathbb{N})$; the $s l(\mathbb{N})$ part generates the perturbation operators $O_{A} ; O_{V} ; O_{M}$, while the $g l(1)$ part generates $O_{a} ; O_{v} ; O_{m}$. $T$ he corresponding beta functions are

In the large $N$ lim it, the line $g_{A}=g_{V}=g_{M}=g_{m}=g_{v}=2 g_{a}=$ $g \quad 1=\mathrm{N}$ is preserved by the RG ow. It is interesting to note that we cannot obtain an invariant line w ith all the coupling constants positive.

C lasses 3 and 4 ( $D$ and C)
These classes have particlehole sym $m$ etry ( $c=1$ ), inforced by sym $m$ etric, respectively antisym $m$ etric $m$ atrix ${ }^{T}=\quad$. W e set $N_{f}=$ $2 N$, but for class $D, N$ can be half integer. T he random elds $A$ and V belong to the algebra so (2N ) (case D ) and sp (2N ) (class C ). These algebra are spanned by a subset of the $s l(2 N)$ generators $e_{I}$, I, selected by the condition $I=\quad \frac{T}{I}{ }^{1}$. The eld $M$ belongs to the com plem ent of these algebras w ith respect to $\operatorname{sl}(2 \mathrm{~N})$, spanned by $\mathrm{T}_{\mathrm{I}} \mathrm{w}$ ith $\mathrm{T}_{\mathrm{I}}=$

$T$ hese classes have tim e reversal (spin rotation) sym $m$ etry, $w$ ith ${ }_{c}=1$ and ${ }^{T}=\quad$ They are sim ilar to classes 3 and $4, w$ ith the random elds $V$ and M changing roles: now M belongs to so ( 2 N ) and $\operatorname{sp}(2 \mathrm{~N})$ respectively, while $V$ belongs to the com plem ent $w$ ith respect to $\operatorname{sl}(2 \mathrm{~N})$. $T$ he beta functions can be obtained from that of the classes 3 and 4 by changing $g_{m} \$ g_{v}$ and $g_{m} \$ g_{v}$.

T he chiral classes
The rst type of chiral classes corresponds to $=1$ in eq. 2 and it com prises three classes. Only disorder of the vector potential type is allow ed, and these classes can be seen as lim its of the previous ones $w h e n g_{v} ; g_{M} ; g_{v} ; g_{m}$ ! 0 .

These classes have also both particle-hole and chiral sym $m$ etry, $w$ th the $m$ atrioes en forcing these constraints anticom $m$ uting, $f ; g=0$.

Ifwe choose ${ }_{c}=1$, them atrix de ning the particle-hole sym $m$ etry is sym $m$ etric for class $D$ I and antisym $m$ etric for class $C I I$, as for the cases 3 and 4 or 7 and 8. The opposite choice exchanges the sym $m$ etry of the m atrix betw een the two classes.

As in the previous case, we split the $g l(2 N)$ generators into four classes. Since $f$; $g=0$, i spans now $g l(\mathbb{N})$, to which the eld A belong. $V$ is generated by , which span $O(2 N) \operatorname{ngl}(\mathbb{N})$ and $\operatorname{sp}(2 N) \operatorname{ngl}(\mathbb{N})$ respectively. $M$ is again generated by T .

At large $N$ the $R G$ ow preserves the line $g_{A}=0$ and $g_{A}^{+}=g_{M}=$ $g_{v}=4 g_{a}$.

W e note that the equations listed above have interesting properties under the transform ation $g_{M} \$ g_{v}$ and $g_{m} \$ \quad g_{v}$. This operation leave the equations for classes $0,2,7$ and 8 invariant and exchanges the ones for classes 3,4 and 9 , therefore it is equivalent to changing the sign of c , when de ned ${ }^{2}$. M oreover, on the line $g_{M}=g_{V}=g$ $\left(=g_{m}=g_{v}, w h e n\right.$ they exist), the ow for $g$ and the ow for $g_{A}$ decouple. This was noted in [18] for class 0 and was related to "spincharge" separation, for class C in [12].

## 4. H ubbard-Stratonovich transform ation and the sigm a m odel

$W$ e consider products of $n G$ reen functions, $n_{R}$ retarded and $n_{A}$ advanced, and we need to introduce a copy of the $m$ ultiplets 4 for each G reen function. W hen the H am iltonian has chiral or particle-hole invariance, the spectrum is sym $m$ etric $w$ ith respect to $E=0$ and we do not need to distinguish betw een retarded and advanced sector. In this case, the density of states can be singular at the point $E=0$.

A s already $m$ entioned, when the coupling constant have equal values, the decoupling of the quartic interaction is particularly sim ple. At that particular point, the disorder perturbation can be w ritten only in term $s$ of singlets of $g l\left(\mathbb{N}_{f}\right)$. T he decoupling $m$ atrix $Q$ couples to these singlets and it has a size independent of $\mathrm{N}_{\mathrm{f}} . \mathrm{Up}$ to an additive constant, the e ective action for $Q$ is

The saddle point equation $S Q=Q=0$ can be solved $m$ aking a diagonal ansaz $Q_{0}=q_{0}$, where $q_{0}^{2}=1$ and has the dim ension of a $m$ ass. A s there is no scale in the problem, $g_{i}$ being dim ensionless, is dynam ically generated. T he group $G$ acts on $Q$ by conjugation, and from a particular saddle point solution $q_{0}$ one generates a wholem anifold by $q_{0}!q=g q_{0} g^{1}$. This $m$ anifold is isom onphic to $G=H$, where $H$ is the stabilizer of $q_{0}$. T he last step in deriving the sigm a model is to evaluate the action 12 on slow ly varying con gurations $q(x)$ on $G=H$. A $n$ elegant $w$ ay of doing it is to use non-abelian bosonisation [17], as in $[4,14]$ and to $w$ rite the free action as a $W$ ZW model. The eld $q(x)$ becom es a m ass term for the W ZW eld, which is foroed to follow it. At scales larger than ${ }^{1}$, the e ective action is

$T$ he coupling constant for the sigm a m odel is given by the inverse of the num ber of the $D$ irac ferm ions, $f=1=N_{f}$.

## N otes

1. Exceptions may be the coupling constants corresponding to som e $u$ (1) part of the disorder, speci c to classes $0,1,2$ and 9 . This situation $w$ as analysed in the case 1 (A III) in [4] and in [18] in a non-hem itian version of case 0 . For the $m$ om ent, we ignore th is point and analyse the case of equal disorder variances.
2. W e thank to $D$. Bemard for pointing out that this can be realized on the $D$ irac $H$ am iltonian via a non-unitary transform ation.
