Them al Fluctuations of a Liquid Helium Inside a Spherical Volum e

The theory of the thermal hydrodynamic uctuations in bounded systems has been developed only for non-super uid liquids on the base of the linearized N avier-Stokes equations [1]. However, the study of e ect of con ned geometry on correlation functions of super uid liquid is important for explanation of experiments in which capillaries, pores, dense suspensions and other objects are probed by radiation [2].

In this paper we present the correlation theory of the equilibrium thermal hydrodynamic uctuations of compressible super uid helium con ned by the spherical cavity of radius R. The hydrodynam ic uctuations in the super uid helium are described on the base of linearized two-liquids Khalatnikov's equations [3] with spontaneous heat and strains. For mass ow \mathcal{J} and relative velocity $w = v_n + v_s$ of normal-uid and super uid components these equations have form

Here s is the entropy per unit mass, p is the pressure; , , and $_1$; $_2$; $_3$ are the heat conductivity, the "rst" viscosity, and the "second" viscosity coe cients, respectively; are the super uid, normal-uid, and total densities. The system (1) is written with account of the Onsager symmetry principle for the kinetic coecients. All kinetic coe cients and therm odynam ic derivatives in (1) assum ed to be independent of coordinates. By (1) the uctuation elds of mass ow, mass density and other variables are linear functionals of random forces in the right parts of these equations.

A ssum ing that the rigid-cavity surface is motionless we apply zero boundary conditions for the perpendicular component of mass ow $\mathcal J$ and temperature uctuations $\mathcal T$ in the liquid helium, and the stick boundary conditions for the normal component of velocity [4]

We present the mass ow, relative velocity, mass density and the temperature uctuations in the form

Here $Y_{m\,n}$ (;') are the spherical functions and j_n (k r) are the spherical Bessel functions [5]. Note that $E_{m\,n}$ (r); $M_{m\,n}$ (r); $N_{m\,n}$ (r) form the system of pairw ise orthogonal functions. From the boundary conditions (2) we nd out eigenvalues k:

We present also the longitudinal and transverse parts of the random viscous force f and heat uxes q in the form of expansion (3) with coe cients f and Q a, respectively, a = M; N; L, and the random potential H -as in eq.(5) with coe cients H.

It is convenient to use the Fourier representation for random \mathcal{J} , w, , \mathcal{T}

Since the equations for the Fourier-am plitudes of the m ass ow $J^{\circ}_{!}$ and relative velocity W $^{b}_{!}$ uctuations (b = M;N) do not contain components of other elds we im mediately obtain that

Ignoring the products of dissipation coe cients, uctuation forces and keeping only the terms linear in the dissipation coe cients we get

and u_1 , u_2 are the rst-and second-sound velocities for the in nite space [3]; $_1$, $_2$ are the attenuation coe cients of the rst- and second-sound, respectively. Ignoring terms proportional to $_{\rm S}$ $\frac{\rm e}{\rm eT}$ $_{\rm p}$ and $\frac{\rm ep}{\rm c_p}$ $\frac{\rm cp}{\rm c_v}$ 1 $\frac{\rm u_2^2}{\rm u_1^2}$ for the rst- and second-sound attenuation coe cients we obtain

where c_p , c_v are the speci c heats at constant pressure and volume, respectively. The expansion coe cients for the excess mass density can be expressed in terms of J^L .

From the expression for the rate of energy dissipation in the liquid ${\tt H\,eII}$ con ned in the sphere volume ${\tt V}$

U sing the Langevin equations (11), (12) we construct as in [6] the matrix of the generalized susceptibilities. And then by FDT and the spectral densities of equilibrium thermal uctuations for the expansion amplitudes of the hydrodynamic elds. This resulted in

where (!;T) is the expression [6] for the average energy of the quantum oscillator.

The result di ers from the spectral densities for an in nite super uid by only the discrete behaviour of the wave numbers k. Factorisation of the coe cient D in (17) allows us to decompose the expressions for the pair correlation function of J^L into the simple fractions. And the spectral densities of the J^L as in the case of an in nite medium [7], consist of two contributions

Now it is easy to construct the spectral densities of therm all uctuations of the mass ow and the mass density hydrodynamic elds

We have separated the rst- and second-sound contributions to the mass density - mass density correlation function. The correlation functions are presented as the sum of the series in dierent spherical harmonics and roots of the transcendental equations (8), (9). As mentioned above, the dierence between this case and that of in nite space is only in the discrete nature of the wave numbers k. Each term in this series generates two M and elstam-Brillouin doublets, which are caused by quasiphonons of two kinds, one having the rst- and the other one the second-sound speed. Each components of the doublets are of Lorentz type, their widths being given by $_1$ u_1 and $_2$ u_2 , and the spectral densities of the thermal uctuations of mass ow and mass density can be presented as combinations of in nite numbers of such Lorentzians.
