W orm like chain or tense string? A question of resolution

It is shown that a worm like chain, i.e., a lament with a xed contour-length S and a bending elasticity , attached to a frame of length L, can be described | at low resolutions | by the same type of elastic free-energy as a tense string. The corresponding tension is calculated as a function of tem perature, L, and S.

E lastic free-energies are used to describe the distorted states and uctuations of softm atter (Chaikin and Lubensky, 1995). The latter includes liquid-crystals (de Gennes and Prost, 1993), surfactant m em branes or interfaces (Israelachvili, 1991), and polym ers (Doi and Edwards, 1989). In this paper, we investigate how the elastic free-energy functional of a lam ent with a xed contour-length and a bending rigidity (worm like chain) depends on the spatial resolution at which it is described. We perform a nite renorm alization group (RG) iteration in order to determ ine the free-energy associated with the length of the lam ent that is hidden at low-resolution. A sim ilar study, focused on surfactant m em branes, was recently published in a short paper (Fournier et al., 2001).

The laments considered here are known as worm like chains (K ratky and Porod, 1949), or sem i- exible polymers (D oi and E dwards, 1989; Landau and Lifshitz, 1971). At temperature T, a lament with a bending rigidity has a persistence length $L_p = =k_B T$ (Landau and Lifshitz, 1971): for contour-lengths S L_p it resembles a exible rod, while for S L_p it resembles a wandering polymer. There are various natural realizations of sem i- exible polymers: actin cytoskeletal laments, L_p ' 4 17 m (K as et al., 1994), m icrotubules, L_p ' 6m m (G ittes et al., 1993), and DNA, L_p ' 50 350 nm (H agerman, 1988; M arko and Siggia, 1995). Here we shall consider uctuating laments with S L_p , however they will be stretched by attachment to a

fram e of w idth L < S.

The paper is organized as follows: in Sec. I we recall how a coarse-graining procedure allows to de ne di erent free-energies associated with di erent (spatial) resolutions of the same system; in Sec. II we describe the high-resolution free-energy of a worm like chain; in Sec. III we calculate the corresponding low-resolution free-energy, and we show that it coincides with that of a tense string; in Sec. IV we sum marize and discuss our results.

I. CONSTRUCTING ELASTIC FREE-ENERGIES

The free-energy of a system in therm odynam ic equilibrium with a heath bath at tem perature T is dened by

where $= 1=k_B T$ is the inverse temperature and i labels the microscopic states (microstates) of the system, H_i being the energy, or H am iltonian of state i. The above sum $P_{i2S} \exp(H_i)$, also called restricted partition function Z_S , runs over di erent subsets S of the phase space of all the microstates of the system. Each subset S de ness a macrostate: it is a collection of microstates that we wish to consider macroscopically as a whole. F [S] is the free-energy of the macrostate S; it is either a functional or a function depending on the explicit form of S. For instance, in the standard therm odynamics of a uid, the macrostates S are de ned by specifying the number of particles N and the volume V of the uid. Hence, F is a function of the variables T;V;N.

It is most convenient to divide the phase space into a collection of disjoint m acrostates S. Then, since we know from statistical mechanics that the probability for the system to be in an arbitrary m icrostate i is given by

where $Z = P_{i2} \exp(H_i)$, the quantity

is the probability to nd the system in the macrostate S. Indeed, from Eq.(1) we have $Z^{-1} \exp(-F[S]) = \frac{P_{-12S}}{P_{-12S}} Z^{-1} \exp(-H_{i})$. In other words, F[S] plays the role of a H am iltonian for the macrostates S. If the macrostates are well-chosen and large enough, the system will uctuate little around the macrostate S[?] that minimizes F[S], i.e., around the most probable macrostate. The latter determines then the macroscopic \equilibrium state" of the system.

In general, for a soft-m atter system, one chooses for the m acrostates S the proles of the orderparameter eld: the latter is de ned as the local average of some interesting material property, e.g., for a nem atic¹, $Q_{ij}(r) = \lim_{i} (x) \lim_{j} (x)$ $\frac{1}{3}_{ij}i$, where m (x) is the orientation of the molecule situated at point x, the average running over a small volum ecentered on r. Note that the size 0^{1} of this volum em ay be chosen at will and sets a cuto 0 for the order-parameter eld. In the case of a lament, one may simply choose the positions r(s) of its constituting elements.

It is essential to note that we have a complete freedom to choose the \resolution" at which the phase space is coarse-grained into the m acrostates S. For example, on the one hand, we m ay be interested in the m icroscopic uctuations of a bilayer m embrane, as resolved at the scale of the m embrane thickness (' 40A). We would then de ne the free-energy F [S], as in Eq. (1), by summing over all the m icrostates i compatible with a given shape S of the bilayer. Specifying one of these m icrostates would require specifying all the coordinates, velocities and conformations of all the lipids within the bilayer. On the other hand, we may be m icro-m anipulating a membrane under an optical m icroscope. In this case, we would only be interested in the Fourier components of the membrane shape with wavevector q less than the typical wavevector of the visible light. We would then construct a free-energy functional F [] by summing over all them icrostates compatible with the poorly resolved shape of the membrane (Fournier et al., 2001). This would give us a toolm ore adapted to the experiment, since exp(F []) is directly the probability of observing (up to a norm alization constant).

The free energy F [] = $k_B T \ln \frac{P}{i2} \exp(H_i)$ associated with the coarse-grained states can be calculated also from

Equations (4) and (5) de nea \coarse-graining" procedure that can be carried-out for any partition of the phase space that is obtained by grouping the elements of a sub-partition S. Note that the RG consists in applying this procedure repeatedly while rescaling the lengths and the elds at each step (G oldenfield, 1992).

It is usually in possible to directly perform the microscopic sum dening F []. However, assum ing on the grounds of symmetry² a simple form for F [S], it may be possible to determ ine F [] analytically from Eq. (4). The functional F [] will in general involve renormalized elastic constants (Chaikin and Lubensky, 1995) depending both on the elastic constants of F [S] and on temperature T (these new elastic constants take into account the elects of the thermal uctuation occurring at shorter scales). However, F [] may have a functional form fairly dilerent from that of F [S], as we shall see in the following.

It should be noted that this procedure, although akin to that of the RG, is di erent from the point of view of its scope. The scope of the RG is to identify the phases and critical points of a system by coarse-graining/rescaling in nitely. Here, the scope is to construct a free-energy functional adapted to the resolution at which the system is actually observed, or described (i.e., a tool t to determ ine the shape and uctuations of the system at this resolution).

II. A WORM LIKE CHAIN AT HIGH RESOLUTION




FIG.1 Param eterization of the lam ent's shape. The disc indicates the plane norm alto \hat{x} , in which r(x) lives. In practice, we shall consider lam ents that remain in the vicinity of the x-axis.

Let us consider a lament of xed contour-length S, attached at its extrem it is to two xed points, separated by a distance L along the x-axis (Fig. 1). We choose as m acrostates S (see Sec. I) the m icroscopic shape of the lament, measured at the resolution that corresponds to its thickness. We restrict our attention to small deform ations of the lament, hence we parameterize its shape by a norm all displacement eld r(x), with r = 0 and $x \ge [0; L]$. Each m acrostate S thus corresponds to a eld r(x). Let us introduce its Fourier transform r_q : extending r(x) periodically in such a way that r(x + L) = r(x) for each x, we may write

with q = n = 2 =L, where n is a positive or negative integer. Since the highest resolution for r(x) corresponds to the lament's thickness ' a, we require

The lament is assumed to be made of a xed number of incompressible segments, hence its

is xed. Here we have used the exact expression for the elementary arc-length ds = $dx^{p} \frac{1}{1 + (dr=dx)^{2}}$ and we have expanded the result up to second-order in r(x). In the following, assuming small tranverse excursions of the lament, we shall system atically expand all expressions in power-series of r(x), and retain only second-order term s.

U sing Eq. (6) and $\frac{R_L}{0} dx \exp(iqx) = L_{q;0}$, where is the K ronecker symbol, we have

We have used the property $r_q = r_q^2$ that follows from the fact that r(x) is real-valued.

We assume that the free-energy of the lament, obtained in principle from the microscopic material properties through the procedure embodied in Eq.(1), is simply proportional to the integral of the square of the lament's curvature (Harris and Hearst, 1966; Kratky and Porod, 1949). More precisely,

Let us calculate the squared curvature up to second-order in r. From $dM = dx \pm dr$, where M is a vector the extrem ity of which runs along the lam ent, we deduce the tangent vector t = dM = ds' $\begin{bmatrix} 1 & \frac{1}{2} (dr=dx)^2 \end{bmatrix} \pm dr=dx$. Hence, the curvature is $dt=ds' = \begin{bmatrix} (d^2r=dx^2) & (dr=dx) \end{bmatrix} \pm \frac{1}{2} = dx^2$ and $(dt=ds)^2'$ $(d^2r=dx^2)^2$. The functional in Eq. (11) becomes, up to second order in r,

III. THE SAME WORM LIKE CHAIN AT LOW RESOLUTION

Let us now assume that we are not interested in the Fourier components of the lam ent's shape in the range $\langle jqj \rangle _{0}$ (with $\rangle 0$). For instance, we may be observing the lam ent with an experimental setup of resolution 2 = . The coarse-grained macrostates of interest (see Sec.I) correspond then in real space to

The eld R (x), i.e., the poorly resolved shape of the worm like chain, has a cuto lower than that of r (x). We are interested in the free-energy F [R] de ned as in Eq. (4) and not in F [r]. Indeed, expf F [R]g is, up to a multiplicative constant, the probability for the occurrence of a given low-resolution shape R (x) | with any possible wrinkle in the either inaccessible or uninteresting range < jrj < _0; on the contrary, expf F [R]g would be the probability for the occurrence of a given low-resolution shape R (x) having no high-wavevector wrinkles at all (which is useless since it corresponds to a very particular and unlikely event). Note that in a purely harm onic system | which is not the case here because of the xed contour-length constraint | the probability weight of the wrinkles is actually independent of the low-resolution shape R (x); in this case F [R]= F [R].

Following the procedure embodied in Eq. (4), we have

Here, r_q^0 and r_q^{00} are the real and in aginary parts of r_q , respectively. The integration variables [the wrinkles hidden in R (x)] span the range $\langle q \rangle_0$ of positive wavevectors only, because r_q and r_q are not independent (they are complex conjugates). In principle, the above calculation is valid only for sm all values of r_q , however, thanks to the G aussian character of the integrand, we take the integrals as running over] 1;1 [. The D irac delta-function takes into account the constraint on the lam ent's contour length [see Eq. (12)].

Let us call S the contour-length of the low resolution shape R(x), i.e., the apparent contourlength. The latter, which is no longer xed, is given by

up to a multiplicative constant independent of , which we discard as it merely shifts F \mathbb{R}] by a xed amount independent of R (x). We obtain

Thus the free-energy associated to R (x) contains a bending term [as previously for r(x)] plus a new potential (S) function of the contour-length of the low-resolution lament's shape. Note that corrections to would have been generated if we had taken into account the non-harm onic term s in Eq. (13) (Helfrich, 1985; Peliti and Leibler, 1985). A correct treatment of these terms, including measure factors (Caietal, 1994) is outside the scope of this paper.

In the therm odynam ic lim it (L ! 1), the integral in (S) can be approximated by its saddlepoint value (W alker, 1970). This yields




FIG.2 P bt of the reduced e ective worm like chain's tension against the reduced hidden length s. The hatched region is forbidden. The top curve corresponds to $= 10^{-4}$ and the lower one to $= 10^{-3}$. For $< s_{max}^{-1}$ there is no way to obtain a vanishing tension: the lament behaves as a tense \string".

The parameter s measures the hidden length of the lament. Since L < S < S, we have

The dimensionless number $_0$, appearing in Eqs. (30) and (33), is the ratio of the persistence length of the lament, $L_p = _0$, to its thickness $_0^1$. For a worm like chain, we expect

The parameter is the ratio of the high-resolution scale (the lament thickness) to the low-resolution scale 1 . O by iously, we shall consider the case

The parameter (having now a dierent meaning than in Sec. I) measures the lament's tension in units of 2_0 . Note that for ${}_0$ 1, the quantity 2_0 is much larger than $k_B T_0$, which we would expect if the tension were of molecular origin.

In terms of these dimensionless quantities, the lament's tension, (s), is de ned by the equation:

Let us now study the various regimes displayed by (s). For s ! 0, diverges as (1)=s, as can be easily seen by neglecting k^2 with respect to in Eq.(36). decreases monotonically and vanishes at s = s[?]() with (for 1)

it becomes then negative. When $< s_{max}^{1}$, s[?] lies beyond s_{max} and is thus unreachable (Fig.2). Hence, as in the membrane case discussed by Fournier et al. (2001), there are two regimes: for $> s_{max}^{1}$, i.e., when the resolution is higher than $_{0}=s_{max}$, the lament is in a oppy regime, while for $< s_{max}^{1}$ (low resolution), it is in a tense regime.

In the oppy regime, the low-resolution contour R (x) exhibits a loose shape with an apparent contour-length uctuating in the vicinity of the value S[?] (associated to s[?]) that m inimizes the potential (S). At S = S[?], we have = 0: the tension e ectively vanishes. This is rem inescent of the case of m em branes (D avid and Leibler, 1991; Seifert, 1995).

B. E ectively a tense string




FIG. 3 The same worm like chain viewed at high and low resolutions. The elasticity describing the low-resolution shape and its uctuations (not drawn) is similar to that of a tense string.

In the tense regime, the apparent contour-length minimizing (S) corresponds to the lowest possible value of , attained at $s = s_{max}$, which corresponds to the lowest possible value of S, i.e., L. The low-resolution, apparent shape of the lament is thus the straight line joining the two xed extrem it is (Fig.3). The lament, described at such low resolutions, behaves therefore e ectively as a tense string of tension $_0 = (L)$. As one pulls on the \string", the apparent contour-length increases (S > L) and so does the tension.

A though Eq. (36) cannot be solved analytically for , approximate solutions can be obtained in the tense regime both formedium and high tensions. Assuming 1, we replace the lowest bound of the integral in Eq. (36) by zero. This gives s' $(1=^{p})$ arctan $(1=^{p})$, which yields the following approximations: s' = (2^{p}) for 0 < 1 (medium tensions), and s' 1= for 1 (high tensions).

For real worm like chains and in the high tension case, we should actually take into account the nite stretching elasticity of the lament: this would modify our results. We shall therefore concentrate on the medium tension states of the tense regime. The relation $s' = (2^p)$ yields

This represents the free-energy we have to pay in order to increase the apparent contour-length of the lam ent by a unit am ount. It is worth noticing the intrinsic character of this expression: it

is independent both of the m icroscopic cuto $_0$ and of the resolution at which the lament is observed. For Eq. (38) to hold, it is necessary that

in order to be well into the tense regime (s_{max}^1).

IV. CONCLUSION

We have shown that at spatial resolutions much less than the wavevector $_{\rm c}$ de ned above, a worm like chain, i.e., a lament with a bending elasticity and a xed contour-length S, behaves as a tense string when it is attached at its extrem ities to a frame of length L. In other words, if one forgets about the microscopic wrinkles of the lament by considering only its low-resolution shape R (x) (the Fourier transform of the microscopic shape truncated at the cuto), one is actually considering a system that has the same type of elastic free-energy as a tense string. Indeed, in the minimum energy con guration, the low-resolution shape of the lament is straight and its tension is given by

which follows from Eq. (38) by setting S = L. Again, we note that this elective tension is independent of the resolution (as long as c). For small deform ations about this straight state, one can neglect the fact that increases with S as one pulls on the \string". Then, the elastic free-energy of the lament, as seen at low-resolution, is

In this last expression, we have neglected the remaining energy associated with the bending of the lament [see Eq.(22)]. It is actually negligible in the tense regime: for all the permitted wavevectors (q <), we have q $_{c}$, and therefore $_{0}q^{2}$ q^{4} since $p_{0} = _{c}$, as can be seen from Eqs. (39) and (40).

A lthough this paper is focused on the concept of e ective tension for a worm like chain viewed at a low resolution, Eqs. (22), (23) and (29) actually give the e ective free-energy t to describe an attached worm like chain viewed at any resolution.

It is interesting to compare the present results with those of previous works. For instance, using the worm like chain model, M arko and Siggia (1995) have calculated the force f needed to extend a DNA molecule attached at its extrem ities. In agreement with experiments (Sm ith et al., 1992), they found that the end-to-end distance approaches the DNA contour-length as f¹⁼². P recisely, they obtained $(4fL_p=k_BT)^{1=2}$ ' 1 L=S in the strong force limit. Since I_p , Eq. (40) reproduces exactly the same result, upon identifying the elective tension $_0$ with the force f.

Since the early work of Helfrich (Helfrich, 1985; Peliti and Leibler, 1985), a large literature has been devoted to the renorm alization of the elastic constants of m embranes. No sim ilar work has been performed on worm like chains, however: this is in part because it is possible to directly calculate the tangent-tangent correlation function by analogy with the di usion on a unit sphere (Harris and Hearst, 1966). A large amount of work has been devoted instead to the interpolation between the worm like and the Gaussian chain (Aragon and Pecora, 1985; Bawendi and Freed, 1985; Ha and Thirum alai, 1995). To the best of my know ledge, how ever, there has been no previous analysis in the spirit of the present paper.
