ON THE CALCULATION OF OHM IC LOSSES AT THE METALLIC SURFACE WITH SHARP EDGES

A bstract

We discuss the applicability of the perturbation theory in electrodynamic problem swhere the local Leontovich (the impedance) boundary conditions are used to calculate the ohm ic losses at the metallic surface. As an example, we exam ine a periodic grating formed from sem i- in nite rectangular plates exposed to the spolarized electrom agnetic wave. Two di erent ways for calculation of the ohm ic losses are presented: (i) the calculation of the re ection coe cient obtained with the aid of the perturbation theory (the impedance is the small parameter) and (ii) the direct calculation of the energy ux through the metallic surface, when to get the answer only the tangential magnetice eld at the surface of a perfect conductor of the same geometry has to be known. The results (i) and (ii) dier noticeably. The same diculty is inherent in all the problems where the metallic surface has rectangular grooves. We show that the standard rst order perturbation theory is not applicable since beginning from a number n even the st corrections to the m odal functions $_{\rm n}$ used to calculate the $_{\rm elds}$, are of the sam e order as the zero order modal functions (the impedance is equal to zero). Basing on the energy conservation law we show that the accurate value for the ohm ic losses is obtained with the aid of the approach (ii).

IN TRODUCTION

In the present publication we would like to x the readers attention on an unexpected situation arising when the perturbation theory is used for calculation of the ohm ic losses at the highly conducting m etallic surfaces with sharp edges. As an example we exam ine the one-dimension metallic periodic grating formed from sem i-in nite rectangular plates (see Fig.1) that is illuminated by s-polarized light.

All the calculations are performed in the framework of the local impedance boundary conditions (the Leontovich boundary conditions) applicability [1, 2]. In other words, we assume that

where is the penetration depth of an electrom agnetic wave into the metal, b is the characteristic size of the surface contour (in our case, the period of the grating) and = 2 c=! is the vacuum wavelength,! is the frequency of the incident wave.

This allows us to restrict ourselves to solution of the Maxwell equations in the region external with respect to a metal. At the metallic surface the boundary conditions for the elds are

 E_{t} and H_{t} are tangential components of electric and magnetic vectors at the metallic surface, n is the unit external normal vector to the surface. The two-dimensional tensor is the surface impedance tensor. The real and imaginary parts of the impedance denergy and the phase shift of the rected electromagnetic wave respectively (see, for example, [1]). In what follows we suppose that in Eqs.(2) the impedance is an ordinary multiplying operator, and it is the same as the impedance of a perfectly at surface of the same metal.

Of course, the boundary conditions (2) are not rigorous ones. In general the relation between $E_{\rm t}$ and $H_{\rm t}$ is nonlocal. Moreover, when the metallic surface is not at, even the local terms in the expression for the components of the surface impedance tensor have corrections depending on the shape of the metallic surface (see, for example, [3, 4].) However, when the inequalities (1) are full led, the leading term in the expression for is equal to the impedance of the perfectly at metallic surface. Having in mind to calculate the leading term in the expression for the ohmic losses we restrict ourselves to these approximation only.

In what follows we assume that the metal is an isotropic one. Then the surface $\lim_{q \to \infty} \frac{pedan}{pedan}$ tensor is = . Under the conditions of normal skin e ect [1] = $\frac{pedan}{pedan}$ (1 i), where is the conductivity of the metal. Under the conditions of anomalous skin e ect the expression for the surface in pedance is more complex (see, for example, [5]). In our calculations we do not specify the character of skin e ect. We only take into account that in the order of magnitude j j = . For good metals this ratio is extremely small.

Note, the local impedance boundary conditions (2) are valid up to the term s of the order of j jonly. Consequently, when calculating the elds the term s of the higher order (for example, of the order bj $\frac{1}{2}$, $\frac{1}{2}$ and so on) must be om itted as far as they exceed the accuracy allowed by the boundary conditions.

Strictly speaking, inequalities (1) provide the possibility to use the local boundary conditions, Eqs.(2), when calculating the elds above the metal only if the surface of the metal is rather smooth. The presence of sharp edges makes this possibility questionable. Of course, in real life all the sharp edges are rounded ones. Undoubtedly, the boundary conditions (2) can be used only if the smoothing characteristic size is greater than too. However, it is rather dicult to take the smoothing regions into account accurately even for very simple surface proles. Therefore rather often Eqs.(2) are used, assuming that a smoothing changes the results only slightly.

It must be noted that the grating depicted in Fig.1 is in nitely long in the x_0 direction. At rst it seems that the boundary conditions (2) are not valid in this case. To justify ourselves we take into account that in the s-polarization state the elds decay exponentially inside the grooves when the distance from the throat of the groove increases. As a result the elds in the vicinity of in nitely deep grooves and the grooves of nite, but rather large depth h (h ma and m is of the order of some units) are practically the same. For such grooves the smoothing of the contour allowing us to use the boundary conditions (2) can be done rather easily.

A first all these prelim in any remarks we are faced with a rigorously set mathematical problem: suppose that a plane wave $E^i = E_0 e^{i(kx_3 + !t)}$ (k = !=c) is normally incident upon the surface depicted in Fig.1. At the metallic surface we have the boundary conditions (2) that are valid up to the terms of the order j j. We impose an outgoing wave or exponentially decaying boundary conditions on the rejected elds. Our problem is to

de ne the ohm ic losses. In other words, we need to calculate the energy ux through the surface of the metal.

Let us introduce the time-averaged Pointing vector in the region outside the metal

that is the density of the time-averaged energy ux. A coording to the energy conservation law [1]

The consequence of the last equation is the equality of the integrals

where the integral in the left-hand side is taken over the surface in nitely distant from the metal. The integral in the right-hand side is taken over the surface of the metal. It do nes the energy ux penetrating through the metallic surface.

It is well known that in nitely far from the metallic surface (x₅) the only nonzero component of the Pointing vector is expressed in terms of the rejection coecient R: $\overline{S}_3 = (c=8) \pm 0.2$ (1 R). Consequently, when the rejection coecient is known, we can calculate the ohm ic losses with the aid of the left-hand side of Eq.(5).

On the other hand we can calculate the energy ux through the surface of the metal directly. With regard to the boundary conditions (2) at the metallic surface the normal component of the time-averaged Pointing vector is $\overline{S}_n = \frac{c}{8} Re \ \frac{1}{2} Re \ \frac{1}{2}$. The last expression can be simplied.

Since j j 1, the magnetic vector H_t at the surface of a good metal is approximately the same as the magnetic vector $H_t^{(0)}$ at the surface of the perfect conductor (the conductivity is in nitely large and, consequently, the impedance = 0) of the same geometry [1]. Then within the allowed accuracy we must rewrite \overline{S}_n as $\overline{S}_n = \frac{c}{8} Re \ \mathcal{H}_t^{(0)} \mathcal{J}_t^2$.

Let us introduce the energy Q_d dissipating in the metal per unit length in the \mathbf{x}_2 direction and per one period. A coording to the previous argumentation and making use of Eq.(5) we can write two equivalent expressions for Q_d

the integral is taken over the contour of the surface relating to one period, and

Note, when Eq.(6a) is used, to calculate Q_d we need to know the magnetic vector $H_t^{(0)}$ at the surface of the perfect conductor only. On the other hand, when we make use of Eq.(6.b) we need to know the rejection coescient R. To calculate R we need the solution of the complete electrodynamic problem in the region over the real metal.

A lot of authors calculated the elds above perfectly conducting gratings (see, for example, [6]). It can be done with the aid of dierent methods [7]. For example, the elds inside the grooves are presented as series of modal functions that are the solutions of the Maxwell equations. The representation incorporates the boundary conditions for perfect

conductors. Above the grooves the usual Rayleigh plane-wave representation is adopted. As a result a matrix equation for the modal amplitudes is obtained. This method makes use of the standard Fourier analysis. There are no doubts with respect to the results obtained with the aid of this method. The other way is based on the solution of the Wiener-Hopf equation. Both methods give the same result.

Applying the local impedance boundary conditions, we can use the same methods when calculating the elds above highly conducting metallic gratings. However, to be sure that we do not fall outside the limits of the boundary conditions (2) applicability, when calculating we have to exploit the perturbation theory based on the inequalities (1). In what follows we show that in this problem the standard perturbation theory is not applicable. More accurately, we show that in our problem the dissipated energy Q_d calculated with the aid of Eq.(6 a) diers from the result obtained with the aid of Eq.(6 b) after calculation of the received and the energy conservation low.

We would like to stress once more, the eld $H_t^{(0)}$ entering Eq.(6a) can be calculated with high accuracy. Then, in the framework of our approximation Eq.(6a) provides the correct result for the ohmic losses. Next, as it is shown below, the method of calculation of the elds above the real metal (the impedance \odot 0) is much alike the one used when calculating the elds above the perfect grating. However, to calculate the dierence 1 Rup to the terms of the order of , we have to use the perturbation theory with respect to the small impedance. Consequently, the source of the obtained discrepancy can be the perturbation theory only.

We faced this problem when calculating the ohm ic losses on the lam ellar grating with nite depth of the grooves exposed to the spolarized light [8]. We found out that for rather deep grooves our result was approximately twenty percents less than the result obtained by LA Vainshtein, SM Zhurav and A ISukov in [9]. In the same frequency region de ned by Eqs.(1) in the framework of the impedance boundary conditions (2) these authors examined the one-dimensional grating with in nitely deep grooves and very thin plates ((b a)=b 1). They based their solution on the application of the Wiener-Hopf equation and calculated the rejection coecient. Then taking into account that according to Eqs.(1) the parameter j j=kb 1, they used the perturbation theory and calculated the difference 1 Rentering Eq.(6b) up to the terms of the order of .

In the s-polarization state there are no physical reasons of dierent results for very deep and in nitely deep grooves. Therefore, trying out to verify our approach, for the grating with in nitely deep grooves we reproduced the perturbation theory calculation of [9] with the aid of the modal function method adopted in our calculations in [8]. The results obtained with the aid of the perturbation theory were the same as in the work of Vainshtein and his co-authors. Then we repeated the calculation with the aid of Eq.(6.a). Comparing the results we found the same twenty percents dierence (see Fig.2).

The result of this analysis is presented in this publication. From our point of view our calculations show that in this problem the application of the standard perturbation theory provide a regular error when calculating the elds above the grating. In what follows we show the place where the standard perturbation theory failed.

It was not the goal of this work to develop a regular perturbation theory allowing us to calculate the elds above lam ellar conducting gratings correctly. The main results of our investigation can be formulated as follows:

i. For highly conducting lam ellar gratings the correct result for ohm ic losses Q $_{\rm d}$ is given

by Eq.(6a).

ii. The coincidence of the result for Q_d obtained with the aid of Eq.(6.a) and Eq.(6.b) can be used as a proof of correct calculation of the elds above the m etallic surface.

The organization of this paper is as follows. In Section 2 we present the modal function approach allowing us to calculate the elds above the metallic grating. In Section 3 we describe the results obtained in the framework of the standard perturbation theory. In Section 4 we calculate the ohmic losses and discuss the reasons why the standard perturbation theory fails. Concluding remarks are given in Section 5. In APPENDIX we show that for an arbitrary value of kb < 1, the formulae used when calculating the elds above the in nitely conducting grating provide the total rejection of the incident wave (the rejection coefficient R = 1).

2 CALCULATION OF THE FIELDS

Let the one-dimensional periodic metallic grating depicted in Fig.1 be exposed to the s-polarized normally incident electromagnetic wave $E^i = (0; E_0; 0) \exp[ikx_0]$. For simplicity we assume that on the at parts $x_0 = 0$ of the surface the impedance is equal to zero. On the inner surfaces of the sem i-in nite grooves the boundary conditions (2) are full led.

The inequalities (1) provide us with three small parameters. Namely,

No other restrictions are imposed on the ratio a=b < 1.

At rst, we will not pay attention to inequalities (7). In what follows we obtain the solution of the problem without using the perturbation theory. We assume only that kb < 1.

Let the superscripts + and denote the elds in the half-space x > 0 and in the central groove respectively. We ith regard to the surface periodicity we adopt the representation 9

for the electric eld above the metal. In Eq.(8) $_0 = k$ and $_q = i (q=b)^2 k^2$, if $q \in 0$. Since on the plain parts $x_3 = 0$ of the surface the impedance is equal to zero, $E_2^+(x_1;0) = 0$, when $a < jx_1j < b$.

Inside the central groove (x_1, y_1, x_2, x_3) we present E (x_1, x_3) as a series of modal functions (x_1, x_3) that are the solutions of the Maxwell equations incorporating the boundary conditions (2) on the vertical sides of the groove¹. Let B_n be the coexients of this series.

Separating the variables we write the modal functions $_n(x_1;x_3)$ as

The set of modal functions $_n$ (x_1 ; x_3) has a lot of interesting properties. We do not discuss them here, but refer the reader to the review work of Yu.I.Lyubarskii [10]. Note, the functions ' $_n$ (x_1) are not orthogonal ones since their scalar product (' $_m$;' $_n$) = (1=2a) $_a^a$ d x_1 ' $_m$ (x_1)' $_n$ (x_1) (the starm eans the complex conjugate) does not equal to zero when m $_n$ n. However, the functions ' $_n$ (x_1) with dierent subscripts are orthogonal:

We used this property of the functions $'_n$ (x_1) when deriving the matrix equation for the modal coe cients (see below Eq.(13)).

Applying the boundary conditions on the plateaus $x_3=0$ and the continuity conditions across the central slit, we obtain two linked matrix equations allowing us to determ ine both the amplitudes e_q^+ and the modal amplitudes B_n . In place of the amplitudes B_n it is convenient to introduce the coexcients X_n ,

We eliminate the amplitudes $e_q^{(+)}$ from the set of matrix equations to obtain the matrix equation for the coe cients X_n . There are two separate matrix equations for the coe cients X_{2n} and X_{2n-1} . The even coe cients X_{2n} satisfy a homogeneous matrix equation. Consequently, all the coe cients $X_{2n}=0$. For the odd coe cients X_{2n-1} our calculations results in the following matrix equation:

We can calculate the coexcients X $_{2n-1}$ solving numerically the in nite set of equations (13). To calculate the rejection coexcient R we take into account that since kb < 1, there is only one rejected wave. In accordance with Eq.(8) its dimensionless amplitude is d and d with d or represent evanescent waves. It seems, that in this way we solve the problem and can calculate the ohm ic losses substituting the found rejection coescient into Eq.(6.b). However, as it was aforementioned, the local impedance boundary conditions (2) are true up to the terms of the order of only. Consequently, to obtain a reliable answer for the ohm ic losses we need to extract the terms of the order of from the expression for 1 R. And this is just the place where the perturbation theory has to be used.

3 THE RESULT OF THE FIRST ORDER PER-TURBATION THEORY

The zero term of our perturbation theory corresponds to = 0. We use the superscript (0) to denote that = 0. Then in accordance with Eqs. (9) we have

M oreover, the impedance enters the matrix equation (13) only through the dependence on $_{21\,1}$. Thus, from Eq.(13) it follows that the coe cients X $_{2n\,1}$ depend not on all the

three small parameters listed in Eq.(7) separately, but on the two small parameters only. They are kb and ". When " = 0 the coe cients $X_{2n}^{(0)}$ (kb) denie the elds above the in nitely conducting grating. Suppose that we know the solution of Eq.(18.1). To take into account the nite conductivity of the metal, we need to make use of the perturbation theory when solving the matrix equation (13) and calculate the rst corrections to $X_{2n-1}^{(0)}$ (kb) in the small parameter ".

Note, according to Eq.(11) and the denition of the coecients $X_{2n\ 1}$, Eq.(12), the same corrections provide the electric eld E up to the terms of the order of . Since the starting point of these calculations, the local impedance boundary conditions (2), do not allow us to calculate the elds up to the terms higher than , when calculating the coecients $X_{2n\ 1}$ the terms of the order higher than " (for example, of the order of) must be omitted within the accuracy of the local impedance boundary conditions applicability.

With the aid of Eq.(17) we expand all the coe cients in Eq.(13) up to the terms of the order of ". Then with regard to Eqs.(18) after tedious, but straightforward algebra we obtain that up to the terms of the order of " the solution of Eq.(13) has the form

4 CALCULATION OF OHM IC LOSSES

At rst, let us calculate the dissipated energy Q_d with the aid of Eq.(6a). We mark the result of this calculation with the superscript (sur). We rem ind that we set = 0 at the at parts $x_3 = 0$ of our surface. Then in Eq.(6a) the integration is performed over the vertical facets of the central groove, where the tangential magnetic vector is $H_3^{(0)}$ (a;x₃) (x₃ < 0). Now we can rewrite Eq.(6a) as

When calculating $Q_{\rm d}^{(1)}$ it is necessary to have in mind, that the dissipated energy has to be equal to zero for a perfectly conducting surface. In other words, when =0 and, consequently, $X_{21\,1}=X_{21\,1}^{(0)}$ (kb), $Q_{\rm d}^{(1)}$ vanishes for an arbitrary value of kb < 1. In APPENDIX we show that this equality is full led for $X_{21\,1}^{(0)}$ (kb) that are solutions of Eq.(18.1).

As a result, substituting the expression (19) in Eq.(24) we obtain $Q_d^{(1)}$ in terms of the coe cients $X_{21\,1}^{(0)}$ (0) and $V_{21\,1}$.

Our next step was num erical calculation of the coe cients 2 X $^{(0)}_{21\,1}$ (0). With this result in hand we evaluated the right-hand side of the matrix equation (20.1) and calculated

the coe cients $V_{21\,1}$. Finally, we calculated numerically $Q_d^{(sur)}$ and $Q_d^{(1)}$ with the aid of Eq.(23) and Eq.(25) respectively.

In Fig 2 we plot the dimensionless values $q_i = Q_d^{(1)} = db \not\!\!\! E_0 \not\!\!\! I^2 Re$ and $q_i = Q_d^{(sur)} = db \not\!\!\! E_0 \not\!\!\! I^2 Re$ as functions of the ratio a=b. We see that for all a=b < 1 the results for $Q_d^{(1)}$ and $Q_d^{(sur)}$ dier noticeably.

In Fig.2 we also display the results for the ohm ic losses obtained by LA Vainshtein and his co-authors in [9]. As it was mentioned in INTRODUCTION, they exam ined the same grating formed from thin plates ((b a)=b 1). In [9] the way of calculation was much alike the one used in the present work when calculating $Q_d^{(1)}$, however some other modal functions were used, and the problem was reduced to solution of the Wiener-Hopf equation. Supposing that the impedance of the at parts $x_0 = 0$ of the metallic surface was equal to zero, the authors of [9] obtained an elegant analytic formulae for the leading term of the ohm ic losses

(The superscript (V) indicates that this is the result of [9].)

We see, that our results for $Q_d^{(1)}$ are in good agreement with the values $Q_d^{(V)}$. This con m sour calculations made in the framework of the perturbation theory. However, neither $Q_d^{(V)}$, $nor Q_d^{(1)}$ coincide with $Q_d^{(sur)}$ that is the true energy ux penetrating through m etallic surface. Consequently, we conclude that the obtained result for $Q_d^{(1)}$ (the same as $Q_d^{(V)}$) is in proper, since it leads to violation of the energy conservation law.

4.1 Ine ciency of the standard perturbation theory

We think that the source of this discrepancy is application of the standard perturbation theory. The point is that if 60 the set of modal functions $2n 1 (x_1; x_3)$ (see Eqs.(9)), used when calculating the rejection coefcient, being complete and minimal still does not form a stable basis. As a result expansions in this set can be very sensitive to perturbations (see, for example, [10]).

To show this, let us note that according to Eqs.(16) the zero order eigenvalues $^{(0)}_{2n}$ are equidistant numbers: $^{(0)}_{2n+1}$ $^{(0)}_{2n+1}$ = . However, the distance between $^{(0)}_{2n}$ de ned by Eq.(17) and $^{(0)}_{2n+1}$ increases linearly when n increases. If, for example, $^{(0)}_{2n+1}$ (that is true for hom ogeneous solids under the conditions of normal skin e ect), we have

We see, that $\prime_{2n\ 1}$ (x_1) is a complex function, whose real and imaginary parts are of the same order. The di erence between $\prime_{2n\ 1}$ (x_1) and $\prime_{2n\ 1}^{(0)}$ (x_1) is small only if n

1= .When n 1= the eigenfunctions $'_{2n\ 1}$ (x_1) do not resemble the non-perturbed eigenfunctions $'_{2n\ 1}$ (x_1) at all. In Fig.3 for x_1 = 0 we plot the ratios Re $'_{2n\ 1}$ (0)= $'_{2n\ 1}$ (0) and Im $'_{2n\ 1}$ (0)= $'_{2n\ 1}$ (0) for two values of : = 0.05 and = 0.01.

We must also take into account that in the s-polarization state the strength of the magnetic eld in the immediate vicinity of a rectangular two-dimensional wedge increases signicantly (see, for example, [7]). When the elds are represented by the expressions of the type (11), to describe the elds near the corner points correctly we need to provide a special asymptotic behavior of the coecients X_{2n-1} when n + 1 (see [7]). For x = 0 the coecients X_{2n-1} x = 1 (see [8])

With regard to all the aforementioned arguments we take for granted that in the spolarization state the perturbation theory presented in Section 3 is not applicable when the local impedance boundary conditions are used to calculate the elds above one-dimensional periodic rectangular metallic gratings.

5 CONCLUSIONS

In this section we summarize the results of our analysis. We would like to remind that here we examined the case of the s-polarization only. We put aside the p-polarization state. In the end of this section we'll add some remarks relating to the p-polarization state.

From our point of view, the main result of this publication is the demonstration that the standard perturbation theory can fail if in the fram ework of the local impedance boundary conditions one try to use it when calculating the electrom agnetic elds above periodic metallic gratings. We exam ined the case of rectangular in nitely deep grooves. However, it is quite possible that the same problems arise when the shape of the grooves is, for example, a triangular one, or, more general, when the surface proble has sharp edges.

Our calculations showed that for rough surfaces the results for the reection coecients obtained with the aid of the perturbation theory (the impedance is a small parameter) are not always reliable. On the other hand, there are no doubts that the dissipated energy calculated with the aid of Eq. (6 a) de nest the ohm ic losses accurately. Thus, we can de ne the reection coecient comparing equations (6 a) and (6 b). Then

where the tangential magnetic eld $H_t^{(0)}$ is calculated up to the terms independent of kb. Let us remind that our results were obtained in the frequency region consistent with the inequalities (1).

On the other hand, this approach allows us to calculate the rejection coexcient only. The elds in the close vicinity of a rough metallic surface (at the distances di

We suggest to use Eq.(29) as a veri cation that the applied perturbation theory is accurate.

In some sense the calculation of the ohm ic losses in the p-polarization state is much more simpl. The point is that if inequalities (1) are full led the magnetic eld penetrates into the grooves on the surface. In this case in the main approximation the magnetic eld in the vicinity of the grooves is the same as near a at surface of the perfect conductor. Thus the entire inner surface of the grooves absorbs the electrom agnetic wave. In [8] for an arbitrary one-dimensional periodic surface this argumentation allowed us to obtain rather simple expression for the leading terms of the electrom surface impedance of the perfect conductor.

In Eq.(30) 2b is the period of the surface structure, L is the length of the surface prole per one period and S is the area of the groove in the plane x_1x_3 . If the elective impedance is known, there are no problem swith calculation of the ohm ic losses:

However, some di culties can arise when the perturbation theory is applied to calculate the evanescent waves near rough surface in the p-polarization state. In the present publication we do not exam ine this question.

Let us demonstrate that the solution $X_{21\,1}^{(0)}$ (kb) (l= 1;2:) of the matrix Eq.(18) guarantees the full lm ent of the energy conservation law for an arbitrary value of kb < 1. The equation (18) corresponds to the in nitely conducting grating (=0), and, consequently, the rejection coefficient has to be equal to one. With regard to Eq.(A.6) and Eqs.(A.7) it is evident that both $Z_{2r\ 1}^{(2)}$ and $Y_{2r\ 1}^{(2)}$ are real numbers. When continuing this procedure, we indout that all the coexcients $Y_{2r\ 1}^{(2q\ 1)}$ are imaginary numbers and all the coexcients $Y_{2r\ 1}^{(2q)}$ are real numbers. On the contrary, T_q is a real number when q is odd, and T_q is an imaginary number when q is even.

In the consecutive order we wrote down equations for $Z_{2s}^{(q)}$. Exam ining these equations we obtained form ulae relating $Z_{2s}^{(q)}$ with the other coexcients $Z_{2s}^{(r)}$ with rq. At the last step we eliminated the functions $Z_{2s}^{(r)}$ with the aid of Eq.(A.6).








