# Bogoliubov - de Gennes versus Quasiclassical description of Josephson structures

The applicability of the quasiclassical theory of superconductivity in Josephson multi-layer structures is analyzed. The quasiclassical approach is compared with the exact theory based on the Bogoliubov - de Gennes equation. The angle and energy resolved (coarse-grain) currents are calculated using both techniques. It is shown that the two approaches agree in SIS<sup>0</sup>IS<sup>00</sup> geom etries after the coarse-grain averaging. A quantitative discrepancy, which exceeds the quasiclassical accuracy, is observed when three or more interfaces are present. The invalidity of the quasiclassical theory is attributed to the presence of closed trajectories form ed by sequential re ections on the interfaces.

Studying charge current through weak links, the Josephson e ect, is one of the most im portant part of superconductivity, both theory and experim ent<sup>1,2</sup>. Besides general interest, this problem is in portant for engineering the num erous devices based on the Josephson e ect. The Josephson e ect reveals itself in tunneling junctions as well as more com plex mesoscopic structures built of superconducting and norm al layers. A major part of the theoretical results in this eld has been obtained using the method of quasiclassical Green's functions<sup>3,4,5,6,7</sup>. The advantage of this general method is that disorder and inelastic processes can be conveniently incorporated into the theory. In a ballistic case, one can apply a more sim ple technique<sup>8,9</sup> based on the Bogoliubov - de Gennes (BdG) equation<sup>10</sup>. A strong side of the BdG -approach is that it is valid for description of the interface re ection and transm ission, where the potential varies on a m icroscopic length and the quasiclassical theory in its original form fails. As shown by Zaitsev<sup>11</sup>, an isolated partially transparent interface can be taken into account by a proper boundary condition for the quasiclassical G reen's functions. Recently, there has been considerable technicalprogress where the boundary condition is form ulated using the Schopohl-M akiparam eterization<sup>12</sup> of the guasiclassical Green's function<sup>13</sup>, or in term s of e ective wave functions<sup>14,15</sup>. However, it has been  $argued^{16,17}$  that these boundary conditions may give a wrong result in the case when a coherent scattering by several interfaces takes place. It is shown in Ref.<sup>16</sup> that the quasiclassical density of states of a SS<sup>0</sup> sandwich disagrees with the \exact" one, found from the G or kov equation. The disagreem ent has been attributed in Ref.<sup>17</sup> to the presence of closed trajectories form ed by sequential re ections by the interface and the outer boundaries of the sandwich. In particular, the correction to the quasiclassical G reen's function due to the loop-like trajectories violates the norm alization condition, which is an essential elem ent of the quasiclassical technique. In this paper, we extend these results to the case of an open geometry and analyse applicability of the quasiclassical theory to the Josephson e ect in a multi-layer mesoscopic structure.

The quasiclassical theory is a simpli ed version of the \exact" theory of superconductivity based on the G or'kov G reen's function form alism . The main assum ption made in the course of its derivation is that the potentials vary slow by on the Ferm i wave length  $^-_{\rm F}$  = 2  $=\!p_{\rm F}$ ,  $p_{\rm F}$  being the Ferm i momentum, that is the parameter  $^-_{\rm F}$  =  $_0$  is small, where  $_0$  is the coherence length ( $_0$   $_{\rm F}$  = ,  $v_{\rm F}$  is the Ferm i velocity). The question we address in this paper is whether there are corrections to the theory which are not controlled by the quasiclassical parameter  $^-_{\rm F}$  =  $_0$  1.




FIG.1: A planar, multi-layer structure consisting of N layers separated by barriers and sandwiched by half-in nite electrodes. The complex order parameter denoted  $_0;:::;_{N+1}$  are considered as inputs. It is assumed that each layer is connected to an independent current source  $I_0;I_1:::s$  that one achieves any given distribution of the phase of the order parameters without violation of the current conservation.

To judge if the quasiclassical approach gives valid results, we compare its predictions with the solution to the BdG equation. In the clean case of the mean-eld theory, the BdG approach is fully equivalent to the G reen's function m ethod, which is the starting point to the derivation of the quasiclassical approximation. For this reason we consider the BdG solutions as <code>\exact"</code> for the purpose of the comparison. More speci cally, we consider a multilayer SS<sup>0</sup>S<sup>0</sup> :::structure shown in Fig.1 and calculate the angle and energy resolved partial current j(;"), where

is the angle of incidence and " is the energy of the excitation propagating through the multi-layer structure. C om paring the results of the two approaches, we make our conclusions on the validity of the quasiclassical approximation.

As discussed in detail in Ref.<sup>16,17</sup>, one cannot make any conclusions comparing directly  $j_{B dG}$  (;"), evaluated from the BdG equation with its quasiclassical counterpart  $j_{qc}$  (;"). The point is that in the BdG approach, the incident particle is taken as a plane wave with precisely de ned wave vector whereas in the quasiclassical approach one deals with classical trajectories, where the momentum in the direction perpendicular to the velocity has quantum uncertainty. The in nitely extended plane wave su ers multiple re ections on the interfaces, and the re ected/transmitted waves inevitably interfere because of the in nite extension. The interference leads to an intricate picture of Fabry-Perot like resonances and a ne structure in the angle dependence on the scale




FIG.2: Angle resolved current in a SISIS structure as a function of angle . The energy " = 12 $_{0}$ . The order parameter in the leftm ost superconductor is  $_{0}$ . The order parameters in the next layers read  $_{1}$  =  $e^{i}$   $^{-4}$   $_{0}$ ;  $_{2}$  = i $_{0}$ . The thickness of the internal layer is a =  $v_{F}$  =  $_{0}$ . The interface transparencies  $T_{1}$  = 0:1;  $T_{2}$  = 0:5. The dashed and solid lines show the BdG  $_{j_{B\,dG}}$  and the quasiclassical current  $j_{\rm gc}$ , respectively.

 $_{\rm F}$  =a where a is the layer width. To illustrate this point, we show in Fig. 2 angle-energy resolved j<sub>B dG</sub> current through a SISIS-system of superconductors (S) separated by two barriers (I) in a narrow region of angles (the B dG calculations are done by the method presented

below, see also<sup>18</sup>). The \exact" current shows rapid and strong uctuations in the region where the quasiclassical current is alm ost a constant. However, on a large scale of angles,  $j_{B,dG}$  averaged in a small angle window (coarsegrain current) is a sm ooth function. As discussed in<sup>16,17</sup>, the coarse-grain averaging is equivalent to building stationary wave packets, peaked on classical trajectories, on which the quasiclassical theory is form ulated. It is on this low resolution level where the quasiclassical and exact theory are expected to agree with each other. For these reasons, we use only coarse-grain BdG -current for com parison with the quasiclassical theory. For de niteness, we calculate the current at the leftm ost interface of the multi-layer structure.

In principle, the coarse-grain averaging can be performed analytically applying the path length expansion m ethod of Ref.<sup>17</sup>. (In case of a double-layer, the averaging can be done directly with the result expressed via the elliptic integrals  $1^{9,20}$ .) Nevertheless, we perform the averaging by a num erical integration to avoid lengthy algebra.

The paper is organized as follows. In Sect.I we discuss solutions to the Bogolubov – de Gennes equation. In Sect.IA, we build plane waves and then, in Sect.IB, we introduce the scattering S-m atrix. In Sect. IC, we express the BdG current via the elements of the S-m atrix. The method which we use to evaluate the current in the quasiclassical technique is presented in Sect.II. Num erical results are shown in Sect. III, and their interpretation is presented in Sect.IV. In Sect.V we discuss validity of our results in m ore realistic models. Technical details of the derivation are collected in Appendices.

# I. BOGOLUBOV-DE GENNES EQUATION

In this section, we consider the theory of multilayer structure in the fram ework of the Bogoliubov – de Gennes equation. Stationary two-component wave function (r) =  $\frac{u}{v}$  of an excitation with the energy E satis es the BdG-equation<sup>10</sup>,  $\hat{H} = E$ ,

where  $(p) = \frac{p^2}{2m}$ ,  $\frac{p_F^2}{2m}$ ,  $p_F$  being the Ferm im om entum, V (r) is the potential energy, (r) is the com plex order parameter, and A (r) is the magnetic vector potential.

The charge current density J can be found as

The non-diagonal elements of current operator  $\hat{J}(\mathbf{r})$ , h<sub>n</sub> $\hat{j}(\mathbf{r})\hat{j}_{n^0}\hat{i}$  are evaluated as

In superconductors, the charge current created by an elementary excitation in a state  $_n$  is not a conserving quantity, i.e. divJ<sub>nn</sub>  $\notin$  0. The charge conservation is restored after the sum mation over all the BdG excitations, provided the pair potential is self-consistent.

To take advantage of the unitarity property, one considers the conserving quasiparticle current,  $j^{\rm qp}$  (r), calculated with the help of the operator,  $\hat{j}^{\rm qp} = \frac{\varrho_H}{\varrho_P}$ , that is

follows from the BdG equation.

We solve the BdG equation for the case of a planar structure shown in Fig.1. It is composed of N layers surrounded by two half-in nite hom ogeneous superconductors. The complex order parameters in each layer is a constant which is taken as an independent input.

Choosing the x axis perpendicular to the layer plane, the partially transparent interfaces are modelled by the -function barrier

where is the strength of the potential, m is the mass. Below, we characterize the interface by the parameters  $R = j = (p_F + i) j^2$  and T (R + T = 1) which have the meaning of the rejection coeccient (R), and transparency (T) for the norm allincidence.

## A. Plane wave solutions

D ue to the in-plane translational invariance, the solutions can be taken in the following form

where  $p_{jj}$  is the in-plane m om entum , and obeys the one-dimensional BdG equation.

First, we consider the plane wave solution to the BdG equation in each of the layers where = const and V = 0. The function (x) satisfies the equation




FIG. 3: 4 linearly independent solutions to BdG equation. Index describes the type of the quasiparticle = + is the electron-like and = the hole-like excitation; de nes the sign of the x component of the momentum. As shown by arrow s, the excitation propagates to the right if = +1, and to the left otherw ise.

Note the orthogonality relation (outside the gap),  $y_{2} = 0$ , in agreement with the current conservation in Eq. (1.7). For any E, the determinant of the matrix [+;] the columns of which are + and , equals to unity (in other words,  $T_{1}^{+}i_{y}^{-} = 1$ ).

For future needs, we de ne conjugated am plitudes <sup>z</sup>,

which posses useful properties of orthonormality and completeness:

where  $\hat{1}$  is the unit 2 2 m atrix. O utside the gap, where  $z = y_{\hat{2}}$ , the orthonorm ality expresses the quasiparticle current conservation.

The physical meaning of the quantum numbers and is clear: in accordance with the sign of the probability ux Eq. (1.16), the excitations with = 1 are electronlike whereas the states = 1 are hole-like. The param eter shows the direction of the momentum. The excitations for which the product equals to +1 (-1) propagate in the positive (negative) direction of the x axis.

#### B. The scattering m atrix

To introduce the scattering matrix, we rst de ne the in-com ing and out-going free states, the amplitudes of which are related by the S-matrix. We number the incom ing plane wave states in the following way:

A sbefore, the rst of the lower indices of 's speci es the electron-hole degree of freedom (\+ " for electron, and \-" for hole) and the second one shows the direction of the m om entum = ; the upper index L or R speci es the initial location of the excitation on the left or right side of the structure. The out-going states are

These equations with i = 1; :::; 4 de ne the 4 4 S-matrix. The method which allows us to evaluate the elements of S-matrix is presented in Appendix A.

### C. The BdG current

Expressed via the distribution function of the excitations  $n_i (E)$ , where E is the energy and  $i = 1; \dots; 4$  and E is the quantum number introduced in Eq. (1.22), the charge current in the x direction reads<sup>10</sup>

where  $J_E^{(0)}(x) = P^4 = J_{kk}(x)$ : here summation is performed over the 4 plane wave states F ig. 3 on the left or right side of the structure. The meaning of  $J_E^{(0)}$  is that it would give the (partial) current in the left or right region if the plane wave states with the given energy E were equally occupied. This is the contribution to the current which produces the bulk supercurrent 2eN  $_{s}v_{s}$ . In our case,  $J_E = 0$  since the phase of the order parameter is assumed to be a constant within the outside regions.

The second term in the right hand side of Eq. (1.26) is due to the interference of the incom ing and outgoing waves. Considering for de niteness the left region, the initial states i = 1;2 interfere with the nal f = 3;4 states. For the energy E outside the gap,  $J_{fi}^{(0)}$  is other than zero only if i = 1;f = 2 or i = 2;f = 1 (i.e. for the interference with the Andreev re ected particle). The partial current density J (E;  $p_{jj}$ ) at the point adjacent to the rst interface, i.e. at x = 0 reads

Calculating the current matrix elements Eq. (A 3) with the amplitudes in Eqs. (1.14), and (A 8), one derives from Eq. (1.27) that

where  $_0$  is the order parameter in the left electrode (see Fig. 1)<sup>21</sup>. The scattering matrix is calculated by the transferm atrix method as described in Section A.

Eq. (1.28) gives the BdG current carried by plane wave states with de nite value of  $p_{ij}$ . This quantity strongly

uctuates (see e.g. Fig. 2) as a function of the incidence angle ,  $p_{jj} = p_F \sin in$  the region 1 = (p a), a being typical interlayer distance. To come to the trajectorylike picture, one perform s averaging in a region of angles

. It is the coarse-grain current which should be compared with the current density found from the quasiclassical technique.

#### II. QUASICLASSICAL CURRENT

In the quasiclassical technique,, the current density j reads<sup>4</sup>:

where " is energy and n a unit vector which shows the direction of the m om entum , n (") is the distribution function, and the angular and energy resolved current  $j_h$  (") is found as

where  $v_F$  is the Ferm i velocity and  $g_n^R$  is the retarded quasiclassical G reen's function (see e.g. Ref.<sup>14</sup> for notation). For a given energy " and a parallel m on entum  $p_{jj}$ , the x component of the current along the x axis is sum of the contributions  $j_{n_1} + j_{n_10}$ , where  $(n_1)_x = \cos$  and  $(n_{1^0})_x = \cos$  with being the angle of the trajectory de ned as sin =  $p_{jj}=p_F$ .




FIG. 4: (a) (b) The multi-layer structure consisting of N superconducting layers surrounded by 2 half-in nite superconductors. The order parameters are  $_0$ ; ;  $_{N+1}$ , the interface transparencies are  $T_1$ ; ; $T_{N+1}$ , and the thicknesses of the layers  $a_1$ ; ; $a_N$ . (a) Scattering on the i'th interface with the transparency  $T_i$ . The angle of the trajectory is . (b) The zig-zag trajectory inside of i'th superconducting layer with the order parameter  $_i$ . Due to the translational symmetry are certain parts of the trajectory equivalent, e.g. 1 \$ 1, 2 \$ 2, .

where the G reen's functions are taken at the same space point, e.g. at the interface shown on Fig.4a.

To evaluate the Green's function  $g (= g^R)$ , we use the method of Ref. 14,16 and express the 2 2 matrix g via two-component \wave functions" on classical trajectories:

where = i<sup>T</sup> y. These am plitudes obey Andreev-like equation on classical trajectories (see<sup>14,16</sup>)). The index denotes solutions with di erent asym ptotic behaviour: the am plitude + ! 0 for the trajectory coordinate x going to + in nity: x ! 1, and ! 0 for x ! 1.

The Andreev equation needs a boundary condition when the trajectory hits an interface and ballistic pieces of trajectories are tied by a \knot", see Fig.4a. The

which relates the wave function on the incoming trajectory j to that on the outgoing trajectory j<sup>0</sup>; here and below, j denote incoming channels, whereas j<sup>0</sup> is the outgoing relected one, e.g.  $j = l_i$  and  $j^0 = l_i^0$  on Fig.4a. The knot" transfer matrix M  $_{j^0}$  j is expressed in terms of knots knot" G reen's function  $g_{k^0 \ k}$  which depends on the amplitudes in the channels on the other side of the interface<sup>14</sup>

where T and R = jrf are the transm ission and the reection probabilities. The indices  $l_i$  and  $2_i$  refer to the channels on the other side of an interface, see Fig.4a. A coording to Eq.(2.8) the \plus" am plitude  $_+$  is needed only in the outgoing channels and the \m inus" am plitude in the incom ing ones.

In order to d the G reen's function in one of the external channels (channels which lead to the in dity) we need to calculate the amplitudes  $_{(j)+}$  and  $_{(j^0)}$  in the channels inside of the structure. To d these amplitudes it is convenient to introduce the total transferm atrix M . If one considers the periodic zig-zag trajectory inside of i'th layer, see Fig.4b the M is de ded as the operator connecting the corresponding parts, for example the trajectories  $(2_i)$  and  $(2_i)$  or  $(2_i^0)$  and  $(2_i^0)$ . The total transferm matrices in the i'th layer shown on Fig.4b read

The transfer m atrices M<sub>1i+1</sub> 1<sub>i+1</sub> and M<sub>1i+1</sub> 1<sub>i+1</sub> are found in the same way. As shown in Ref.<sup>14</sup> the quasiclassical G reen's function is found as

For example if we want to calculate G reen's function in the channel ( $2_i$ ) we rst nd the total transfer matrix M  $_{2_i \ 2_i}$  connecting 's in channels ( $2_i$ ) and ( $2_i$ ) and then we calculate  $g_{(2_i)}$  from Eq.(2.14).

When the quasiclassical Green's functions  $g_{(2_1)}; g_{(2_1^0)}; g_{(1_{i+1})}$  and  $g_{(1_{i+1}^0)}$  are known in each layer, one can invert Eq.(2.5) and calculate the amplitudes  $(2_i); (2_1^0)+; (1_{i+1})$  and  $(1_{i+1}^0)+:$

U sing Eqs.(2.5-2.16) we can write down the following iterative procedure:

where i is the order parameter in the i'th layer, and  $j^2 = u^2 + j_1 j^2$ .

- 2. U sing the values of the am plitudes , the \across-knot" G reen's functions  $g_{2_i^0 2_i}$  and  $g_{1_{i+1}^0 1_{i+1}}$  are constructed from Eq.(2.8).
- 3. The \across-knot" G reen's functions are substituted into Eq.(2.7) to calculate the knot transfer matrices M  $_{j^0}$  , where here and below index j stays for  $1_i$  or  $2_i$  in i'th layer.
- 4. The total transferm atrices M<sub>j</sub> <sub>j</sub> and M<sub>j<sup>0</sup></sub> <sub>j<sup>0</sup></sub> are calculated using Eqs.(2.10-2.11) in all layers.




FIG.5: Angle resolved current in SISIS structure averaged over small range of d = 0.09 as a function of energy. The angle of incidence = =4. The solid and dashed lines show for the quasiclassical and coarse-grain BdG current, respectively. The bars show the uctuation of the high-resolution BdG current around its average value. The order parameters in the leftm ost superconductor is \_0. The order parameters in the next layers read \_1 =  $e^{i = 4}$  \_0; \_2 = i \_0. The interface transparencies  $T_1 = 0.1; T_2 = 0.5$ . the thickness of the layer a =  $v_F = _0$ .

- 5. U sing the values of the total transferm atrices from step 4. the quasiclassical G reen's functions  $g_j$  and  $g_{j^0}$  are found from Eq.(2.14).
- 6. At this stage the quasiclassical G reen's function  $g_j$ and  $g_{j^0}$  are known in all layers and the am plitudes <sub>(j)</sub> and <sub>(j<sup>0</sup>)+</sub> can be evaluated using Eq.(2.15-2.16).
- 7. Continue from point 2. until the convergence is reached.

A fler the last iteration the internal amplitudes  $_{(j)}$  and  $_{(j^0)+}$  are known and one constructs the \knot" transfer matrix M<sub>10</sub>  $_1$  on the leftm ost external interface. Since  $_{(1^0)+}$  and  $_{(1)}$  are the bulk superconductor amplitudes (see Eqs.(2.17-2.18)) one calculates also the G reen's functions  $g_{(1)}$ ,  $g_{(1^0)}$  and the partial current in Eq.(2.3).

### III. RESULTS

In this section we present results of the calculations for typical parameters of the multi-layer structure such as distribution of the order parameter, thicknesses and num ber layers (barriers), and the strength of the barriers. Thicknesses of the layers are usually of order of  $v_{\rm F}=~_0$  where  $_0$  is the gap in the leftm ost layer. The value  $p_{\rm F}=~10^3~_0=v_{\rm F}$  is chosen for the Ferm im omentum .

A typical high resolution angular dependence of the current  $j_{B\,dG}$  () has been already shown in Fig. 2. As expected, it does not have any resem blance to the sm ooth quasiclassical behaviour. How ever, after the coarse grain averaging, i.e. on a low resolution level,  $j_{B\,dG}$  is in perfect




FIG.6: Angle resolved current in a three-barrier structure SISISIS as a function of angle as found from the BdG equation. The order parameters in the leftm ost superconductor is 0. The order parameters in the next layers read  $_1 = i_0; _2 = _0; _3 = i_0$ . The thicknesses of the two internal layers  $a_1 = v_F = _0; a_2 = v_F = _0$ . The energy " = 1:1 0. The interface transparencies  $T_1 = 0:1; T_2 = 0:5; T_3 = 0:5$ . The solid line corresponds to the quasiclassical current, a constant in this narrow interval. The dashed line shows the BdG current.

agreem ent with quasiclassics, see Fig 5. The \error-bars" in Fig 5 show the mean square uctuation of the high resolution current around its coarse-grain average. In the double-barrier case, the agreem ent exists for any angle

and energy , and for any set of parameters of the structure, 's and the barrier's strength.

C ontrary, noticeable deviations from the quasiclassical solutions are seen when there are more than two barriers. Here we present results only for three-barrier structures, more complicated systems show qualitatively same features.

For a three-interface structure, a typical high resolution angle dependence of  $j_{B dG}$  is shown in Fig. 6. In Fig.7 we plot coarse-grain BdG-current together with the quasiclassical curve for slightly di erent geom etries: Fig.7 (a) refers to a symmetric case when the two internal layers have exactly the same thickness whereas in 7 (b) the thicknesses are 10 percent di erent from each other. In the both cases, one sees a clear deviation of the quasiclassical curve from the \exact" one, the deviation lesser in asymmetric geometry.




FIG.8: (a) (b) The total current as a function of energy. The solid line stands for the quasiclassical and the dashed line for the BdG current. The order parameter in the leftm ost superconductor is 0. The order parameters in the next layers read 1 =1 = 0; 2 = 0; 3 = 1 = 0. The interface transparencies  $T_1 = 0:1; T_2 = 0:5; T_3 = 0:1$ . (a) Symmetric case: the thicknesses of the two internal layers  $a_1 = v_F = 0; a_2 = v_F = 0$ . (b) A symmetric case:  $a_1 = 0:9 v_F = 0; a_2 = 1:1 v_F = 0$ .

For the sam e geom etries and the order param eters, the energy dependence of the current integrated with respect to the incident angle are shown in Fig.8. D isagreem ent between the exact and quasiclassical results are clearly seen, again stronger in the symmetric case.

## IV . D ISC U SSIO N

The results of the previous section clearly show that in som e geom etries the quasiclassical theory does not reproduce the \exact" results derived from the BdG equation. The two approaches agree only qualitatively. The quan-



titative discrepancy much exceeds the corrections to the quasiclassical theory of order of  $1=\!p_F a =\!p_F \, v_F$  which one m ight expect. Below, we present our understanding of physics behind the discrepancy.





FIG.9: (a) (b) C lassical trajectories. The trajectory is built of ballistic pieces \tied" by scattering on the two interfaces (knots). The arrows show the direction of the momentum. There are no interfering paths in a double-layer case (a). Loops exist in a three-barrier system (b).

As in our earlier papers<sup>14,16,17</sup>, we ascribe the failure of the quasiclassical theory to the presence of interfering paths or, in other words, bop-like trajectories. From this point, the validity of the quasiclassical theory in the twobarrier case (see Fig.5) is in accordance with our expectations. Indeed, in this simple geom etry, the classical path shown in Fig. 9a, is e ectively one dimensional (treelike trajectory in the term inology of R ef.<sup>14</sup>) in the sense that there is only one path connecting any two points. As discussed in R ef.<sup>14</sup>, one is then able to factorize the full propagator G (x;x<sup>0</sup>), x x<sup>0</sup> labelling the points on the tree-like trajectory, as G (x;x<sup>0</sup>) = g(x;x<sup>0</sup>) exp[ip<sub>F</sub> L<sub>xx<sup>0</sup></sub>], where L<sub>xx<sup>0</sup></sub> is the length of the path along the tree-like trajectory connecting x and x<sup>0</sup>, and g(x;x<sup>0</sup>) is a slow ly varying quasiclassical (2-point) G reen's function. In this

case, derivation of the quasiclassical equation does not m eet any di culty, and the theory gives valid results.

Turning now to the sym m etric three-barrier structure, the trajectory is not simple tree-like (see Fig.9(b)): there are loops and, therefore, interfering paths. Then, one m ay expect corrections to the quasiclassical theory, which are not controlled by the quasiclassical param eter<sup>17</sup>. The origin of the corrections and its relation to the existence of loops, can be understood from the following sem iquantitative argum ents.

In the BdG -picture the current Eq. (1.28) is expressed via the element of the S-m atrix  $S_{12}$  that is the Andreev re ection amplitude  $A_e = S_{12}$ . Scattering amplitudes can be presented as a sum of partial amplitudes, each of which corresponds to a particular path of the particle. Among others, there are closed paths shown in Fig.10. The contribution  $A_e^{\text{loops}}$  of the paths in Fig.10 (a) and (b) to the full Andreev rejection amplitude  $A_{\rm e}$  is evaluated in appendix B ,

where A is a coe cient de ned in Eq. (B5),  $a_1$  ( $a_2$ ) is the distance from the barrier 1 to barrier 2 (from 2 to 3);  $r_1$  and  $r_3$  are the amplitudes of rejection from the barrier 1 and 3 respectively. Note that this simplest loop survives the coarse grain averaging only if  $a_1 = a_2$ . We understand the larger deviation from quasiclassics seen in the symmetric case compared with an asymmetric one, as due to the contribution of the simple loop.




FIG.11: Angle resolved current averaged over sm all range of d = 0.09 as a function of energy. The angle of incidence = =4. The solid line stands for the quasiclassical current. The other two lines correspond to  $_3$  positive or negative. The order parameters in the leftm ost superconductor is  $_0$ . The order parameters in the next layers read  $_1 = i_{0}; _2 = _{0}; _3 = i_{0}$ . The interface transparencies  $T_1 = 0.5; T_2 = 0.5; T_3 = 0.5$ . The thicknesses of the two internal layers  $a_1 = v_F = _{0}; a_2 = v_F = _{0}$ .




FIG.12: The di erences between currents in SSSS setups differing only by the thickness of the last layer. The thicknesses are  $a_1 = a_2 = v_F = 0$  in the rst case and  $a_1 = v_F = 0$  and  $a_2 = 1.002v_F = 0$  in the second case. The order parameter in the leftm ost superconductor is 0. The order parameters in the next layers read  $1 = i_0; 2 = 0; 3 = i_0$ . The interface transparencies  $T_1 = 0.5; T_2 = 0.5; T_3 = 0.5$ .

The existence and importance of this contribution can be checked exploiting the fact that it is sensitive to the phase of the rejection coe cients and the length of the path on the scale of  $1=p_F$ . In Fig.11, we show the current for di erent signs of the barrier strength  $3 = j_3 j$ changing the phase of  $r_3 = i_3 = (p_{F_X} + i_3))$  but leaving the rejection probability intact. In Fig.12, we plot the change of the exact and quasiclassical currents upon tiny variation of the right layer thickness (corresponding to -change of the Ferm i phase factor in Eq. (4.1)). While quasiclassical current remains intact, clearly seen changes are observed in the exact current with the order of magnitude consistent with Eq. (4.1).

To avoid confusion, we rem ind that we deal with coarse-grain averaged currents, and therefore the observed sensitivity to the thickness and the phase of re ection has nothing to do with the size e ects (due to the commensurability of the thickness and the Ferm i wave length) well known in the normal case. We note also, that the loops in Fig.10 do not exist in the normal state because the electron-hole conversion on the interface 2 would not be possible.

W e assert that the loop contribution Eq.(4.1) is chie y responsible for the deviations from the quasiclassical theory. O byiously, this contribution cannot be grasped by quasiclassics since  $A_e^{loops}$  is sensitive to the phase of the re ection am plitudes r and r<sub>3</sub>, whereas the quasiclassical boundary condition<sup>11,13,14</sup> contain only the probabilities jrj and jrj. This is our argument supporting our interpretation of the numerical results. Note that the interpretation is consistence with the observation that the deviation from quasiclassics are significantly smaller in the asymmetric case Fig.8: There, the simple loops are absent and the deviations from the conventional quasiclassics come from higher order loops (like that analysed in<sup>17</sup>).

### V. CONCLUSIONS

In this paper we have exam ined the applicability of quasiclassical theory for description of multiple interface scattering by comparing quasiclassical solutions with ex-act" ones, extracted from coarse-grain averaged solutions to the B ogoliubov -de G ennes equation. We see that the

two approaches agree in simple geometries (one or two interfaces) but show noticeable discrepancy when three or more interfaces are present. This gives an example of a physical system where quasiclassical technique fails to give quantitative description with its expected accuracy

 $1=p_{P_0}$ . A s we understand it, the failure of the quasiclassical theory occur when classical trajectories form closed loops (interfering paths) after sequential rejection and transmission accompanied by electron-hole conversion. This gives additional support to the point of view of R ef.<sup>14</sup> that the derivation of the quasiclassical technique is possible only under the assumption of a simply connected topology, tree-like, of classical trajectories.

The main goal of this paper has been to dem onstrate

the existence of noticeable deviations from the quasiclassical theory in conditions where one m ight expect it to give fully reliable results. For this purpose we have chosen the simplest <code>\exact" m ethod</code>, the Bogoliubov – de G ennes approach, where the superconductivity enters via the m ean – eld order parameter (r) and scattering due to either im purity or surface roughness is not included. It is now time to discuss to what extent our results are sensitive to the simplic cations.

The truly \exact" theory of (phonon-m ediated) superconductivity, for which the quasiclassical technique is an approxim ation, is the set of G or kov-E liashberg equations for disorder averaged G reen's function G"<sup>22</sup>. The equation of motion,  $(" H_{"})G_{"} = 1$ , contains the operator H " which has the sam e structure as the Bogoliubov - de Gennes Ham iltonian Eq. (1.1), with the order param eter replaced by the anom alous part of the electron-phonon self-energy. A part from the "-dependence of H ", the only qualitative di erence is that the H ... has a non-H erm itian part com ing from the self-energies. The latter accounts for the impurity and electron-phonon scattering and, correspondingly, for a nite life time of the excitation with a given m om entum, (") { the scattering-out time. Due to the sim ilarity of the above operators, the interference contribution to observables obtained with the help of the G reen's function technique or simple m inded m ean-eld Bogoliubov - de Gennes equation, would give sam e results. A nite life time is the only important feature m issing in the Bogoliubov - de Gennes approach, and below we discuss its role.

C learly, the interference of waves having travelled different paths occurs if only the decay length is not too sm all compared with the path lengths. By virtue of the optical theorem, the waves corresponding to the ballistic trajectories decays on the distance  $v_{\rm f}$ . In practice,

is controlled by the bulk in purity scattering, so that the loops in F ig. 10 m ay contribute only if the interlayer distances are less or of order of the in purity m ean path. A s far as interface in perfection is concerned, short-range surface roughness is expected to play the role sim ilar to that of the bulk in purity scattering: A lthough the interface re ection becomes partially di usive, the coherent specular component, with the intensity proportional to the Fuchs's parameter P, is nite<sup>23,24</sup>. Thus, the picture of trajectories as that shown in F ig. 10 remains m eaningful as well as Eq. (4.1) if corresponding attenuation factors are inserted. We see that although m icroscopic roughness and bulk scattering suppress the interference e ect, it survives disorder averaging if the disorder is not too strong.

W hen a long-range roughness is present, that is the layer thicknesses are slow ly varying, the global value of the loop contribution in Eq. (4.1) averages to zero (if the thickness m odulation exceeds  $^-_F$ ). However, the interference of paths form ing the loops is sensitive m ainly to the local value of the thicknesses, so that the interference e ects can be seen in the spatial uctuations of the local current, which is a measurable quantity. In the quasiclas-

sical theory, the roughness would reveal itself only of the thickness modulation is somehow comparable with the coherence length. Since the loops are sensitive to variations of geometry on the scale of  $^{-}_{\rm F}$ , their contribution to the uctuations is expected to be much larger than that in the quasiclassical theory.

We see that the deviation from the quasiclassical theory due to the interference e ects, although most pronounced in the idealized model exploited in the paper, are observable in realistic conditions if the disorder is not too strong. A fler disorder averaging, the interference contribution is observable if the mean free path exceeds the interlayer distance and the rough interfaces have not too sm all coe cient of the specular re ection. D etail analysis of the loop contribution to mesoscopic uctuations is beyond the scope of the paper.

A part from disorder, the interference contribution m ay be suppressed by energy integration. Indeed, the integration with the Ferm i-D irac distribution function corresponding to the tem perature T is equivalent to the M atsubara sum m ation, that is energy variable " assumes discrete in aginary values, multiples of i T. Then, the waves

decay on the length  $_0$ , and, consequently, the loops contribute to equilibrium properties only if the paths are shorter than the coherence length.

Sum m arizing, we have shown that the quasiclassical technique fails in geom etries where classical trajectories form closed loops. In particular, this happens when it is applied to the Josephson multi-layer structure with num - ber of sem i-transparent interfaces larger than 2. This conclusion does not underm ine the conventional quasiclassical technique but only limits its applicability in some special geom etries where the interference of classical paths cannot be neglected. W ithin the quasiclassical approach, the interference can be incorporated into the theory with the help of the method suggested in Ref. 17.

# APPENDIX A:THE TRANSFER AND SCATTERING MATRICES

To nd contribution of the bops, we rst analyze the elementary process that is the scattering on an isolated barrier.
