N ovel O rder P aram eter to C haracterize V alence-B ond-Solid States

W e propose an order param eter to characterize valence-bond-solid (VBS) states in quantum spin chains, given by the ground-state expectation value of a unitary operator appearing in the Lieb-Schultz-M attis argument. We show that the order parameter changes the sign according to the con guration of the valence bonds. This allows us to determ ine the phase transition point in between di erent VBS states accurately. We demonstrate this theory in the bond-alternating H eisenberg chain and in the frustrated spin ladder.

x1. Introduction

To study Haldane's conjecture¹⁾, A eck, Kennedy, Lieb and Tasaki proposed the valence-bond-solid (VBS) state, and showed that the ground state of the spin S = 1 Heisenberg chain is described approximately by the VBS state²⁾. Since the spin congurations of the VBS state show the hidden antiferrom agnetic order, den N ijs and R om melse proposed the string order parameter (SOP) to characterize the S = 1 Haldane phase³⁾,

where = $x_iy_iz_i$ and j_0im eans the ground state. Thus this order parameter enables us to detect the VBS state indirectly. The SOP was generalized to S > 1 cases by 0 shikawa⁴.

On the other hand, A eck and Lieb studied the Haldane's conjecture by the Lieb-Schultz-M attis (LSM) type argument⁵⁾. However, relation between the LSM argument and the VBS picture including the SOP has not been fully understood. In this paper, we show that the ground-state expectation value of a unitary operator appearing in the LSM argument, for a spin chain with length L,

plays a role of an order parameter which detects VBS ground states directly, and that it can be applied to determ ination of phase boundaries in between di erent VBS states. We demonstrate this idea in the bond-alternating Heisenberg spin chains, and in the S = 1=2 two-leg frustrated ladder.

x2. Properties of the Order Param eter

2.1. The valence-bond-solid picture

A coording to the LSM argument, if the unique ground state j_0i and $U j_0i$ with $U = \exp[(2 \ i=L) \sum_{j=1}^{L} jS_j^z]$ are orthogonal ($z_L = 0$), there exists at least one eigenstate with energy of 0 (L⁻¹). Now we consider the overlap z_L in the opposite situations such as the Haldane gap phase. In order to calculate z_L explicitly in VBS states, we introduce the Schwinger boson representation for the spin operators:

where these bosons satisfy the commutation relation $[a_i;a_j^Y] = [b_i;b_j^Y] = {}_{ij}$ with all the other commutations vanishing. a_j^Y (b_j^Y) increases the number of up (down) S = 1=2 variables under symmetrization. Then, a generalized VBS state in a periodic system is written as

where B $_{i,j}^{Y}$ $a_{i}^{Y}b_{j}^{Y}$ $b_{i}^{Y}a_{j}^{Y}$, N is a norm alization factor, and jusci is the vacuum with respect to bosons. m and n are integers satisfying m + n = 2S. Using relations $Ua_{j}^{Y}U^{-1} = a_{j}^{Y}e^{+i}$ and $Ub_{j}^{Y}U^{-1} = b_{j}^{Y}e^{-i}$, a twisted valence bond $UB_{j;j+1}^{Y}U^{-1}$ for 1 j L 1, and that located at the boundary are calculated as follows,

In the latter case, a negative sign appears for each valence bond. Thus the asym ptotic form of z_L is given by

It turns out that $z_{\rm L}$ changes its sign according to the number of valence bonds at the boundary, $z_{\rm L}$ can be calculated in m ore detail by the m atrix product form alism .

2.2. The sine-Gordon theory

Next, we consider z_L from the view point of a low energy e ective theory. In general, the Lagrangian density of a spin chain is given by the sine-G ordon model,

where is the imaginary time, is a short range cut o, and K and y are the parameters determ ined phenom enologically. In the gapped (gapless) region one has y (l) ! 1 (y (l) ! 0) for l! 1 under renorm alization ! e^1 . On the unstable

Gaussian xed line [y (0) = 0 with K (0) < 4], a second-order \Gaussian transition" takes place between the two gapped states. In this form align, the spin wave excitation created by U corresponds to the vertex operator exp (i $\frac{1}{2}$), so that z_{Ip} is related to the ground-state expectation value of the nonlinear term as z_L / hcos($\frac{1}{2}$) i and the three xed points y = 1;0 correspond to z = 1;0, respectively. Thus the Gaussian critical point can be identiced by observing $z = 0^{6}$.

x3. Application to Physical System s

3.1. The bond-alternating Heisenberg chain

In the bond-alternating Heisenberg chain,

$$H = \sum_{j=1}^{X^{L}} [1 \quad (1^{j})]S_{j} \quad S_{j+1}; \quad (3.1)$$

the VBS picture is considered to be realized approximately: The conguration of the valence bonds (m;n) changes from (0;2S) to (2S;0) successively as is increased form 1 to 1, meaning the existence of 2S quantum phase transitions. We calculate z_L for 2S = 1;2;3;4 in a periodic system by the quantum M onte C arbo (QMC) method with the continuous-time loop algorithm ⁷⁾, and con med that qualitative behavior of z_L agrees with our theory given in Sec. 2.

Next, we determ ine the successive dimerization transition points by observing $z_L = 0$ with L up to 320. Extrapolation of the data has been done by the function $_{\rm c}$ (L) = $_{\rm c}$ (l) + A=L² + B=L⁴ + C=L⁶. For S = 1 [(1;1)-(2;0)], S = 3=2, [(2;1)-(3;0)] and S = 2 [(2;2)-(3;1), (3;1)-(4;0)] cases, we obtain the transition points $_{\rm c} = 0.25997$ (3);0:43131(7);0:1866(7);0:5500(1), respectively, where () denotes 2 . The results are consistent with the previous estimates, but much more accurate: $_{\rm c} = 0.2595$ (5) for the S = 1 case by the QMC calculation for the susceptibility $^{8)}$, and $_{\rm c} = 0.2598;0:4315;0:1830;0:5505$ obtained by the level-crossing method $^{9)}$.

3.2. The spin-1=2 frustrated ladder

W e discuss z_L in the S = 1=2 two-leg ladder with frustration:

$$H = \begin{bmatrix} X^{L} \\ S_{j} \\ j=1 \end{bmatrix} (S_{j} \\ S_{j+1} + T_{j} \\ S_{j+1} + J_{2} \\ S_{j} \\ S_{j} + J \\ (S_{j} \\ S_{j+1} + T_{j} \\ S_{j+1} \end{bmatrix}; (3.2)$$

where S_j and T_j denote S = 1=2 operators at j-th site. In has been pointed out¹⁰⁾ that there appears competition between a rung dimer phase $(J = J_2)$ and a Haldane phase $(J_2 = J = 1)$, and that these two phases are identified by two distinct SOPs, O_{odd} ; O_{even} given by Eq.(1.1) where S_j is replaced by the following two types of composite spin operators:

$$S_{odd;j} = S_j + T_j; S_{even;j} = S_j + T_{j+1};$$




Fig.1. J -dependence of z_{odd} and z_{even} in the S = 1=2 frustrated ladder for $J_2 = 1$ and L = 14, calculated by the exact diagonalization. The point $z_{odd} = z_{even} = 0$ gives the dim er-Haldane phase boundary.

Then, $O_{odd} = 0$ and $O_{even} \notin 0$ for the rung dimer phase, and $O_{odd} \notin 0$ and $O_{even} = 0$ for the H aldane phase. Instead of O_{odd} and O_{even} , we introduce z_{odd} and Z_{even} de ned

by Eq.(1.2) where S_{i}^{z} is replaced by $\mathtt{S}^{z}_{\texttt{odd}; j}$ and $\mathtt{S}^{z}_{\texttt{even}; j}.$ In Fig. 1, we show z_{odd} and z_{even} for $J_2 = 1$ and L = 14calculated by the exact diagonalization. We nd that j_{kdd} j€ j_{zeven} jin general, and zodd and zeven have opposite signs. Especially, $z_{odd} = z_{even} =$ 0 at the sam e point w hich corresponds to the dimer-Haldane phase boundary. This tells us that one of the two z_L has enough information to describe this system , since $z_{\rm L}$ characterizes the system by its magnitude and sign, while the SOPs give zero or nite value without changing the sign. Thus z_I, turns out to be a more rational order param eter to describe VBS

states in a uni ed way. The properties of $z_{\rm i}$ is also useful to determ ine the accurate phase boundary from num erical data of nite-size clusters.

x4. Sum m ary

We have introduced z_L given by Eq. (1.2) as an order parameter to characterize VBS states. The proposed order parameter changes its sign according to the conguration of valence bonds. This property enables us to determ ine the critical point between diment VBS states by observing $z_L = 0$. We have demonstrated this theory for phase transitions in the bond-alternating Heisenberg chain, and in the frustrated spin ladder. Details of the present results will be published elsewhere¹¹⁾.
