## A cellular-autom ata model of ow in ant-trails: non-monotonic variation of speed with density

A bstract. Generically, in models of driven interacting particles the average speed of the particles decreases monotonically with increasing density. We propose a counter-exam ple, motivated by the motion of ants in a trail, where the average speed of the particles varies non-monotonically with their density because of the coupling of their dynamics with another dynamical variable. These results, in principle, can be tested experimentally.

Particle-hopping models, form ulated usually in terms of cellular autom ata (CA) [1], have been used to study the spatio-tem poralorganization in system s of interacting particles driven far from equilibrium [2, 3, 4, 5] which include, for example, vehicular tra c [6, 7]. In general, the inter-particle interactions tend to hinder their motions so that the average speed decreases monotonically with the increasing density of the particles. In this letter we report a counter-example, motivated by the motion of ants in a trail [8], where the average speed of the particles varies non-monotonically with their density because of the coupling of their dynam ics with another dynam ical variable.

The ants communicate with each other through a process called chemotaxis by dropping a chemical (generically called pheromone) on the substrate as they crawl forward [9, 10]. Although we cannot smell it, the trail pheromone sticks to the substrate long enough for the other following sning ants to pick up its smell and follow the trail. In this letter we develope a CA model which may be interpreted as a model of unidirectional ow in an ant-trail. Rather than addressing the question of the emergence of the ant-trail, we focus attention here on the tra c of ants on a trail which has already been form ed.

Each site of our one-dimensional ant-trail model represents a cell that can accomodate at most one ant at a time (see g.1). The lattice sites are labelled




Figure 1. Schem atic representation of typical con gurations; it also illustrates the update procedure. Top: C on guration at time t, i.e. before stage I of the update. The non-vanishing hopping probabilities of the ants are also shown explicitly. M iddle: C on guration after one possible realisation of stage I. Two ants have m oved compared to the top part of the gure. A lso indicated are the pherom ones that m ay evaporate in stage II of the update schem e. B ottom : C on guration after one possible realization of stage II. Two pherom ones have evaporated and one pherom one has been created due to the m otion of an ant.

by the index i (i = 1;2;:::;L); L being the length of the lattice. We associate two binary variables  $S_i$  and  $_i$  with each site i where  $S_i$  takes the value 0 or 1 depending on whether the cell is empty or occupied by an ant. Sim ilarly,  $_i = 1$  if the cell i contains pherom one; otherwise,  $_i = 0$ . Thus, we have two subsets of dynam ical variables in this model, namely, fS (t)g  $(S_1(t);S_2(t);...;S_i(t);...;S_L(t))$  and f (t)g  $(_1(t);_2(t);...;_i(t);...;_L(t))$ . The instantaneous state (i.e., the con guration) of the system at any time is speci ed com pletely by the set (fSg;f g).

W e assume that the ant does not move backward; its forward-hopping probability, however, is higher if it smells pherom one ahead of it. The state of the system is updated at each time step in two stages. At the end of stage I we obtain the subset fS(t+1)g at the time step t+1 using the full information (fS(t)g; f(t)g) at time t. At the end of the stage II we obtain the subset f(t+1)g at the time step t+1 using the subsets fS(t+1)g and f(t)g.

Stage I: The subset fSg (i.e., the positions of the ants) is updated in parallel according to the following rules:

If  $S_i(t) = 1$ , i.e., the cell i is occupied by an ant at the time step t, then the ant hops forward to the next cell i + 1 with

where, to be consistent with real ant-trails, we assume q < Q.

Stage II: The subset f g (i.e., the presence or absence of pherom ones) is updated in parallel according to the following rules:

If  $_{i}(t) = 1$ , i.e., the cell i contains pherom one at the time step t, then it contains pherom one also in the next time step, i.e.,  $_{i}(t+1) = 1$ , with

probability =  $\begin{array}{ccc} 1 & \text{if } S_i(t+1) = 1 \text{ at the end of stage I;} \\ 1 & \text{f} & \text{if } S_i(t+1) = 0 \text{ at the end of stage I:} \end{array}$ (2)

where f is the pherom one evaporation probability per unit time. On the other hand, if  $_{i}(t) = 0$ , i.e., the cell i does not contain pherom one at the time step t, then

$$_{i}(t+1) = 1$$
 i  $S_{i}(t+1) = 1$  at the end of stage I: (3)

In certain limits ourmodel reduces to the N agel-Schreckenberg (NS) model [[11] which is the minimal particle-hopping model for vehicular trac on freeways. The most important quantity of interest in the context of ow properties of the trac models is the fundam ental diagram, i.e., the ux-versus-density relation, where ux is the product of the density and the average speed. For a hopping probability  $q_{NS}$  at a given density c the exact ux F (c) in the NS model is given by [6, 12]

$$F_{NS}(c) = \frac{1}{2}^{h} p \frac{i}{1 - 4 q_{IS} c(1 - c)}^{i}$$

which reduces to  $F_{NS}$  (c) = m in (c; 1 c) in the determ inistic lim it  $q_{IS}$  = 1.

Note that in the two special cases f = 0 and f = 1 the ant-trail model becomes identical to the NS model with  $q_{NS} = Q$  and  $q_{NS} = q$ , respectively. Extensions of the NS model have been used not only to capture di erent aspects of vehicular tra c [6] but also to simulate pedestrian dynamics [7, 13, 14]. In a closely related CA model for pedestrian dynamics [14] the oor elds, albeit virtual, are analogs of the pherom one elds f g in the ant-trail model. However, in the pedestrian model there is no exclusion principle for the oor eld.

The ant-trailm odel we propose here is also closely related to the bus route m odel (BRM) [15, 16]. The variables S and in the ant-trailm odel are the analogs of the variables representing the presence (or absence) of bus and passengers, respectively, in the BRM. Because of the periodic boundary conditions, the number of ants and buses are conserved while the pherom one and passengers are not conserved. How ever, unlike the BRM, the pherom ones are not dropped independently from outside, but by the ants them selves. Another crucial di erence between these two m odels is that in the bus-route m odel Q < q (as the buses m ust slow down to pick up the waiting passengers) whereas in our ant-trailm odel Q > q (because an ant is m ore likely to m ove forward if it sm ells pherom one ahead of it).

In g2 we show the fundam ental diagram s obtained by extensive computer simulations of the ant-trail model for several values of f. The most unusual features of the fundam ental diagram s shown in g2 are that, over an interm ediate range of




Figure 2. The ux of ants plotted against their densities for the parameters (a) Q = 1;q = 0.25 and (b) Q = 0.75;q = 0.25. The discrete data points corresponding to f = 0.0001(5), 0.0005(3), 0.001(), 0.005(), 0.01(4), 0.05(2), 0.10(), 0.25(+), 0.50() have been obtained from computer simulations; the dotted lines connecting these data points merely serve as the guide to the eye. The two continuous solid curves at the top and bottom correspond to the ux in the NS m odel for  $q_{\rm NS}$  = 1.0 and  $q_{\rm NS}$  = 0.25, respectively, in (a) and for  $q_{\rm NS}$  = 0.25, respectively, in (b).

values of f (for example, f = 0.0005;0.001;0.005;0.01 in g2) the ux in the lowdensity limit c! 0 is very close to that for the NS model with  $q_{NS} = q$  whereas in the high-density limit c! 1 the ux for the same f is almost identical to that for the NS model with  $q_{NS} = Q$ . These unusual features of the fundam ental diagram s arise from the non-monotonic variation of the average velocity with the density of the ants (see g.3).

The presence of the pherom one essentially introduces an elective hopping probability  $q_e$  (c), which depends on the ant density c. The particle-hole symmetry (and hence the symmetry of the fundamental diagram about c = 1=2) observed in the special limits f = 0 and f = 1, are broken by the c-dependent elective hopping




Figure 3. The average velocity of ants plotted against their densities for the parameters (a) Q = 1;q = 0.25 and (b) Q = 0.75;q = 0.25. Same symbols in the gs2 and 3 correspond to the same values of the parameter f.

probability for all 0 < f < 1 leading to a peak at c > 1=2. Furtherm ore, the analysis of correlation functions reveals some interesting clustering properties which will be studied in detail in a future publication [17].

The qualitative features of the c-dependence of  $q_p$  can be reproduced by an analytical argument based on a mean-eld approximation (MFA) [17]. In this MFA, let us assume that all the ants move with the mean velocity hV i which depends on the density c of the ants as well as on f; although, to begin with, the nature of these dependences are not known we'll obtain these self-consistently.

Let us consider a pair of ants having a gap of n sites in between. The probability that the site in mediately in front of the following ant contains pherom one is  $(1 f)^{n+W}$  is since  $\frac{n}{hV i}$  is the average time since the pherom one has been dropped. Therefore, in the MFA the elective hopping probability is given by

$$q_{e} = Q (1 f)^{n=hV i} + qf1 (1 f^{n})^{hV i} q;$$

We replace n by the corresponding exact globalm can separation  $\ln i = \frac{1}{c}$  1 between

successive ants. M oreover, since hV i is identical to  $q_e$  , we get the equation

$$\frac{q_{e}}{Q} = \frac{q}{q} = (1 \quad f)^{\frac{1}{e}}$$

which is to be solved self-consistently for  $q_{e}$  as a function of c for a given f. Note that the equation (6) in plies that, for given f,  $\lim_{c! 0} q_{e} = q$ ; this rejects the fact that, in the low-density regime, the pherom one dropped by an ant gets enough time to completely evaporate before the following ant comes close enough to smellit. Equation (6) also implies  $\lim_{c! 1} q_{e} = Q$ ; this captures the suicently high density situations where the ants are too close to m iss the smell of the pherom one dropped by the leading ant unless the pherom one evaporation probability f is very high. Similarly, from (6) we get, for given c,  $\lim_{f! 1} q_{e} = q$  and  $\lim_{f! 0} q_{e} = Q$  which are also consistent with intuitive expectations.

In view of the fact [10] that the lifetime of pherom ones can be as long as thirty to sixty m inutes, the interesting regime of f(1), where the average velocity varies non-m onotonically with the ant density, seems to be experimentally accessible. We hope that the non-trivial predictions of this m in im alm odel of ant-trail will stimulate experimental measurement of the ant ux as a function of the ant density for dienent rates of pherom one evaporation by using dienent varieties of ants [8].
