M agnetic Field Scaling in Spin G lasses and the M ean-Field Theory

The scaling of the magnetic eld dependence of the remanent magnetization for di erent temperatures and di erent spin-glass sam ples is studied. Particular attention is paid to the elect of the de Almeida-Thouless (AT) critical line on spin-glass dynamics. It is shown that results of the mean-eld theory of aging phenomena, with two additional experimentally justiled assumptions, predict $H = H_{AT}$ (T) scaling for remanent magnetization curves. Experiments on a single crystal CuM n 1.5 at % sample in the temperature interval from 0:7T_g to 0:85T_g give results consistent with this scaling. Magnetization vs. eld curves for di erent CuM n and thiospinel sam ples also scale together. These experimental results support the predictions of the mean-eld theory of aging phenomena.

I. IN TRODUCTION

E ect of a magnetic eld on the spin-glass state is one of the most important open problems in spin-glass physics. Twom a pr theoretical descriptions of spin-glass phenom ena have evolved over the past twenty years. O ne of them is the mean-eld theory for the static and dynam ical properties of spin glasses, based on the Parisi replicasymmetry-breaking formalism and related ideas.^{1,2} The alternative approach is the droplet model, based on the Migdal-Kadano approximation^{3,4} The two pictures provide very di erent physical interpretations of observable spin-glass phenomena. This di erence is particularly pronounced when spin-glass properties in a magnetic eld are considered. The mean-eld theory predicts a spin-glass state with replica-symmetry breaking at nite magnetic elds below a critical line in the (T;H) plane.⁵ The droplet m odel states that a true phase transition occurs at zero m agnetic eld on ly. C om pelling experim ental support for either model has not yet been presented. A detailed analysis of magnetic eld e ects on real spin glasses can provide information about the com parative validity of the theoretical predictions.

Recent experimental results favor the mean-eld picture. Torque measurements have shown that Heisenberg spin glasses with random anisotropy are characterized by a true spin-glass ordered phase at high magnetic elds⁶. Experimental studies of violations of the uctuation-dissipation theorem under an increasing eld

change also support predictions of the mean-eld theory?

The rem anent m agnetization, m easured after a change in m agnetic eld, contains allessential inform ation about spin-glass dynam ics. The general features of its eld dependence have been studied for various spin glasses.⁸ A ll experim ental results to date, how ever, have been treated phenom enologically. A com prehensive theoretical picture which can explain these results, and predict the eld dependence of m easurable quantities over a wide range of

eld variations, rem ains lacking. The mean- eld theory of aging phenom ena, 2,9,10,11 developed in recent years,

now appears able to provide such a description within the linear response regime. The theory relates the m acroscopic relaxation properties of the spin-glass state to m icroscopic correlations. M any conclusions, derived from this theoretical picture, can be tested experimentally. In the present paper, we study the scaling of m agnetization curves with m agnetic eld for several spin-glass sam ples. W e show that, under som e additional experimentally justi ed assumptions, our experimental results support predictions of this theory.

This paper is organized as follows. In the next Section, the theoretical picture underlying our analysis is outlined. Sec. IIIA presents experimental results on the

eld scaling for di erent tem peratures. In Sec. IIIB, experim ental data for di erent sam ples are com pared. Section IV sum marizes our conclusions.

II. THEORETICAL BACKGROUND AND SCALING PREDICTIONS

The equilibrium susceptibility of an Ising spin glass, identi ed with the equilibrium value of the experimental eld-cooled susceptibility, is given by the following expression:¹²

This susceptibility includes contributions from di erent pure equilibrium states with the nontrivial distribution of overlaps q(x). The value $q(1) = q_{EA}$ is the equilibrium E dwards Anderson order parameter, and $q(0) = q_{m in}$ is the minimum possible overlap, nonzero in the presence of a magnetic eld. The spin-glass state is chaotic in magnetic eld¹² meaning that the average equilibrium overlap of two states at slightly di erent values of magnetic eld is equal to q_{in} .

The linear response susceptibility, identied with the experimental zero-eld-cooled susceptibility at short ob-

servation times = t \ddagger , is given by the uctuationdissipation theorem (FDT) in its integral form $:^{11}$

Here, C (t;t_w) is the autocorrelation function for a system of N Ising spins, de ned as follows:

The linear response susceptibility is associated with transitions within a single pure state. The di erence between the values of the eld-cooled and zero-eld-cooled susceptibilities is a manifestation of replica-symmetry breaking.¹²

Spin-glass dynam ics is lim ited to a single ergodic component, because the energy barriers, separating the pure equilibrium states, are divergent in the therm odynam ic lim it. The long-tim e dynam ics within one pure state can be view ed as a series of transitions from a trap to a deeper trap.² The barriers surrounding these traps are high, but

nite, and \traps encountered at long times tend to increasingly resemble the actual states contributing to the equilibrium " 13 T his interpretation leads to a description of asymptotic spin-glass dynamics, algebraically similar to the static replica-symmetry-breaking form alism .

Dynamical de nitions of $q_{\rm A}$ and $q_{\rm m \ in}$ are given in terms of the correlation function 2,11

Eq. (5) means that, after a small eld change following a nite waiting time t, the system evolves towards an equilibrium state that has the minimum possible correlation with the initial state state at $t = t_w$.

Experiments¹⁵ and computer simulations¹⁶ suggest the following picture of spin-glass relaxation. At short observation times, t_{w} , the relaxation is fast (on the linear time scale) and equilibrium in nature. The correlation function, Eq. (3), drops from 1 to q_{EA} . The uctuation-dissipation theorem holds, and the susceptibility is given by Eq. (2). At longer observation times, $> t_{w}$, the relaxation is very slow and t_{w} -dependent. The correlation decreases from q_{EA} to q_{min} . The FDT is violated, and the zero- eld-cooled susceptibility relaxes towards the equilibrium value, presumably given by Eq. (1).

It is proposed in the mean-eld theory of aging phenomena² that, for large t_w , the susceptibility depends on its time arguments only through the correlation function, i.e. = [C (t; t_w)], even when the uctuation-dissipation theorem is violated. The susceptibility (C) is a piecewise function.^{10,11} It is linear in the equilibrium regime:




FIG.1: A diagram of the spin-glass relaxation at tem perature T after magnetic eld H is applied. The thick line is the master curve ~(C). The straight line segment from $(q_1;0)$ to $(q_{EA}; z_{FC})$ represents the equilibrium relaxation regime. The slope is 1=T. The master curve segment from $(q_{EA}; z_{FC})$ to $(q_{min}; F_{C})$ corresponds to the aging regime.

In the aging regime, the relaxing part of the susceptibility, $_{\rm ag}$ (C), is nonlinear:

The well-known Parisi-Toulouse approximation¹⁴ m akes use of the following assumptions: the equilibrium susceptibility, Eq. (1), is independent of temperature, while q_{EA} and $q_{m in}$ are functions of only temperature and magnetic edd, respectively. The dynamical version of this approximation in plies^{10,11} that the function $_{ag}(C)$ in Eq. (7) is both T - and H -independent. This means that the dependence (C) is universal in the aging regime, and follows a master curve ~(C). If the value of the susceptibility at the limit of validity of the FDT, i.e. at C = q_{EA} , is denoted as $_{ZFC}$, one can write the following:

Fig.1, taken directly from Cugliandob et al.,¹¹ displays the master curve ~(C). Each point on this curve corresponds to a transition from the equilibrium to the aging regime at some temperature 0 < T < T_g. The quantity q₁ is the initial correlation C (t_w; t_w), which depends on the number of spin components. It appears instead of unity in Eqs. (6) and (7) if the spins are not Ising.

The contribution of this paper is the experimental study of the magnetic eld dependence of the remanent susceptibility $_{FC}(H) = _{ZFC}(T)$. A coording to Fig. 1, it is related to the di erence $q_A(T) = q_{in}(H)$. In order to derive a magnetic eld scaling relationship, we must introduce two additional assumptions. First, we consider relatively high temperatures and assume that the master curve \sim (C) at low C can be approximated by a straight

line. Then the triangles in Fig.1 are geom etrically sim – ilar for all allowed T and H , and the following relation holds:

Second, let us suppose that $q_{m \text{ in}}$ (H) is a hom ogeneous function of order p, that is $q_{m \text{ in}}$ (aH) = $a^p q_{m \text{ in}}$ (H) with som e p \in 0. Then, introducing the critical AT eld, one can write:

Here we used the condition¹² that the de Almeida-Thouless critical line is de ned by $q_{lin} = q_{EA}$. It follows from Eqs. (9) and (10) that the remanent susceptibility, $_{FC}$ (H) $_{ZFC}$ (T), should scale as $H = H_{AT}$. This is a consequence of the proposed universality of ~(C). The present paper is devoted to the experimental study of this

eld scaling. W e shall also use our experim ental data to justify the two assumptions which lead to Eqs. (9) and (10).

III. EXPER IM EN TAL RESULTS AND ANALYSIS

Before presenting our experim ental results, we would like to make some prelim inary remarks.

P redictions of the mean-eld theory of aging phenomena, mentioned in the previous section, are expected to hold only in the linear response regime. This means that a change in magnetic eld, acting as a probe of the spinglass state, must be much smaller than the AT eld at a given measurement temperature. A larger eld change would lead to a deviation from linear response. The measured zero-eld-cooled susceptibility would then become

eld-dependent, and the arguments, based on Fig. 1, could not be used.

Eqs.(8)-(10) can be applied to experimental data only if the zero- eld-cooled susceptibility is measured at the end of the uctuation-dissipation regime. For relatively short waiting times, the transition from one regime to the other is not well de ned. C om puter simulations show 16 that violation of the FDT becom esvisible at observation times at least one order of magnitude shorter than the waiting time t_w , the violation becoming strong at ±. . All of our experiments have been performed on a com mercial Quantum Design SQUID magnetometer. The shortest possible observation time is about 40 s. The typicale ective cooling time is 600 s because of the rather low cooling rate near the measurem ent tem perature. By the time the stepperimental point is taken, the fast initial decay is essentially over. Thus, the short-tim e m easurements yield results, which are approximately at the end of the uctuation-dissipation regime, even at zero waiting time.




FIG.2: The eld-cooled magnetization of the single crystal Cu M n 1.5 at% for di erent temperatures Tr = T = Tg. The inset displays the irreversibility (1 ZFC=MFC) 100% as a function of temperature for H = 200 Oe.

In our analysis, we use experimental values of magnetizations instead of susceptibilities. This is because numerical differentiation requires thing, and any thing involves interpretation. Of course, all arguments regarding the eld scaling apply to magnetizations as well. For example, Eqs. (9) and (10) suggest that the slope of the remanent magnetization, M FC Z FC, at eld H, divided by its slope at H = 0, will be a function of H = H_{AT} (T). The rest of this Section presents our experimental results, which will support this prediction.

A. Field scaling for di erent tem peratures

In order to test validity of Eqs. (9) and (10), we measured the eld-cooled (M FC) and zero-eld-cooled (Z FC) magnetizations as functions of the eld H = H for four di erent tem peratures. All results reported in this subsection were obtained for a single crystal C u M n 1.5 at %. It is a long-range H eisenberg spin glass with a glass tem perature T_g of approximately 15.2 K. The experimental phase diagram for this sample will be presented elsewhere. Them easurem ents of the Z FC magnetization were made at the shortest observation time, with zero waiting time between the cooling and application of the eld.

Fig.2 exhibits the eld dependence of the eld-cooled m agnetization. The data are presented as taken, without any rescaling of the eld or adjustment of the m agnetization m agnitude. Error bars are considerably smaller than the symbol sizes and are not shown in the gure. The same applies to the other gures in this paper that do not exhibit error bars. It is evident that M F C (H) is virtually independent of tem perature. Therefore, the Parisi-Toulouse approximation works rather well in the




FIG. 3: The rem anent m agnetization of the single crystal Cu M n 1.5 at% as a function of eld for the same tem peratures as in Fig. 2.

case of this sample. This appears to be a common feature of CuMn spin glasses. 11

The spin-glass phase is characterized by the di erence between the eld-cooled and zero-eld-cooled magnetizations. The inset of Fig. 2 displays tem perature dependence of the MFC ZFC irreversibility at xed magnetic eld. Weak irreversibility in the CuMn 1.5 at % single crystal appears slightly above the glass tem perature of 152 K. The irreversibility becomes strong as temperature is lowered, evolving to a region where it increases linearly with a large slope. The strong ΜFC ZFC irreversibility is interpreted as a sign of the spin-glass phase transition. The T-intercept of the linear t in this region is taken as the crossover tem perature T_c (H). These crossover tem peratures, determ ined for di erent magnetic elds H, de ne the AT line.

Fig. 3 displays eld dependences of the M FC ZFC inveversibility for di erent tem peratures. The four curves are similar in shape, but the eld scale for each depends on the m easurem ent tem perature. The peak in M FC ZFC corresponds to a strong violation of linear response. It turns out that the position of this peak depends on the value of the AT eld.




FIG.4: From top to bottom : H_{AT} (T), the experimental AT critical line; H_M (T), the position of the peak in TRM (H); H_m (T), the position of the peak in (M FC ZFC)(H).

The experimental AT line for the CuMn 1.5 at $\$ single crystal sample is exhibited in Fig. 4. One can see that this line has the functional form T_g T_c(H) / H²⁼³, typical of the AT line⁵ in the Sherrington-Kirkpatrick (SK) model.¹⁷ Fig. 4 also shows temperature dependence of the position of the peak in TRM (H), which we denote as H_M (T), and of the peak in (M FC ZFC)(H), which we refer to as H_m (T). The therm oremanent magnetization, TRM, is not equal to M FC ZFC if linear response is violated, and H_m < H_M for any temperature. However, both H_M (T) and H_m (T) are proportional to the critical eld H_{AT} (T), according to Fig. 4.




FIG. 5: Scaling of the rem anent m agnetization curves for di erent tem peratures. The positions of the peaks, H $_{\rm m}$ (T), are used as scaling parameters.

the AT line itself. In this subsection, we shall use its position, H $_{\rm m}$ (T), as the eld scaling parameter, and consider H =H $_{\rm m}$ scaling instead of H =H $_{\rm A\,T}$ scaling.

Fig.5 exhibits the M F C Z F C interversibility, norm alized by its value at H_m , and plotted versus $h = H = H_m$. O ne can see that the curves for dient temperatures fall on top of one another for h < 1. This is the interval of eld variations where linear response holds, at least approximately. Therefore, the eld scaling, predicted by Eqs. (9) and (10), is indeed observed in spin-glass experiments. For h > 1, how ever, the scaling is rather poor. There is strong nonlinearity in the spin-glass response in this regime, and the mean-eld theory of aging phenom-ena will not be applicable.




FIG.6: The master curve ~(C) for the single crystalCuMn 1.5%, estimated from the experimental $_{Z \ F \ C}$ (T) dependence. The master curve for the SK model is ~= (1 C)¹⁼².

O f course, nonlinearity by itself does not necessitate lack of scaling. There are at least two probable reasons for the observed di erences in high- eld behavior at different tem peratures. First, freezing of the transverse spin components¹⁸ in Heisenberg spin glasses produces the weak irreversibility in the longitudinal direction. Second, the distribution of glass tem peratures, alw ays present in realsam ples, has a strongere ect at higher measurement tem peratures and higher elds. The inset of Fig 2 shows that there is a signi cant rem anence at the crossover tem – perature. It corresponds to the rem anence near the AT line at h 3.5 in Fig. 5. O by iously, we cannot expect the H = H_{AT} scaling to hold precisely in this region.

The scaling of the M FC ZFC curves in Fig. 5 suggests, a posteriori, that the assumptions leading to Eqs. (9) and (10) are in fact reasonable. In order to clarify this conclusion, we determ ined the master curve ~ (C) according to the method of Cugliandob et al.¹¹ If the zero- eld cooled susceptibility is measured at the limit of validity of the FDT, the corresponding correlation can be obtained from Eq. (6). Then the values of $_{ZFC}$ (T) for di erent temperatures, plotted vs. C (T), span the master curve ~ (C). The experimental master curve is shown in Fig. 6. The data points were taken in the interval from T = 2.4 K to T = 15.0 K at the same low

eld H = 160 e. E ach m easurem ent was independent of the others, and included a quench from above the glass tem perature.

F ig. 6 dem onstrates that the experim ental dependence of on C is close to linear over a wide range of correlations. This justi es the assumption underlying Eq. (9): the master curve ~ (C) at relatively low C can be approximated by a straight line.

The experimental data for the AT critical line in Fig. 4 suggest that, to the leading order of magnitude, $q_{m \ in}$ (H) / H²⁼³. Therefore, $q_{m \ in}$ (H) is indeed a hom o-

geneous function of order p = 2=3, and the assumption underlying Eq. (10) is also veried.

These argum ents, of course, should be taken with caution. A reliable experim ental determ ination of the master curve ~ (C) would require independent m easurem ents of both the susceptibility and the correlation. Fig. 6 only gives an idea of how the real curve may look. In particular, the experim entalm aster curve in Fig. 6 does not exhibit a signi cant downturn at high values of C =q. The di erence between this curve and the theoretical curve $\sim = (1 \quad C)^{1-2}$ for the SK model¹⁰ is very pronounced in that region. This problem, however, is beyond the scope of the present paper. It is also evident that we cannot expect the above two assumptions to hold beyond the leading order of m agnitude even at high enough tem peratures and low values of C. It would be correct to say, therefore, that the AT eld de nes a characteristic eld scale at any tem perature, but the scaling itself is always approxim ate.

B. Field scaling for di erent sam ples

The results of the previous subsection suggest that the master curve $\sim (C)$ in Fig.1 is universal, that is T and H independent, thus supporting the Parisi-Toulouse approximation. It would be interesting to see, therefore, if this curve depends on the choice of sample. Dierent spin-glass samples have dierent microscopic properties, and, consequently, dierent e ective magnetic

eld scales. If the Parisi-Toulouse approximation holds, the magnetic eld H appears in the analysis through $q_{m\ in}$ (H) only. Therefore, if the master curve \sim (C) is sample independent, and $q_{m\ in}$ (H) has always the same functional form, we can expect the scaling of magnetization curves to hold for di erent samples.

In order to study this issue, we measured the eldcooled (MFC) and the therm orem anent (TRM) m agnetizations as functions of H = H for ve di erent spinglass samples. In addition to the single crystal CuMn 1.5 at %, described previously, we used a single crystal CuMn 0.6 at %, with the glass temperature of about 6:0 K. Both samples have been prepared in Kammerlingh Onnes Laboratory (Leiden). Sim ilar single crystals have been used for new tron-scattering experiments.¹⁹ The other three of our samples are polycrystalline. The polycrystal CuMn 6.0 at % has been extensively studied before.²⁰ Its glass tem perature is near 31:0 K . The thiospinel C dC $r_{1:7}$ In_{0:3}S₄ is an insulating short-range spin glass with $T_q = 16.7 \text{ K}$. It has also been studied in detail.²¹ The second thiospinel sam ple, used in our analysis, has been obtained from the part of the st sample by sifting it through a 100 nm mesh. This was done to probe the nite-size e ects². The sifted thiospinel has a slightly lower glass tem perature T_q 16:5 K .




FIG.7: Them orem anent magnetization for ve spin-glass samples measured at $t_w = 30$ m in. The positions of the maxim a, H_M (T), are proportional to the AT elds.

Fig. 7 displays the therm orem anent m agnetizations versus the eld H for these ve sam ples. All data points are taken at the sam e short observation time of 90 s after




FIG.8: Scaling of the eld-cooled magnetization curves for the versam ples. The values of H $_{\rm M}$ (T) are used as scaling parameters.

the eld is cut to zero. The waiting time between the end of the cooling process and the eld change is 30 m in. The reduced m easurem ent tem peratures, $Tr = T = T_g$, for different sam ples are not exactly the same, but it is not very in portant considering the results of Sec. IIIA. It is evident from Fig.7 that di erent sam ples have very di erent characteristic eld scales. The e ect of the same m agnetic eld is strongest in the case of the thiospinel, and it is much less pronounced for the single crystal CuM n 1.5 at %. The characteristic eld scales for these two sam ples di er by one order of m agnitude.

O ne can see from Fig.7 that each TRM (H) curve has a maximum. According to Fig.4, the position of this maximum, H_M (T), is proportional to the corresponding




FIG .9: Scaling of the therm orem anent m agnetization curves from Fig.7, plotted vs. H =H $_{\rm M}$.

AT eld, H_{AT} (T). In this subsection, we will characterize each sample by its value of H_M , and consider $H = H_M$ scaling instead of the $H = H_{AT}$ scaling.

Fig. 8 exhibits experimental M FC (H) curves, plotted versus $h = H = H_M$ and normalized by their values at h = 1. All vecurves seem to scale well together. This suggests that, apart from the dimension in the eld scales, the physical mechanism behind the observed eld dependence is the same for all these very dimension -p les. Fig. 8 suggests that the functional form of q_m in (H) is essentially independent of sam ple.

The experim ental TRM (H) curves from Fig.7, plotted versus the reduced eld $h = H = H_M$, are presented in Fig. 9. The overall scaling is surprisingly good, taking into account the diversity in properties of the ve sam ples. We conclude that the observed nonlinearity in spin-glass response has the same physical origin for all sam ples.




FIG.10: Comparison of results for the two thiospinel samples. The di erences in the values of H_M and in the low – eld behavior can be attributed to the nite-size e ects on the spin-glass properties of the sifted sample.

The major deviations from perfect scaling seem to result from nite-size e ects. They are not clearly visible in Fig.9, but can be seen in Fig.10. This gure exhibits the normalized TRM curves, divided by $h = H = H_{\rm M}$, for the two thiospinel sam ples. The full thiospinel sam – ple with $T_{\rm g}$ 16:7 K has a broad distribution of particle sizes. The sifted thiospinel sam ple with $T_{\rm g}$ 16:5 K consists of particles smaller than 100 nm in diameter. The measurement temperatures were 14:4 K and 14:2 K, respectively, so that the reduced temperature $Tr = T = T_{\rm g}$ has the same value of 0.86 for both sam ples.

Two conclusions can be derived from the data in Fig. 10. First, the characteristic ekd for the sifted sam – ple is about 10% higher than for the full sam ple. This is consistent with the mean-ekd-theory predictions. The di erences in free energies per site for di erent equilibrium states are of the order of 1=N, where N is the total num ber of spins. For sm aller N, a stronger perturbation is needed to redistribute these energy di erences and thus

reshu e the weights of di erent pure states²³ Therefore, nonlinearity in response appears at higher eld changes for smaller particles. The second conclusion is that the di erences in behavior between the full sample and the sifted sample are more pronounced in the low - eld region. This is also in agreem ent with results of the mean-

eld theory. The magnetic correlation length, $_{\rm H}$, drops sharply as the change in eld increases²³ If the eld change makes two spins uncorrelated, existence of a grain wall between them becom es irrelevant. Thus, nite-size e ects on spin-glass dynamics are more pronounced at lower eld changes. O f course, there may be other reasons for the di erences between the two thiospinel sam – ples.

Apart from the nite-size e ects, the overall scaling in Fig. 9 is in pressive, and demonstrates the validity of 7

the theoretical analysis in Section II.Our results suggest that both the master curve \sim (C) and the function $q_{\rm m\ in}$ (H =H $_{\rm A\ T}$) are essentially independent of the nature of a particular spin-glass sample. This is a strong evidence in support of mean- eld theory.

IV. CONCLUSION

The mean-eld theory of aging phenom ena establishes a relation between the susceptibility and the correlation C in both the equilibrium and aging regimes of spin-glass relaxation. It suggests that (C) is a universal function in the aging regime, and that the remanent $_{\rm Z\,F\,C}$ is related to the di erence susceptibility FC q_{in} in the values of the correlation. We have Q_{EA} shown in this paper that two additional assumptions, the linearity of (C) in the aging regime and the hom ogeneity of $q_{m \ in}$ (H) in a wide range of elds, lead to a prediction of H = H $_{\rm A\,T}$ (T) scaling of the rem anent susceptibility curves. Our experim ents on the single crystal CuMn 15 at % demonstrate the existence of such scaling in the temperature interval T = Tg = 0.7:::0.85. M oreover, the therm orem anent m agnetization curves for di erent spin-glass sam ples also scale quite well together if plotted vs. $H = H_{AT}$. These results indicate that there is universality for the magnetic properties of di erent spin glass systems at di erent tem peratures. They also suggest that the magnetic eld e ects on spin-glass dynamics in the linear response regime are correctly described by the mean-eld theory of aging phenomena.
