C om m ent on "H istory E ects and P hase D iagram near the Low er C ritical P oint in Y B a_2 C u_3 O $_7$ S in-gle C rystals":

A lower critical point B_{lm c} of the st order transition line B_m (T) signaled by a magnetization jump often (YBCO) at a magnetic eld in appears in YB a_2 C u_3 O $_7$ tesla range, for example, as a result of enhanced extrinsic point disorder [1]. Recently, Zhukov et al. [2] have found in their magnetization data the presence of B im c and of a history e ect in lower elds than B_{mc} . To try to explain B_{inc} increasing [2,3] with decreasing oxygende ciency acting as an extrinsic pinning disorder, they have invoked an intrinsic pinning disorder, of electronic origin, increasing with decreasing by assuming B_{lmc} as well as the upper critical point B_{umc} to be induced by some (static) disorder. However, since both Bum c and $B_{lm c}$ decrease with increasing [3], a comprehensive understanding of the phase diagram based on the argum ent in ref.2 would require such an unacceptable assumption that B_{mc} is controlled by the intrinsic disorder, while B_{umc} is mainly determ ined by the extrinsic one.

It is well accepted at present that the macroscopic properties in vortex states of real type II superconductors should be described based on the G inzburg-Landau (GL) model characterized by three material parameters, i.e., the uctuation strength, anisotropy (dimensionality), and pinning strength. Since a single pinning strength describes possible point-like disorders altogether in GL theory, the doping dependences of B_{lmc} and B_{umc} cannot be understood consistently even if articially introducing [2] a couple of di erent pinning disorders. Below, we brie y point out that the dependences of the critical points on [2,3] and on an extrinsic pinning disorder [1] can be explained altogether within the GL theory [4,5] if taking account of the fact that the mass and the uctuation strength (/ 2 (T)) inanisotropy crease with increasing , where (T) is the in-plane penetration depth. First, we note that B_{umc} is generally believed [4] to decrease with increasing an e ective pinning strength D_{p;e} (a relative strength of point disorder to the uctuation strength) which is e ectively enhanced by increasing elds. This statem ent is valid particularly in type II lim it where the magnetic screening, important near H $_{c1}$, is neglected. A ssum ing the type II lim it in the

eld range far above H_{c1} where the two critical points were detected [2,3] in YBCO is safely valid. Rather, in our theory [5], the appearance of $B_{\rm Im\,c}$ is based on the fact [4] that, in layered system s, the vortex-glass (VG) transition curve $B_{\rm VG}$ (T) in type II limit can lie above the $B_{\rm m}$ (T)-line (de ned in clean limit) in lower elds only because of a di erence in their T-dependences. Since the 0 hm ic resistance vanishes at $B_{\rm VG}$ (T) possibly corresponding to $B_{\rm p}$ (T) in ref2, the $B_{\rm m}$ (T)-line in B < $B_{\rm Im\,c}$ lies within a glass phase. Namely, the superconducting transition in B < $B_{\rm Im\,c}$ is a continuous VG transition,

and B_m (T) is not realized there as the therm al storder transition signaled by a jump of reversible magnetization. Up to the lowest order in the bare pinning strength, the resulting lower critical point is estimated as

where d the layer spacing, 0 the in-plane coherence length, and c_L is a constant taking a value between 10 2 and 10³. The inverse of param eter combination in the bracket m easures the uctuation strength per layer. In contrast to $B_{\,\rm um\,\,c}$, the primary origin of $B_{\,\rm lm\,\,c}$ decreasing [2,3] with increasing is, according to eq.(1), its remarkable dependence on and (0) both of which increase with increasing . A though it is not straightforward to predict a B $_{\rm lm\,c}$'s sam ple dependence because it depends com petitively on allof the three material param eters, nevertheless we note that, by assuming 8 for the fully-oxidized case and, for brevity, other parameters to have no doping dependences, B_{lmc} may stay in tesla range on the overdoped side. Eq.(1) may be insu cient in quantitatively explaining lower B_{lmc} values in optimally doped samples where the higher Landau level uctuations neglected in obtaining eq.(1) are no longer negligible below 1.7 (T) [6]. Nevertheless, the -dependence of eq.(1) is qualitatively consistent not only with the absence (in accessible elds) of $B_{lm\,c}$ in BSCCO and underdoped YBCO with quite large -values but also with a -dependence of B_{lm c} suggested from optim ally-doped and three overdoped YBCO samples [3].

Further, according to recent works [7], a B $_{\rm Im\,c}$ of several tesla is present in the parallel eld case even in underdoped YBCO. This fact is compatible not with the interpretation invoking an intrinsic disorder [2] negligible in underdoped YBCO but only with the present theory based on the GL m odel with extrinsic disorder [8].
