Two-dim ensional D irac ferm ions with random axial-vector potential

A D irac ferm ion m odel with random axial-vector potential is proposed. At a special strength of random ness, the sym m etry of the action is enhanced, which is due to the gauge sym m etry a la N ishim ori. Some exact scaling exponents of single-particle G reen functions are computed. The relationship with the XY gauge glass m odel is discussed.

R andom D irac ferm ions have attracted m uch current interest in condensed m atter physics. They have actually intim ate relationship with integer quantum H all (IQ H) transitions [1{3], dirty d-wave superconductors [4,5], etc. C ritical theory of IQ H transitions is believed to be a strong coupling xed point of the D irac ferm ion with random m ass, vector and scalar potentials [1], though the xed point is still m issing. Near the zero energy quasiparticles of disordered d-wave superconductors can be described by the D irac ferm ion, giving four kinds of novel universality classes [6,7]. Including the conventional orthogonal, unitary and sym plectic classes and corresponding chiral classes, ten universality classes have been established for disordered system s [6].

On the other hand, it has been reported recently that several other symmetry classes should exist [8{10]. One example is realized [9] on the N ishim ori-line [11] of the random bond Ising model [12]. The random bond Ising modelhas O (2n) symmetry [13,14], belonging to the universality class D [5] (the class of superconductors with broken spin rotation and time reversal symmetry) in Z imbauer's classi cation [6]. A lthough the enhancement of the symmetry on the N ishim ori-line has already been discussed in [15], G nuzberg et. al. have explicitly shown that the symmetry [9]. This class is not included in Z imbauer's classi cation.

Among these developments, the D irac ferm ion with random vector potential only is one of simplest but nontrivial m odels, still providing hot topics. It gives multifractal scaling exponents of local composite operators [1{3], exact zero-energy wave function for any realization of disorder [1,2,16], replica symmetry breaking [17,18], etc.

In this paper, we study a D irac ferm ion in two dimensions including random axial-vector potential. We show that the symmetry of the model is enhanced at a strong disorder strength, which is analogous to the N ishim oriline of statistical models. Similarly to the conventional model with random vector potential, this model can be solved exactly, giving us some exact scaling dimensions. It turns out that this model corresponds to the spin wave model for the XY gauge glass model.

The system we will study is

where 1, 2, and 5 denote the three Pauli matrices, and A is a random axial-vector potential. Being dened in 2D Euclidean space, this Ham iltonian is nonhem itian due to 5 coupled with the vector potential. Therefore, the model (1) may have a relationship with Hatano-Nelson model [19]. However, ensem ble-average yields the square of the antiherm itian term, and the Lagrangian becom esherm itian. It should also be mentioned that without mass, the Ham iltonian has chiral sym metry $_{5h_{\rm A}}$ + $h_{\rm A}$ $_{5}$ = 0, telling that the model belongs to the class A III in Z imbauer's classi cation.

where the normalization factor is given by $N_A = R_{DAe}^{\frac{1}{2}} d^2 x A^2$. At a given M atsubara frequency !, the partition function of the model with quenched disorder is given by

The Lagrangian is invariant under the following chiral gauge transform ation,

It is well-known that this transform ation gives rise to a nontrivial Jacobian, but as we shall see later, it is irrelevant to our problem. The !-term serves as a symmetrybreaking term.

A lthough it is possible to take quenched average of the partition function without resort to the replica

trick, we will rst apply it in order to explain the enhancement of the symmetry at a special coupling constant. Integration over disorder for replicated partition function Zⁿ yields an e ective Lagrangian, $L_{A} = {}^{a} (i \theta + i!) {}^{a} \frac{g}{2} {}^{a} 5 {}^{a} {}^{2}$, where a =1;:::;n. Due to the identity $_5 = i$, we have $\frac{g}{2} = \frac{a}{5} = \frac{g}{2} = \frac{a}{2} = \frac{a}{2}$. Compared with the elective Lagrangian of the V-model, L_V = ^a ($i\theta + i!$) ^a $\frac{g}{2}$ ^a ^a ², the present A-m odel tums out to be equivalent to the V-m odelbut with negative coupling constant g. Namely, the partition function Z_A^n (g) of the A-m odel with the coupling constant g > 0is equivalent to that of the V-m odel \overline{Z}_{y}^{n} (q). Therefore, som e properties, e.g., the scaling dim ensions of som e local operators for the A-m odel can be obtained directly from the V-m odel by the use of the form al replacem ent q, as we shall see m om entarily. q!

However, the A-m odel has some peculiar properties. One of them is the enhancement of the symmetry at a special coupling constant g = . The Lagrangian in Eq. (3) has global U (n) U (n) symmetry for any g when ! = 0. Explicitly, it is readily seen that for any realization of the axial-vector potential it is invariant under the transformation $! (U_1P_+ + U_2P_-)$ and $! (U_1^{y}P_- + U_2^{y}P_+)$, where $P = (1 _{5})=2$ and U_i is a n n unitary matrix which acts on the replica space. Since the Lagrangian is invariant under local chiral gauge transformation, we have

where L = $a = i\theta + p \overline{g} + A = V$ is the \volume" of the gauge space V = D, and () is a Jacobian due to chiral gauge transformation [20]. This equation is based on the same argument as N ishim ori applied to the random-bond Ising model [11]. Since the Jacobian is multiplied by a factor n, it should vanish in the replica limit n ! 0. This is also justiled below in the direct computation of the exact scaling dimensions of the single-particle G reen functions. Now using the ferm ionization of the gauge variable via ferm ion-boson correspondence in 2D,

where the Lagrangian now includes an additional Oth fermion $L = iQ \frac{p}{g}(a_5 a_+ + \frac{q}{g})$ (b) A. The Greek superscript runs from 0 to n, whereas a from 1 to n. When g = (and ! = 0), the ensemble-averaged Lagrangian can be written in a symmetric way together with the 0th fermion as $L = i\theta + \frac{1}{2}$, telling that the symmetry is enhanced to U (n + 1) U (n + 1). This enhancement of the symmetry for the D irac fermion with random axial-vector potential is quite analogous to that for the M a jorana or D irac fermion with random mass (the random -bond Ising model). Interestingly, such an enhancement does not occur in the case with conventional vector potential.

W hat happens at this special coupling constant? For the conventionalm odel h_V , the exact scaling properties have been obtained by various methods [1{3]. Since the present H am iltonian h_A is nonherm itian, we exactly solve the model by taking the quenched average directly, without using the replica trick or the SUSY technique. One of most interesting properties in disordered systems is the multifractality of the scaling exponents. The D irac ferm ion with random vector potential is a typical example having such exponents. By the use of the single-particle G reen function,

ensemble-averaged density of state (DOS) and a eld-theoretical analogue of the inyerse participation ratios (IPR) $P^{(k)}(E) = \frac{1}{n j_n (x) f^k} (E = E_n) = \frac{1}{n j_n (x) f} (E = E_n)$ can be computed as [21]

where $_{n}(x)$ is a two component spinor wave function of nth eigenstate, tr is a trace for spinor indices, and $C_{k} = (2k \quad 3)! \models (2n \quad 2)!!$. It is useful to introduce the chiral basis, = P and $^{y} = P$, which was actually used by M udry et. al. [2]. In what follows, we will take similar notations to this reference. Since $= {}^{y}_{+} + {}^{y}_{-}$, the kth power of the G meen function can be written as

Here we have introduced species a to calculate the kth power of the G reen function, although we will not use the replica trick. Expanding the product, we have various operators with various scaling dimensions. M ost dom inant operators depends on whether k is even or odd. De ne

then an example of most dominant operator is $O_e^{(k)} = O^{(k)}$ for even k and $O_o^{(k)} = O^{(k)} \frac{yk}{k}$ for odd k.

In the chiral basis the Lagrangian is converted into

where z = x + iy, z = x iy, $A = A_x iA_y$, and a = 1;2;; k. The dimension for Atells that the right- and left-movers have opposite charges, as mentioned previously. In 2D the gauge elds can be decomposed into two independent components A = $\ell + \ell$, or in the chiral basis, $A_+ = 2i\ell_z (+i)$, and $A = 2i\ell_z (-i)$. The probability distribution (2)

where N_R; is a normalization factor N = $\binom{R}{p} e^{\frac{1}{2} d^2 x (\theta)^2}$ and similar for N. V is the gauge transformation ^a ! $e^{\frac{p}{g}(i)a}$ and ^{ya} ! $y^a e^{\frac{p}{g}(i)}$, the axial-vector potential completely disappears in the Lagrangian,

The chiral gauge transform ation yields a nontrivial Jacobian D D ! D D e^{ik} () [20]. However, this factor appears in the denominator Z as well as in the num erator in Eq. (9), and hence cancels out. Finally, $O_e^{(k)}$ is gauge-invariant while $O_o^{(k)}$ is not. A ctually, they obey the transform ation law s

By the use of the free action (15) after the gauge transformation, the correlation function of $O_{e,o}^{(k)}$ can be evaluated as follows. The two point correlators of the free ferm i elds are $h_{+}^{a}(z)_{+}^{ya^{0}}(0)i_{+}^{aa^{0}}z_{+}^{1}$ and $h_{+}^{a}(z)_{+}^{ya^{0}}(0)i_{+}^{aa^{0}}z_{+}^{1}$. Therefore, we have

Note that these do not depend on and therefore the change of the scaling dimension due to disorder is involved with only. The average-over is easily taken and the scaling dimension of $O_{e,o}^{(k)}$ nally reads $_{k} = k$ for even k whereas $_{k} = k + \frac{g}{2}$ for odd k, and this is itself nothing but the dom inant scaling dimension of the kth power of the single-particle G reen function $(\text{trg })^{k}$. Som e comments may be in order. In the conventional V-m odel the random eld plays a role in the change of the dimensions due to disorder. In the present case, the role

of and is exchanged by $_5$ in Eq. (1), and causes the change of the scaling dimensions. Furthermore, the eld gives in general negative scaling dimensions for the V-m odel, whereas gives positive dimensions for the present m odel.

Using the dom inant scaling dimensions of the Green functions obtained so far, we can calculate the scaling properties of the DOS and IPR.Since ! couples with g in the Lagrangian, the dimension of ! reads z = 1[1,2]. Therefore, we expect (!) $!^{(2 z)=z}$. This is just the sam e form ula for the V-m odel but with negative g. It is also readily seen that the random axial-vector potential is a marginal perturbation and the theory moves along a critical line. However, starting from the free ferm ion point, the A-m odelm oves, as g increses, to the opposite direction to which the V-m odel m oves. Therefore, the line on which the A-m odel lies is not reached by the conventional random vector potential model. In this sense, the present model is complementary to the full critical line of U(1) U(1) symmetry. The dimension of is an increasing function of g, so that the DOS is suppressed around the zero energy if the random axial-vector potential is switched on. At the special point g =where the symmetry is enhanced, the exponent becomes in nity. Therefore, it is likely that the theory is well-de ned only for g < , and the enhancem ent of the sym m etry is a signal that the theory reached at a singularity.

The scaling behavior of the IPR is obtained in a similar way: P^(k) ! $k^{=z}$, where k = 2 for even k and k = 0 for odd k. As stressed by M udry et. al. [2], the IPR de ned by Eq. (10) is not necessarily coincides with that of the original de nition P^(k) = $\overline{j_n} (x_k) = N f^k$, where the normalization N is de ned by N² = $d^2x j_0(x)f$. A ctually, the zero energy wave function can be obtained exactly as

for the present A m odel, where '_0 is a constant spinor, while __0(x) = e (x) - i (x) '_0 for the conventional Vm odel. The IPR of the latter wave function has been studied by various m ethods, e.g., replica m ethod [1], SUSY m ethod [2], the m ethod using the equivalence to the random energy m odel [16], etc. They have all given the same scaling exponent for sm all g. Eq. (18) for the present m odel also gives $j_0(x)f' / e^{2(x)}$. Since the present A m odel has the same probability distribution (14) as the conventional V-m odel has, we expect that the the A-m odel should have the sam e scaling dimension $_k = (2 - \frac{g}{k})(k - 1)$ as the V-m odel has, which is quite di erent from the conjectured $_k$ based on (10).

So far we have studied som e peculiar properties of the D irac ferm ion with random axial-vector potential. As already m entioned, the H am iltonian is nonherm itian, because it is de ned in the Euclidean space. Then, is this m odel unrealistic? To address the question, we next exam ine the bosonized form of the A-m odel, as has been

done for the V-m odel by Bernard [3]. By the use of the correspondence (6), the H am iltonian (1) is converted into

This is a low-tem perature e ective H am iltonian of the XY gauge glass m odel [11,22,23] whose H am iltonian is de ned on a 2D square lattice,

where $_{ij}$ is a random gauge variable with a probability distribution $_{\rm P}$

Provided that K and K_p are large, we actually reach the Ham iltonian (19) with $g = \frac{K}{K_p}$ and the probability distribution (2) as well by expanding the cosine terms s up to second order, de ning $_i$ $_j$ a_0 @ (x) and $_{ij}$ a_0A (x) with the lattice constant a_0 and rescaling the elds ! = K and $A ! A = K_p$. This is the so-called spin-wave approximation. The spin-wave Ham iltonian (19) is expected to be unstable against vortex excitations if K or K_p becomes small.

On the other hand, it has been shown that the model (20) with (21) has a Nishim ori-line K $_{\rm p}$ = K , on which som e exact results can be obtained in a similar way as the random -bond Ising model [11,23]. The equivalence of the condition $K_p = K$ to g =im plies that the symmetry enhancement of the Dirac fermion with random axial-vector potential re ects the gauge sym metry on the N ishim ori-line of the gauge glass m odel. A s to the sym metry of the model, it is di cult to read its enhancement from the spin-wave Hamiltonian (19). Even if we apply the replica method, the symmetry always remains U (1). This rem inds us of the case of the random -bond Ising model: We only come accross the continuous O (n) symm etry when the model has been described by the Majorana ferm ion via the Jordan-W igner transform ation. In the present case, the enhanced symmetry also becomes manifest only in the ferm ion description. However, the Lagrangian discussed so far is just for the spin-wave part of the gauge glass model and it is quite necessary to include vortices to fully describe the lattice model (20). Then, such theories should be well-de ned eld theories with manifest enhanced symmetry on the Nishim ori-line. It is an interesting issue to derive and study such eld theories.

F inally, let us discuss the sym m etry for the dual theory of the gauge glass m odel (20) [24]. The periodicity of the H am iltonian can be described by $e^{K \cos(i - j^{+} - ij)}$

By the use of the Poisson sum mation formula [24], we reach the following H am iltonian, H d = \frac{1}{2K} (0)^{2} + i \quad A \quad 0 \qquad 2y \cos 2 \quad ; \\ where is a dual eld and y is a fugacity. This is the sine-G ordon m odel coupled with random vector potential A \quad . \end{array}$

Therefore, it turns out that there is a duality between the random axial-vector potential and conventional vector potential. The form er model yields a symmetry enhancement whereas the latter does not. Recently, the replica symmetry-breaking of the V-model has been suggested [17,18], which might be understood via this duality relation.

In sum m ary, we have studied a D irac ferm ion with random axial-vector potential. This model has an enhanced sym m etry at a special strength of random ness, which rem inds us of the N ishim ori-line of the statistical models. Indeed, the model is equivalent to the spin wave H am iltonian of the XY gauge glass model. It turns out that this model m oves along a critical line for increasing g up to , and som e exact scaling exponents have been obtained.
