On Keller Theorem for Anisotropic Media

A bstract

The K eller theorem in the problem of elective conductivity in anisotropic two-dimensional (2D) many-component composites makes it possible to establish a simple inequality $\stackrel{e}{is}(_i^{1}) \stackrel{e}{is}(_k) > 1$ for the isotropic part $\stackrel{e}{is}(_k)$ of the 2-nd rank symmetric tensor b_{ij}^e of elective conductivity.

The extension of the Keller theorem [1] in the problem ofe ective conductivity in the in nite 2D two-component com posites on the many-component case [2] poses a new question on the duality relation for the 2-nd rank sym metric tensor be of e ective conductivity in anisotropic media. It is related to the restrictions imposed on the linear invariant of $b_{i;j}^e$ which is called an isotropic part $_{is}^{e}$ ($_{k}$) of e ective conductivity. Recently the perturbation theory for the in nite periodic three-component 2D checkerboard with two-fold rotation lattice sym metry was developed $[\beta]$ where the coincidence of $^{e}_{is}(k)$ solution $_{\rm B}$ ($_{\rm k}$) of B ruggem ann E qn was established up to the 6-th order term. This fact is curious because it gives grounds to think that E ective Medium Approximation (EMA) describes exactly $\frac{e}{is}(k)$ in this certain structure. Here we will discuss this conclusion.

Let us de ne the isotropic part of conductivity tensor

which is an invariant scalar with respect to the plane rotation and recall the Keller theorem for the principal values b_e^{xx} ; b_e^{yy} of diagonalized matrix b_e^{ij} for 2D n-component composite

Both (1) and (2) make us possible to derive a simple inequality for $\frac{e}{is} = \frac{e}{is} (\frac{1}{i}) \frac{e}{is} (\frac{1}{k})$

where the only isotropic media $b_e^{xx} = b_e^{yy}$ corresponds to the equality in (3). At the same time another isotropic invariant $\dot{b}_{ij}^e = \det b_{ij}^e$ ($_k$) satisfies the duality relation

The EMA theory of the in nite 2D n-component isotropic comosite has its consequence the Bruggemann Eqn [4]



which necessarely leads to the duality relation

that re ects both the conformal invariance of the Maxwell Eqns in 2D isotropic comosite and S_n -permutation invariance of the n-colour tessellation of the plane. The latter means that $^{\rm e}_{\rm is}$ can satisfy the Bruggemann Eqn only for isotropic S_n -permutation invariant media: $b_{\rm e}^{\rm xx}=b_{\rm e}^{\rm yy}$; $b_{\rm e}^{\rm xy}=0$ in any reference frame fx;yg.

The in nite periodic 2D three-component checker-board was considered in [3] for sym m etrically related partial conductivities ($_1$ = 1; $_{2;3}$ = 1).





Such structure doesn't possess an isotropy of the 2-nd rank conductivity tensor $b_e^{i j}$ that follows from the simple crystallographycal consideration [5] as well as from the straightforward calculation [3] of the non-diagonal term b_e^{xy} / 2 . Therefore $_{is}^e$ ($_k$) for this structure can not satisfy the B ruggem ann E qn (4) even if its coincidence with $_B$ ($_k$) riched the $_6$ term in the perturbation theory.
