An Electron Param agnetic Resonance Study of Phase Segregation in Nd_{0.5}Sr_{0.5}M nO₃

Abstract

Wepresent results of an electron param agnetic resonance (EPR) study of Nd_{1} x Sr_xM nO₃ with x = 0.5 across the param agnetic to ferrom agnetic, insulator to m etal transition at 260 K (T_c) and the antiferrom agnetic, charge ordering transition (T $_{\rm N}$ = T $_{\infty}$) at 150 K. The results are com pared with those on $N d_{0.45} Sr_{0.55} M$ nO $_3$ which undergoes a transition to a hom ogeneous A -type antiferrom agnetic phase at T $_{\rm N}~=~230$ K and on La_{0:77}C a_{0:23}M nO₃ which undergoes a transition to coexisting ferrom agnetic m etallic and ferrom agnetic insulating phases. For x = 0.5, the EPR signals below T_c consist of two Lorentzian components attributable to the coexistence of two phases. From the analysis of the tem perature dependence of the resonant elds and intensities, we conclude that in the mixed phase ferrom agnetic and A-type antiferrom agnetic (AFM) phases coexist. The x = 0.55 compound shows a single Lorentzian throughout the tem perature range. The signal persists for a few degrees below T_N. The behaviour of the A-type AFM phase is contrasted with that of the two ferrom agnetic phases present in $La_{0.77}Ca_{0.23}MnO_3$.

The comparison of behaviour of A-type AFM signal observed in both $Nd_{0.5}Sr_{0.5}MnO_3$ and $Nd_{0.45}Sr_{0.55}MnO_3$ with the two FM phases of $La_{0.77}Ca_{0.23}MnO_3$, vis-a-vis the shift of resonances with respect to the param agnetic phases and the behaviour of EPR intensity as a function of tem perature conclusively prove that the $Nd_{0.5}Sr_{0.5}MnO_3$ undergoes phase separation into A-type AFM and FM phases.

1 Introduction

M anganites of the general formula $Re_1 \times A_x M nO_3$ where Re is a trivalent rare earth ion and A is a divalent alkaline earth ion, exhibit a number of interesting phenom ena such as colossal magnetoresistance (CMR), insulator to m etal, param agnetic (PM) to ferrom agnetic (FM) or antiferrom agnetic (AFM) transitions and charge/orbitally ordered states as a function of x and temperature T [1, 2]. Not surprisingly, they have been the subject of intense study in the last few years. Recent experim ental and theoretical studies indicate that m anganites undergo intrinsic phase separation (PS) in the CMR regime [3]. PS refers to the spontaneous and competing coexistence of two (or more) di erent phases such as FM clusters in an AFM background observed in the x-T 0.5, of large and interm ediate electron bandphase diagram for x width manganites. A large number of experimental techniques including transport, [4] m agnetic, electron m icroscopy, [5] scanning tunneling m icroscopy, [6] sm all angle neutron scattering, [7] B rillouin scattering, [8] NMR [9] and muon spin relaxation measurements,[10, 11] mainly on the prototype m anganite $La_1 \times Ca_x M nO_3$ have provided evidence for

m icroscopically inhom openeous FM phases below the Curie tem perature (T_{c}) . Recently the Nd_{1 x}Sr_xM nO₃ compound for x = 0.5 is also shown to spontaneously phase segregate [12, 13, 14]. W oodward et al. [12] using techniques such as x-ray di raction and neutron di raction showed a number of interesting features in its phase diagram. It was found that on cooling below T_c, an intermediate A-type AFM phase appeared in addition to the FM phase. Below $T_N = 150$ K, the FM state transform s to a CE-type AFM state in the tem perature range of 150 K to 100 K, indicating the presence of FM phase in this tem perature range apart from the A-AFM and CE-AFM phases. A study by Ritter et al. [15] also illustrates coexistence of these three phases at 125 K . It was suggested that such phase segregation aids the eld induced structural transitions observed in Nd_{0.5}Sr_{0.5}M nO₃ (NSM O 0.5) [16]. W hile most of these studies report the occurrence of PS below T_c, photoem ission studies indicated the presence of a phase separated state even above T $_{\rm c}$ [3].

Theoretical attempts to understand PS have been mainly through num erical simulations and mean – eld calculations. Two dierent scenarios have emerged, viz electronic phase segregation and disorder-induced mixed state. In the former, a phase separated regime interpolates between the AFM and FM phases while approaching the FM phase by hole doping of the AFM phase. When long-range C oulomb interactions are taken into account, the phase separated domains turn out to be of the order of a few nanom eter size as observed in some experiments [17]. How ever, experimental results of U ehra et al. [5] indicate the presence of much larger (micrometer size) domains. It is well known that the A-site cation radius < r_A > plays a major role in determining the properties of manganites. It was also found [18, 19] that the disorder caused by m ism atch in the ionic sizes could play a signi cant role in phase separation as well as in determ ining the CMR properties. The size of the A-site cation in uences the Mn-O-Mn bond angle which in turn a ects the hopping rate of the charge carriers. A random distribution in the size of A-site cations leads to a random distribution of the rate of hopping and the random distribution of the exchange coupling constant J which is also determ ined by the Mn-O-Mn bond angle. A local variation in these parameters, leads the system to be either in FM or AFM state depending on the param eters. On the other hand, creating a large num ber of FM -A FM interfaces is not energetically favourable. C om petition between these two tendencies in a system leads to the form ation of clusters much larger than the lattice spacing in which the number of interfaces is reduced and the tendency for local disorder to form either a FM or an AFM phase is partially satis ed. A hom ogeneous phase would therefore be expected for a compound such as PrC aM nO 3 where the A-site cation radii are comparable. As the size disorder grows, the cluster size goes on reducing in the phase separated state. Looking at the ionic radii of various A-site cations in 6-coordinated octahedral structures (Nd: 1.123 A⁰, Pr: 1.13 A⁰, Ca: 1.14 A⁰, Sr: 1.32 A⁰) one can expect that N dC a or P rC a m anganites have m ore hom ogeneous phases than NdSr or PrSr m anganites which are expected to phase segregate as indeed found experimentally [13, 20]. In spite of a large number of experimental and theoretical studies, a clear and consistent picture of the PS phenom enon is yet to emerge. For example the recent X - band EPR study of Rivadulla et al. [21] proposes a coexistence of a FM phase with a PM phase in LaC aM nO $_3$ instead of the FM and AFM phases as believed commonly.

Since EPR is a very powerful local probe and is found to be sensitive

to the presence of inhom ogeneities, we have used the technique to study Nd_{1} x Sr_xM nO₃ single crystals and powders with a view to investigating the phenom enon of phase separation . We have used samples with x = 0.5 (NSM 00.5) and x = 0.55 (NSM 00.55). The phase diagram of x = 0.5 sample is fairly complex [13] with coexisting phases in certain regions of the phase diagram . It is a param agnetic insulator at room tem perature. Neutron di raction studies, however, reveal presence of two-dim ensional FM uctuations [22] in the param agnetic state in the vicinity of $T_c = 260$ K where it transforms to a FM phase. Below 200 K, A-type AFM peaks in the neutron di raction experiments are observed along with the FM phase indicating a coexistence of FM and A-typeAFM phases [13]. The A-typeAFM phase consists of FM planes coupled antiferrom agnetically to each other and is characterised by the $d_{x^2 \ v^2}$ type orbital ordering. Below the Neel tem perature $T_N = 150$ K a CE-type AFM state is form ed which also coexists with the A-type AFM state [13]. The CE-type state is characterised by $3x^2 - r^2/3y^2 - r^2$ orbital ordering. The Neelten perature is also the charge ordering tem perature in this material. NSM 00.55 on the other hand is not known to show any phase separation. It is a param agnetic insulator at room tem perature and transforms to an A-type AFM state at T $_{\rm N}~=~230$ K with $d_{x^2 v^2}$ orbital ordering without any charge ordering [13]. We compare the EPR results of NSM 00.55 which does not show any phase segregation with those of NSM 00.5 and nd that these two samples behave very di erently [23]. To compare and contrast with the results on these two materials we have also studied $La_{0.77}Ca_{0.23}M nO_3$ (LCMO). LCMO (T_c 230 K) shows phase separation into two ferrom agnetic phases, one m etallic and the other insulating [24]. Thus we can expect very di erent behaviour of various lineshape parameters in LCMO from the ones in

the $Nd_{0:5}Sr_{0:5}M nO_3$ and $Nd_{0:45}Sr_{0:55}M nO_3$.

2 Experim ental

The single crystals of NSM 00.5 were prepared by the oat zone technique. The resistivity measurements show a transition from insulating state to a metallic state at $T_c = 260$ K. Further transition to an AFM insulating state is observed at $T_N = 150$ K. Magnetization measurements show a sharp increase in the susceptibility at 260 K, which remains practically temperature independent till 150 K, below which it shows a sharp drop. Single crystals of NSM 00.55 were also prepared by the same method. The resistivity measurements show a monotonic increase with decreasing temperature and a sharp increase at $T_N = 230$ K. The magnetization measurements show a monotonic increase in the susceptibility till 230 K with a sharp fall at this temperature.

The EPR experiments were carried out on both single crystal and powder samples of NSM 00.5 using a Bruker X - band spectrom eter (model 200D) equipped with an Oxford Instruments continuous ow cryostat (model ESR 900). Similar experiments were carried out on a single crystal and powdered single crystal of NSM 00.55 and LCM 0. The spectrometer was modiled by connecting the X and Y inputs of the chart recorder to a 12 bit A /D converter which in turn is connected to a PC enabling digital data acquisition. With this accessory, for the scan-width typically used for our experiments is 6000 G auss, one could determine the magnetic eld to a precision of 3 G auss. For single crystal study the static magnetic eld was kept parallel to the c-axis of the crystals. The tem perature was varied from 4.2 K to room tem perature (accuracy:

1K) and the EPR spectra were recorded while warming the sample. For measurements on powder the samples obtained by nely crushing the single crystals of the respective m aterials, were dispersed in para n wax. During all the experiments a speck of DPPH was used as a g-m arker whose signal was subsequently subtracted digitally to facilitate lineshape tting.

3 Results and D iscussion

Figure 1 shows a few typical EPR signals of those recorded from the powder sample of NSM 00.5 in the temperature range from 290 K to 80 K. The signal intensity goes on decreasing below 150 K and below 80 K the signal becomes too weak to analyse. As can be seen from the gure the relatively narrow EPR lines in the PM phase become broad below T_c. Further they show considerable variation in the lineshapes as a function of temperature. Based on the nature of the lineshapes, we have divided the whole temperature range into ve di erent regions and have tted appropriate lineshape functions to the signals in each region. In gure 1 we have indicated the region to which the respective signals belong. The method of analysis followed for each region is described below.

 In the tem perature range between 290 K and 255 K (the signals at 290 K and 277 K in gure 1), the signals are narrow and are well tted to the derivative of a single Lorentzian described by equation: [25]

where H is the linew idth and H $_0$ is the center eld.

2. D is torted signals are observed in the tem perature range of 250 K to 200 K as shown by data for 210 K . These signals are also quite broad and therefore they have to be tted with the derivative of Lorentzian consisting of two terms given by equation

where the rst term represents signal response due to the clockwise polarized component of microwaves and the second term represents the signal due to the anticlockwise polarized component of the microwaves [25]. In this temperature range, we found that we could obtain better to by using two Lorentzian functions with di erent linewidths and center elds, each described by equation 2.

3. M uch broader signals are observed in the tem perature range from 200 K to 155 K which could be very well tted to the lineshape function as described in (2) above consisting of two Lorentzians (signal at 180 K shown in gure 1).

The separation into regions two and three has been m ade based on the quality of ts which we have obtained using the same equation in the two regions. It can be clearly observed that the quality of ts continuously goes on improving as the temperature is reduced in region 2 till 200 K (note the di erence between the experimental curve and the tted curve at 240 K and 210 K), indicating an evolution of lineshapes which results in the lineshapes of region 3.

4. In the temperature range between 150 K to 100 K we observe the development of a distortion in the signal close to zero eld (indicated by a circle on the signal at 140 K in gure 1). The signals in this range could not be tted either to a single Lorentzian as in region 1 or to two Lorentzians as in regions 2 and 3. However if the data set in the low eld region is excluded we could t these signals to a single Lorentzian.

5. Undistorted broad signals between 100 K and 80 K are observed which t excellently to a single Lorentzian (equation 2) (signal at 80 K shown in gure 1).

In Figures 2a and 2b we plot the center elds (H₀) and linew idths obtained from the lineshape ts as described above as a function of tem perature. The vertical dotted lines show the di erent regions in which we categorized the di erent tem perature ranges from 80 K to 290 K.As can be seen from Figure 2a, the center eld at 290 K is 3407 G auss (3 G auss) corresponding to g'=1.976 which is less than the free electron by' value. In region 2 where we have tted the signal to two Lorentzians, H_0 of one of the components is less than H_0 in region 1 (component P'). The H₀ of this component goes on decreasing with decreasing temperature upto 200 K. The H $_0$ of the second component (component \mathfrak{Q} ') on the other hand is greater than the H $_0$ in region 1 and it shows a weak tem perature dependence and increases as the tem perature is reduced. In the third region these two components have opposite temperature dependences to that in region 2. The P' component shows an increase in H_0 as the tem perature is reduced remaining less than the H_0 value in region 1. Component Q' on the other hand shows a decrease as a function of decreasing temperature. In region 4 the single ${\rm H}_{\,0}$ of the Lorentzian tted to the signal excluding the low eld region, shows a non-monotonic behaviour and has a magnitude less than that in region 1. In region 5, H_0 is practically tem perature independent.

As can be seen from Fig. 2b, the linewidth of the single Lorentzian tted to the signals in region 1 shows an increase as a function of decreasing temperature. This increase continues in regions 2 and 3 for both the Lorentzian components P' and Q' tted in these regions. In region 3 at a temperature 170 K $1.1 T_N$ a peak in the linew idth is observed. Below this temperature in region 3 linew idths of both the signal components decrease with decreasing temperature. In regions 4 and 5 it again increases as a function of decreasing temperature. It is noteworthy that unlike the other manganites studied before [26, 27] signals do not disappear in the antiferrom agnetic phase is below $T_N = 150 \text{ K}$.

Figure 3 shows the signals from the single crystal of N SM 0 0.5 at di erent temperatures. At temperatures from 290 K to 260 K the signals have D ysonian lineshapes which progressively distort as the temperature is lowered below 260 K and evolve into very broad lines presumably consisting of more than one signal. A distortion near the zero eld similar to signals in the powder sample appears in these signals as well below 150 K. The line further broadens, decreases in intensity as the temperature is reduced below 100 K. Below 80 K the signal becomes very broad with a signal to noise ratio too poor for analysis. The signals down to 270 K could be tted to the Dysonian lineshape [25].

where is the asymmetry parameter representing the ratio of the absorption component to the dispersion component of the response. How ever it was not possible to t the signals below that temperature to any of the following models: (i) single Lorentzian with two terms, to take into account both left and right circularly polarised microwave elds. (ii) two Lorentzians (accounting for phase segregation) with two terms each to take into account both left and right circularly polarised microwave elds. (iii) single Dysonian with two terms to take into account both

left and right circularly polarised m icrow ave elds. (iv) two D ysonians

(accounting for phase segregation) with two terms each to take into account both left and right circularly polarised m icrowave elds. Keeping in m ind the fact that the signals from the powder of the same sample could be adequately tted, we conclude that the inability to do so in case of the single crystal samples is due to the elect of the multidom ain structure which m ay be present.

In the inset of gure 4 we show few representative signals obtained from powder sample of LCMO. The resonance elds obtained by tting these signals (to a single Lorentzian described by eq. 1 in the param agnetic phase and to two Lorentzians, each described by eq. 2, below 165 K) are also shown in the gure.

Figure 5 shows the signals from the powder sample of NSM 00.55 from 200 K to 290 K. Below 200 K the signal is too weak to analyse. The signals are narrow and are symmetric. They are tted to the Lorentzian lineshape and the tting parameters thus obtained, viz, H_0 , peak to peak linewidth H_{pp} are plotted in Fig. 6 as a function of tem – perature. As shown in Fig. 6a the linewidth monotonically decreases as the temperature is reduced till 210 K below which it shows a sharp increase. Them inimum in the linewidth occurs at 210 K. Here again, we observe a signal in the AFM state which is A -type. The resonance elds H_0 plotted in g. 6b show a weak temperature dependence throughout the temperature range increasing till 210 K and then shows a decrease. The g value obtained from the resonance elds is less than the free electron g value and remains so throughout the temperature range. The intensity shows a peak at 210 K and then decreases sharply. It roughly follows the temperature dependence shown by dc susceptibility.

In gure 7, we plot the double integrated intensities of di erent signal components in the three materials for the sake of comparison.

Based on an analysis of the di erent lineshapes of the powder signals of NSM 0.5 we make the following observations. In region 1, the signals

t very well to the derivative of a single Lorentzian. C learly, the sam ple is m on ophasic and hom ogeneous. Neutron di raction m easurem ents [12, 13] also show that the sample is param agnetic and m onophasic in this region. The 'g' value obtained from the EPR experiments is smaller than the free electron by value as expected for a CMR m anganite in contrast with the hole doped CO manganites where by values are greater than the free electron values. Linew idths in this region are much sm aller than those of the CO m anganites studied by us earlier in their param aqnetic state [26, 27]. A swe go into region 2, the quality of the ts to the derivative of single Lorentzian deteriorates. This may be understood in terms of the building up of FM correlations as veried by neutron di raction [22] and by the two-dimensional nanoscopic structural correlations as proposed by Kiryukhin et al. [17] based on x-ray di raction experiments. Presence of such uctuating FM correlations may cause distortion of a Lorentzian signal due to the uctuating internal elds. We have tted these signals to the derivative of Lorentzians containing two components. The center elds corresponding to these two com ponents have magnitudes shifted above and below the center eld in the PM region. We attribute this behaviour to the presence of A-type AFM (componentQ) and FM (component P) phases in the sample, respectively. Detailed evidence will be provided below in support of this assignm ent.

Now we would like to consider another possibility which could possibly give rise to a multiline spectrum in the ferrom agnetic state. It has been observed in single crystal specimen of ferrom agnetic metals like Nickel [28] and Iron [29] that a multiline complex spectrum results due to the magnetic anisotropy of the ferrom agnetic sample. When the applied magnetic eld is oriented away from the easy axis, the two com - ponents of magnetisation, one driven by the torque of the anisotropy

eld and the other due to the applied magnetic eld, can cause the splitting of the EPR spectrum. Sin ilar splitting was observed in a polycrystalline ferrite sam ple by Schlom ann et al. [30] who have studied the tem perature dependence of the resulting EPR spectrum. This happens when the anisotropy elds are large with respect to the resonant eld. However the situation in manganites is dierent. A study of the elect of magnetic anisotropy on EPR signals of manganites has been carried out by Lo and et al. [32] in single crystalline Lq $_{\rm x}$ Sr_xM nO₃ and they estimate the anisotropy eld to be 160 G auss. The anisotropy eld in N SM 0 0.5 could not be very dierent from that in Lq $_{\rm x}$ Sr_xM nO₃ since the two are structurally sim ilar high bandwidth manganites. Therefore, the anisotropy eld in N SM 0 0.5 is much less than the resonance eld which is 3000 G auss.

Schlom ann et al. [30] have done the tem perature study of split signals in ferrites. They observe that due to magnetic anisotropy of their ferrite samples, the splitting of their signals increases as the tem perature is decreased. However, both the components of the signal shift towards the low eld side as a function of decreasing temperature and the intensity of the low eld component continuously increases. Our observations in NSM 00.5 are qualitatively very diement from these as seen from Fig. 2a. The intensity of the two signal components also does not follow the trend as seen by Schlom ann et al. Moreover, the two line structure observed in the polycrystalline samples is due to a powder pattern [31] and does not to two Lorentzian lineshape functions. Because of these reasons we believe that the observed splitting of the EPR signal cannot be attributed to the magnetic anisotropy in NSM 00.5. In a recent work Sham es et al. [33] derive sim ilar conclusion for their EPR study on La_{1 x}Ca_xM nO₃ (x=0.5)

A nother complicating factor in m agnetically ordered m aterials, namely, the dem agnetizing elds due to possibly di erent sized and shaped particles does not seem to be signil cant in our experiments. A smentioned by Lo and et al. [32] and Patillet al. [34] dem agnetizing elds cause a shift in the position of the DPPH signal. Throughout the temperature range, we did not observe any change in the DPPH position, even across T_c when the dem agnetizing factors were expected to come into picture.

As seen in Fig. 2b, the linew idths in the regions 2 and 3 are much larger compared to those in CO manganites probably due to the large distribution of internal elds in the FM state. The linew idths of the AFM component are also large as expected, and are comparable to linew idths of the FM phase. A peak in the linew idth in region 3 appears at nearly $1.1T_N$. In region 4, only CE-type and A-type phases are expected to be present according to the neutron di raction studies of Kajim oto et al. [13]. However the signals in this region show distortion near the zero eld. This is the tem perature range just below T_N . The lineshape has been tted to the part of the signal excluding this distortion. The tem perature dependence of the center eld is non-monotonic showing a peak at 130 K. The linewidth also shows a non-monotonic tem perature dependence in region 4, passing through a m in in um at 130 K.Below 100 K ie in region 5 according to the neutron di raction studies of K a jim oto et al. and W oodward et al. A -type and C E -type phases are present. The signal observed in this region, a broad but a single Lorentzian ts very well to equation 2. We can attribute this signal to the A-type AFM phase or the FM phase which gradually converts to

CE phase since CE-type AFM phase does not give an EPR signal as shown by our previous studies in CO manganites $Pr_{0.6}Ca_{0.4}M nO_3$ and $Nd_{0.5}Ca_{0.5}M nO_3$ [26,27]. The linewidth in this region increases monotonically with center eld being practically temperature independent. We shall come back to the origin of these signals in the subsequent discussion.

From the above analysis of results of NSM 00.5 powder, it is clear that the EPR lineshapes are very sensitive to the magnetic inhom ogeneity of the sam ple. The analysis of the single crystal data was made di cult by large linewidths, large internal eld e ects and the sensitivity of the signals to the orientation of sam ple with respect to the magnetic

eld. Fitting of the highly distorted signals below T_c was practically impossible. Below 100 K, only a part of the line could be recorded in the available eld range as can be seen from Fig. 3.

In the previous discussion of the EPR results on N SM 00.5, we have presented two important results, (1) EPR presents evidence for phase segregation and (2) Thisphase segregation in N SM 00.5 involves, separation into a ferrom agnetic phase and an A-type antiferrom agnetic phase. In the follow ing we provide additional evidence to support these conclusions. We present EPR results on $La_{0:77}Ca_{0:23}M nO_3$ (LCM 0), which is known to phase separate into two ferrom agnetic phases [24] and on N d_{0:45}Sr_{0:55}M nO₃ (N SM 00.55) which is known to undergo a transition to a hom ogeneous A-type AFM phase.

EPR in LCM O

As can be seen from the inset of g. 4, the EPR signals in LCM 0 from room temperature to 225 K (T_c 230 K) are narrow (denoted by symbol A') and can be tted to the Lorentzian lineshape function given

by eqn 1. The signals in the range 225 K -170 K (see for example the signal at 210 K) seem to be consisting of two components. The narrow signal component A' observed in this tem perature range represents the presence of residual param agnetic phase. The ferrom agnetic phase gives rise to the broad signal component B'. The component A' decreases in intensity with decreasing tem perature and the component B' increases in intensity resulting in a lineshape shown at 165 K. The signals from 165 K down to low est tem perature how ever could be very well tted to two Lorentzians each represented by eqn 2. W e have obtained the resonanant elds and the double integrated intensity from these ts. The resonance elds plotted in g. 4 are practically tem perature independent in the param agnetic phase. In the ferrom agnetic phase how ever, both the signal components show a resonance eld shifted to lower eld side compared to that in the param agnetic phase as expected from a ferrom agnetic phase. This is consistent with the earlier evidence from NMR experiments [24] that the two phases at this composition are ferrom agnetic (one being insulating and another being m etallic.) It is to be noted that we start observing the signatures of phase separation at a higher tem perature than the NMR studies. We believe that this is because of the di erent tim escales of the two techniques, EPR being a much faster probe than NMR.A very important point to note here is that the shift of resonance elds in LCMO in the phase separated regime is very di erent from that of NSM 00.5, in that, one of the two signals (m arked as Q') in NSM 00.5 shifts to a resonanant eld higher than the resonant eld in the param agnetic phase and the other signal (m arked as P') shifts to a lower eld than the signal in the param agnetic phase. eld shift indicates that component P' is obviously from the This low ferrom agnetic phase present in the sample in this tem perature range.

We propose that the high eld signal component in region 2 and 3 in g. 2a is indeed due to A-AFM phase which is present in the sample in that temperature range. To substantiate this claim we now discuss the results of NSM 00.55 which is a single phasic hom ogeneous sample but goes into an A-AFM phase.

EPR in NSM 00.55

Figure 6 presents the EPR parameters H_{pp} and H_0 obtained from the Lorentzian ts to the signals of NSM 00.55.

Throughout the tem perature range in which we observe the EPR signal, we see that the signal is a single Lorentzian as expected for a hom ogeneous powder sample. It may be noted that we observe a signal below the Neel tem perature unlike the CO manganites studied before [26, 27] but similar to NSM 00.5 which has an A-type AFM phase below 200 K. We would also like to mention here that the resonance eld of the component Q of NSM 00.5 also has a 'g' value smaller (as indicated by the shift of the signal towards higher elds) than the param agnetic 'g' value similar to NSM 00.55 signals. Further, the tem perature dependence in the two cases is also qualitatively similar which supports our interpretation that the component Q of NSM 00.5 signals is due to the A-type AFM phase.

Finally, we analyse the intensities of the EPR signals in the three materials studied here. As can be seen from g. 7a, in case of NSM 00.5, the EPR intensity in the PM phase shows a weak temperature dependence as expected for the PM phase. The intensity of both the signal components below T_c rises very sharply. However, below 200 K which is reported to be the Neel temperature of A-AFM phase [12, 13, 15], the intensity of the component Q drops very rapidly. A similar sharp

drop of intensity below 210 K is also seen in NSM 00.55 (g. 7b). On the other hand the intensity of the P component shows a much broader peak indicating nearly temperature independent intensity down to 150 K. The FM phase in the temperature range of 240 K to 150 gradually changes over to CE phase below 150 K [12]. R itter et al. [15] have also observed the presence of FM phase at 125 K. Hence it is to be expected that the signal intensity of the component P drops gradually as the am ount of FM phase in the sam ple decreases gradually. The resonance

elds of these signals are below PM values. Hence we conclude that the behaviour in regions 4 and 5 of g. 2a and 2b in the temperature range of 150 K to 80 K are to be attributed to the residual FM phase in the sample.

In marked contrast to this behaviour is the behaviour of intensity of the two phases in LCMO. (g. 7c) The intensity of these two phases remains practically temperature independent down to very low temperature as is to be expected for any FM phase which remains stable down to very low temperature.

In conclusion, the present study of x=0.5 and 0.55 compositions of N d₁ $_x$ Sr_xM nO $_3$ and La_{0:77}C a_{0.23}M nO $_3$ demonstrates that EPR can be used as a powerful diagnostic tool for investigating phase segregation in m anganites.

W hile this paper was about to be submitted, we came to know of the work by Rivadulla et al. [37] which also reports brie y on their EPR study of $Nd_{0.5}Sr_{0.5}M nO_3$. W hile both of our works report the presence of a mixed phase in this compound, Rivadulla et al. conclude that ferrom agnetic and param agnetic phases are present below T_c while we believe for the reasons described in detail in this paper, the mixed phase consists of FM and A-type antiferrom agnetic phases.






