Quantum uctuation generated vortices, dual singular gauge transform ation and zero tem perature transition from d-wave superconductor to underdoped regime

By extending the original Anderson singular gauge transform ation for static vortices to two mutual ux-attaching singular gauge transform ations for moving vortices, we derive an e ective action describing the zero tem perature quantum phase transition from d-wave superconductor to underdoped regime. In this action, quantum uctuation generated vortices couple to quasi-particles by a mutual statistical interaction with statistical angle = 1=2 and a dynamic D oppler shift term, the vortices are also interacting with each other by long-range logarithm ic interactions due to charge uctuation. Neglecting the charge uctuation rst, we nd that the mutual statistical interaction is exactly marginal. In the underdoped regime, the quasi-particles are described by 2+1 dimensional QED; in the superconducting regime, they are essentially free. However, putting back the charge uctuation changes the physical picture dram atically: both the dynam ic D oppler shift term and the mutual statistical interaction become irrelevant short-ranged interactions on both sides of the quantum critical point. There are no spin-charge separation and no dynam ic gapless gauge eld in the Cooper-pair picture. The form alism developed at T = 0 is applied to study therm ally generated vortices in the vortex plasm a regime near the nite temperature KT transition. The important e ects of the AB phase scattering and the Doppler shift on ARPES data presented in Phys. Rev. Lett. 87, 227003 (2001) are also brie y reviewed.

I. IN TRODUCTION




Fig 1: The tem perature (T) versus doping (x) diagram of high $T_{\rm c}$ cuprates.

In this paper, we are trying to study the nature of zero temperature quantum phase transition from d-wave superconductor at $x > x_c$ to the underdoped regime at $x < x_c$ of the high temperature superconductors (Fig.1).

It is well known that inside the superconductor phase $x > x_c$, there are low energy quasi-particle excitations near the four nodes of the Ferm i surface, the quantum phase uctuation of the C ooperpair condensates are suppressed, the positive and negative vortices are bound together. As the doping decreases from the right to x_c , the phase uctuation increases. At the underdoped regime $x < x_c$, the quantum phase uctuations are so strong that they generate free hc=2e vortices, destroy the long range phase coherence of the d-wave superconductor, therefore the superconducting ground state. How ever, the local short-range pairing still exists, the low energy

quasi-particles at the four nodes remain. This quantum phase transition is driven by the condensation of hc=2e vortices. Starting from this physical picture, Balents, F isher and N ayak discussed Q uantum phase transitions from d-wave superconductor to underdoped regine and to the anti-ferrom agnet regine e with focus on the condensation of hc=e vortices in [1]. Earlier discussions on the stability of hc=e vortex starting from M ott insulating phase were given in R ef. [2]. The present paper focus on the condensation of hc=2e vortices.

M athem atically, we can describe the transition by starting from the d wave BCS Ham iltonian inside the superconducting state $x > x_c$ in the presence of external magnetic eld K [3]:

Based on the earlier work on d-wave superconductor by Simon and Lee $[\beta]$ and on t $\ J$ model by Ye and Sachdev [4], the author derived the gauge-invariant form in Ref. [6]:

where $\;$ is the phase of the order parameter $\;$ (r) and p $_x$ and p $_y$ are the m om enta relative to the origin .

Because high T_c cuprates are strongly type II superconductors (= = 1), we assume the gap am plitude to be a constant (x) $_0e^i$ across the transition from $x > x_c$ to $x < x_c$. The phase can be set to be zero inside the superconducting state $x > x_c$ because its uctuation is suppressed. However in the underdoped regime $x < x_c$, there are strong phase uctuation which leads to the free hc=2e vortices located at \tilde{R}_i with parity $n_i = 1$, then the phase satis esr r = 2 \hat{z} $_i n_i$ (r \tilde{R}_i).

A bt of work has been done on a closely related problem where quasi-particles are coupled to the vortices generated by external magnetic eld inside the superconducting state [3,6{15]. Employing semi-classical approxim ation, Volovik pointed out that the circulating supercurrents around vortices induce D oppler energy shift to the quasi-particle spectrum, which leads to a nite density of states at the nodes [8]. This e ect (Volovik e ect) has been employed to attempt to explain the experimental observations [16] of longitudinal therm al conductivity $_{xx}$ in [9].

Starting from BCS Ham iltonian, W ang and M acD onald performed a rst numerical calculation on quasiparticle spectrum in vortex lattice state [7]. By phenom enological scaling arguments, Sim on and Lee (SL) proposed the approxim ate scaling form s for longitudinal and transverse therm alconductivities for dirty d wave superconductors in the mixed state [3]. Anderson [10] em ployed the rst single-valued singular gauge transform ation to study quasi-particle dynam ics in the m ixed state. Unfortunately, Anderson made an incorrect mean eld approximation which violates the "T in e-R eversal" sym m etry [6], therefore leads to the incorrect conclusion that there is Landau level quantization of energy levels of the quasi-particle. Franz and Tesanovic employed a di erent single-valued singular gauge transform ation and studied the quasi-particle spectrum num erically [11]. They did not see the signature of Landau level quantization in their num erical calculations. M ore detailed studies in various kinds of vortex lattice states were conducted in Refs. [12,13]. The quasi-particle spectrum around a single vortex, paying special attention to the strong an isotropy of Fermi and gap velocities, was given in [14,15].

In the vortex lattice state, the vector potential only provides a periodic potential instead of scattering quasiparticles, its e ect on the energy spectrum and other physical quantities is not transparent. In Ref. [6], the author studied the quasi-particle transport in the disordered vortex state where the random AB phase scattering m ay show its important e ects. I observed that because in nite thin hc=2e vortices do not break the T reversal symmetry [5], there is no Landau level quanti-

zation, any correct m ean eld theory should respect this T symmetry (The other way around need not be necessarily true, for example, in = 1=2 Fractional Quantum Hall system [27], the mean eld state is a Ferm i surface of composite ferm ion which respects T symmetry even the original electron system breaks the T symmetry due to the external magnetic eld). I applied the Anderson singular transform ation Eqn.3 to disordered vortex state and found that the long-range logarithm ic interaction between vortices suppresses the uctuation of super uid velocity (scalar potential), but does not a ect the uctuation of the internal gauge eld. Therefore the scalar eld acquires a "m ass " determ ined by the vortex density, but the gauge eld remains "massless". The quasi-particle scattering from the "massless" internal gauge eld dom inates over those from the well-known "massive" Volovik e ect and the non-magnetic scattering at su cient high magnetic eld. This dom inant scattering mechanism is a purely quantum mechanicale ects which was overboked by all the previous sem i-classical treatments [9]. In fact. it is responsible for the behaviors of both $_{xx}$ and $_{xy}$ in high magnetic eld observed in the experiments [16].

W hen the vortices are generated by quantum uctuations them selves are moving around, new physics may arise. For example, moving hc=2e vortices does break T reversal symmetry and leads to Hall voltage drop, a moving hc=2e vortex is di erent from a moving hc=2e vortex. This in-equivalence renders FT gauge in Ref. [11] useless for moving vortices although it is equivalent to Anderson's gauge for static vortices. Anderson gauge has to be employed to study moving vortices. Intuitively, from Newton's third law, the vortices must also feel the counter-acting AB phase coming from the quasi-particles. Therefore there is a mutual AB phase scattering between vortices and quasi-particles. The dynam ic D oppler shift term on the quasi-particles can also be equivalently viewed as an elective gauge eld coupled to the phase uctuation (see Eqn.14). In this paper, we enlarge Anderson singular gauge transform ation to two mutual ux-attaching singular gauge transform ations. We then apply them to study the physics of quasiparticles coupled to moving vortices near the zero tem perature quantum critical point. In canonical quantization and in Coulomb gauge, we perform the two sinqular transform ations (which are dual to each other) to quasi-particles (which are spinons) and moving vortices (which are holons) respectively to satisfy all the possible commutation relations. Just like a conventional singular gauge transform ation leads to a conventional Chem-Sim on (CS) term, the two mutual singular gauge transform ations lead to a mutual CS term . This elegant mutualCS term describe the mutualAB phase scattering between vortices and quasi-particles. A lternatively, in path-integral presentation, the e ective action describes the quasi-particle moving in both vector and scalar potentials due to the phase uctuations of quantum gen-

erated vortices. By a duality transform ation presented in Refs. [17,18] to a vortex representation, the quantum uctuation generated vortices couple to quasi-particles by a mutual CS term, the vortices are also interacting with each other by long range logarithm ic interactions due to charge uctuation described by a Maxwell term . Neglecting the charge uctuation and its associated dynam ic Doppler shift term rst, we nd a xed line characterized by the mutual statistical angle and calculate the universal spinon, vortex and mutual Hall drag conductivities which continuously depend on . This transition can also be viewed as a simple example of con nement and decon nem ent transition. In the disordered phase, the quasi-particles are described by 2 + 1 dim ensional QED. In the superconducting side, they are essentially free. W e stressed explicitly the lack of periodicity of U(1) mutualCS gauge theory. W hen the U (1) charge uctuation is taken into account, we treat both U (1) gauge uctuations on the same footing and nd the U(1) charge uctuation turns the xed line into a xed point separating the d-wave superconductor and some unknown charge ordered state. Both the dynam ic Doppler shift term and the mutual statistical interaction become irrelevant short-ranged interactions on both sides of the QCP. The spinon and holons are con ned into electrons and Cooper pairs in the condensation of hc=2e vortices, in contrast to the condensation of double strength hc=e vortices discussed in [1,2] and reviewed in most general form in appendix B. There are no gapless gauge eld uctuations in the naltheory, in contrast to U (1) and SU (2) gauge theory [21]. W e also discuss the properties of the two stable phases: disorder and superconducting phases around the critical point.

As stressed in Ref. [6], in weakly type-II lim it < < d_v, the super uid velocity vanishes in the interior of the superconductor, the D oppler shift e ect is com pletely absent, the AB phase scattering e ect becom es the sole scattering mechanism [28]. In this case, the interaction between vortices become short-ranged. The discussions in [6] on high T_c cuprates are limited to H $_{c1}$ Η H ~2 . Except H is extremely close to where d, H_{c1}, we can safely take ! 1 limit. The interaction between vortices become long-ranged logarithm ic interaction and played leading roles as demonstrated in [6]. In this paper, the quantum or thermal uctuation gen- $^{2}_{c}$ (here $_{c}$ is erated free vortex density scales as nf the correlation length rather than the coherence length). For high T_c cuprates, = = 60, =a 5, then 60 300a, so as long as d $_{\rm c}$ < , namely except we get extremely close to the phase boundary, we can safely set ! 1 . Then we have to consider the long-range interaction between the vortices which is mediated by charge gauge eld, its important role will be dem onstrated explicitly in Sec. IV. All the present experimental situations lie in the regime $_{c}$ < .

The paper is organized as the following. In the next

section, we derive the e ective action with both the mutual C-S interaction and the charge uctuation, rst in the path integral language, and then in canonical quantization representation. W e stress the importance of the dual singular gauge transform ation on the moving vortices to keep them utual statistics invariant and derive the in portant expression of real electron operator in term s of spinon and holon (Eqn. 25). In Sec. III, neglecting the charge uctuation, we concentrate on the e ect of the mutual C-S interaction and calculate the critical exponents and universal conductivities for general statistical angle . Im plications for double layers Quantum Hall System are given. Some technical details are relegated to appendix A . In appendix B , we study double strength hc=e vortices in the most general form by assuming moving hc=e vortices also scatter quasi-particles by a m utual C-S term with any integer statistical angle. In Sec IV, we discuss the combined e ect of mutual C-S interaction and charge uctuation, we show how the long-range charge uctuation change the physical picture in Sec. III dram atically. There are only electrons and Cooper pairs in the spectrum; the xed line is replaced by a quantum critical point (QCP) separating d-wave superconductor and som e still unknown charge -ordered state; there are no spin-charge separation and no gapless gauge eld uctuations in the naltheory, in contrast to U (1) or S (2) gauge theories investigated in Ref. [21]. We also discuss the properties of the two phases around the QCP. In section V, we apply the form alism developed for quantum generated vortices to study them ally generated vortices and random static vortex array in an external magnetic eld inside d-wave superconductor and recovered the results established previously in Ref. [6]. Finally, in Sec. VI, we discuss the connection and di erences of our present approach to the Z_2 gauge theory and point out som e open problem s.

II. THE DUAL SINGULAR GAUGE TRANSFORMATION, EFFECTIVE ACTION AND SINGLE ELECTRON OPERATOR

In the follow ing, we follow the notation in Ref. [10,6]and introduce the spinon by perform ing a general singlevalued Anderson singular gauge transform ation $d = U d_s$:

where $_{A} = 0$; $_{B} =$ or vice versa and is the phase of the Cooper pair. In the form er(latter), the spinon is electron-like (hole-like). The original Anderson singular gauge transform ation [10] is devised for static vortices. Here we extend it to moving vortices whose phase is also uctuating, therefore, depends on both the space and time.

A . Path integral form ulation

Expanding H_s around the node 1 where $p = (p_F; 0)$, we obtain H_s = H₁ + H_c. The corresponding linearized quasi-particle Lagrangian L_{qp} in the presence of the external gauge potential A in the imaginary time is:

where v_f;v are Ferm i and gap velocities respectively, $v = \frac{h}{2}Q$ $\frac{e}{c}A$; = x;y; is the dynam ical gaugeinvariant super uid m om entum , it acts as a scalar scattering potential and provides dynam ical D oppler shift to the quasi-particles (this e ect can be considered as a dynam ic Volovik e ect), $a = \frac{1}{2} Q (A B)$ is the dynam icalAB gauge eld due to the phase winding of vortices. Note that the external gauge potential only appear explicitly in the super uid momentum v . The ferm ion at node 1 (2) only couples to the x (y)-com ponent of superuid m om entum, because the Ferm im om entum at node 1 (2) is along the x (y) direction. Because there are equal num ber of positive and negative vortices, on the average, the vanishing of v and a is automatically ensured in the Anderson gauge.

W e get the corresponding expression at node 1 and 2 by changing v_f ! v_f ; v ! v in the above Eqn.

W here $\sim = p + a$ is the covariant derivative [25]. H_c takes the same form for all the four nodes. A lthough H_c is very important for the therm al H all conductance in the presence of external magnetic eld [6], it is irrelevant near the quantum critical point, so we will not discuss it anym ore in the present paper.

Performing a P H transformation $\sim_1 = \frac{y}{1}$ (; are p-h indices) at node 1 and the corresponding transformation at node 2, the above Eqn. becomes:

In order to make the nalexpressions explicitly SU (2) invariant, we perform the singular gauge transform ation $_{12} = e^{i(a_{B}-b)} - _{1}$ and the corresponding transform mation at node 2, then a ! a , Eqn.7 takes the same form as Eqn.4 [22]. Adding the two equations leads to:

where a = 1;2 is the spin indices. ^{Os} m atrices are acting on particle-hole space. A sintended, the above Eqn. is explicitly SU (2) spin invariant. Equivalently, we can start with the explicitly spin SU (2) invariant approach advocated in Ref. [1] and perform the singular gauge transform ation in the p-h space.

Under this uniform U (1) transform ation, the corresponding elds transform as:

d;v ;a all are invariant under this external U (1) transform ation. Therefore the spinon d is charge neutral to the external magnetic eld.

Under this internal U(1) transform ation, the corresponding elds transform as:

A lthough the spinon d is charge neutral to the external magnetic eld, it carries charge 1 to the internal gauge eld a .

It is easy to realize that U_u (1) acts only on the boson sector, since the spinon is charge neutral, U_s (1) acts only on the ferm ion sector. In fact, U_s (1) should be a discrete local Z_2 symmetry for static vortices, because up and down static hc=2e vortices are equivalent and do not break T symmetry [6].

The phase uctuation is $\sin ply 2 + 1 \dim ensional X - Y$ m odel (For $\sin plicity$, we neglect the possible an isotropy in the spin-sti ness):

It is easy to see that the dynam icalD oppler shift term on the quasi-particles can also be equivalently thought as a dynam icale ective gauge eld coupled to the phase uctuation. (Note that in the static vortex array generated by external magnetic eld [6], the super uid momentum is static and causes D oppler shift to the quasi-particle, there is no feed-back e ect on the super uid momentum from the quasi-particles)

From Eqn.14, it is easy to identify the two conserved Noether currents: spinon current and electric current.

The spinon current is given by:

O byiously the spinon current only comes from quasiparticle. In principle, the spinon current is not conserved due to scatterings between di erent nodes which lead to anom alous terms not included in Eqn.14. However, the inter-node scatterings involve large momenta transfer K_i K_j for $i \in j$, so we neglect them due to momentum conservation in the long wave-length limit of the phase uctuation [23]. The exact conserved spin current j^S is with ~=2 inserted in the above spinon currents.

The electric current is given by:

W here the rst part coming from Cooper pair and the second from the quasi-particle. A lthough they are not separately conserved, their sum is.

It is a combination of electric and spinon currents, therefore also conserved.

Following Refs. [17,18], we perform a duality transformation to Eqn.14

W here we have separated topological trivial spin-wave part and topological non-trivial vortex parts.

Integrating out the spin-wave part, we get the conservation equation for the total current $j^{t} = j^{e} - \frac{1}{2}j^{s}$. In fact, as shown in the previous paragraphs, j^{e} and j^{s} are separately conserved. Therefore we can introduce spin and electric gauge elds by:

where $a^t = a^e - \frac{1}{2}a^s$ is the total gauge eld felt by the moving vortices.

U sing for the vortex operator and adding the quasiparticle part, we get the follow ing e ective action:

where V $(j_{1}) = m^{2} j_{1}^{2} + q_{1}^{2} j_{1}^{4} +$ stands for the short range interaction between the vortices. The last term is due to the Berry phase in the boson representation [18] which is a rst order time derivative term. It can be absorbed into A^{eff} by redening A^{eff} ! $A^{eff} + i$, it acts like an external magnetic eld in the \hat{z} (namely = 0) direction in the above vortex representation. There are M = 1 species of vortex and N = 4 species of D irac ferm ion (2 spin components at 2 nodes at the upper half plane), the mutual statistical angle = 1=2. W e also changed the notation by setting $a = a^{v}; a = a^{s}; a^{e} = a$. The dynam ic D oppler-shifted tem iK ¹ J 0 a (The dynamic Doppler shift effect) is encoded in the second to the last term in Eqn.22. Note that this term only involves electrical gauge eld. This e ect was not written down explicitly in the Z_2 gauge theory [19].

Eqn.22 again enjoys the gauge symmetry U $(1)_c$ U (1)_{cs} which is a dynam ic generalization of U (1)_u U (1)_s in Eqns.10,12. The st one acting on the vortex sector is the electric U $(1)_c$ U $(1)_a$ gauge eld, the second on both the vortex and ferm ion sectors is the U $(1)_{cs}$ mutualCS gauge eld which is a dynam ic generalization of U (1)s. The mutual Chem-Sim on term enforces the constraints: 2 f =@a;2 y = 0 a . Physically, it means that when a quasi-particle encircles a vortex, it picks up a phase 2 . Equivalently when a vortex m oves around a quasi-particle, it also picks up a phase 2 . A lthough the conventional C-S term breaks T sym metry and has periodicity under $! + 2 [26,27,29{32}],$ the mutual C-S term does not break T symmetry and does not have the periodicity under ! + 1. For example, = 1=2 is not equivalent to = 1=2.

B.Electron operator

In principle, the electron G reen function G $(x;t) = \langle C (x;t)C^{y}(0;0) \rangle$ can be calculated from the above equation. It is easy to see that the real electron in Eqn 25 is invariant under the internal gauge transform ation U $(1)_{s}$.

C.Canonical quantization approach

In subsection A, we derived Eqn 22 by path integral approach, in this subsection, we rederive this equation by canonical quantization m ethod and stress the importance of the dual singular gauge transform ation Eqn 29.

Substituting Eqn 24 into Eqn 3, we nd that the singular unitary transform ation U takes the physically more transparent form :

The rst factor leads to the dynam icD oppler shift term which is not explicitly written in the Z_2 gauge theory. The second leads to mutual CS term with = 1=2. To see this, in Anderson electron-like gauge, we rewrite \tilde{a} in the second quantization form in terms of the vortex operator :

O bviously, d_s still satis as ferm ion commutation relation. When the vortices are static, $j_0^v(x) = \frac{1}{i} (x - x)$, Eqn 28 recovers the original Anderson singular gauge transform ation and is the only necessary transform ation. However, when vortices are generated by quantum uctuations, they have their own dynamics. Eqn 28 alone can not satisfy all the possible commutation relations. This motivated us to introduce the following dual singular gauge transform ation to the vortex operator:

M ost importantly, from Eqns 26 and 29, we can check that d_s and $_s$ commute with each other, so their mutual statistics is kept intact which is our original motivation. Note that for static vortices, the dual transform ation in Eqn 29 is unnecessary, because the static vortices are not dynam ic variables.

It is very instructive to compare the above transformations to the well-known singular gauge transform ation leading to composite boson in = 1=3 Fractional Quantum Hall state by Zhang, Hansen and Kivelson (ZHK) [26] and composite ferm ion in = 1=2 system by Halperin, Lee and Read (HLR) [27]:

The crucial di erence between Eqn.31 and Eqns.26,29 is that in the form er, we attach electron's own ux to itself (= 3 in = 1=3 FQH state to change ferm ion to boson and = 2 in = 1=2 system to keep ferm ion statistics intact), the constraint r a(r) = 2 (至) (Eqn.32) in Coulomb gauge $l_i a_i = 0$ leads to composite ferm ion coupled to conventional CS term which breaks T symmetry, has periodicity under ! + 2; however, in the latter, we attach vortex's 1 = 2= ux to quasi-particle or vise versa, the two constraints $r = a(r) = 2 \frac{y}{b}(r); r = a(r) = 2 \frac{s}{b}(r) (Eqns.28,30)$) in Coulom b gauges $Q_{i}a_{i} = Q_{i}a_{i} = 0$ naturally leads to quasi-particles and vortices are coupled by mutual CS term in additional to the electrical gauge eld which mediates the logarithm ic interaction between vortices. The mutualCS term does not break T symmetry and does not have the periodicity under ! + 1.

It is easy to see that when a vortex is moving around a closed loop, it pick up two phases, one is U $(1)_{\rm cs}$ phase due to the spinon current, described by the mutual C – S term , another is U $(1)_{\rm c}$ phase due to the total electric charge current described by the M axwell term . In the following section, we will neglect the electric charge uctuation (therefore its associated D ynam ic D oppler shift term) and concentrate on the mutual statistics term . In Sec. IV , we will study the com bined e ect of charge uctuation described by the M axwell term and the mutual C – S term .

For sim plicity, we neglect all the possible anisotropy in the quasi-particle and vortex velocities. We also take the relativistic form for both ferm ion and boson, because the di erence between the velocity of spinon and that of vortex in Eqn 22 is expected to be irrelevant near the zero tem perature QCP [20].

III. THE EFFECT OF MUTUAL STATISTICS

In this section, we neglect the charge uctuation, namely setting a = 0 in Eqn 22. The associated dynam ic D oppler shift term also drops out. A spointed out in [6] and re-emphasized in the introduction, this is the weakly type II case. So far, weakly type II superconductors are all swave superconductors where there is no low energy quasi-particles. So the results in this section can only be applied to presum ed "weakly type II d-wave superconductor "which has not been discovered yet in nature. The model is also a relativistic version of the H all drag problem in double layer Q uantum H all system [36], therefore the model itself is interesting on its own right and deserves detailed investigation.

The charge uctuation can be suppressed by assuming the condensation of hc=e vortices reviewed in appendix

B.W e could add the kinetic and potential terms for the hc=e vortex operator $_2$ to Eqn 22:

As shown in [1] and in appendix B, there is no mutual statistical interaction between spinon and hc=e vortices $_2$. The long range logarithm ic interaction between hc=2e vortices and hc=e vortices $_2$ is mediated by the electrical gauge eld a. where a = 1;2;3;4 stands for N = 4 species of D irac ferm ion. In fact, two M axwell terms for a and a can be added to the above equation, but they are subleading to the mutual CS term in the low energy lim it. It is expected that there is no periodicity under ! + 1 in the continuum lim it.

The RG calculation in Refs. [29{31] can be used to show that is exactly marginal, therefore there is a line of xed points determ ined by the mutual statistical angle

. In order to calculate the spin conductivity along this xed line, a source eld could be introduced to couple to the spin current $j^s = y$ (~) . Sim ilar calculations follow.





A lthough its form is similar to the conventional connection formulas discussed in [27,29,30], the physical interpretations of the conductivities are quite di erent (see the following).

W hen the vortices are generated by external magnetic eld and pinned by impurities as discussed in [6], the total conductivity is the same as the ferm ion conductivity because the static vortices do not contribute. As explained in section V, the static vortices only feel the electric gauge eld a , but not the statistical gauge eld a .

The equations 41,42 are exact, but 1; 2; 3 can only be calculated perturbatively in the coupling constant $g^2 = 2$. The renorm alized propagators for a and a can be found from the following Feym ann diagram s:





By using the bare propagators < a a >= $k = k^2$ and the bare ferm ion and boson loop results $f^0 = b^0 = \frac{q^2}{16}k(k = k^2)$, we can not easily the renormalized a and a propagators $G = G = \frac{q^2}{16k}(k = k^2)$. In contrast to the conventional CS theory studied in [29,30], the propagators are even in k, this is because the theory respects T symmetry. On the other hand, in contrast to the M axwell propagators, they behave as 1=k instead of 1=k^2.

The three loop diagrams for $_1$ are given by:





Fig 3: The three loop diagrams of $_1$. The thick wiggle line stands for the renorm alized propagators of a , the thin solid line stands for the ferm ion propagator. The one loop diagram is not show n.

By using G and extracting the sym metric part of the gauge propagator in the large N results in Refs. [29,30], we are able to calculate the above three loop diagram s. Furry's theorem can be used to eliminate large number of null diagram s. We get the following series:





Fig 5: One of the four loop diagram s of 2. the thin solid line stands for the ferm ion propagator, the thick solid line for the boson propagator. All the other four loop diagram s can be obtained by shu ing the positions of the three bare propagator lines.

From Eqn.40, ; are even functions of , but the mutual Hall drag conductivity is an odd function of . These are expected from P H transform ation. Under the P H transform ation of the vortex operator ! ^y in Eqn.35, it can be shown that A ; is equivalent to . From Eqn.39, we reach the same conclusions. Α; Speci cally, ^H takes opposite values for = 1=2, the ! + 1 is not preserved. Experperiodicity under in entally, the Hall drag conductivity can be detected by measuring the transverse voltage drop (or transverse tem perature drop for therm al conductivity) of spinons due to the longitudinal driving of vortices. The Hall drag conductivity in double layer Q uantum H all system s has been investigated by several authors [36]. In double layer system s, the electrons in di erent layers are treated as two di erent species. There is a mutual CS interaction between the two species (both are ferm ions) which is directly responsible for this Halldrag conductivity, although the C oulom b interaction between the two species is responsible for the Coulomb (longitudinal) drag [37]. This example shows that no external magnetic eld is needed to produce a Halle ect ! For example = 1=2lead to opposite H all drag conductivities although static

1=2 vortex leads to no Hall conductivity.

Again, by using the large N result of [29,30], we nd the anom alous dimensions of the ferm ion and vortex to two loops:




F ig 6: The two loop diagram s for the self energies of spinon (a) and vortex (b). The renorm alized operators are used.

The above Eqn. indicates that ferm ions and bosons are coupled to the same gauge eld whose dynam ics is described by Maxwell term instead of C-S term. This Eqn. is sim ply 2 + 1 dim ensional combination of spinor QED and scalarQED. This action is similar to a relativistic analogue of the U (1) gauge eld theory investigated extensively in Ref. [21]. The RG analysis at 4 by dimensional regularization is possible, because the marginal dimension of all the relevant couplings are 4. However a RG analysis directly at 2 + 1 dimension is form idable. The physical meaning of is obscure and the exact marginality of is a highly non-trival result in the boson representation, but all these become evident in the dual vortex representation Eqn. 35. It is evident that there is no periodicity under ! + 1 in Eqn.49.

If we perform duality transform ation again on Eqn.49 to go to the vortex representation, then we recover Eqn.22 upon neglecting the two M axwell terms which are subleading to the mutual C-S term .

In the next subsection, setting the two source terms vanishing, we look at the properties of the di erent phases on the two sides of this quantum critical point.

B. 2+1 dim ensionalQED in the underdoped phase and free ferm ions in the superconducting phase

This is simply 2+1 dimensional spinorQED which was studied by large N expansion by the authors in [34]. They used four component D irac ferm ions and discussed possible dynam icm ass generation of the ferm ions which break the chiral symmetry, but preserves Parity and T imereversal symmetry. However, for 2+1 dimensional compact QED, the possible important instanton elects were not well understood yet. The possible connection between this dynamic mass generation and Anti-ferrom agnetism in the context of gapless ux phase was discussed by Marston [35].

In fact, we reach the same description from the boson representation Eqn.49. Because in the disordered phase, the boson is massive, therefore can be integrated out, it generates the M axwell term $\frac{1}{4m}$ f² which dom inates over the existing non-critical M axwell term . We reach Eqn.51 after identifying m $\frac{2}{0}$.

In the superconductor phase, the vortex is massive, therefore can be integrated out, it leads to the old M axwell term $\frac{1}{4m}$ (f)². Integrating out a generates a m ass term :

The D irac ferm ions become free. In fact, we reach the same description from the boson representation Eqn.49. Because in superconductor phase, the boson condense, therefore generates a mass term $\frac{2}{0}$ (a) $_{t}^{2}$ which renders the M axwell term ine ective. We reach the same conclusion from both sides by identifying m $\frac{2}{0}$ which is dual to the relation in the disordered phase m $\frac{2}{0}$.

In short, in the disordered phase, the system is described by spinor QED Eqn.51; in the superconductor side, by free D irac ferm ion. We can view the transition as a simple example of con nem ent-decon nem ent transition. In the con ned (disordered) phase, the boson and ferm ion are con ned together by the uctuating gauge eld. In the decon ned (superconductor) phase, the boson condensed, the gauge eld becom es m assive, the ferm ion becom es free. There is a line of xed point governed by the mutual statistical angle separating the two phases.

IV . THE EFFECT OF CHARGE FLUCTUATION AND THE ABSENCE OF MASSLESS DYNAM IC $\label{eq:gauge} GAUGE\ FIELD\ AT\ T=0$

In this section, we try to investigate the e ect of charge uctuation on the xed line characterized by the statistical angle discovered in the last section by considering the combined e ects of U $(1)_{cs}$ mutual statistical gauge uctuation and U (1)c electrical gauge uctuation and treat both U (1) gauge elds on the equal footing. We nd the condensation of hc=2e vortex condensation indeed leads to the con nem ent of spinon and chargon into Cooper pairs and electrons, in contrast to the condensation of hc=e vortex. The xed line in the last section is destroyed and replaced by a quantum critical point separating the superconducting state and some sort of charge ordered state. There is no gapless gauge eld left in the naltheory, in sharp contrast to the U(1) or SU(2) gauge theory [21]. Both m utual C-S interaction term and the dynam ic D oppler-shift term become irrelevant shortranged interactions.

The authors in Ref. [20] studied the similar model. They performed a perturbative RG calculation and reached very di erent conclusions from ours.

A. Quantum critical point

where Therefore the vortex and ferm ion are asymptotically decoupled. It indicates that the charge uctuation neglected in the last section destroy the xed line characterized by . However, very dierent conclusions are reached in Ref. [20]. We think that the perturbative RG calculation in [20] may not treat the charge gauge eld uctuation correctly.

Just like the last section, it is instructive to go to dual representation of Eqn.54, namely go to the boson representation:

C om paring to Eqn.49, the important di erence is that the gauge eld acquires a mass due to the charge uctuation which renders the Maxwell term ine ective. Note that the dynam ic D oppler shift term is encoded in A^{eff}. Up to irrelevant couplings, we can safely set $a = A^{eff}$ in the above equation and nd

m eans the irrelevant couplings between bosons where and ferm ions.

The above Eqn. leads to the conclusion that the mutual statistical interaction between hc=2e vortex and spinons leads to the con nement of spinon and chargon into electron and Cooper pair. The quasi-particles carry charge 2 e which can be identied as electrons or holes, the Cooper-pairs are described by 3D X-Y model. The mutual C-S coupling and the dynam ic D oppler-shift coupling between C ooper pairs and electrons are shortranged interactions which are irrelevant near the guantum critical point. There is no gapless gauge elds in the nale ective action ! How ever, there are several im portant factors left out in the above analysis: (1) The Berry phase term for the boson which is rst order time (56 derivative term is not included. This term is vanishing only at half-lling with particle-hole symmetry hopping.

m eans higher than second order derivatives.⁽²⁾ The long-range C oulom b interaction between C ooper pairs and electrons is not included. W hen the both effects are taken into account, the nalground state in the underdoped side at T = 0 m aybe an insulating state with som e kind of charge order. The nature of the QCP between the d-wave superconducting state and this charge ordered state is an important unsolved problem . However, the conclusion that there is no spin-charge separation and no gapless dynamic gauge uctuation remains robust !

B. D isordered and superconducting phases

W e follow the discussions in the previous section. In the disordered phase, the vortex condense < > = which generates a mass term for a in Eqn.54. Integrating out the massive a leads to a Maxwell term for a .

Because of the mass term, the D irac ferm ions become free and carry spin 1=2 and charge 2 e. In fact, we reach the sam e conclusion from the boson representation Eqn.59.

In the superconductor phase, the vortex is m assive, therefore can be integrated out, it leads to the old Maxwell term $\frac{1}{4m}$ (f)². Integrating out a generates a mass term for a :

where m is the mass of the vortex.

D iagonizing the last two mass terms leads to a continuously changing charge. This is expected, because in the superconducting state, the quasi-particle is a linear combination of electrons and holes, therefore carrying continuously changing charge. In fact, we reach the same description from the boson representation Eqn.59. Because in superconductor phase, the boson condense $< > = _0$, therefore generates a mass term for a :

W hich is essentially the same as Eqn.62 after the identication m $\frac{2}{0}$.

In short, in the disordered phase, the quasi-particles carry charge 2 e and spin 1=2 which can be identied as electrons or holes. When the Berry phase term and the long-range C oulom b interactions are taken into account, the electrons may form some charge ordered state. In the superconducting side, the quasi-particles carry continuously changing charge which is a linear combination of electrons and holes.

V . APPLICATION TO STATIC DISORDERED VORTEX ARRAY AND THERMALLY GENERATED VORTICES

So far, we discussed the vortices generated by quantum uctuations in the underdoped regime. Vortices can also be generated by an external magnetic eld inside superconductors or by therm al uctuations in the pseudo-gap regime. They were discussed in Refs. [6] and [40] respectively. In this section, we apply the form alism developed for quantum generated vortices at T = 0 to study vortices generated by an external magnetic eld or by therm al uctuations. By studying the three di erent kinds of vortices in a uni ed picture, we not only recover the previous established results, but also provide additional physical insights on the internal gauge eld uctuations.

Inside the d-wave superconductor, although the Cooper-pair condensates dom inates the electrical transport at zero frequency, the quasi-particles near the four nodes of a d-wave superconductor are responsible for the heat and spin transport at low temperature. Recently Ye studied the quasi-particle transport in a random vortex array with a fully quantum mechanical approach [6]. A lthough the previous sem i-classical approach only capture the physics of the Volovik e ect, fully quantum mechanical approach treats the Volovik e ect (scalar eld scattering) and the AB phase scattering (the gauge eld scattering) on the equal footing. Ye found that the long range logarithm ic interaction between vortices suppress the super uid velocity uctuation, but does not

a ect the internal gauge eld uctuation. He concluded that the quasi-particle scattering from the random gauge eld dom inate over that from the super uid velocity (the Volovik e ect).

Roughly speaking, the mixed state with vortex density $n_{\rm v}$ corresponds to the vortex condensed phase (disordered phase). As discussed in the previous sections, the vortex condensation leads to a mass term $\frac{1}{2}n_{\rm v}$ (a $)^2$ for the statistical gauge eld a in Eqn.22. Adding the mass term to the equation, integrating out a and keeping only the time component of the charge gauge eld a_0 which mediates the long-range density-density logarithmic interaction between the static vortices, we get two static Maxwell terms for a ;v respectively and a mass term for v :

where p is added to stand for an unknown function of pinning potential, f = 0 a 0 a; $f^v = 0$ v 0 v.

In Eqn.64, the averages over a ;v should be understood as quenched instead of annealed averages. N am ely there is no feedback e ects on the gauge eld and scalar eld propagators from the ferm ions [41]. The above equation shows that the long-range logarithm ic interaction between vortices suppress the uctuation of the superuid velocity and leads to a mass term for the superuid velocity and the incom pressibility of the vortex system. The quasi-particle is moving in a long-range correlated random m agnetic eld and short-range correlated scaler potential. The distribution of the random gauge eld is given by the corresponding static M axwell term and that of the scalar eld is given by the corresponding static M axwell term and the m ass term . Eqn. 64 is essentially the sam e as Eqn. 9 in Ref. [6].

Strictly speaking, the gauge eld from the random vortex array is a random Z_2 gauge eld. In Ref. [6], in order to perform an analytic calculation in the continuum limit, Ye made an approximation by replacing the discrete random Z_2 AB phase by a continuous random U (1) AB phase and perform ed a standard diagram matic perturbation theory.

In Ref. [40], assuming the nite temperature phase transition from d-wave superconductor to pseudo-gap regime is a K osterlize and Thouless (KT) vortex and antivortex unbinding transition [39], Ye studied the electron spectral function in the vortex plasma regime in Fig.1 [40]. Starting from Eqn 25, he found that the random gauge eld a missed in the previous semiclassical approaches [42] destroyed the coherent spinon motion and leads to branch cut singularities and pertinent non-Ferm i liquid behaviors. There are three subtle di erences between therm ally generated vortices from the static vortices generated by an external magnetic eld inside the d-wave superconductor: (1) The vortex density n_v should be replaced by free vortex density n_f above KT transition tem perature. (2) Therm ally generated vortices are moving around, the U (1) character is stronger than Z_2 character. They destroy the superconductivity. But static vortices only destroy the superconductivity inside the vortex cores. (3) The distribution of therm ally generated vortices is precisely given by vortex hydrodynam ics in the long-wavelength lim it. The free vortex density n_f is the only relevant parameter. We can set p equal to 1 in Eqn.64.

A fler taking into account these subtle di erences, the above procedures leading to Eqn.64 can be equally applied to therm ally generated free vortices with density n_f . The following alternative derivation of Eqn.64 may be stimulating: the vortices being treated classically, their com mutation relations can be neglected, the dual singular gauge transform ation in Eqn.29 on the vortices is not necessary, the Berry phase term for the boson (the linear tim e derivative term) can also be neglected. M ore specifically, only the time component of the charge gauge eld a_0 in Eqn 22 is kept to mediate the long-range densitydensity logarithm ic interaction between the vortices. O bviously, a₀ couples to the vortices the sam e way as the super uid velocity v couples to the spinon, its uctuation leads to a mass term for the v v correlation. How ever, being orthogonal to the spatial component a , a а correlator rem ains gapless. This also leads to exactly the same equation as Eqn.64 with p setting equal to 1 and the same conclusions as those rst reached in Ref. [6].

However, at zero temperature, the vortices being treated quantum mechanically, all the components of the charge gauge eld a should be kept to mediate the long-range current-current logarithm ic interactions between the vortices. Then the charge gauge eld uctuation leads to mass terms not only for v, but also for the spatial component a . There is no gapless dynam ic gauge uctuations in the Cooper-pair picture as demonstrated in Eqn.61. The phenom enon that the two gapless gauge elds cancel each other is sim ilar to the standard H iggs mechanism. In H iggs mechanism, the gapless gauge eld is eaten by gapless G oldstone modes. The two gapless modes annihilate each other, the G oldstone m ode disappears, while the gapless gauge eld becom es massive.

VI.DISCUSSIONS AND CONCLUSIONS

B ased on the earlier work by B alents, F isher and N ayak [1], Senthil and F isher developed Z_2 gauge theory [19,20] to study quasi-particles coupled to vortices generated by quantum uctuations. By breaking electrons and C ooper pairs into sm aller constitutes: chargons with charge e, spin 0 and spinons with charge 0, spin 1=2, SF introduced a local Z_2 gauge degree of freedom to constrain the H ilbert space to be the original one. The electric action describes both chargons and spinons coupled to local uctuating Z₂ gauge theory with a doping dependent Berry phase term . By the com bination of standard duality transform ation of 3 dim ensional XY model and that of \mathbb{Z}_2 gauge theory, the action is mapped into a dual vortex representation where the hc=2e vortices and spinons are coupled by a mutual Z_2 CS gauge theory. As usual vortices in XY model, the hc=2e vortices also couple to a uctuating U (1) gauge eld which mediates the long-range logarithm ic interaction between the vortices. Starting from the dual representation, the authors in Ref. [20] studied a transition from d-wave superconductor to con ned M ott insulator driven by the condensing of hc=2e vortices at half lling. In order to study the critical behaviors of this particular con nem ent and decon nem ent transition, they replaced the Z_2 mutual CS theory on the lattice by U (1) mutual CS theory in the continuum and perform ed renorm alization G roup (RG) analysis. Some of their RG analysis may not be correct as demonstrated in Sec.IV. In contrast to U (1) gauge theory which has only con ned phase, Z₂ gauge theory has both con ned and decon ned phases. The topological excitation of the Z_2 gauge eld play an important role. If hc=2e vortices condense, the visons are also condensed, the system is in the con ned phase, the chargon and spinon are con ned into electron, Cooper-pair and magnon. If he vortices condense, the visons are gapped, the system is in the decon ned phase, the spinon and chargon are asymptotically decoupled in the longwavelength lim it. SF argued that the cuprates are in the decon ned phase, therefore the zero tem perature transition at $x = x_c$ is driven by the condensation of hc=e vortex. They further proposed the "vison trapping experim ent " to test their spin-charge separation scenario. Several groups perform ed such experim ents, but found no signature of visons [38].

The original Anderson singular gauge transform ation [10] was proposed for static vortices. In this paper, we extend the one singular gauge transform ation for static vortices to two mutual ux-attaching singular gauge transformations for moving vortices generated by quantum uctuations. By making a close analogy to the conventional singular gauge transform ation of FQH system, we perform the two singular gauge transform ations attaching ux of moving vortices to quasi-particles or vice versa. Just like conventional singular gauge transformation leads to conventional CS term, the two mutual singular gauge transform ations lead to mutual CS term . In this way, we propose an intuitive and physical transparent approach to bring out explicitly the underlying physics associated with the condensation of the hc=2e vortices. W hen considering both mutual C-S interaction and long-range logarithm ic interaction between the vortices, we nd that there are only electrons and Cooper pairs in the spectrum and there are no gapless gauge eld uctuation in contrast to the U (1) or SU (2) gauge

theory [21]. W hen taking into account both the linear time derivative Berry phase term for the bosons and the long-range Coulomb interactions between Cooper pairs and electrons, the true ground state in the underdoped side m ay be som e unknown charge ordered state. Understanding the zero tem perature transition from d-wave superconductor to this unknown charge ordered state is an in portant future research direction. The electron spectral weight starting from Eqn 25 m easured by ARPES in the pseudo-gap regime at $T > T_c$ indicated in Fig.1 was presented in a separate publication [40]. The theory presented in this paper focus on the con ned phase. The recent experiment [38] indicates that the cuprates may be inside the con ned phase. In principle, our theory should be equivalent to the Z_2 gauge theory in the con ned phase side after tracing out the uctuating Z $_2$ gauge eld except the D oppler shift e ect m issing in \mathbb{Z}_2 gauge eld is also explicitly incorporated into the present approach.

The importance of the Volovik e ect and the AB phase scattering in random static vortex array was stressed in Ref. [6]. As concluded in this paper, when the vortices are generated by quantum uctuations at T = 0, the dynam ic D oppler shift e ect and them utualC -5 phase scattering both become irrelevant short-ranged interactions. How ever, there is a crossover regime between these two lim its which is the vortex plasm a regime near the nite temperature KT transition. In this regime, there is a energy scale separation between the quasi-particle and the vortices: the vortices are moving much slower than the quasi-particles, therefore can be treated in a hydrodynam ic approximation. The important e ects of Volovik and AB phase scattering on ARPES data was discussed in Ref. [40].

As explicitly stressed in this paper, the U (1) mutual CS theory in the continuum does not have the periodicity under ! + 1, because moving hc=2e vortex is di erent from moving hc=2e vortex. In fact, the periodicity of the conventional CS theory under ! + 2 is also a very intricate issue. On the one hand, the perturbative RG expansion in terms of the statistical angle

in the continuum limit in Refs. $[30{32}]$ does not have this periodicity. On the other hand, properly regularized on the lattice, the CS theory does have this periodicity [43]. The two di erent regularizations do lead to di erent conclusions on the Q uantum H all transitions. It also leads to notorious H all conductivity di culty at = 1=2 [44]. A deep understanding on the periodicity problem in both conventional CS term and mutual CS term is clearly required in the near future.

In the Landau gauge = 0 and putting $\tilde{k} = 0$, we recover the results calculated in Sec. III.

APPENDIX B: MOVING HC=E VORTICES AND THE IRRELEVANCE OF THE DYNAM IC DOPPLER SHIFT EFFECT

For he=e vortex, we can perform a neutral-like singlevalued gauge transform ation by setting A = B = -2. The double strength vortex and its stability was investigated in Ref. [2], the associated spin-charge separation has been discussed extensively in Refs. [1,19]. In this appendix, considering a moving hc=e may still scatter quasi-particles by the AB phase, in analogy to the hc=2e vortices discussed in the main text, we still include a possible mutual C-S interaction with the statistical angle taking any integer values. For = 0, we recover the results in R ef. [1] and also get the new result on the expression of current operator I in the superconducting phase. A lthough the static Volovik e ect is marginally relevant [6,40] and cause nite density of states of the quasi-particles at zero energy. In this appendix, we show that surprisingly the dynam ic Volovik e ect is highly irrelevant on the both sides of the QCP.

Putting A = B = -2, namely setting a = 0 in Eqn.14 leads to:

where the second term is the Berry phase term which is a rst order time derivative and means the irrelevant couplings between bosons and ferm ions. Eqn B 5 is essentially the same as Eqn B 1.

However, a moving home vortex may still scatter quasiparticles by AB phase. In general, we should also include a possible mutual C-S term in the elective action. The most general form is again given by Eqn 22 with the statistical angle taking any integers and $A^{eff} =$ A K¹J for home vortex. The form ulation developed in Sec.IV can be straight-forwardly applied to home vortices. Putting the above two values for and A^{eff} into Eqn 59 leads to

The above equation indicates that the quasi-particle carries charge which can take any integer numbers. O byiously, there is no periodicity in . The most natural and simplest choice is = 0 where the above equation reduces to Eqn B5. In this equation, bosons and ferm ions are asymptotically decoupled. The ferm ions

(spinons) carry only spin 1/2, the bosons (holons) carry only charge e. There is spin-charge separation. The long-range C oulom b interaction could be incorporated by adding the dynamic term for the time component of the gauge eld $\frac{1}{2}k \mathbf{\hat{A}}_0(\mathbf{k}) \mathbf{\hat{f}}$ [45]. W ithout the ferm ionic part, the action is the same as the superconductor to insulator transitions studied in [46], except here condensed is a charge e boson instead of a C ooper pair.

In the underdoped regime, the vortex condenses < >= $_0$ which generates a mass term for a in Eqn B2 $\frac{1}{2} {}^2_0$ (a) 2_t . Integrating out the massive a leads to a Maxwell term for A^{eff} = A K¹J from which we can identify the automatically conserved electric current I = $\frac{1}{2} {}^2_0 (^2J + (^2J + (^2J)^2))$ [1]. The dynamic Doppler shift e ect is $\frac{1}{2} {}^2_0 (^2J)^2$, it is a four ferm ion term with two derivative, therefore highly intelevant [1]. The static Volovik e ect is marginally relevant [6,40] and cause nite density of states at zero energy. Surprisingly, the dynamic Volovik e ect is highly irrelevant. Note that its coe cient $_0^2$ diverges as we approach the QCP from the underdoped side.

In the superconductor phase, the vortex is massive, therefore can be integrated out, it leads to the old M axwell term $\frac{1}{4m}$ (f)². Integrating out a generates a mass term $\frac{1}{2}m$ (A^{eff})². From the mass term, we can identify the automatically conserved electric current I = m (J)_t. Note that although the quasi-particle electric current is not conserved itself, the total electric current I = m ($\frac{q}{q^2}$)J (q) is conserved. The dynam ic D oppler shift e ect due to the virtually uctuating vortex-anti-vortex pairs is m (J)²_t. It is a four fermion interaction term, therefore irrelevant. Note that its coe cient vanishes as we approach the QCP from the superconducting side.

We reach the conclusion that the dynamic Doppler shift term is irrelevant on both sides of the QCP. We conjecture that it is likely also irrelevant at the QCP. Counter-intuitively, it contains two more derivatives in the vortex condensed underdoped regime than in the vortex depleted superconducting phase, therefore even more irrelevant in the underdoped regime than in the superconducting phase. The previous scaling argument on the irrelevance of this term at the QCP presented in Ref. [1] is questionable, because the authors scaled the phase like a free eld. In fact, should be con ned to be

0 < 2, so it is far from being a free eld. (B 6)

Putting $_{\rm A} = _{\rm B} = = 2$ in Eqn.23, we get the electron annihilation operator:

The above Eqn. demonstrates clearly that electron is separated into charge e boson $b = e^{i} = 2$ and spin 1=2 spinon . Note that the crucial di erence from Eqn.25 is that there is no internal gauge eld !

In the underdoped regin e, boson $b = e^{i^{=2}}$ is massive, therefore short-ranged correlated. Being the product of ferm ion and boson G reen functions, the electron correlation function is also short-ranged. The underdoped regin e is a M ott insulator as suggested in Refs. [1,19,20].

At the critical point, in real space, b decays with a power law $1 + _{X Y}$, the electron G reen function decays with a power $2 + 1 + _{X Y}$.

In the superconductivity phase, < b > 6 0, the electron G reen function decays with a power 2. The anom alous G reen functions F (x;t) = < C * (x;t)C * (0;0) > also starts to form :

It also decays with power 2. Note that the matrix elements between di erent p h indices are non-vanishing.
