Spin Fluctuation Induced Dephasing in a M esoscopic R ing

W e investigate the persistent current in a hybrid A haronov-B ohm ring -quantum dot system coupled to a reservoir which provides spin uctuations. It is shown that the spin exchange interaction between the quantum dot and the reservoir induces dephasing in the absence of direct charge transfer. W e dem onstrate an anom alous nature of this spin- uctuation induced dephasing which tends to enhance the persistent current. W e explain our result in terms of the separation of the spin from the charge degree of freedom. The nature of the spin uctuation induced dephasing is analyzed in detail.

Persistent current (PC) in a mesoscopic Aharonov-Bohm (AB) ring is an ideal probe of quantum coherence of electron motion in the equilibrium state. U sually the PC is likely to be suppressed by various dephasing processes. The role of the intrinsic dephasing at low tem perature has not been well understood till now [2]. An alternative view point to this is to introduce an arti cial dephasor, in order to study the e ect of decoherence in a controlled m anner [3]. A conceptually sim ple but instructive example for that purpose is an AB ring attached to an electron reservoir which exchanges charges with the ring [4]. In the reservoir electrons are scattered inelastically and there is no phase coherence between electrons absorbed and those em itted by the reservoir. Therefore charge transfer between the ring and the reservoir dim in ishes the coherence and thus the AB oscillation. On the other hand, the e ect of the spin exchange interactions on the PC has been attracting growing interest in recent years [5{11]. It has been proposed that the spin uctuation a ects the PC in a drastically di erent m anner com pared to the case of charge uctuation [6{8,12]. Experimentally, the role of coherent spin uctuation has been investigated by transport m easurem ents using AB interferom eter setup [15,16]

In this Letter, we address the e ect of dephasing induced by the spin uctuations. For this purpose we consider the geometry schematically drawn in Figure 1, where the spin uctuation between the ring and the reservoir is mediated via antiferrom agnetic exchange interactions with the quantum dot (QD), while direct charge transfer is prohibited by the C oulom b blockade. We end a counterintuitive result that the dephasing tends to enhance the PC rather than to reduce it in this geometry. We argue that this enhancement can be regarded as a signature of the separation of the spin degree of freedom from the charge one.

Ourmodel is described by the Hamiltonian:

where H $_0$, H $_R$ and T stand for the hybrid dot-ring system, reservoir, and tunneling between the QD and the

reservoir, respectively. H $_{\rm 0}$ is decomposed into the three parts as

where H_{QD} , H_{ring} , and H_{t^0} correspond to the Ham iltonians describing the quantum dot, the AB ring, and the dot-ring hybridization, respectively:

Here, we describe the ring by using a tight-binding H am iltonian with N lattice sites, and the Q D by a single Anderson in purity. The single particle energy and the on-site C oulom b repulsion in the Q D are represented by "d and U, respectively. The phase ' in Eq. (3b) comes from the AB ux, and is de ned by ' = 2 = 0, where

and $_0$ are the external ux and the ux quantum (= hc=e), respectively. Note that Eq. (3b) can be diagonalized and the corresponding eigenvalues are given by " $_m = 2t\cos^1_N$ (2 m ') (m being an integer num ber). The reservoir is modeled by a Ferm i sea of electrons with single particle energies fE $_k$ g :

Finally, coupling between the QD and the reservoir is given by a tunneling H am iltonian

The hopping strength of reservoir-dot and that of ring-dot are represented by $_{\rm R}$ and 0, respectively. $_{\rm R}$, assumed to be constant at the energy interval of ~D < " < D, is de ned as

where $_{\rm R}$ and represent the density of states in the reservoir and the tunneling am plitude between the reservoir and the QD. For half-lled case (where the Ferm i energy is set to be zero) in the continuum limit, ⁰ can be simply written as [12]

Our study is restricted to the simplest half-lled case, which does not a ect the result and conclusion we will draw .

To rule out the e ect of charge uctuation, we consider the parameter limit of "d;"d + U 0 + $_{\rm R}$. In the absence of the reservoir, the B ethe ansatz result [7] shows that the PC is not a ected by the QD in the K ondo limit with =T_K ! 0, where T_K stands for the K ondo energy scale. For nite value of =T_K, the coupling of the ring to the QD linearly reduces the PC as a function of =T_K for sm all =T_K, and induces a crossover from the continuum K ondo limit (=T_K 1) to an e ectively decoupled ring-dot system (=T_K 1) [8].

To calculate the PC in the presence of the reservoir, we adopt the leading order 1=N s-expansion with N s being the magnetic degeneracy. This approach was shown to describe well the essence of the K ondo correlation preserving the Fermi liquid properties [13]. In addition, for the ring-dot system without reservoir, this approximation reproduces the exact Bethe ansatz result for =T_K ! 0 [8]. Here we consider the in nite-U limit since the consideration of nite U and double occupancy in the QD does not provide any modi cation to the renormalized physical quantities [14]. Then the problem is reduced to solving the self-consistent equation:

where f (") is the Ferm i distribution function. E $_{G}^{0}$ E $_{G}$ E, where E is the energy of the ground state without tunneling. E $_{G}$ corresponds to the ground state energy of the coupled system at zero temperature.

At zero tem perature the 2nd term of Eq. (9) can be calculated analytically and the latter is rewritten as

The PC is de ned in term s of the phase sensitivity of the ground state energy as

Combining Eq.(11) with Eq.(10), the PC can be expressed as the sum of two terms, I_{ring} and I_{int} , originating from the ideal ring and from the interactions, respectively:

is the contribution to the PC from the bare ring energy level ${\tt "_m}$, and

corresponds to the renormalization constant for the ground state. Note the negative sign at the R H S. of Eq.(12c) which leads to the reduction of the PC for nite value of $=\!\!T_K$.

Figure 2 displays the e ect of the coupling to the reservoir on the PC. The PC is plotted as a function of the dimensionless coupling strength de ned by

Note that the PC is a universal function of $\ ,\ '$, and $=T_{\kappa}^{0}$, which does not depend on the parameter detail chosen here. T_{κ}^{0} in the gure denotes the K ondo energy scale in the absence of the coupling to the reservoir ($_{\rm R}$ = 0) for ! 0, (while $T_{\rm K}$ stands for the counterpart including the reservoir). First, one should recall that for $_{R} = 0$ the PC is reduced to I_{ring} in the continuum limit (T_{K}^{0}), and is suppressed for nite value of $=T_{\kappa}^{0}$ [8]. It will be natural to believe that the reservoir would reduce the AB oscillation since it is expected to play the same role as a charge reservoir which induces decoherence. However, the result is opposite to this sim ple expectation. Coupling to the reservoir enhances the PC as shown for several values of $=T_{K}^{0}$. As increases, the PC is enhanced and eventually it saturates to I_{ring} for su ciently large .

This anom alous result is interpreted as follows. Instead of reducing the PC, coupling to reservoir suppresses $\rm I_{int}$ only, the contribution originating from the spin exchange interactions. This makes net increase of the PC because

the direction I_{int} is opposite to I_{ring} . This is a unique signature that the spin and the charge degrees of freedom are decoupled. That is, the reservoir degrades the coherence of spin degree of freedom (I_{int}) only, while it does not a ect the charge one (I_{ring}) .

To be more precise, the in uence of reservoir on the system can be classi ed into two factors. (i) Increase of the K ondo binding energy: A s the coupling turns on, the e ective spin exchange interactions between the electrons in the QD and the conduction electrons increase. This results in the enhancement of the binding energy (or reducing the size of the K ondo screening cloud). (ii) D ecoherence of electrons: The K ondo scattering provides e ective charge ow between the ring and the reservoir. Since the electrons in the reservoir are scattered inelastically, no phase coherence exists between the electrons absorbed and those em itted by the reservoir. This feature has never been addressed before in the K ondo lim it.

Both e ects ((i), (ii)) are present in the result of Figure 2. The e ect of enhanced K ondo binding energy is not a unique feature of our geom etry. That is, the energy scale is modied by changing other parameters as well, and it can be well understood in terms of the renorm alized energy scale, T_K . In order to extract the dephasing e ect, we show the PC as a function of $=T_K$ for three dierent values of in Figure 3(a). The e ect (i) is already included in the renormalized parameter $=T_K$ with dependent T_K . The PC displays a crossover at $=T_K$ 1 from the K ondo $\lim it (=T_K)$ 1) to the e ectively decoupled limit ($=T_K$ 1), regardless of the coupling to the reservoir. For large $=T_K$ the PC saturates to the value which corresponds to that of the ideal ring with one electron subtracted from the present system (denoted by the dotted line). This demonstrates e ective decoupling of the ring from the rest part of the system .

Here we point out that the PC increases as increases even after subtracting the e ect of rescaled K ondo energy, as shown in Figure 3(a). This demonstrates the anom alous nature of the K ondo-assisted dephasing that enhances AB oscillation. That is, the dephasing inuences only the interaction part of the current, I_{int} , through the spin- uctuation channel, which results in a net increase of the PC. This property is analyzed in m ore detail in Figure 3(b). For small $=T_K$, $I_{int}=I_{ring}$ shows -dependent linear behavior as $I_{int}=I_{ring} = c() =T_K$,

where c() > 0.0 ne can see that the slope c() decreases as increases. The reduction of the slope as a function of is the result of dephasing through spin exchange interactions.

To complete our discussion it is instructive de ne the coherence factor, , associated with the spin-uctuationinduced dephasing by the ratio

The coherence factor (Figure 4) decreases m onotonically

as increases. This is a manifestation of decoherence mediated by the spin uctuations. This behavior is quite universal independent of any parameter detail.

In conclusion, we have investigated the e ect of reservoir coupled to a composite AB ring -QD system on the PC. In the Coulom b blockade limit, spin uctuations induce decoherence of the system in an anom alous way. The persistent current circulating the ring is enhanced due to the dephasing in the K ondo limit. We have argued that this enhancem ent is closely related to the separation of the spin from the charge degree of freedom.




FIG.1. Schematic diagram of the hybrid quantum dot - AB ring structure coupled to a reservoir.





FIG.2. Persistent current as a function of the renormalized coupling strength of the reservoir to the QD () for 0 = 0:125t, "_d = 0:7t, and ' = 0:1 with several values of = $T_{\rm K}^0$.






FIG.3. (a) Persistent current as a function of the renormalized level spacing ($=T_K$) for three dimensional values of . O ther parameters are given the same as those in Figure 2. The dotted line indicates the PC of the ideal ring with one electron subtracted. (For ' = 0.1, it corresponds to $\frac{4}{9}I_{ring}$.) (b) Interaction contribution to the persistent current for the same e parameters.




FIG.4. Coherence factor (de ned in Eq.(14)) as a function of .
